**DESCRIPTION**

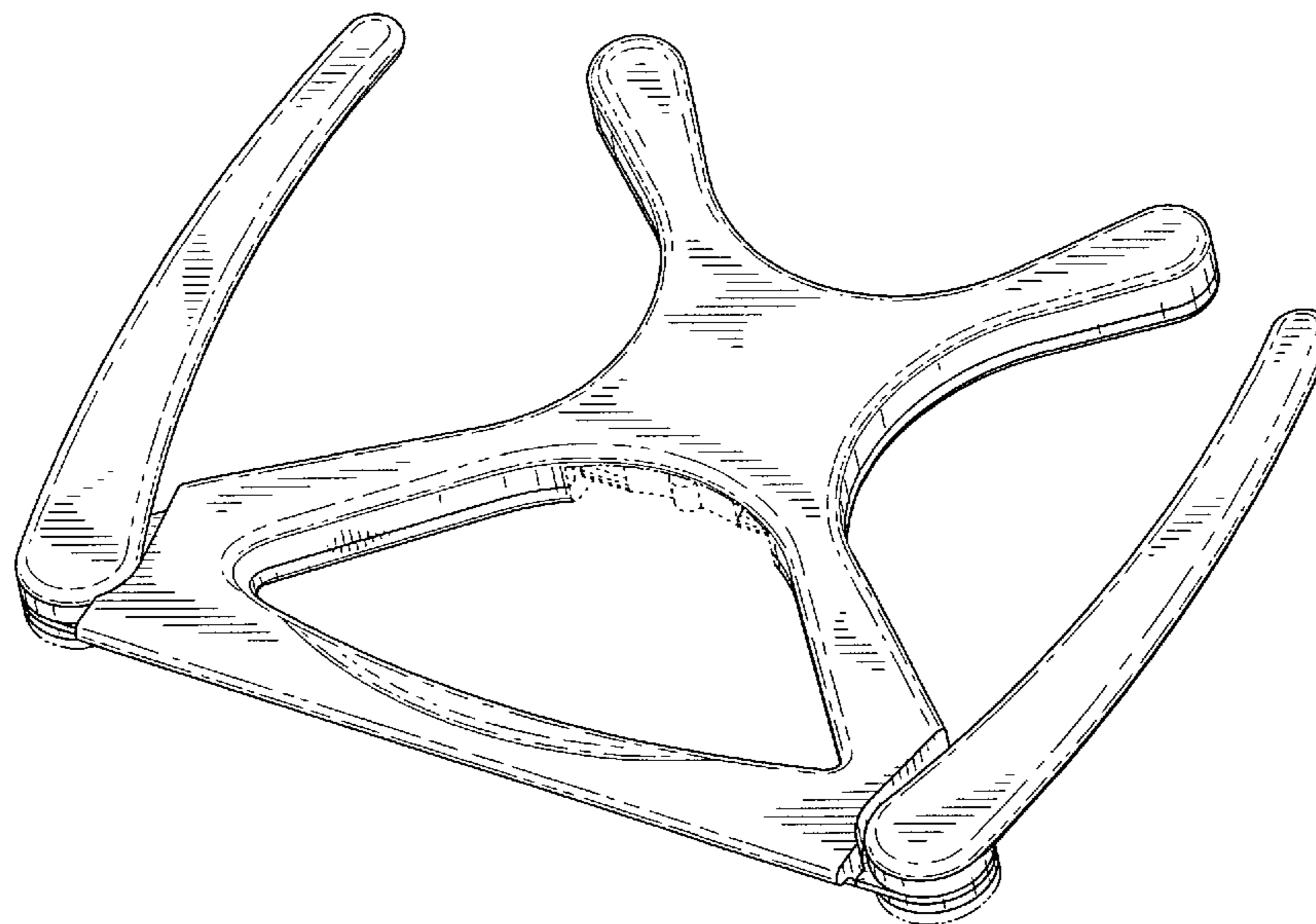

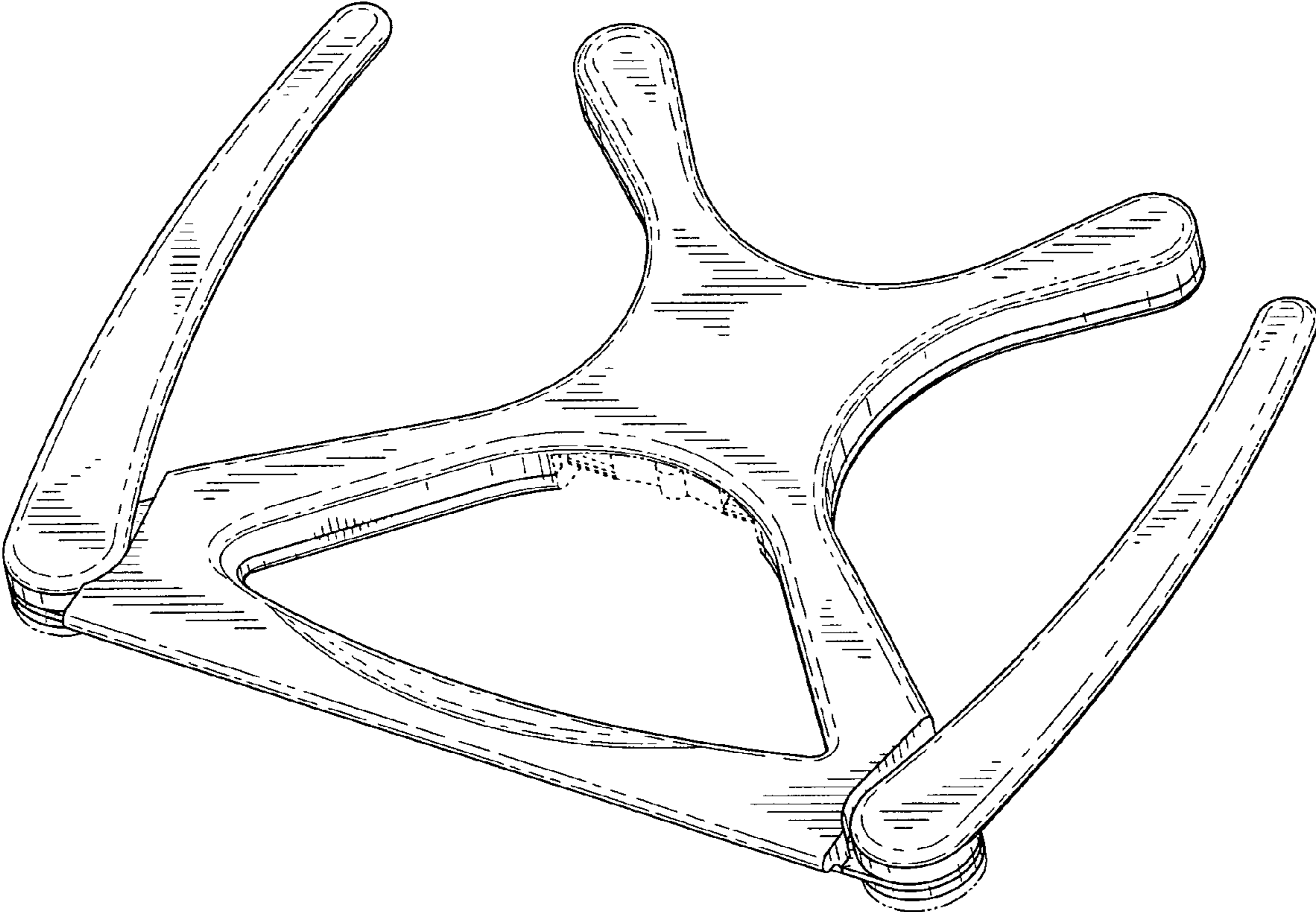

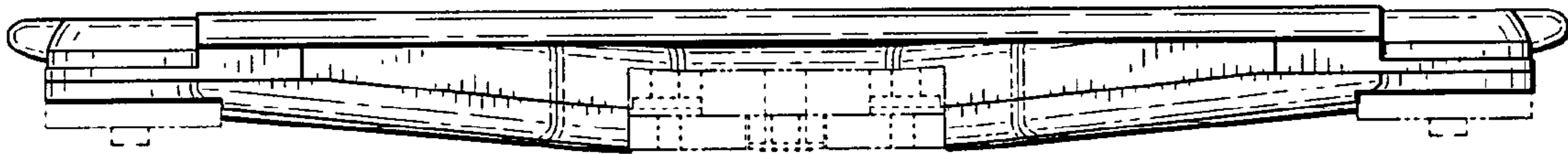

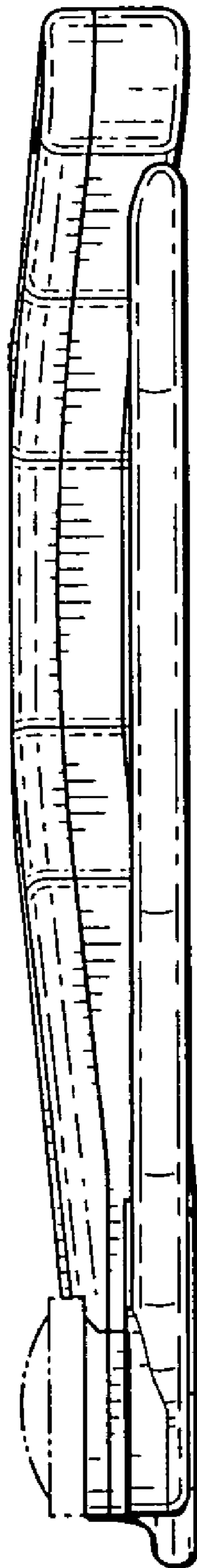

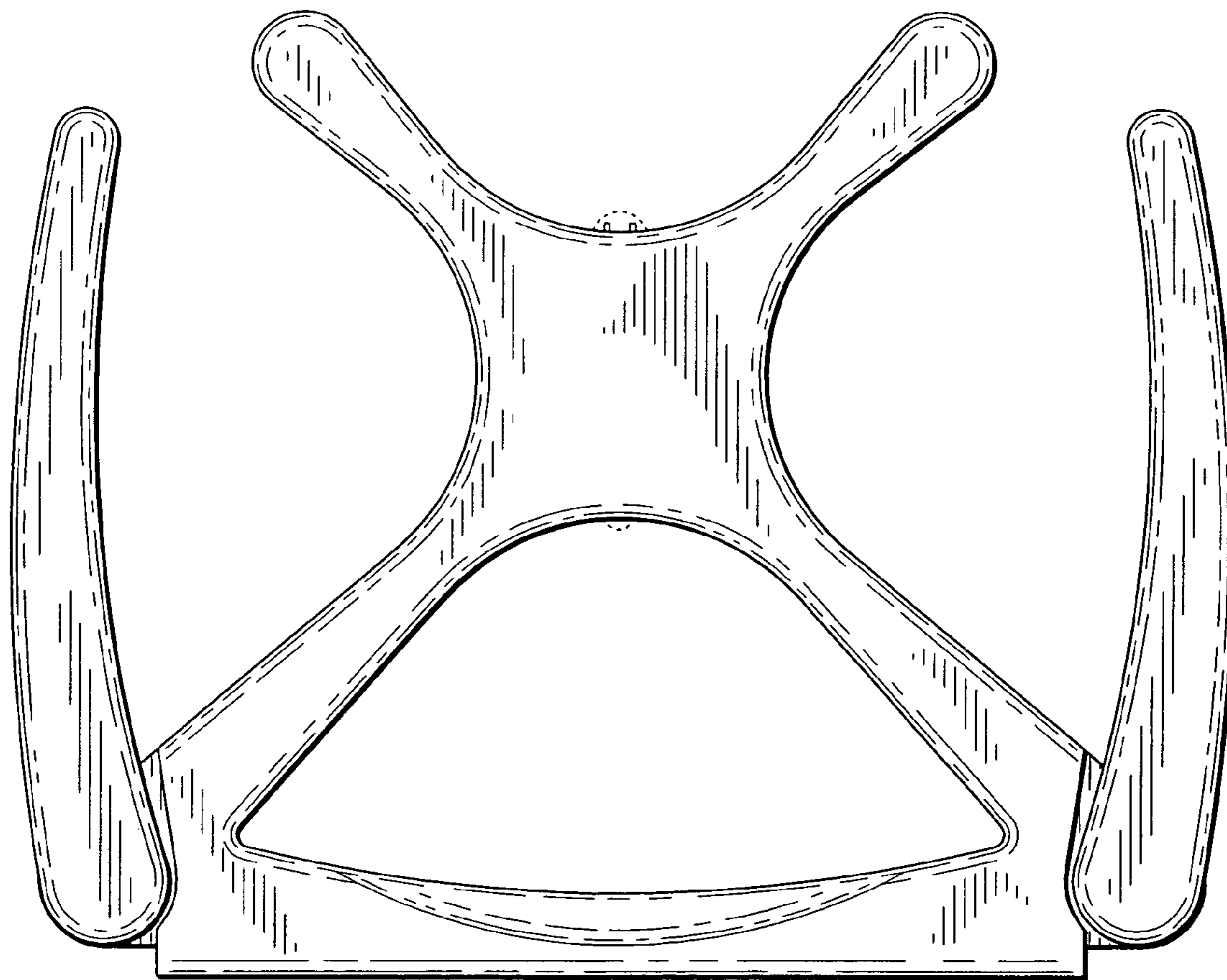
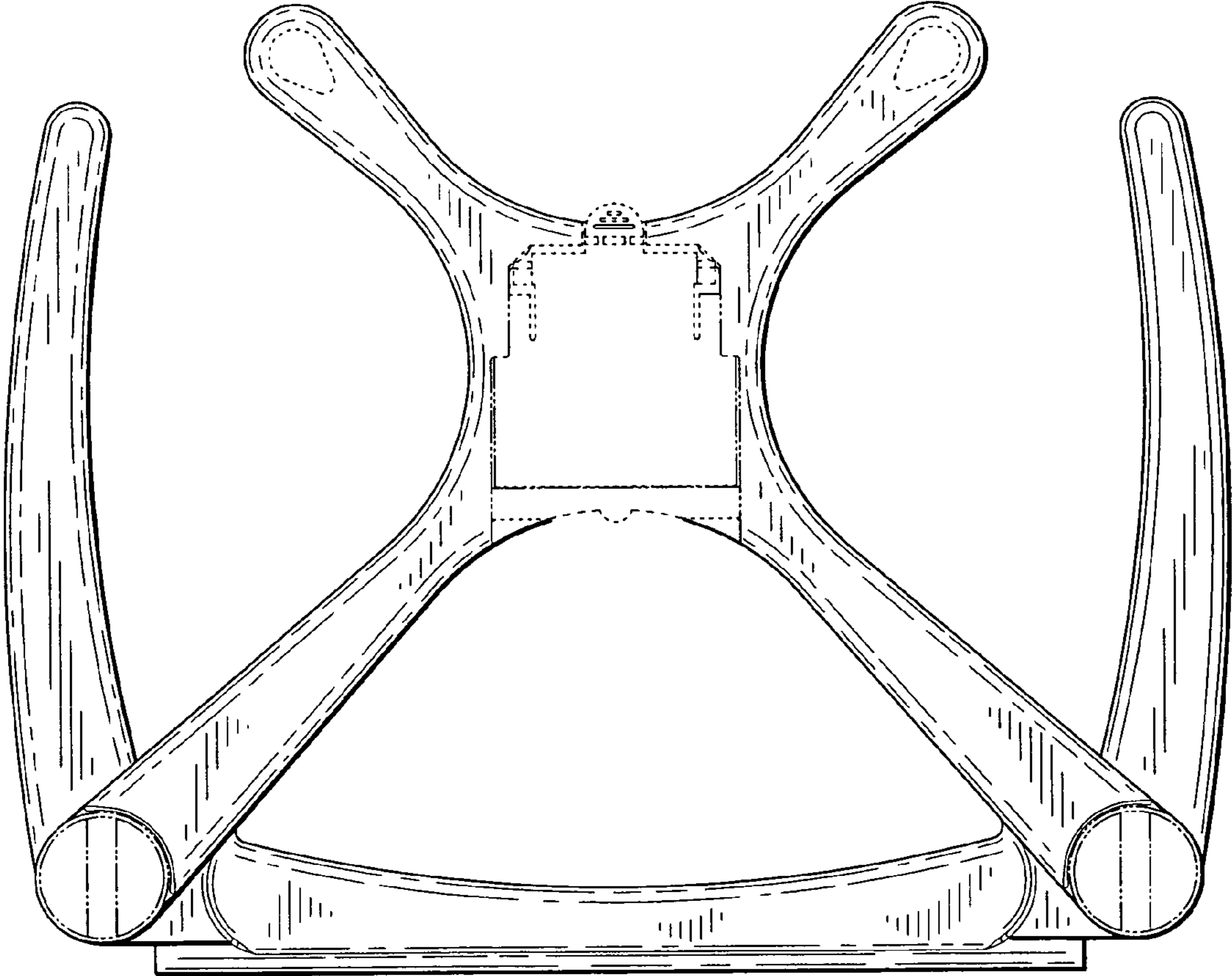
