FIG. 4 is a right side view;

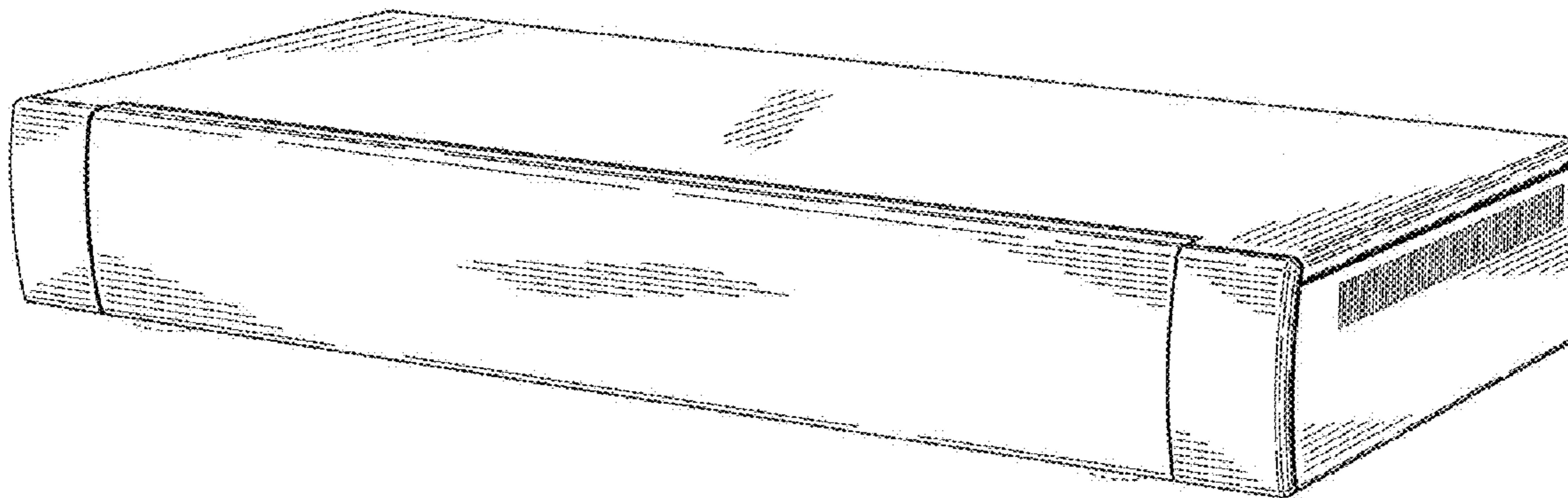
FIG. 5 is a left side view;

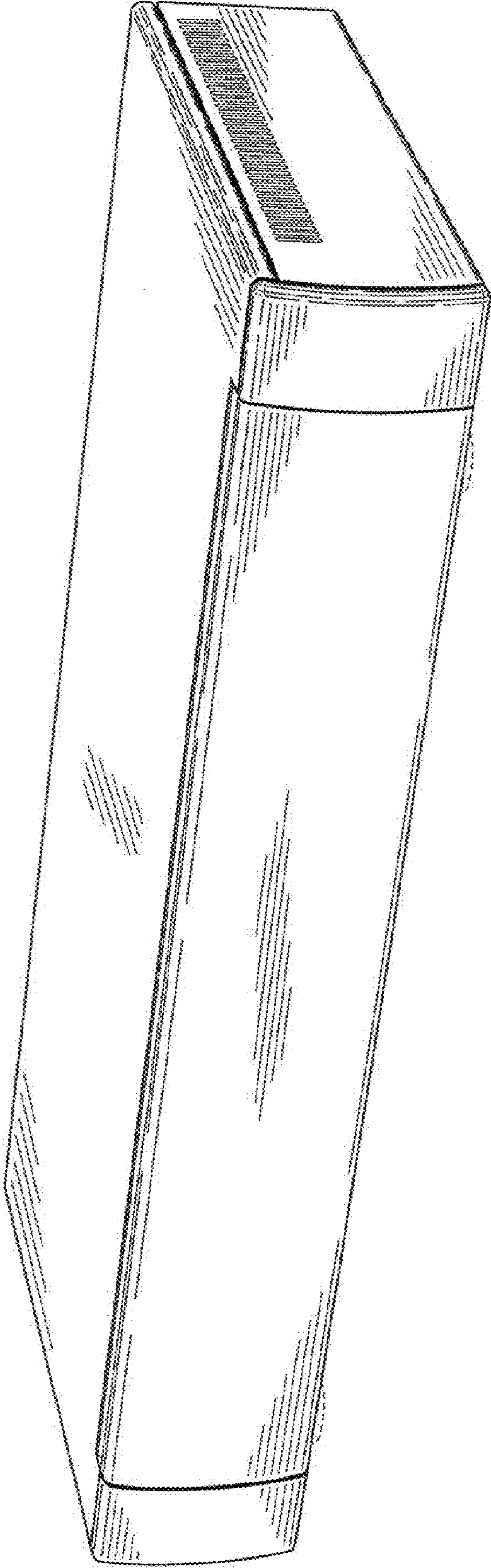

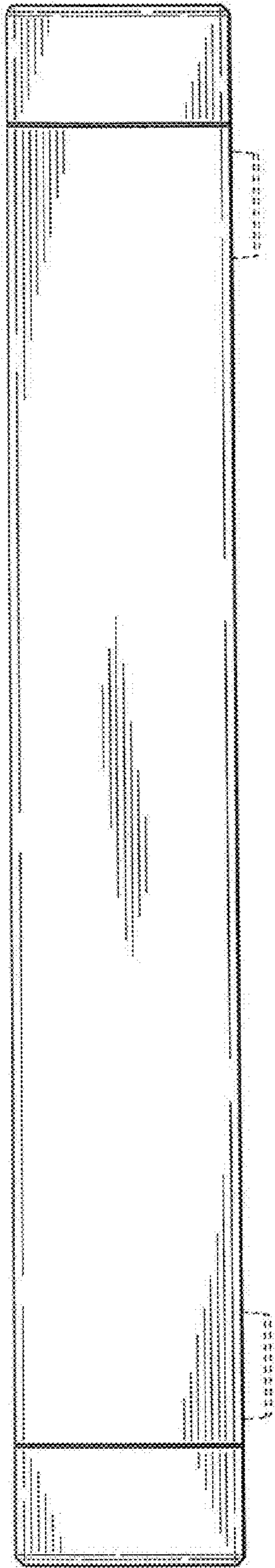

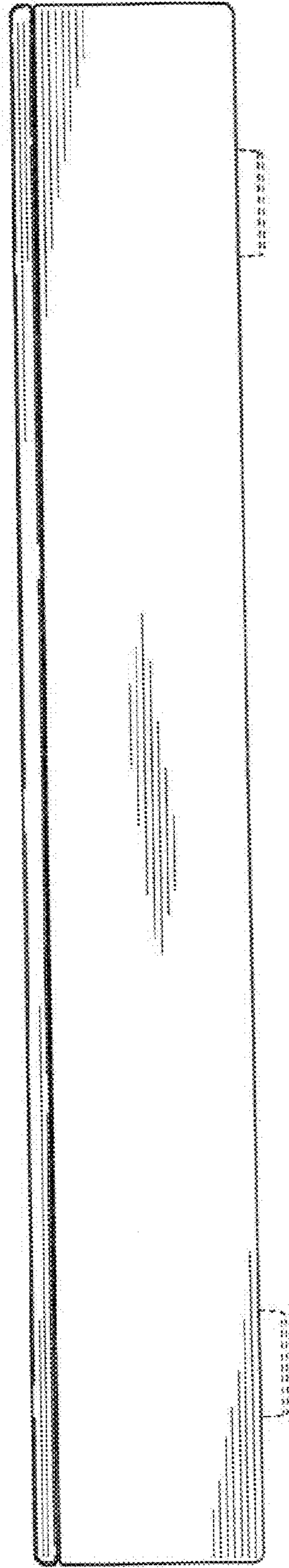

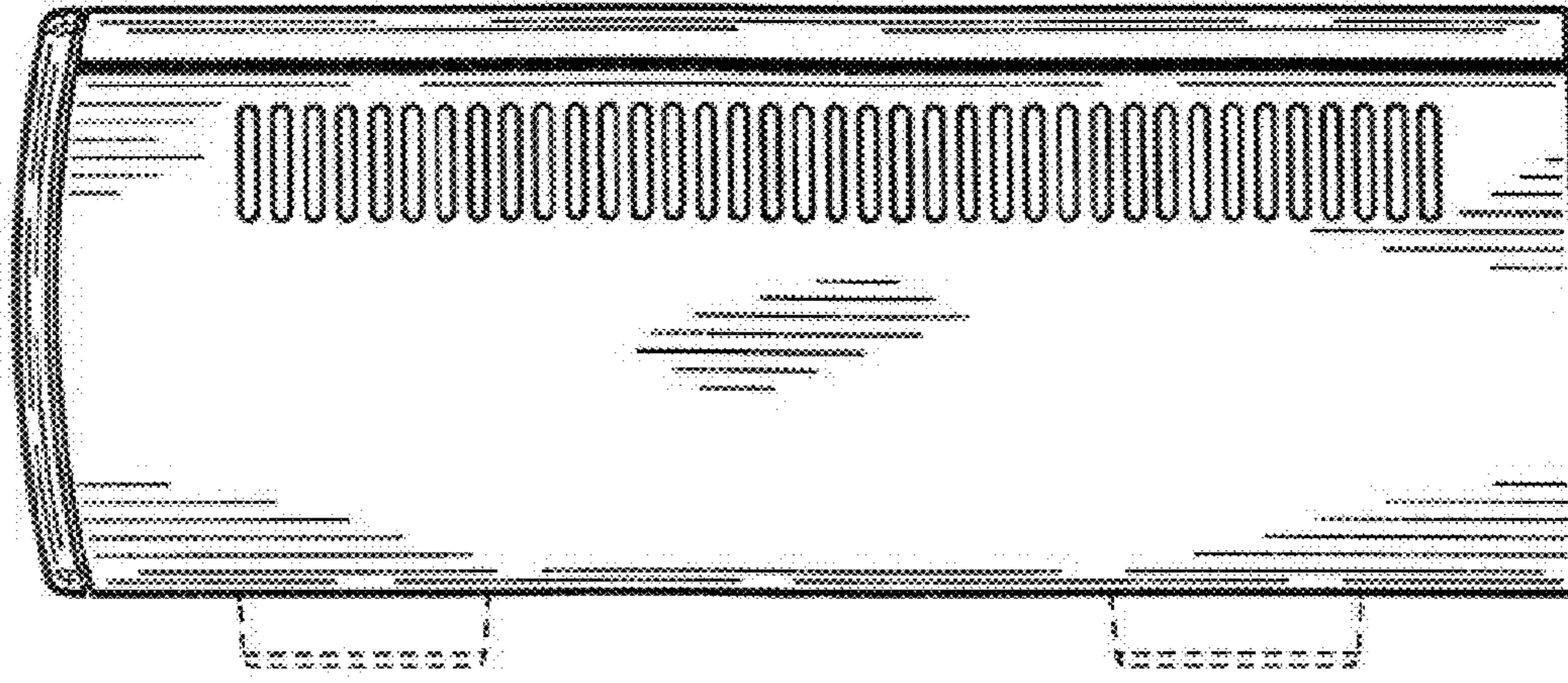

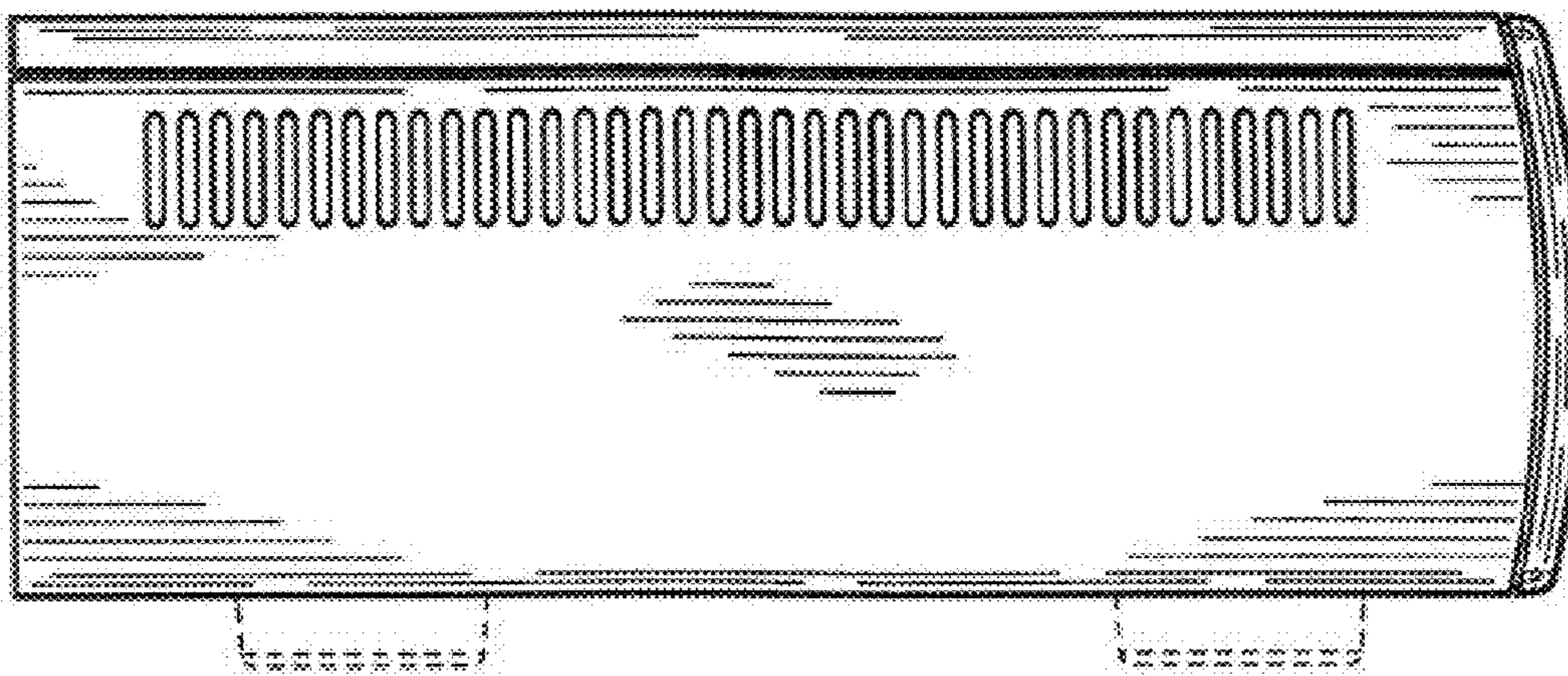

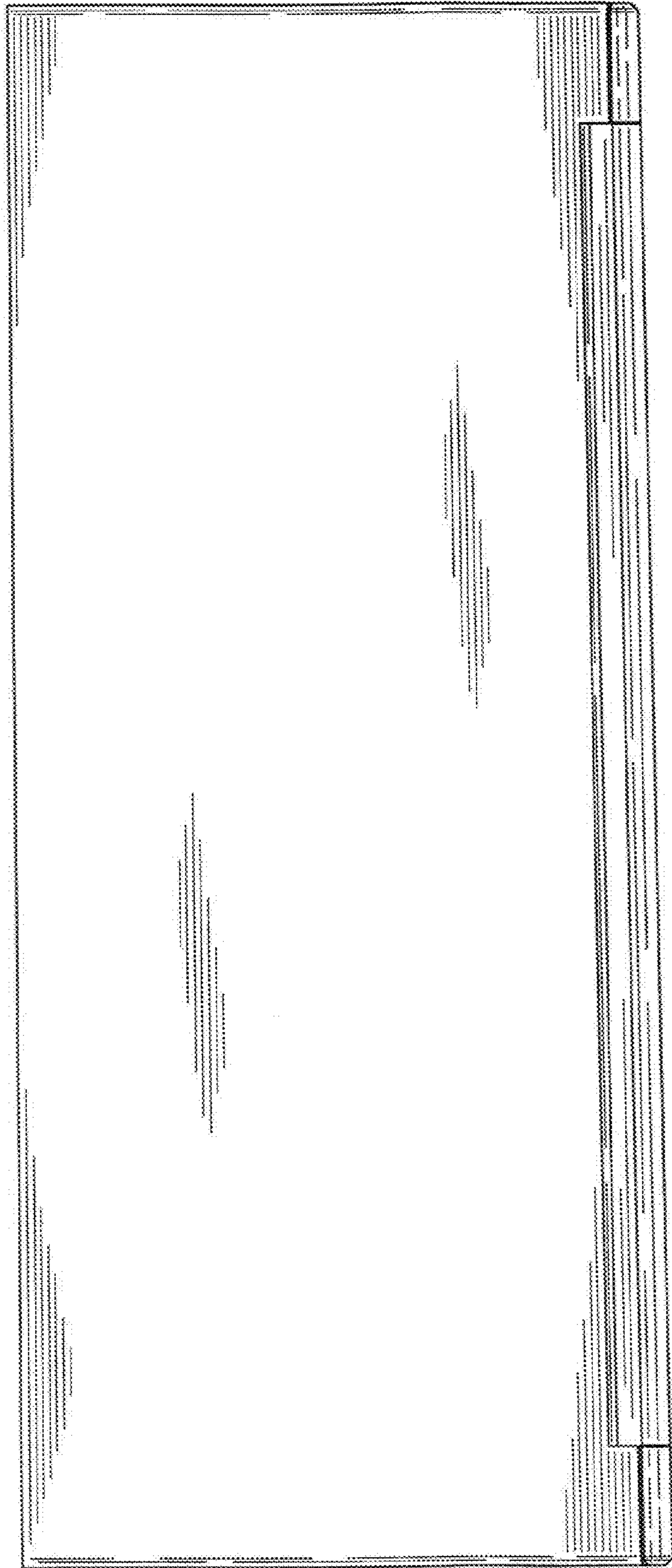

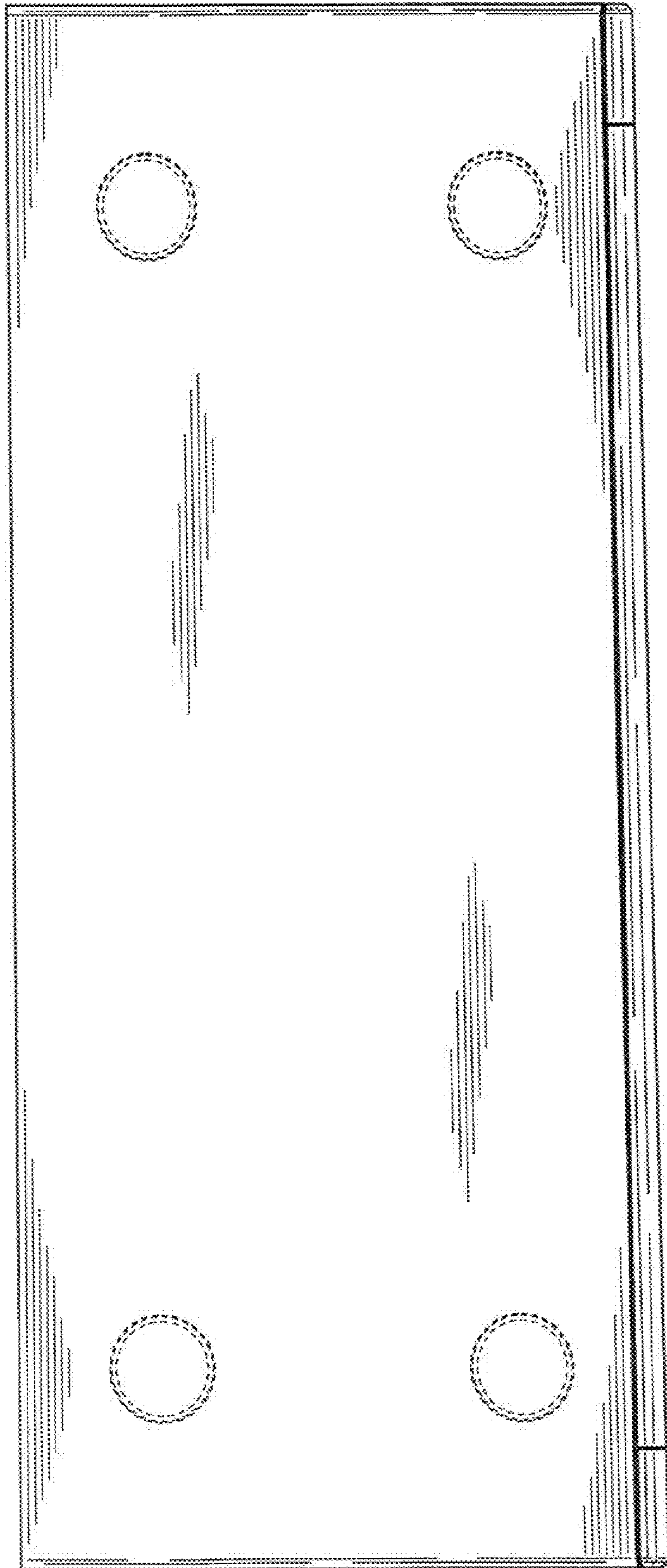
