FIG. 11 is a front view of the second embodiment of the pouch;

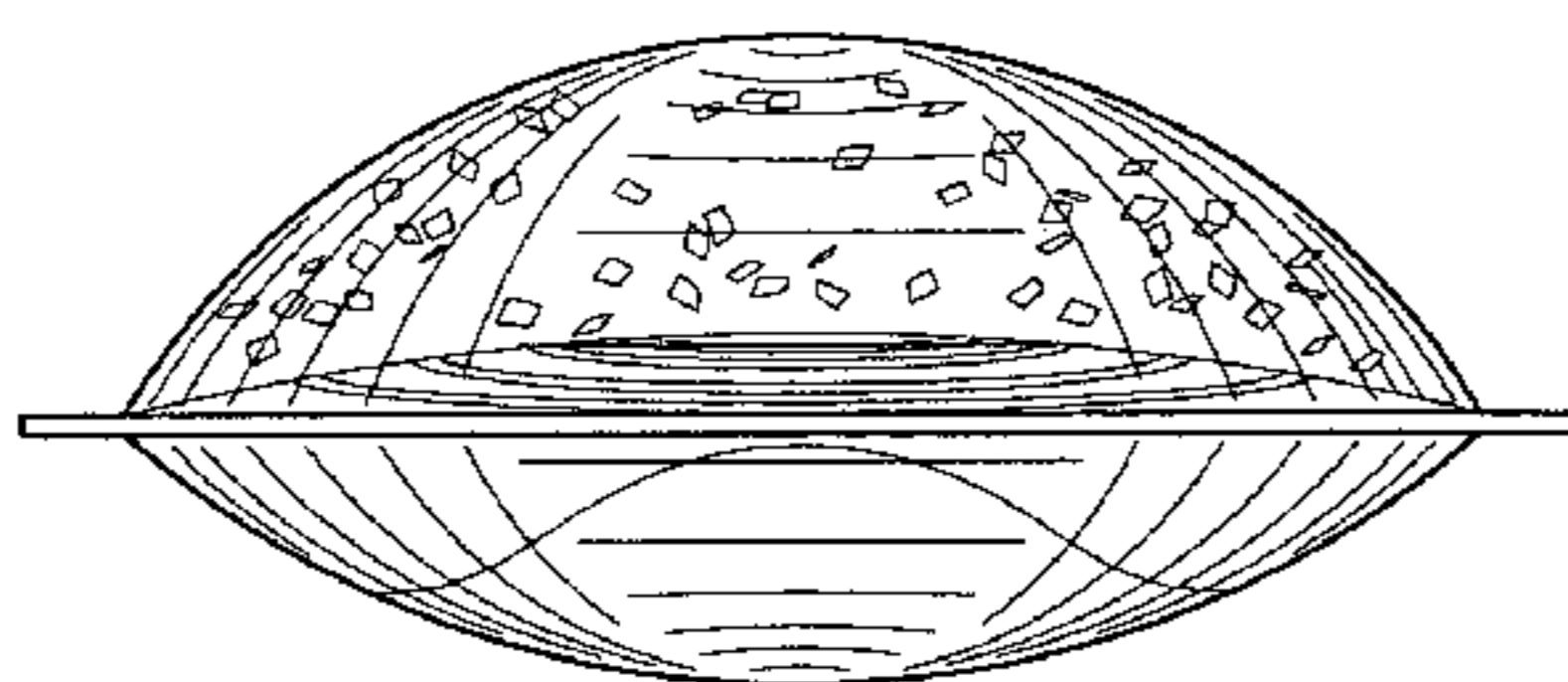
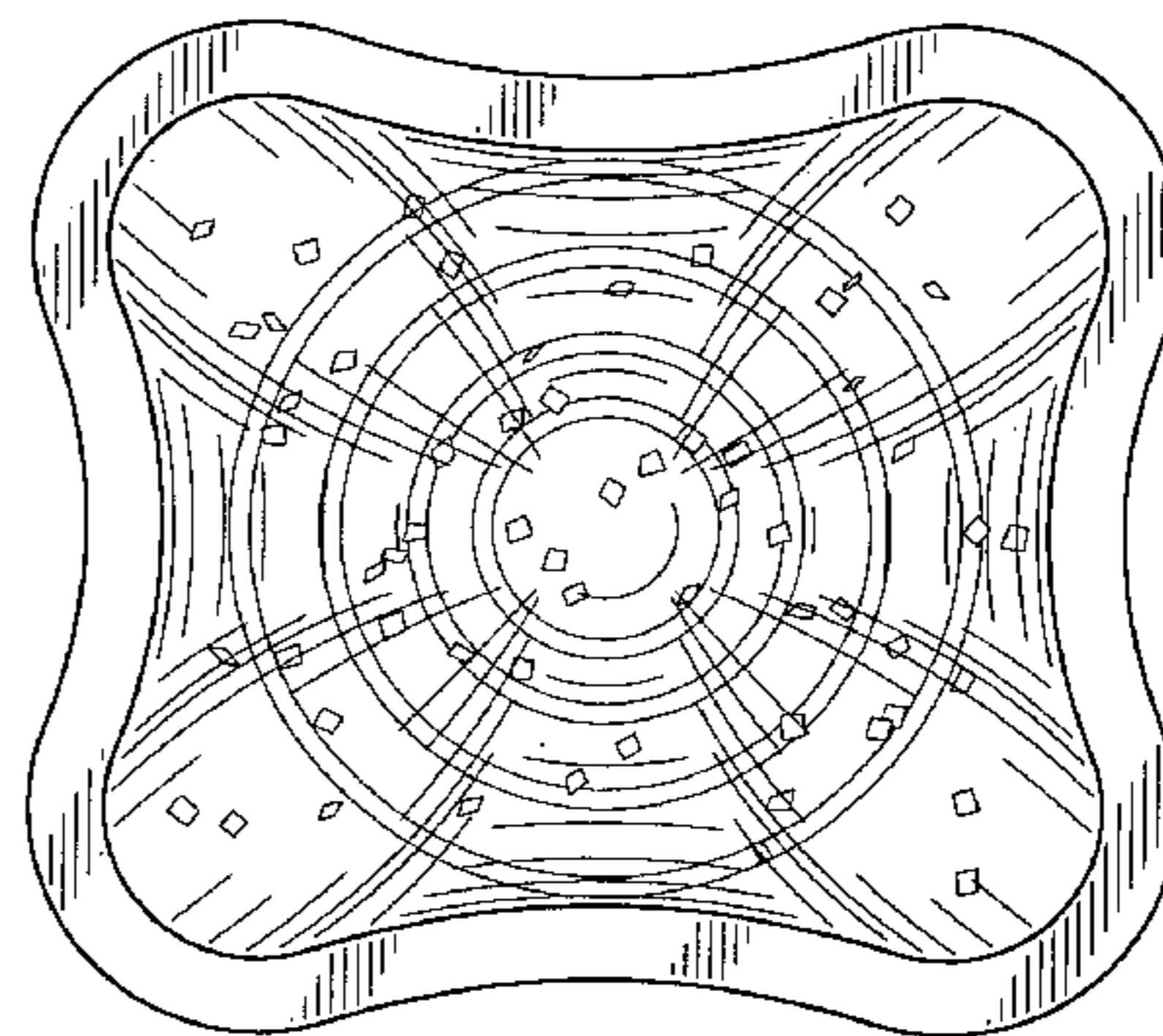
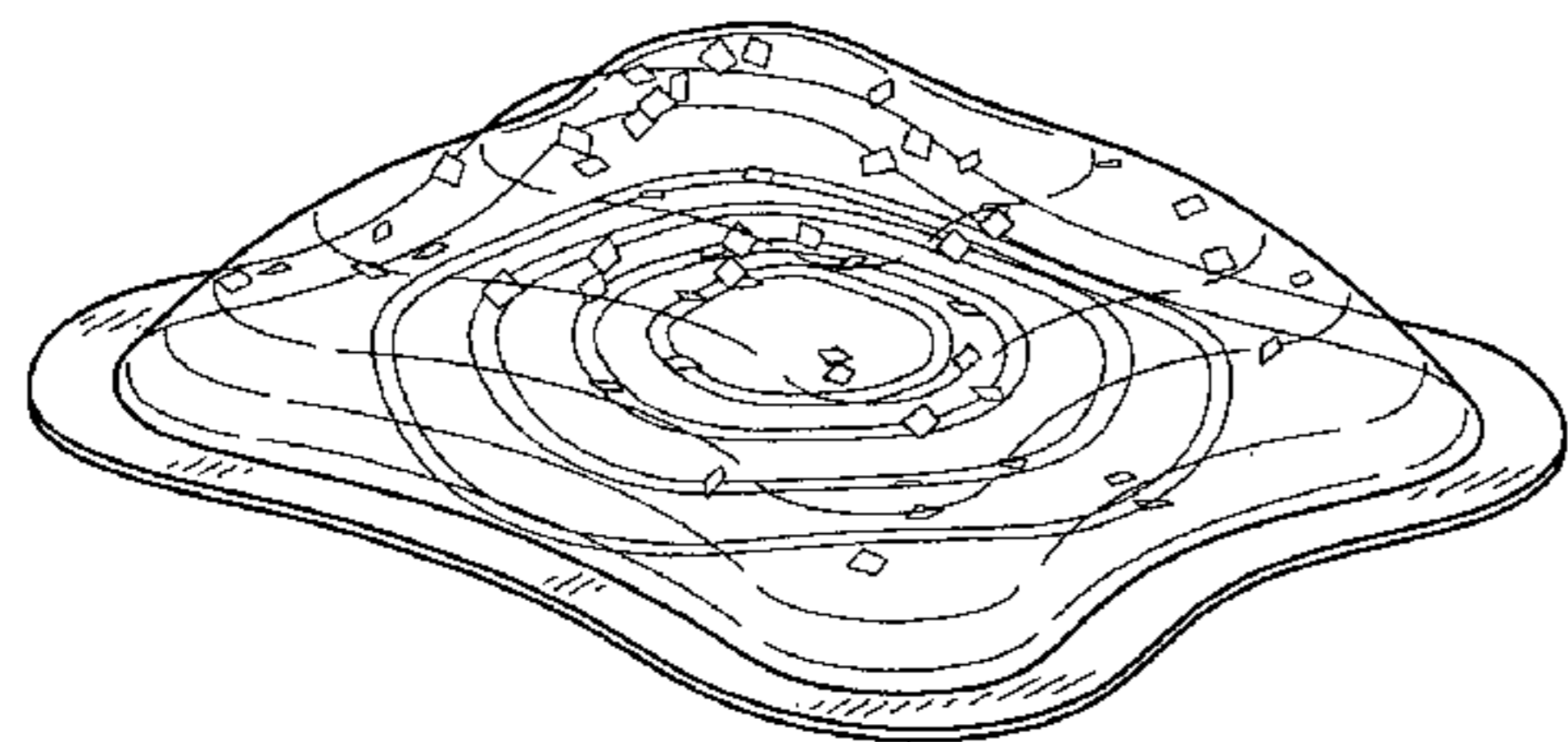
FIG. 12 is a back view of the second embodiment of the pouch;

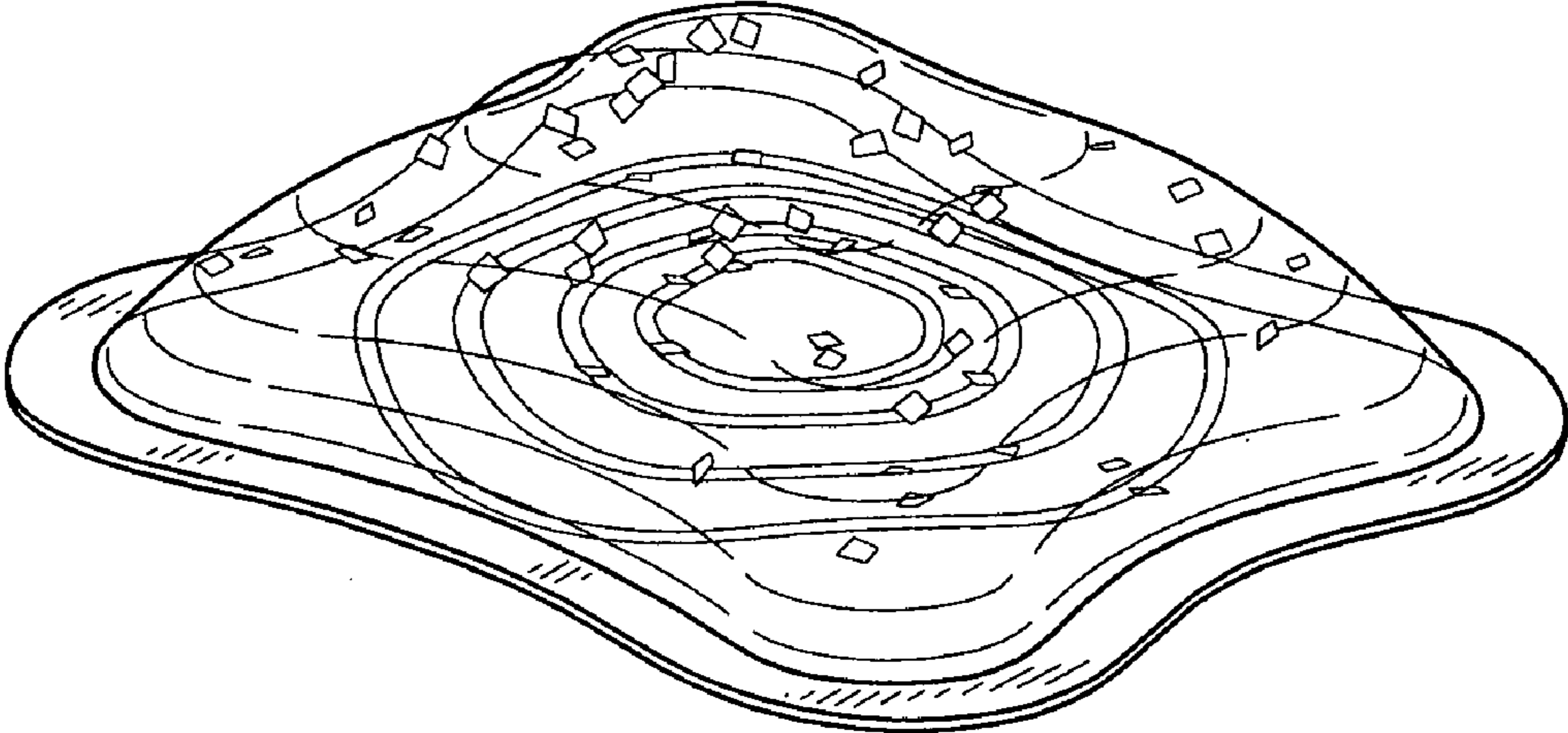

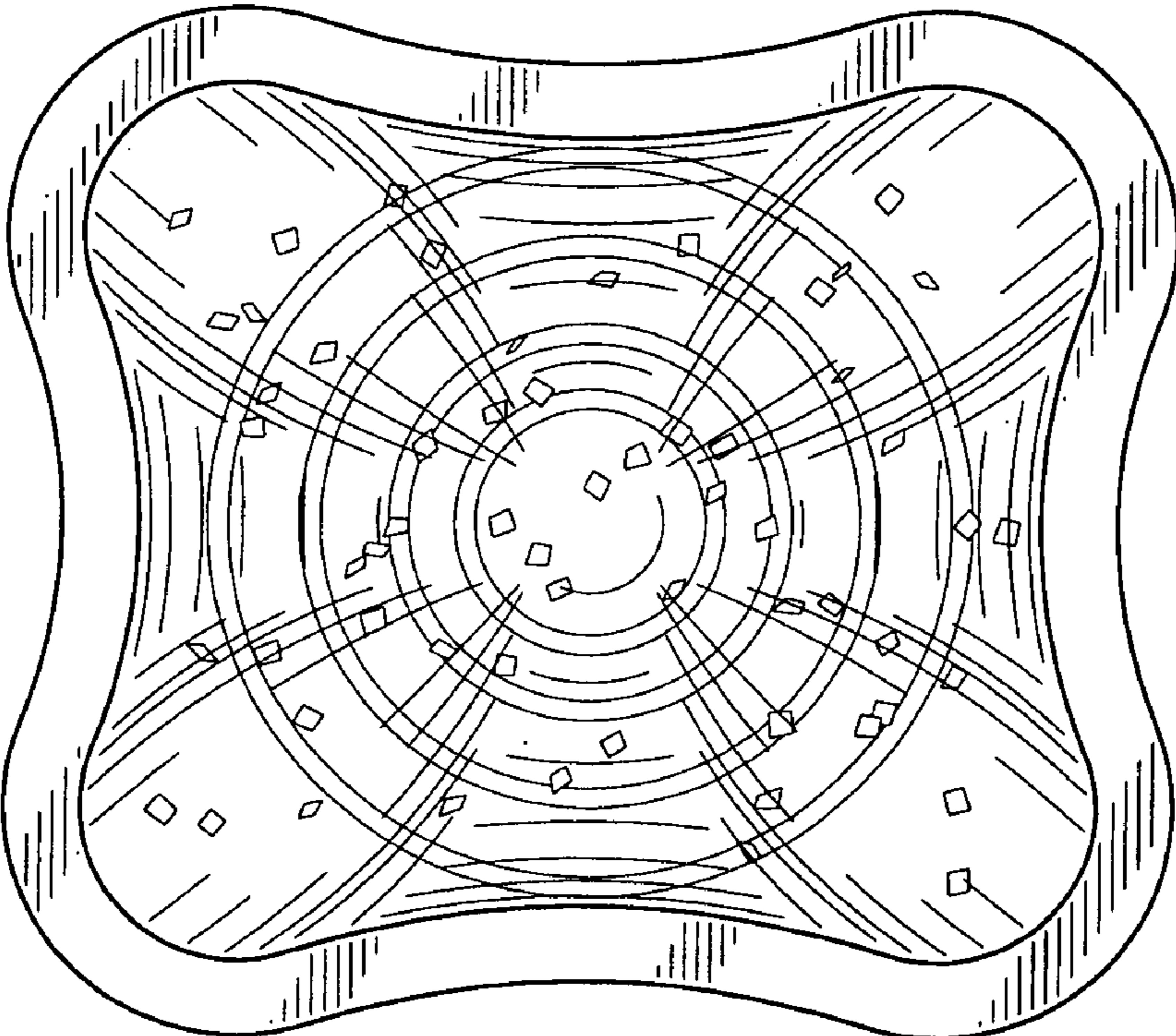

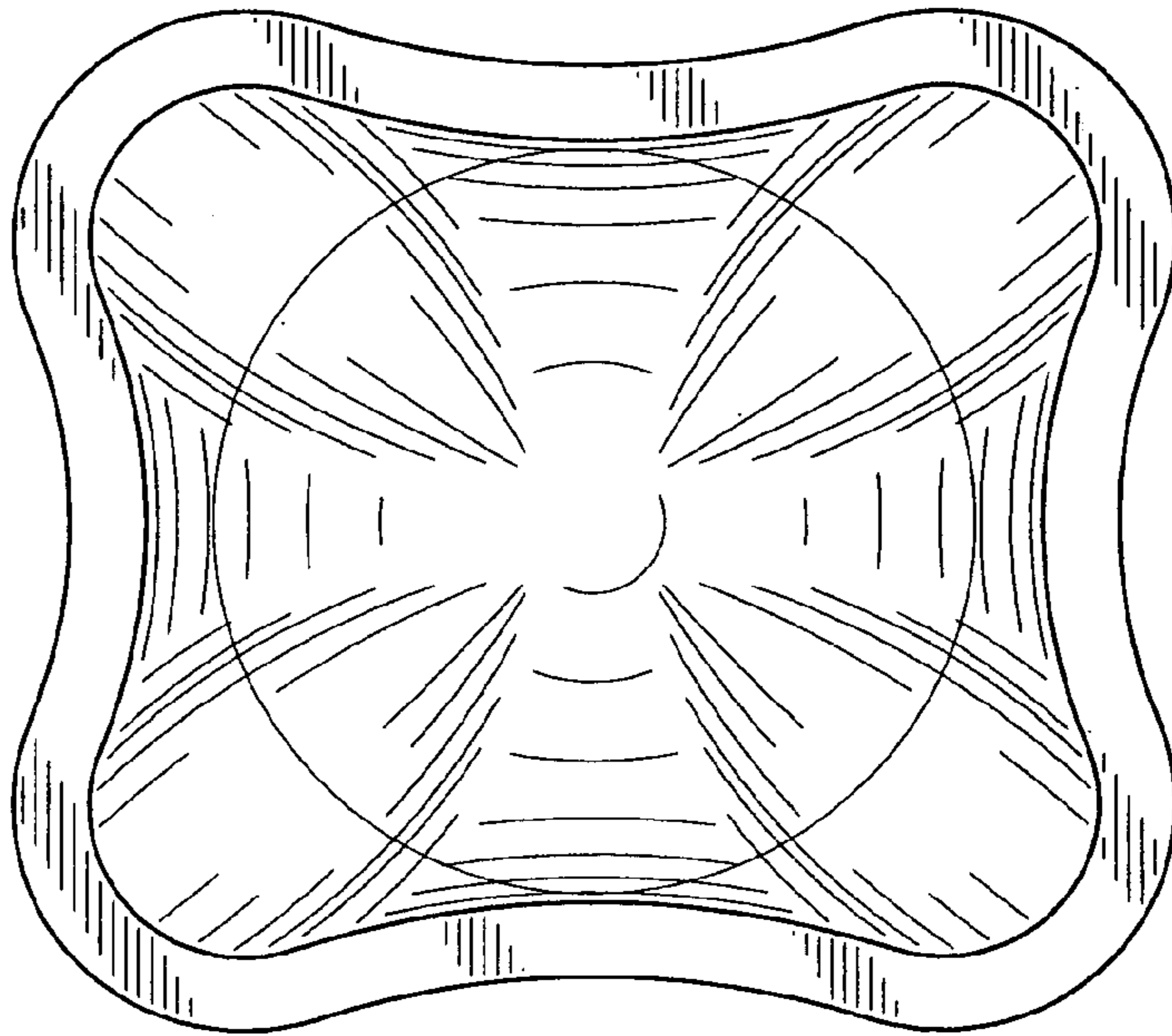

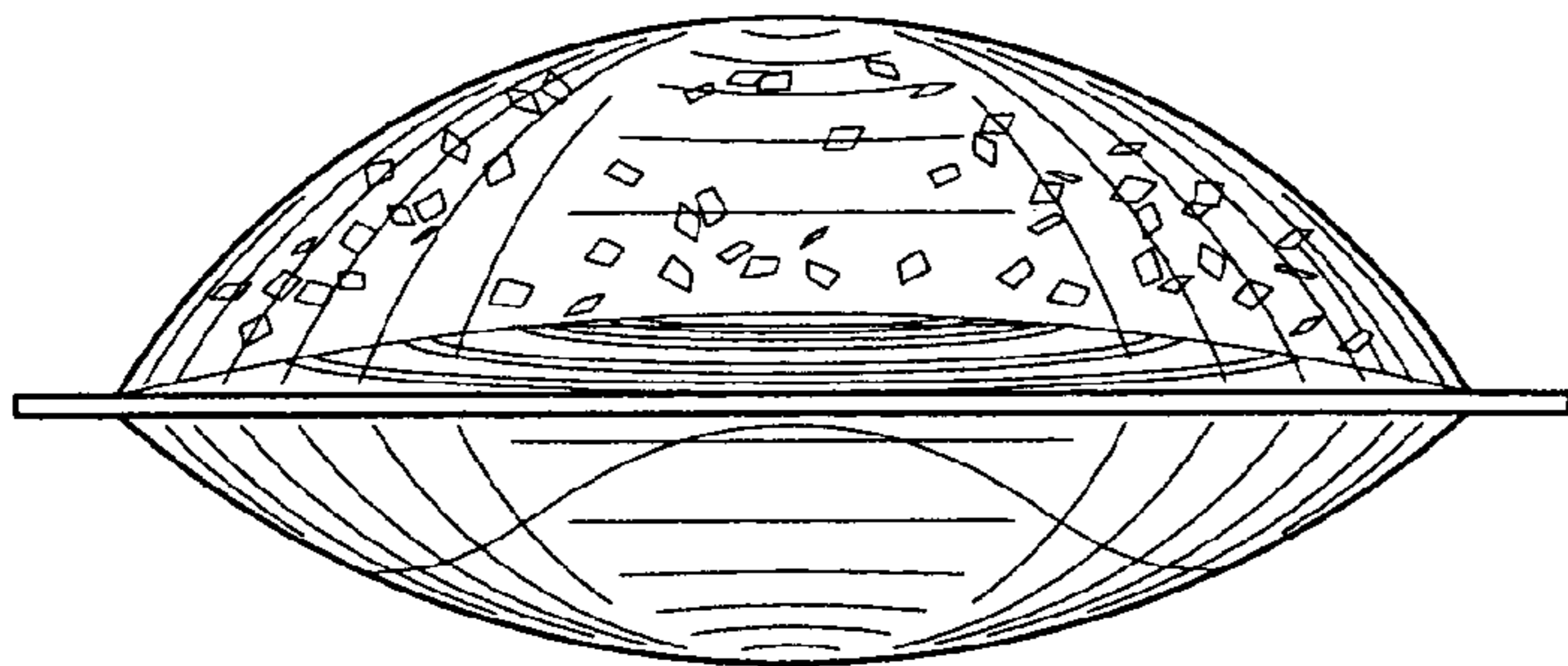

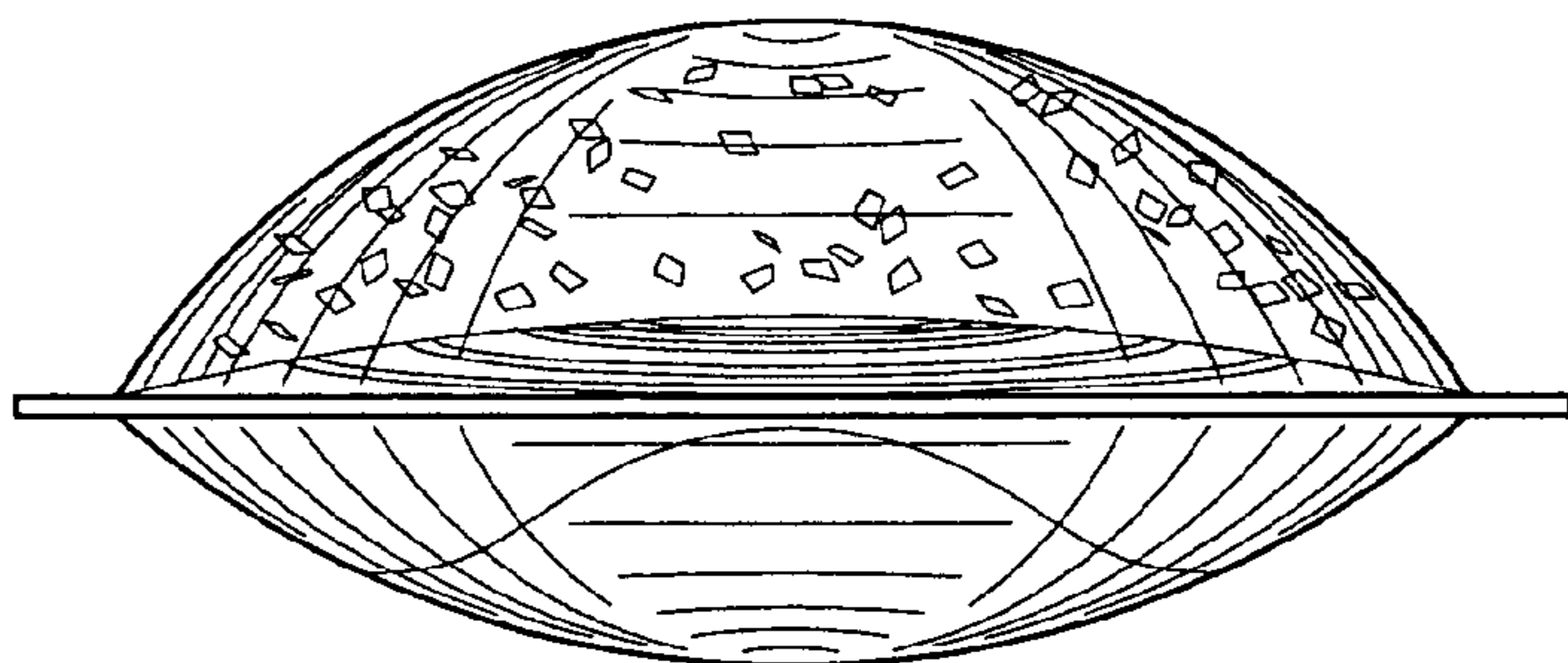

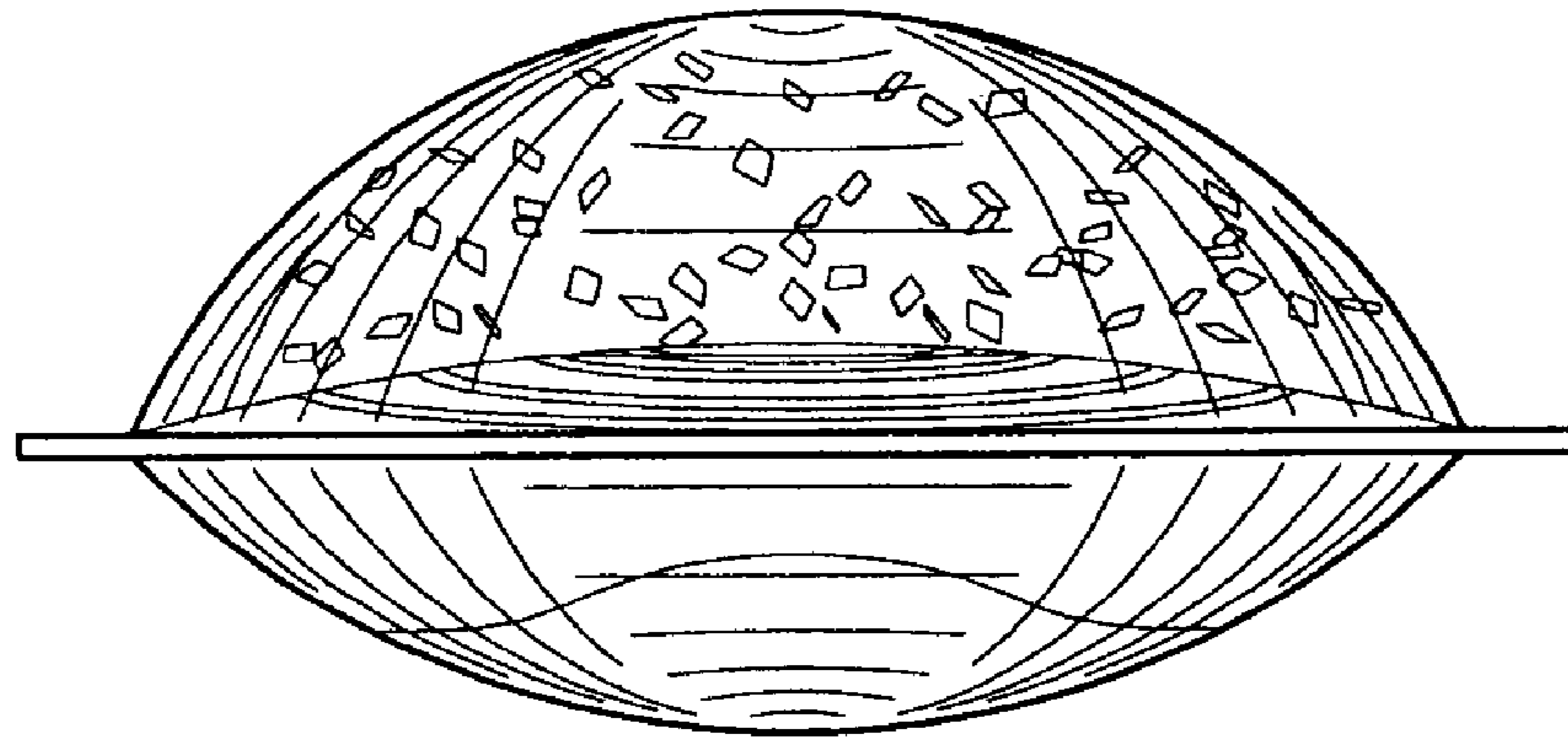

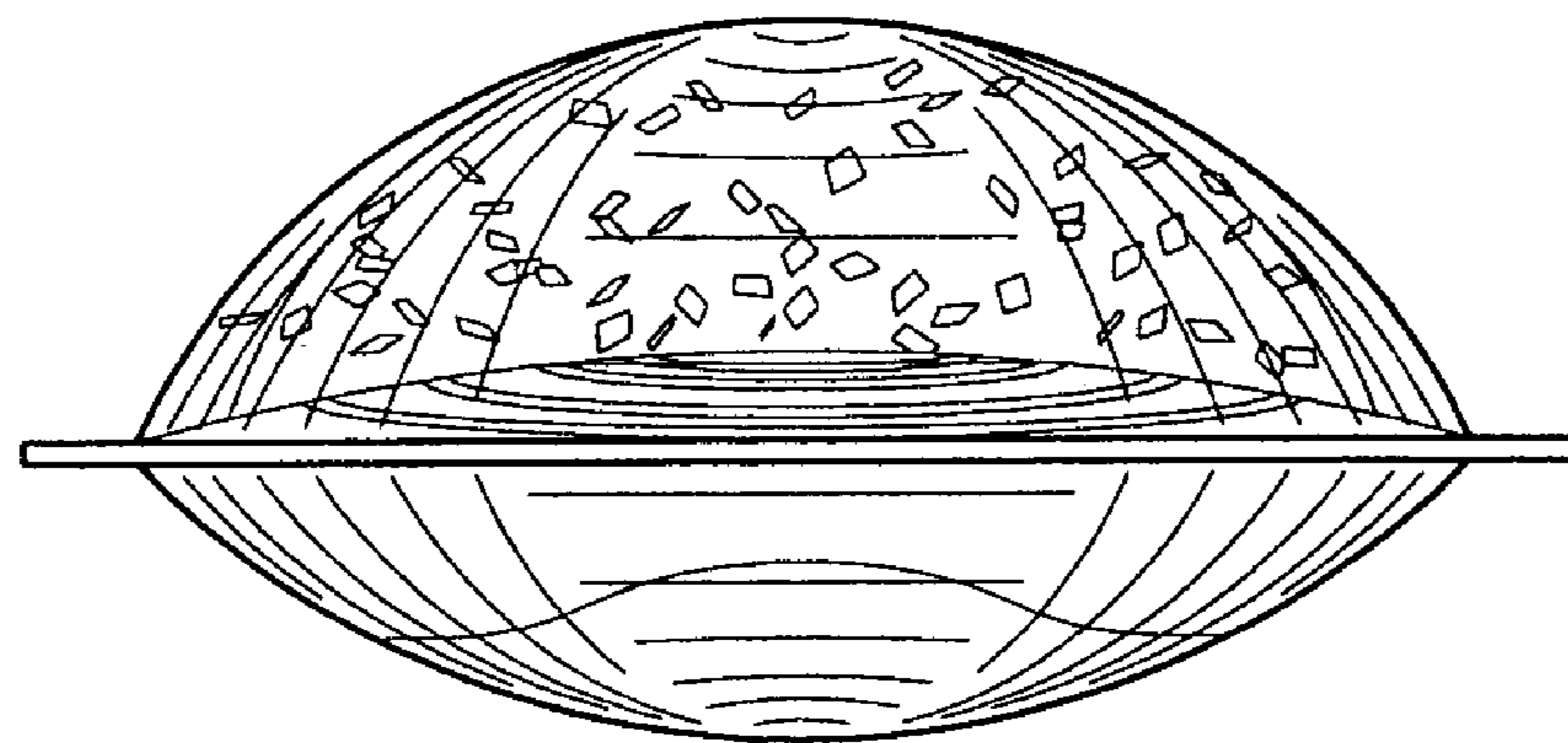

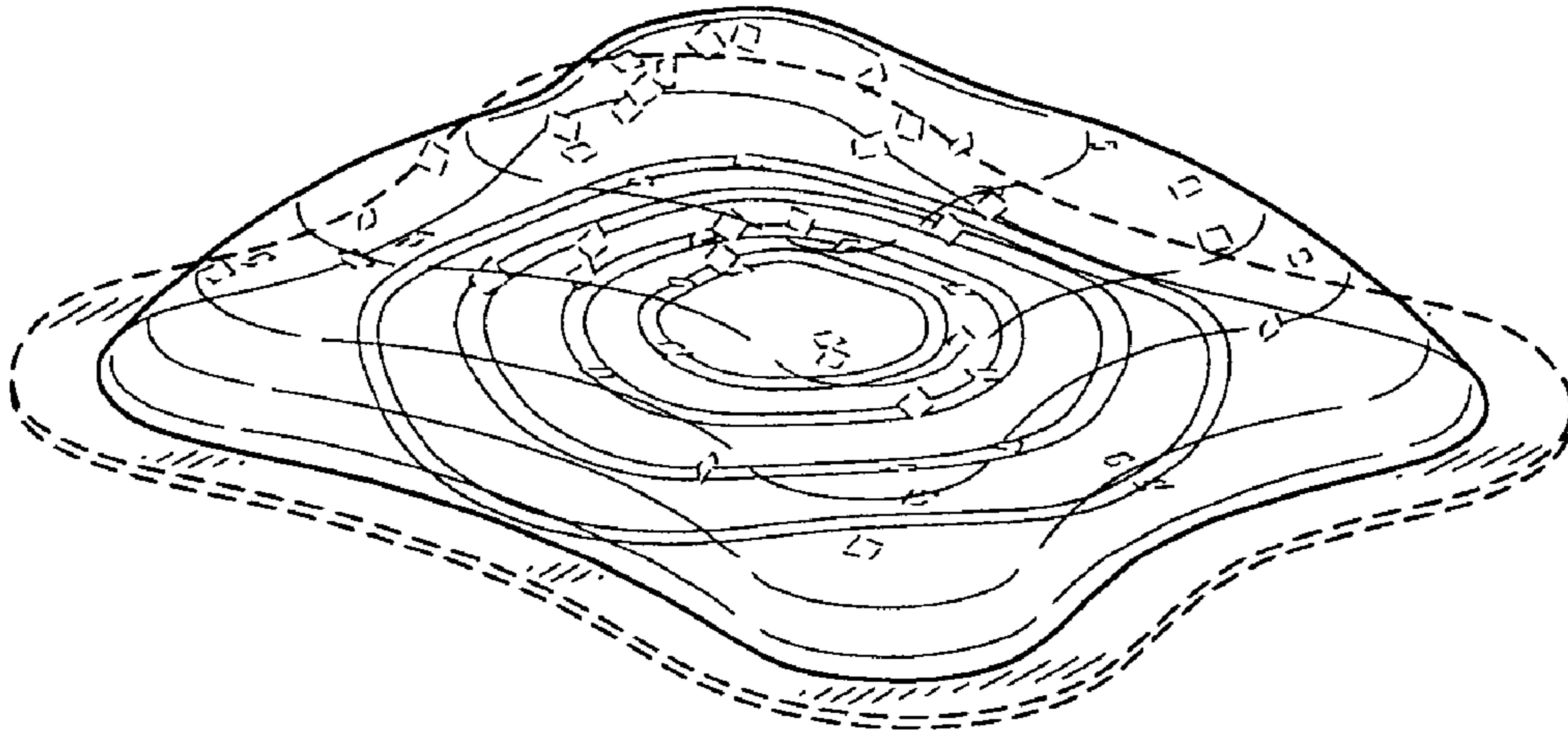

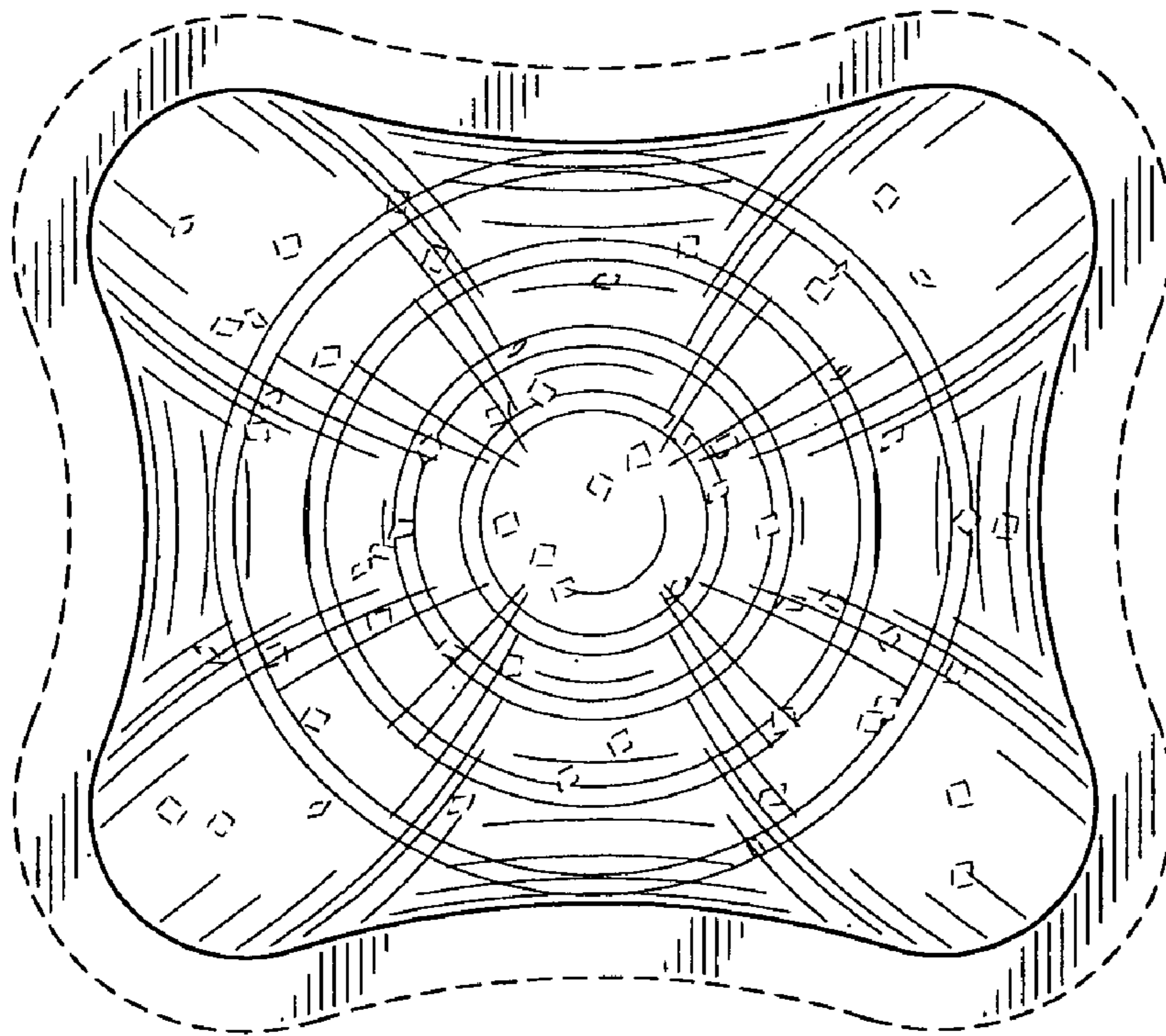

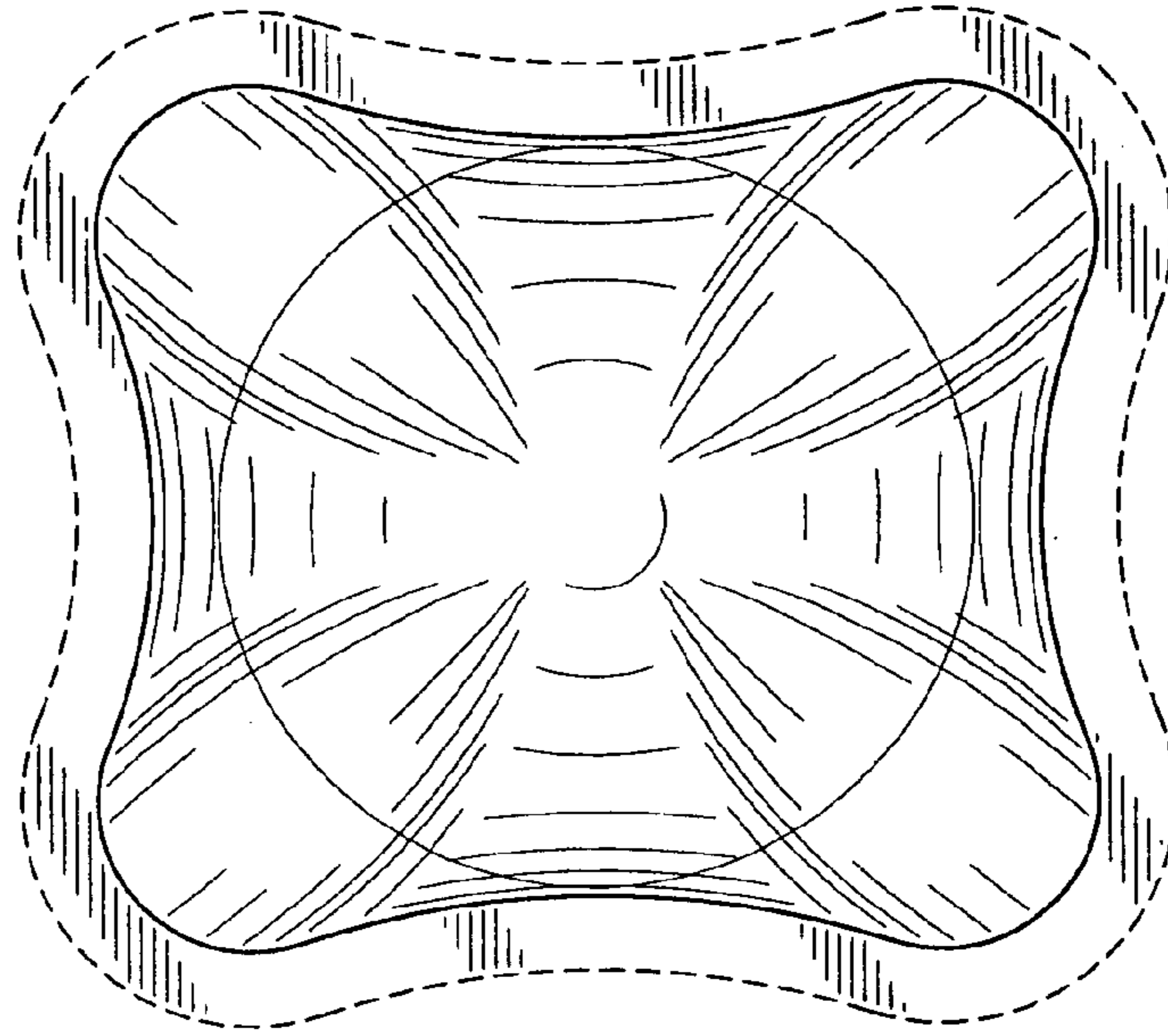

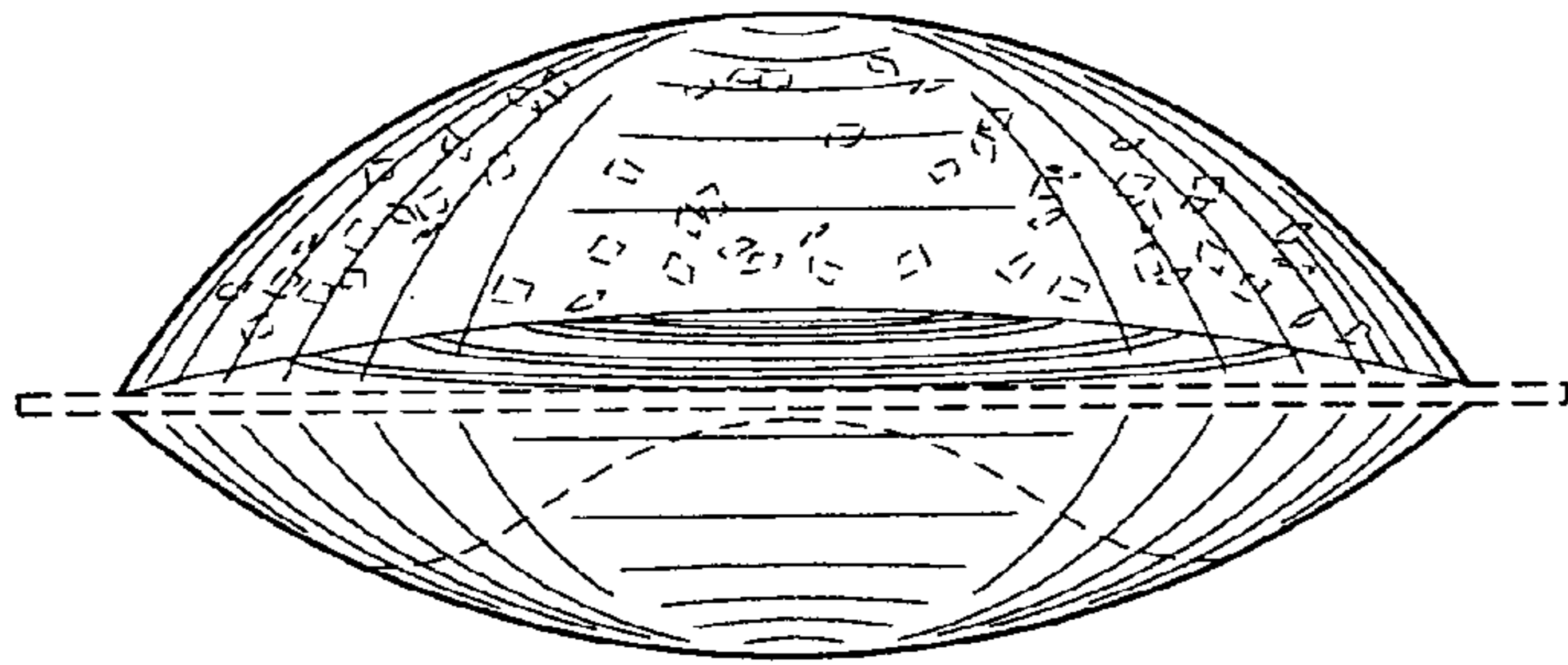

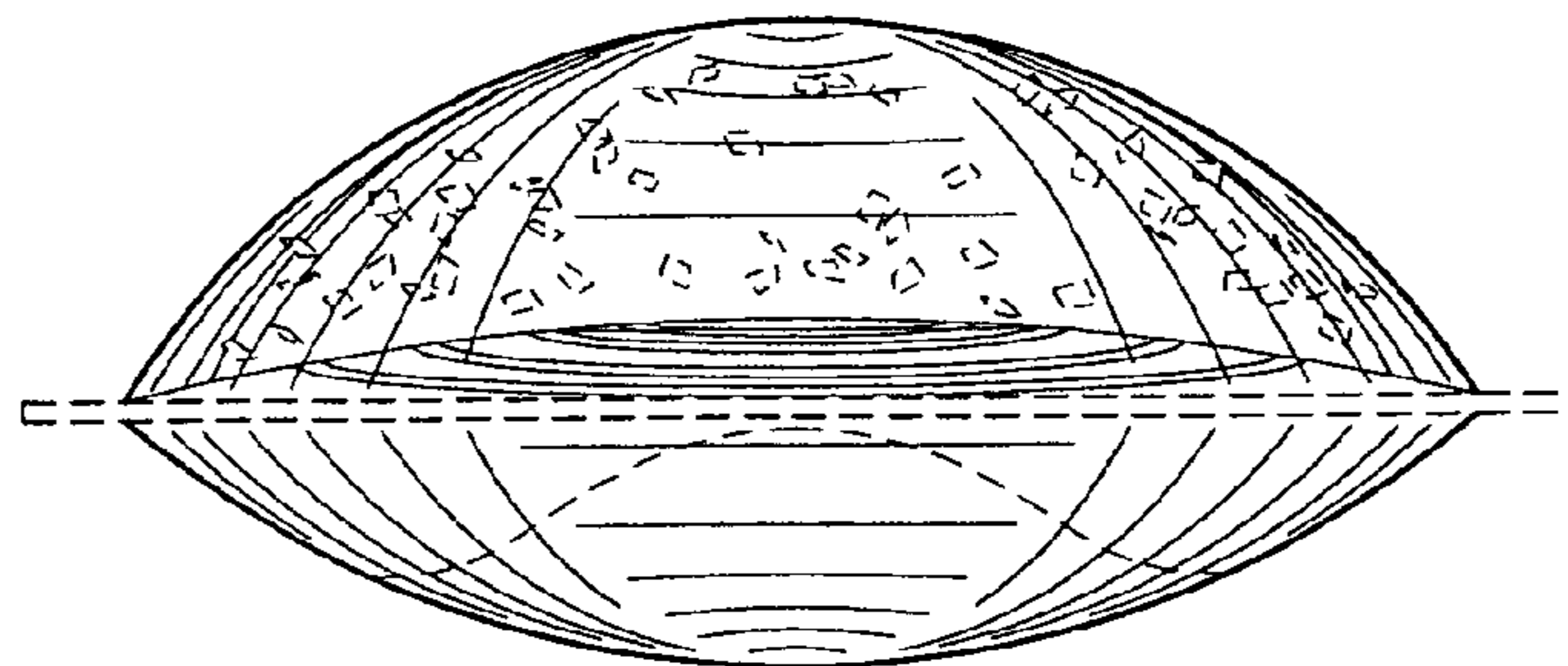

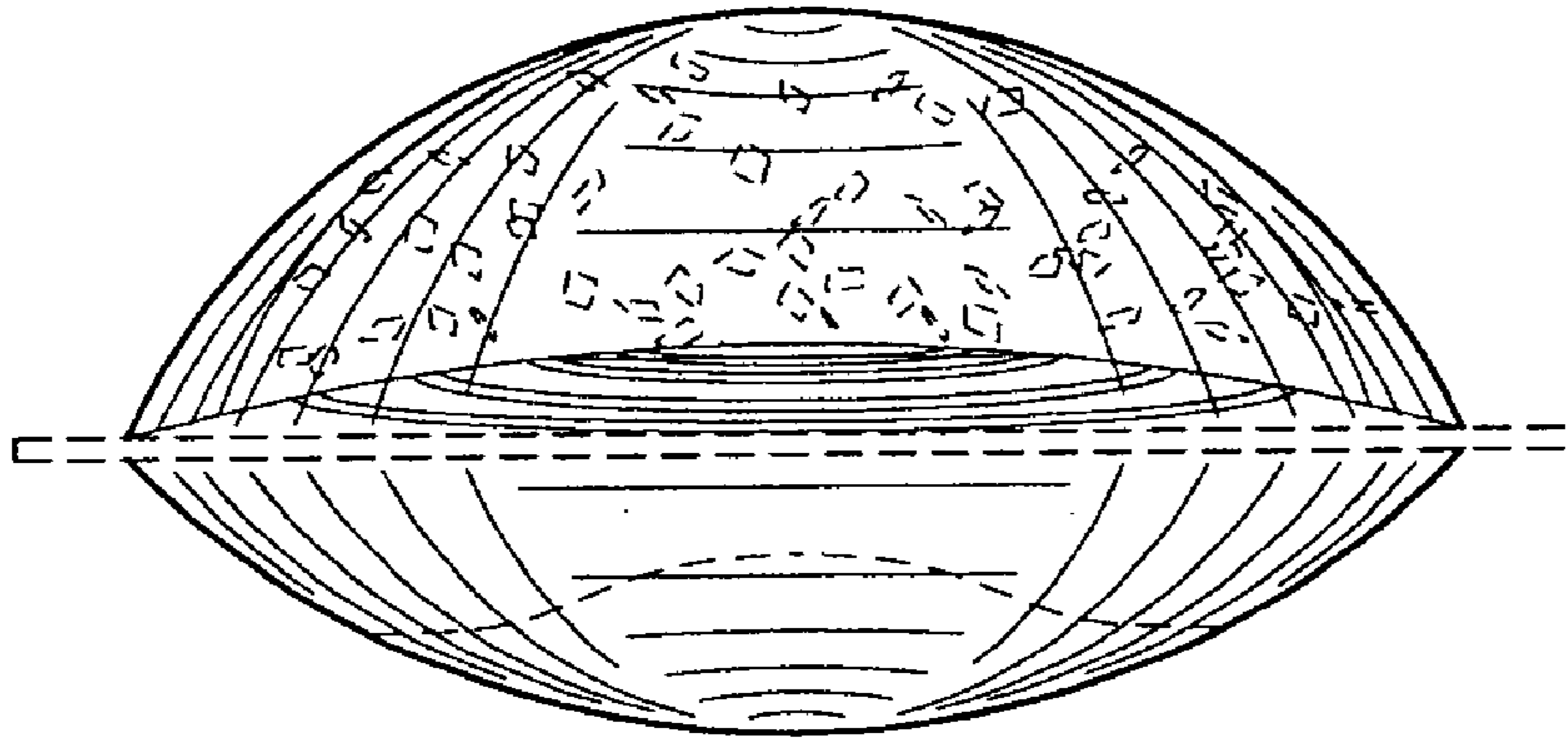

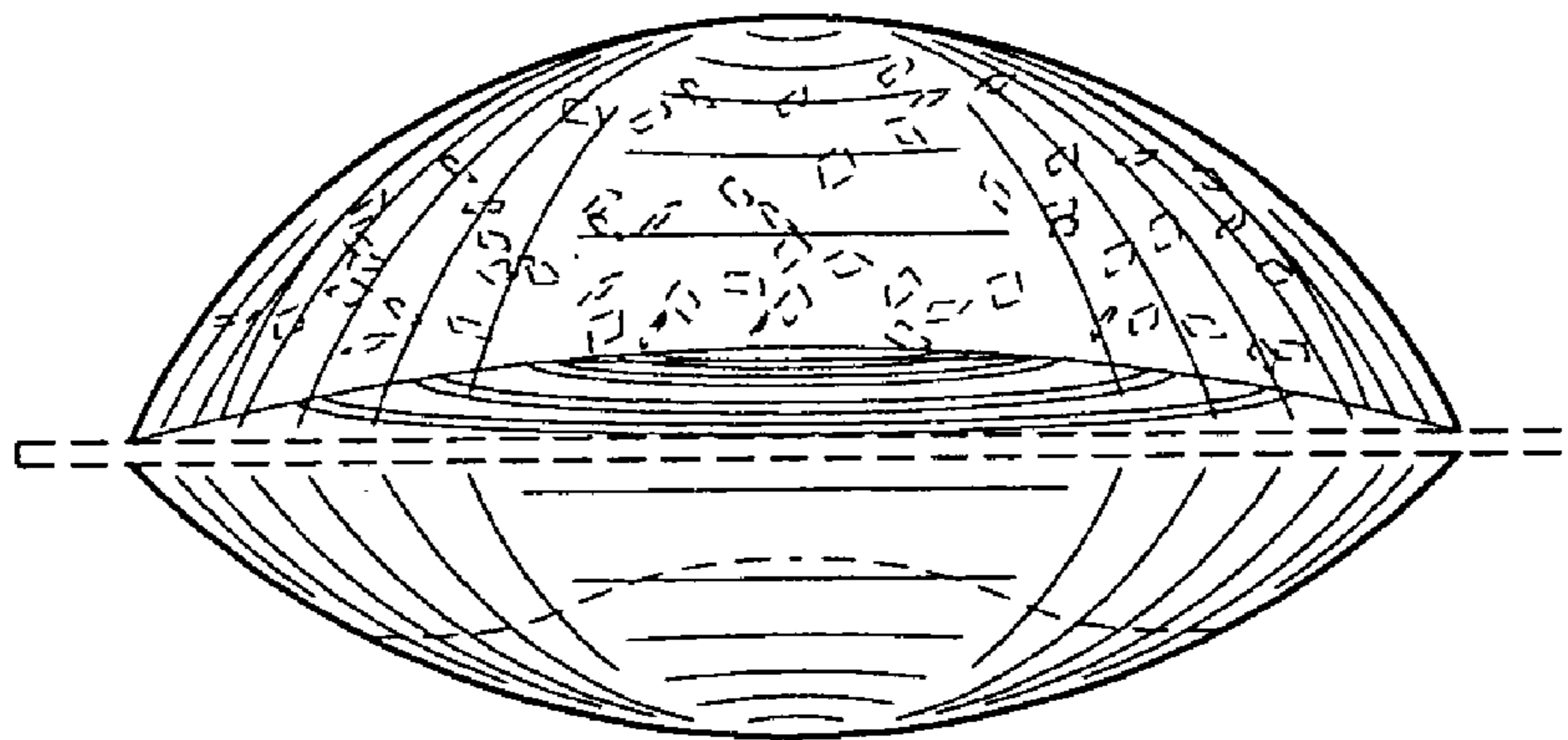
