We claim the ornamental design for a double dog bowl, as shown.

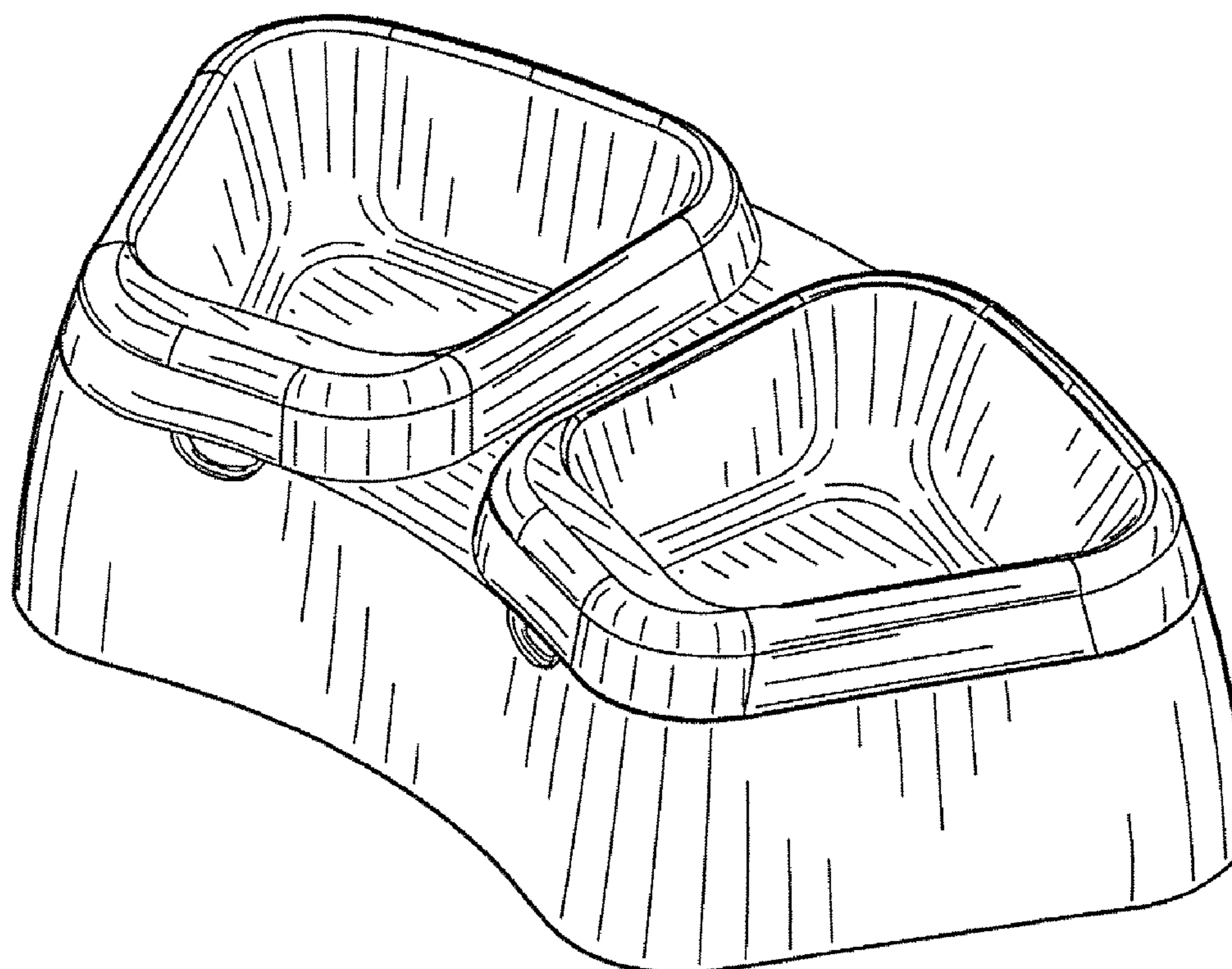

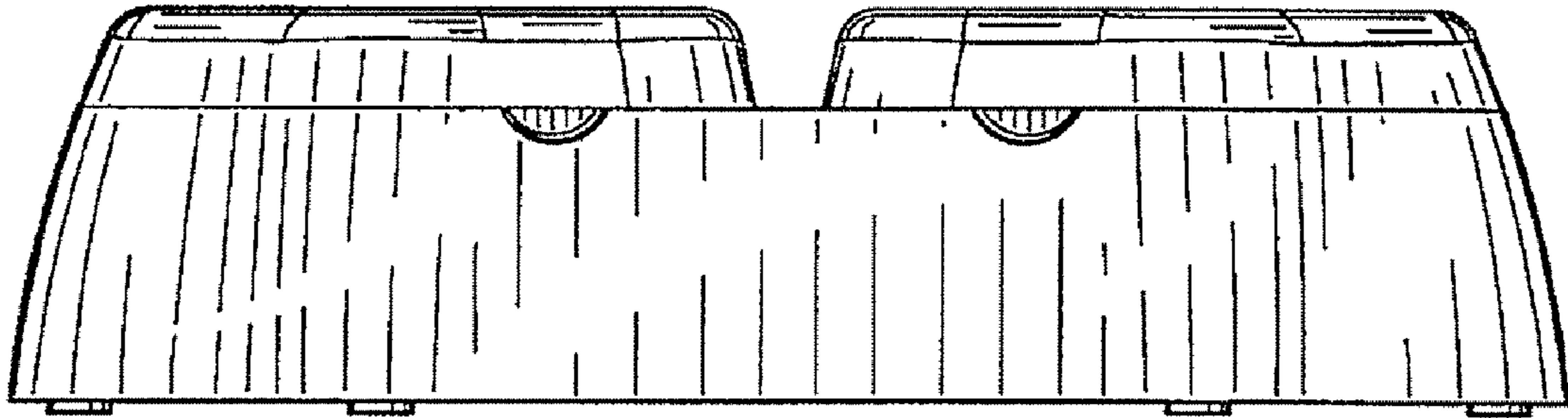

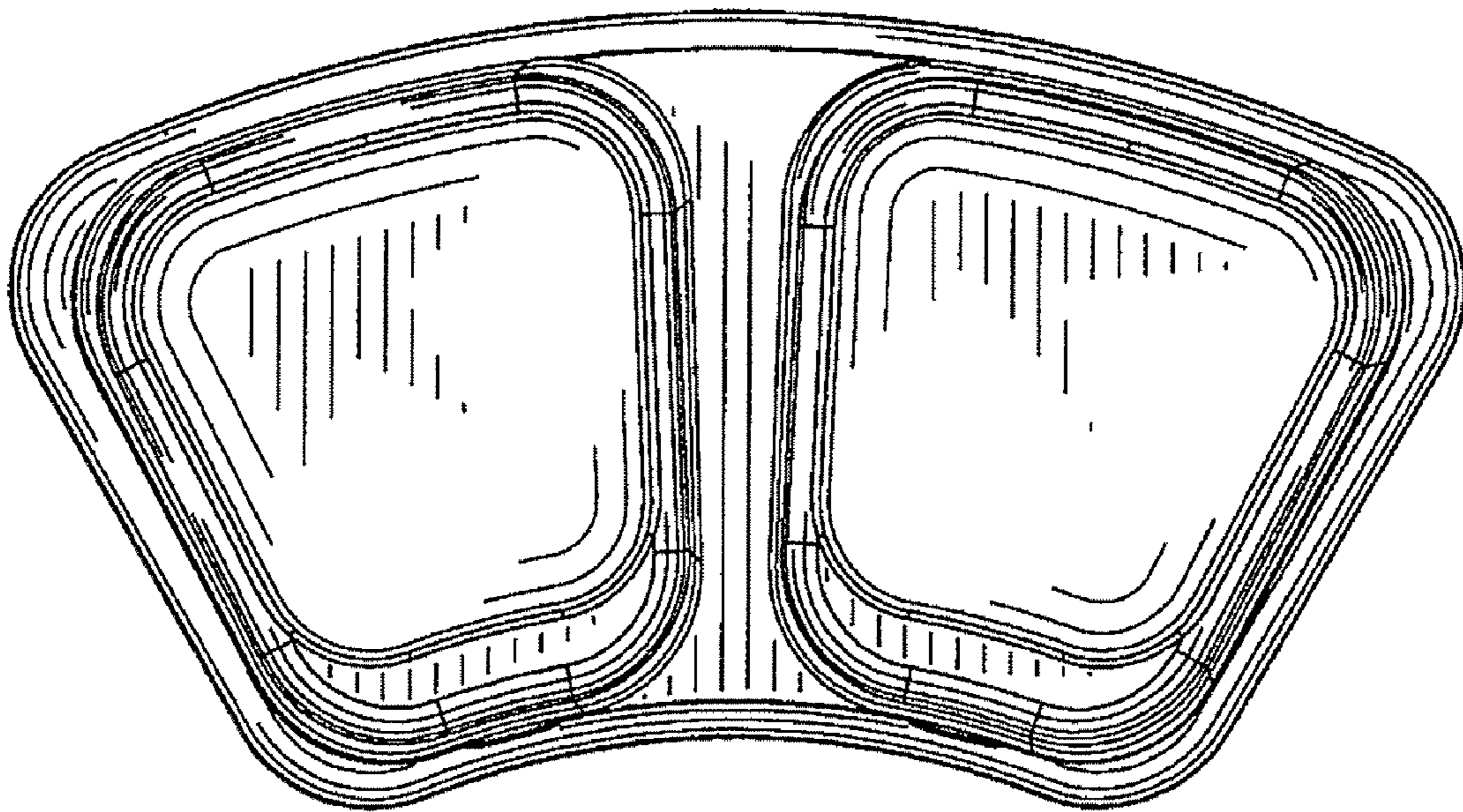

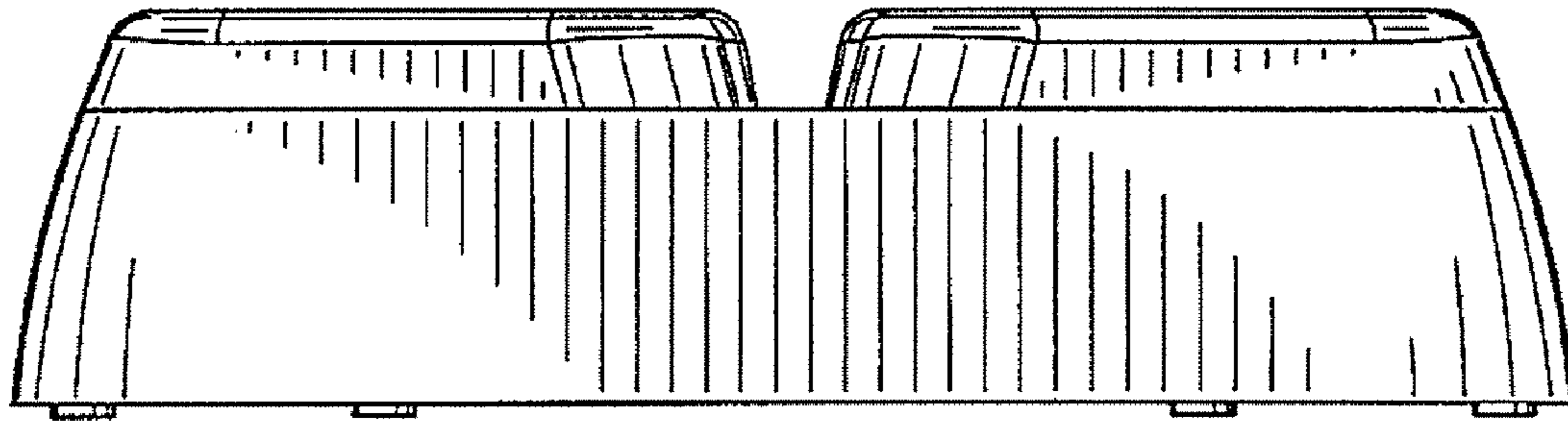

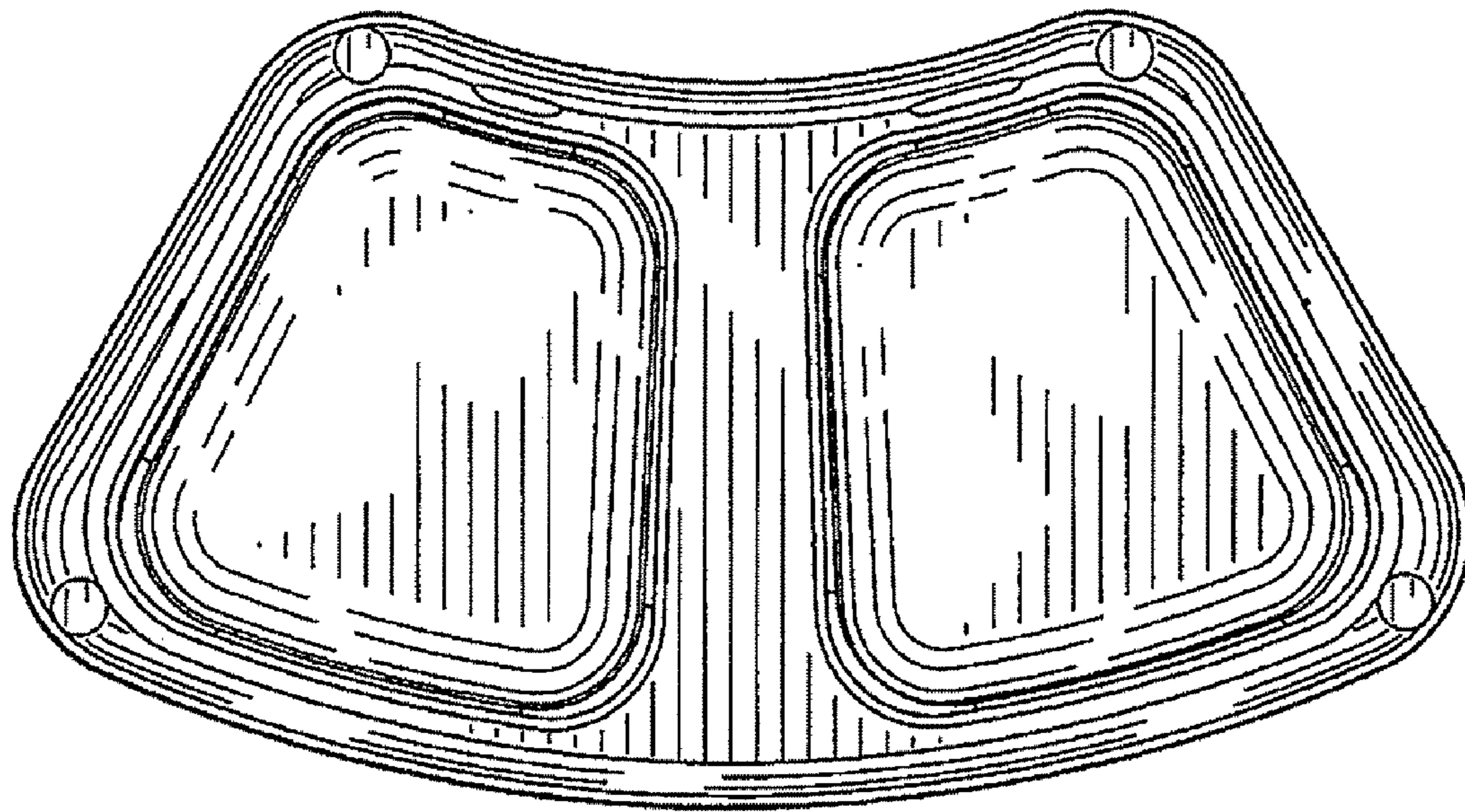

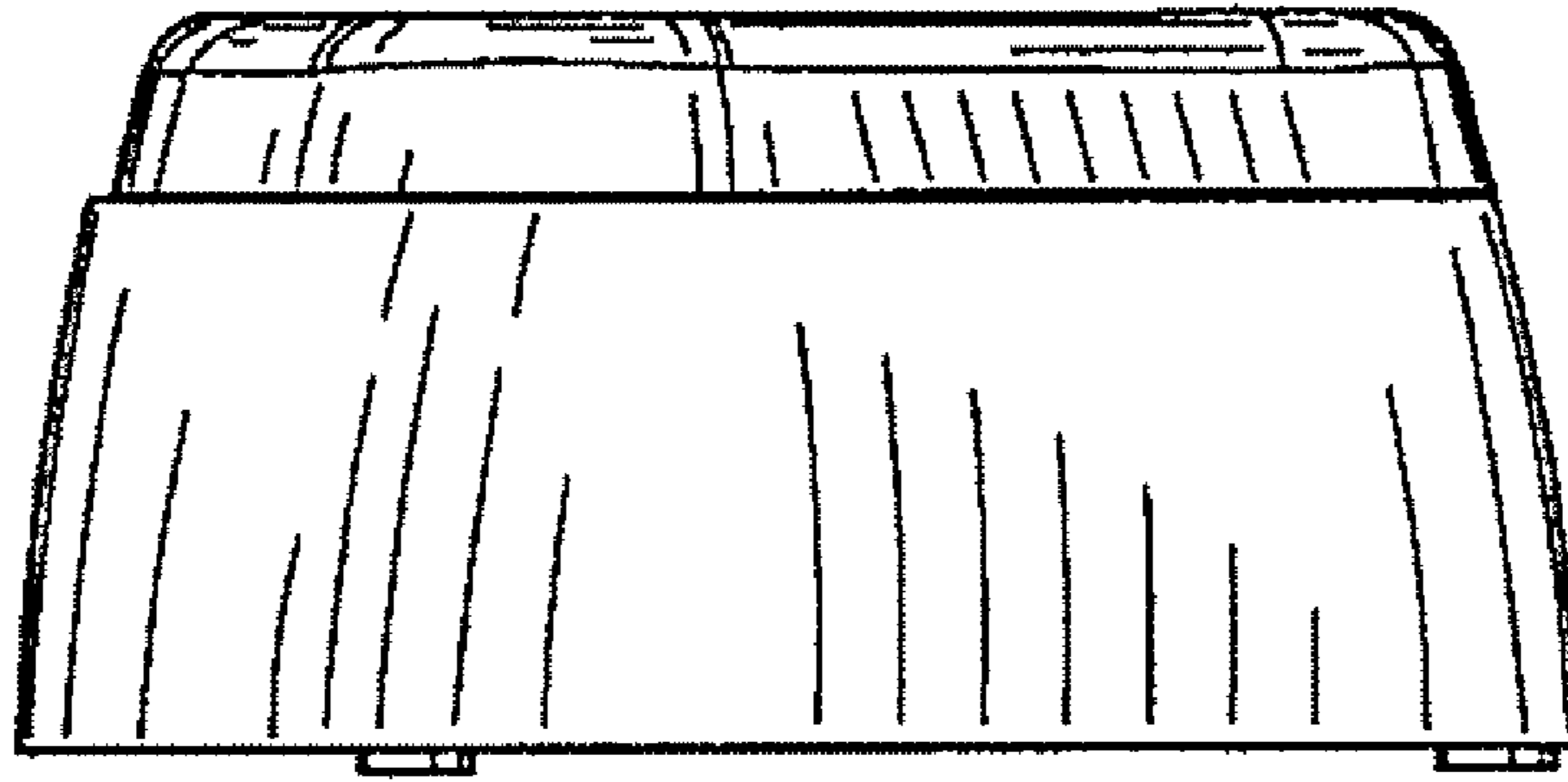

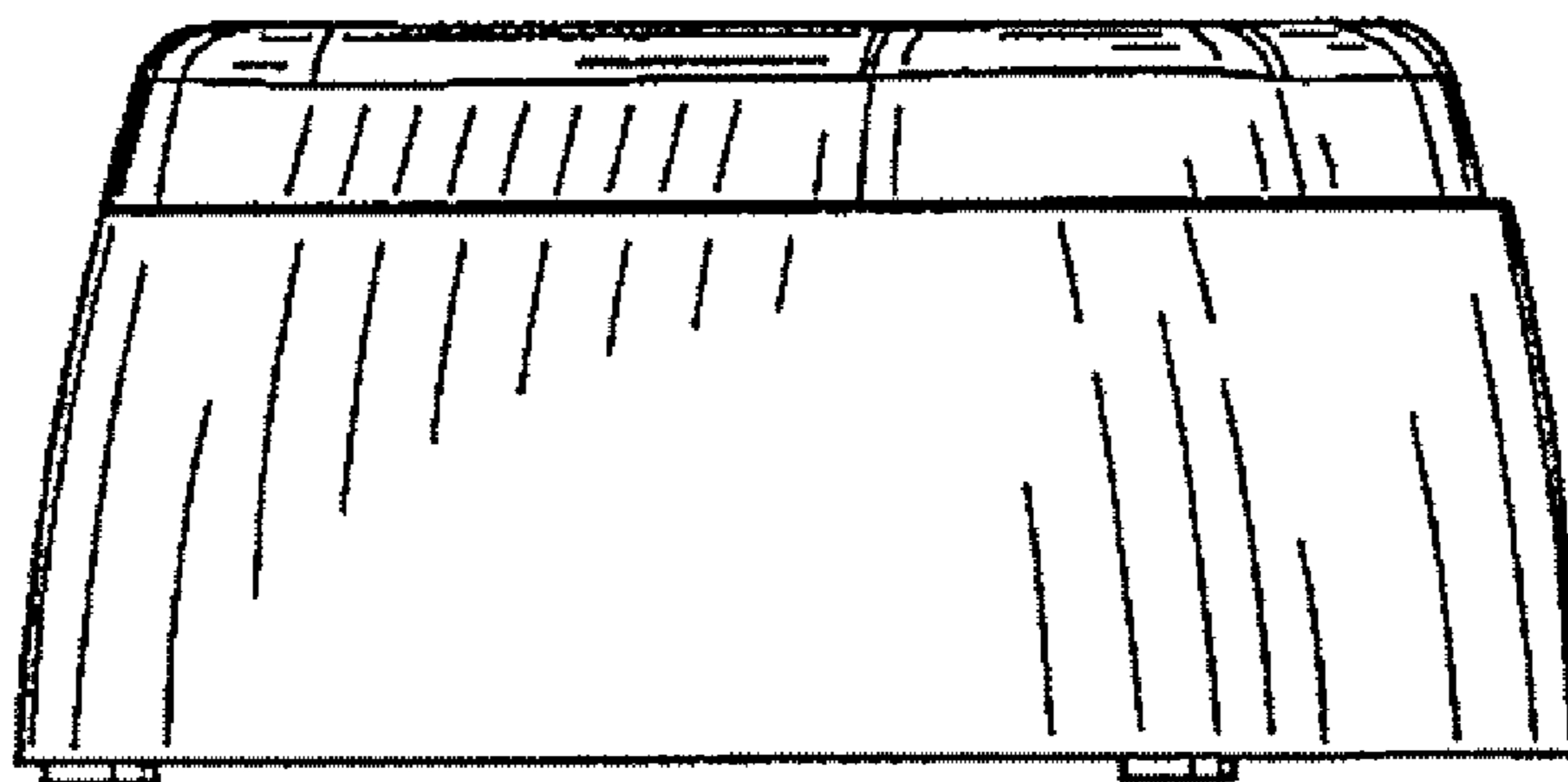

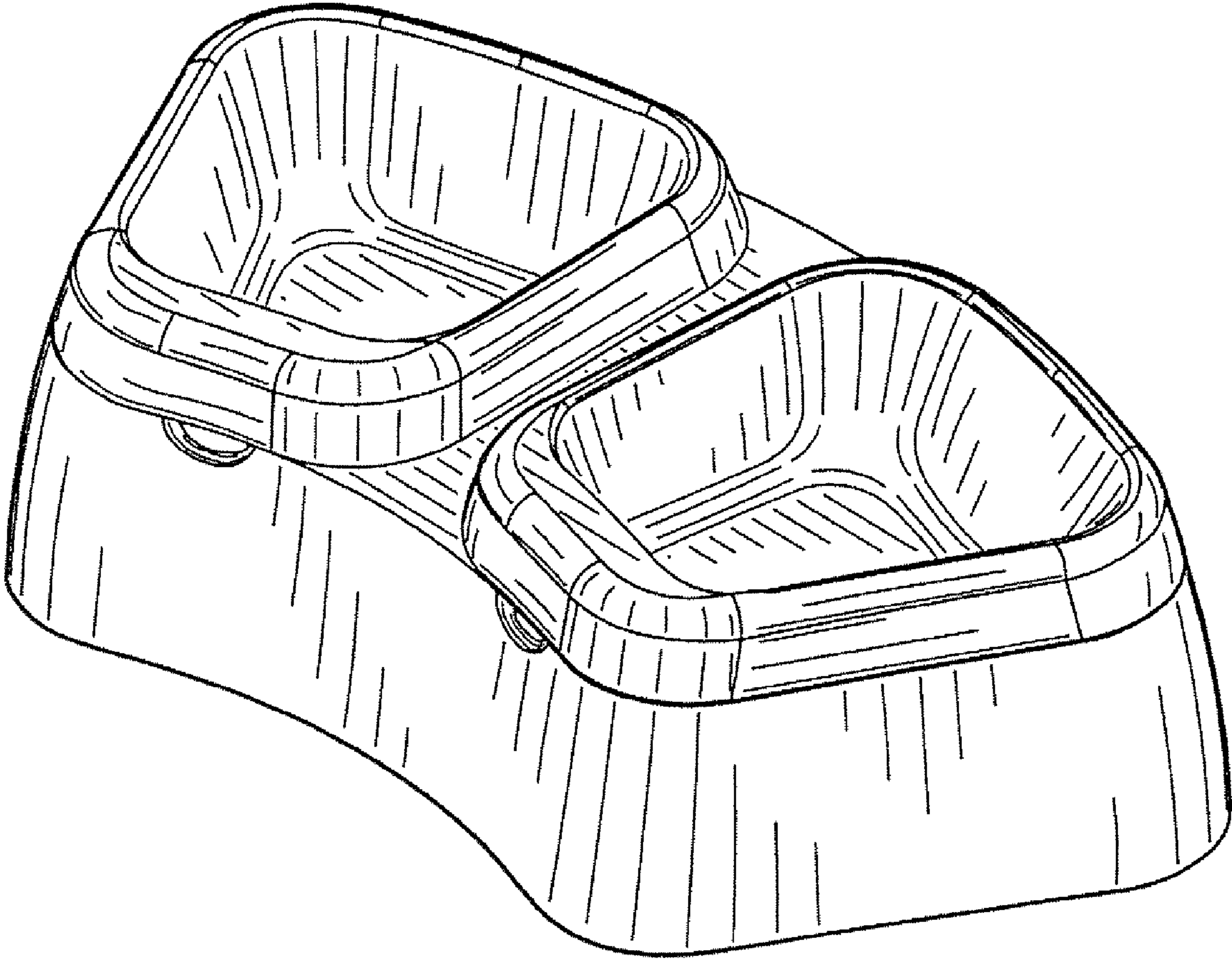
