(57) **CLAIM**

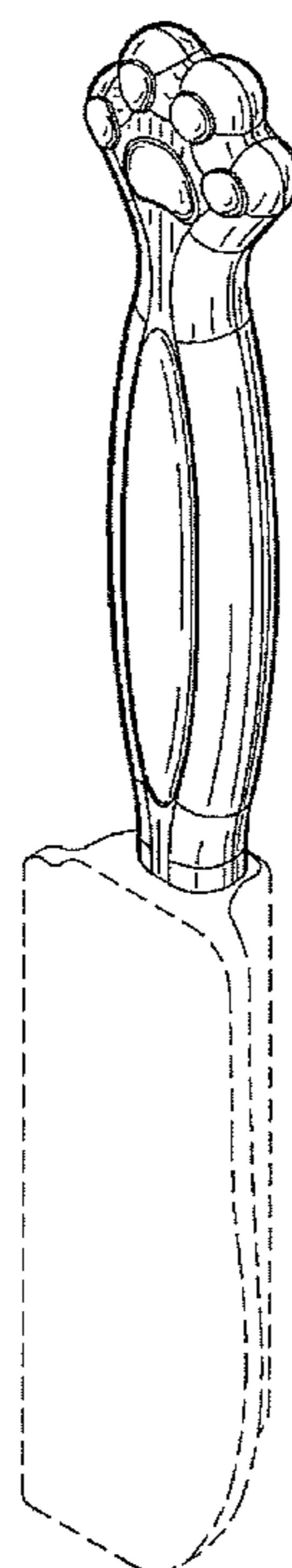
I claim the ornamental design for a pet utensil handle, as shown.

DESCRIPTION

FIG. 1 is a front view of the pet utensil handle;
FIG. 2 is a right side view of the pet utensil handle;
FIG. 3 is a bottom view of the pet utensil handle;
FIG. 4 is a back view of the pet utensil handle;
FIG. 5 is a left side view of the pet utensil handle;

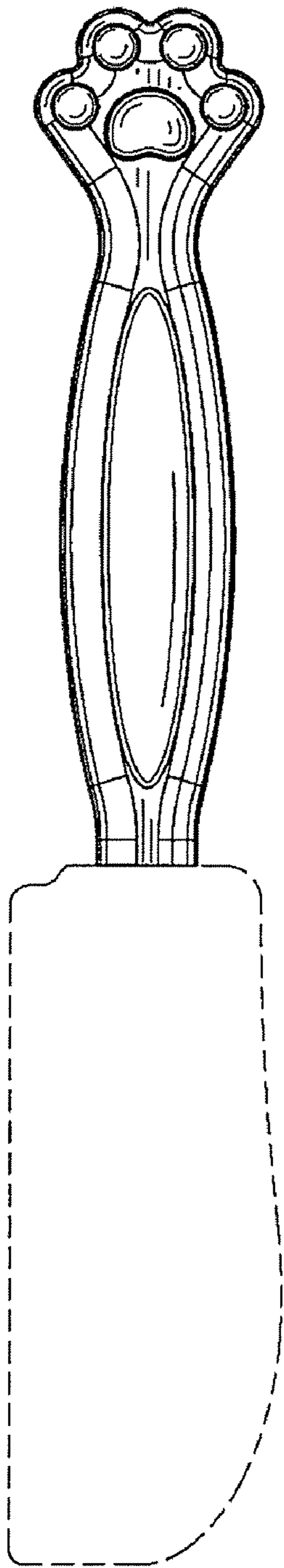

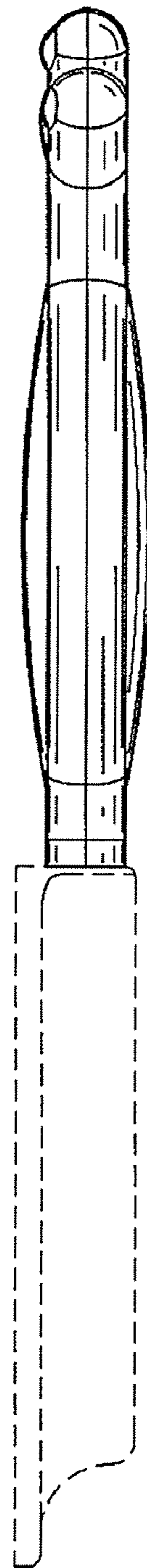

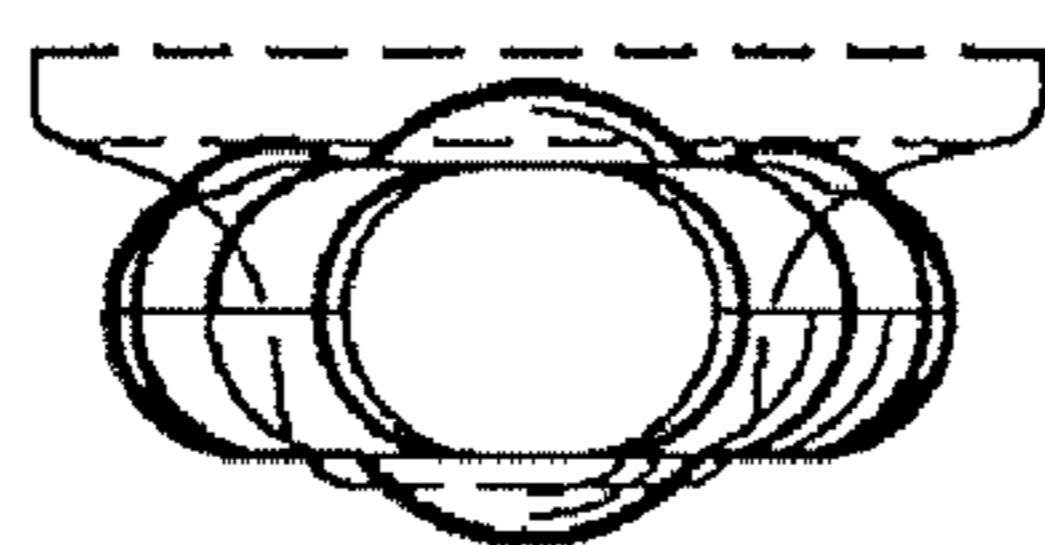

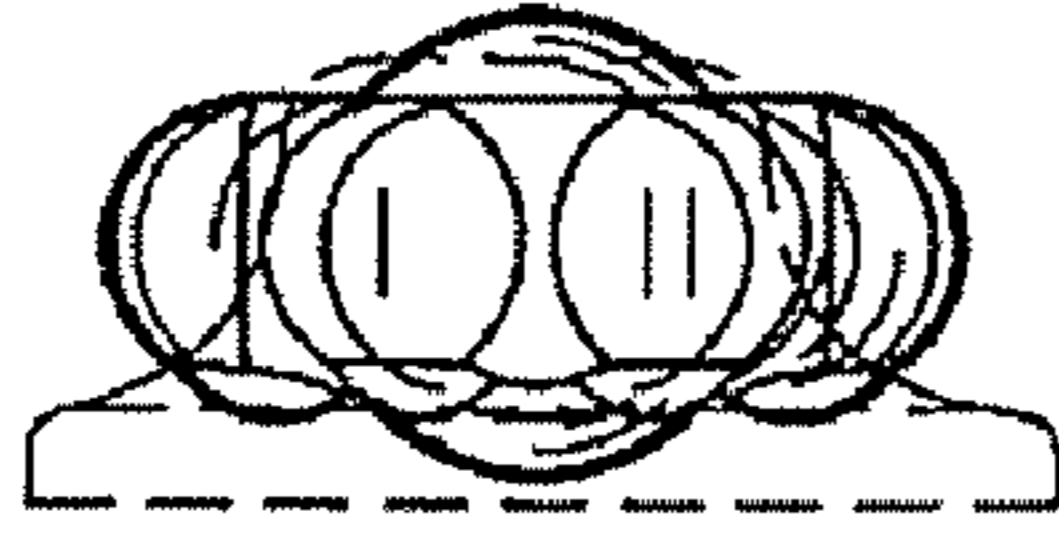

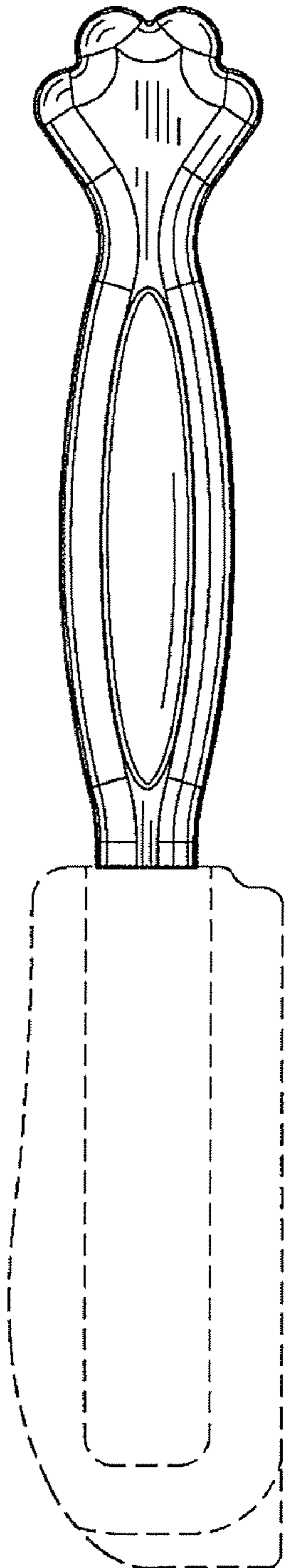

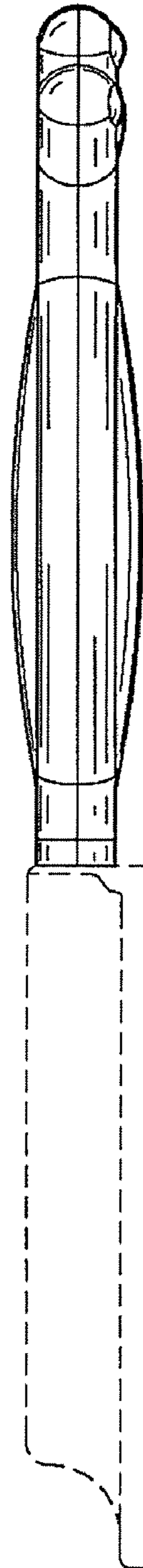

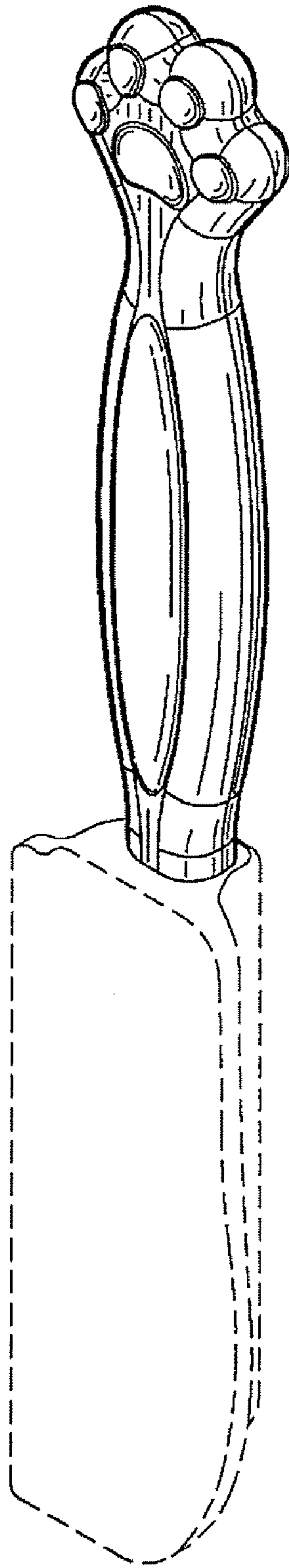
