FIG. 2 is a front view of FIG. 1;

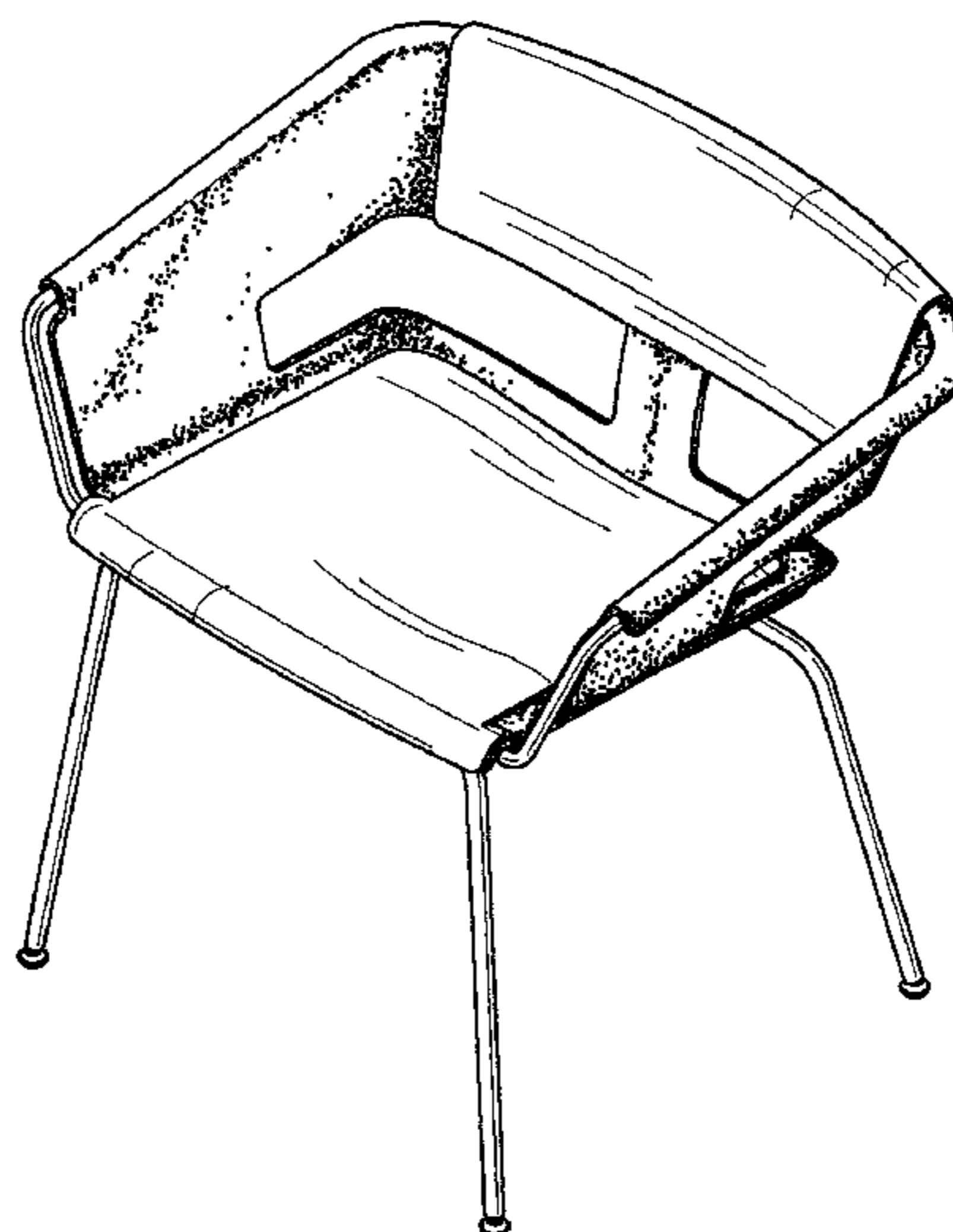
FIG. 3 is a right side view of FIG. 1, the left side being a mirror image thereof;

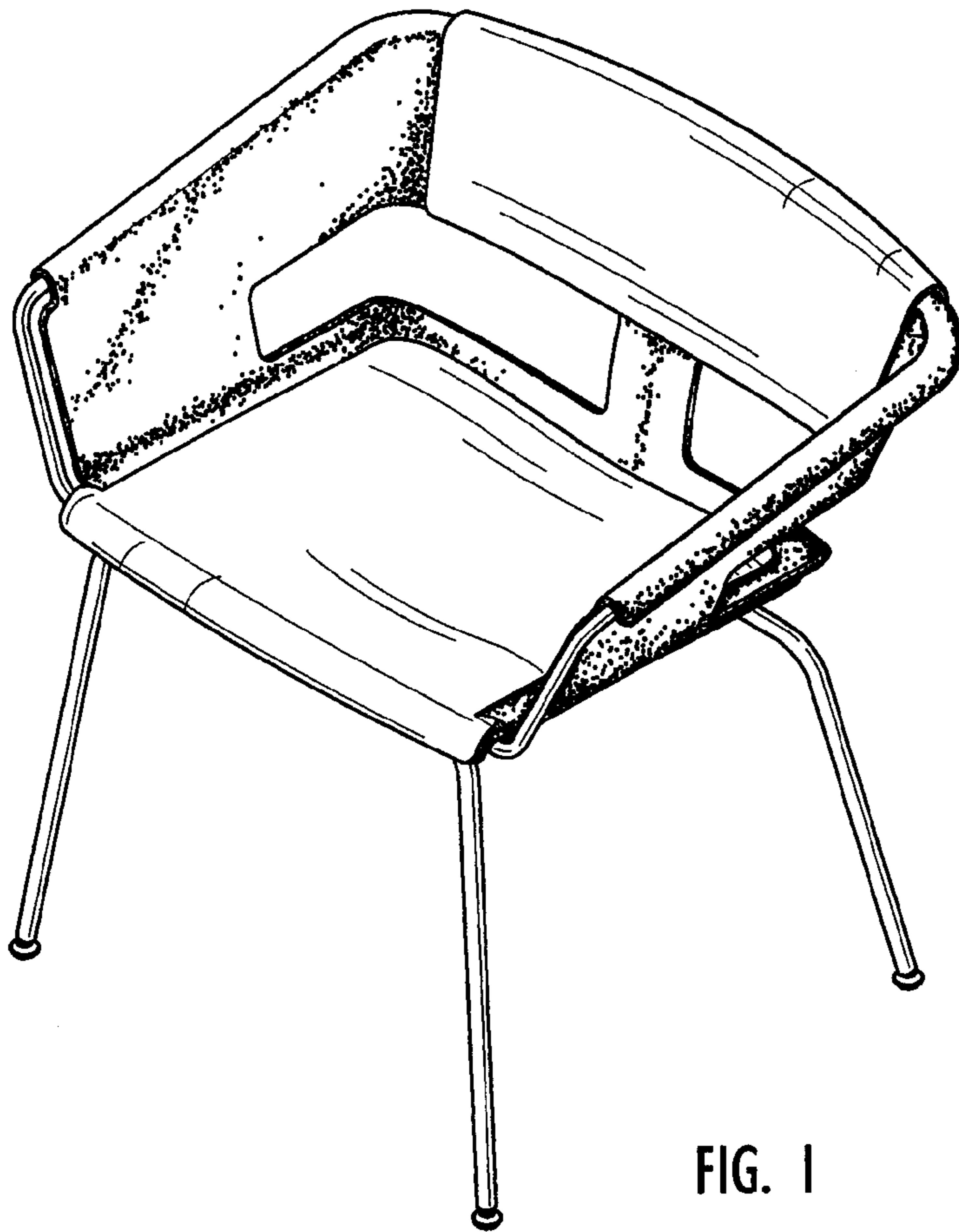

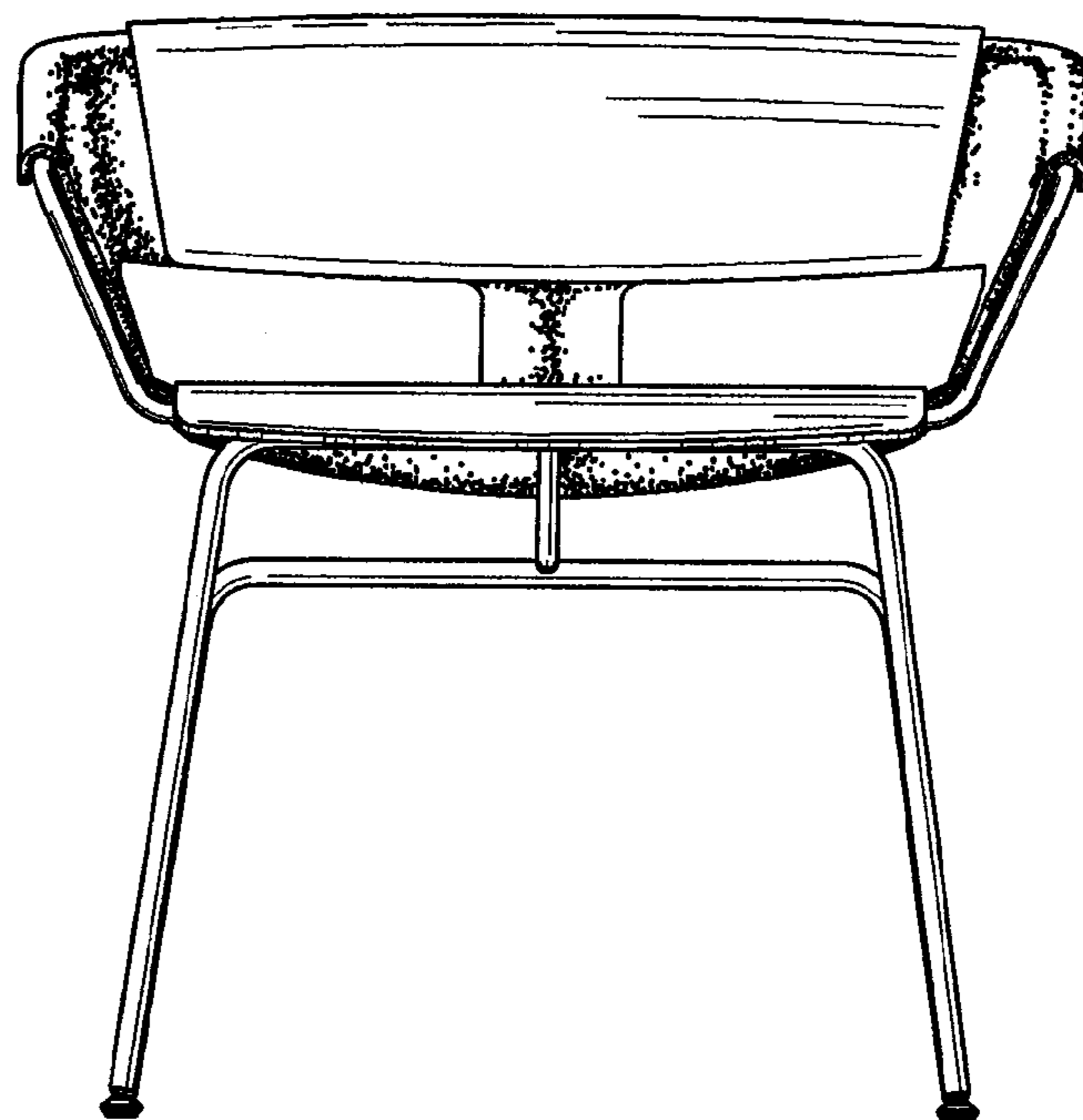

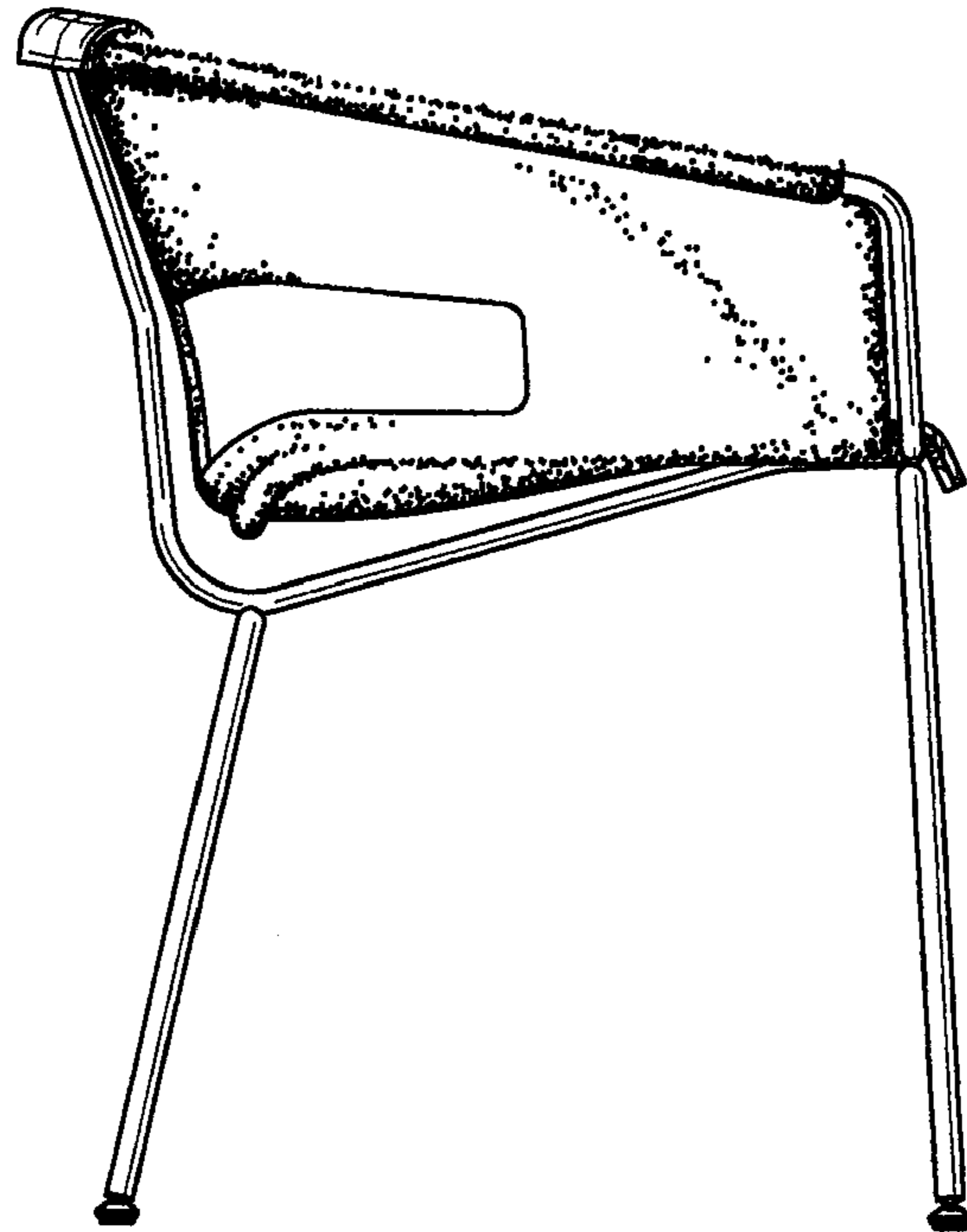

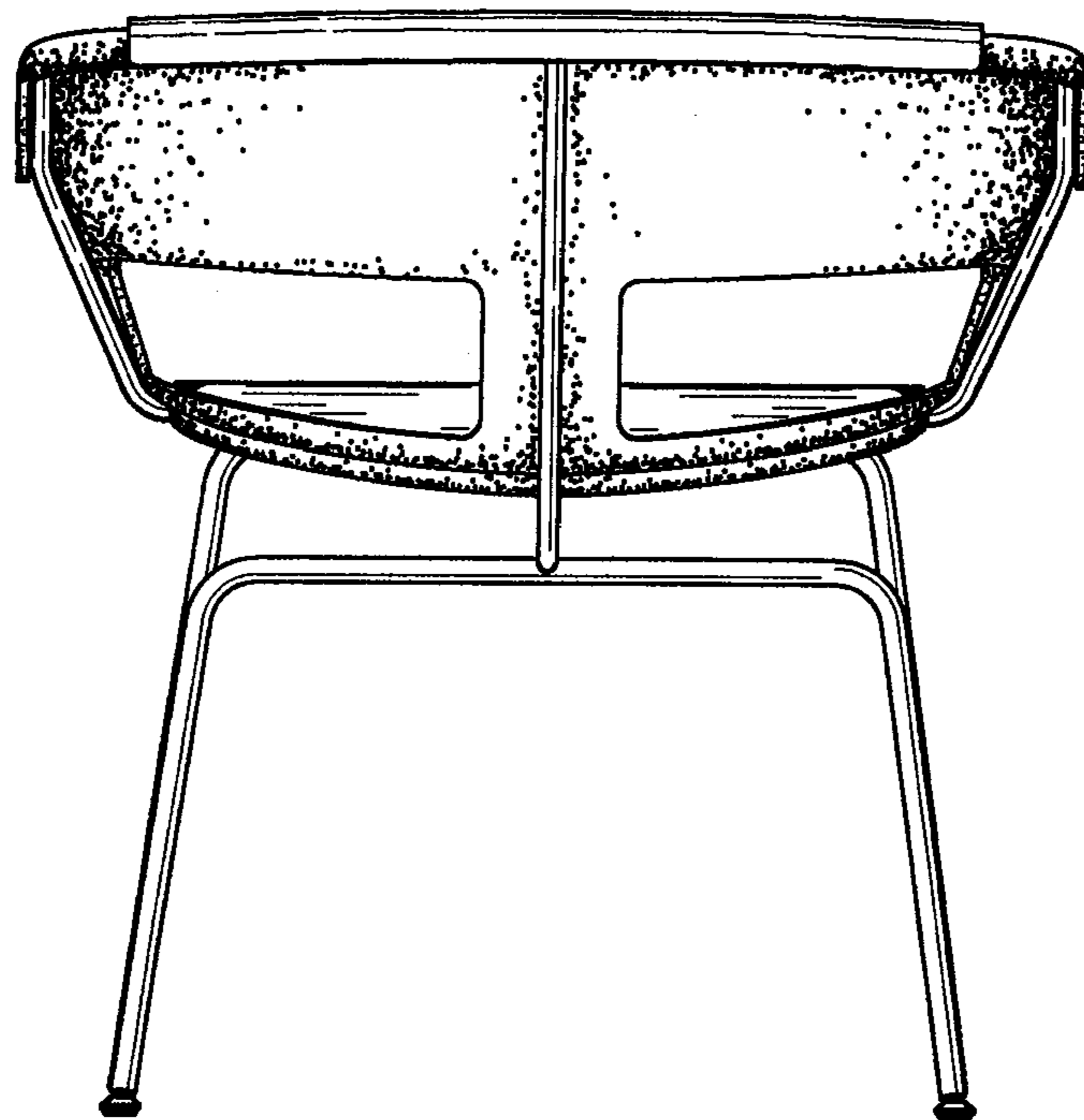

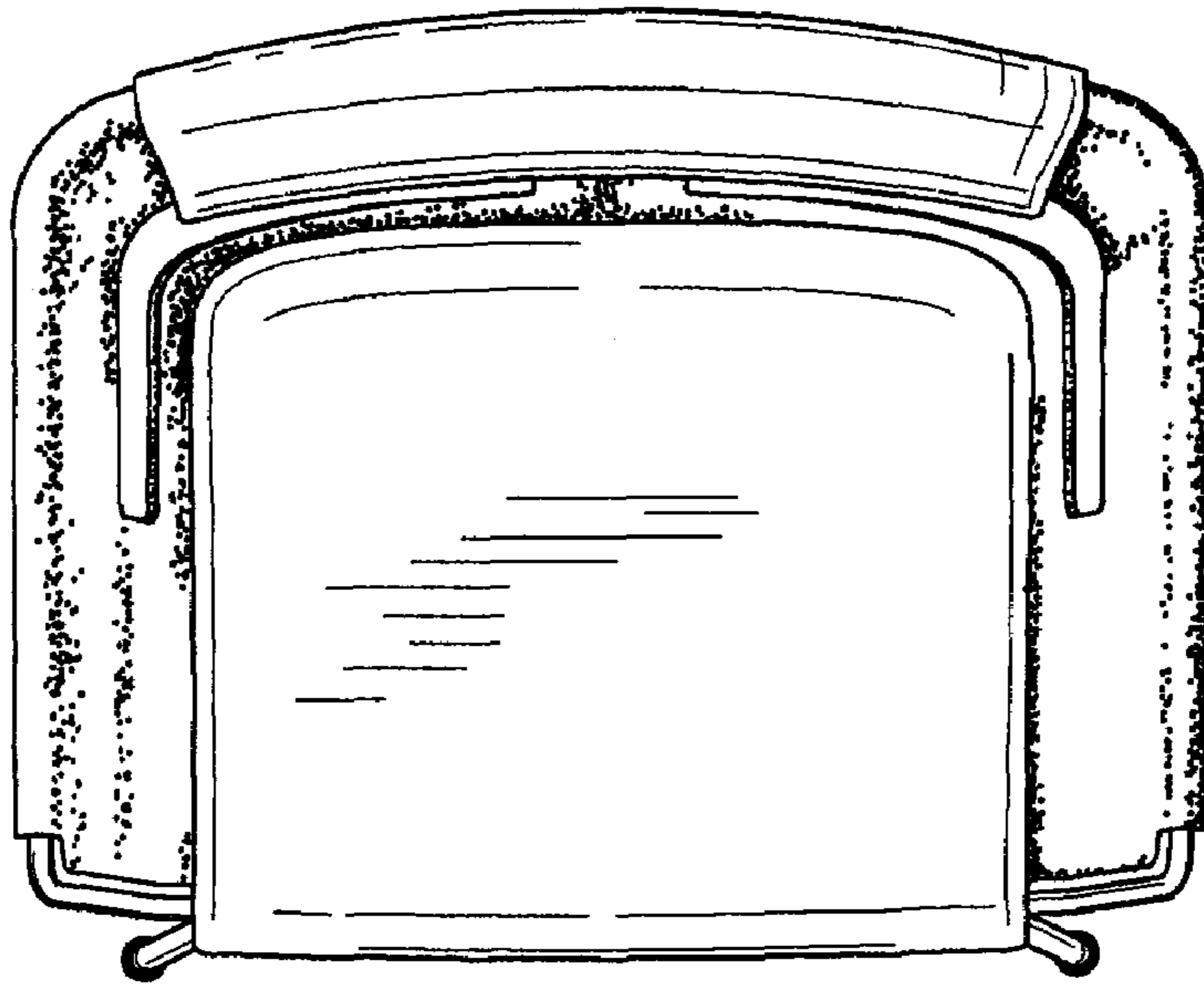

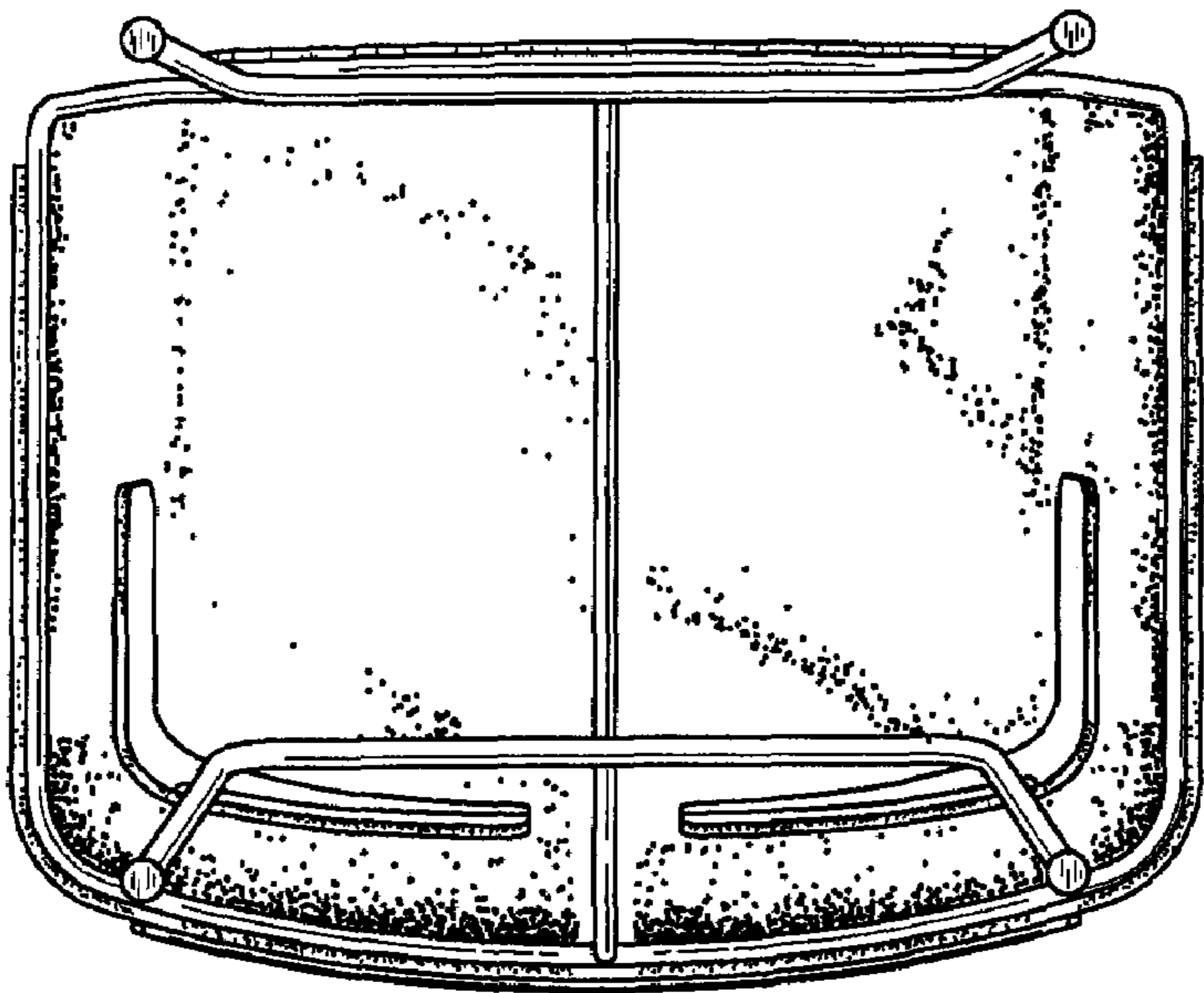
