(57) **CLAIM**

The ornamental design for a reversible ratcheting wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a reversible ratcheting wrench showing the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 11 is a left side elevational view thereof;

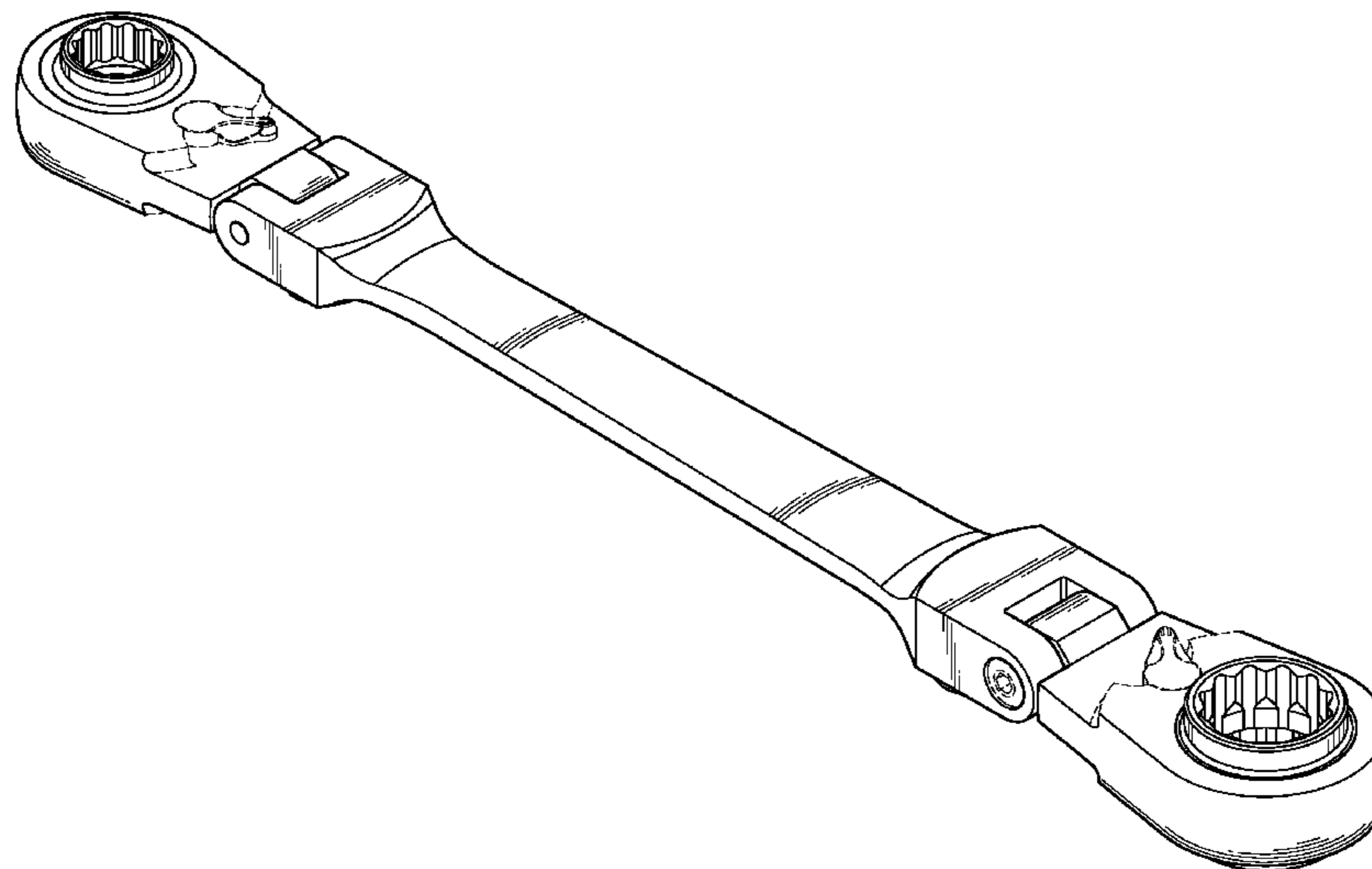
FIG. 12 is a right side elevational view thereof;

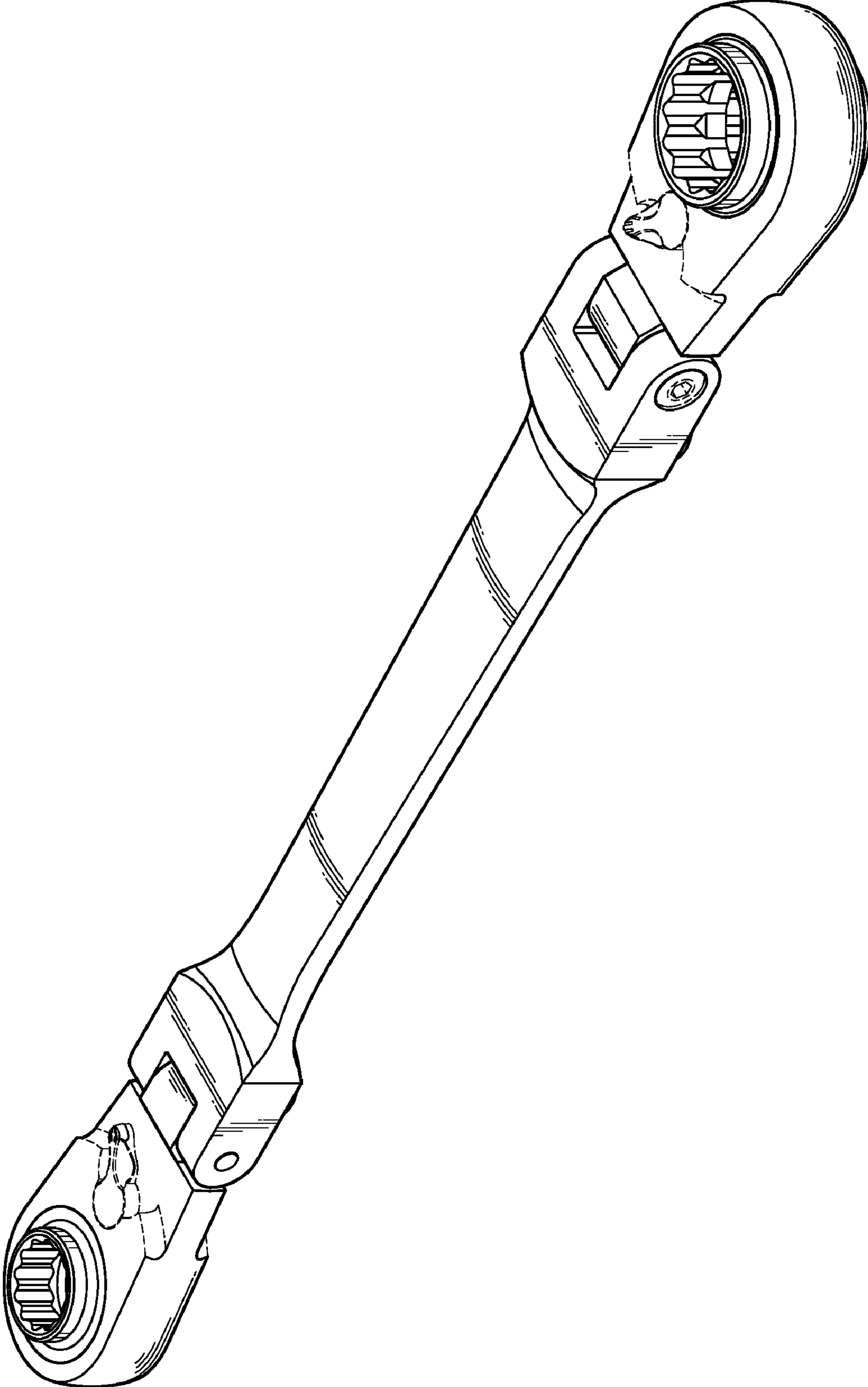

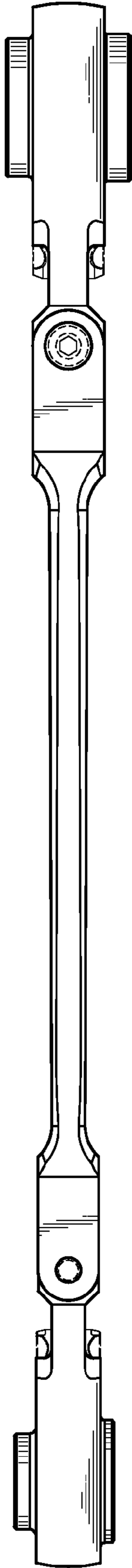

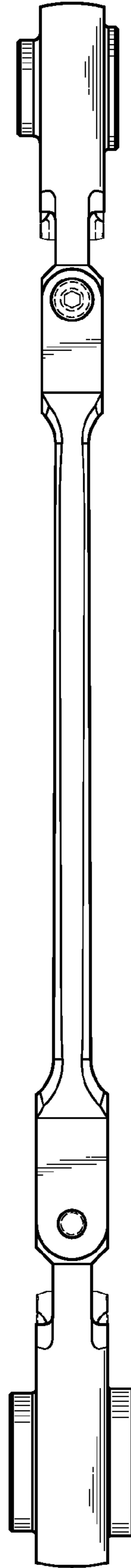

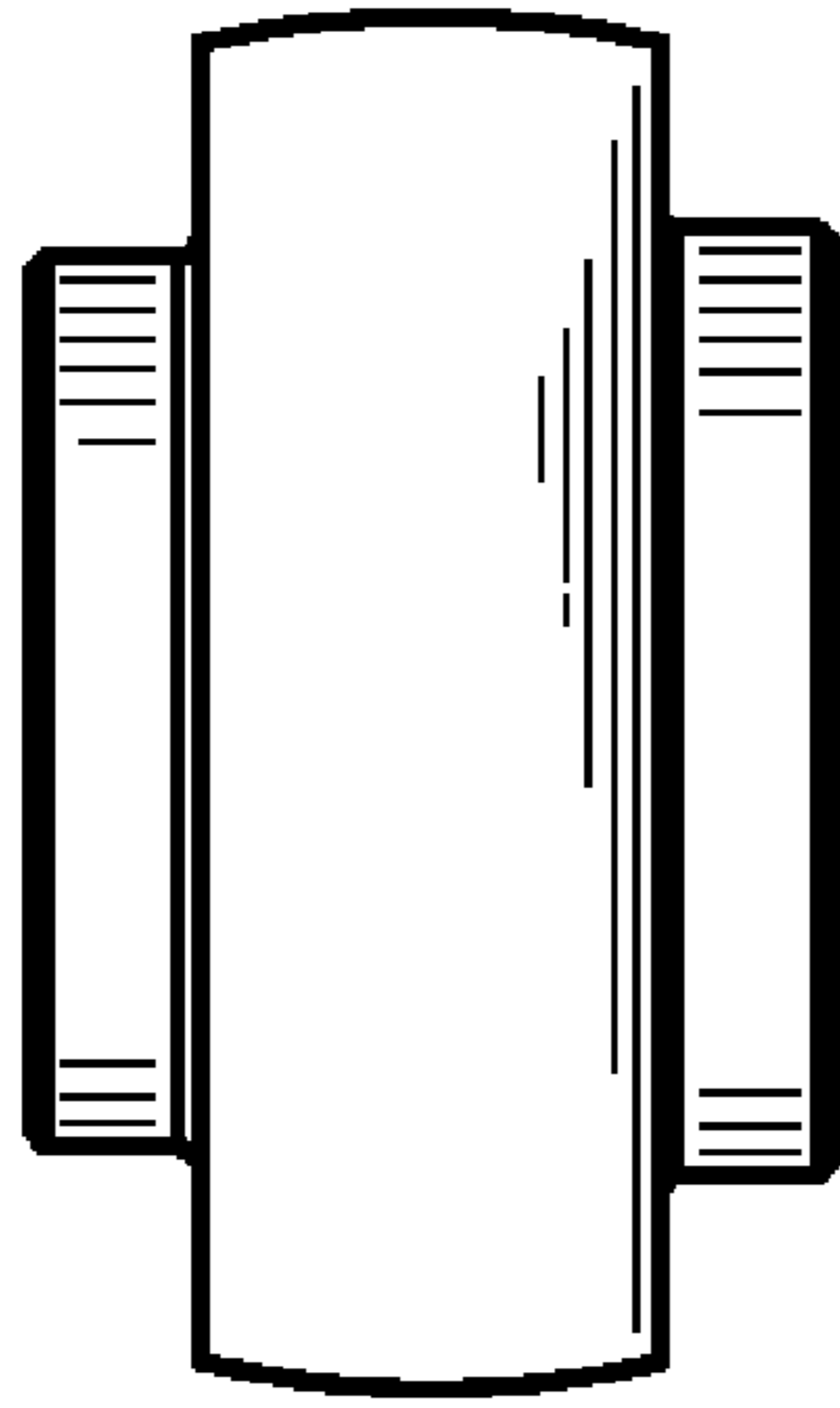

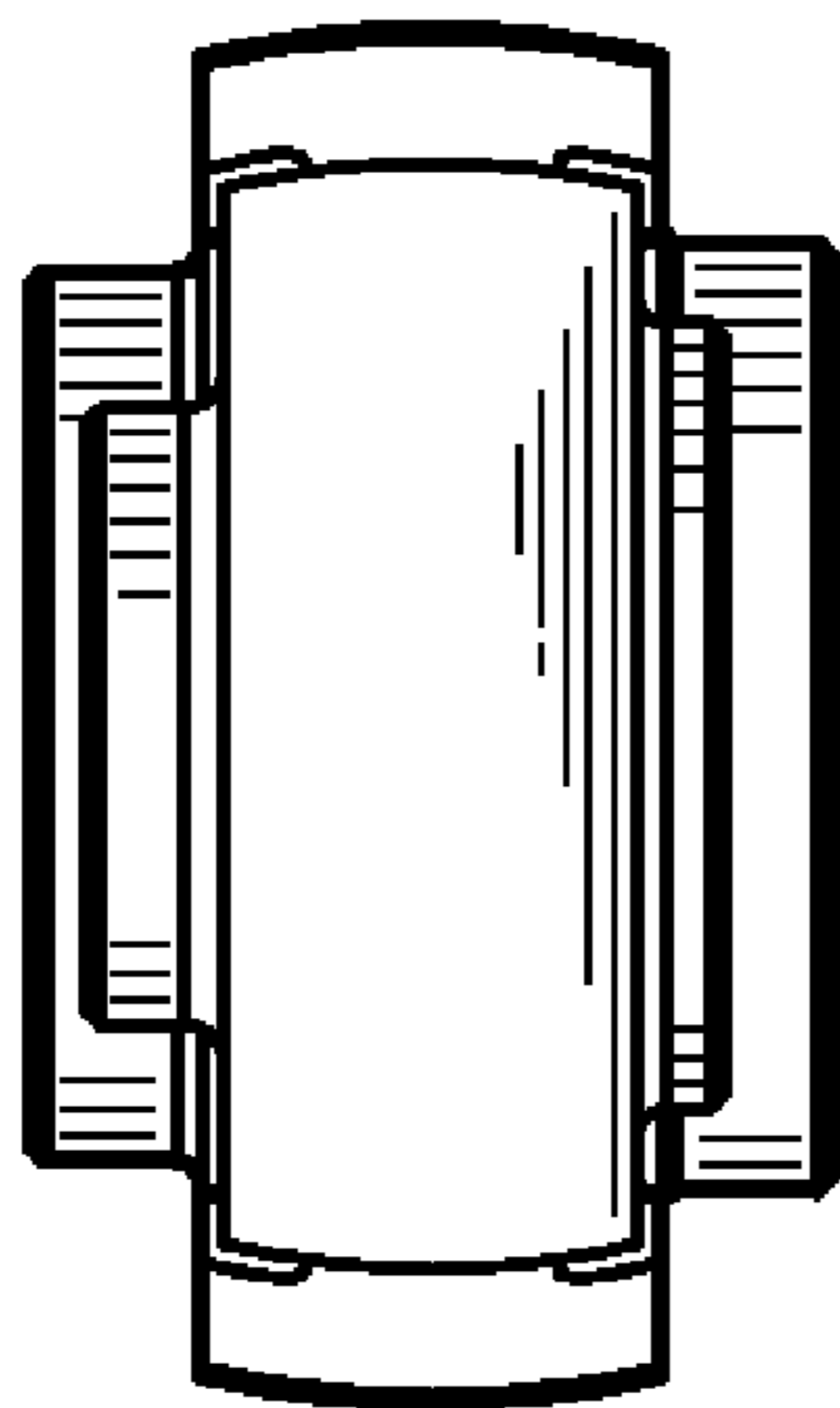

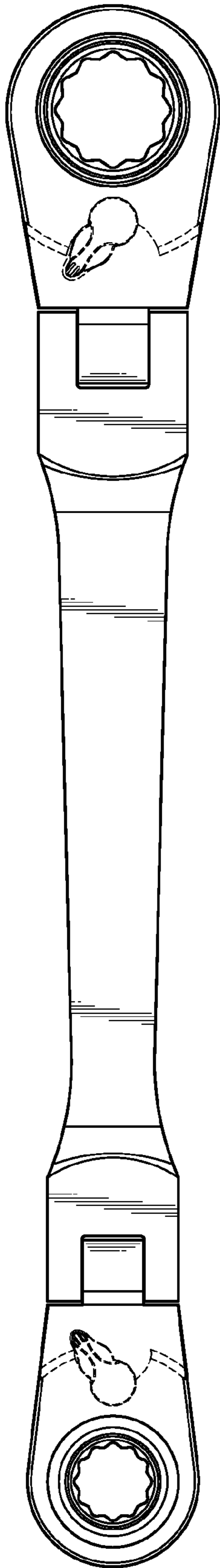

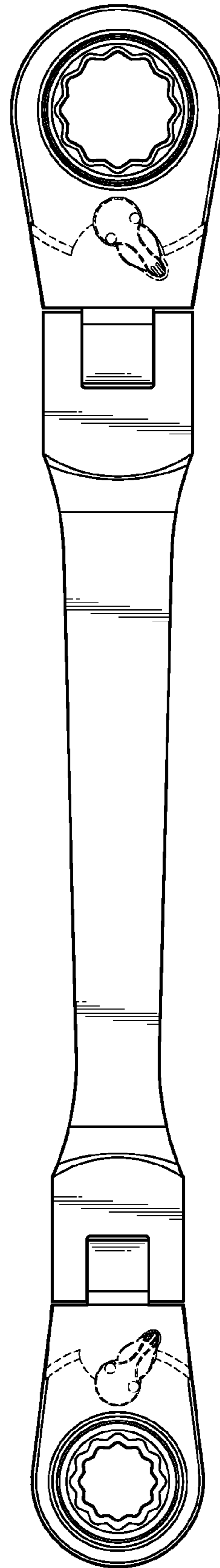

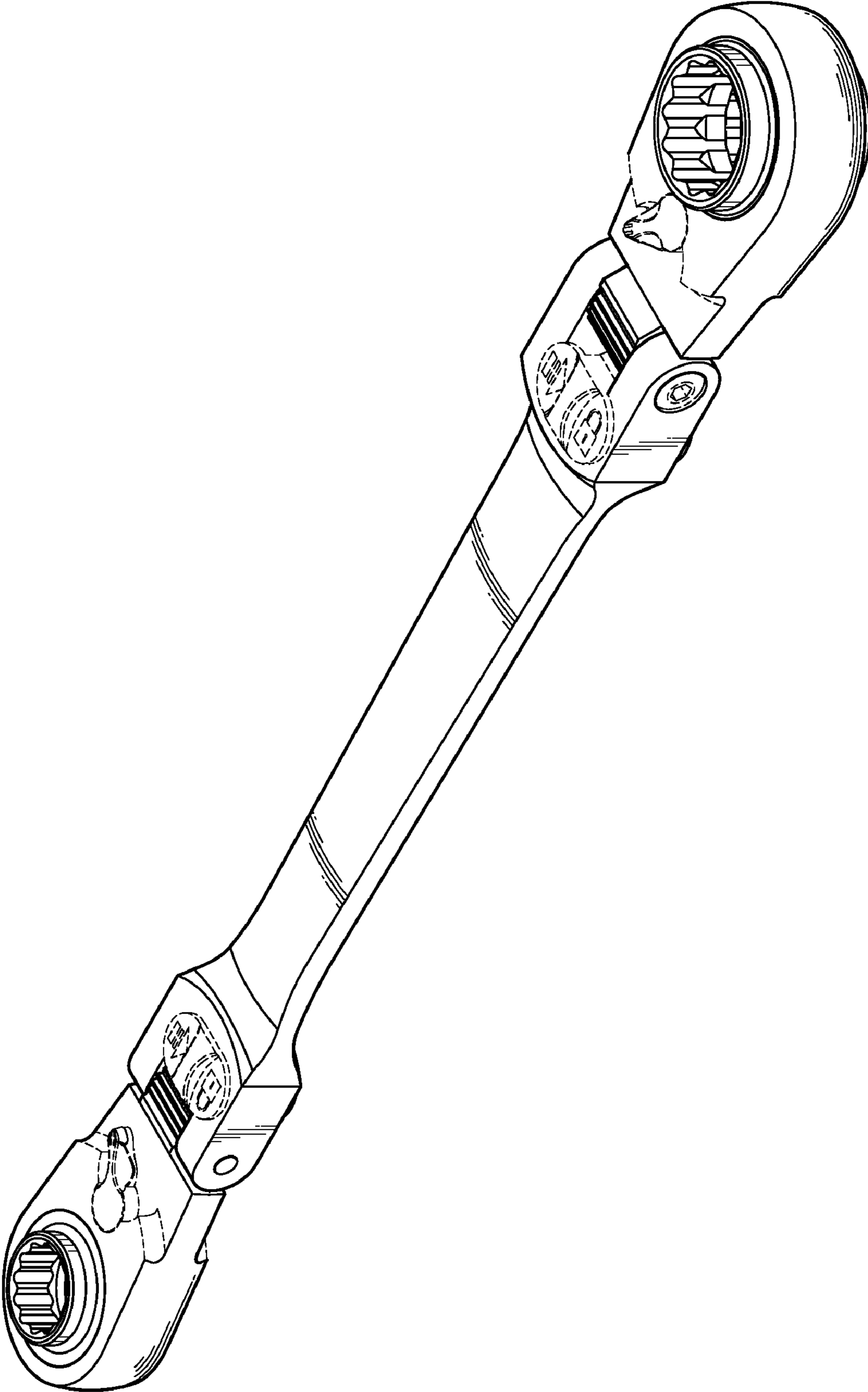

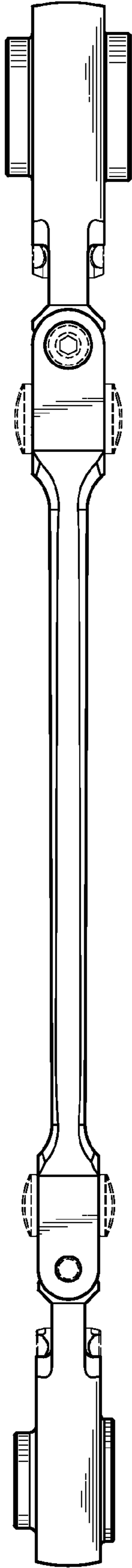

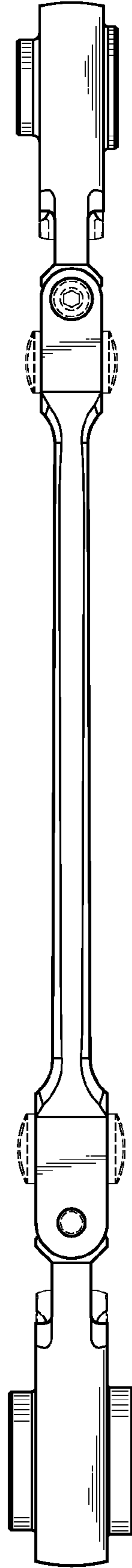

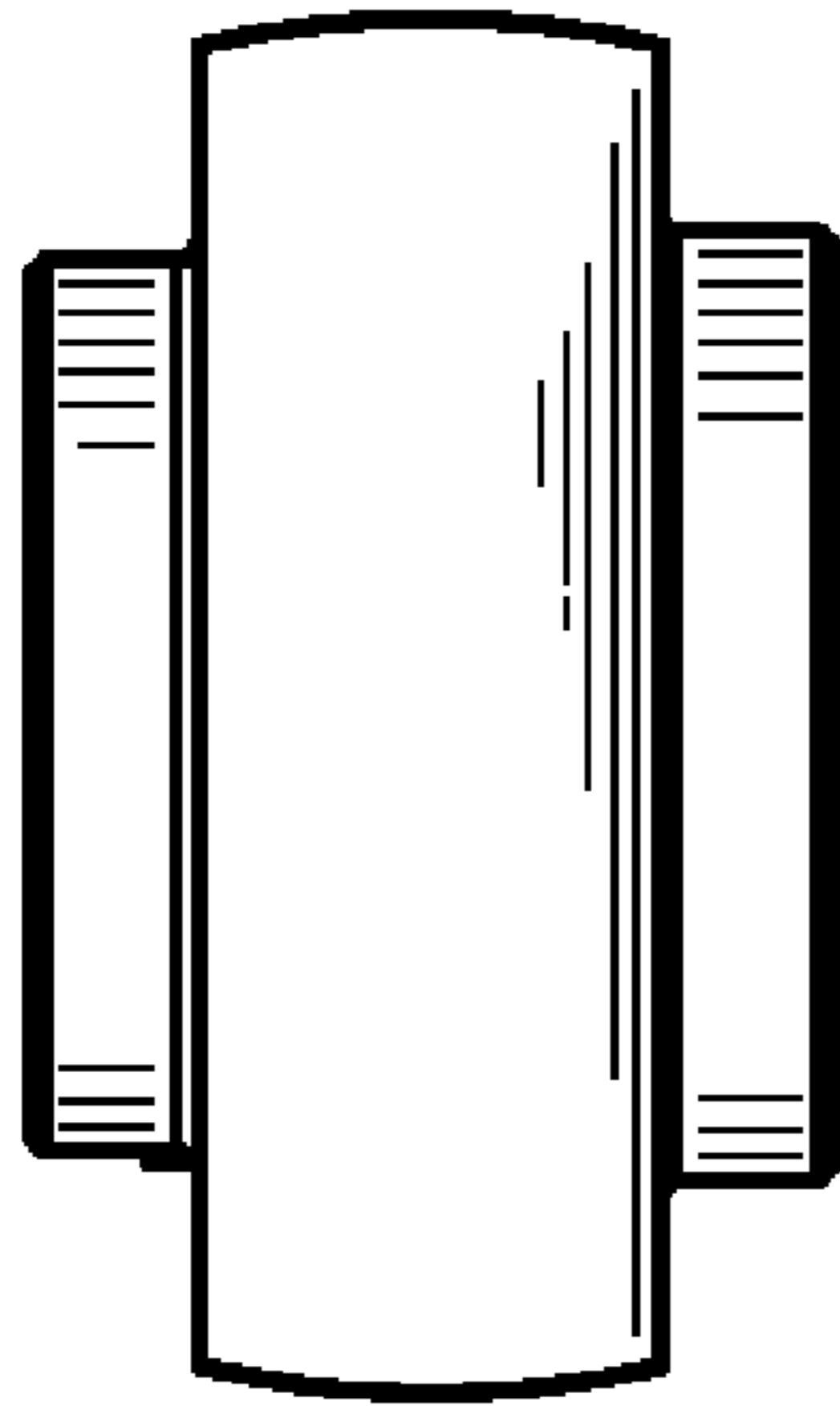

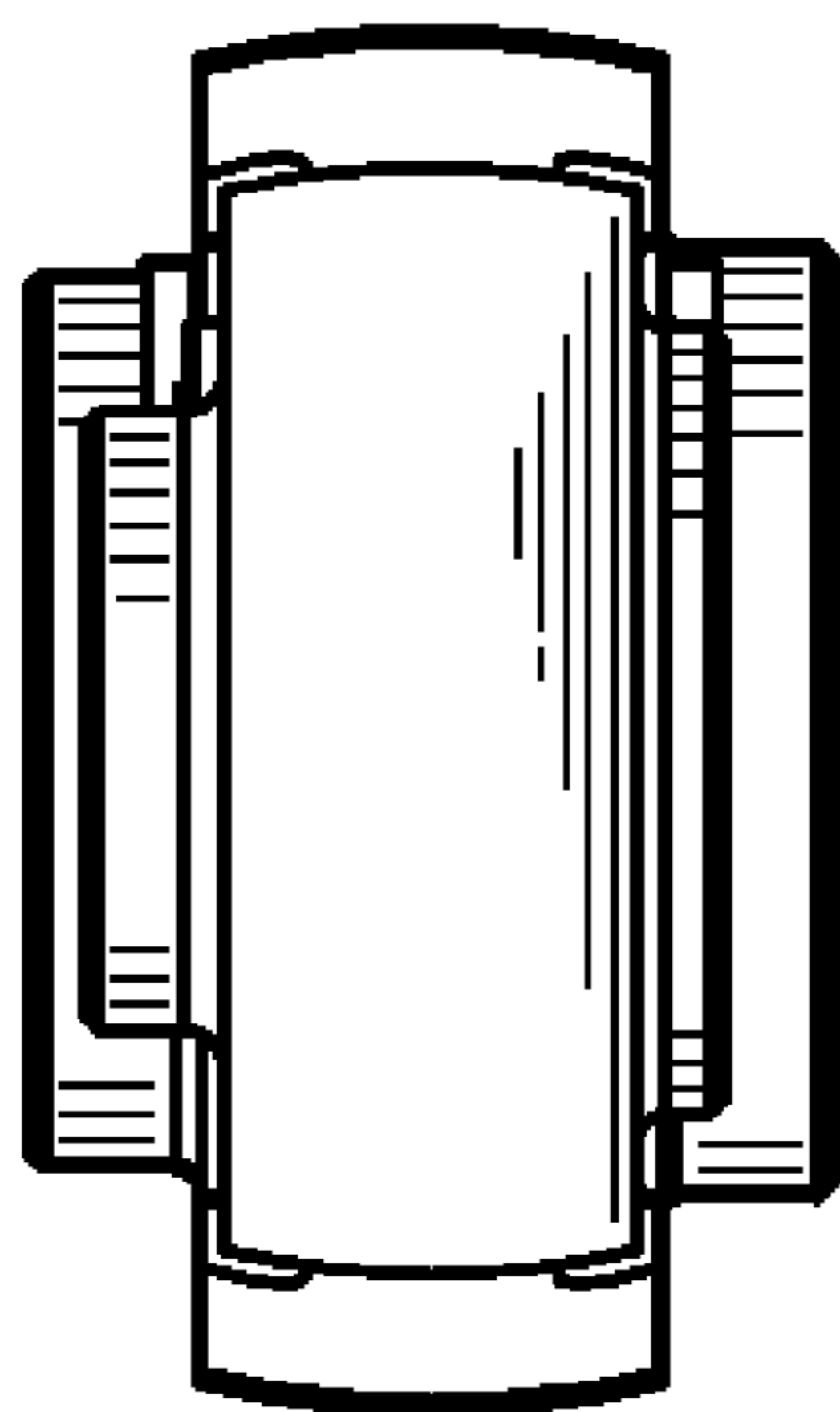

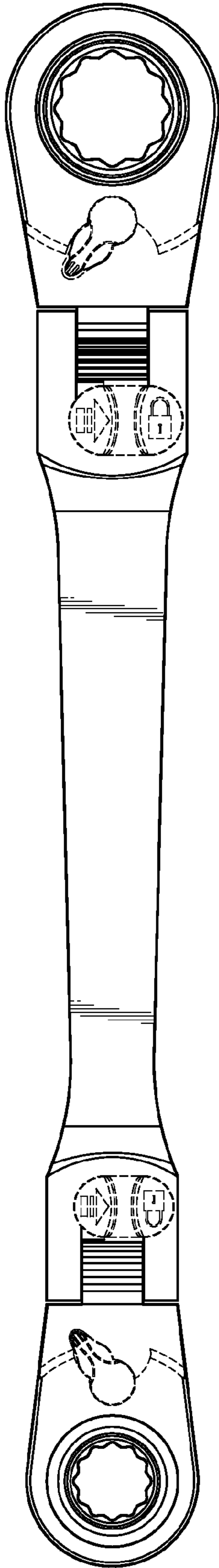

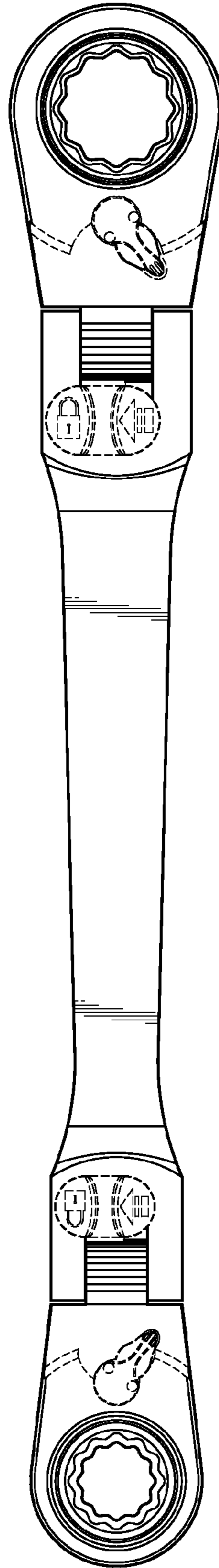
