The ornamental design for a soldering iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a soldering iron;

FIG. 11 is a side elevational view of the soldering iron of FIG. 8;

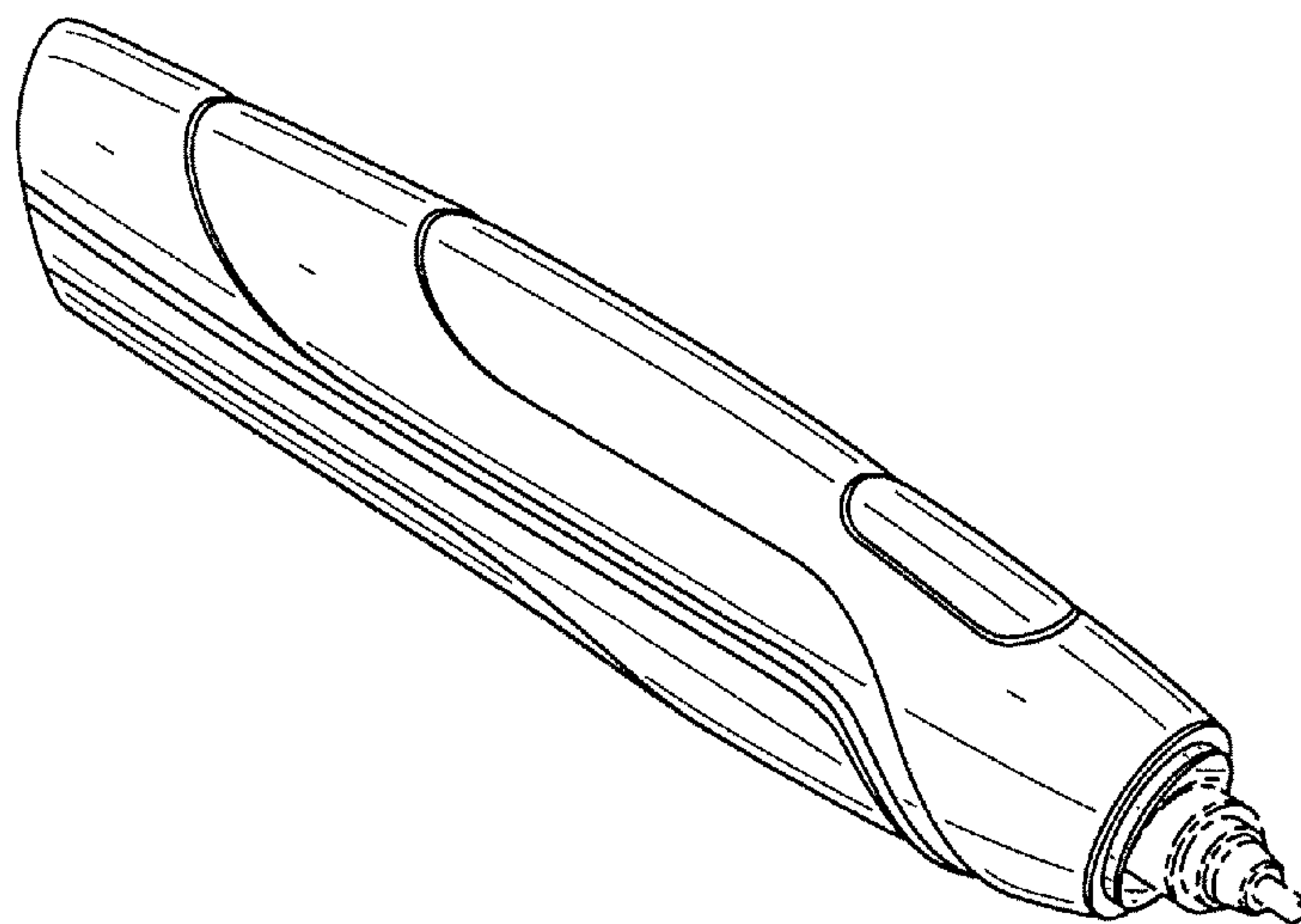
FIG. 12 is a bottom view of the soldering iron of FIG. 8;

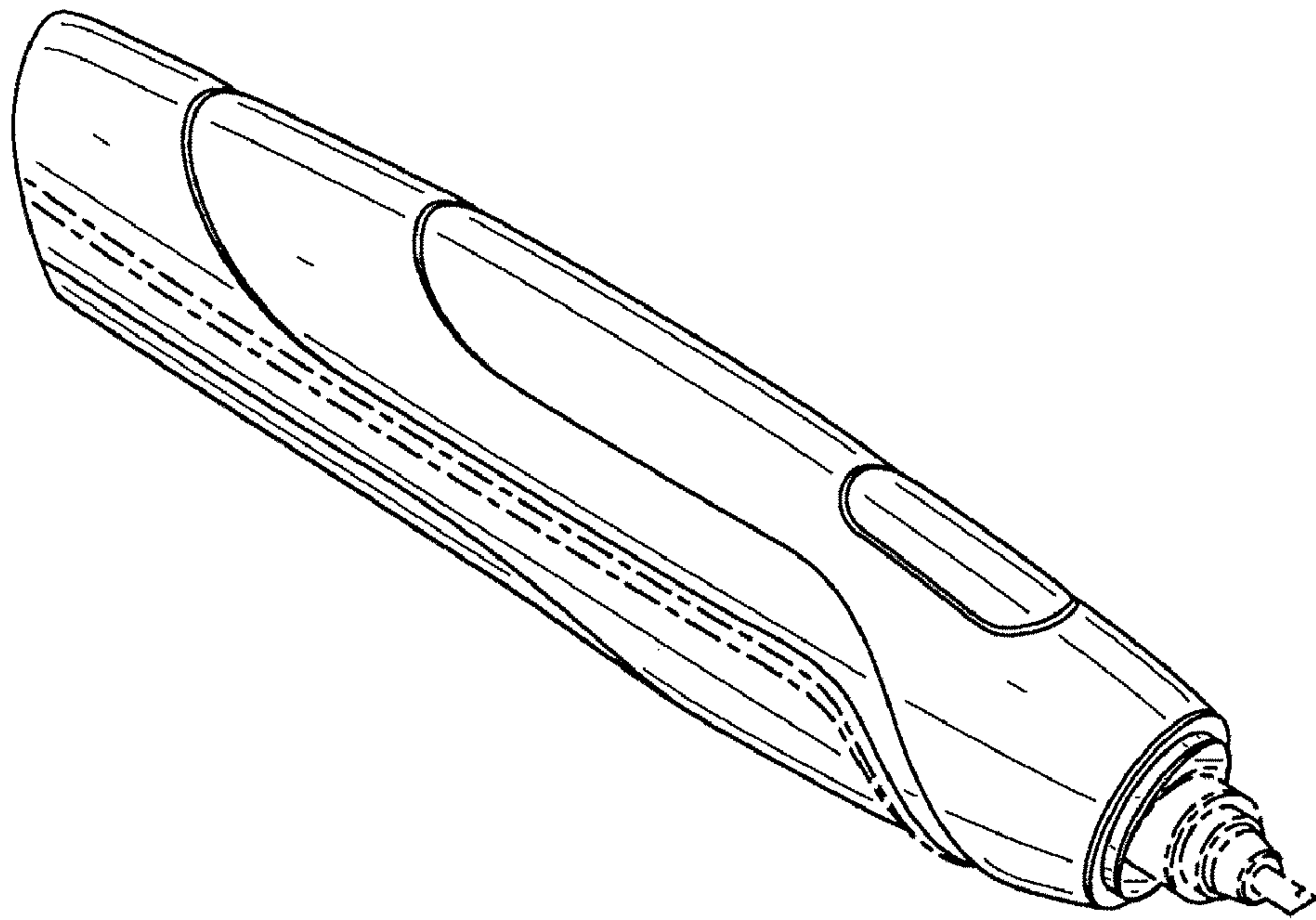

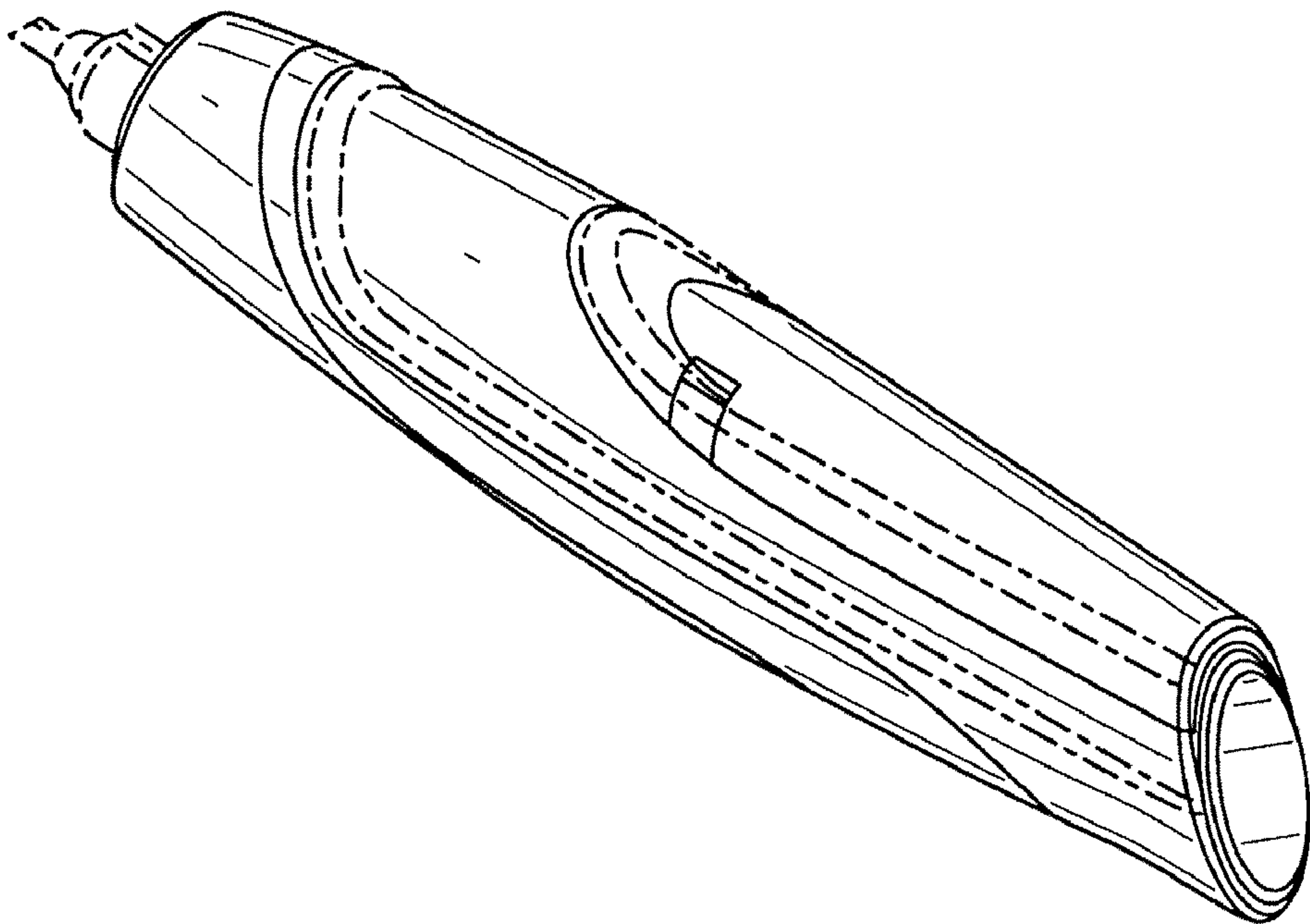

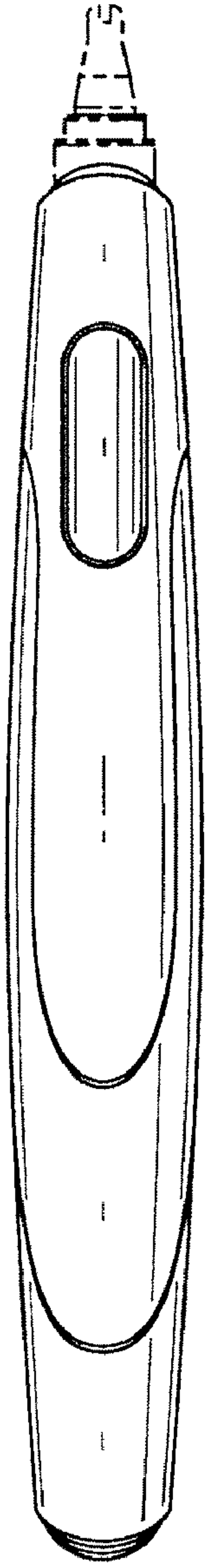

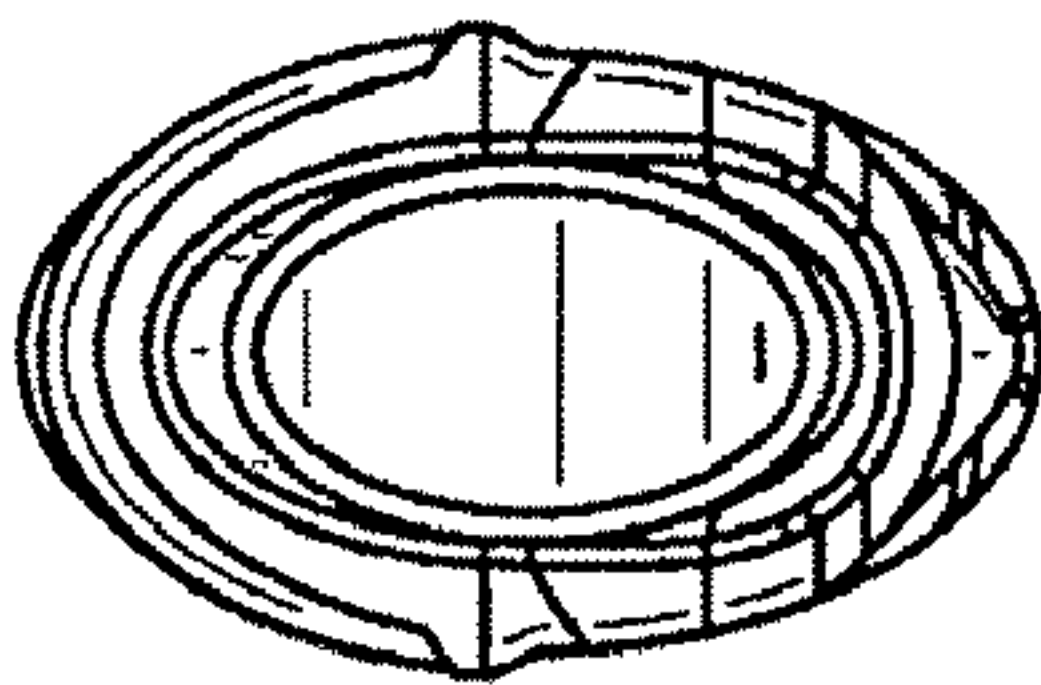

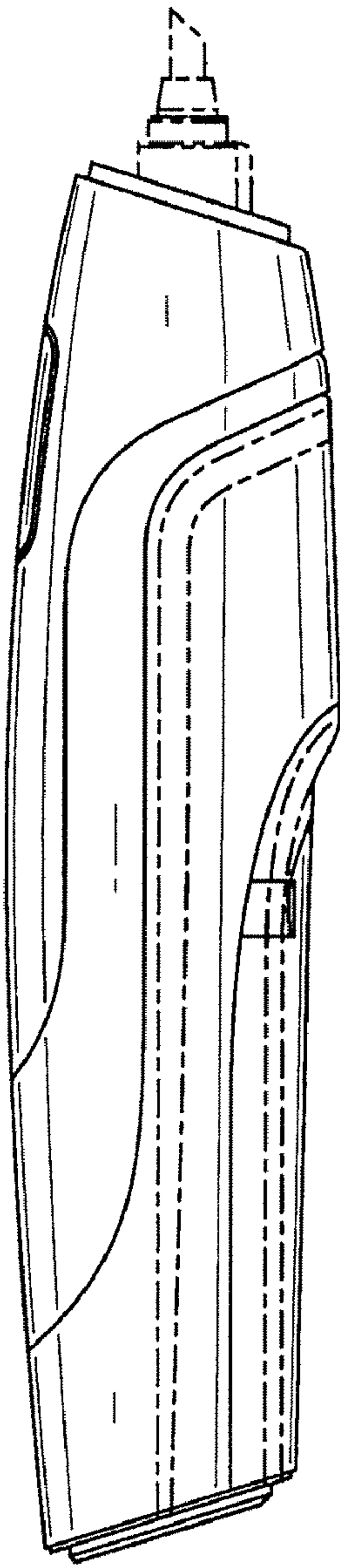

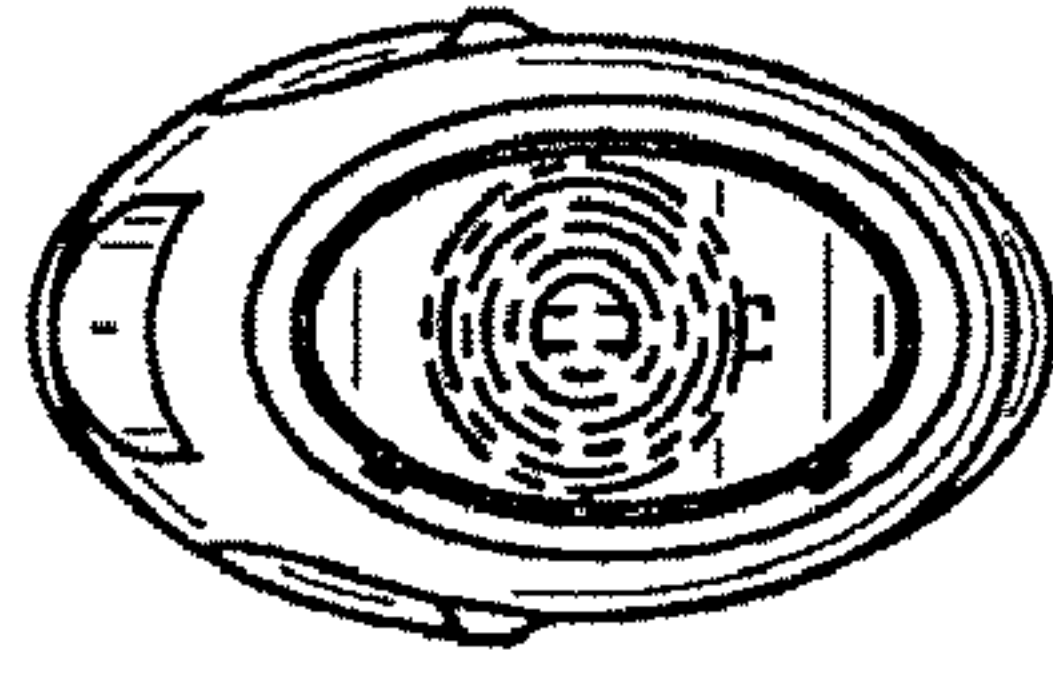

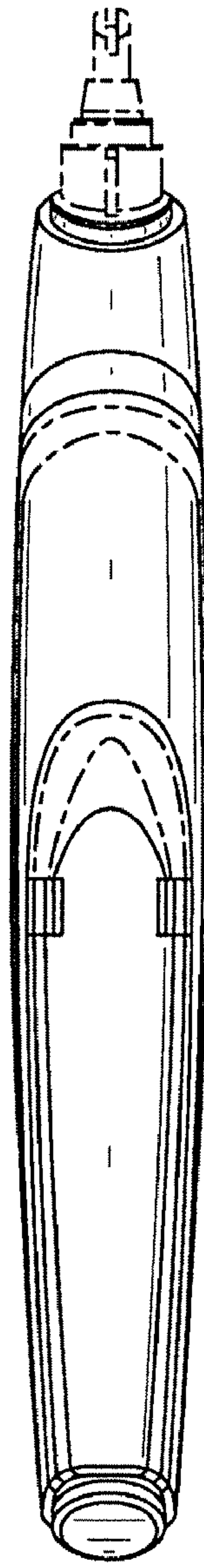

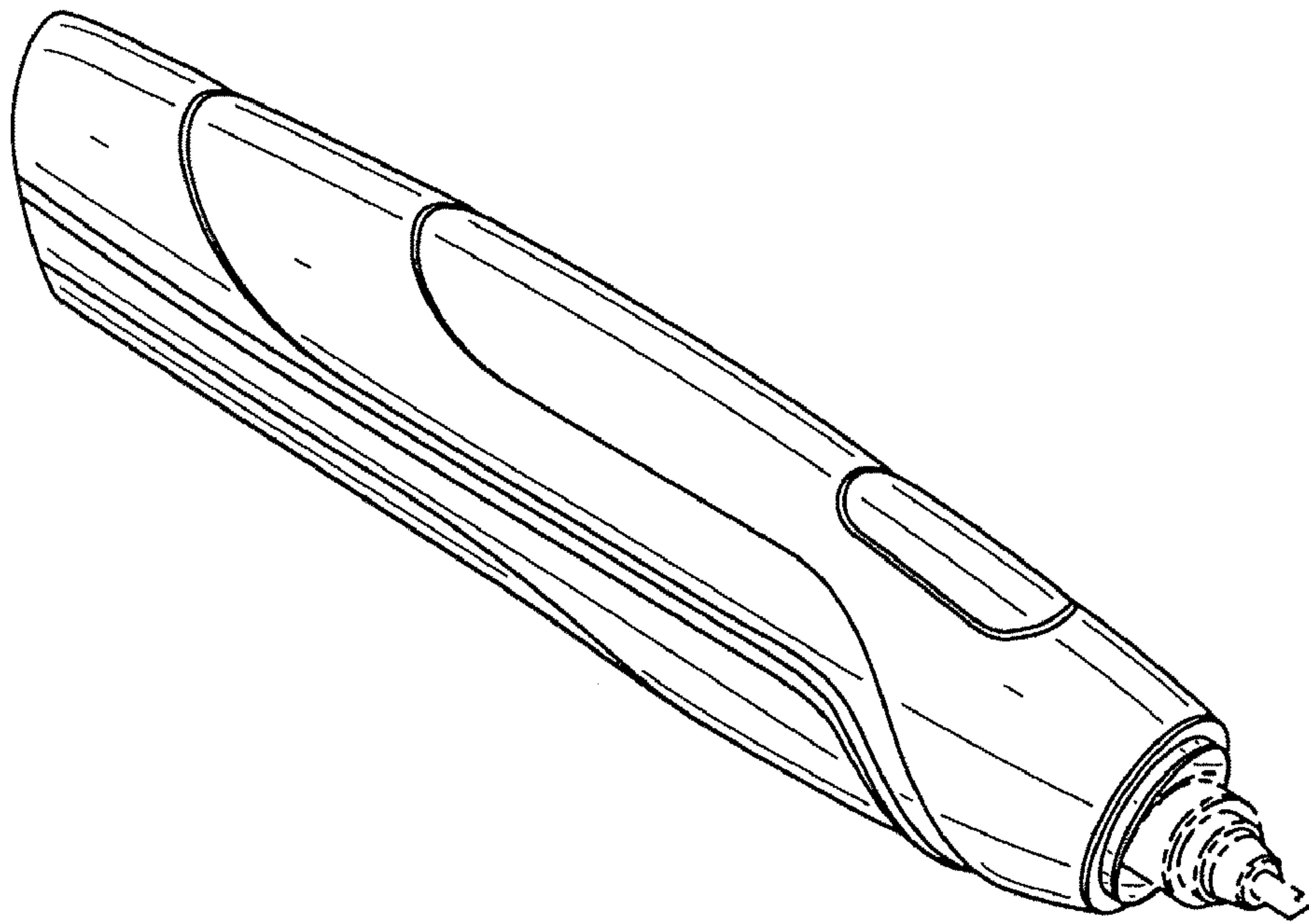

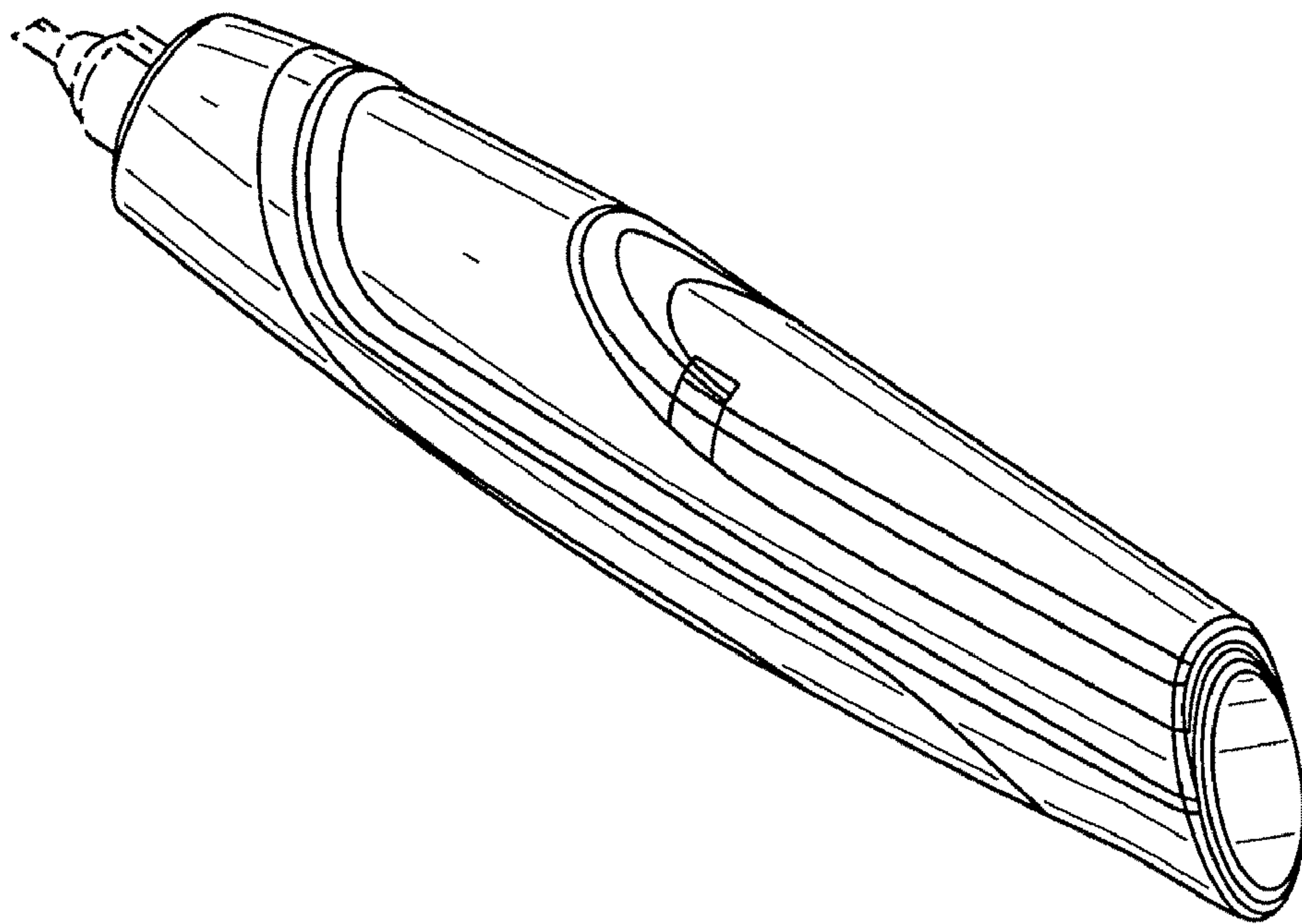

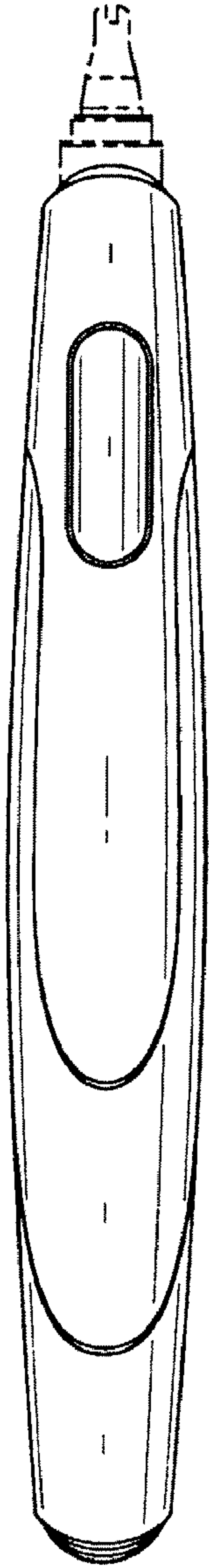

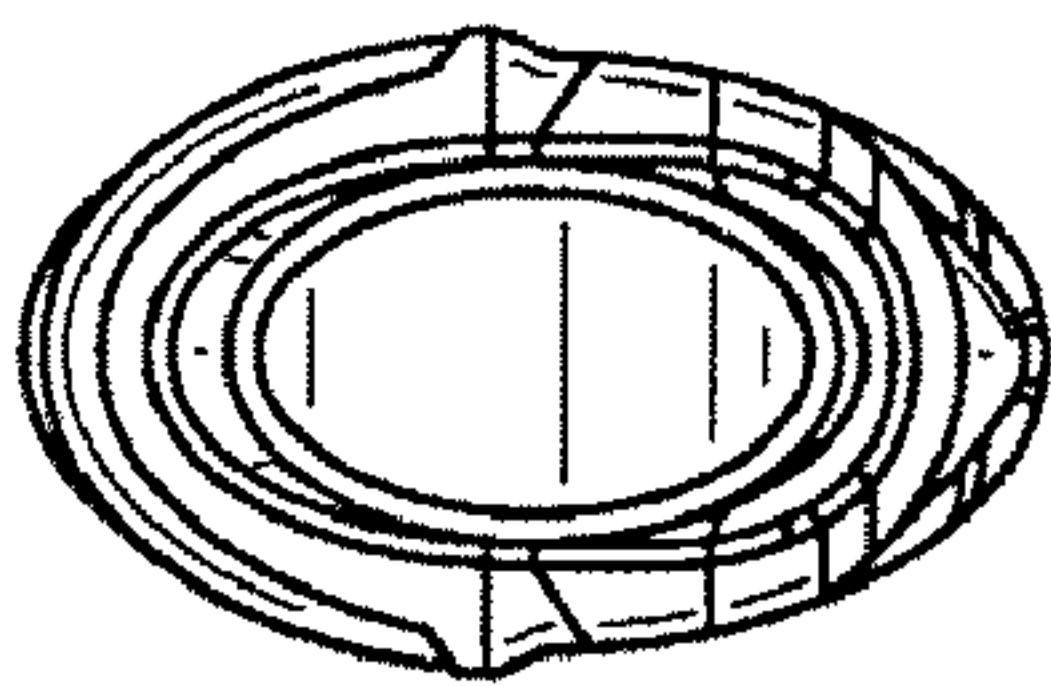

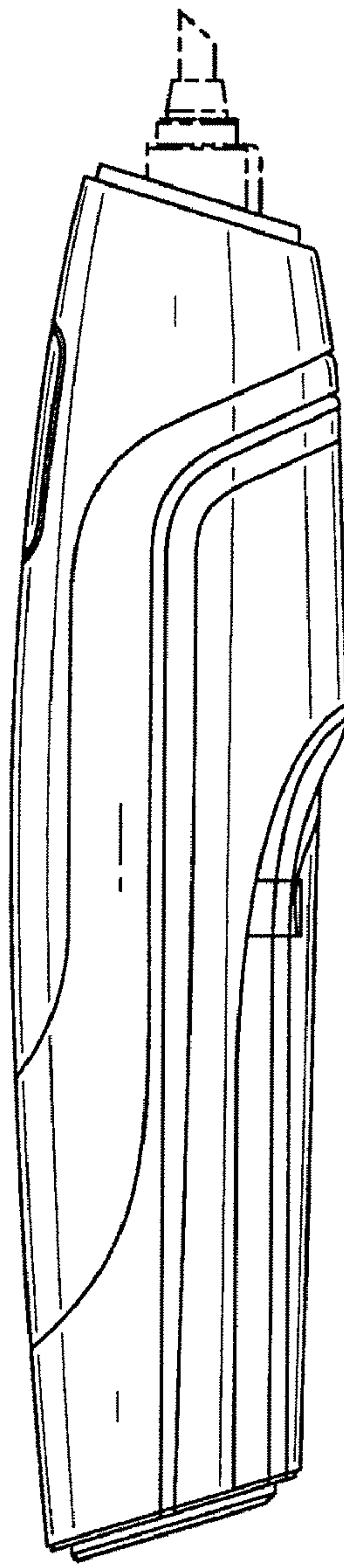

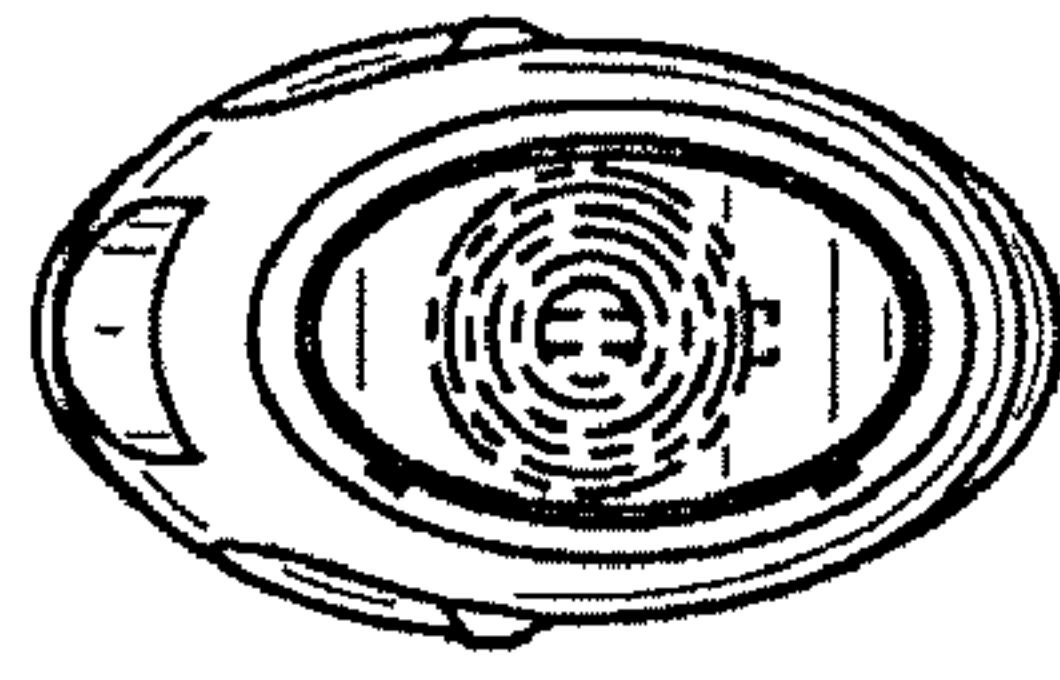

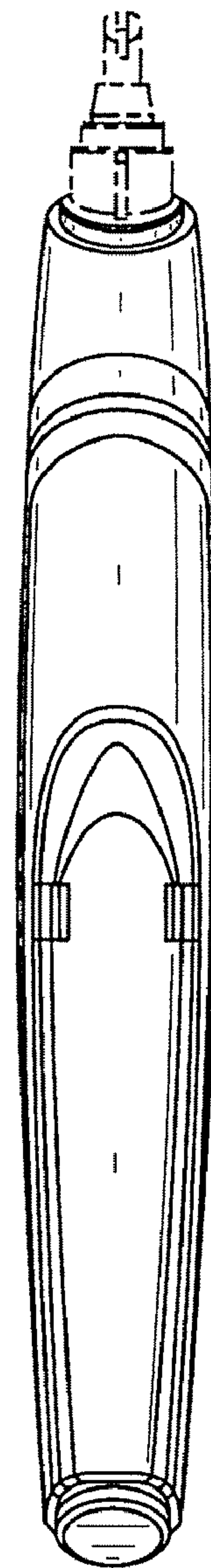
