**DESCRIPTION**

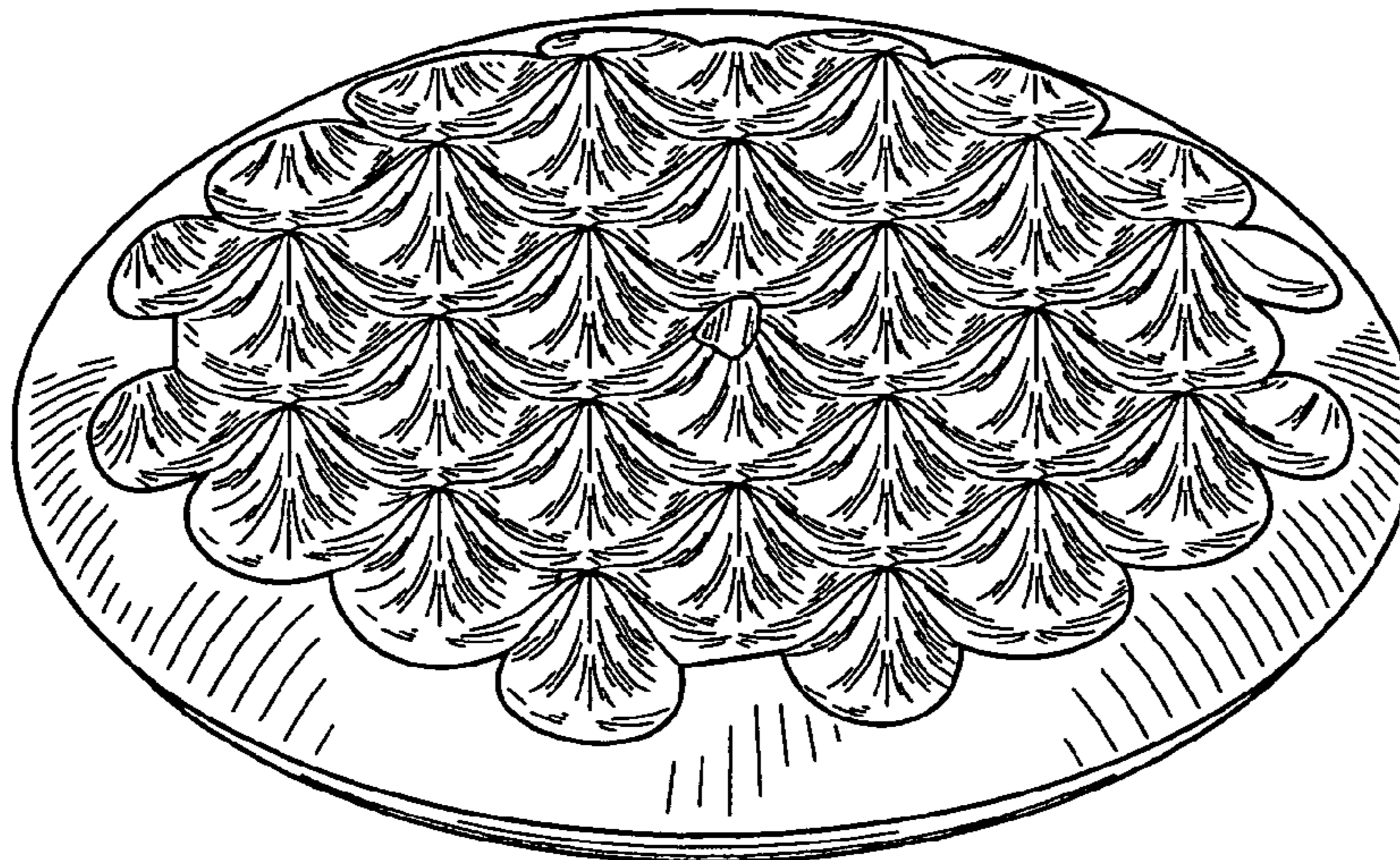
FIG. 1 is a perspective view of a waffle round edge pad in accordance with the invention;

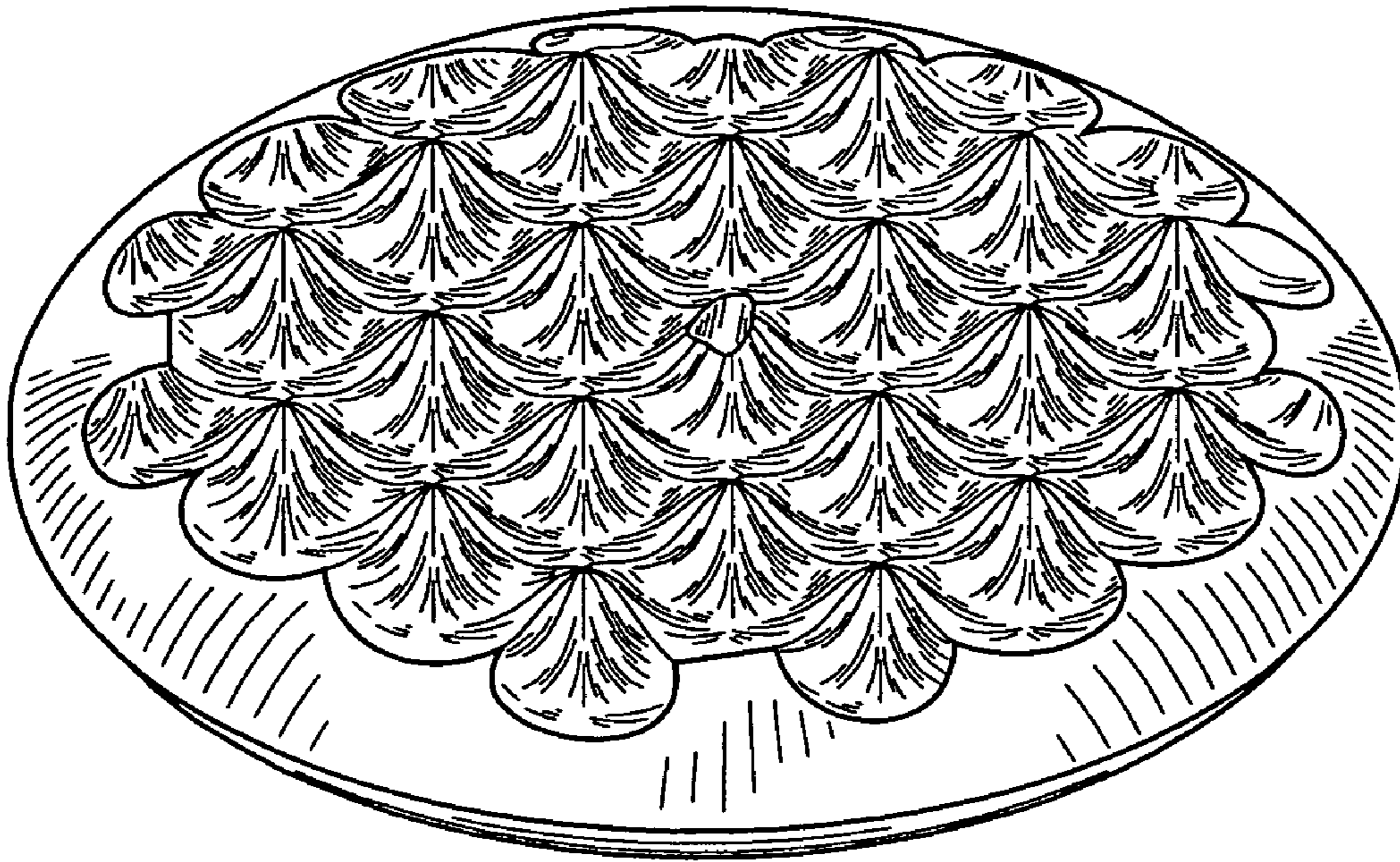
FIG. 2 is a side view of the waffle round edge pad;

FIG. 3 is a top view of the waffle round edge pad; and,

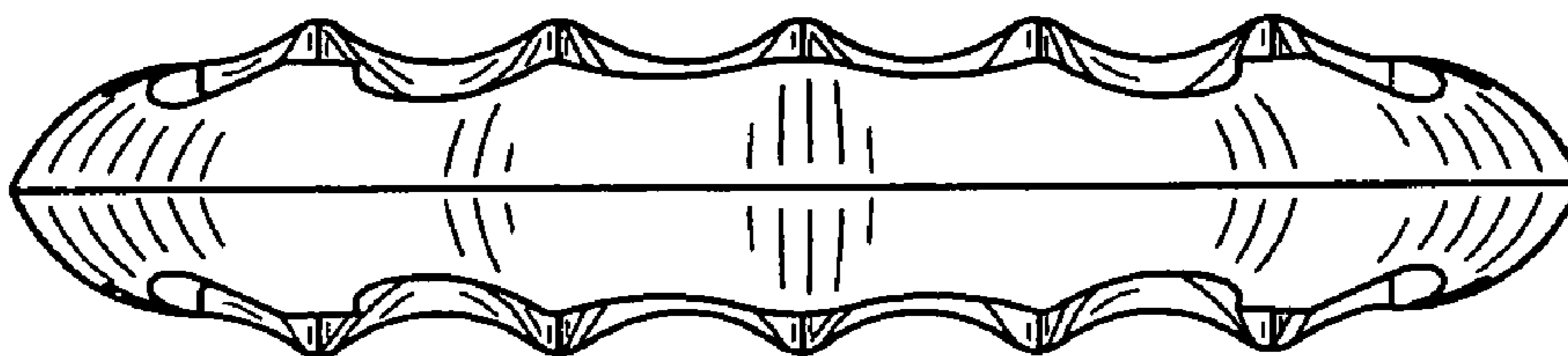
FIG. 4 is a bottom view of the waffle round edge pad.

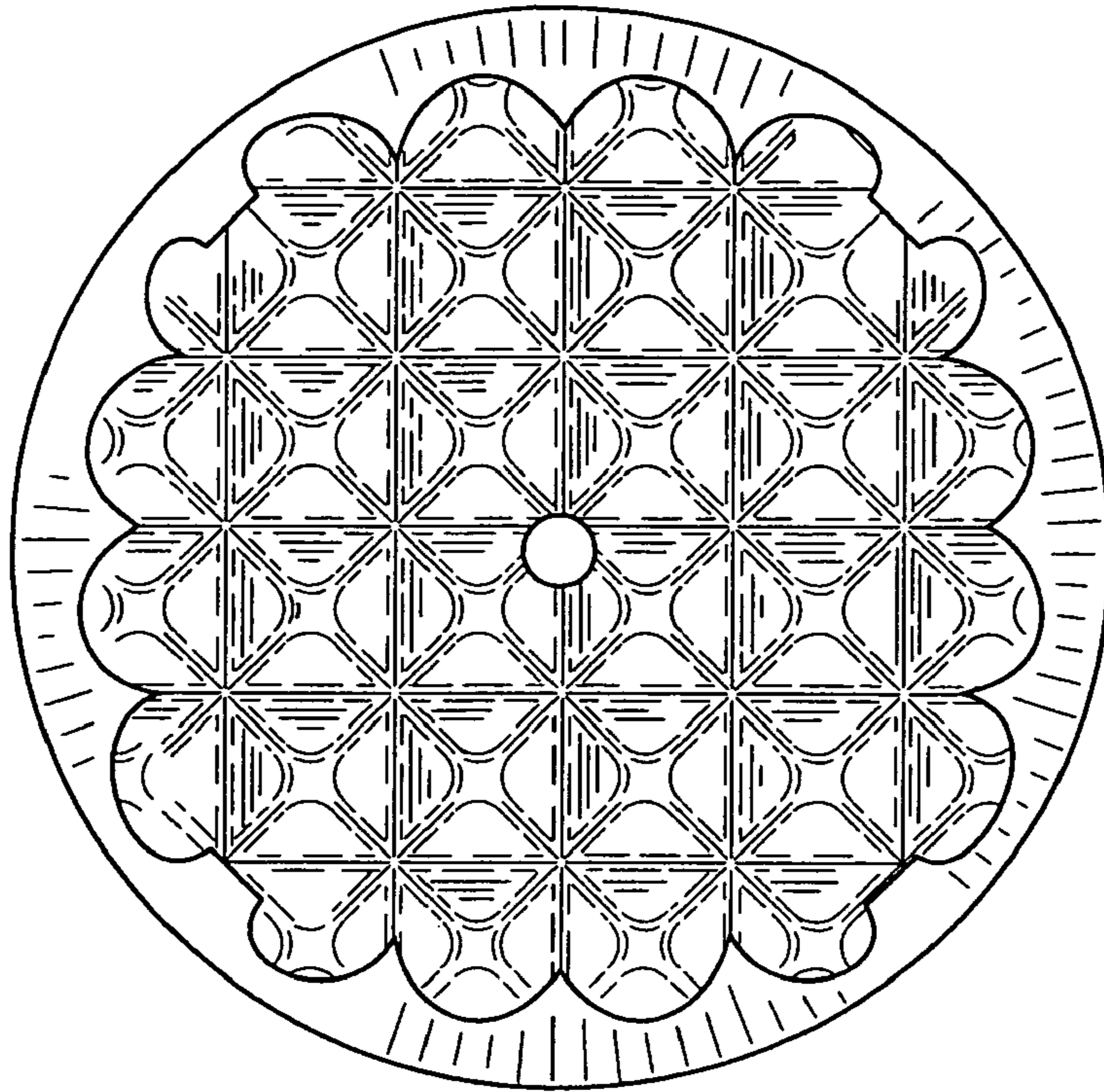

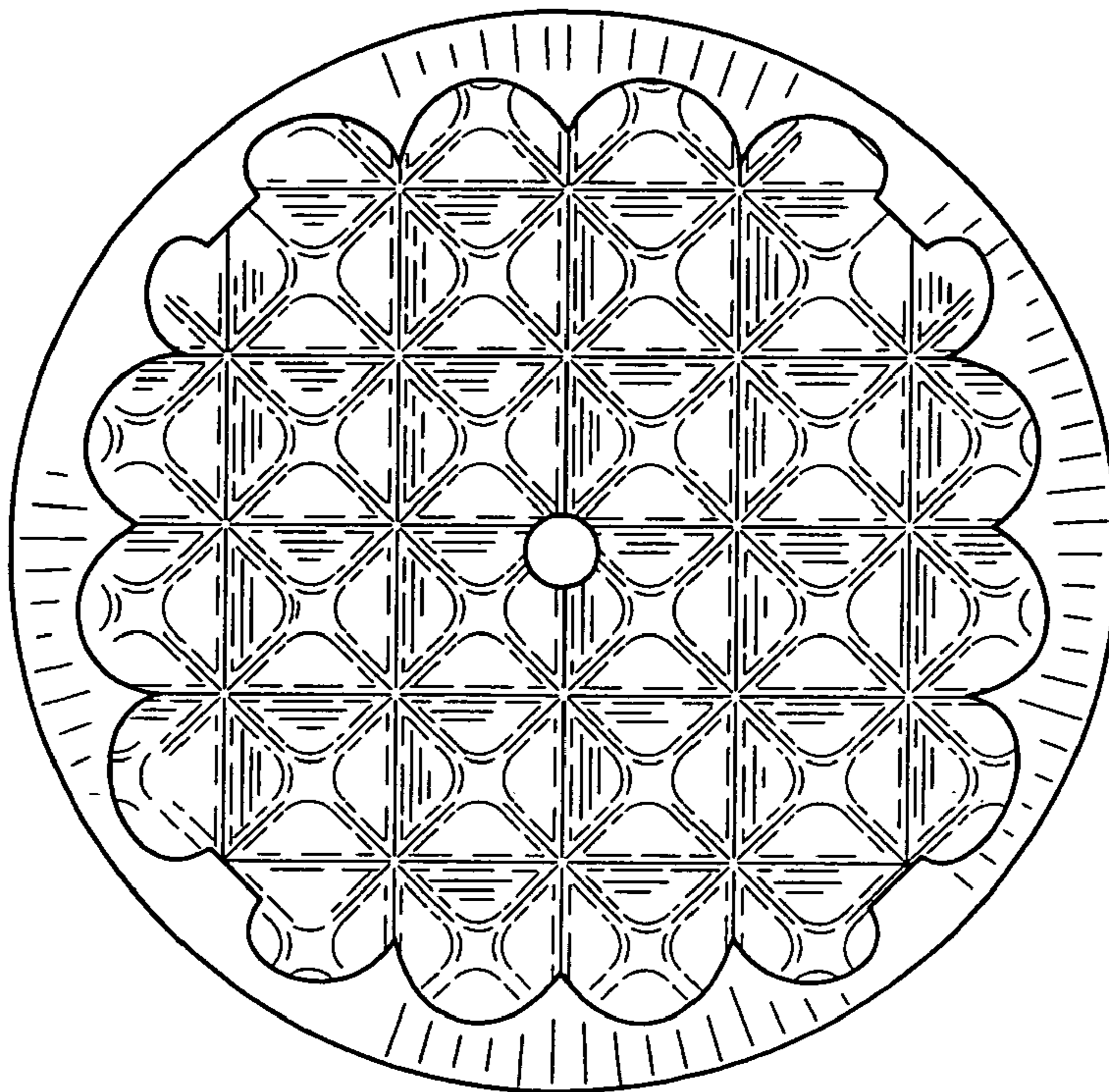
