DESCRIPTION

FIG. 1 is a perspective view of a can;

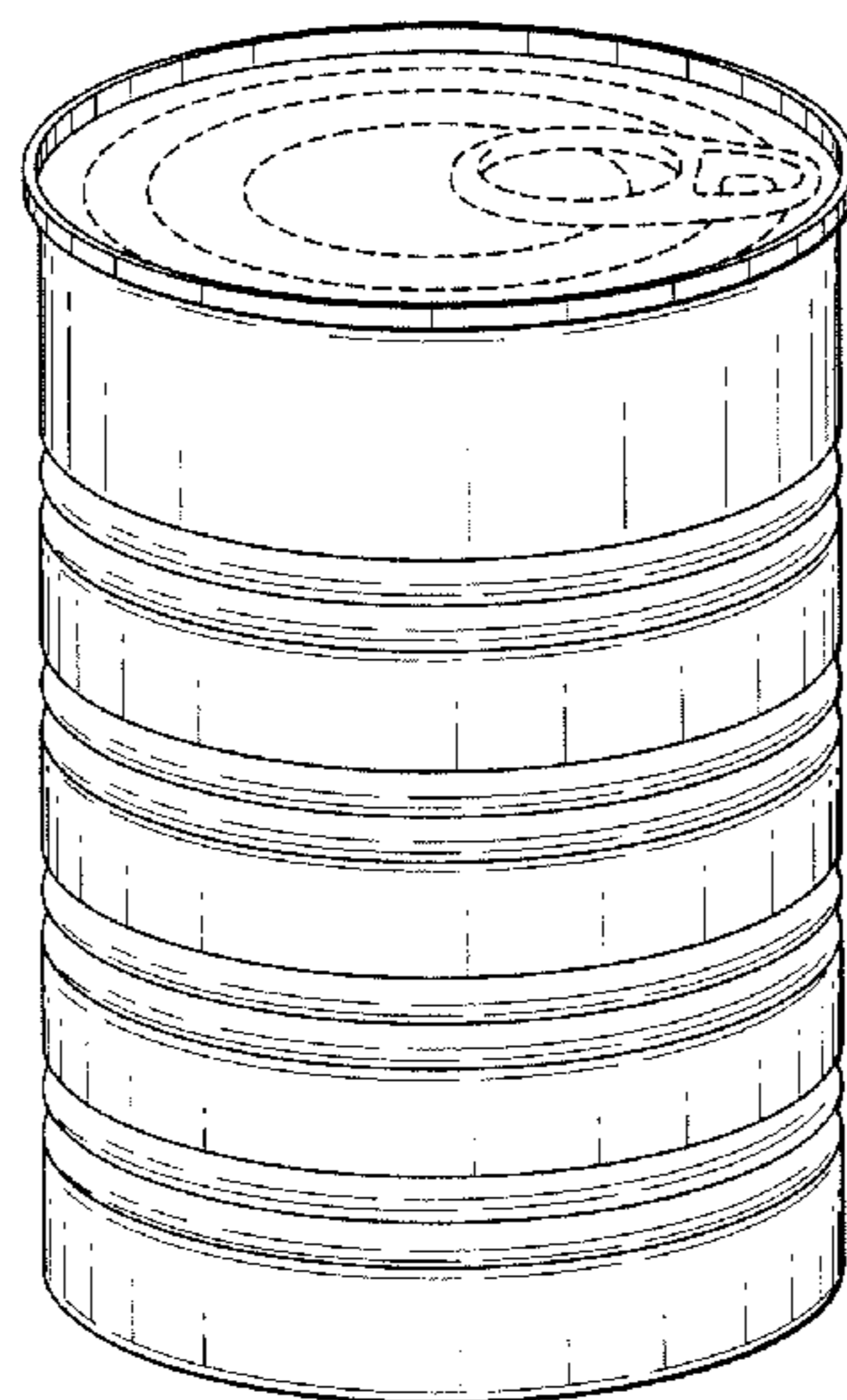
FIG. 2 is a side view of the can shown in FIG. 1, the opposite side, front and rear views being identical thereto;

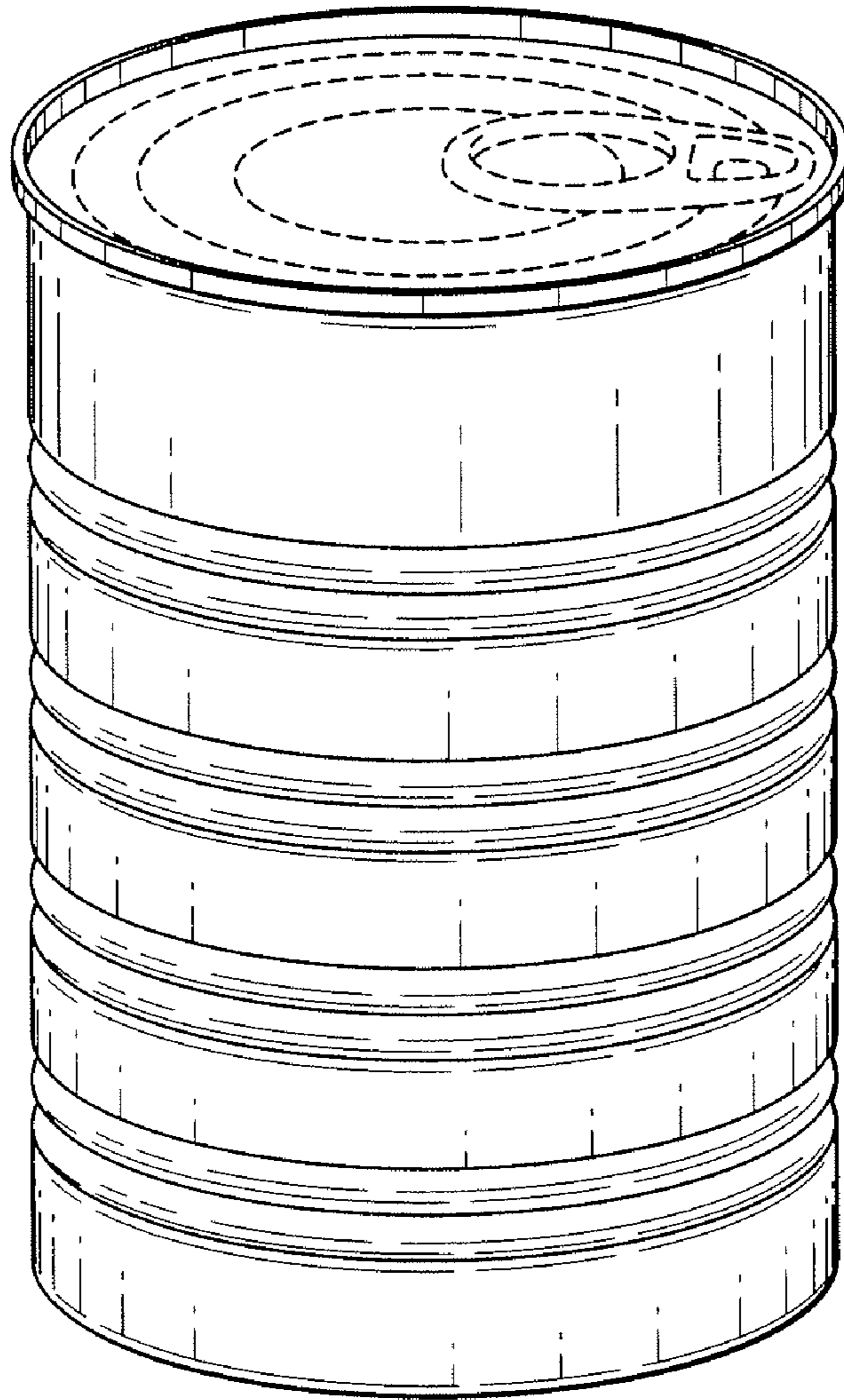

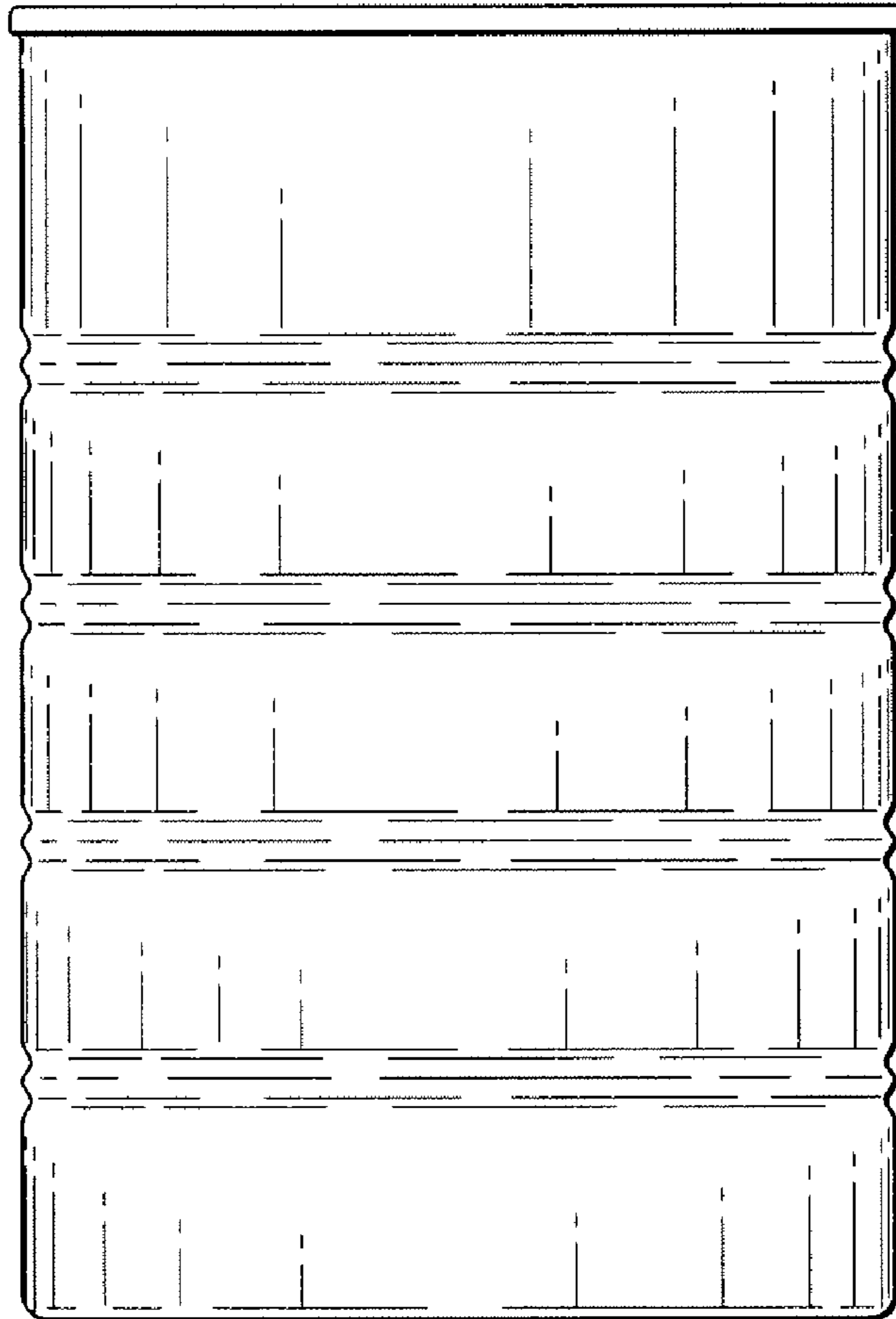

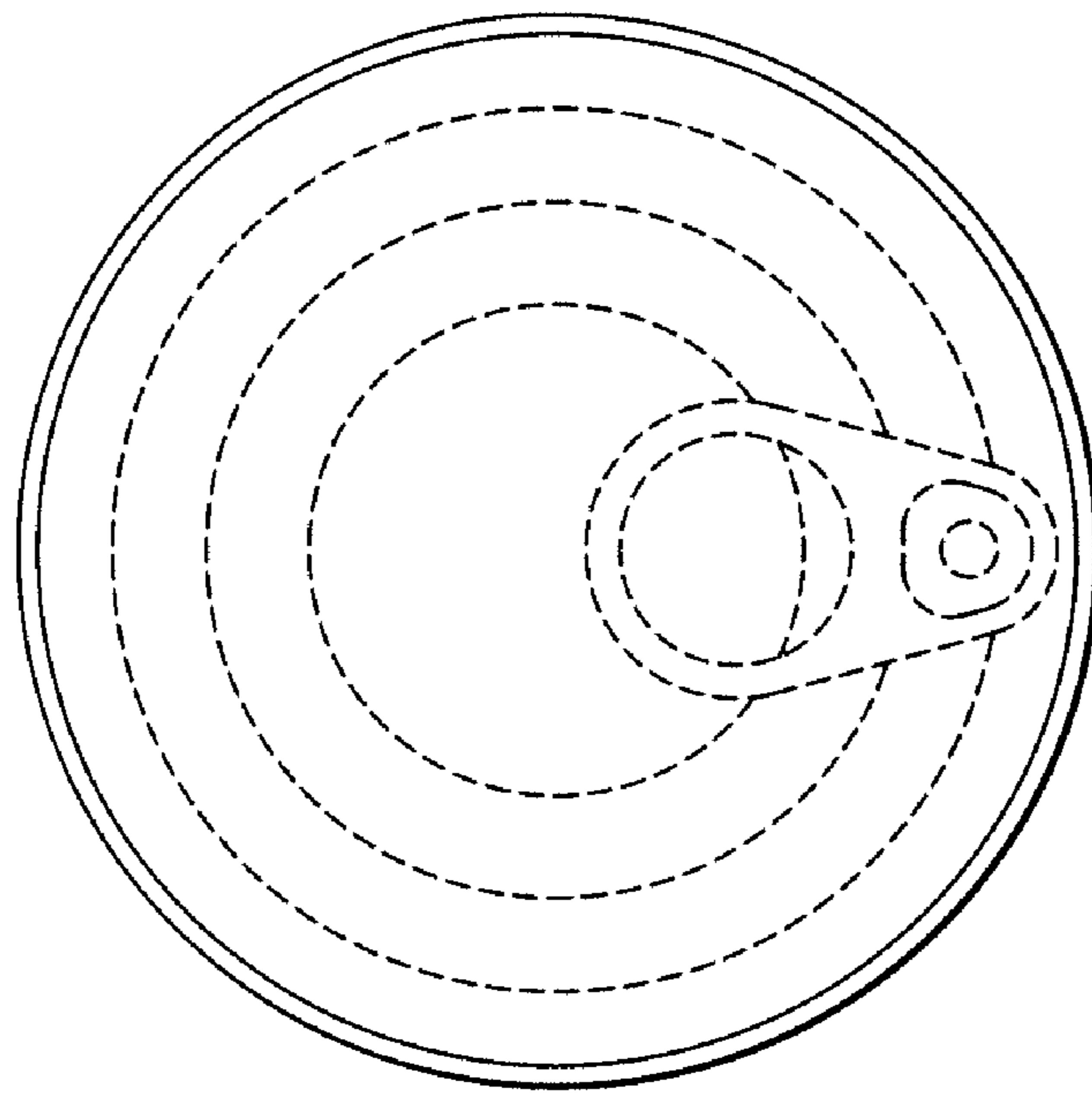

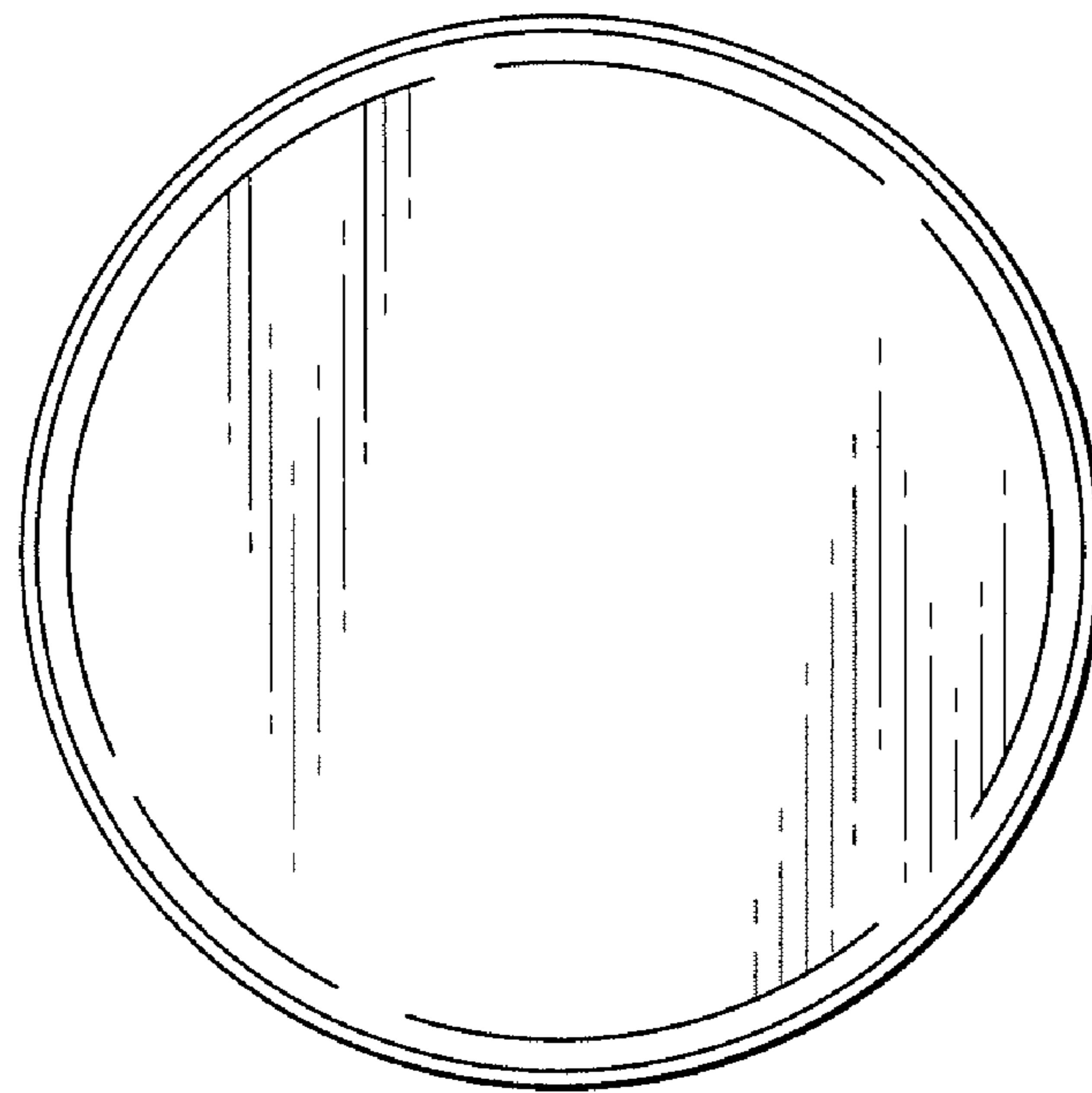
