The ornamental design for a belt adjustment device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a belt adjustment device showing my new design;

FIG. 2 is a plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a right side view thereof; a left side view being the same as the right side view;

FIG. 6 is a sectional view thereof taken along line 6—6 in FIG. 1; and,

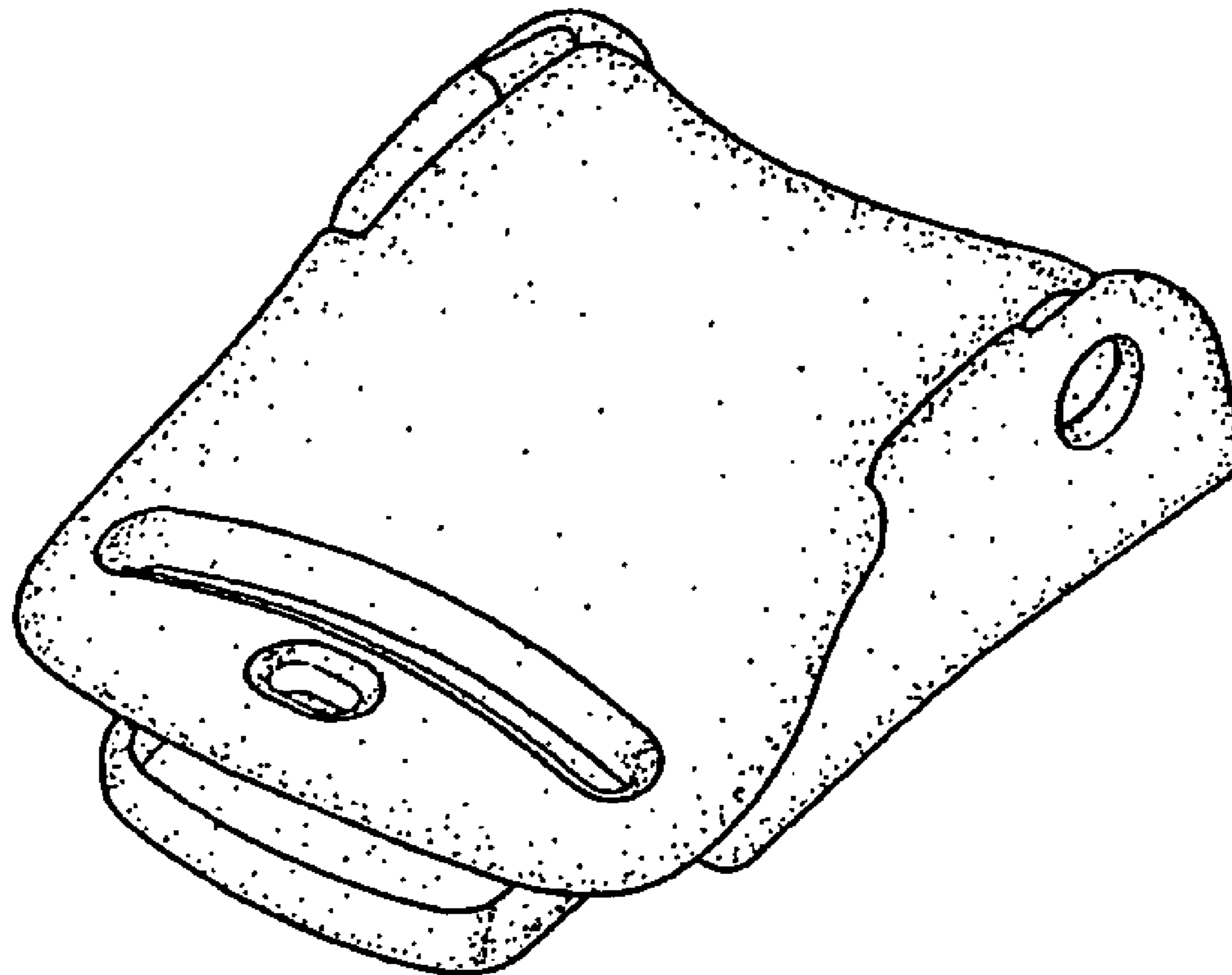

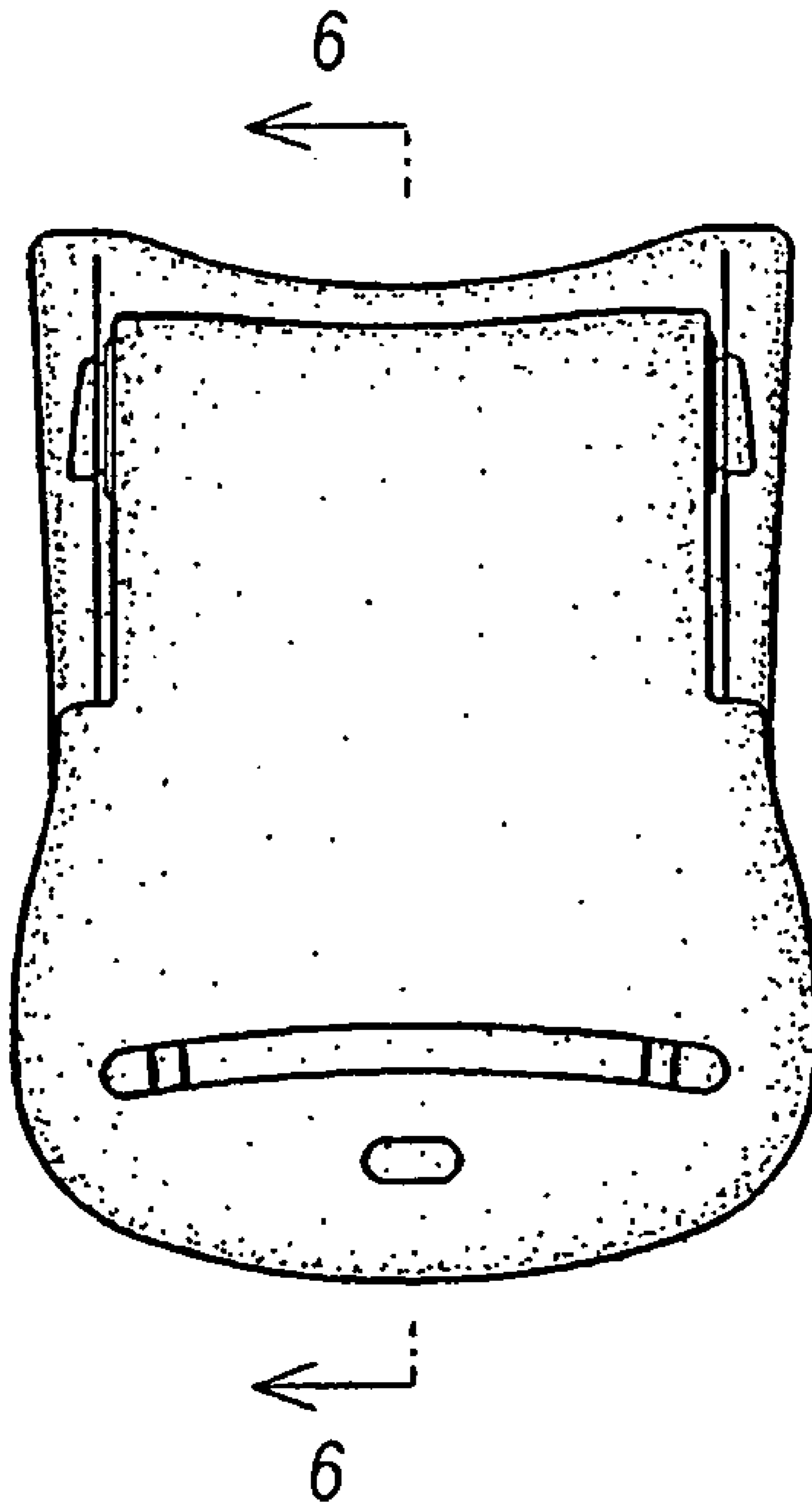

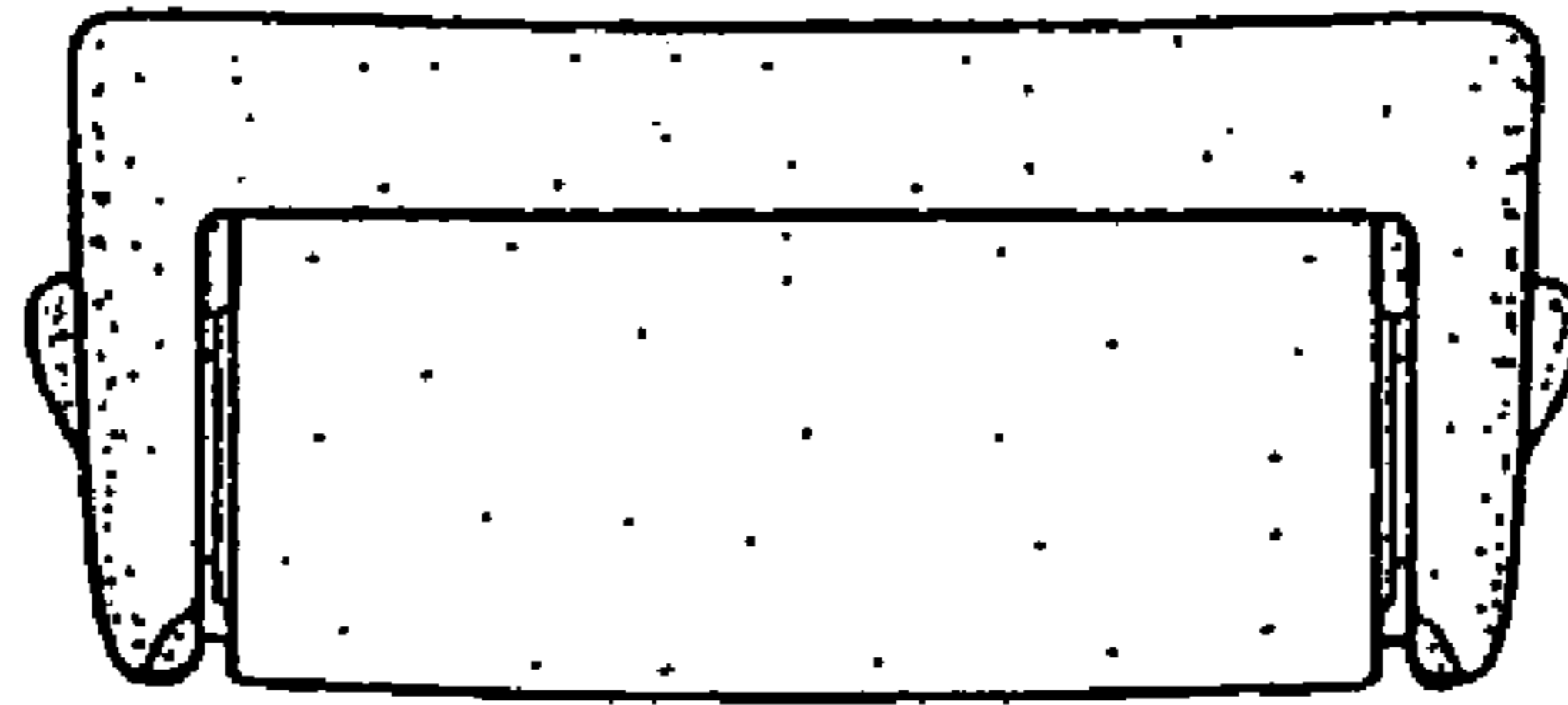

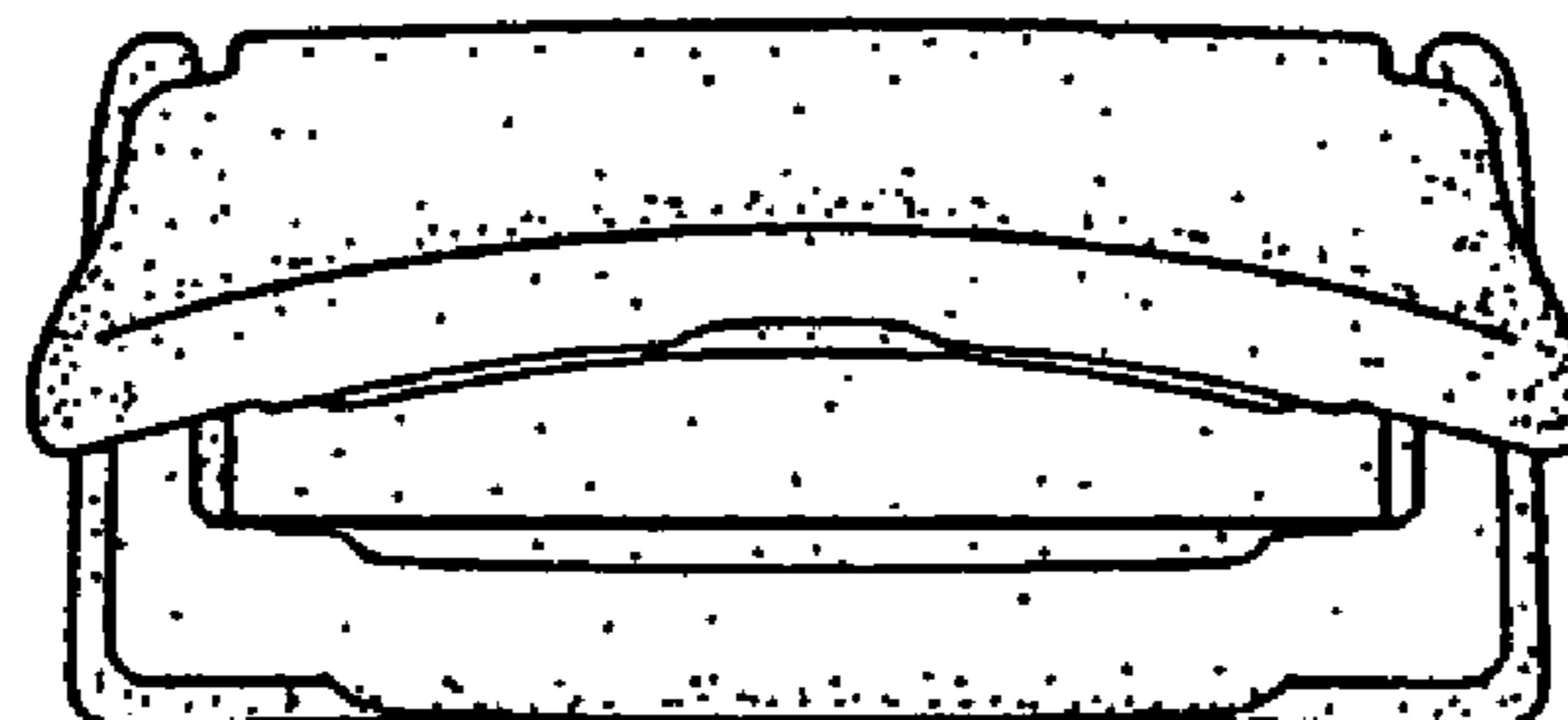

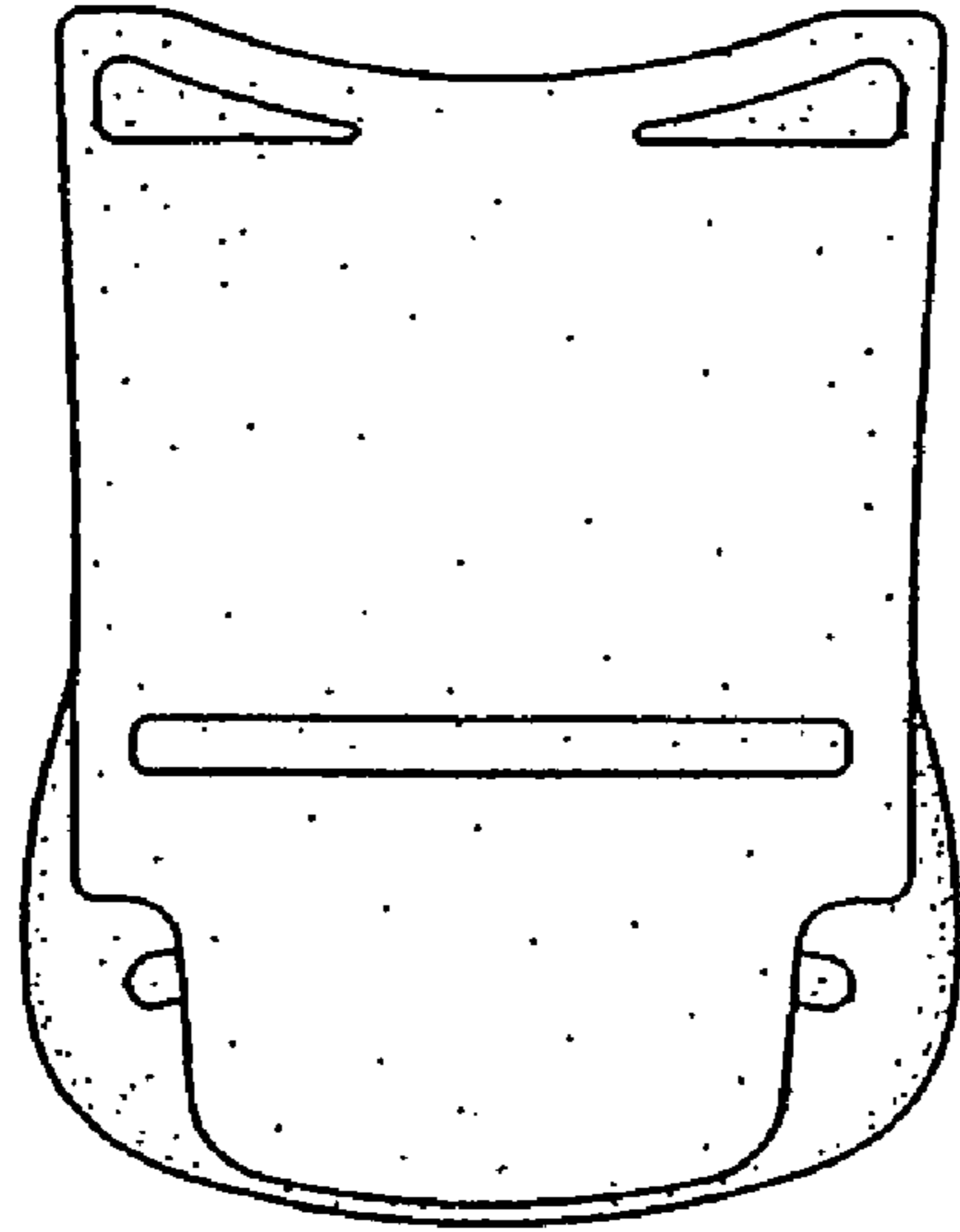

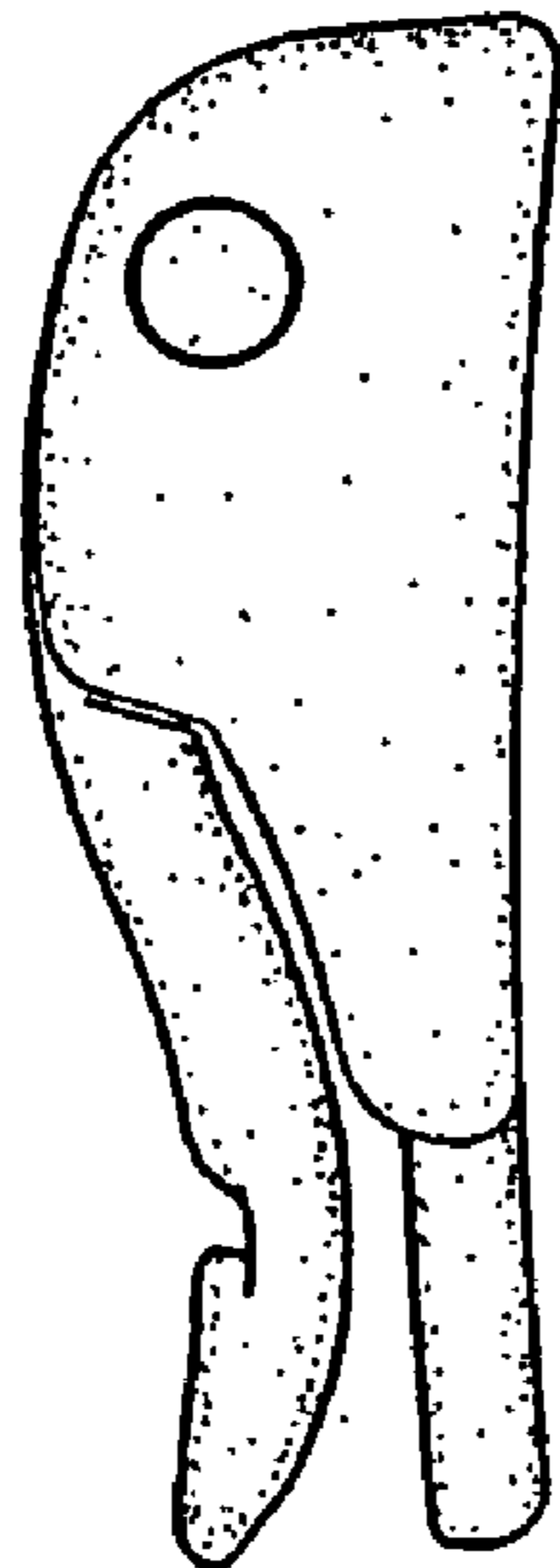

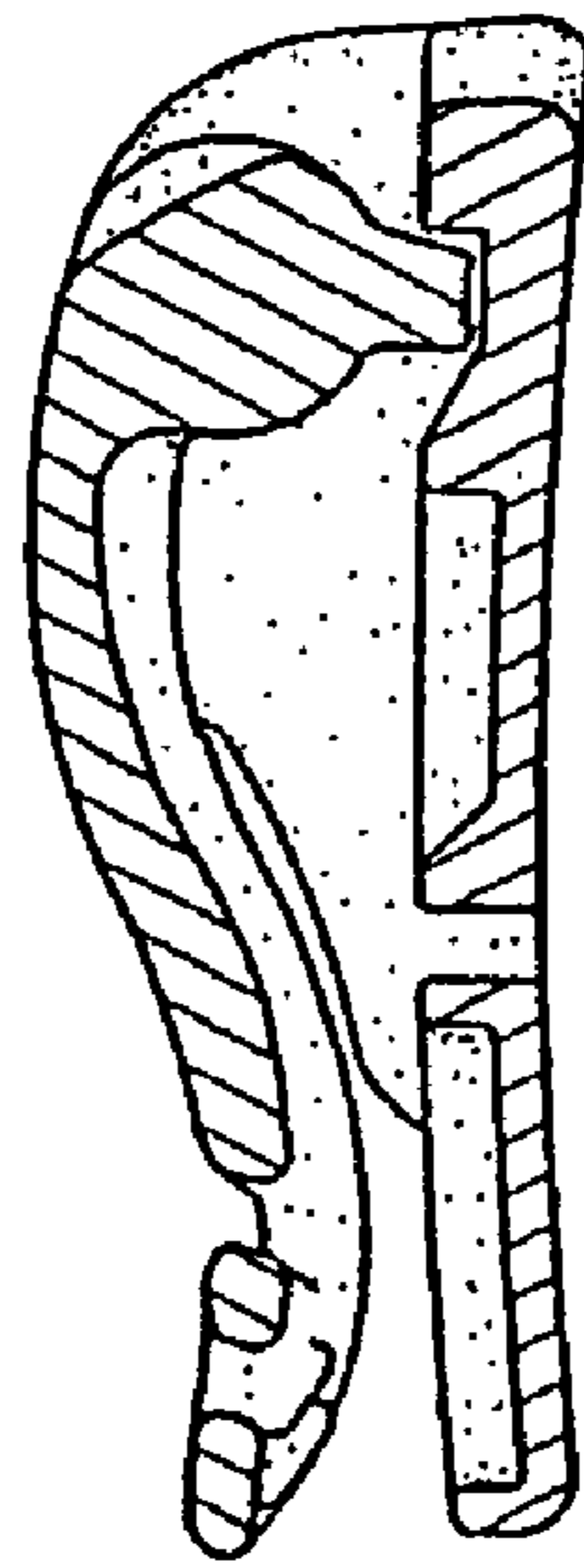
