(57) **CLAIM**

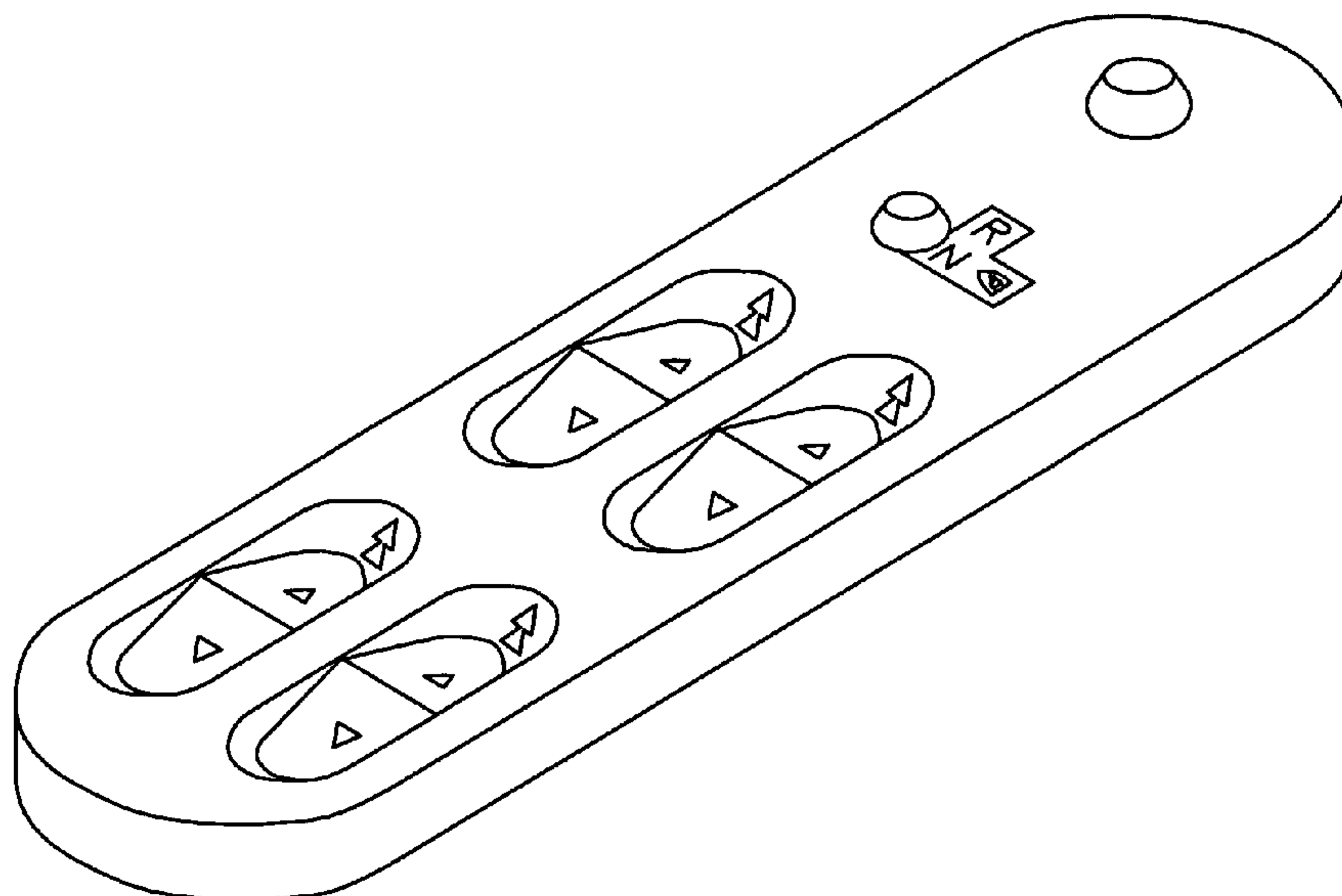
I claim the ornamental design for a stage for a motor vehicle door, as shown.

DESCRIPTION

FIG. 1 is a top view of the stage for motor vehicle door showing the new design; and,

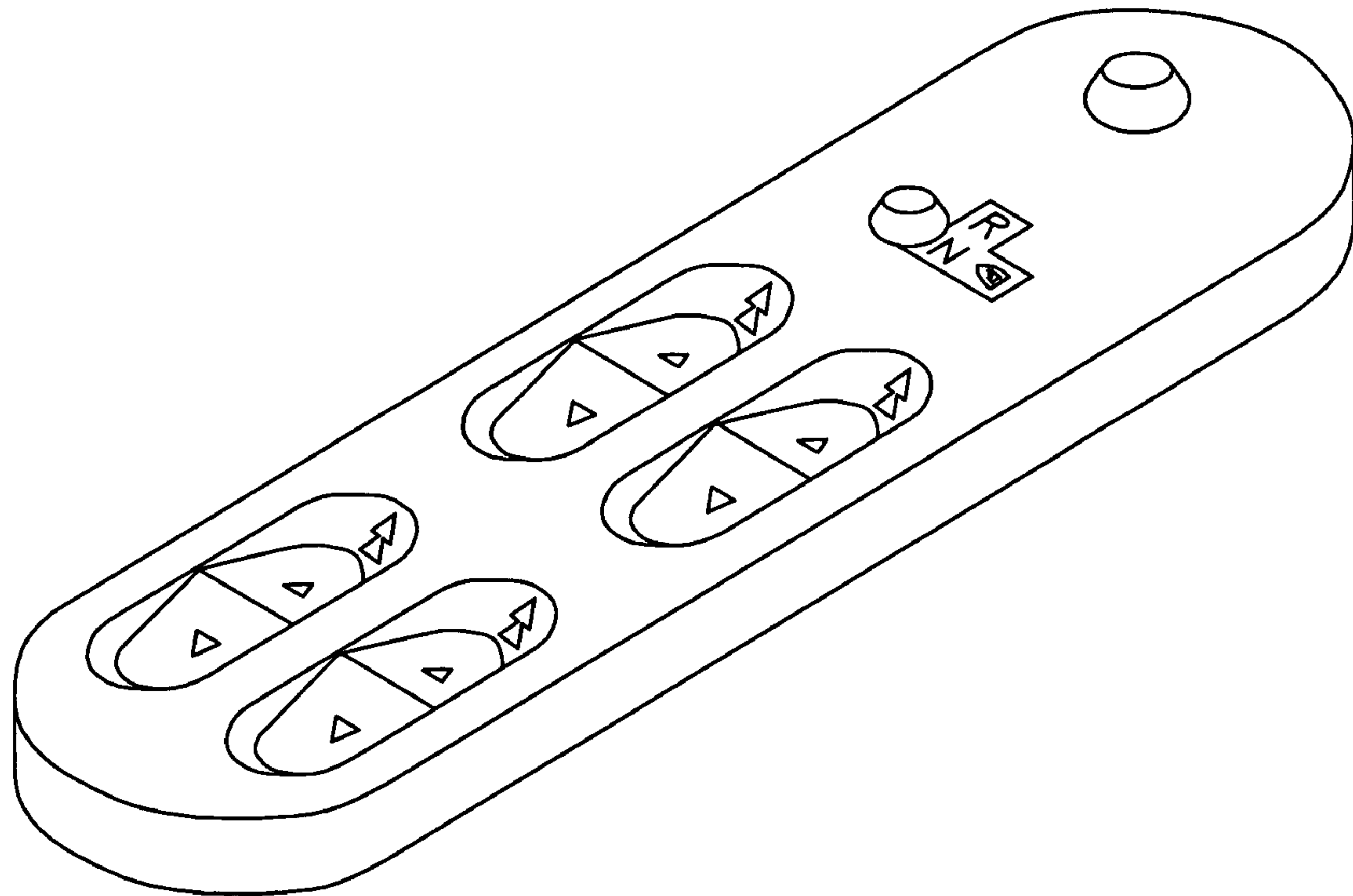

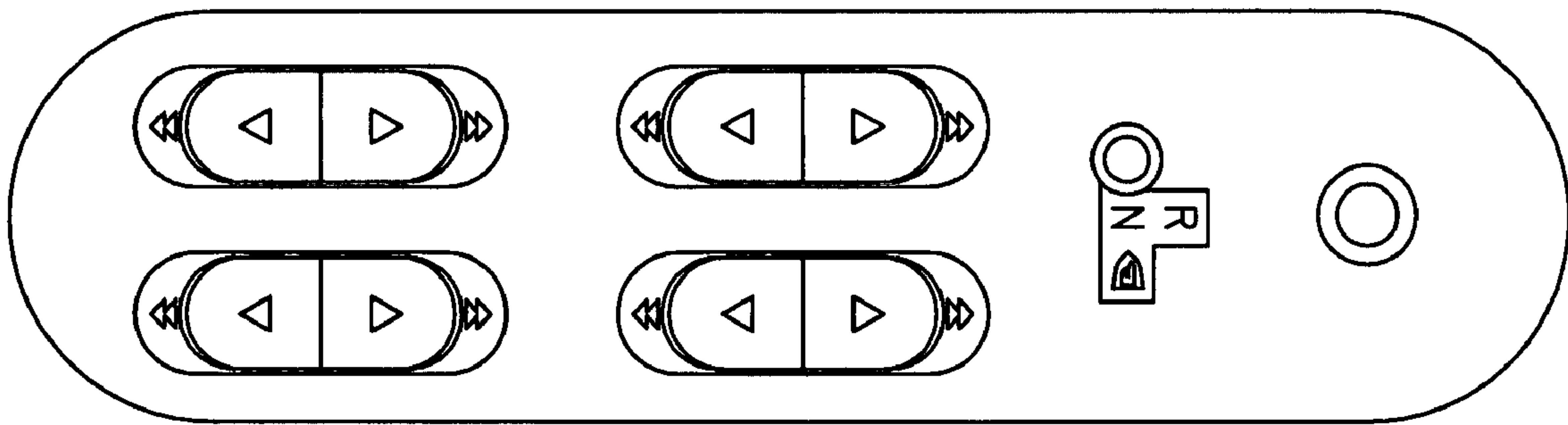
