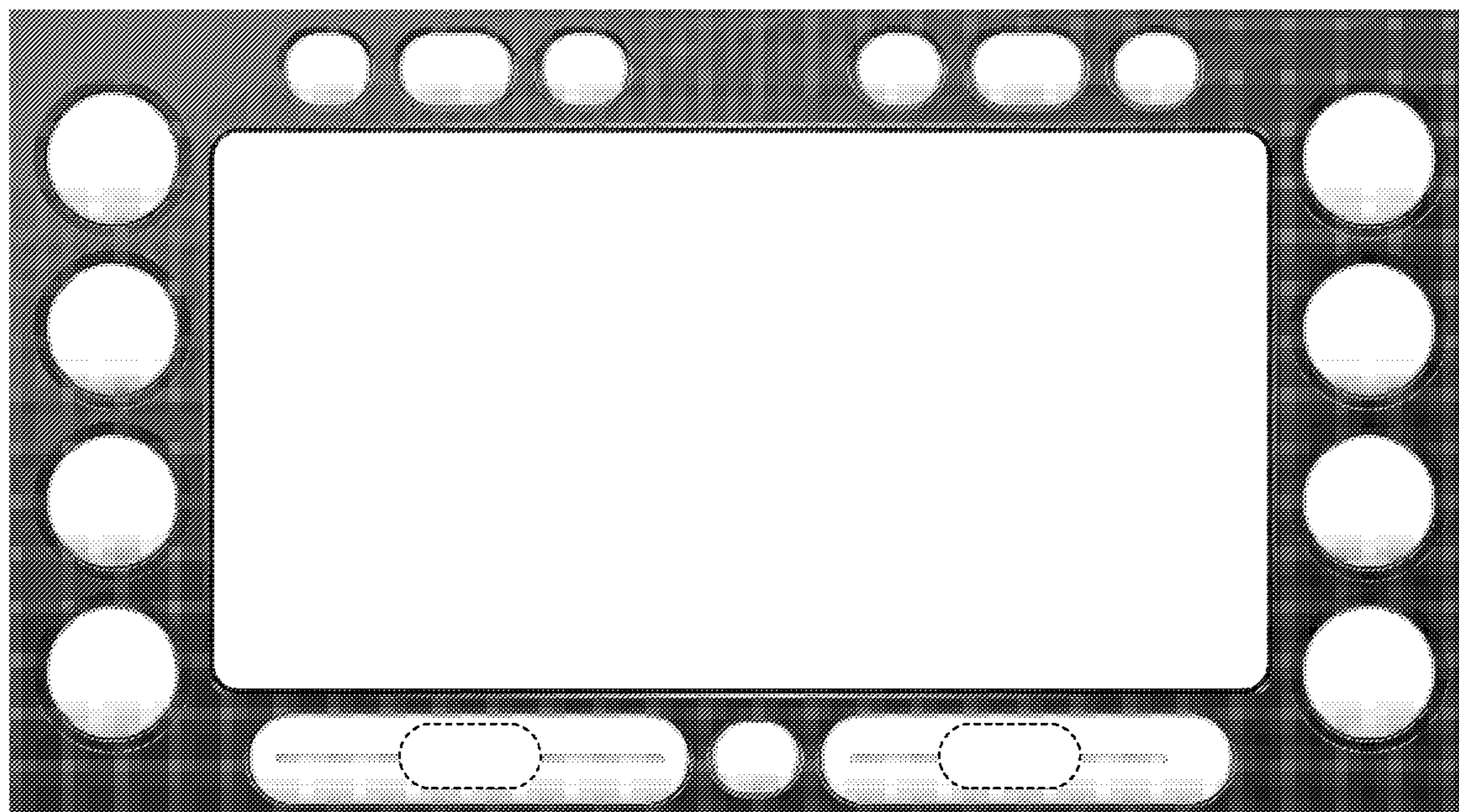
The ornamental design for a graphical user interface for a display screen, as shown and described.

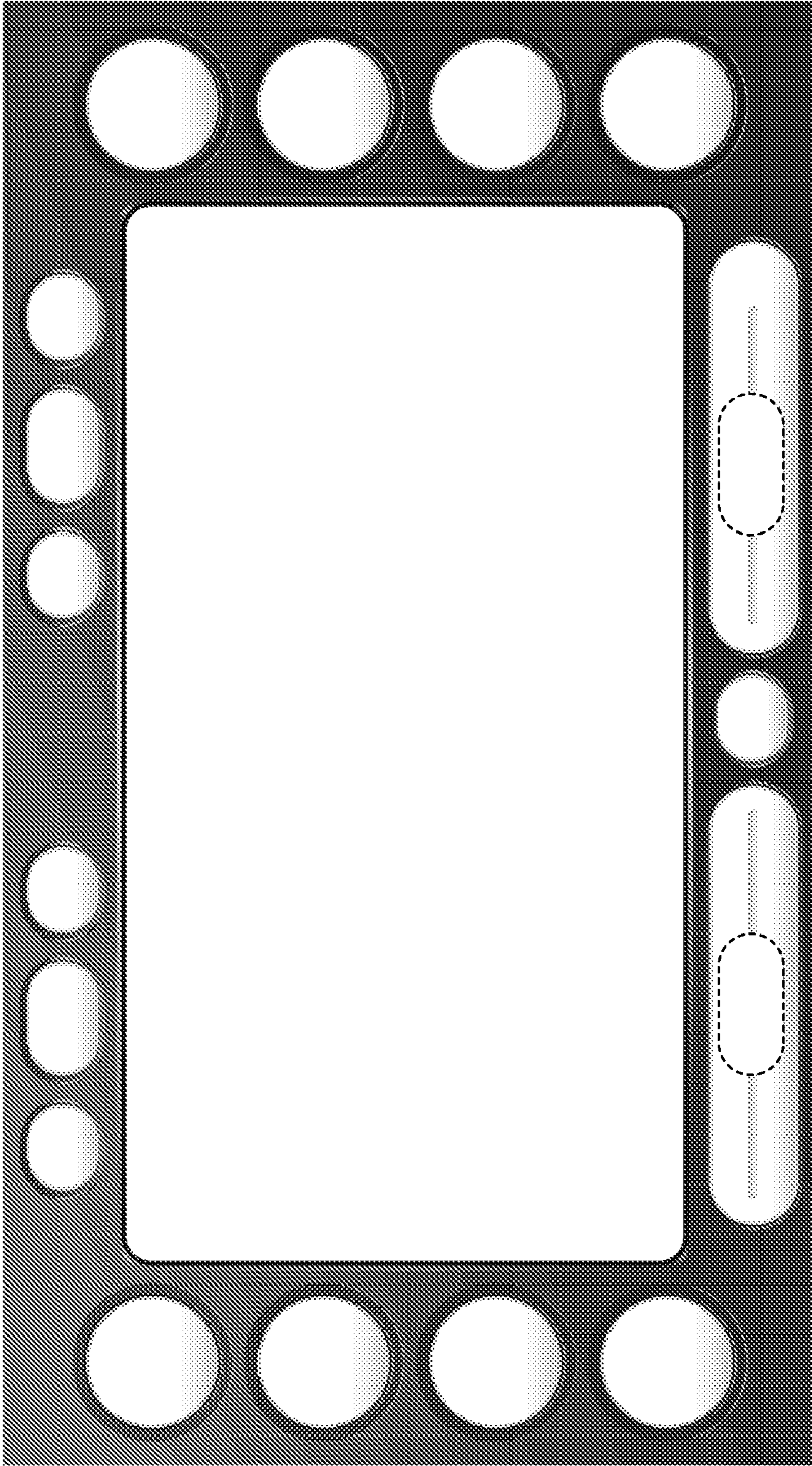
DESCRIPTION
