The broken lines in FIG. 1 represent a fisherman and are or are not part of the claimed design

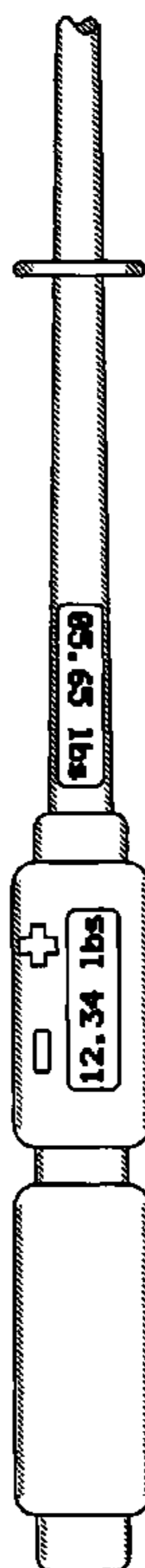
The broken lines of the reel shown in FIG. 2 and FIG. 3 is shown for the convenience of illustration and is not part of the claimed invention.

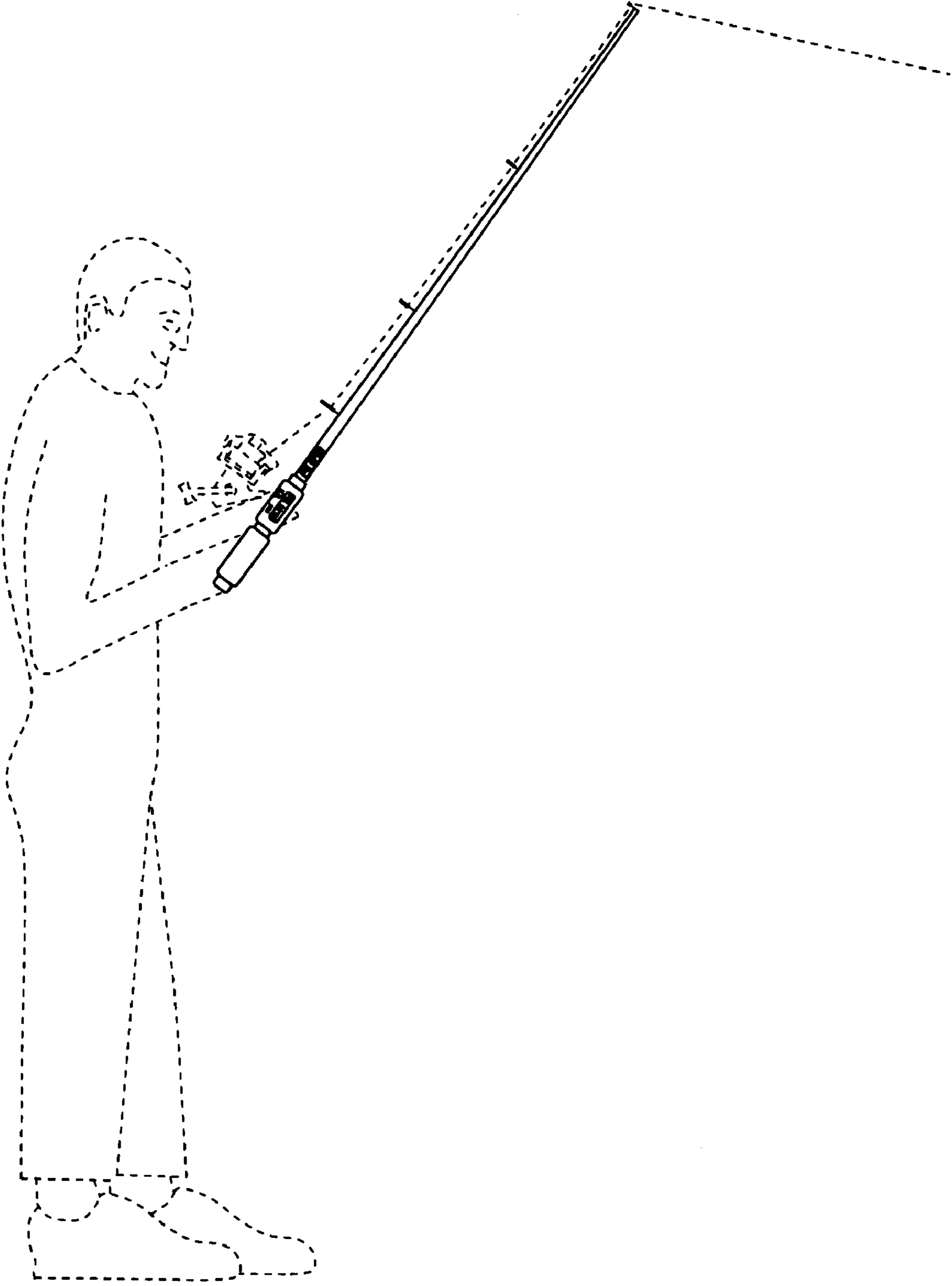

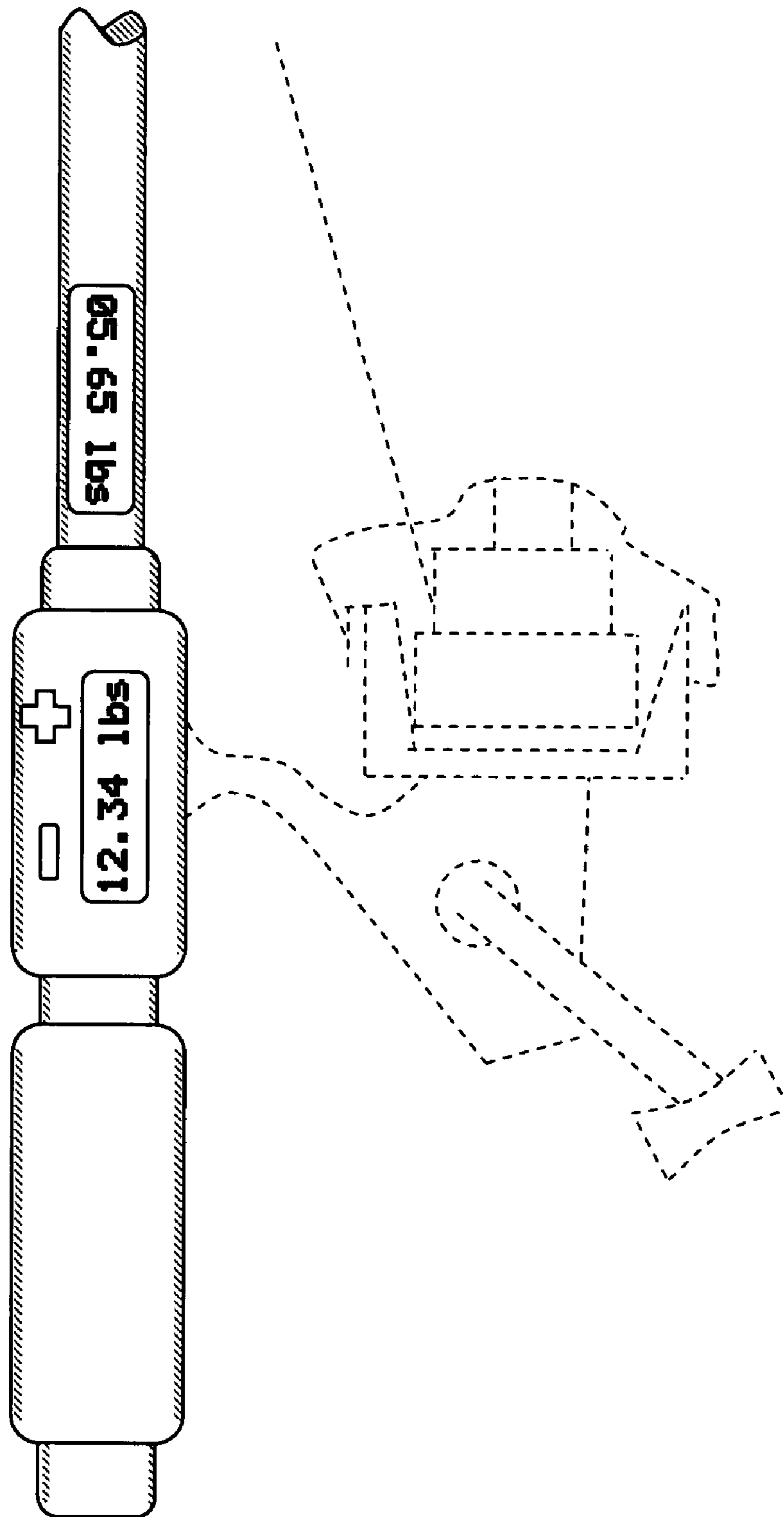

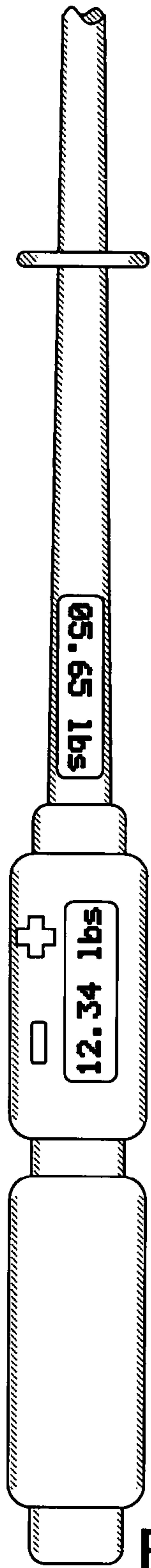

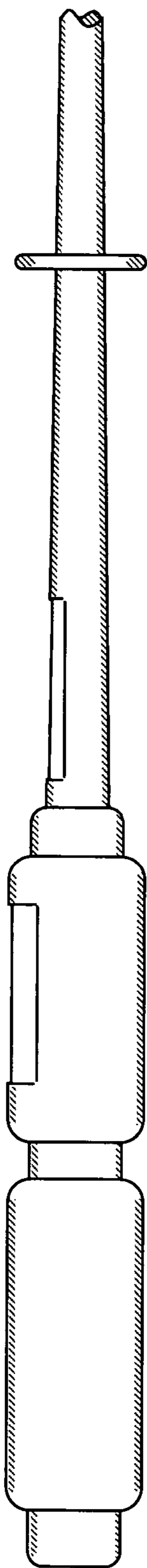

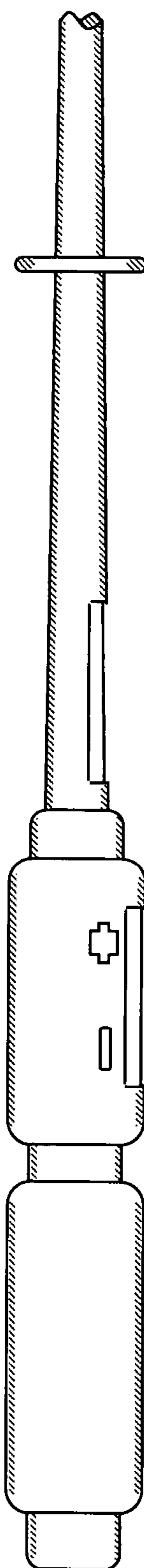

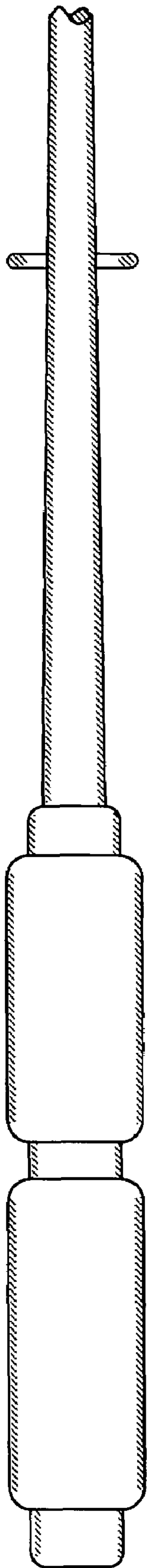

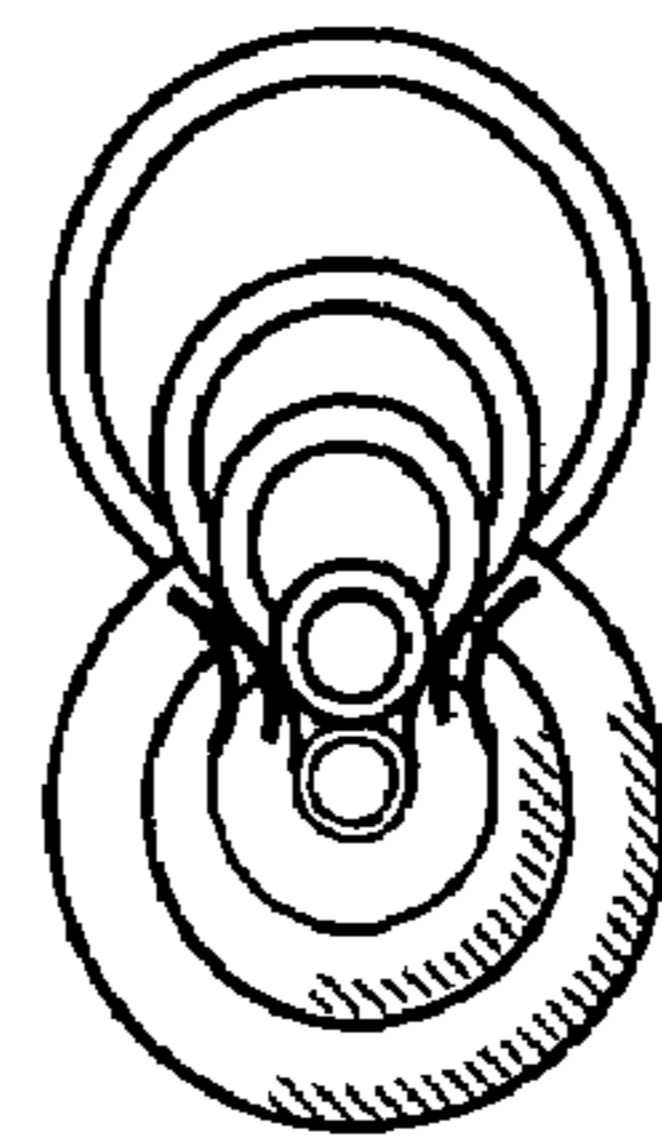

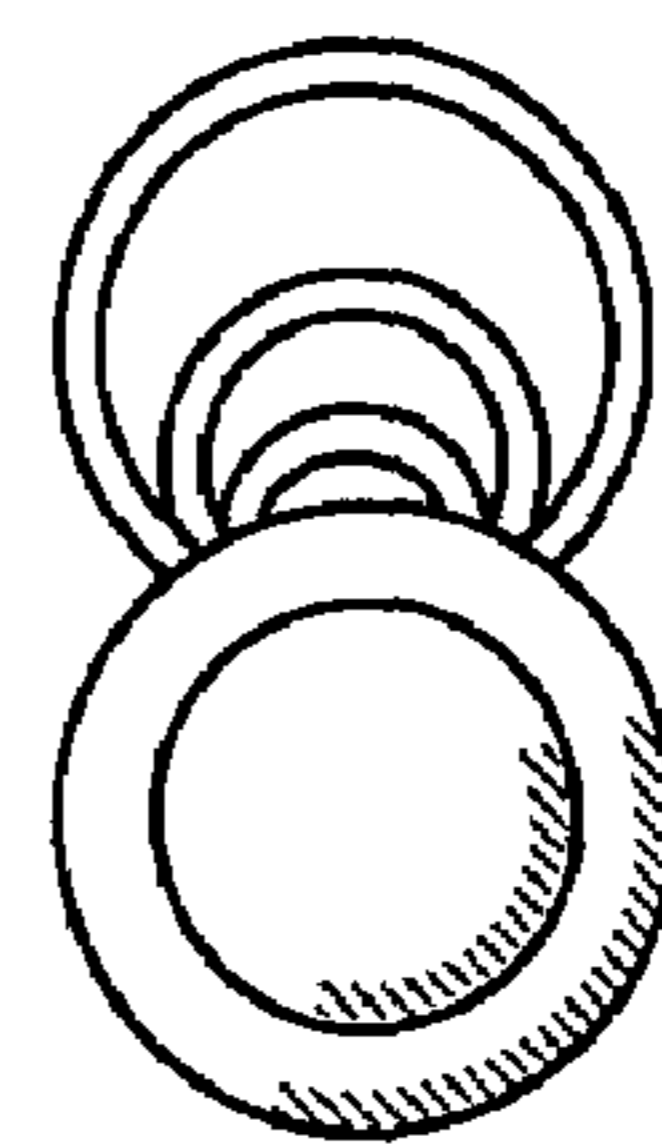
