FIG. 2 shows a bottom perspective view thereof;

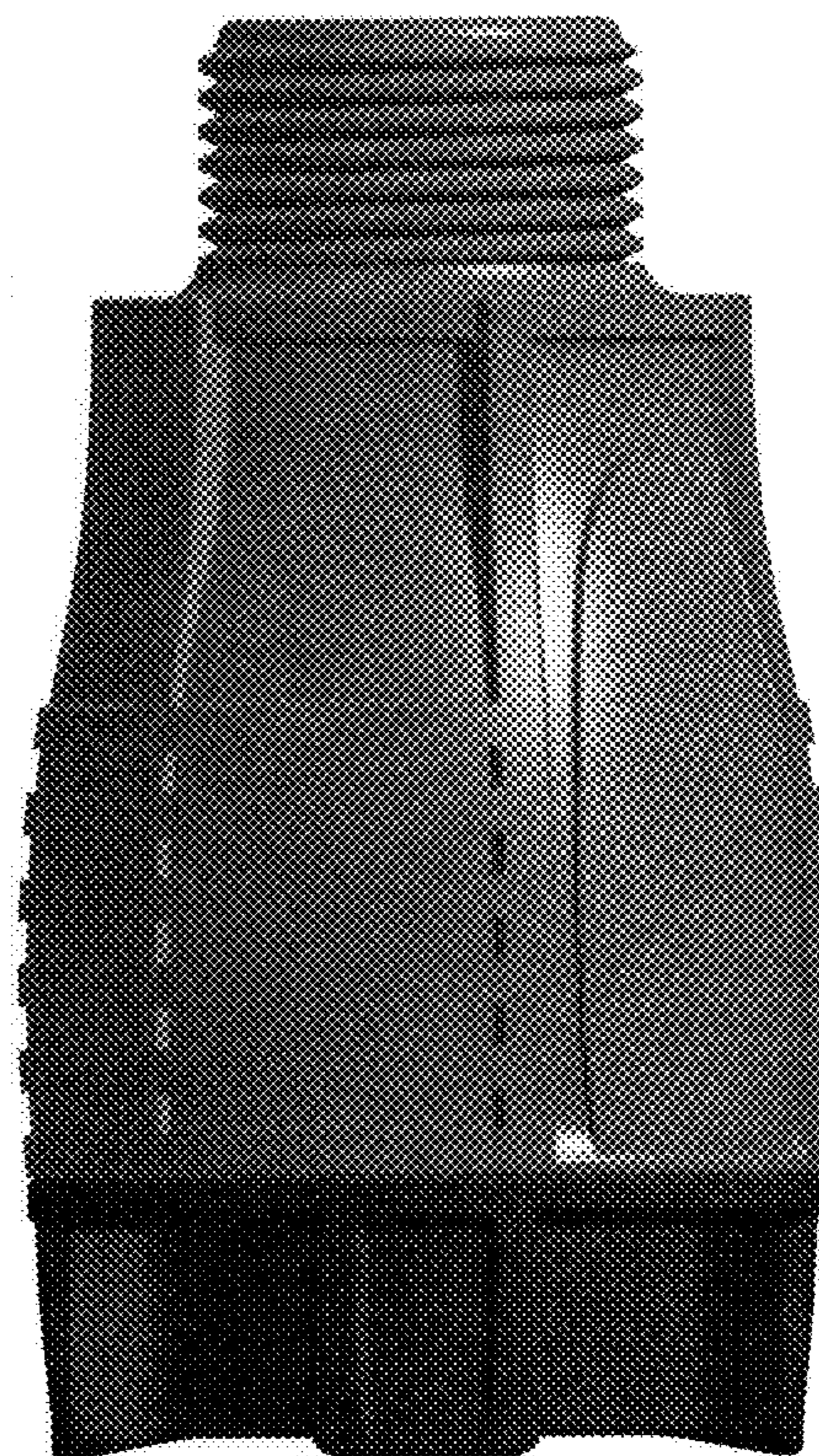
FIG. 3 shows a bottom perspective view thereof, rotated 45° from FIG. 2;

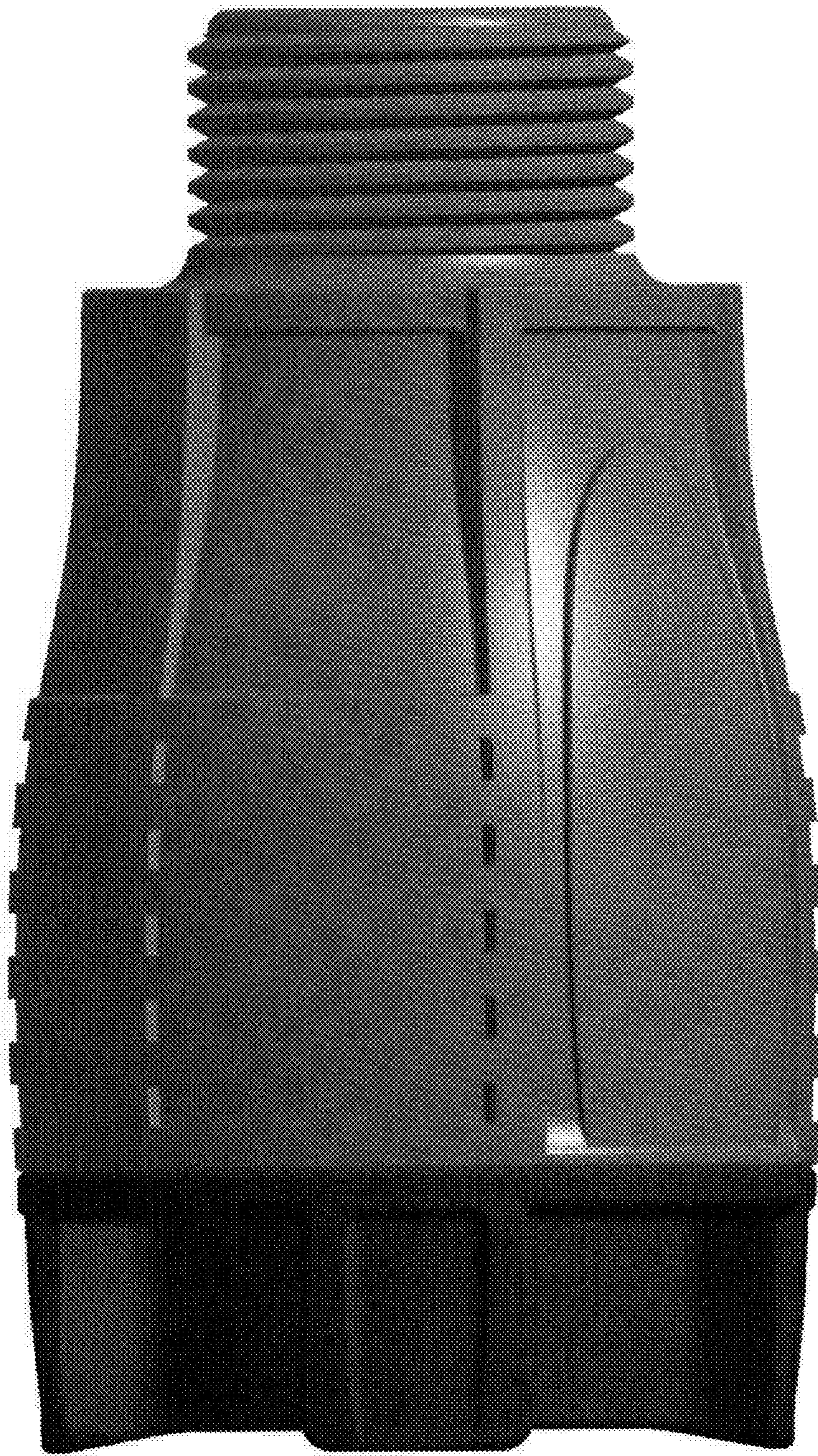

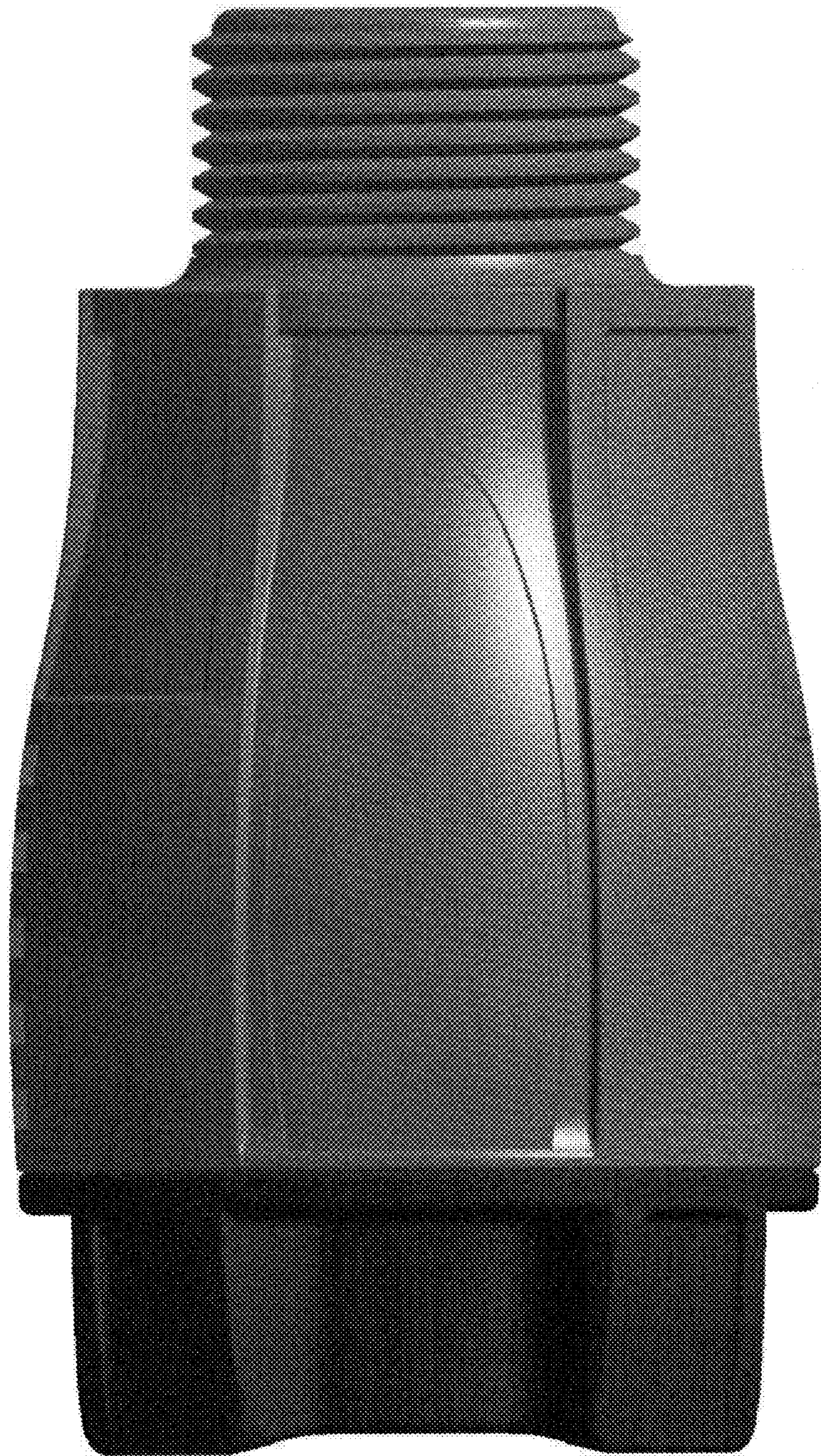

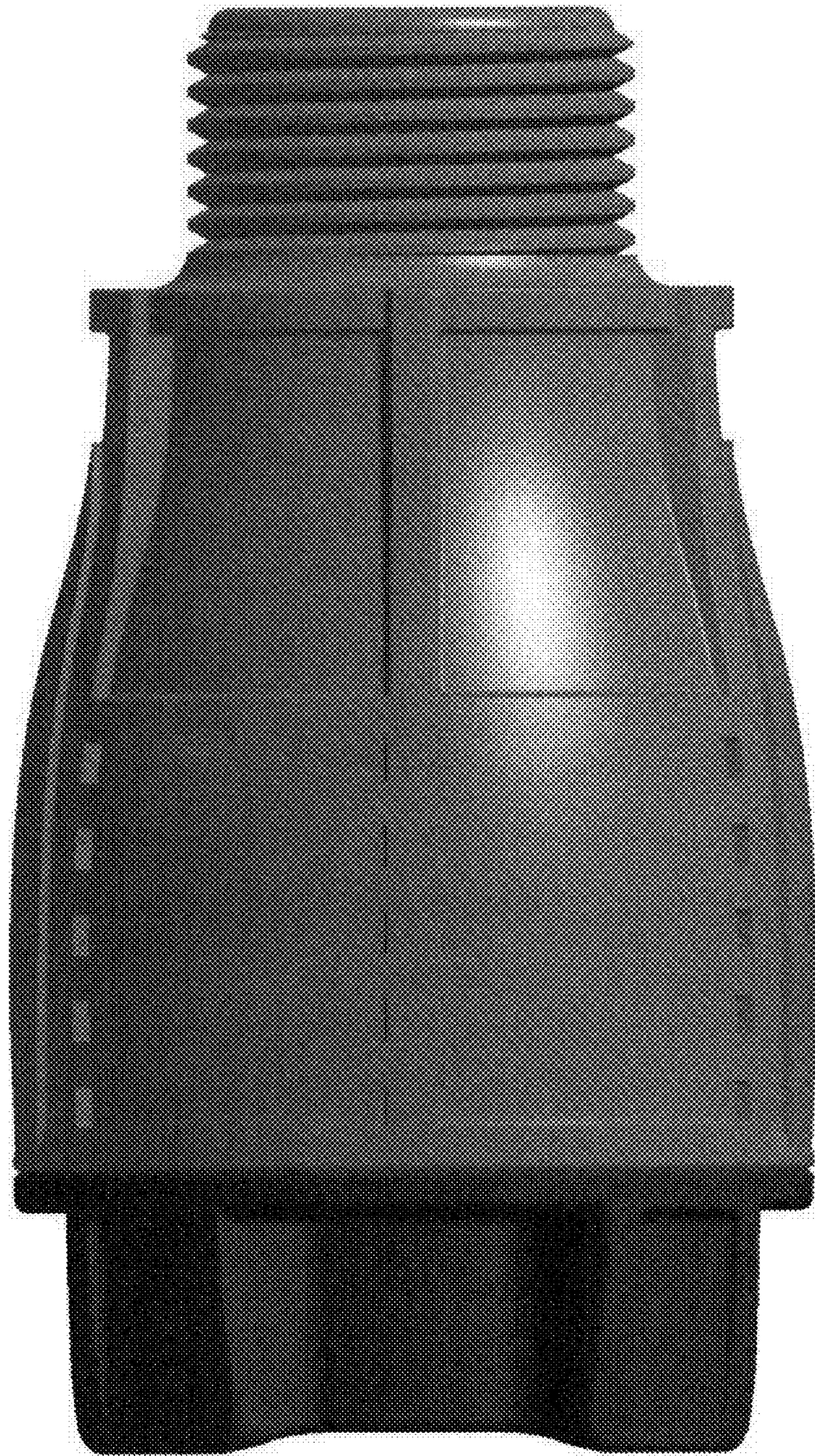
