(57) **CLAIM**

The ornamental design for a pipe gasket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the pipe gasket of the invention showing the overall profile of the gasket;

FIG. 2 is a left side view of the pipe gasket of FIG. 1;

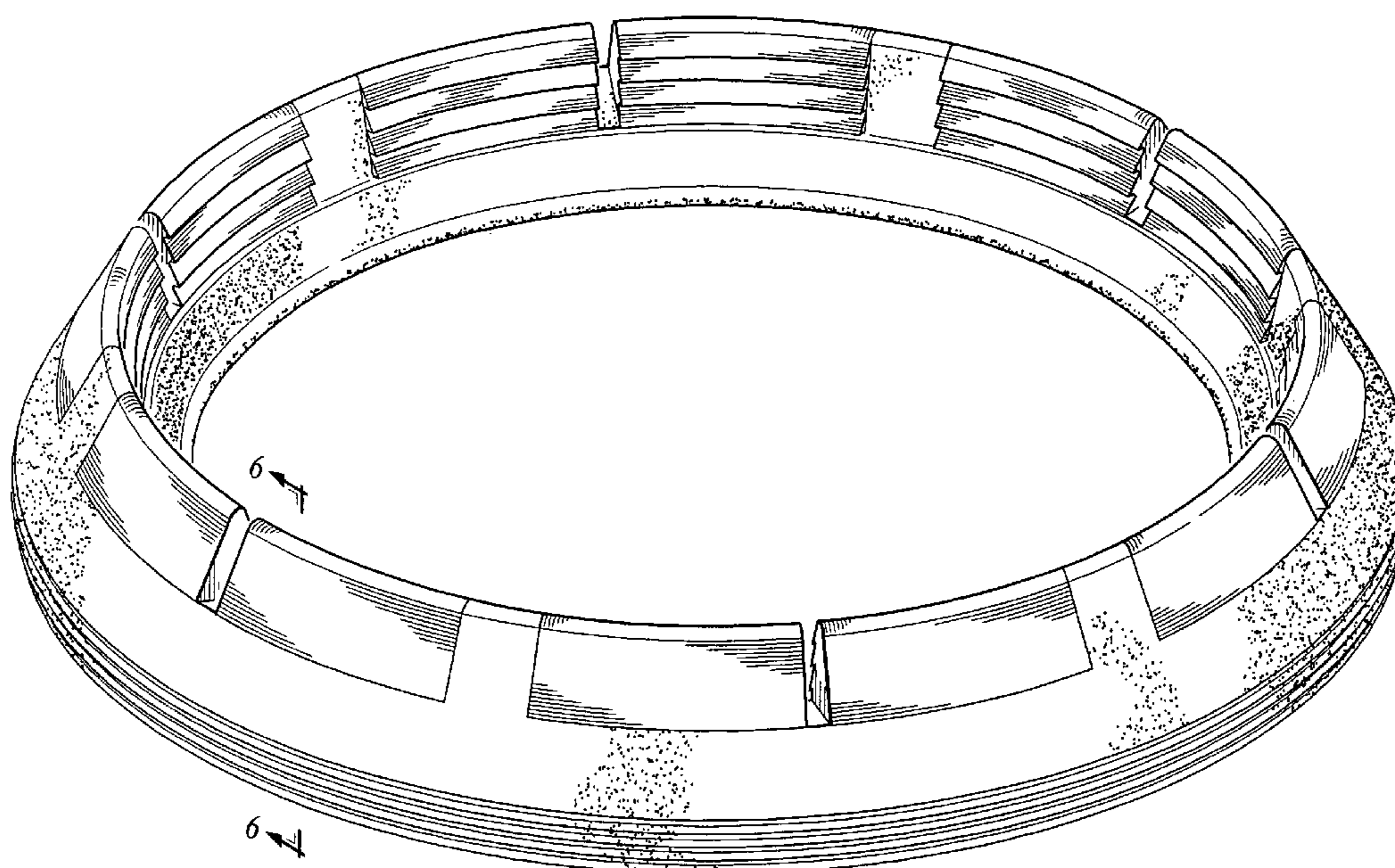
FIG. 3 is a right side view of the pipe gasket of FIG. 1;

FIG. 4 is a top view of the pipe gasket of FIG. 1;

FIG. 5 is a bottom view of the pipe gasket of FIG. 1; and,

FIG. 6 is a cross sectional view of the pipe gasket showing the detail of the external surfaces of the gasket, taken along line 6—6 as shown in FIG. 1.

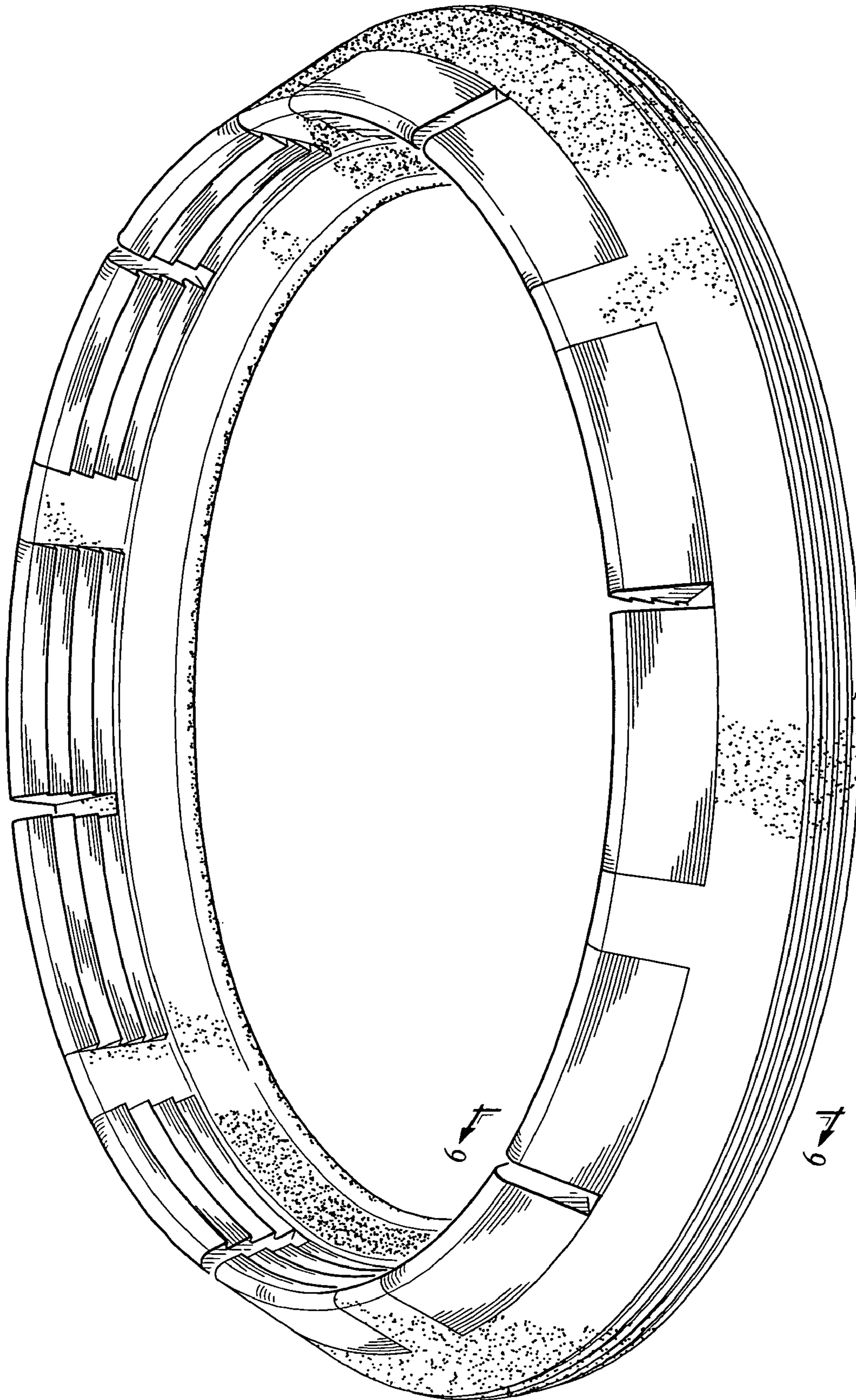

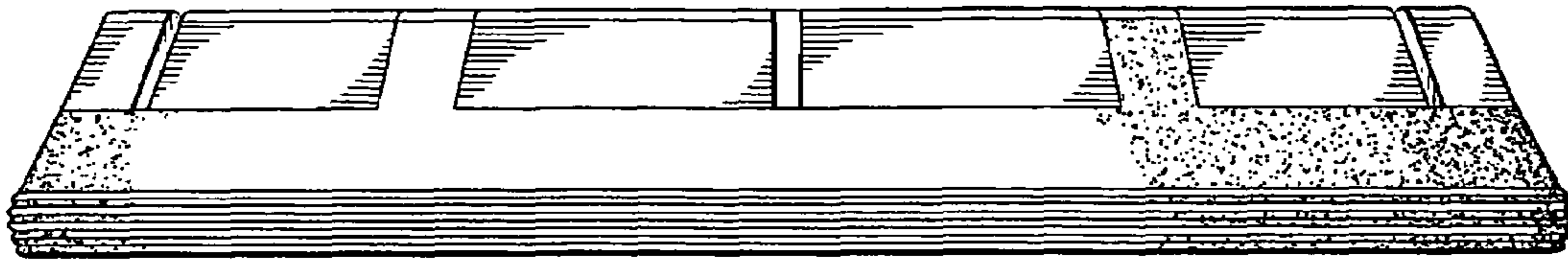

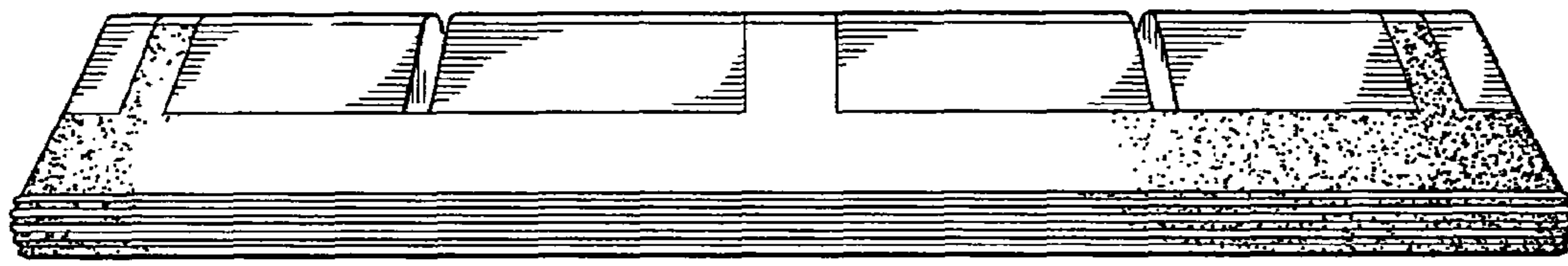

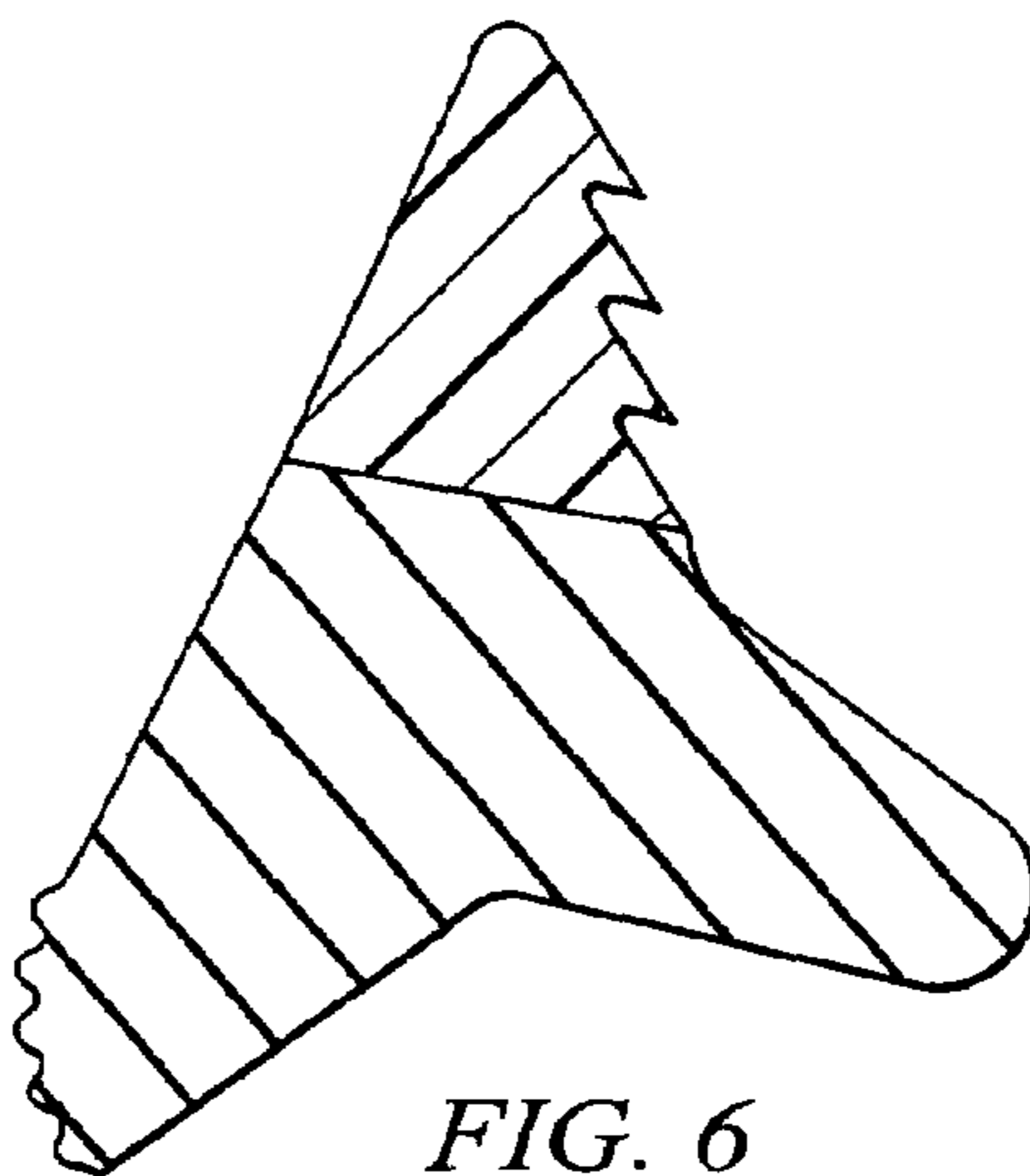

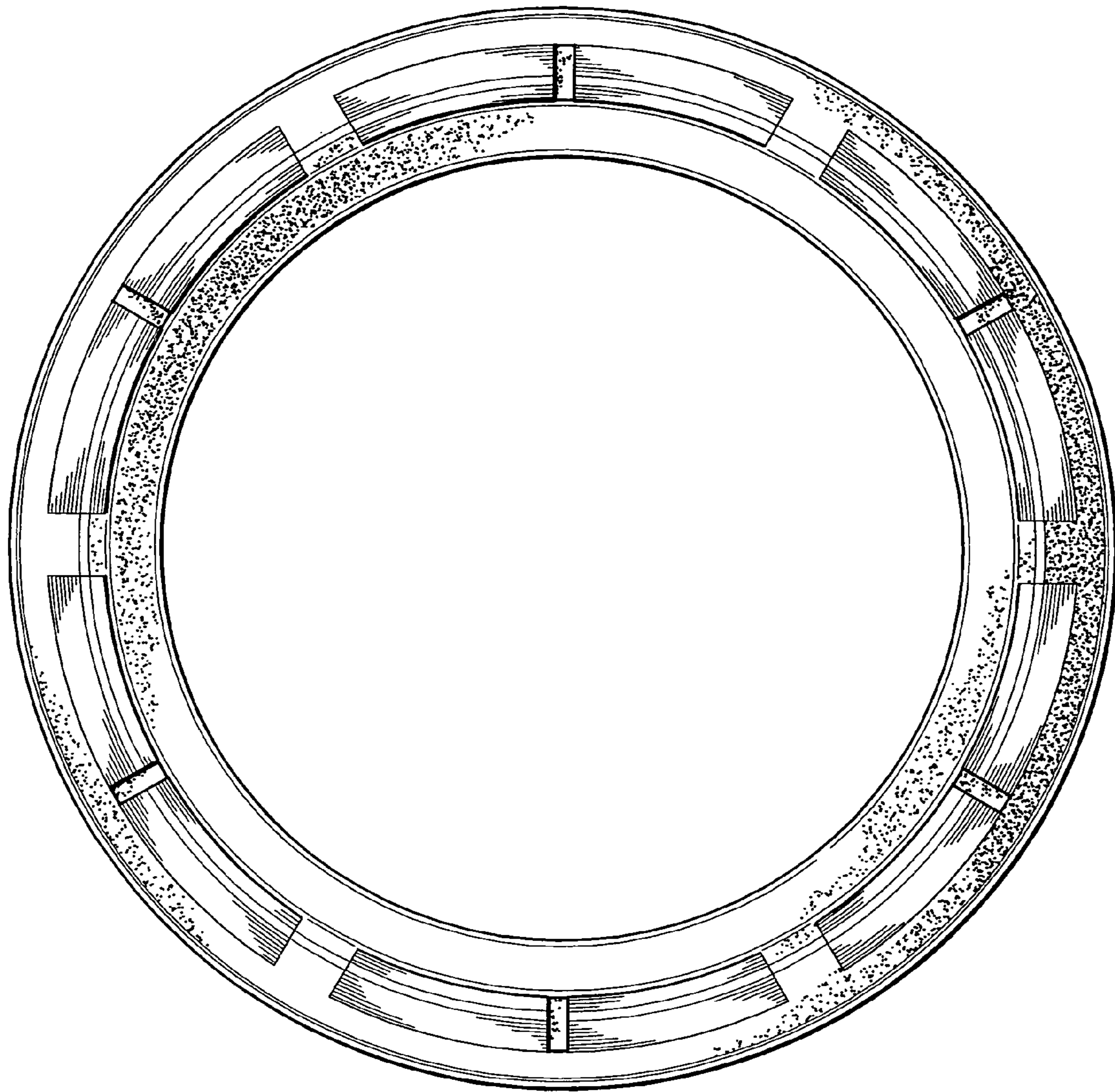
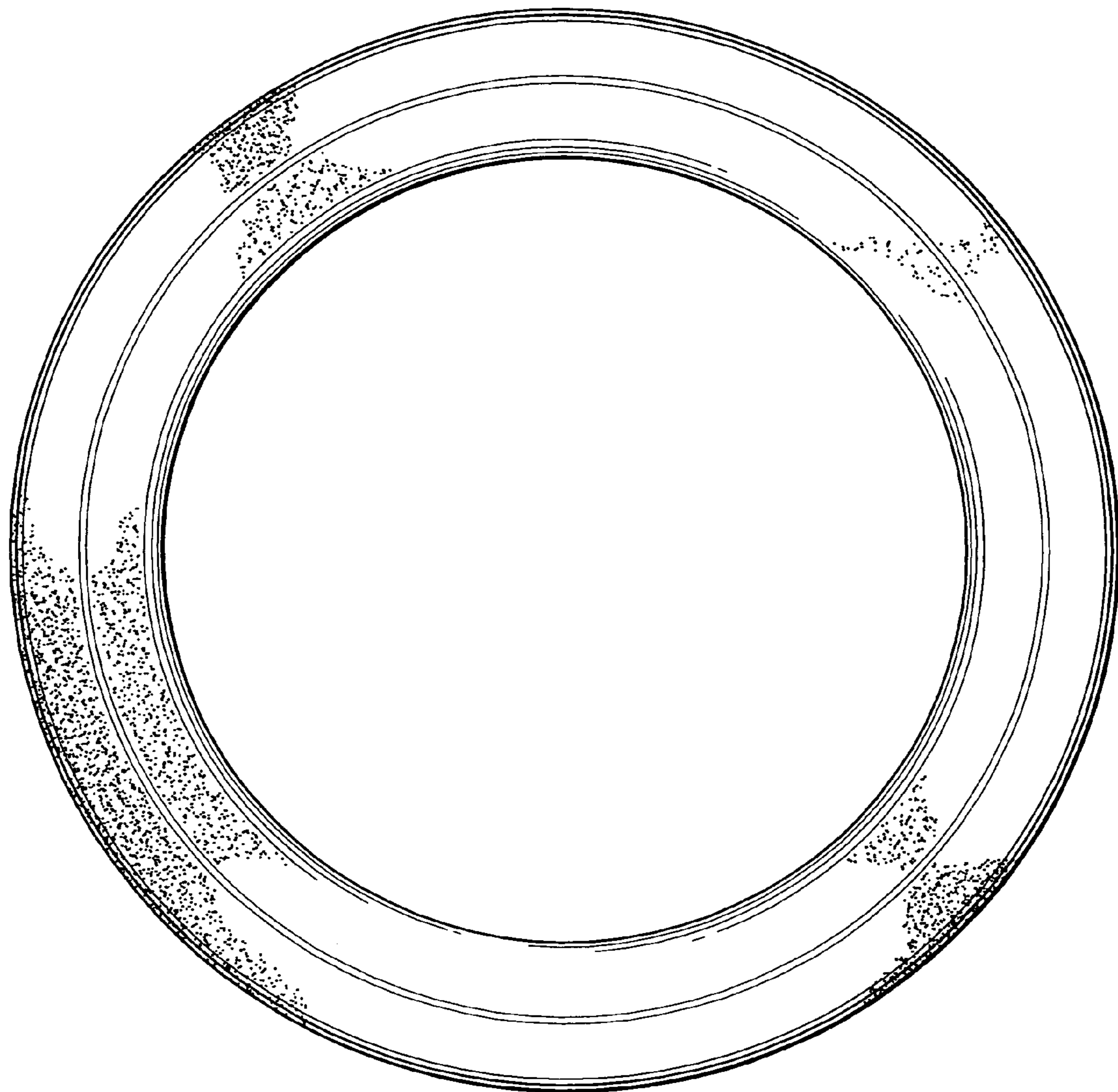
