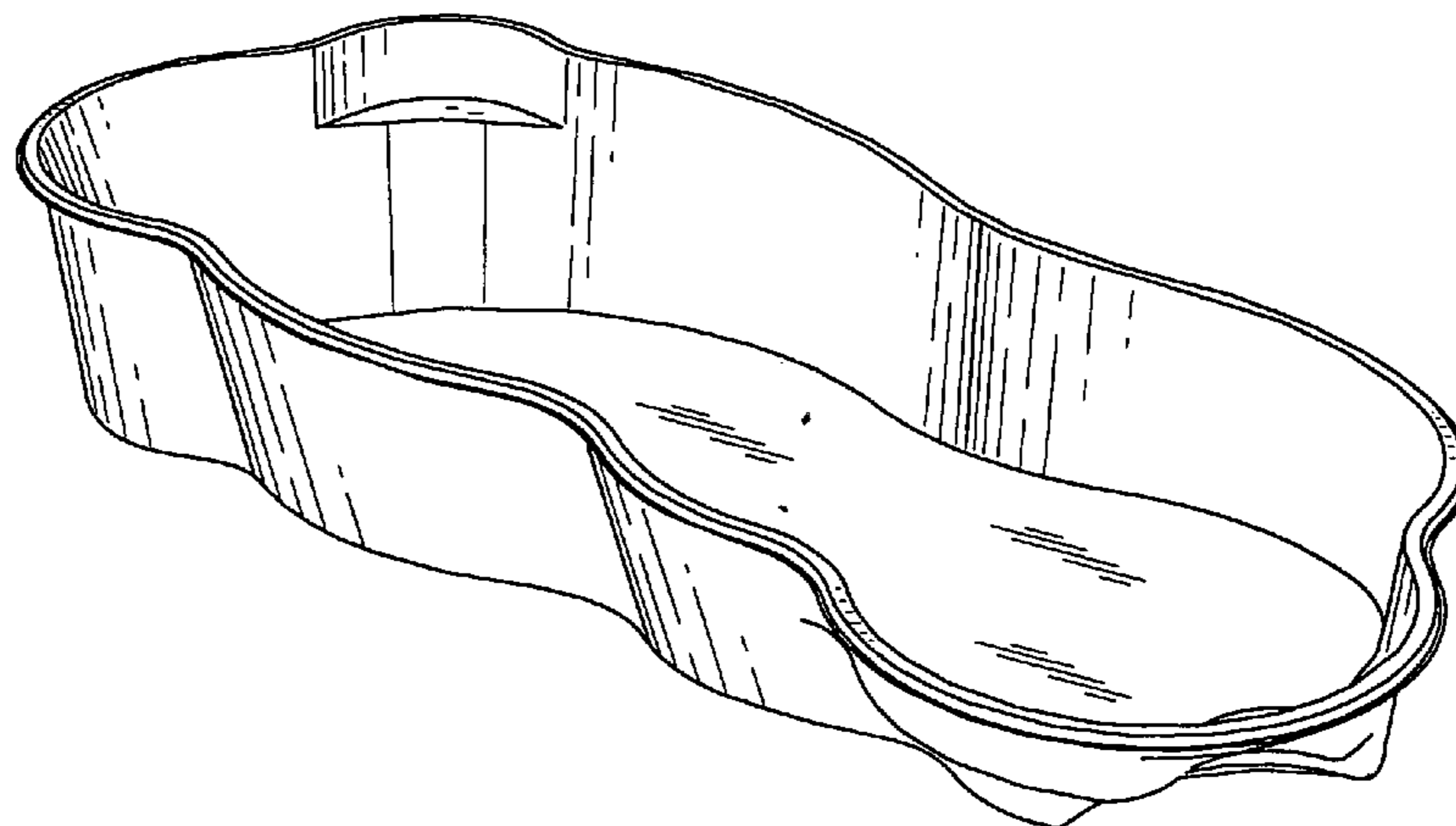

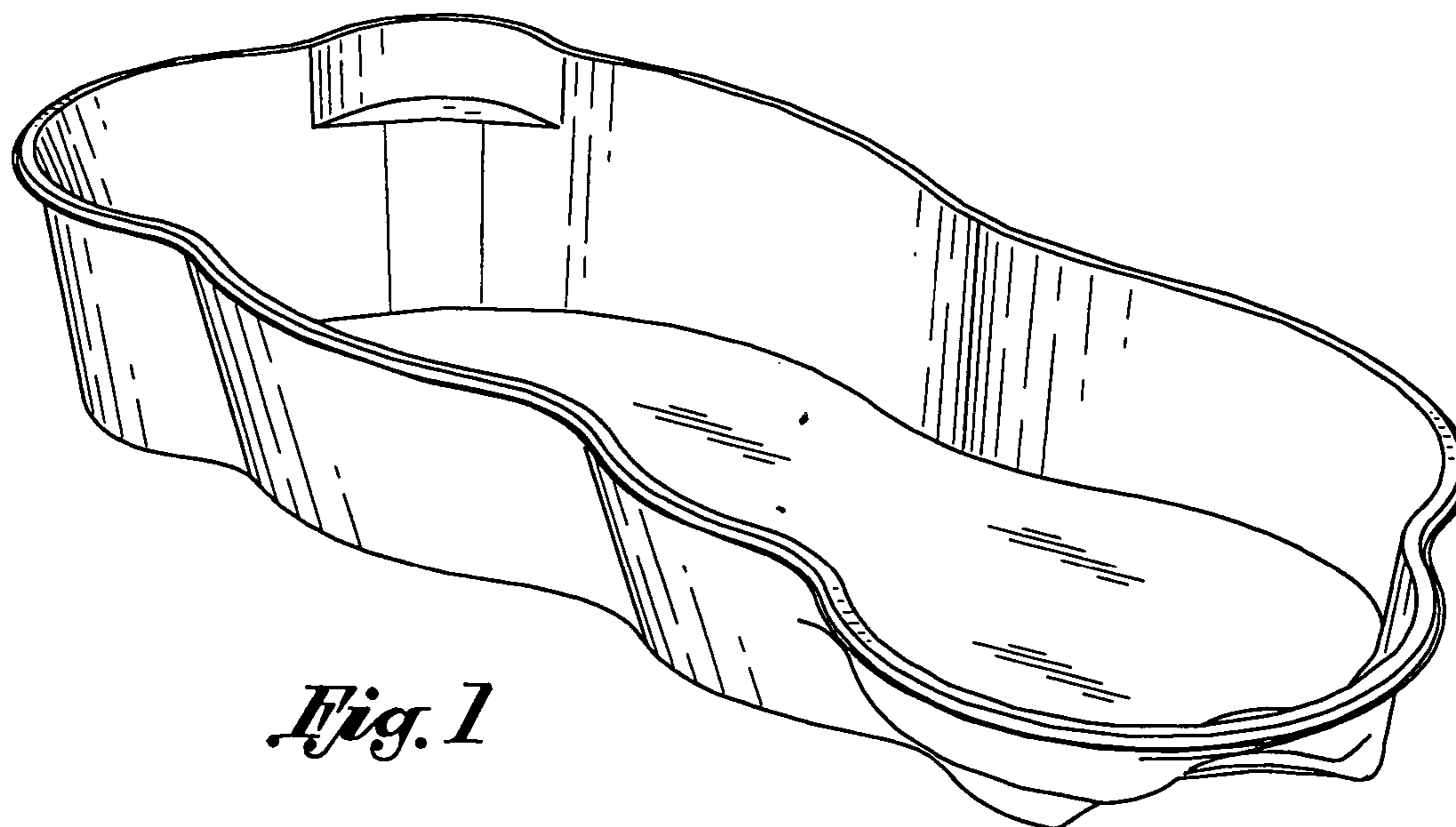
The ornamental design for a fiberglass swimming pool, as shown and described.

**DESCRIPTION**

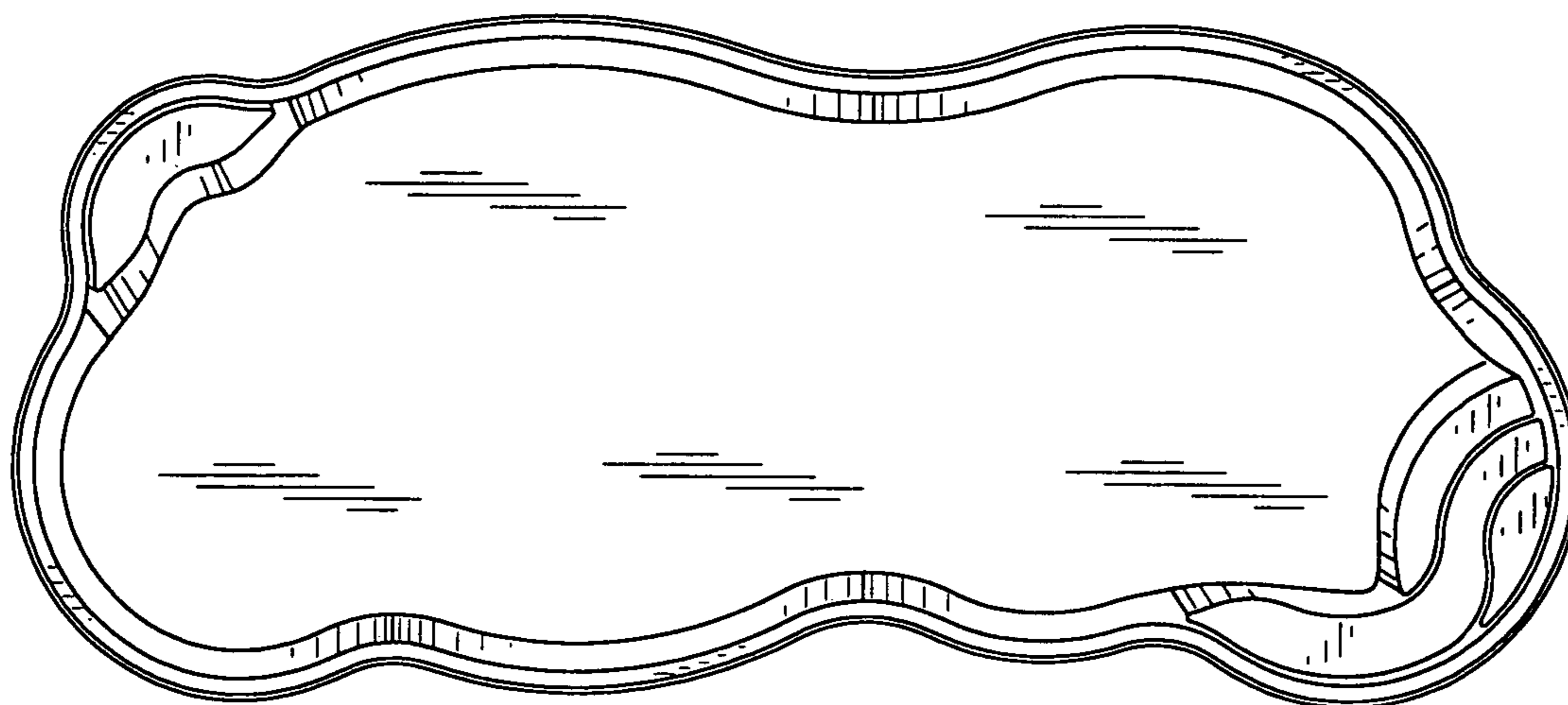
- FIG. 1 is an elevated perspective view of a fiberglass swimming pool showing my new design;

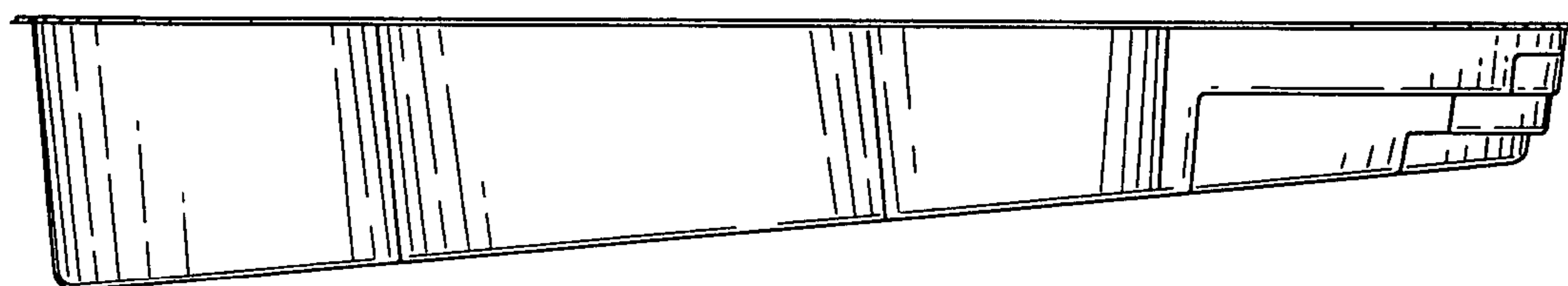




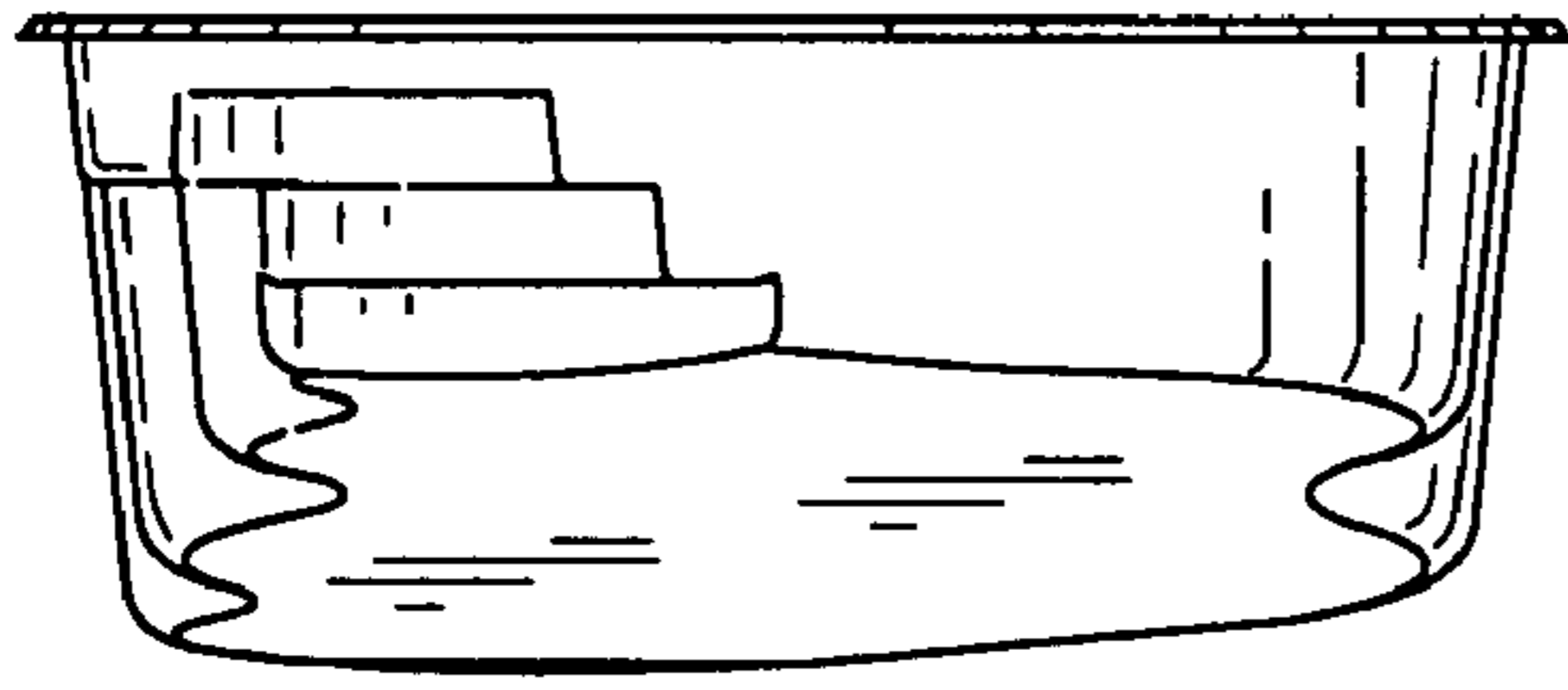

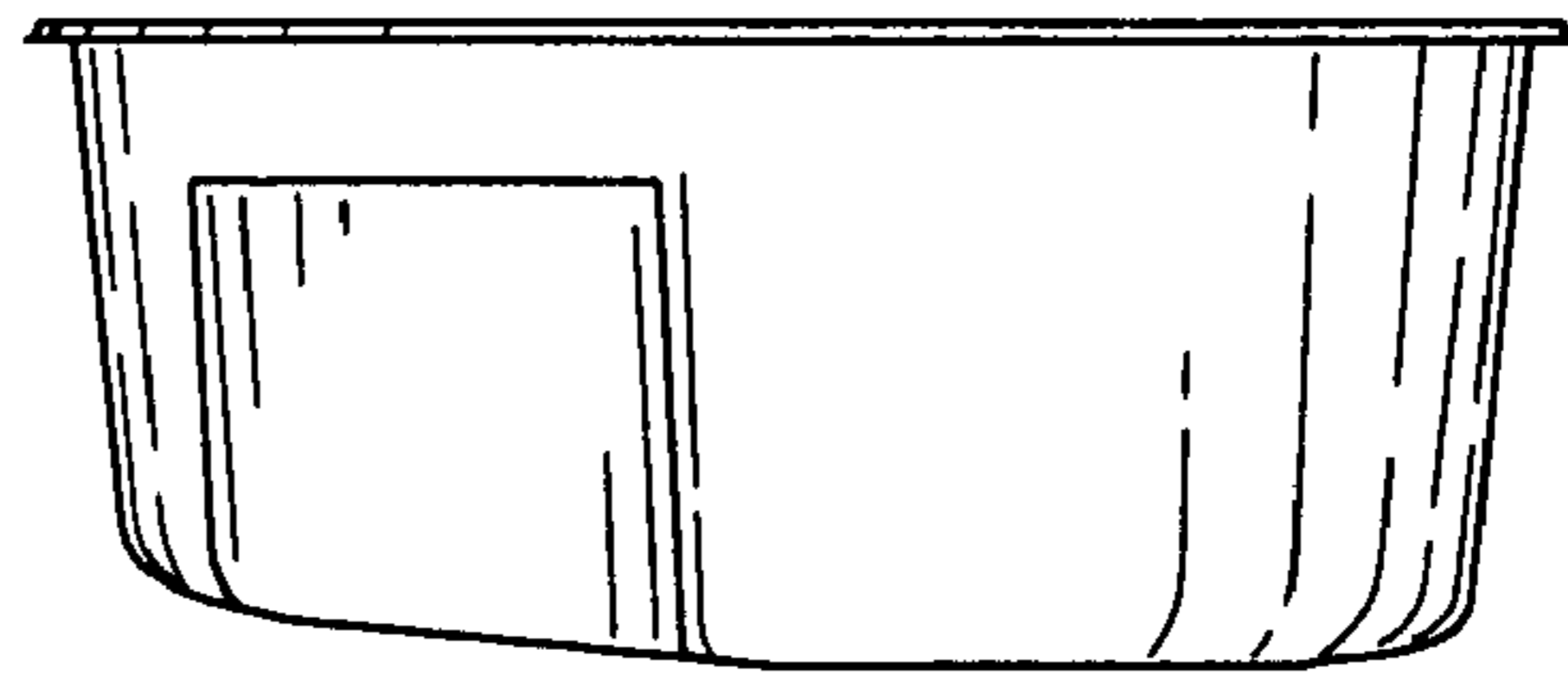

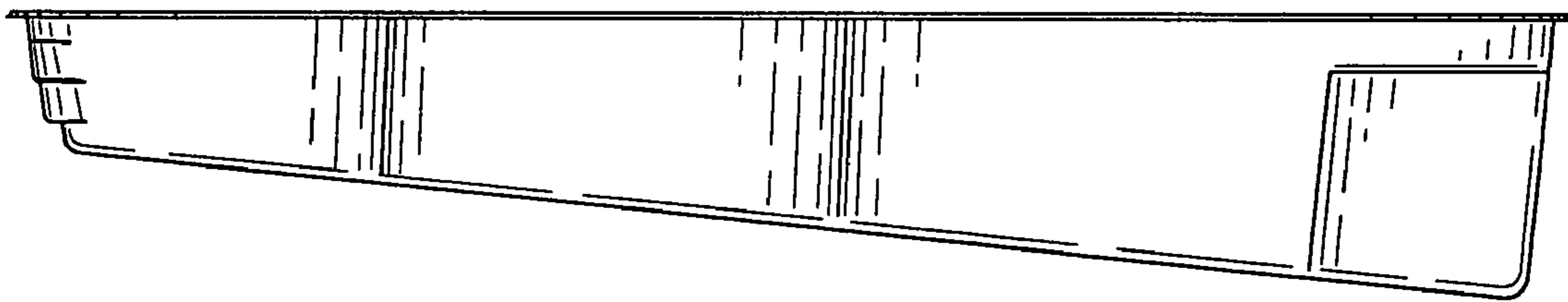

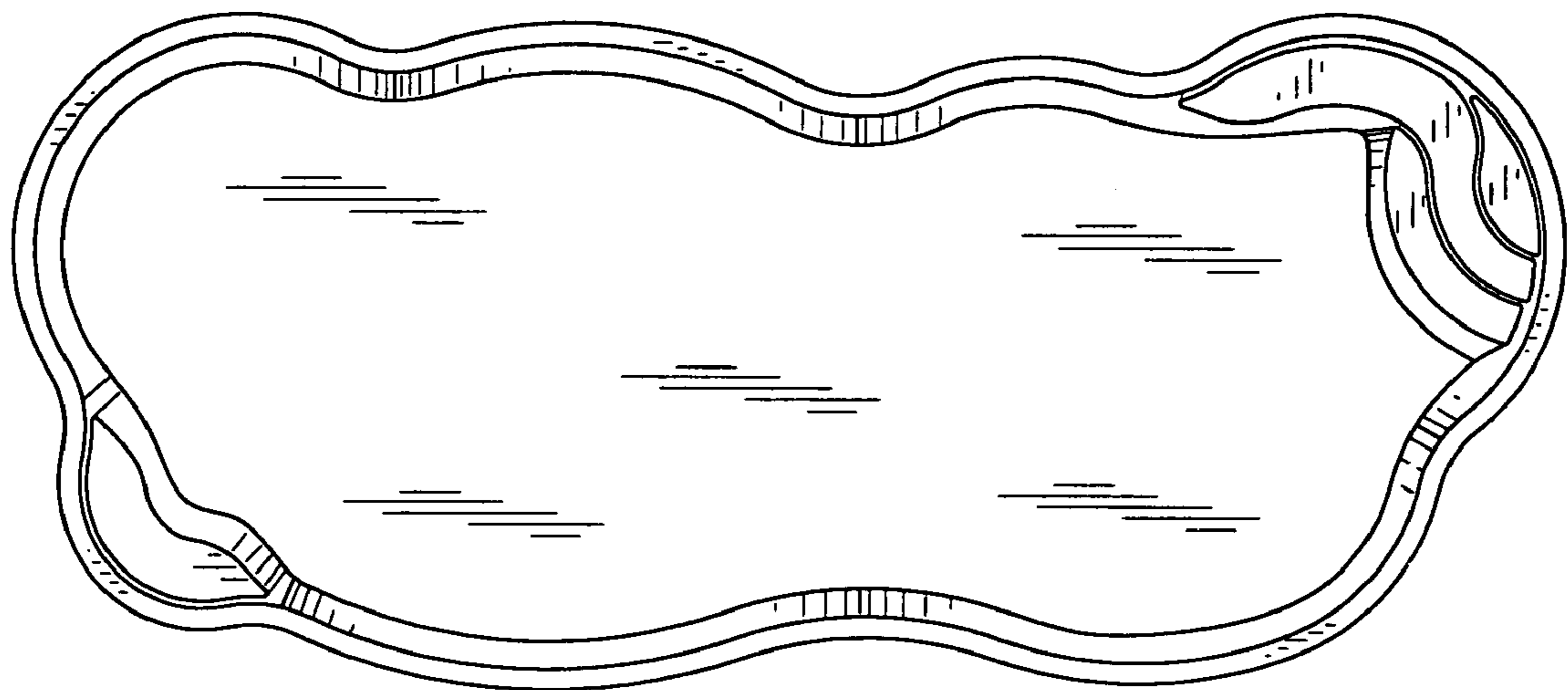
