The ornamental design for a living module, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a living module showing my new design;

FIG. 2 is a top, left, rear perspective view of a living module showing my new design;

FIG. 3 is a right side elevational view of the living module shown in FIG. 1;

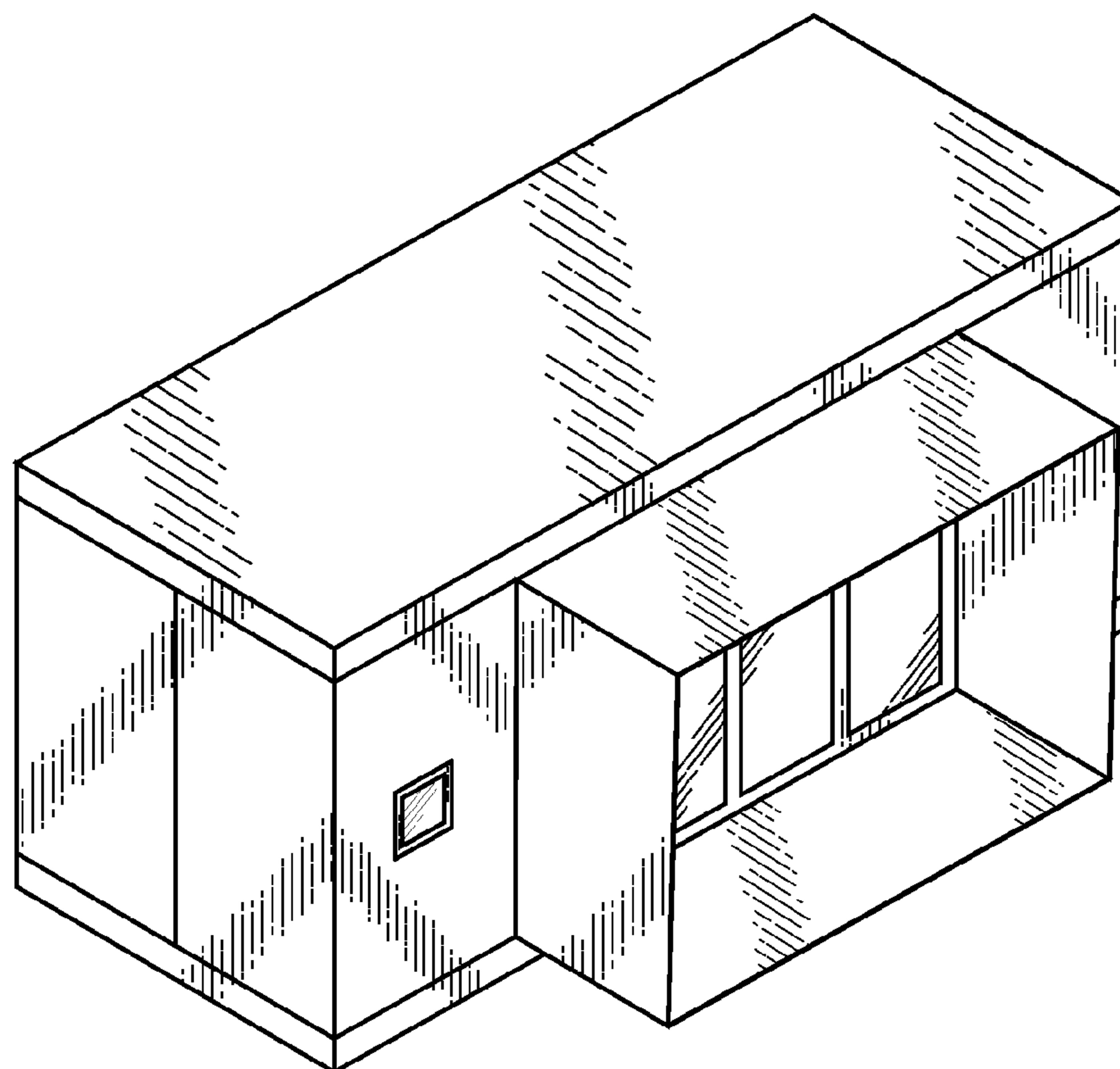
FIG. 4 is a front elevational view of the living module shown in FIG. 1;

FIG. 5 is a left side elevational view of the living module shown in FIG. 1; and,

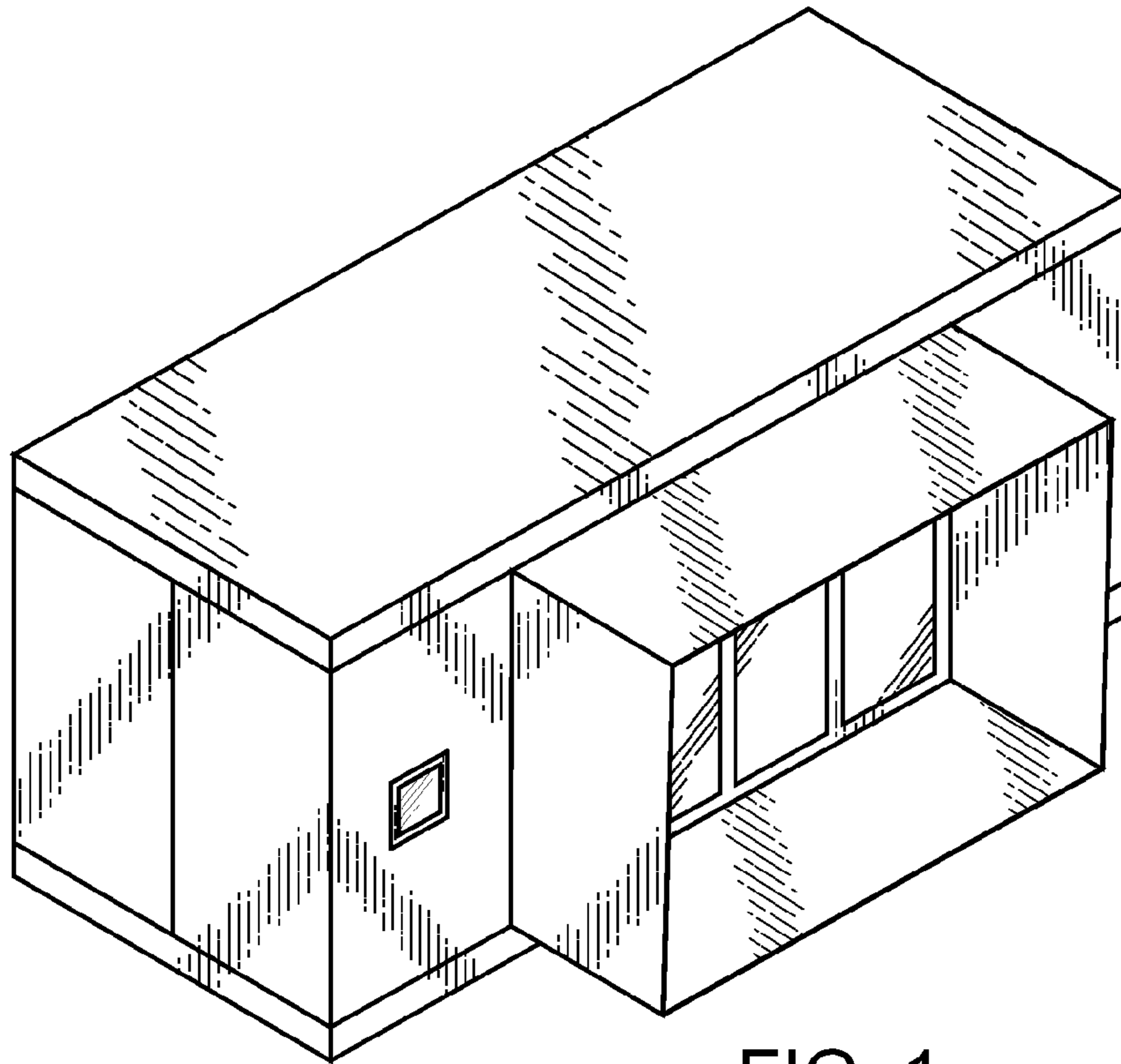

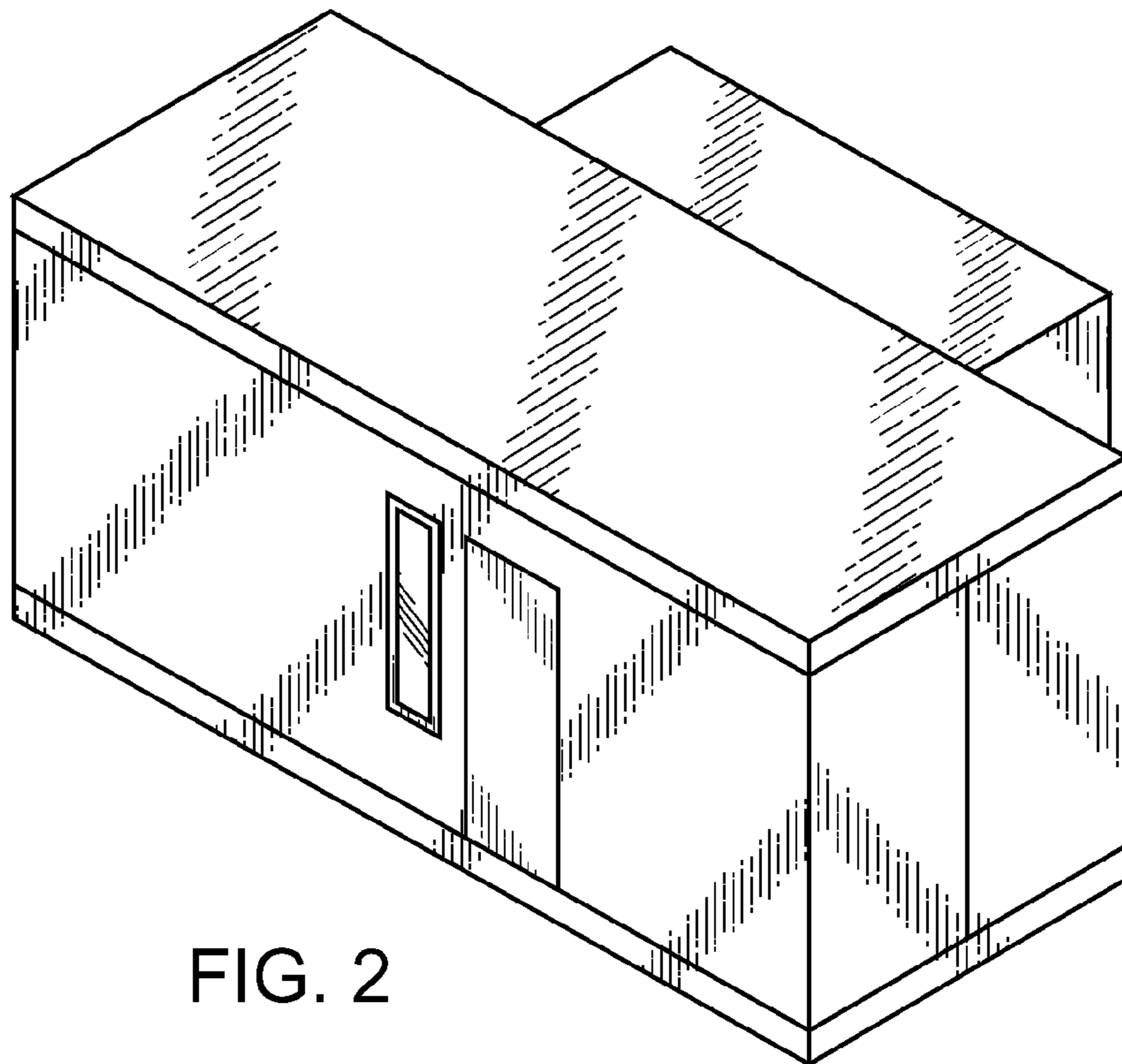

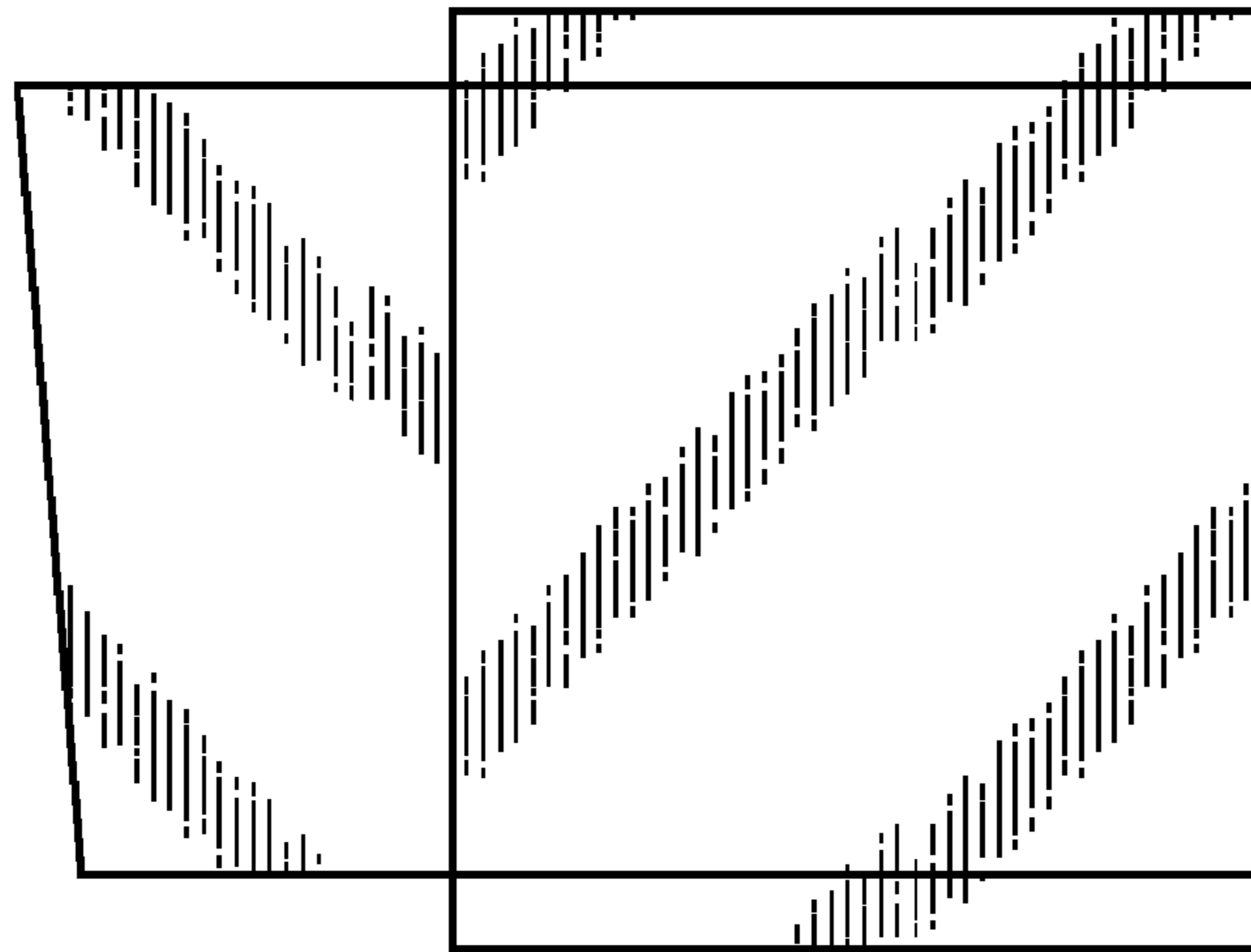

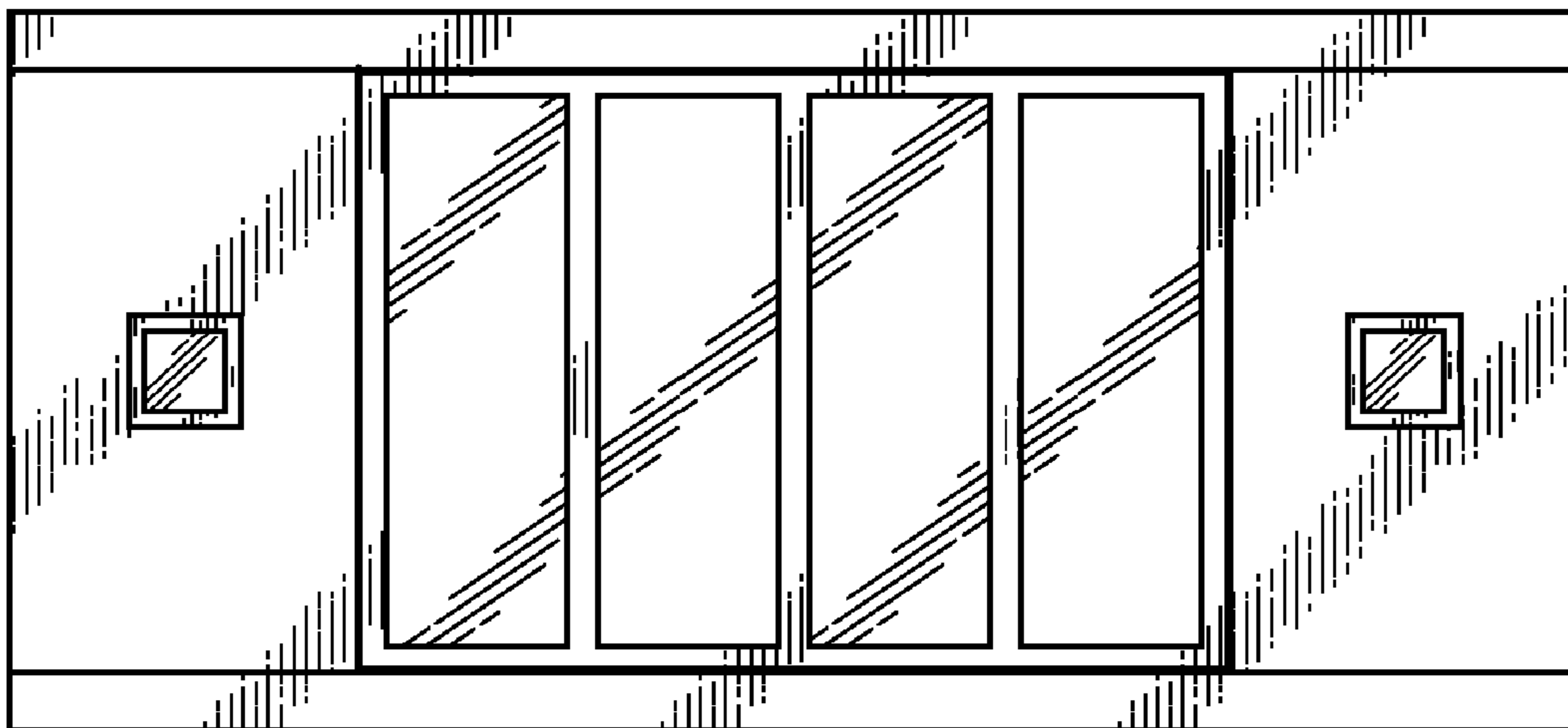

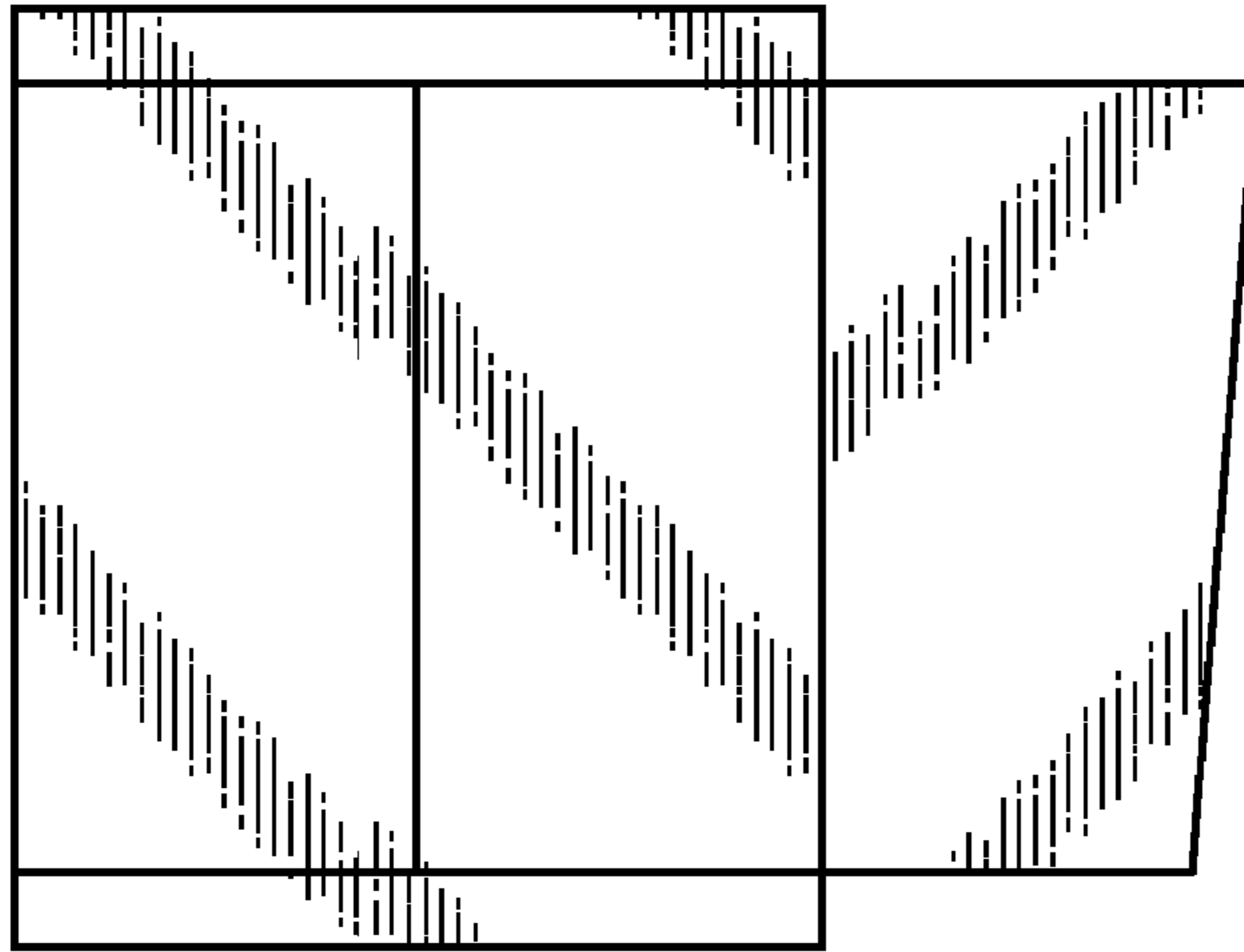

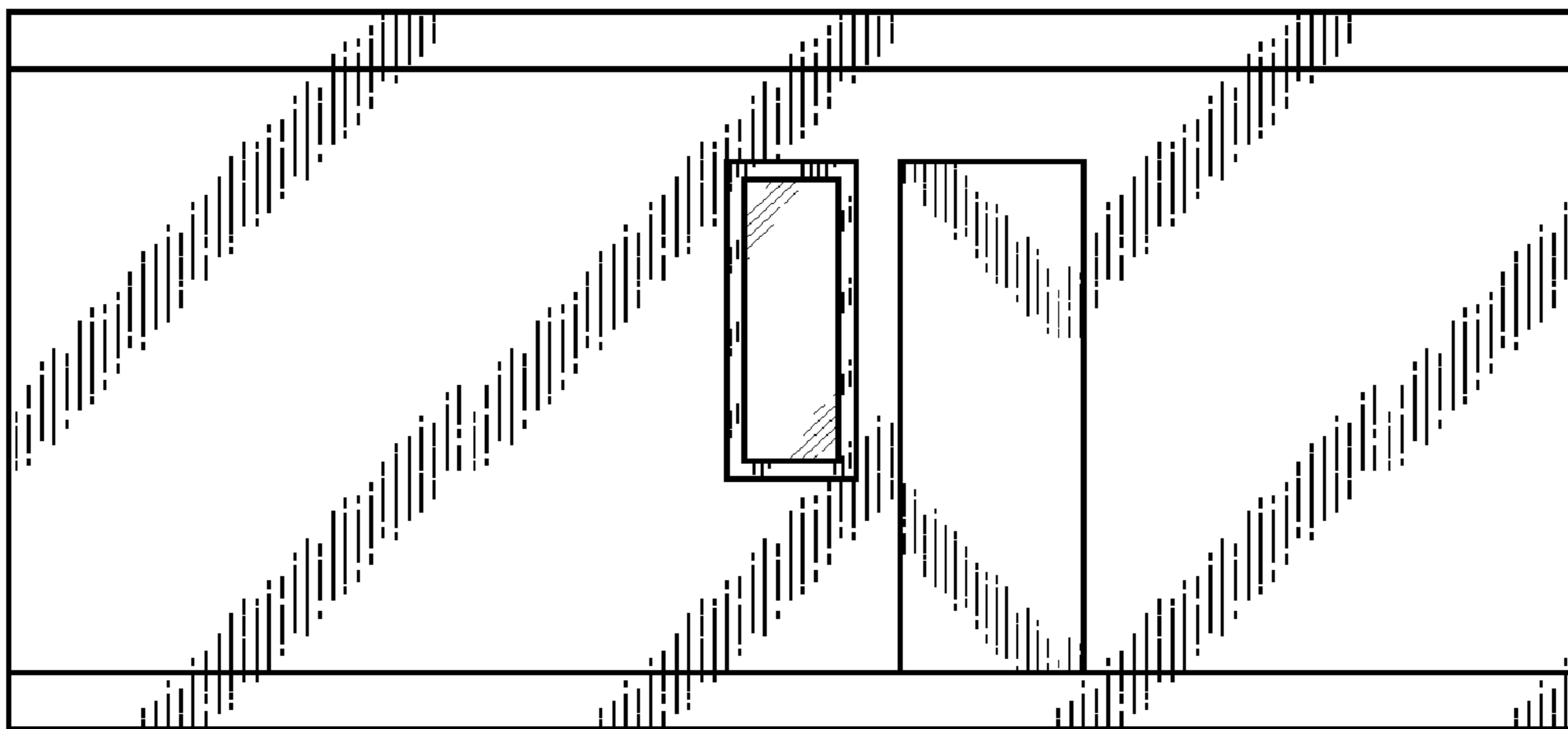
