(57) **CLAIM**

The ornamental design for an automobile headlight lens, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a left automobile headlight lens attached to a vehicle, no part of the vehicle is claimed;

FIG. 2 is a perspective view of the left automobile headlight lens;

FIG. 3 is a front elevational view of the left automobile headlight lens;

FIG. 4 is a left side elevational view of the left automobile headlight lens;

FIG. 5 is a top plan view of the left automobile headlight lens;

FIG. 6 is a bottom plan view of the left automobile headlight lens;

FIG. 7 is a front elevation view of a automobile headlight lens illustrated in FIGS. 1-6, showing a right automobile headlight lens, with the automobile shown in broken lines and forming no part of the claimed design;

FIG. 8 is a perspective view of the right automobile headlight lens;

FIG. 9 is a front elevational view of the right automobile headlight lens;

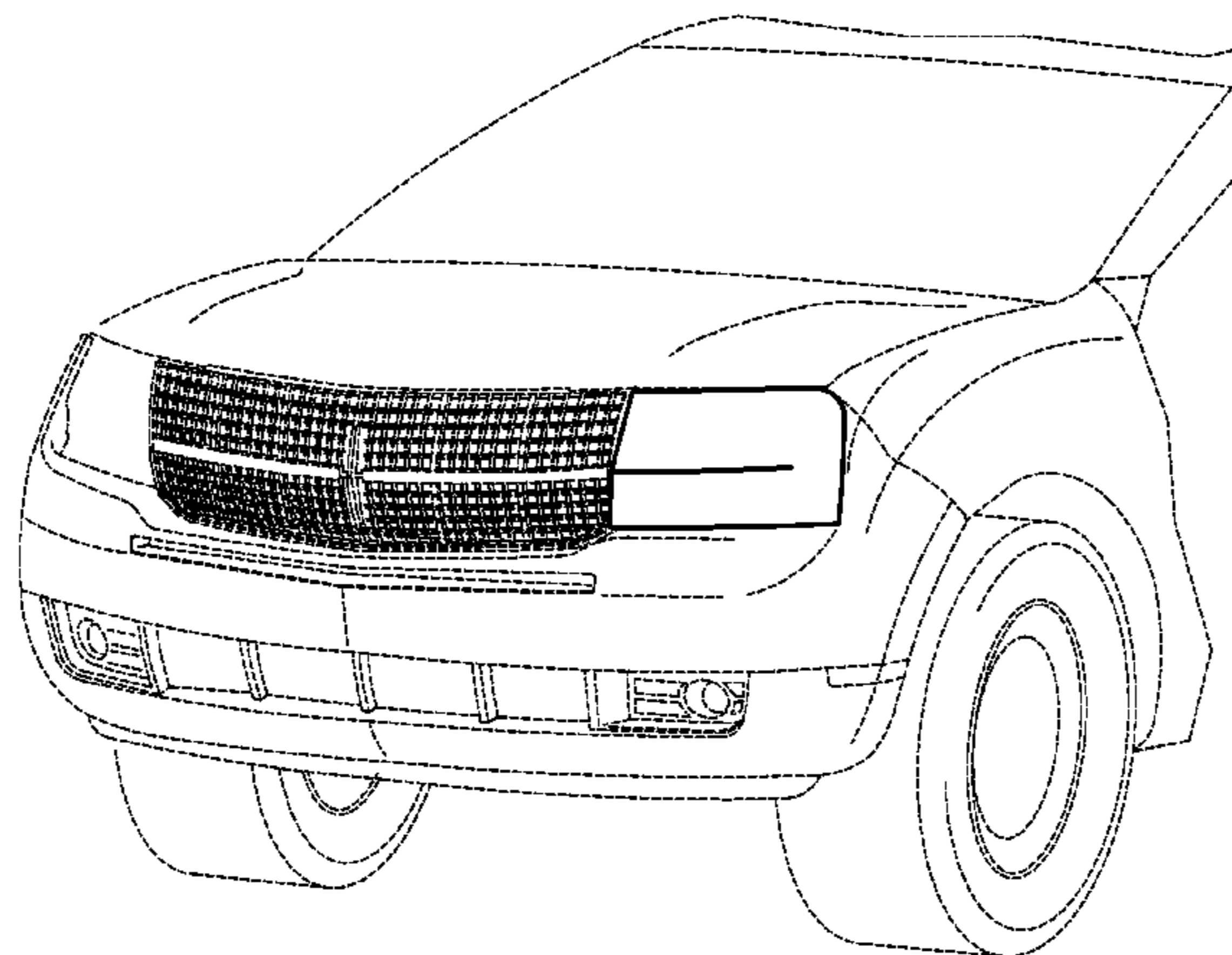
FIG. 10 is a right side elevational view of the right automobile headlight lens;

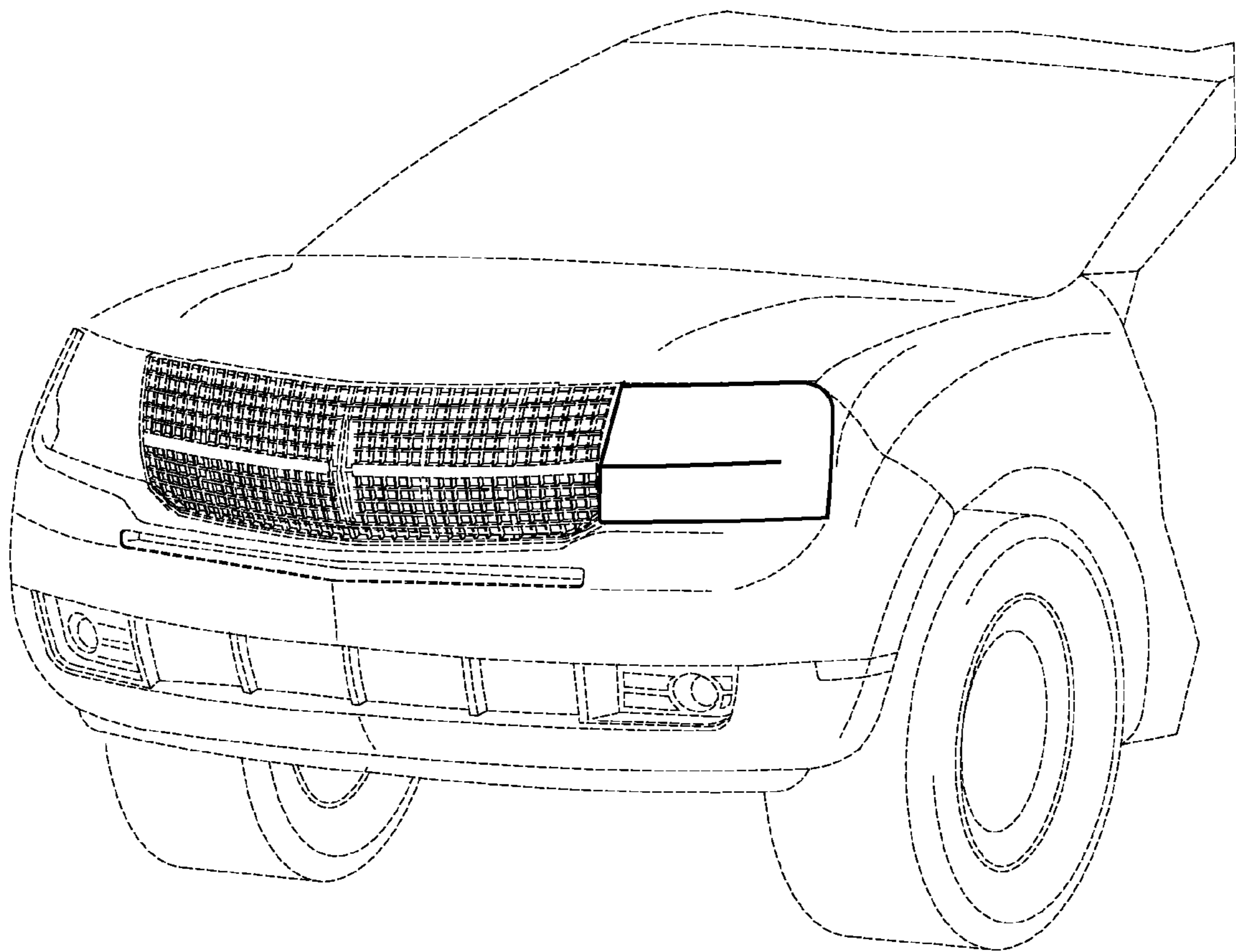

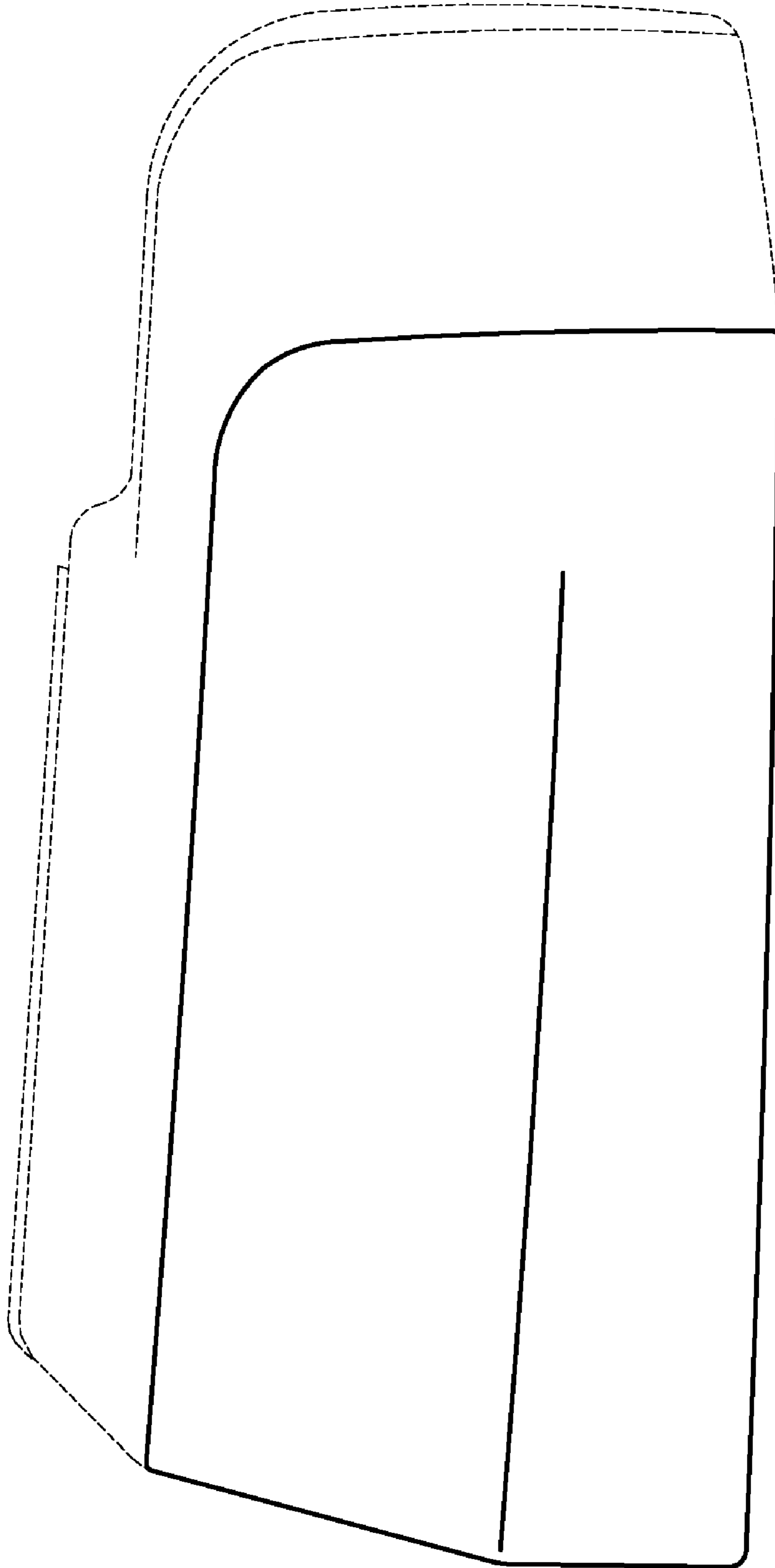

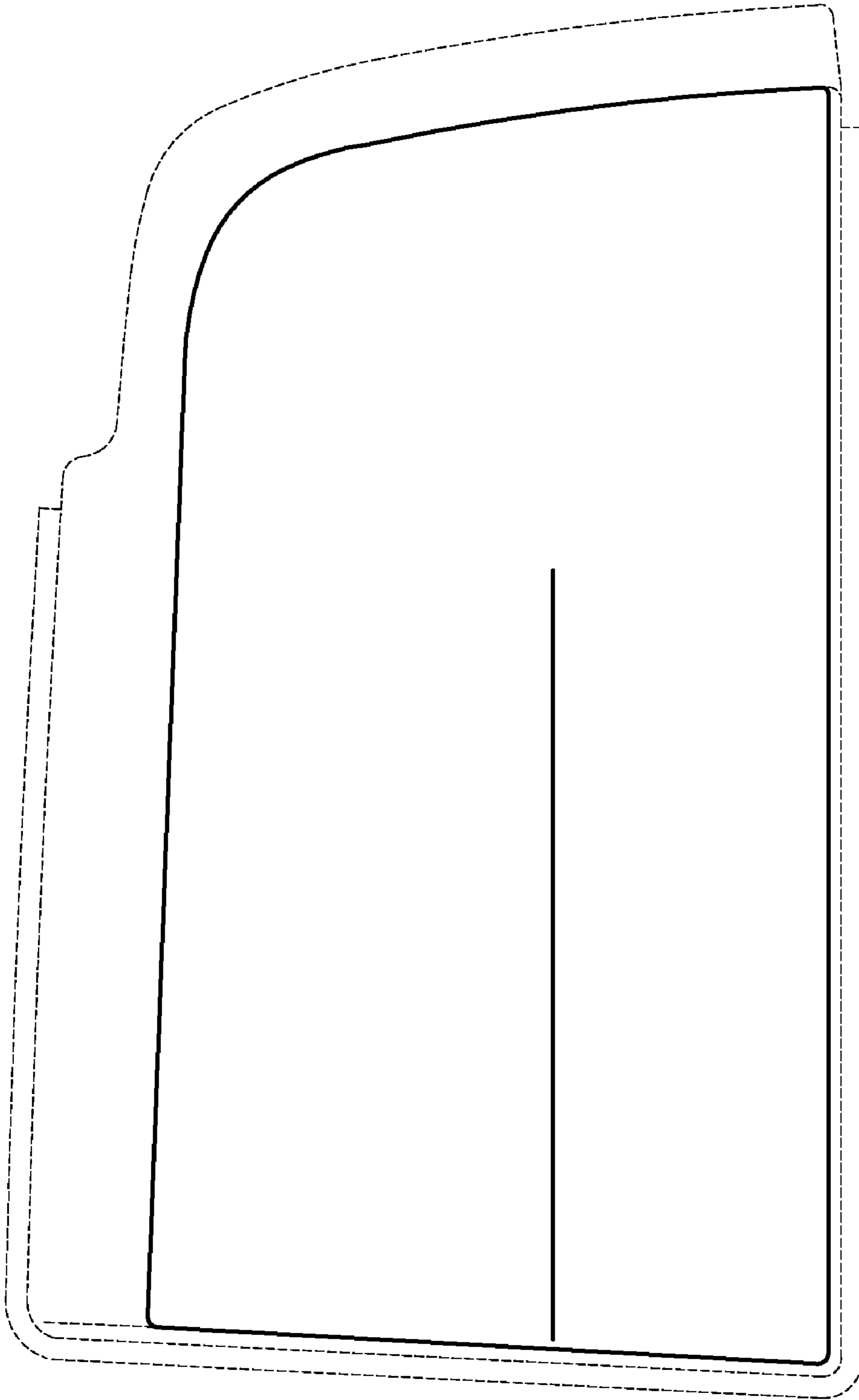

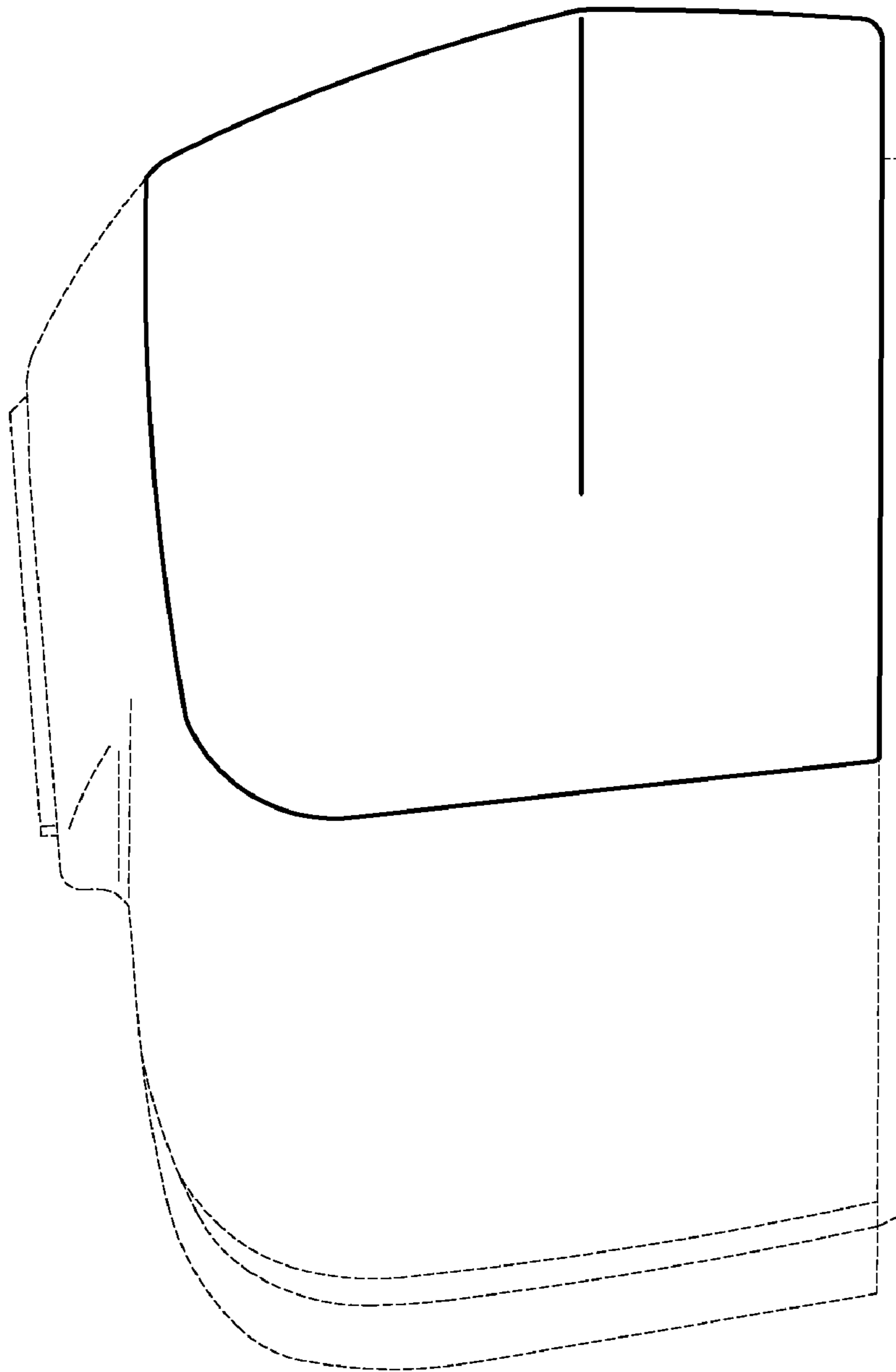

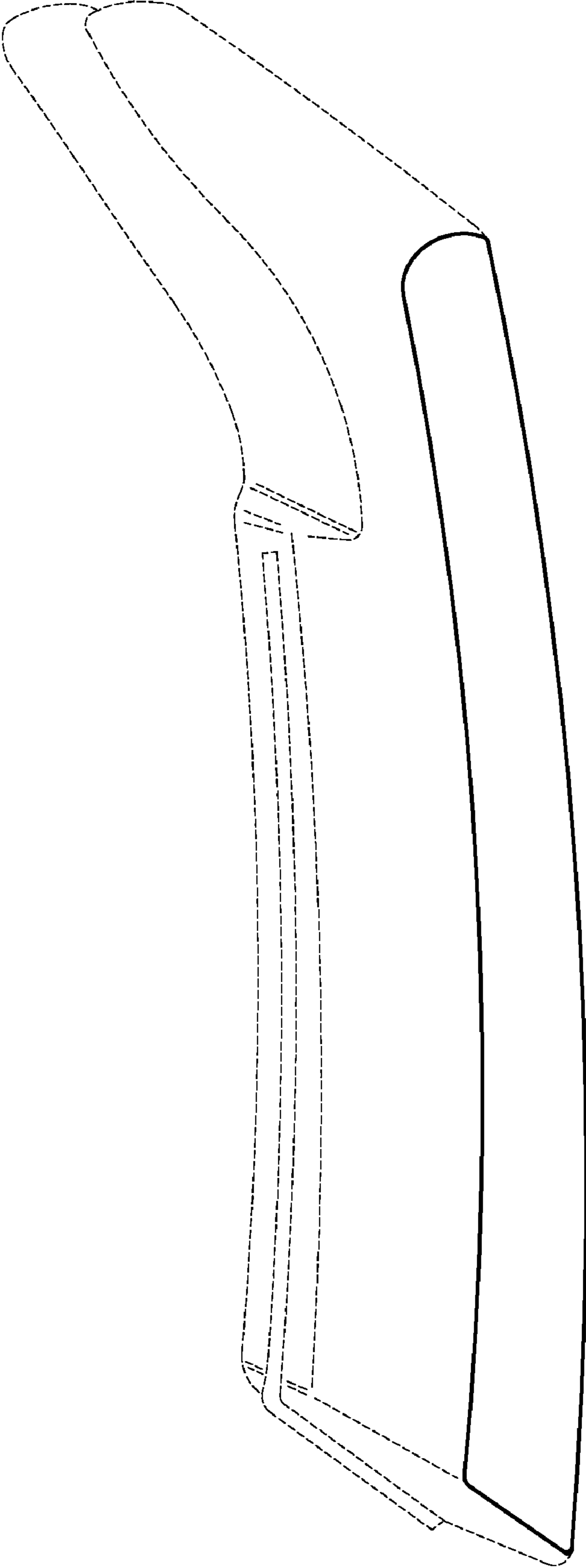

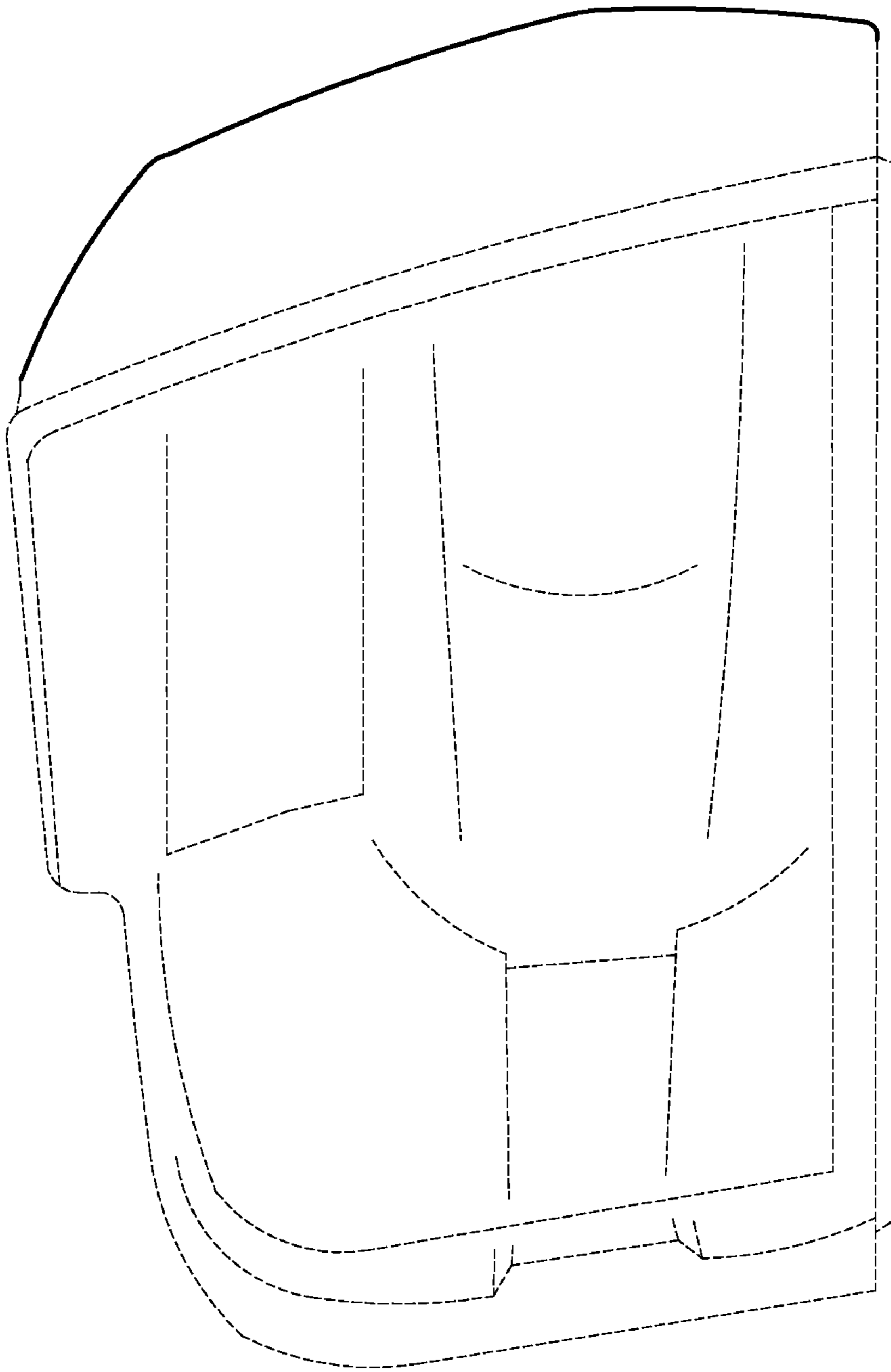

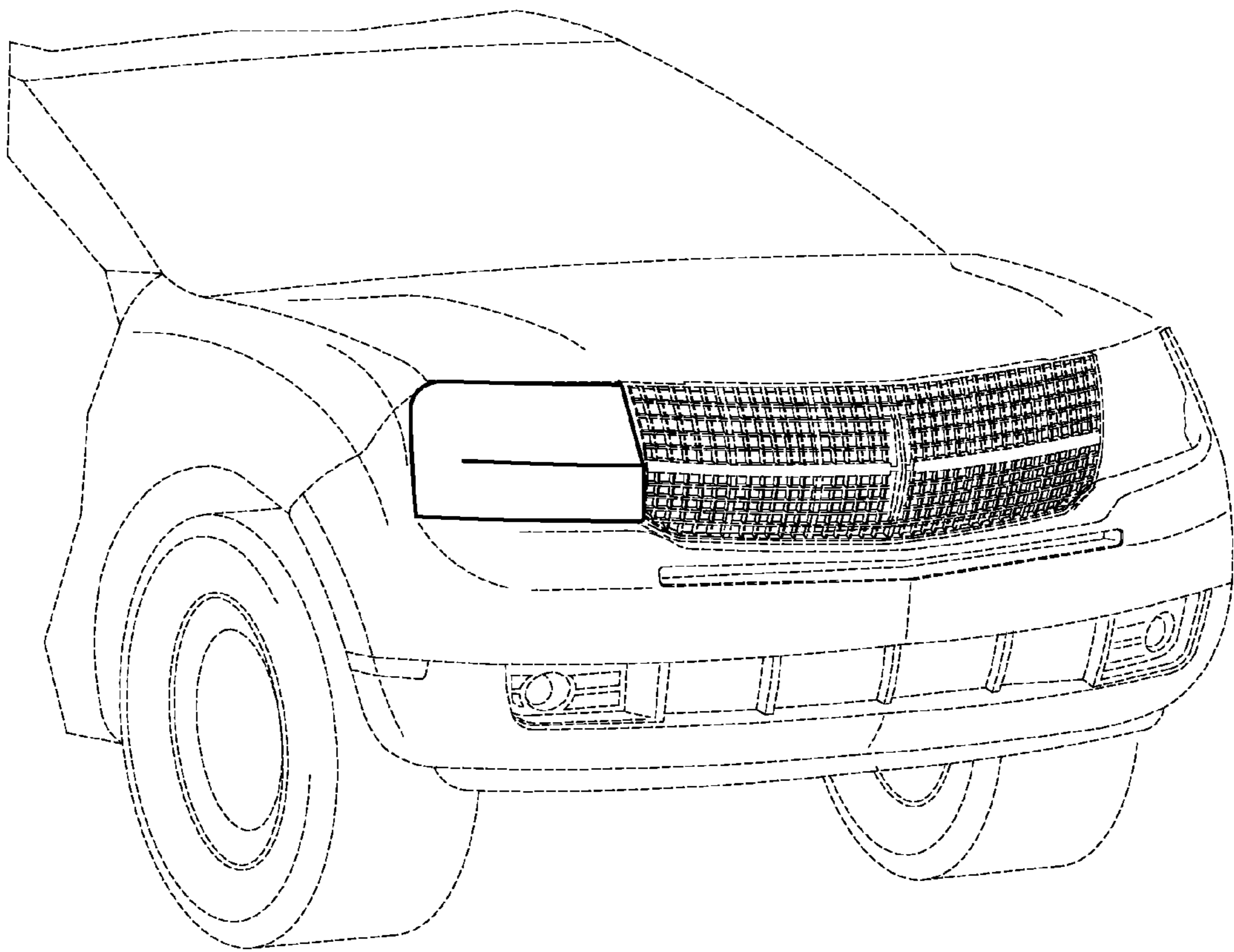

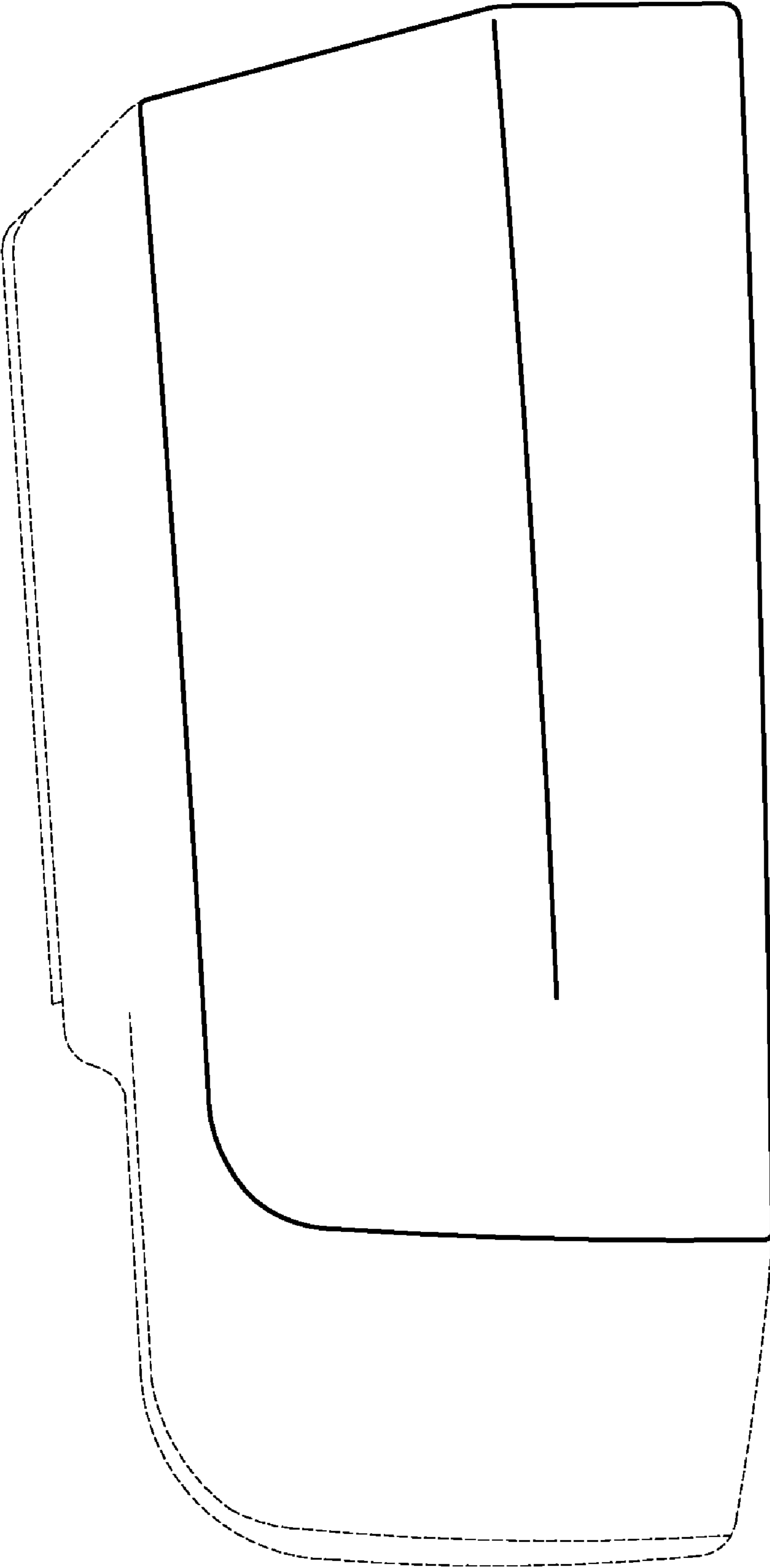

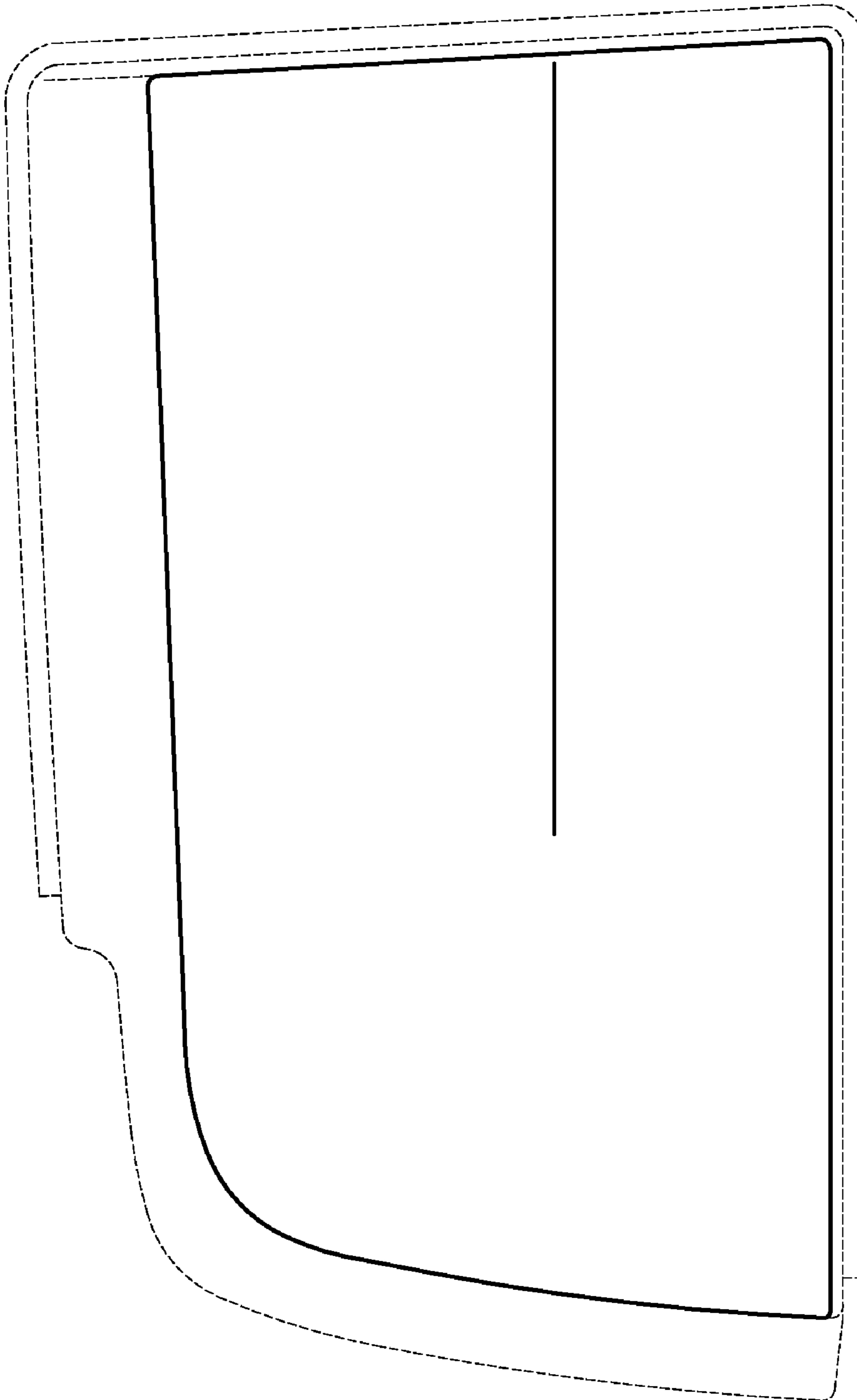

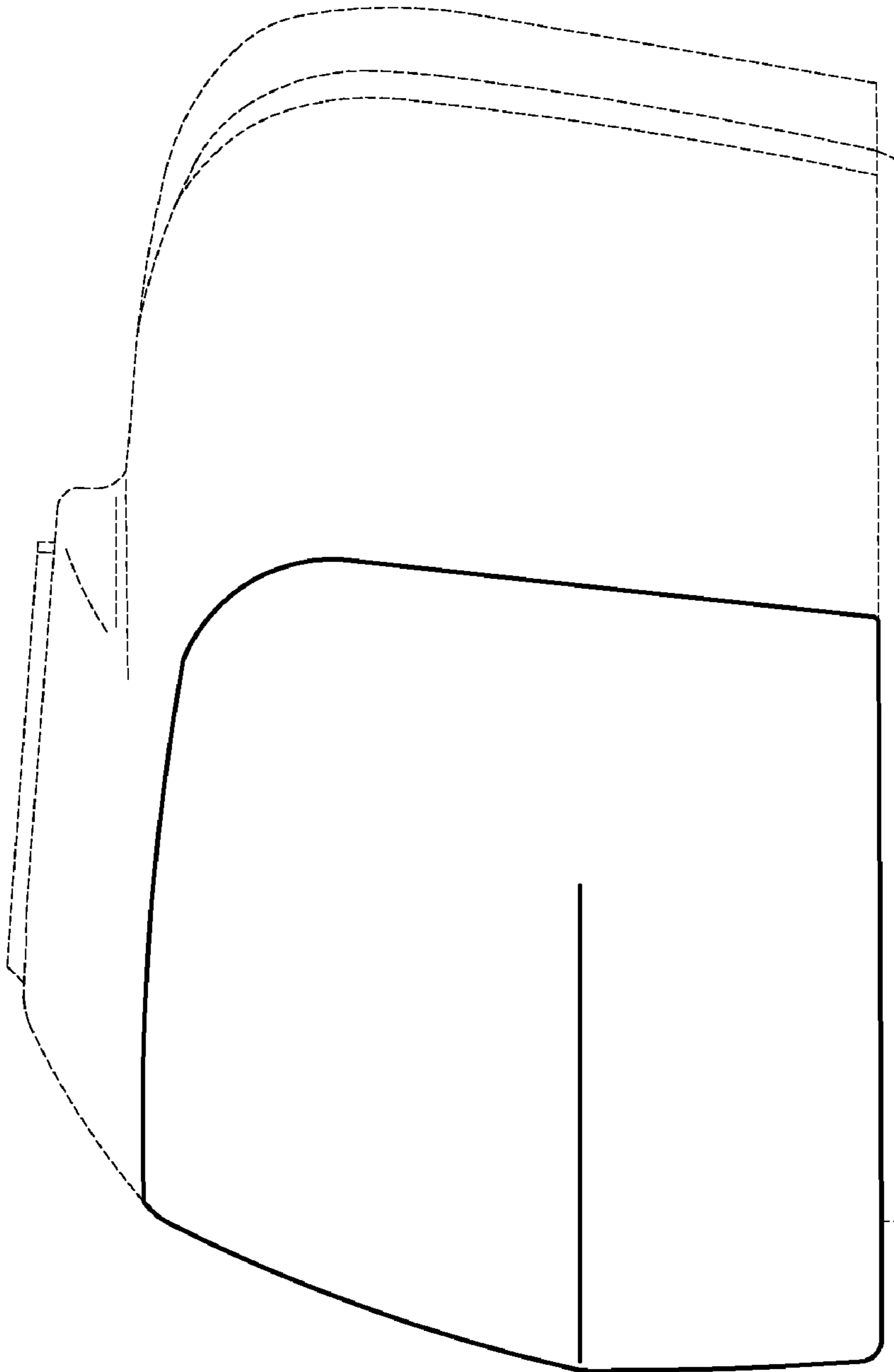

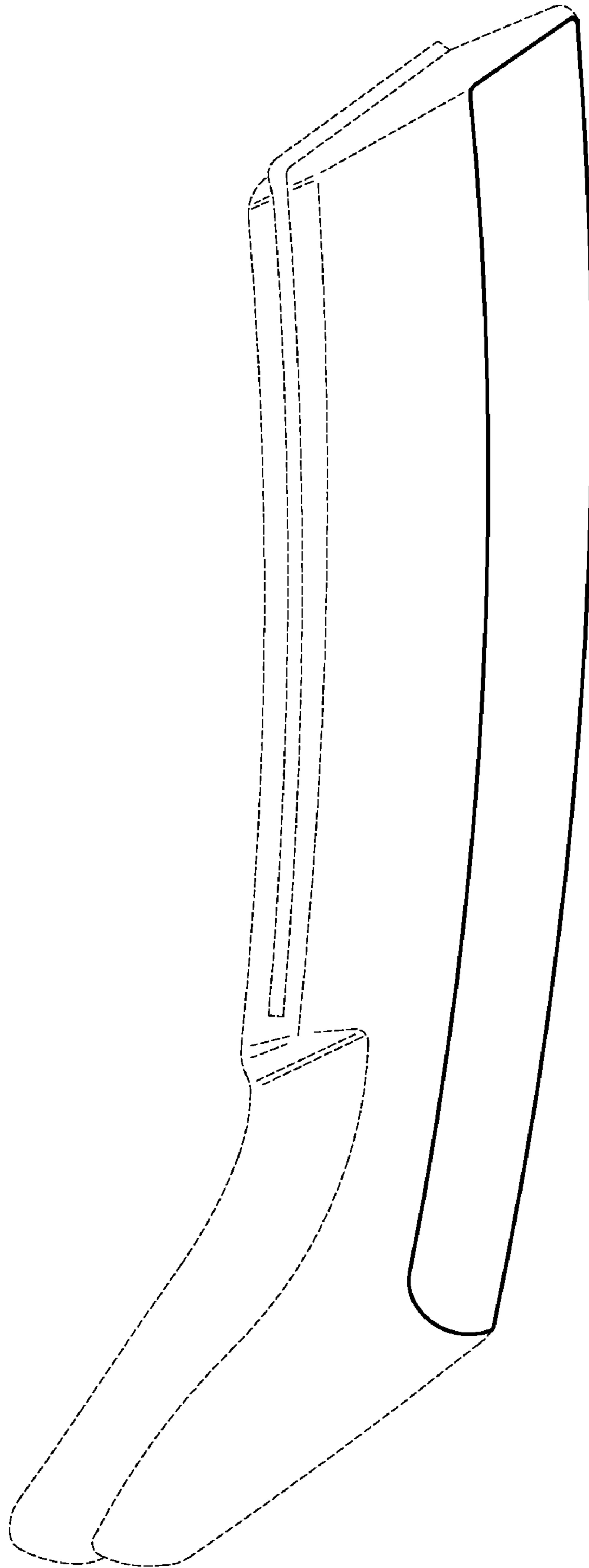

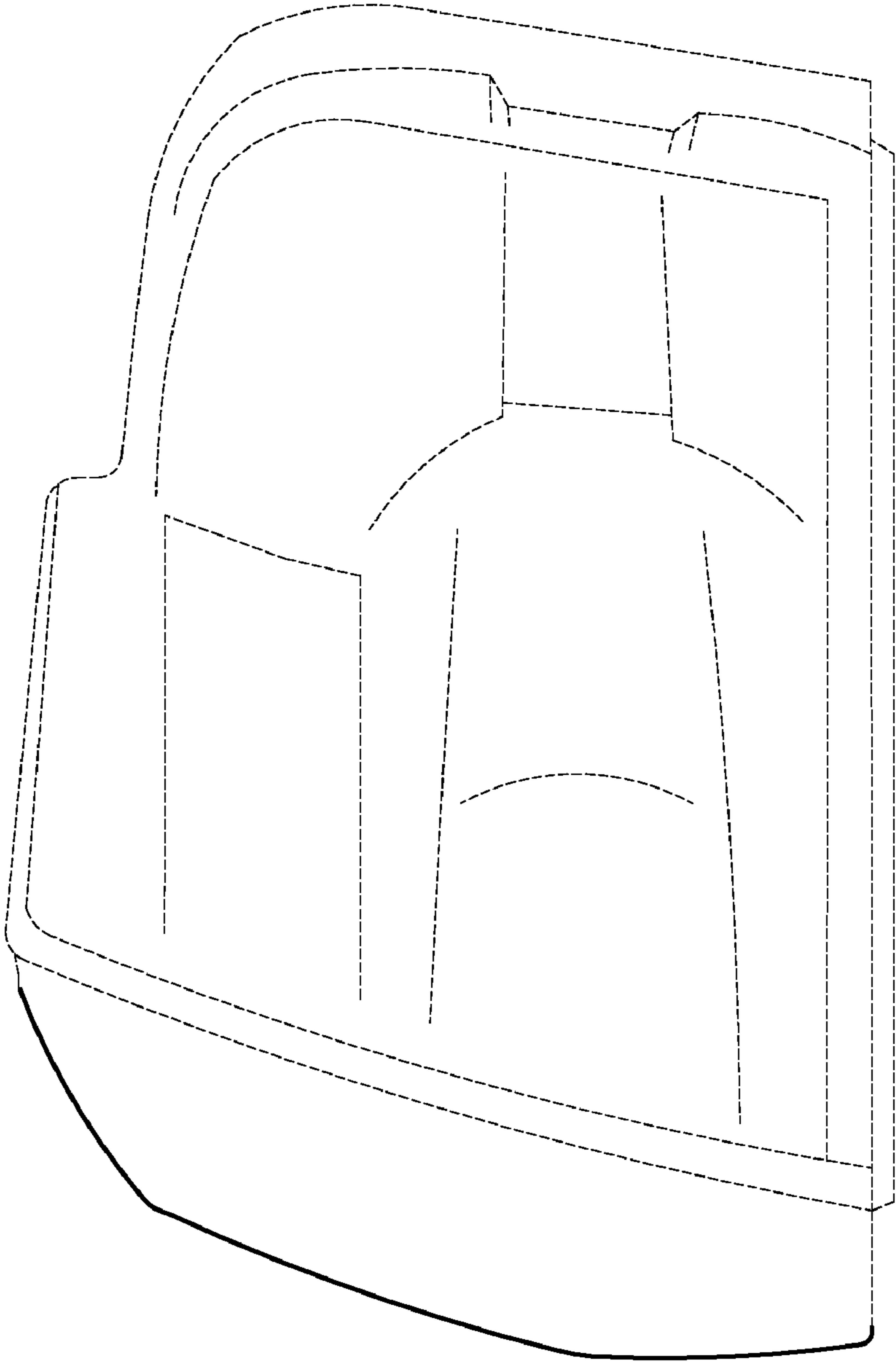
