 FIG. 22 is a perspective view of a fourth embodiment of the pouch comprising a silver colored portion;

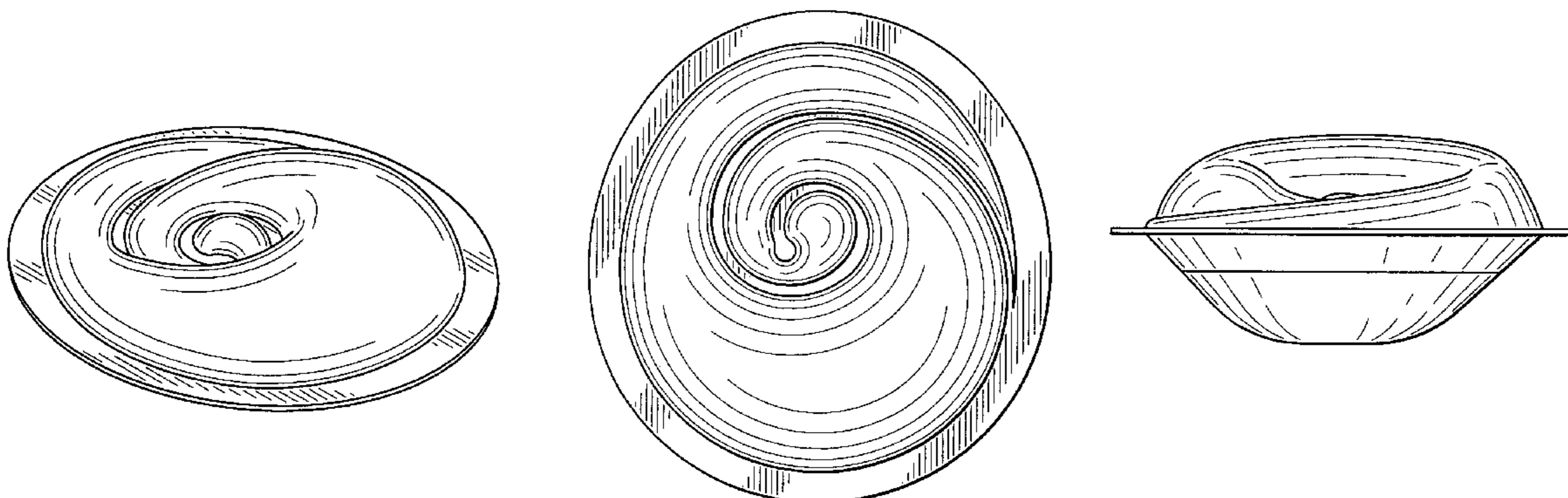


FIG. 23 is a top view of the fourth embodiment of the pouch comprising a silver colored portion;

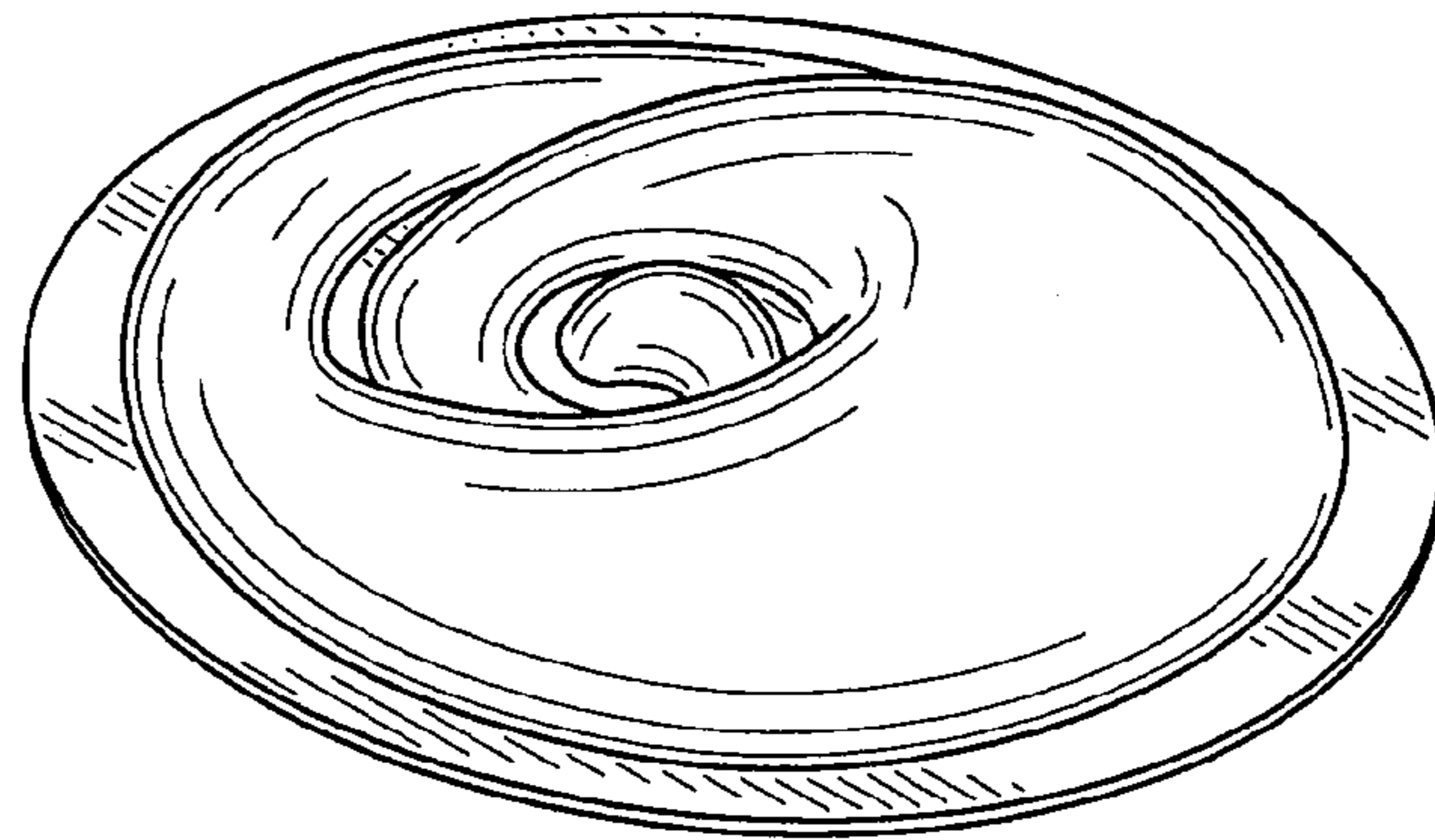

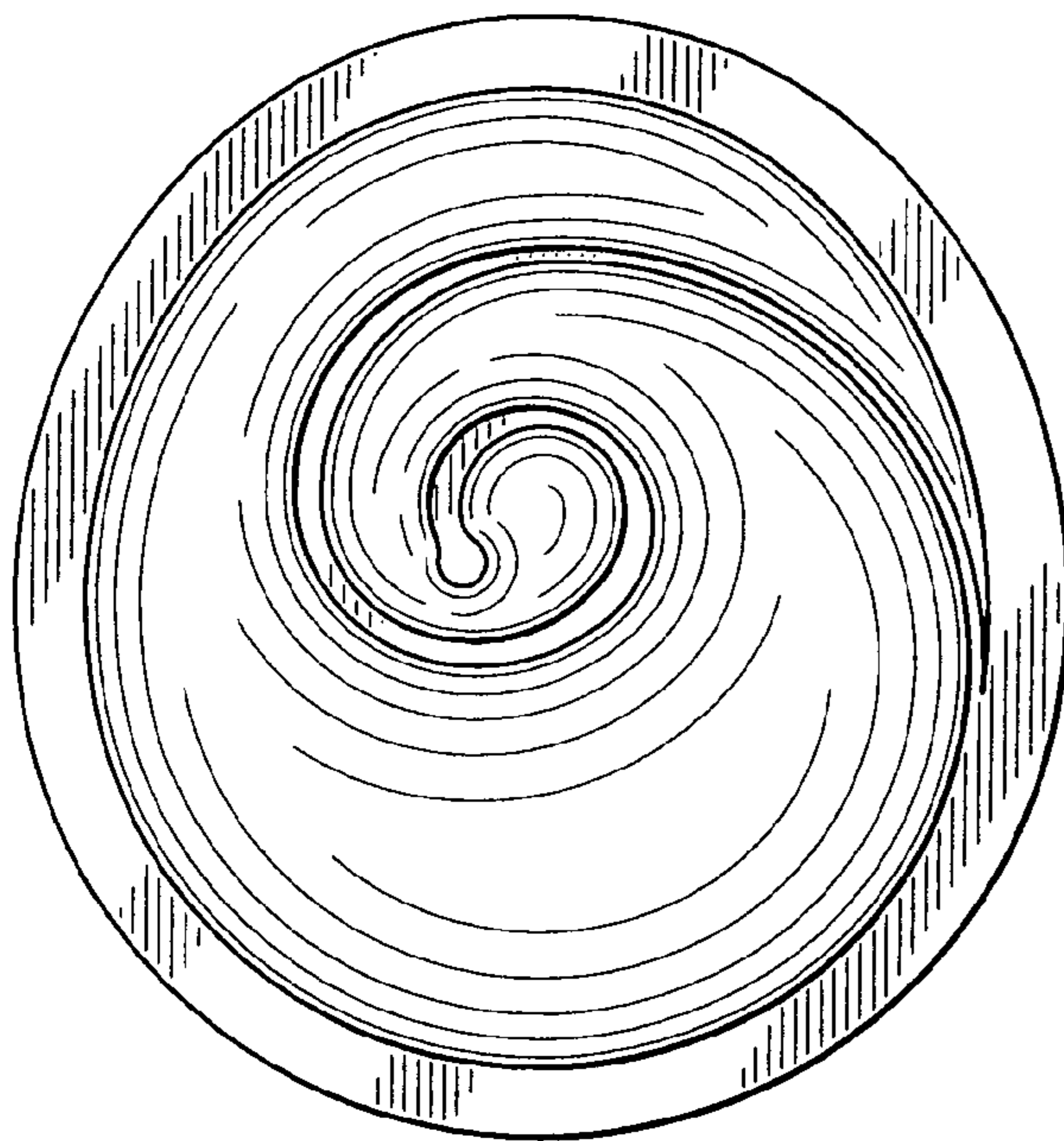

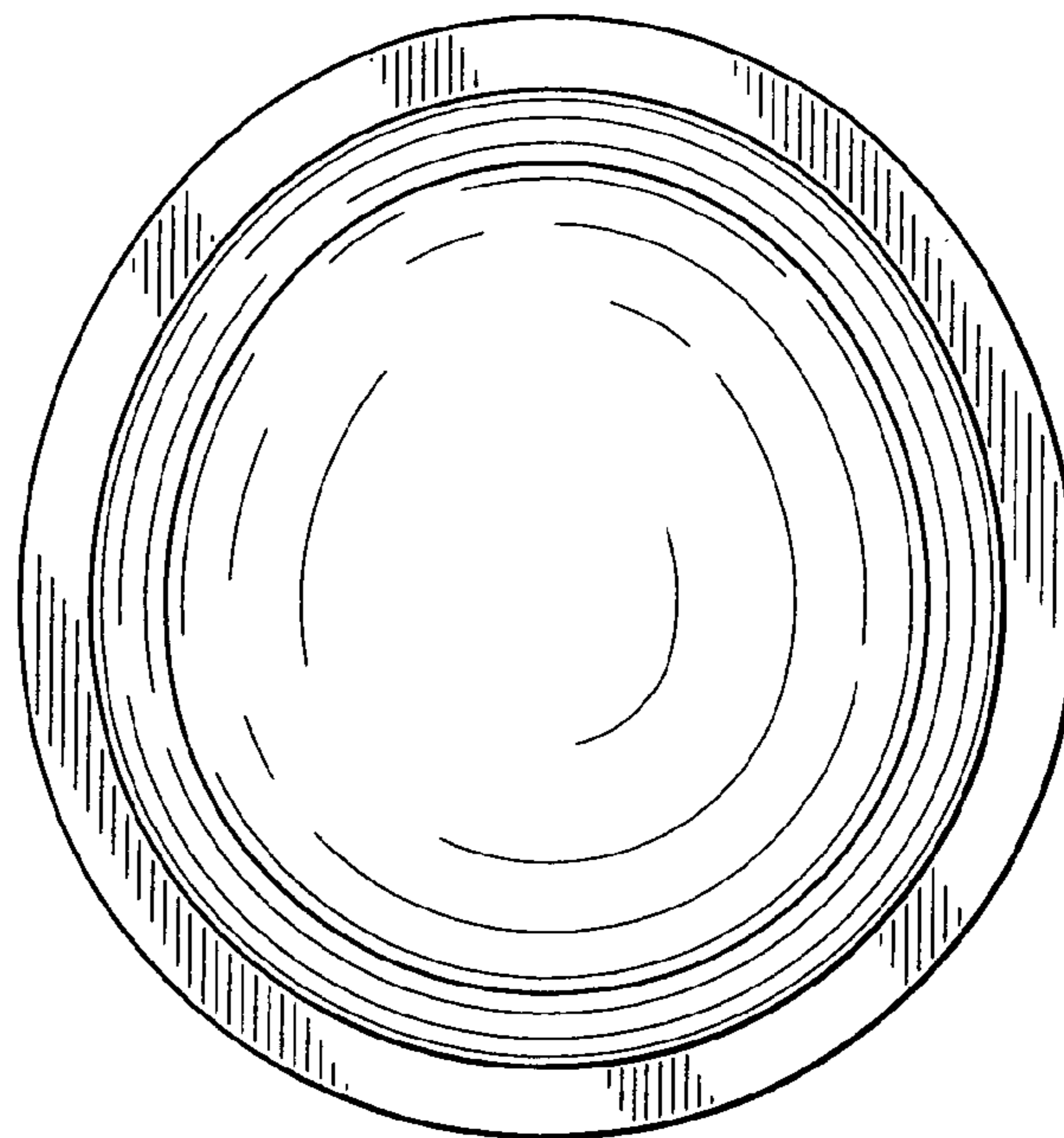

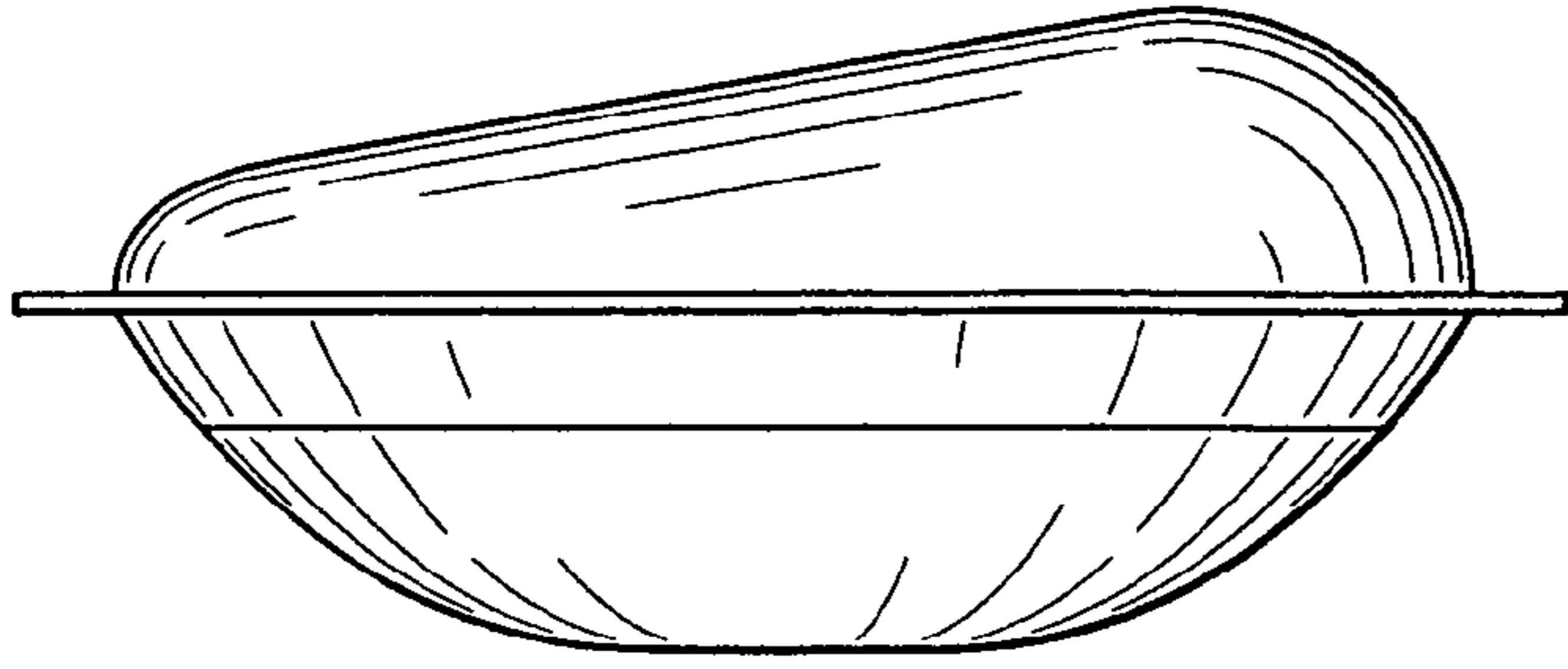

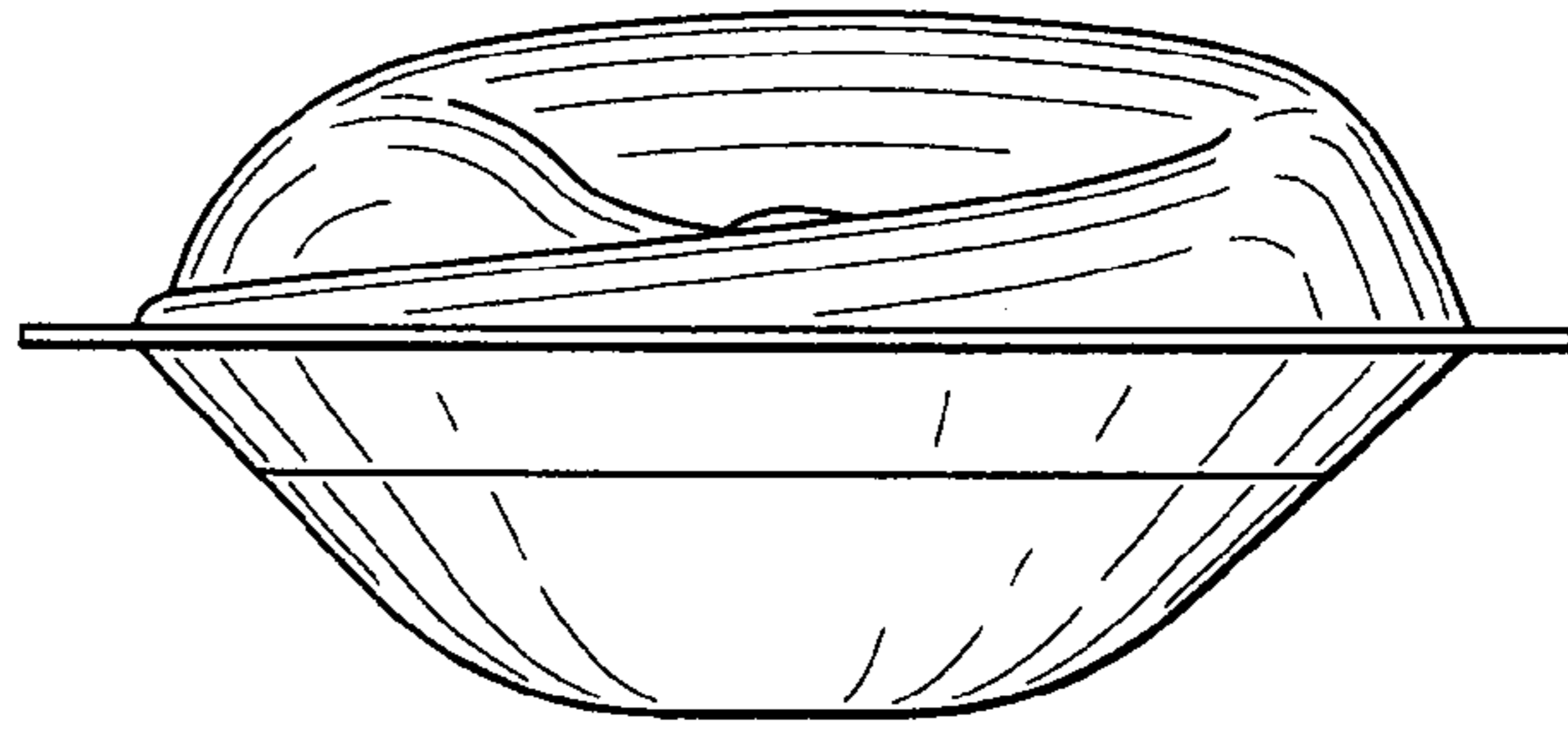

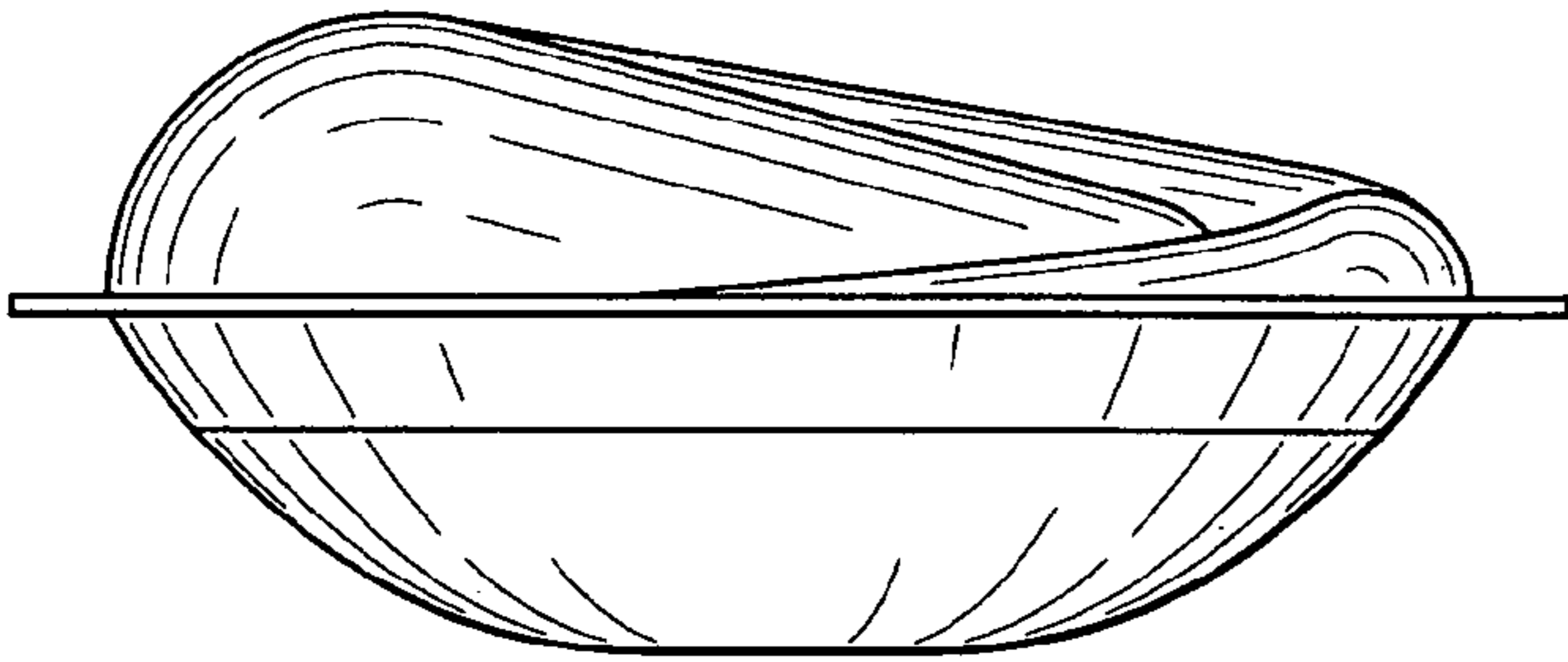

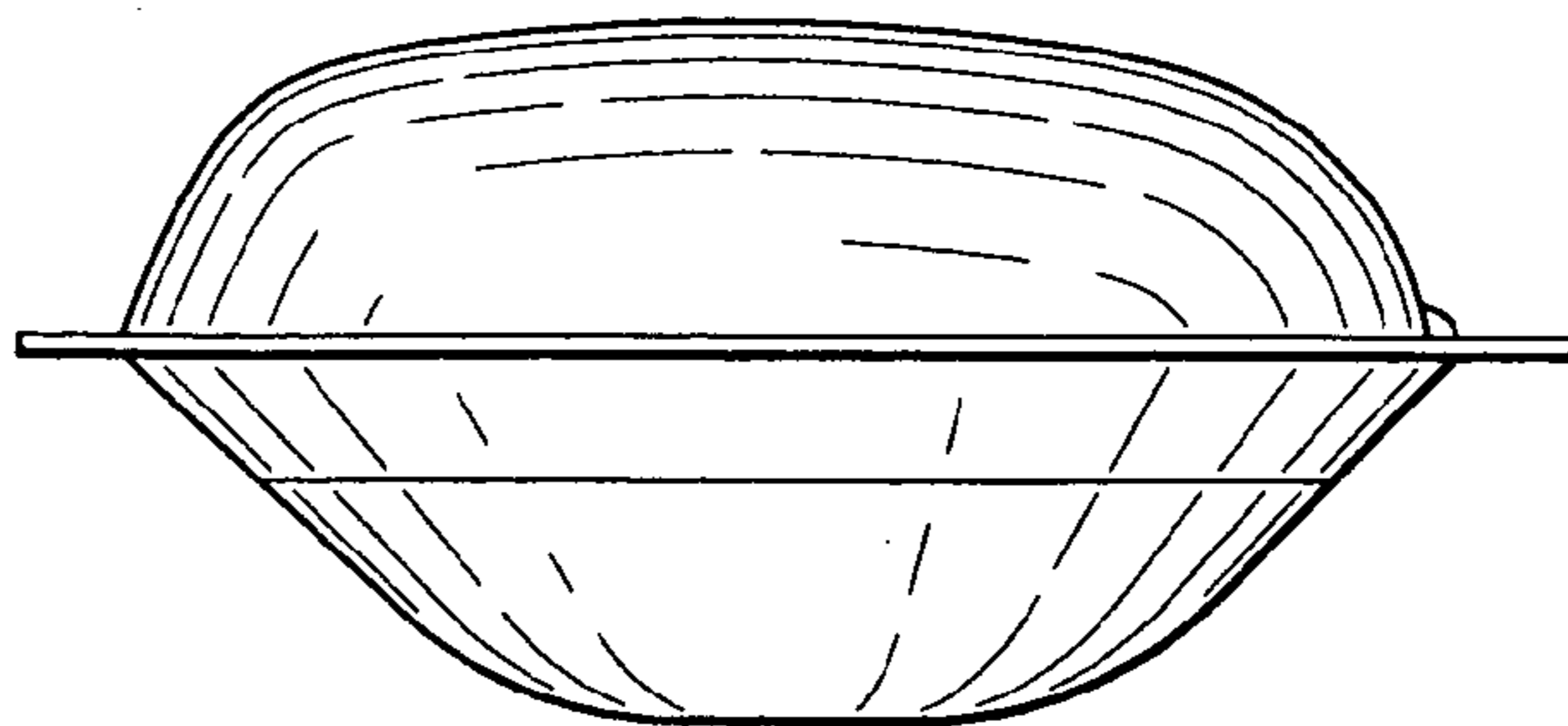

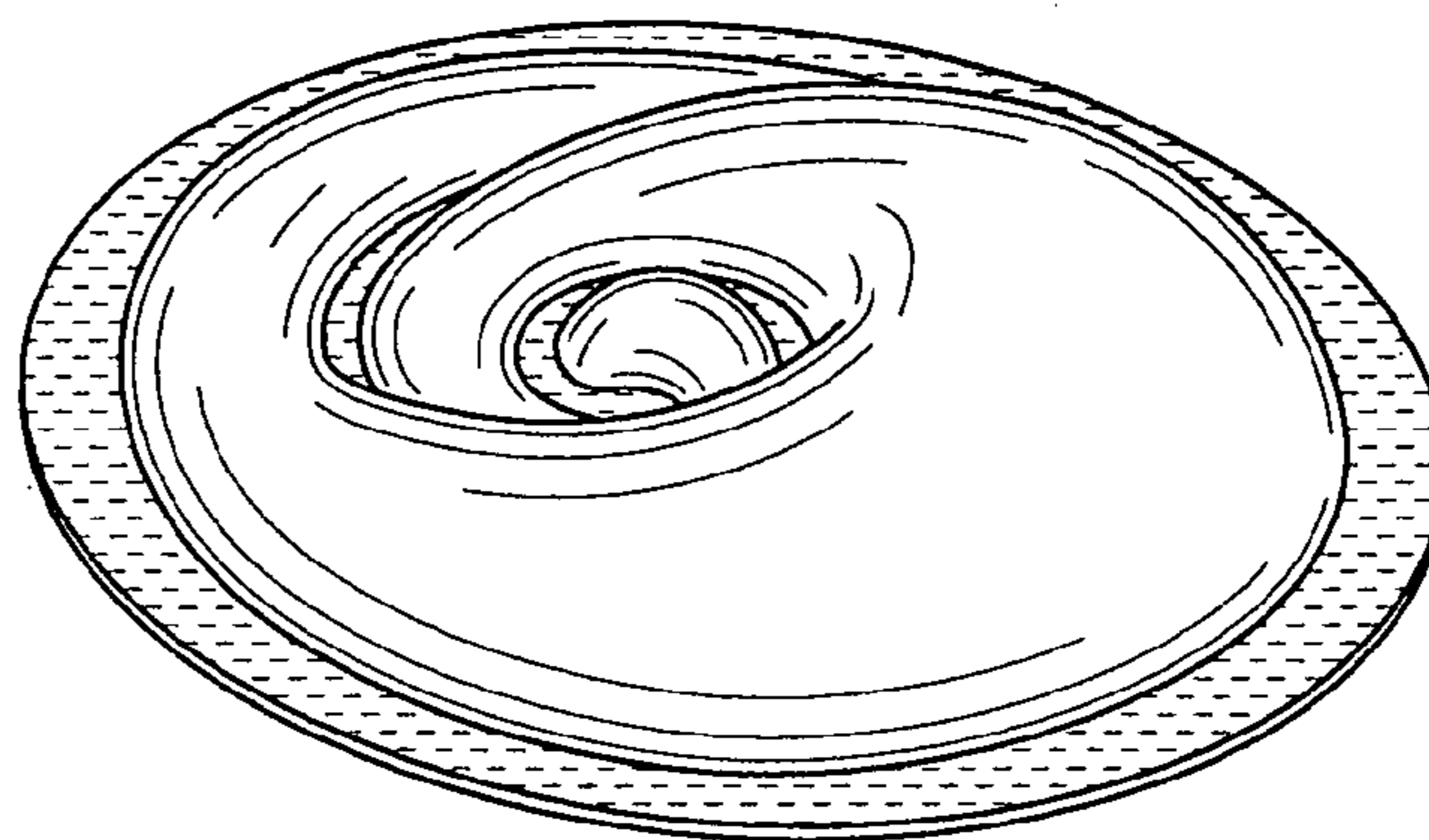

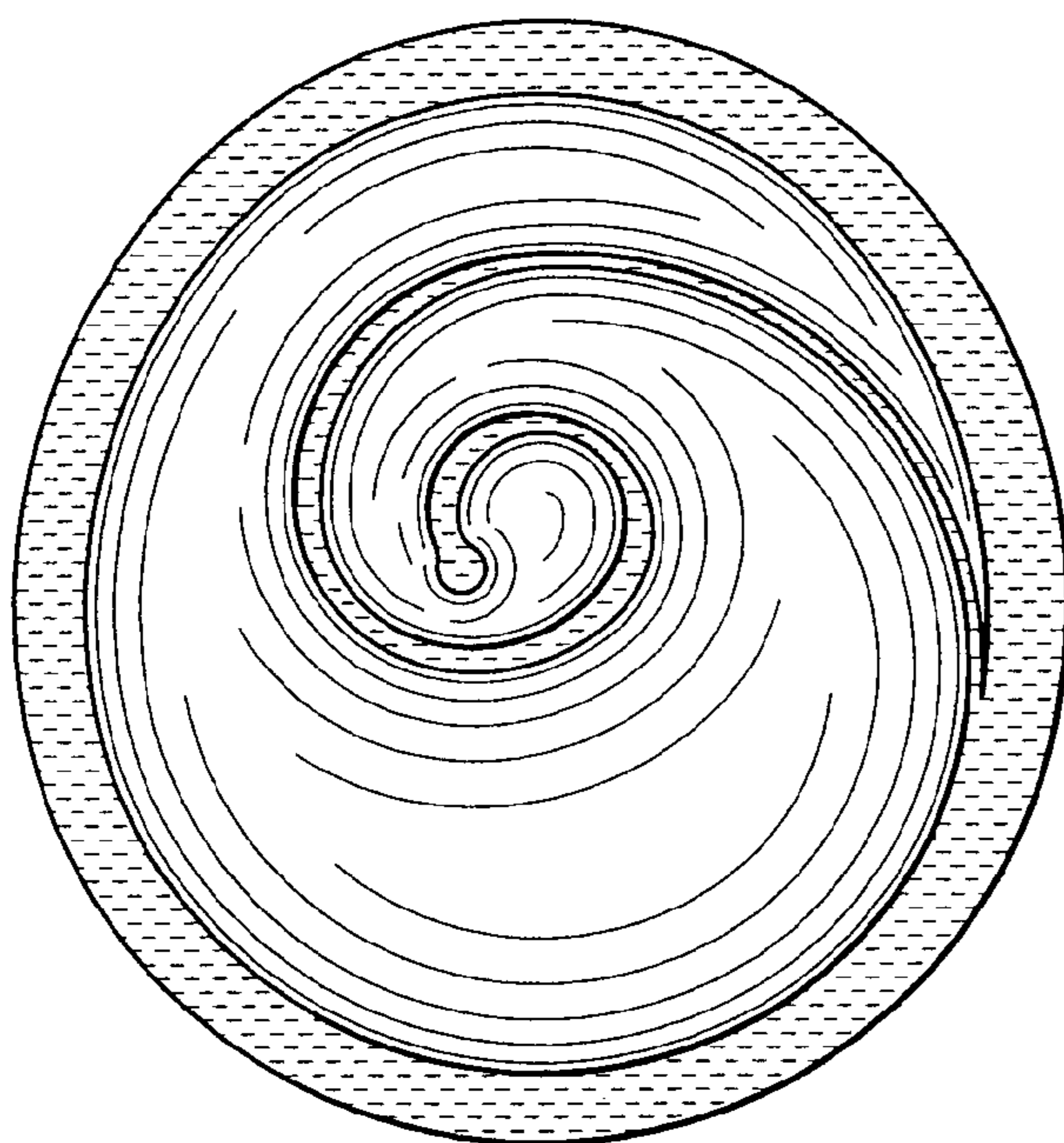

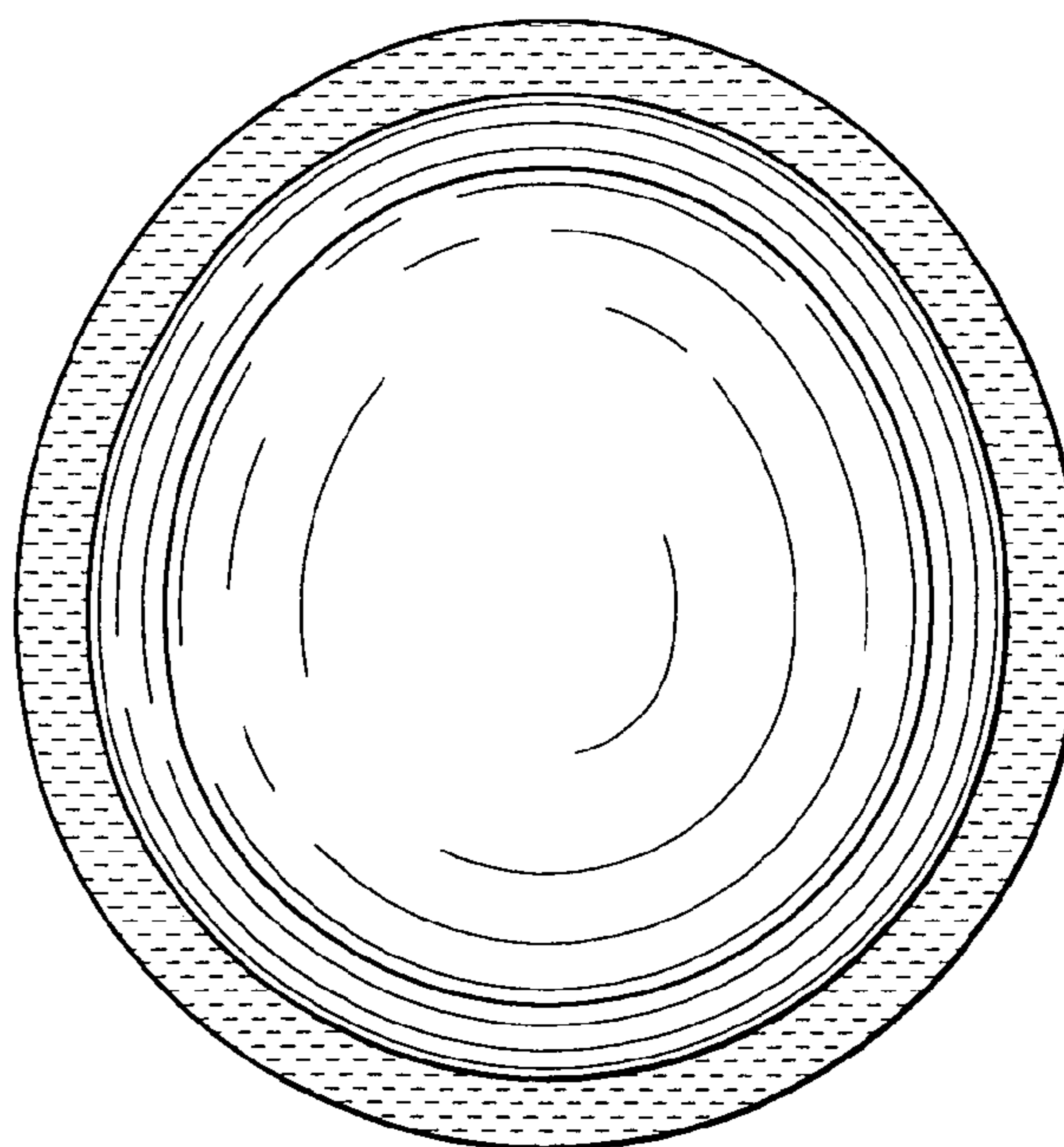

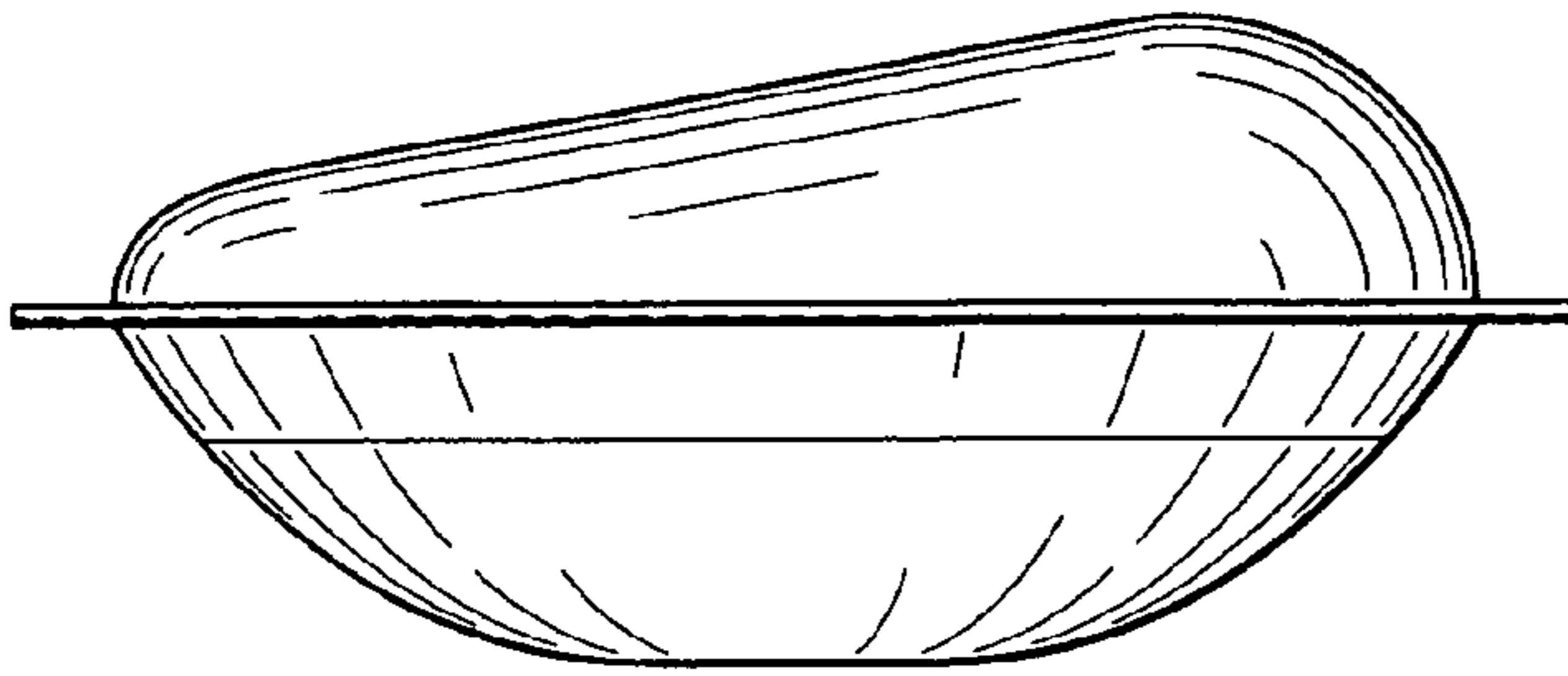

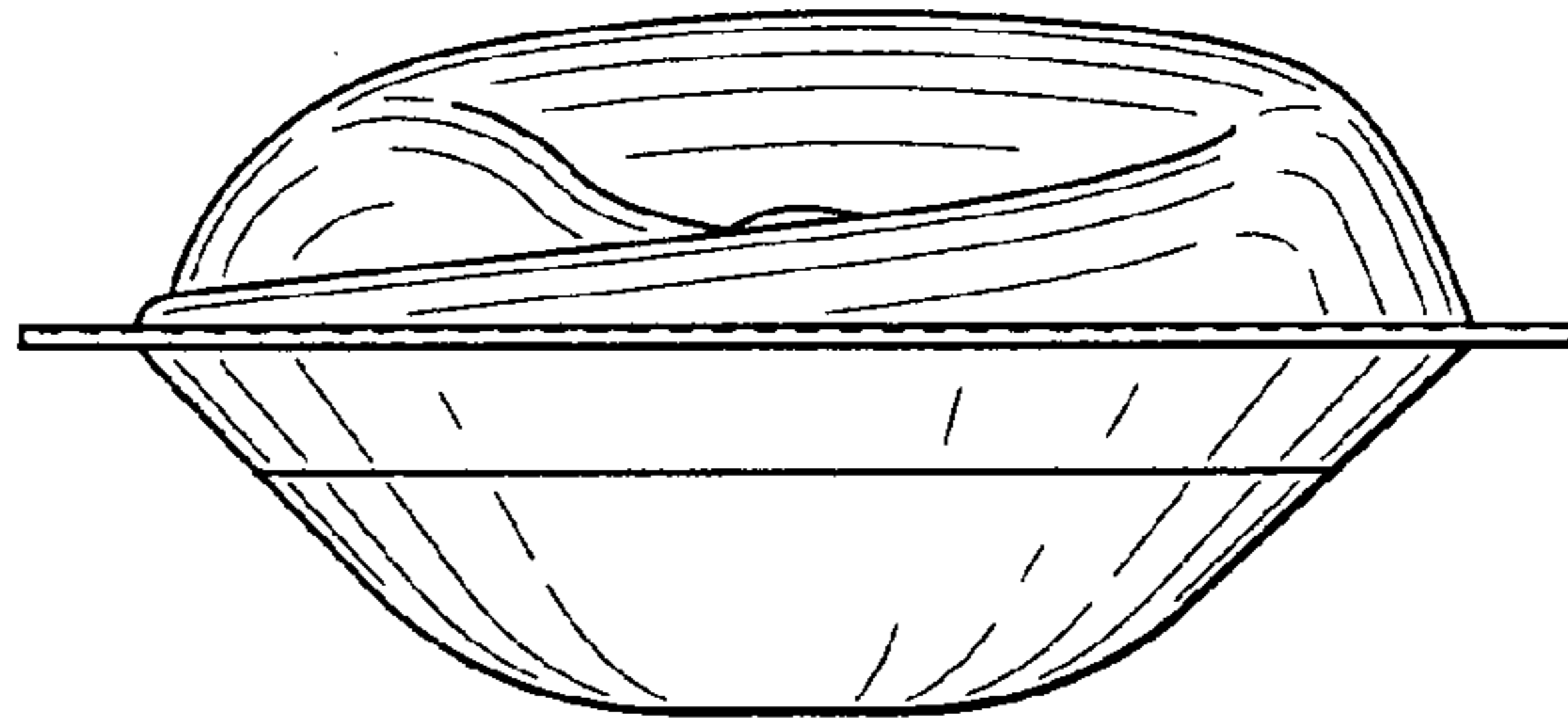

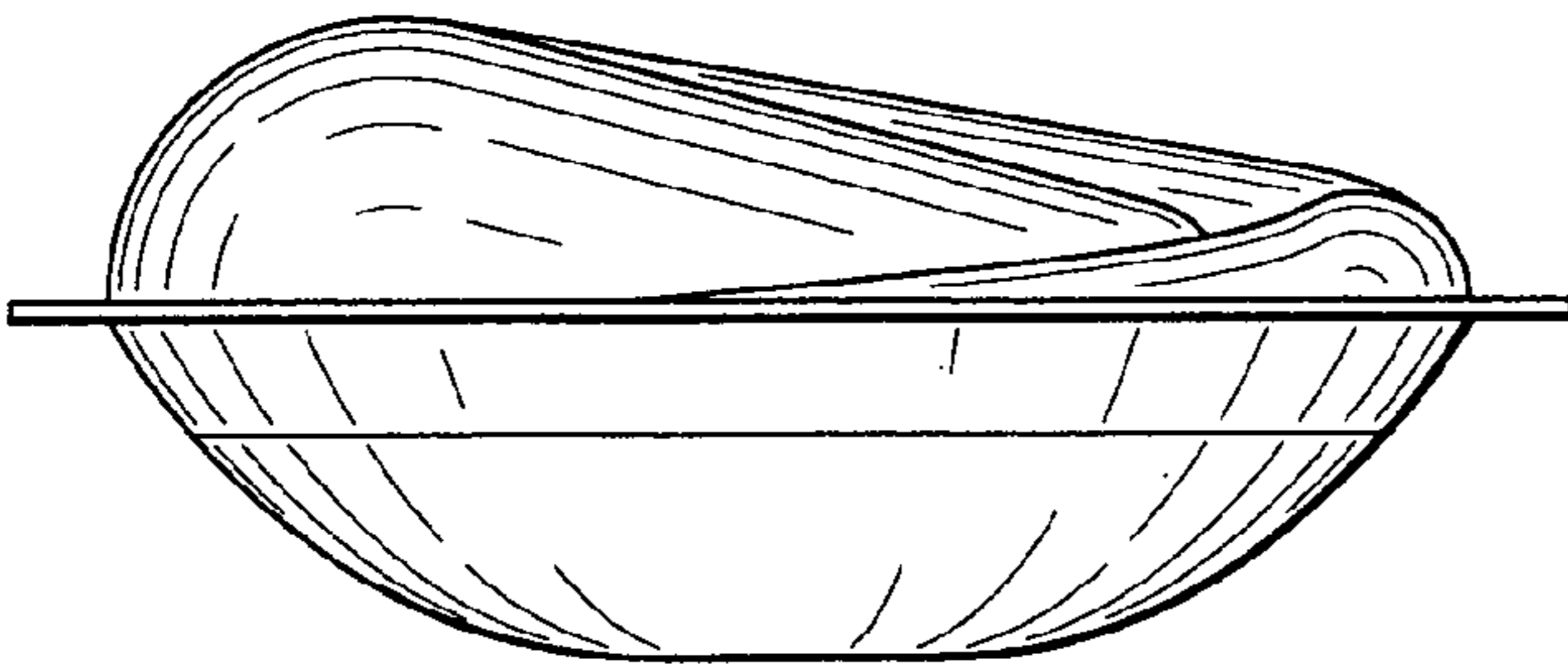

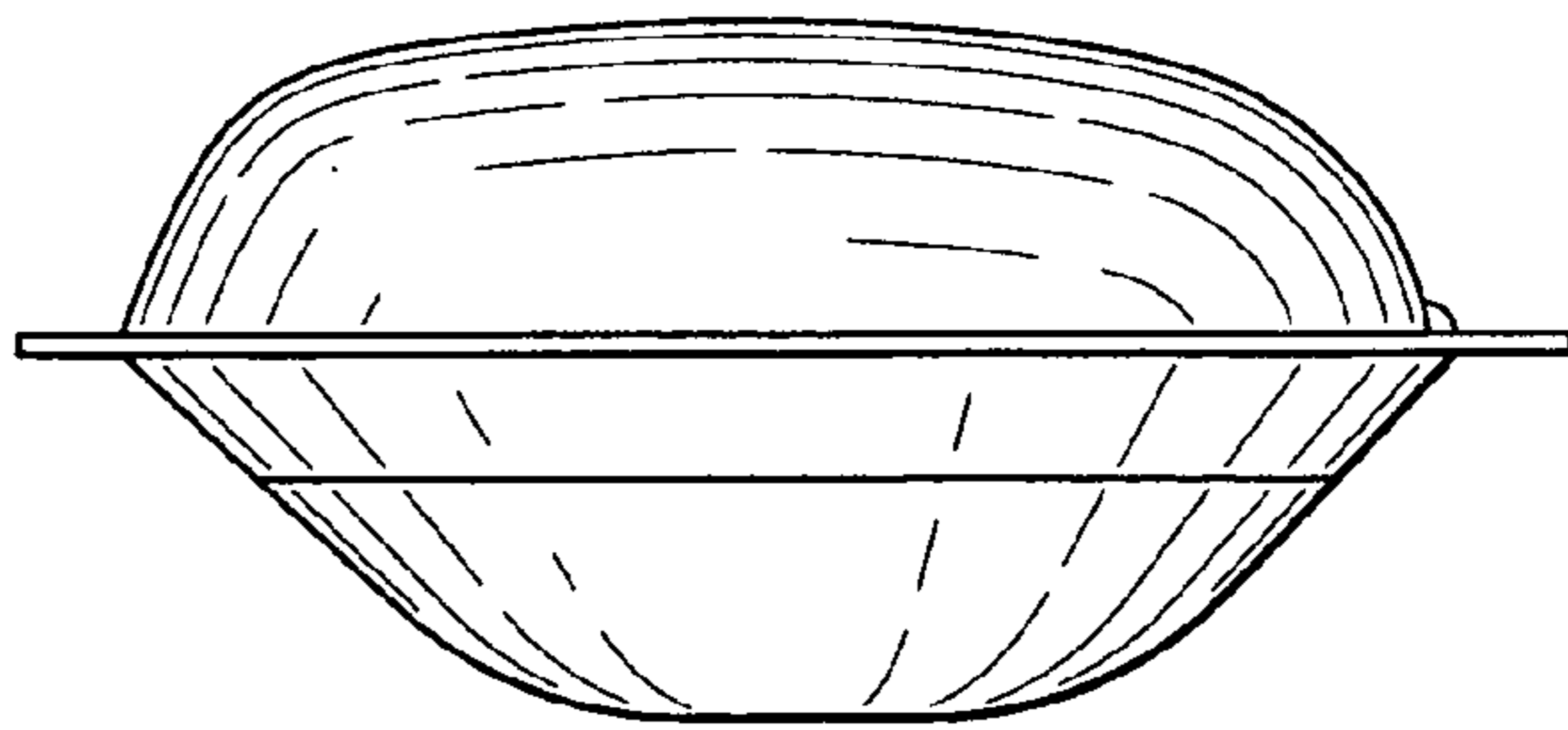

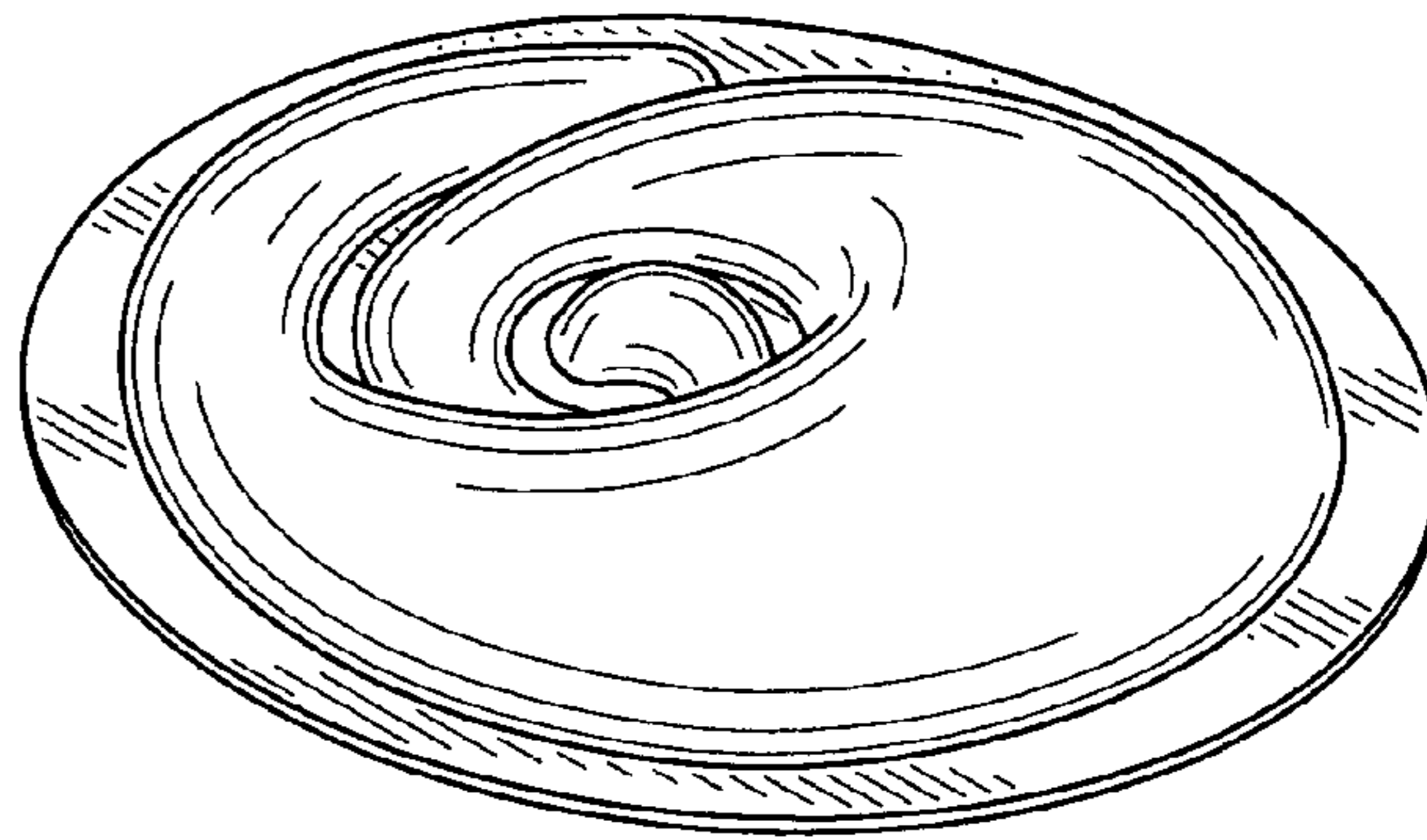

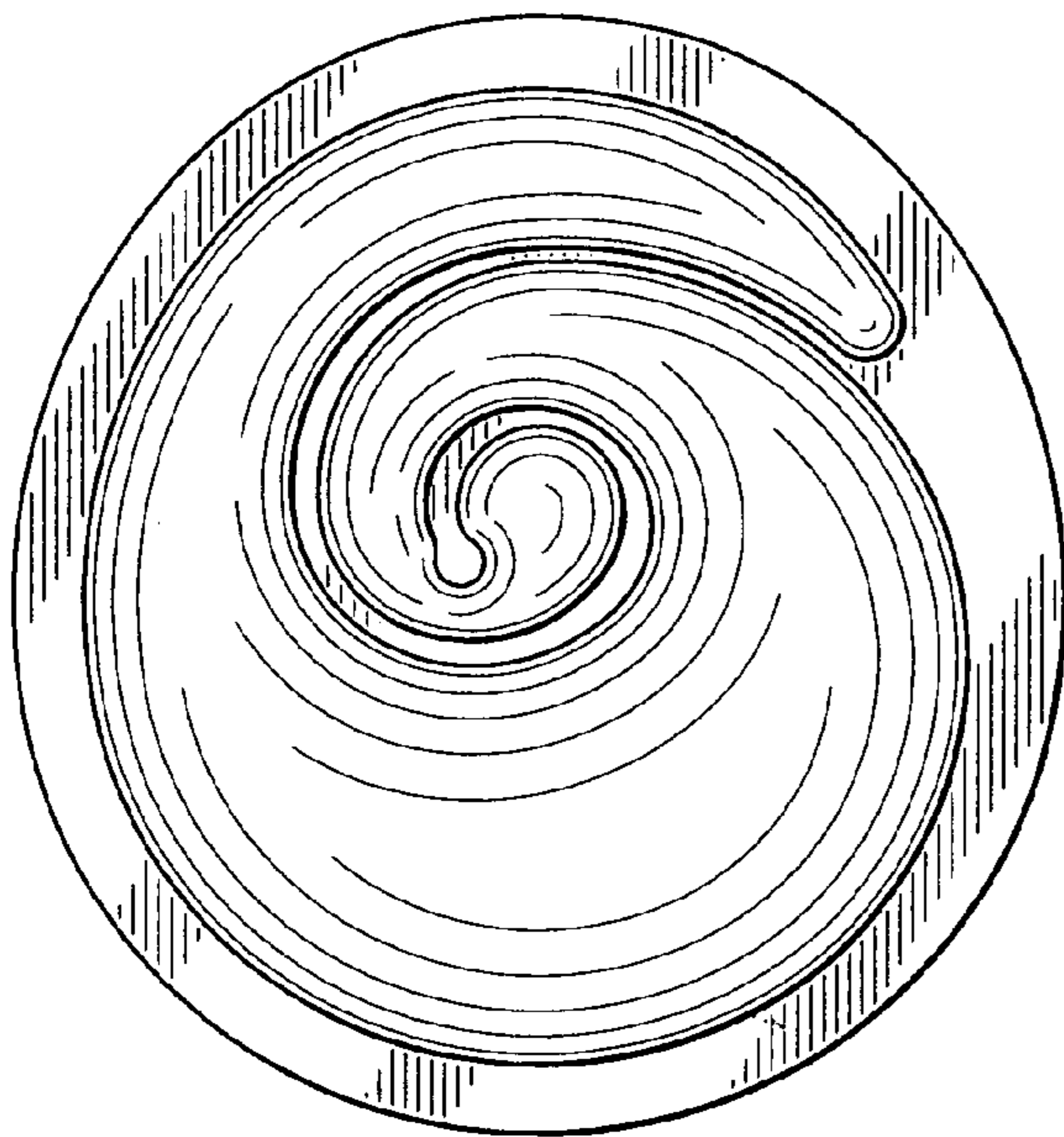

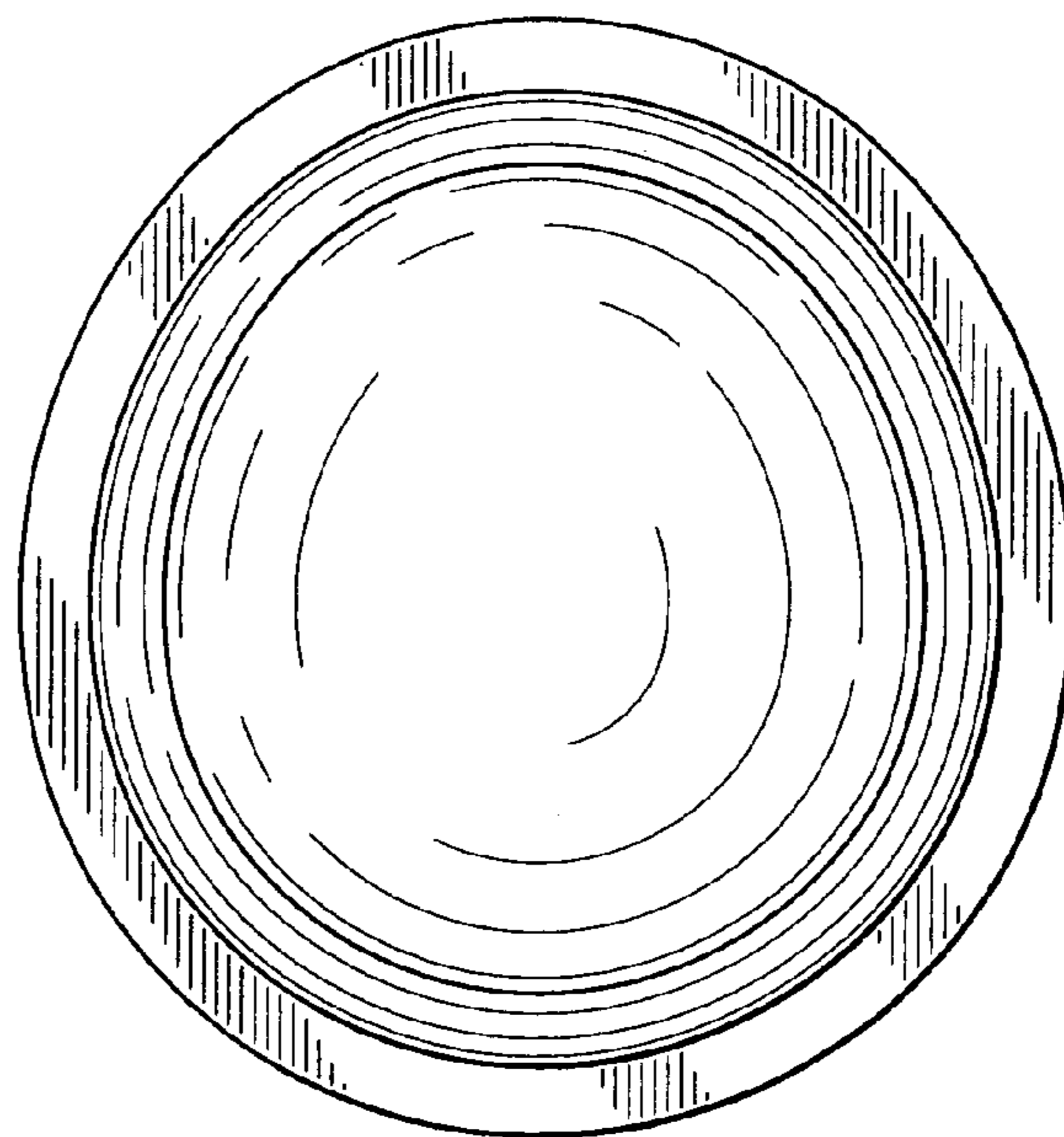

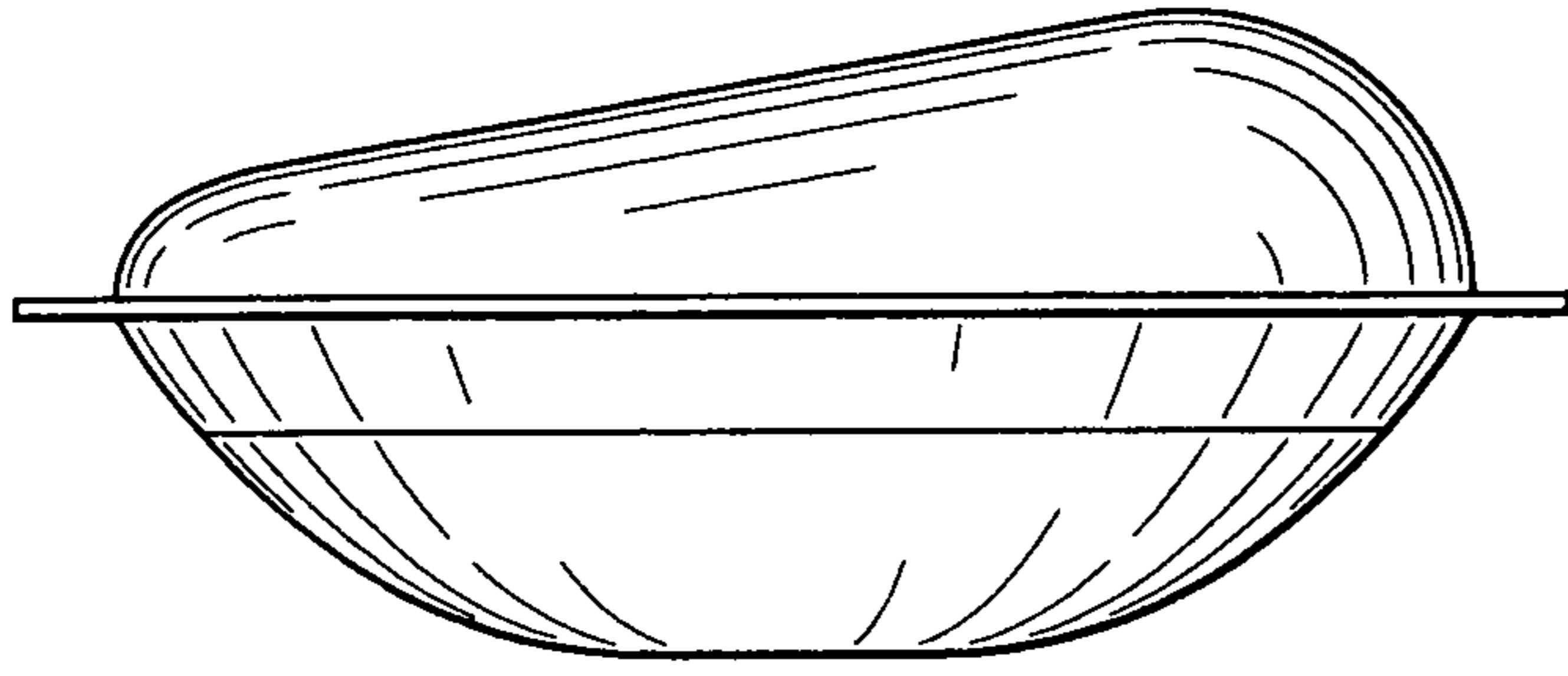

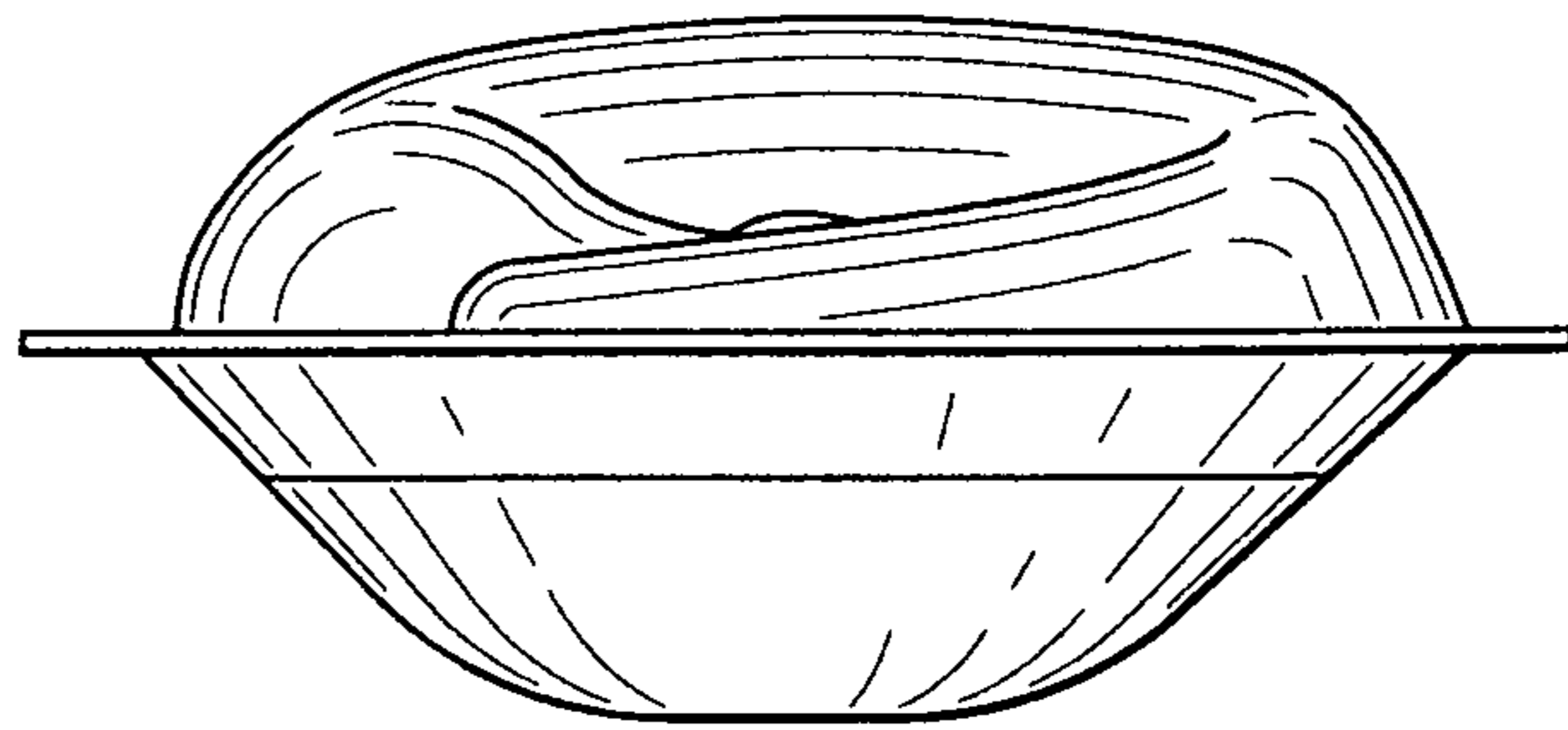

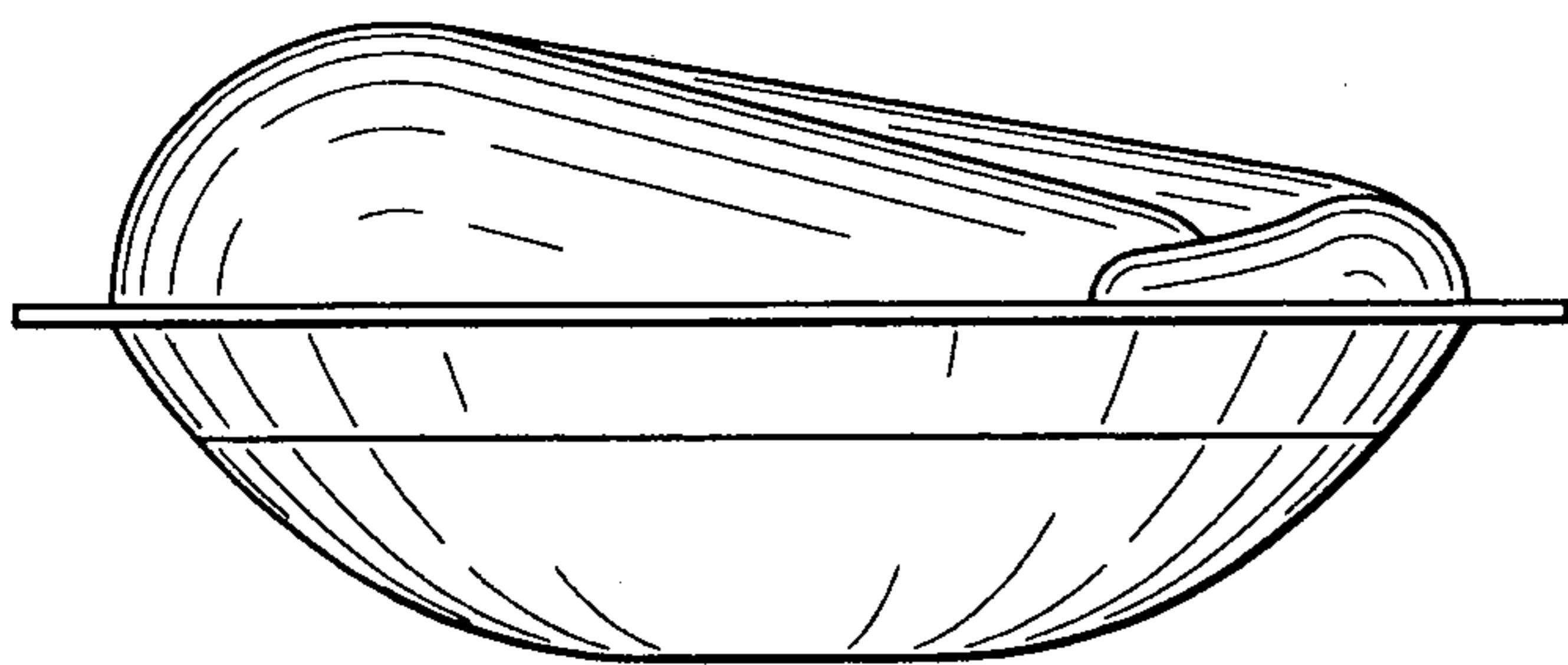

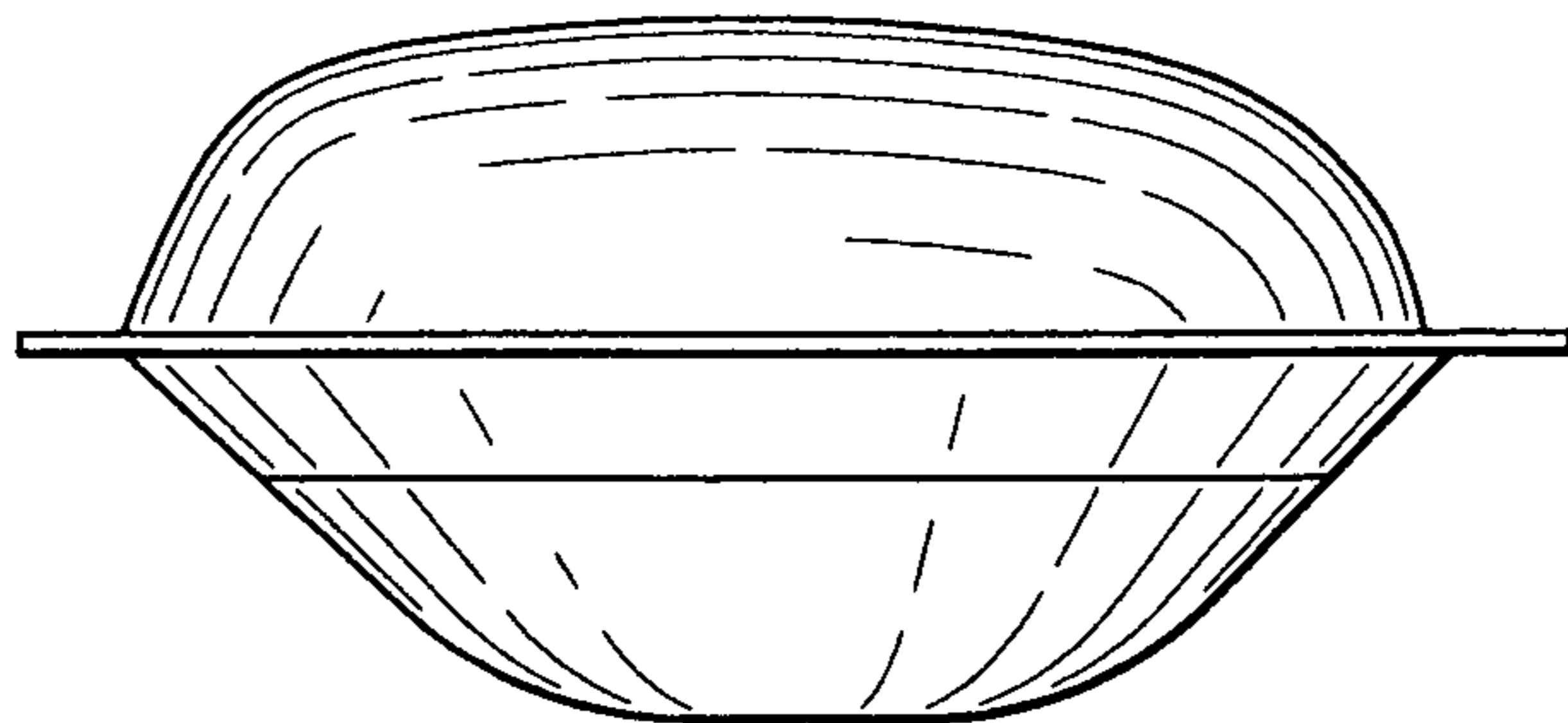

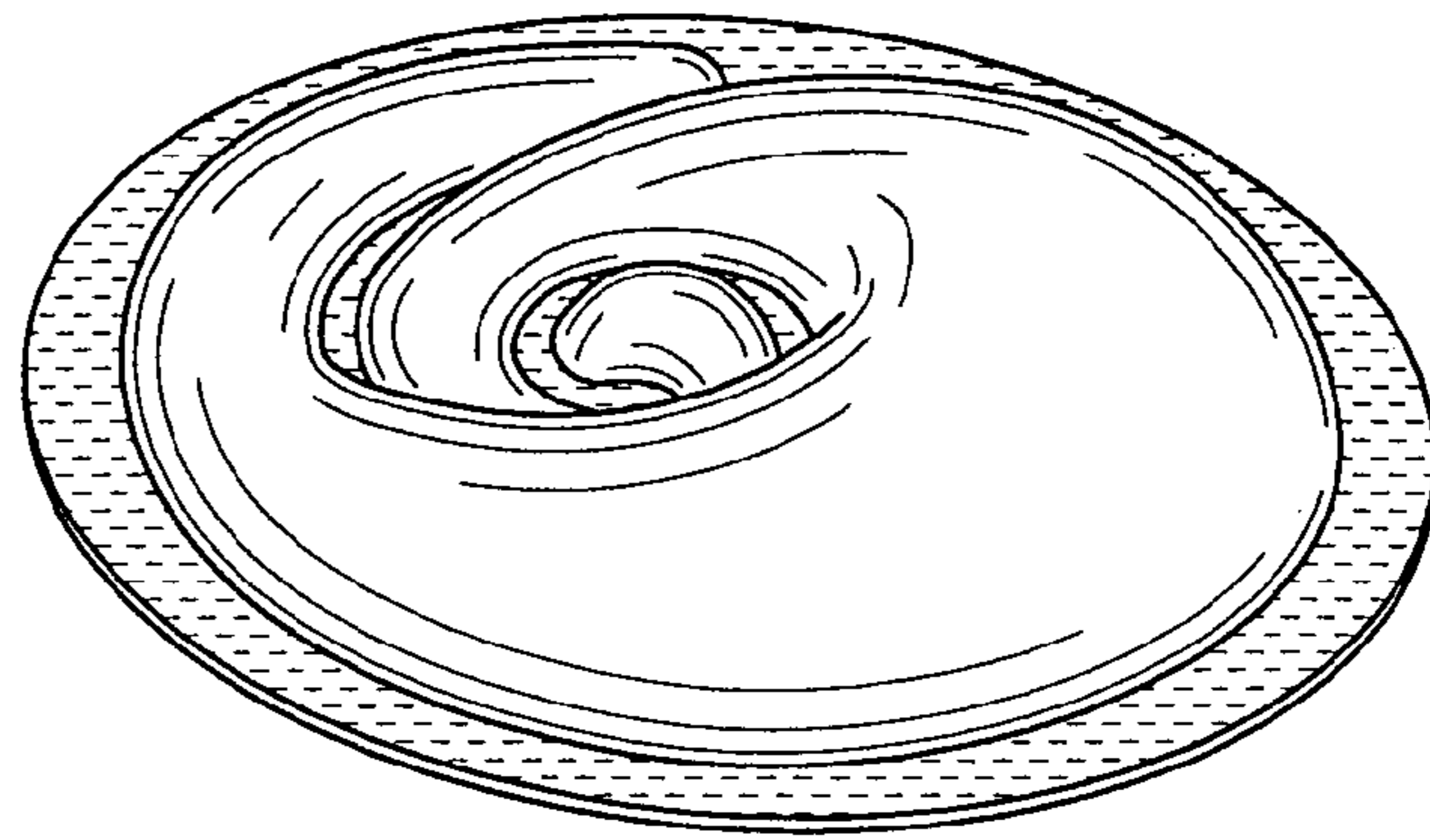

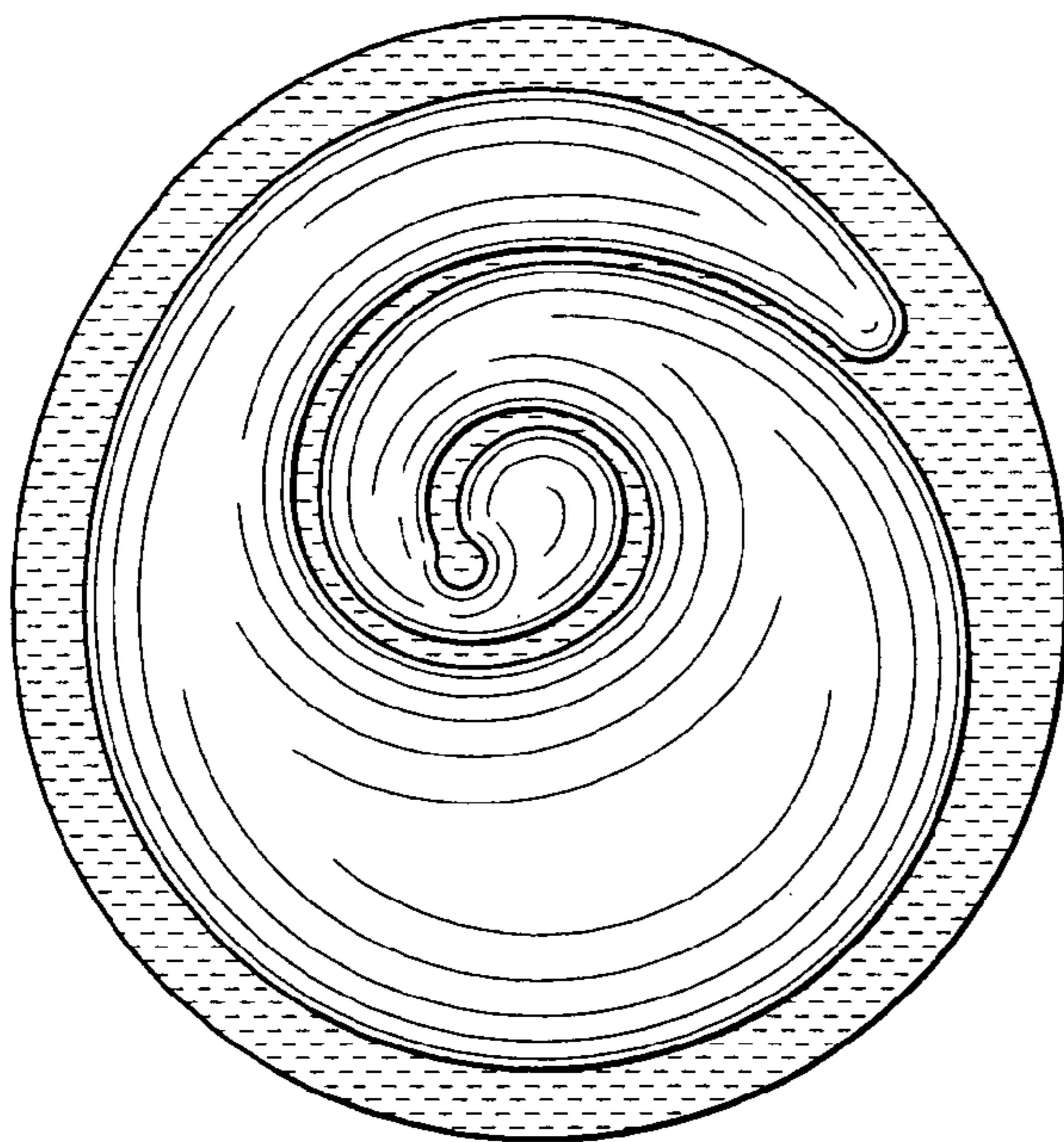

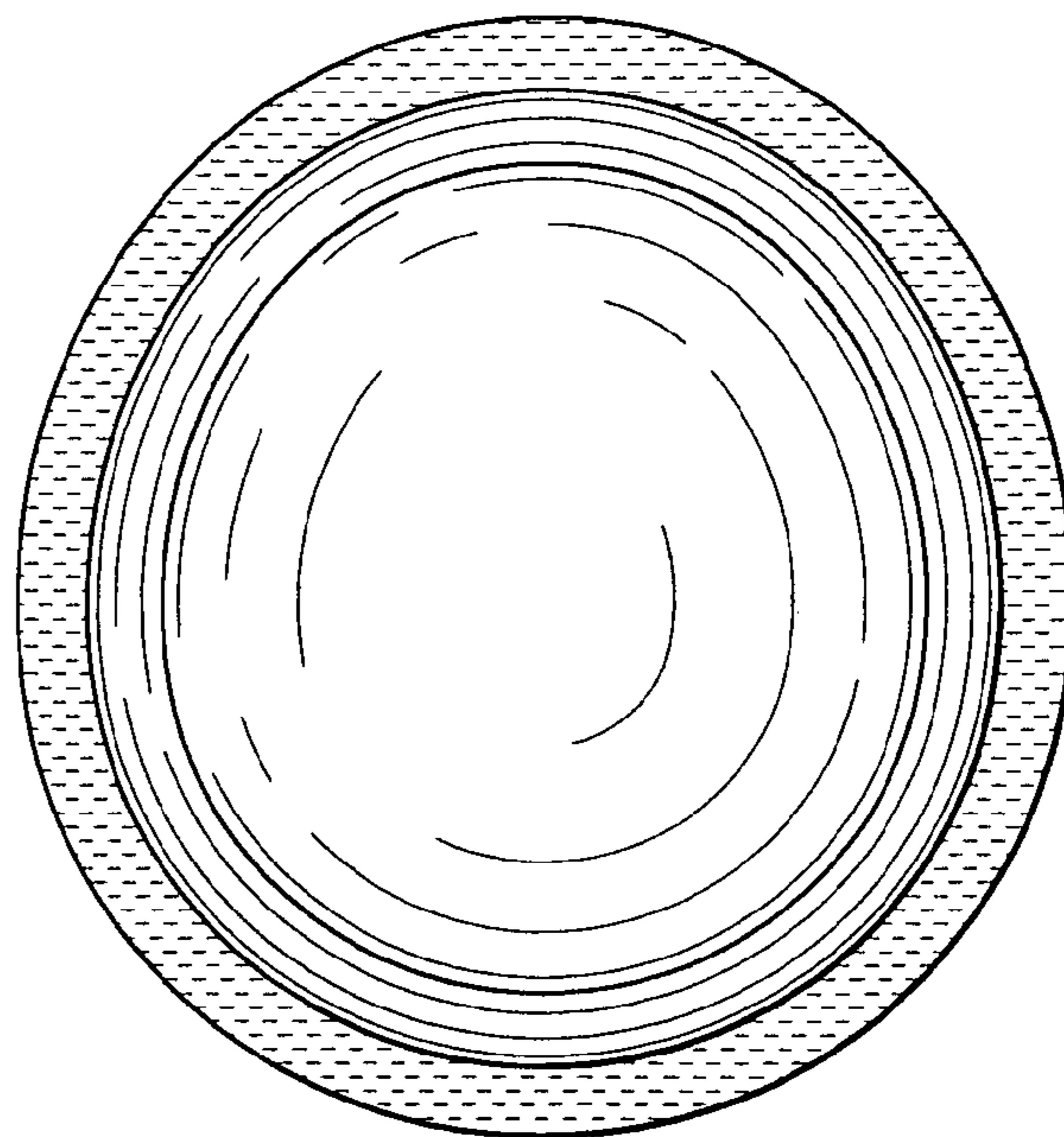

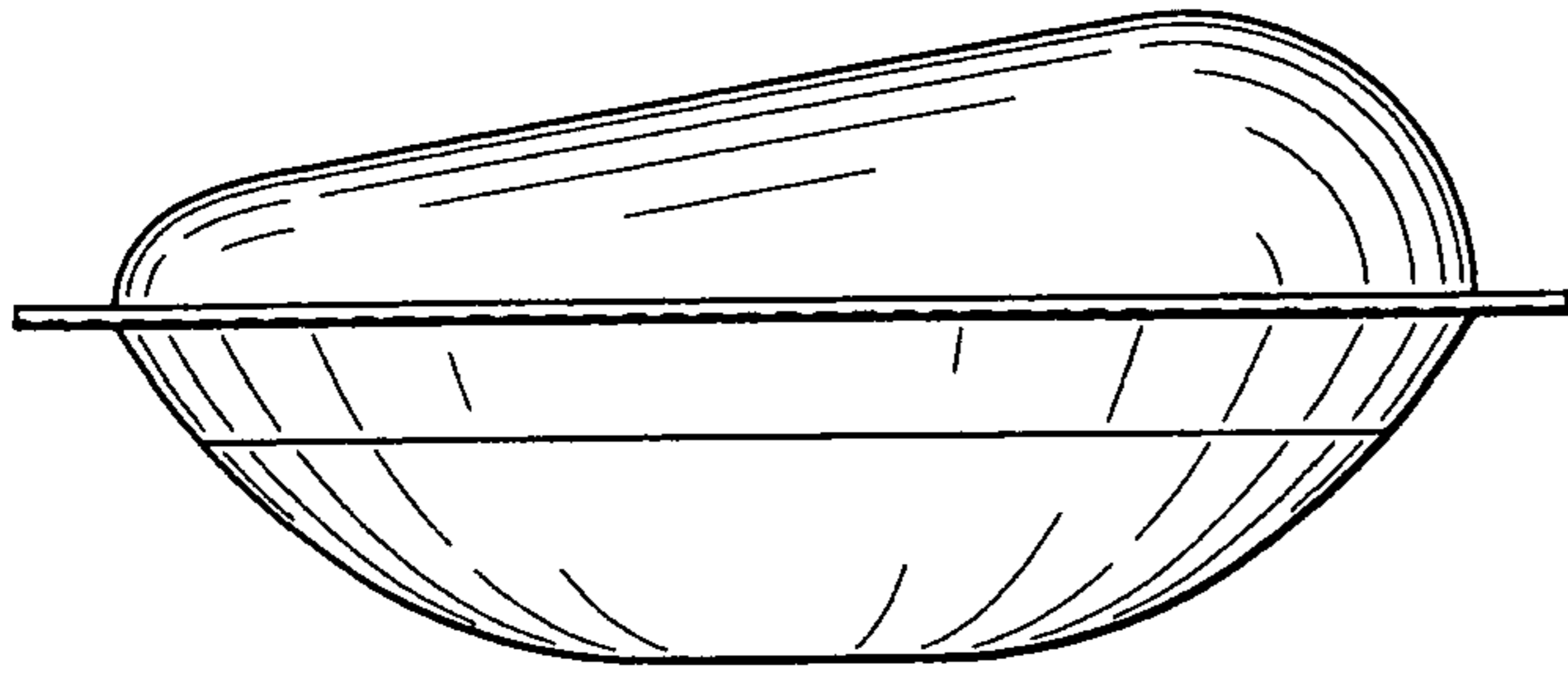

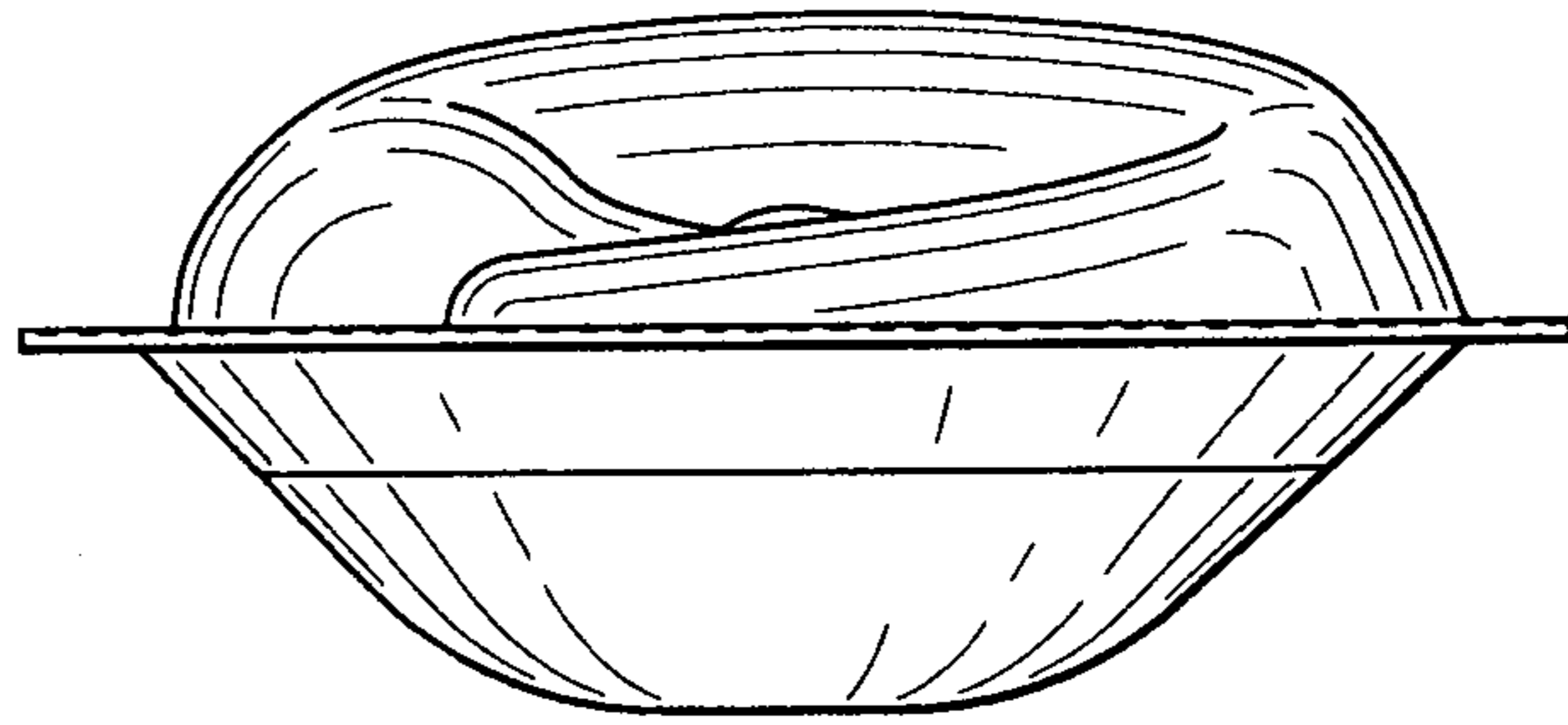

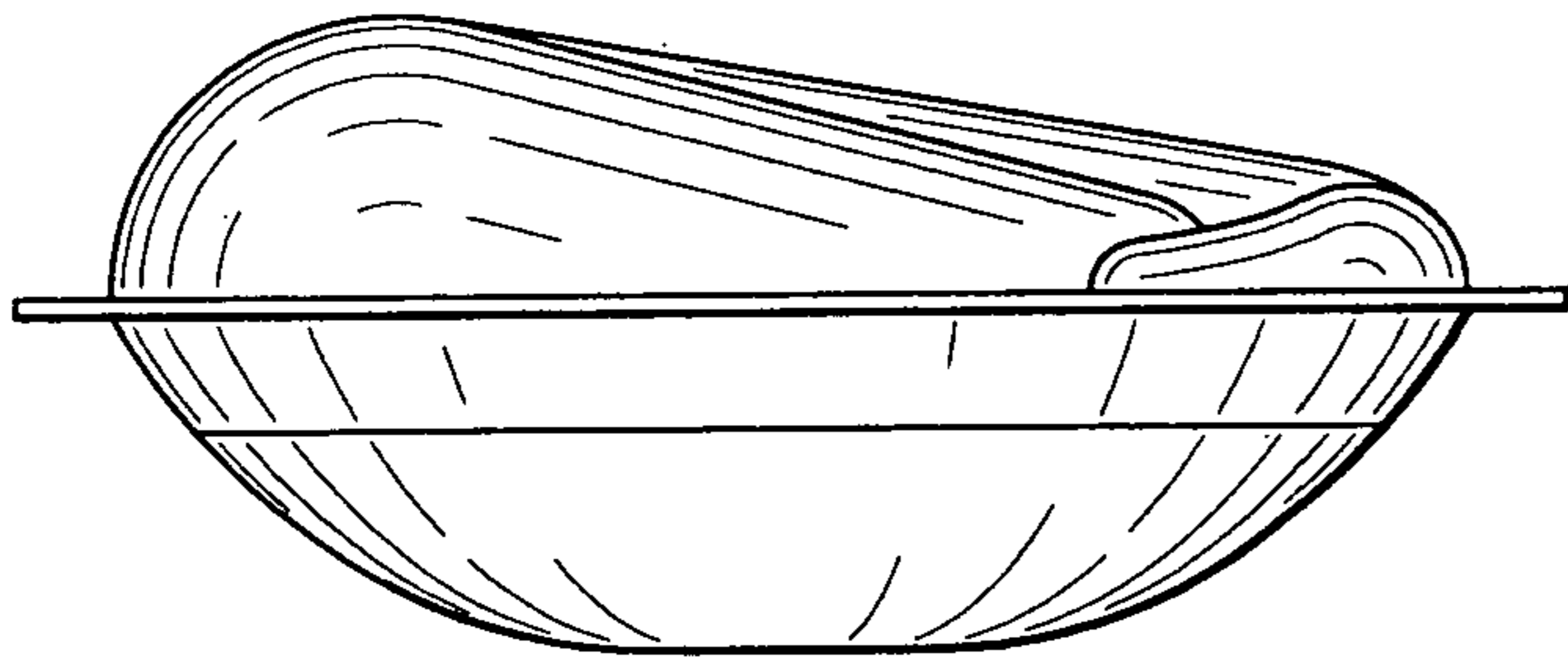

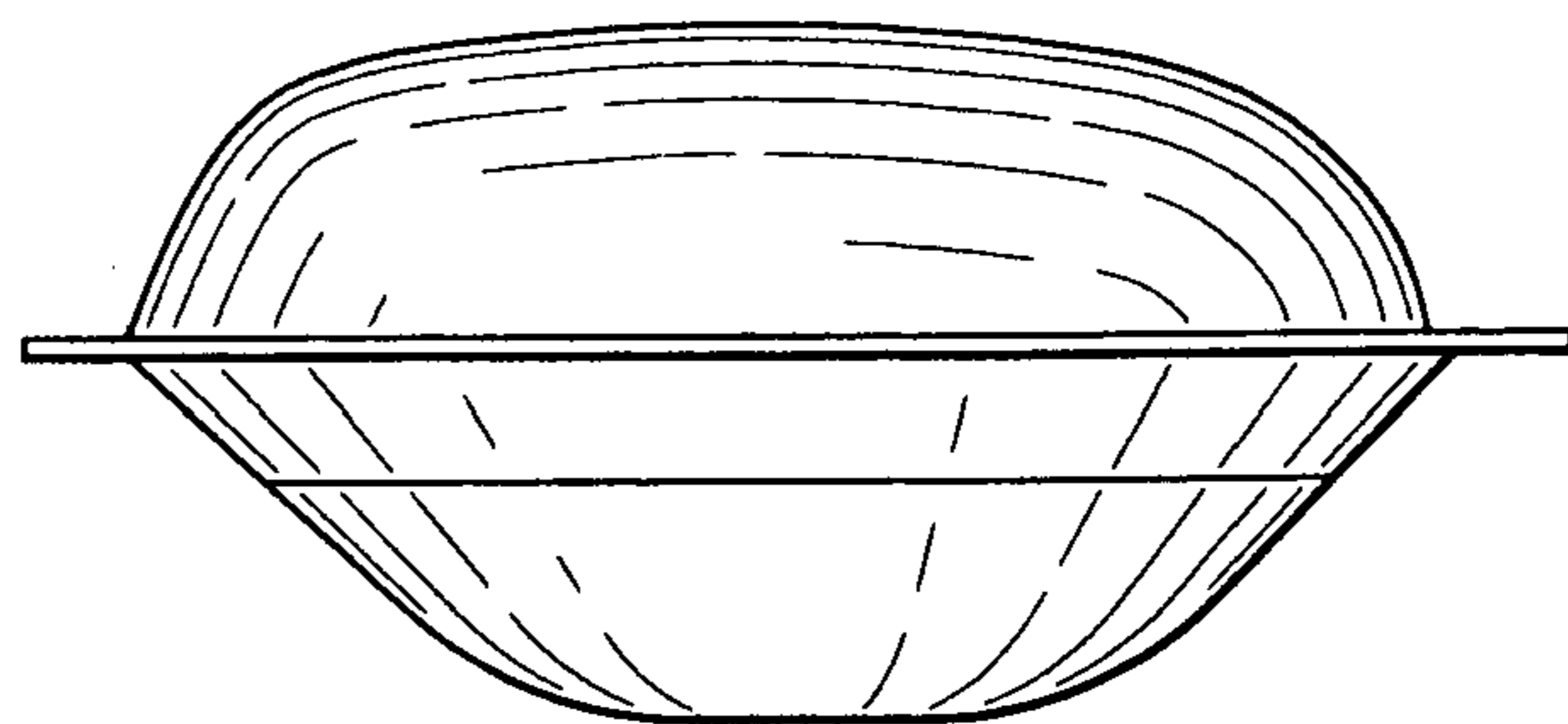

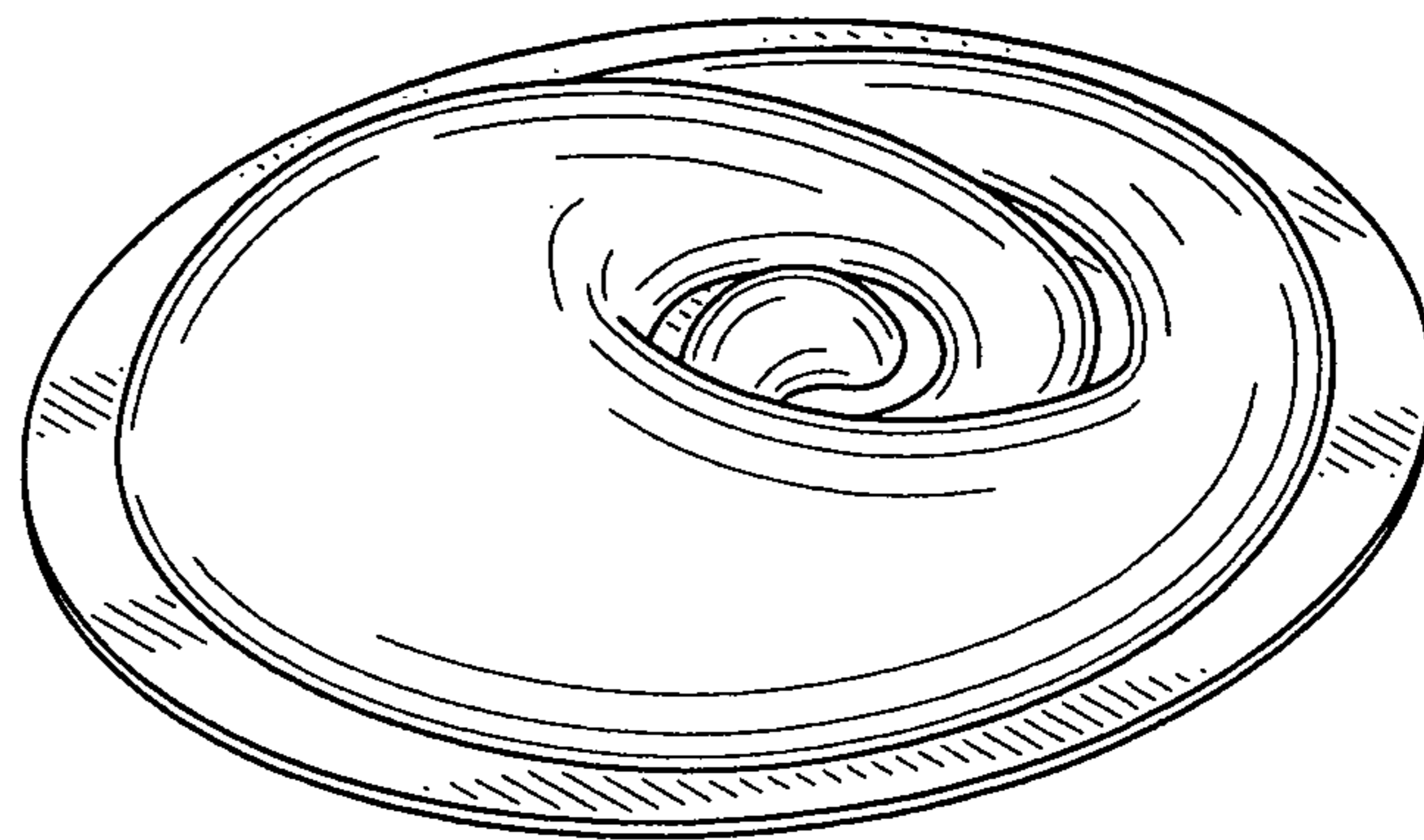

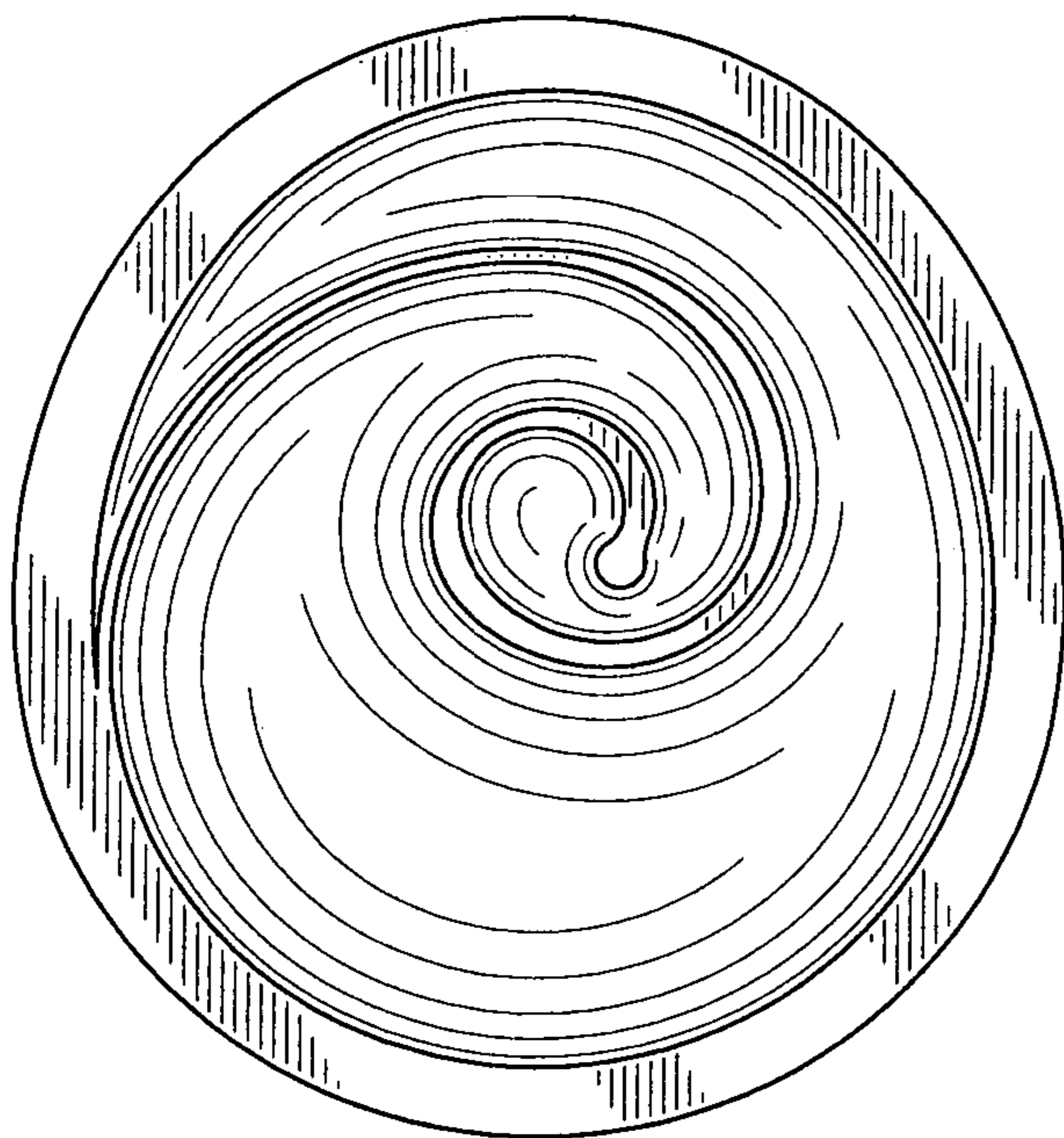

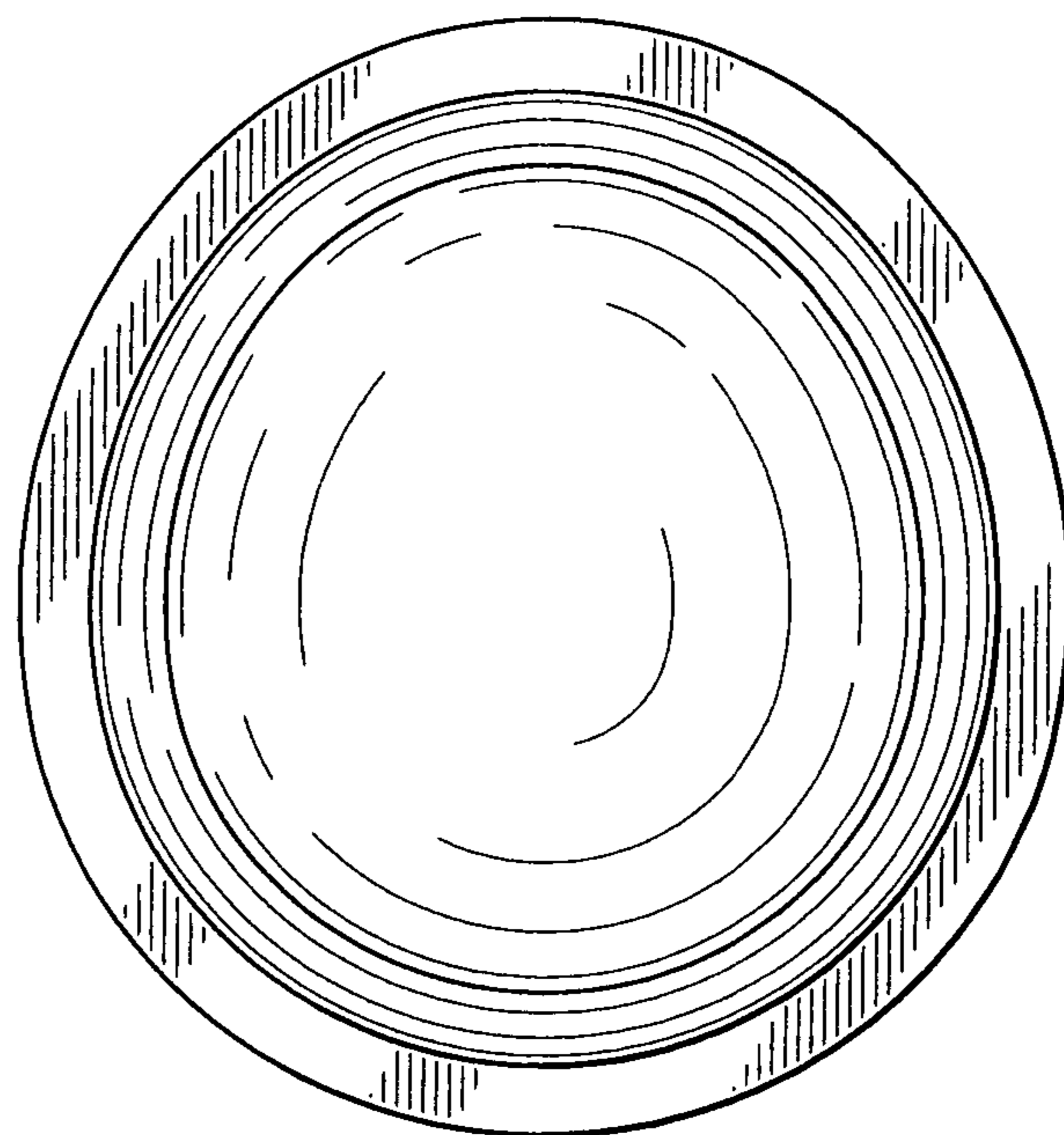

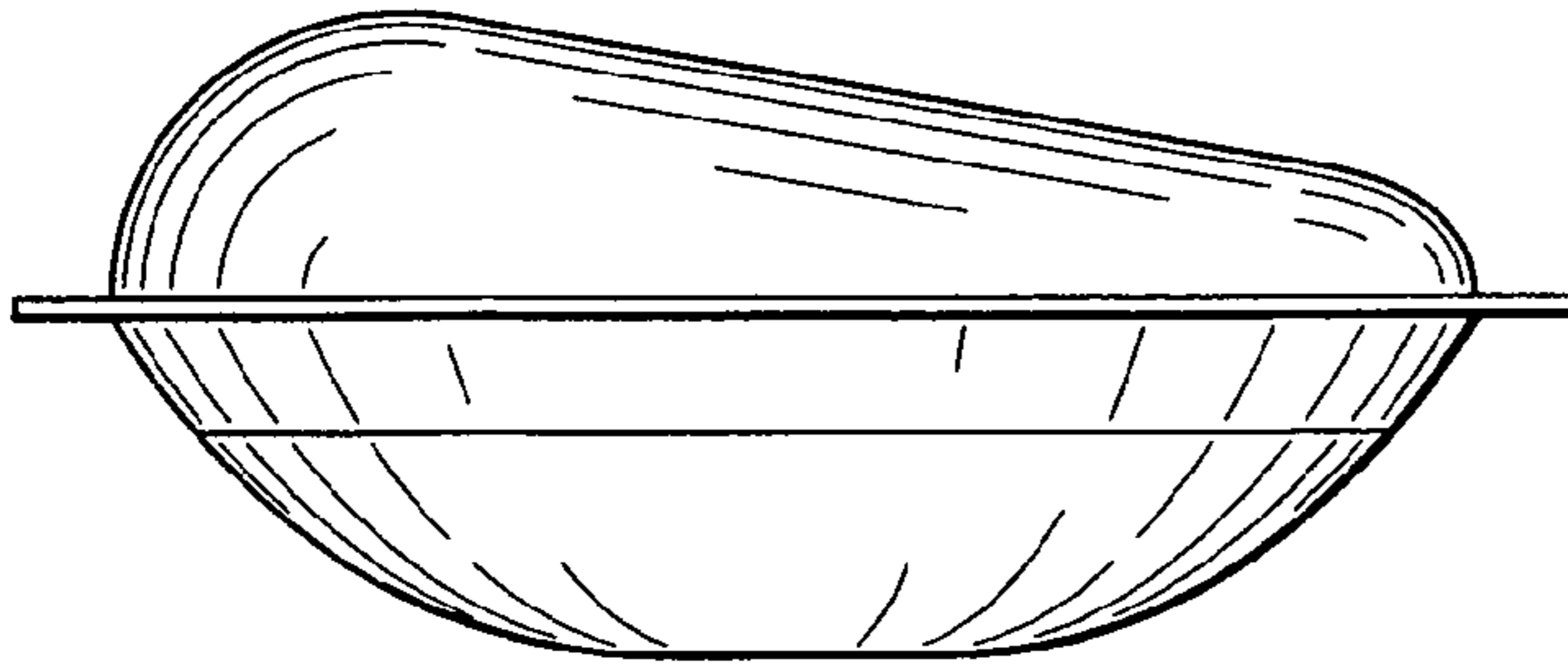

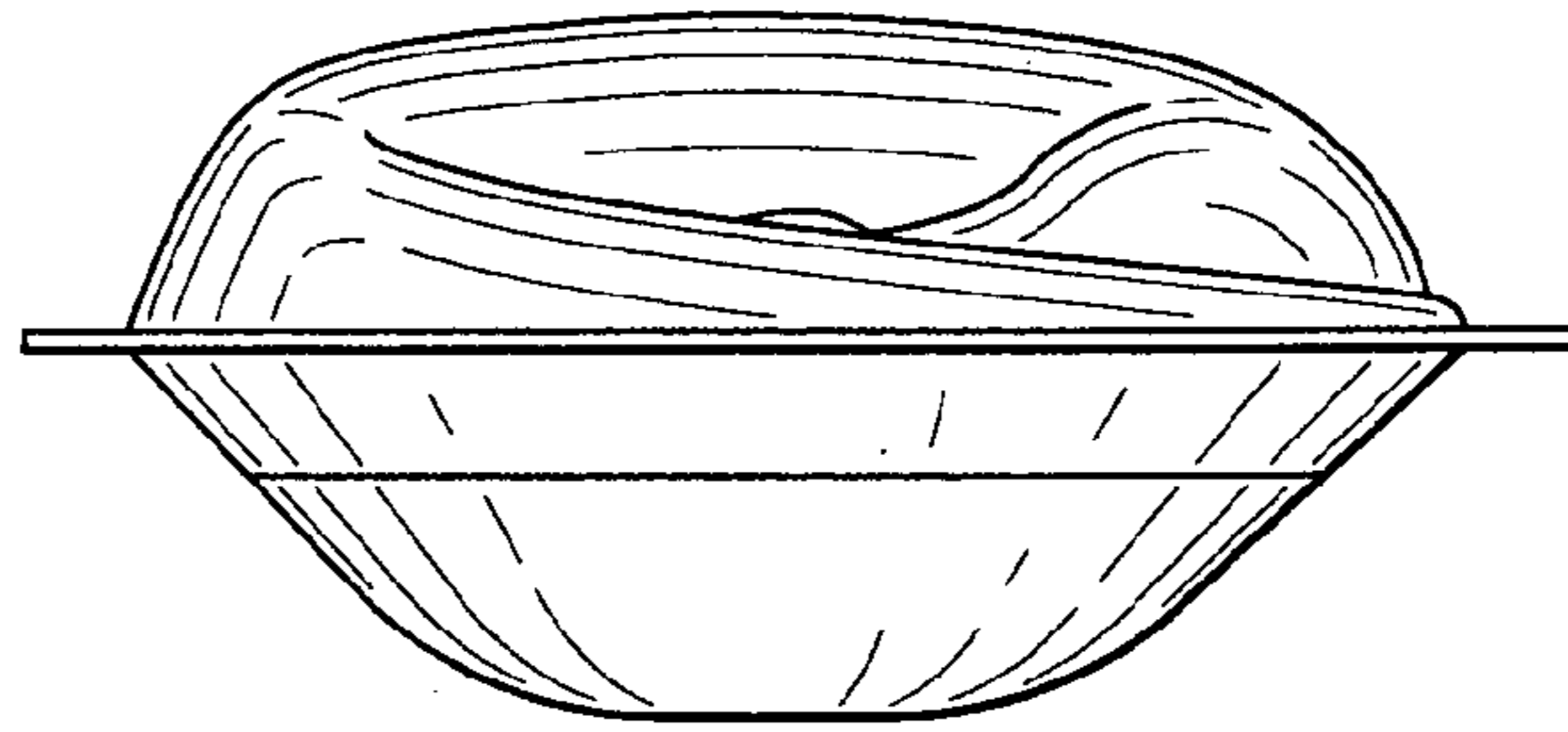

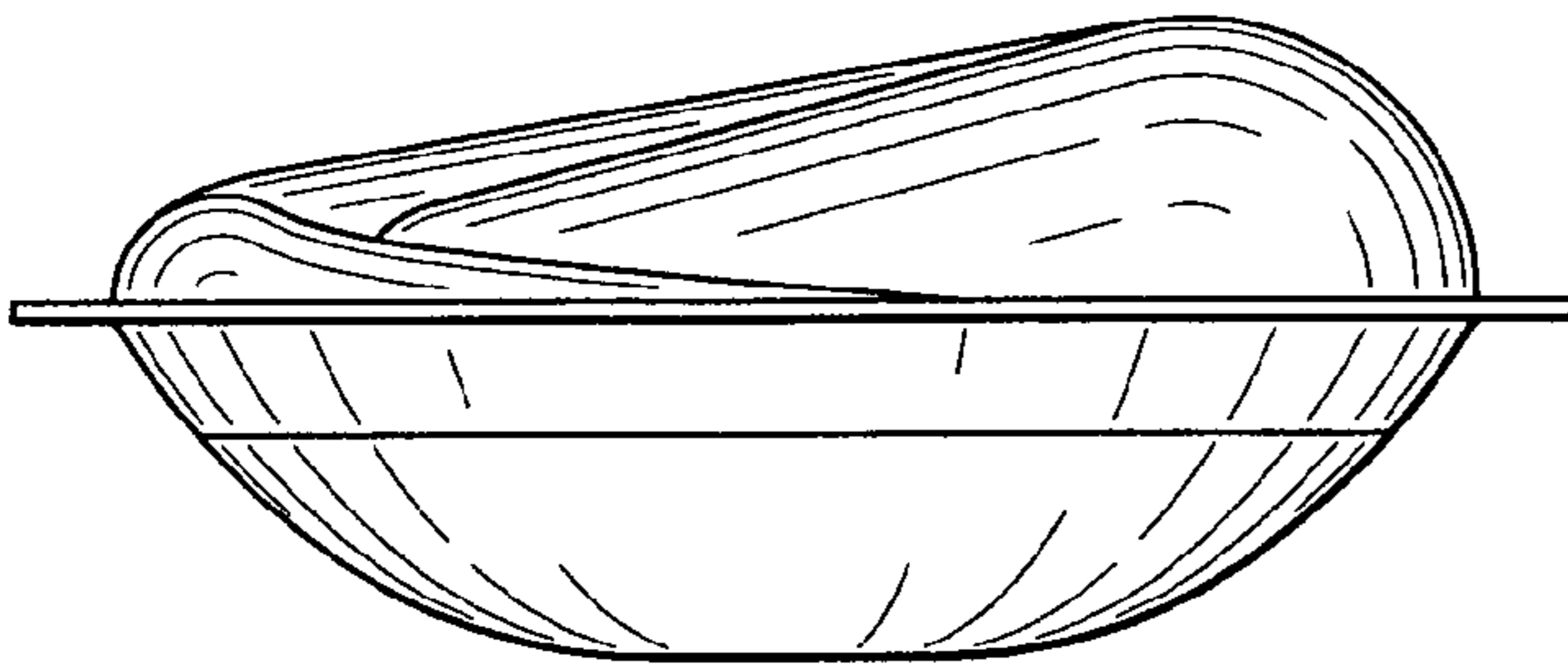

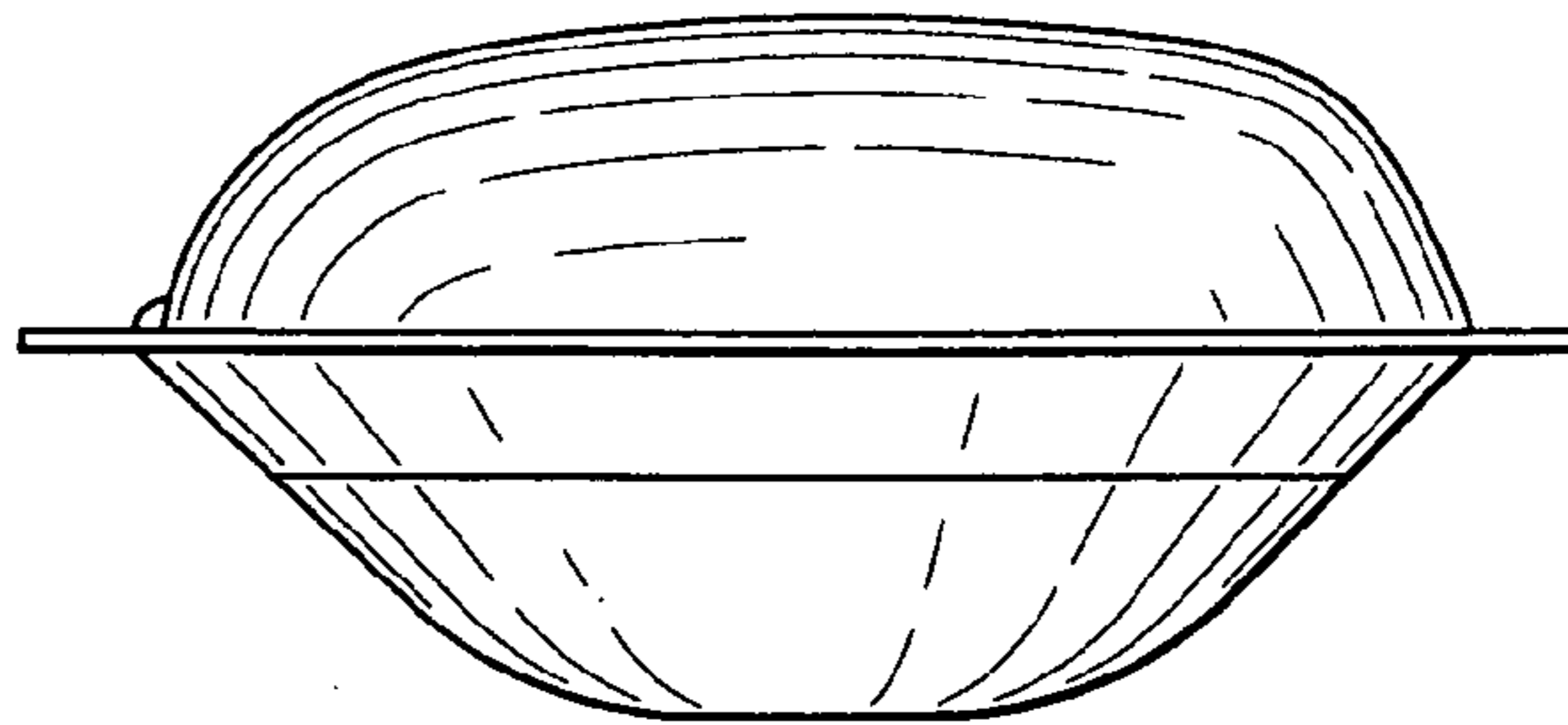

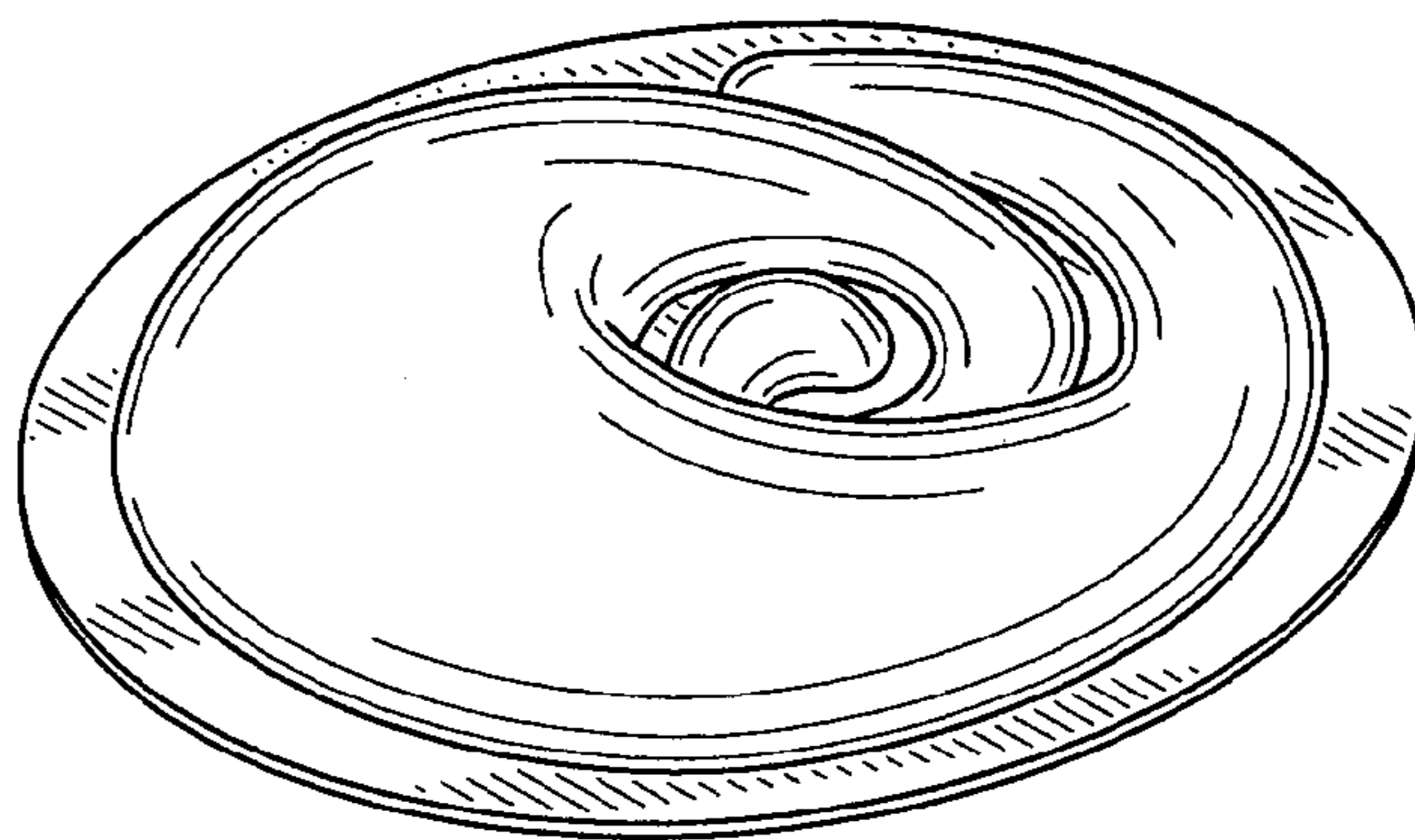

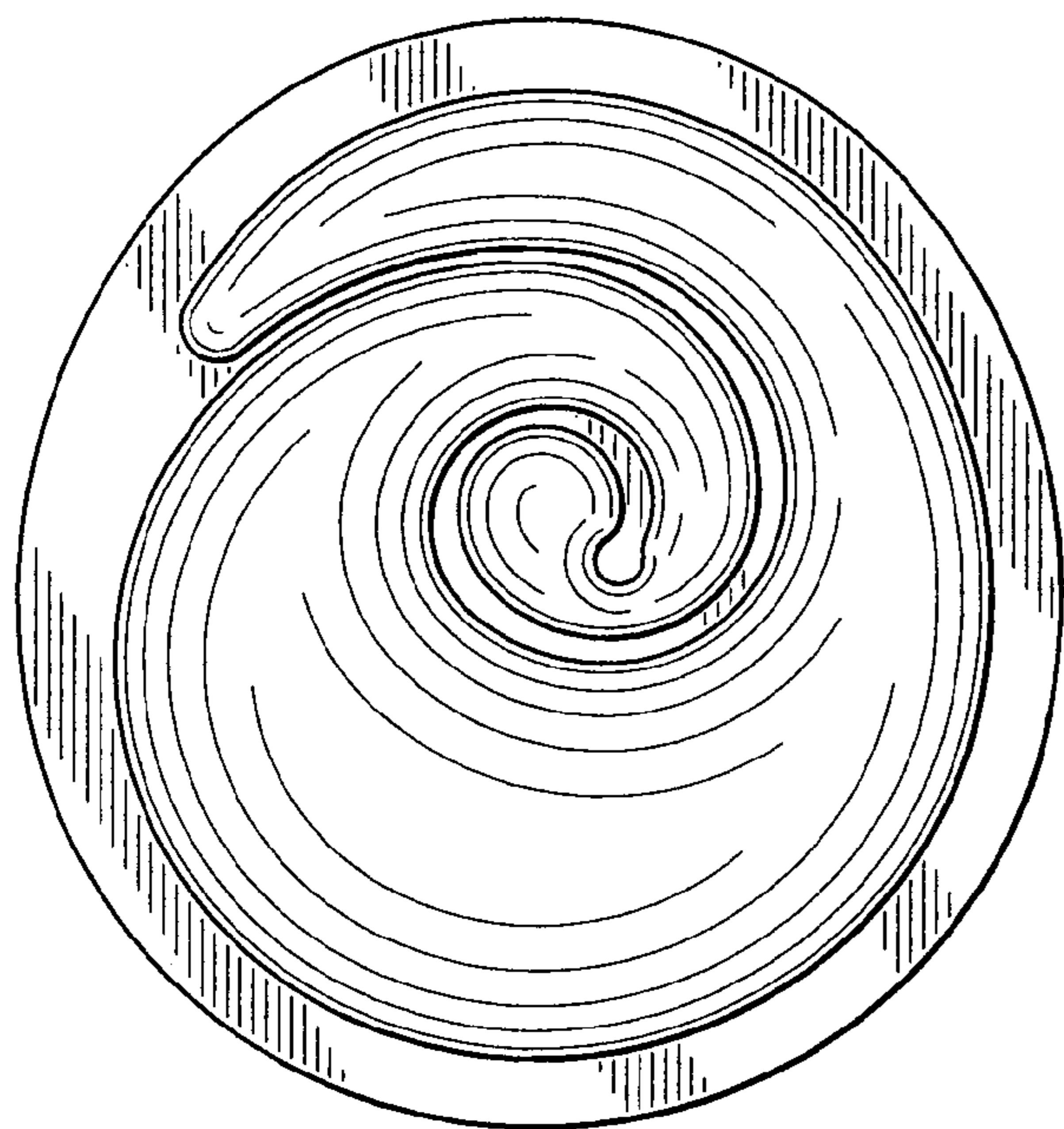

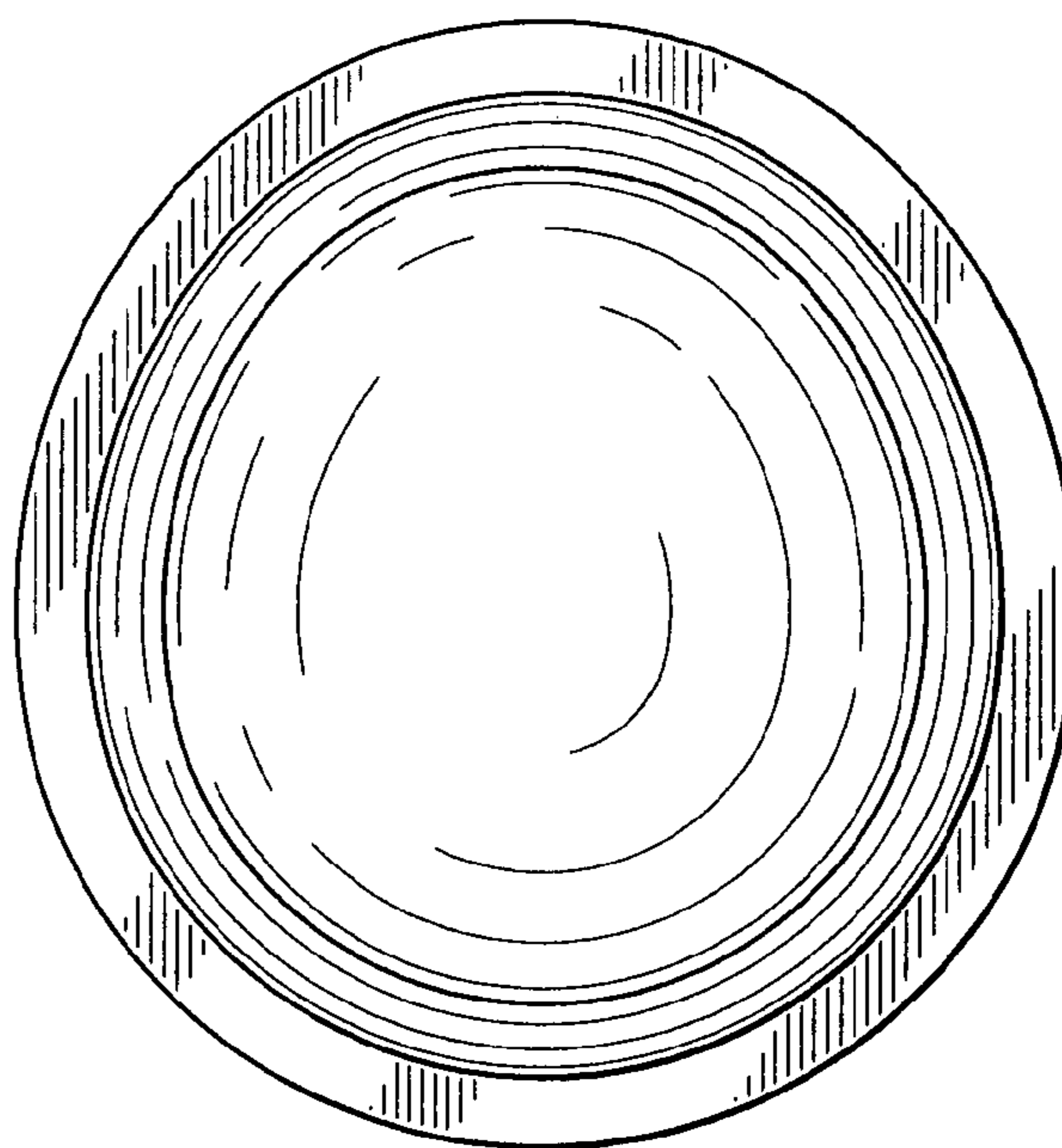

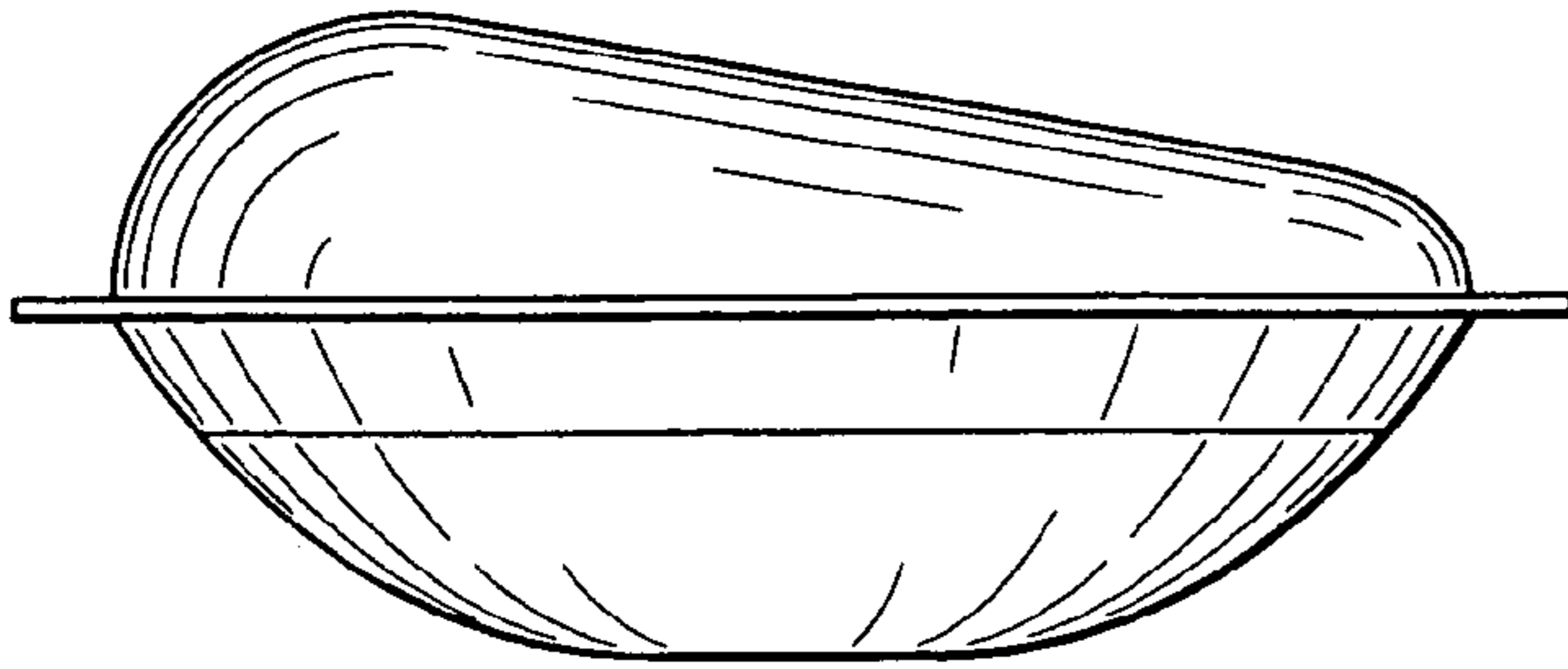

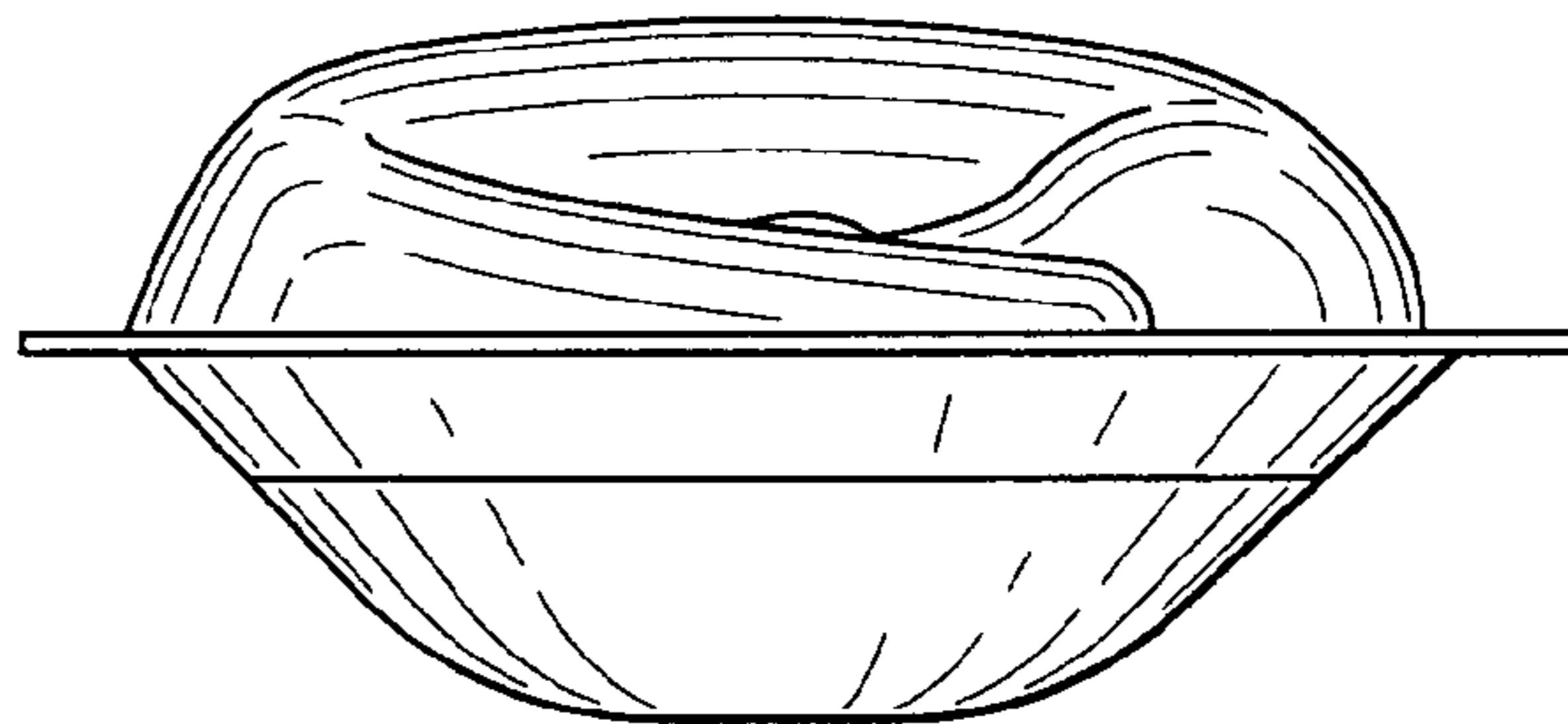

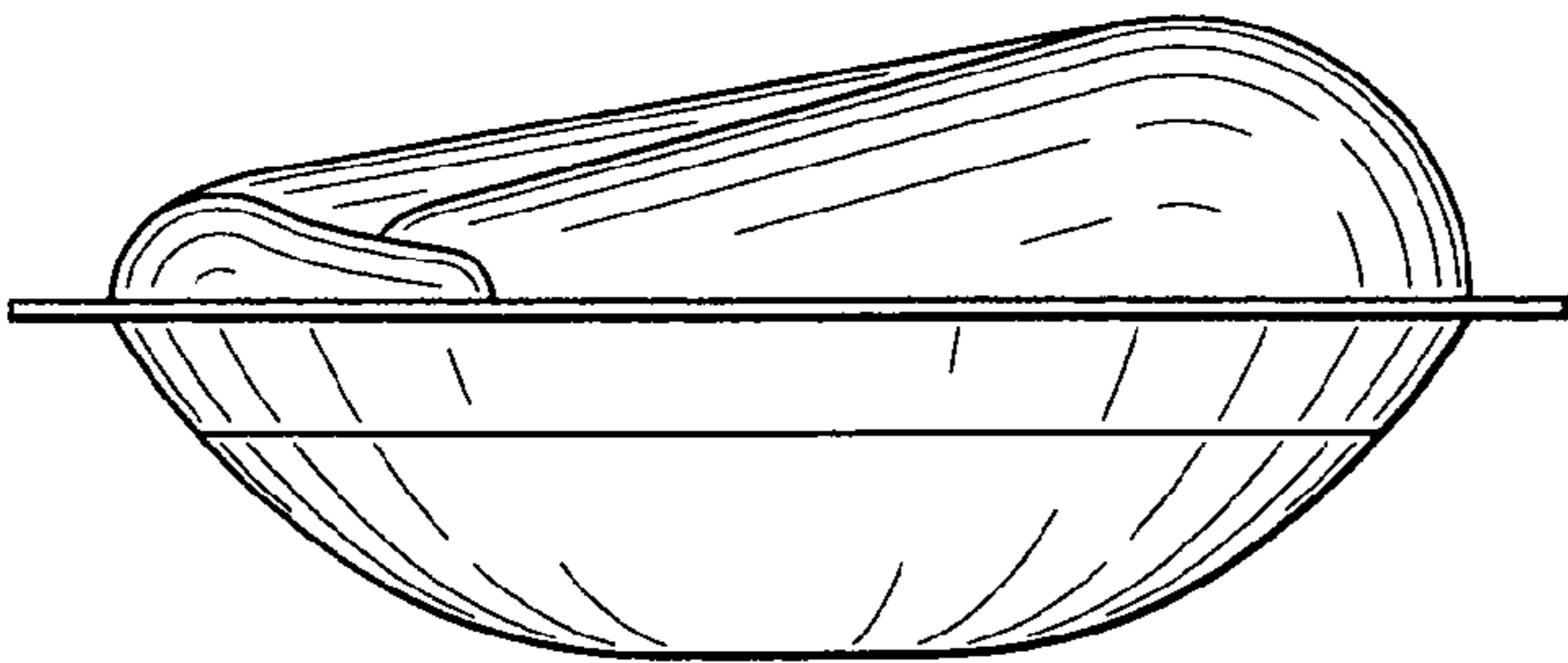

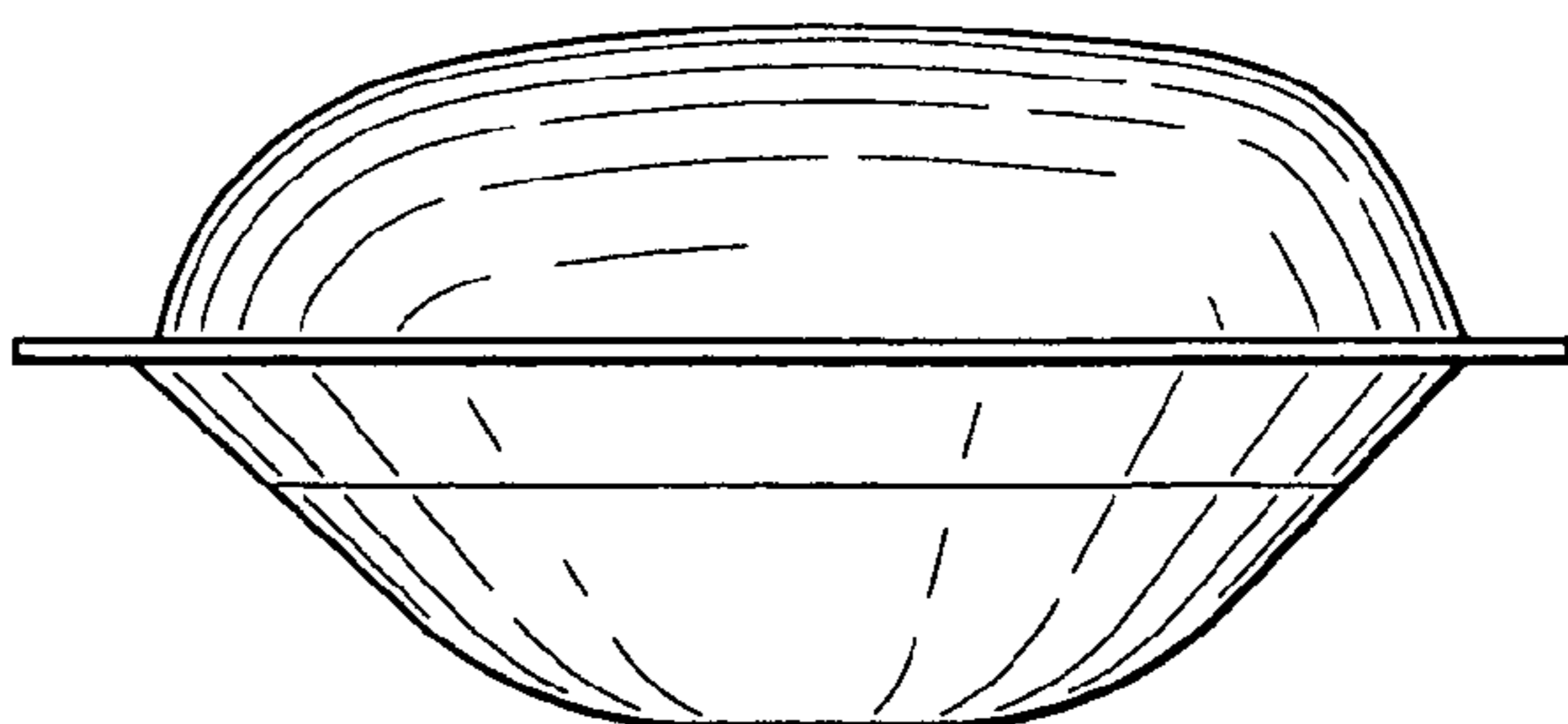
