FIG. 19 is a back view of the third embodiment of the pouch comprising a silver colored portion;

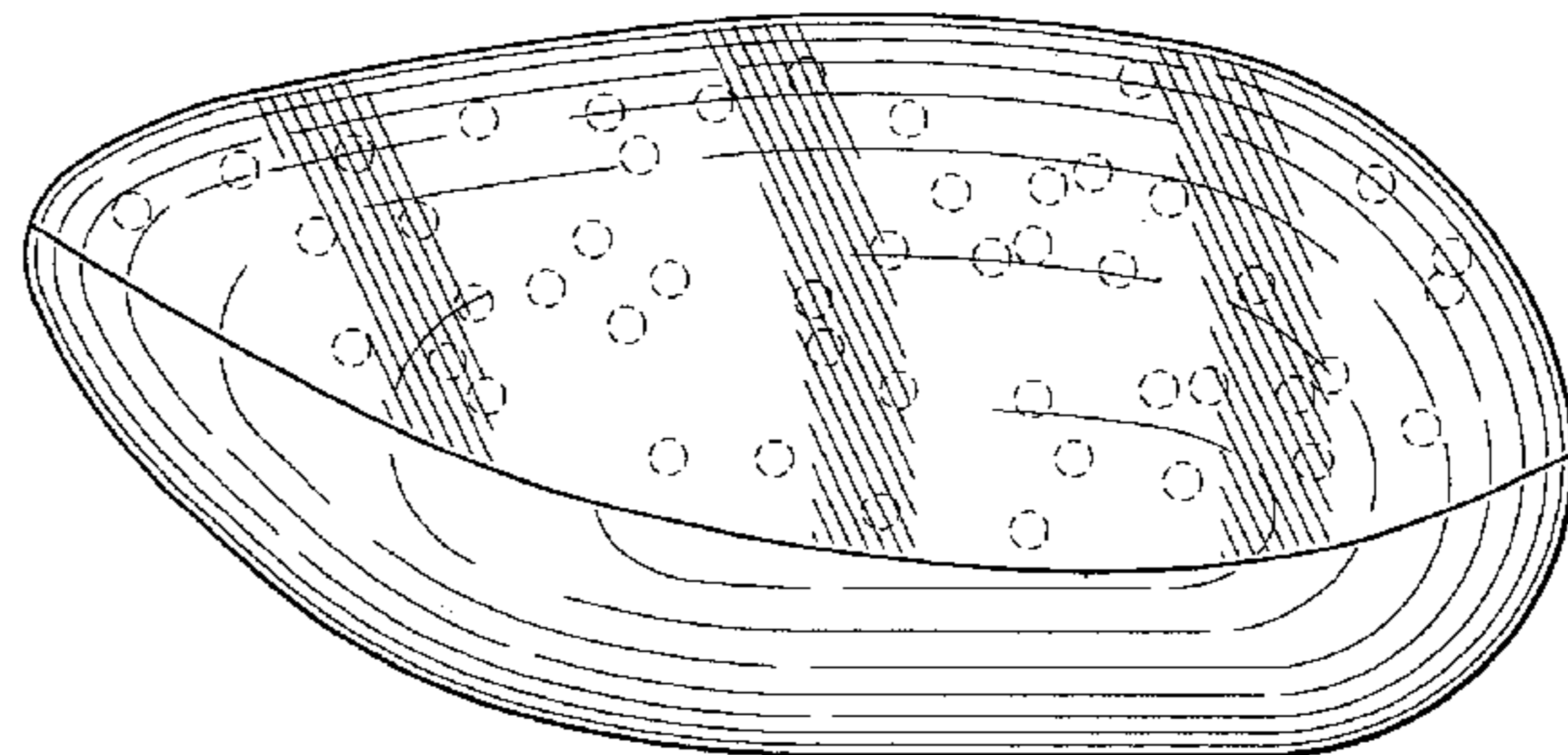
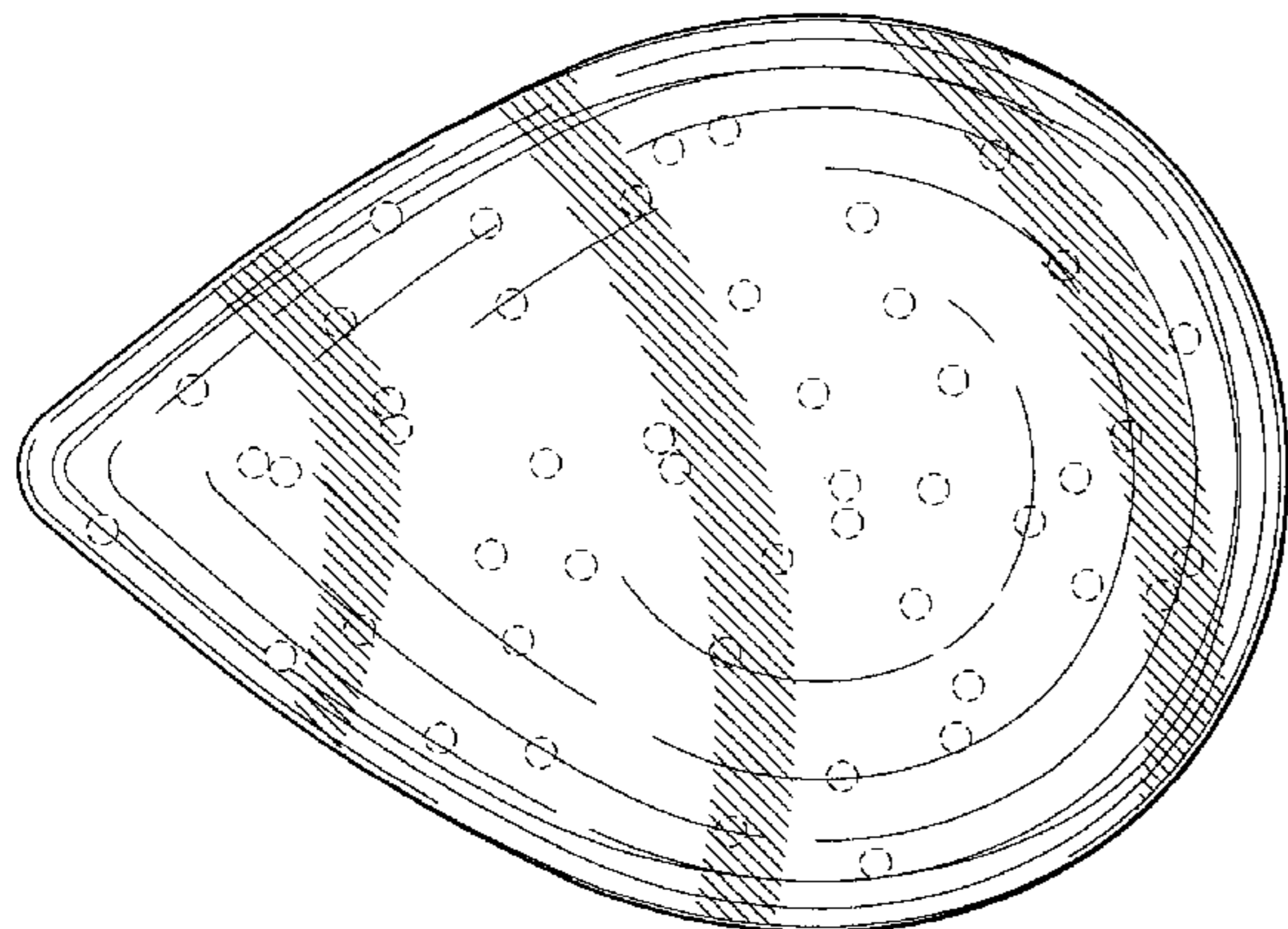
FIG. 20 is a left view of the third embodiment of the pouch comprising a silver colored portion; and,

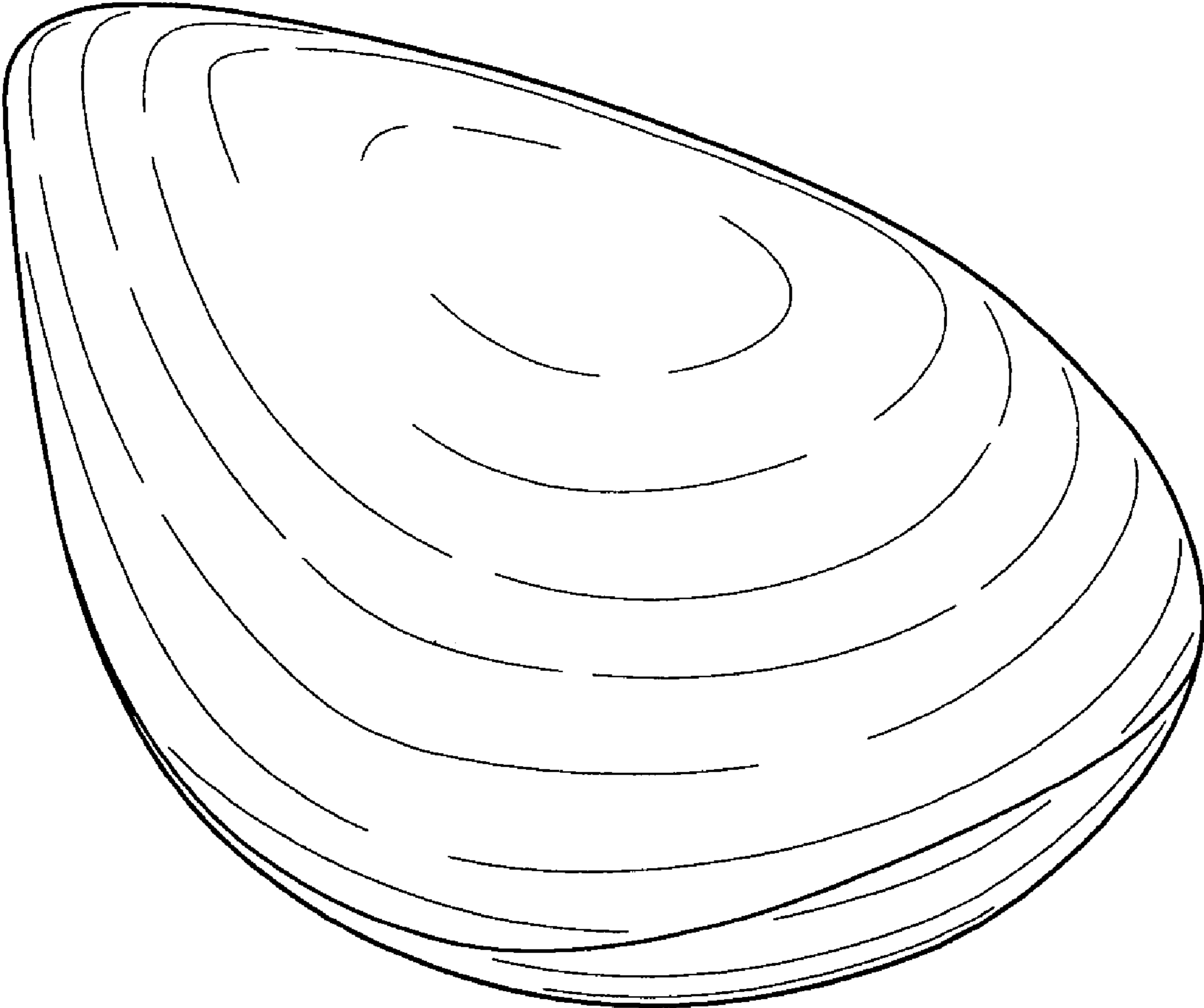

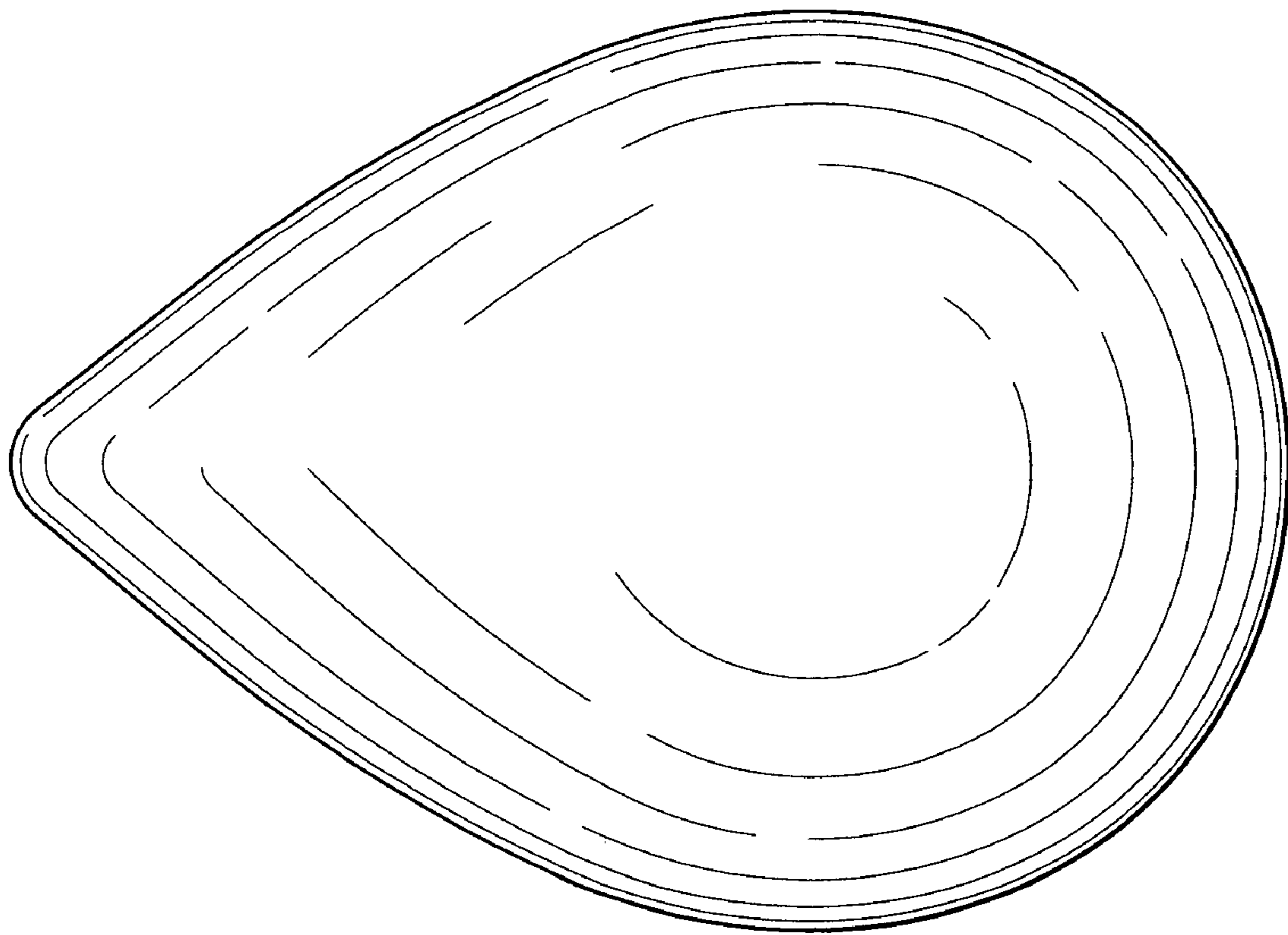

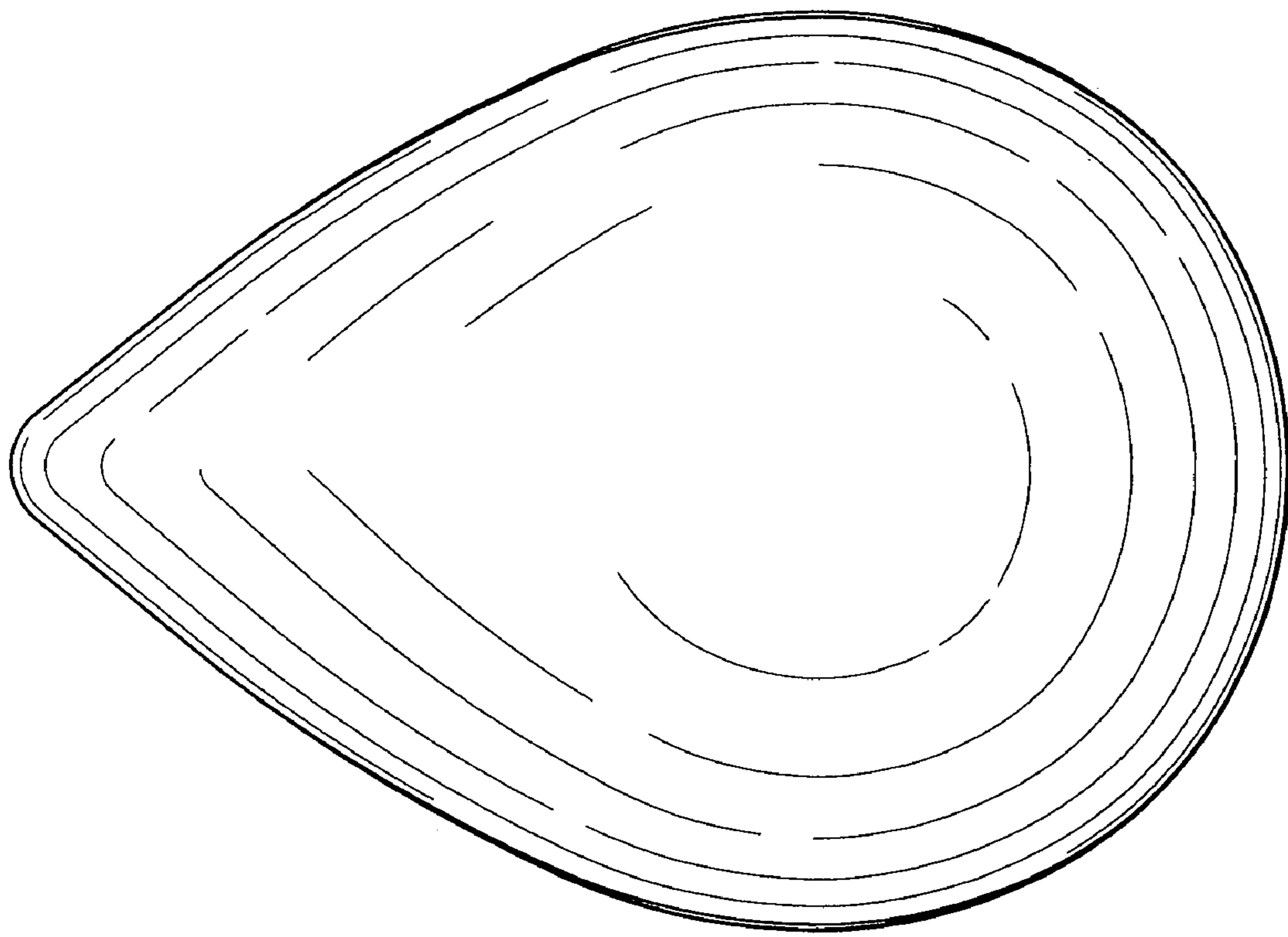

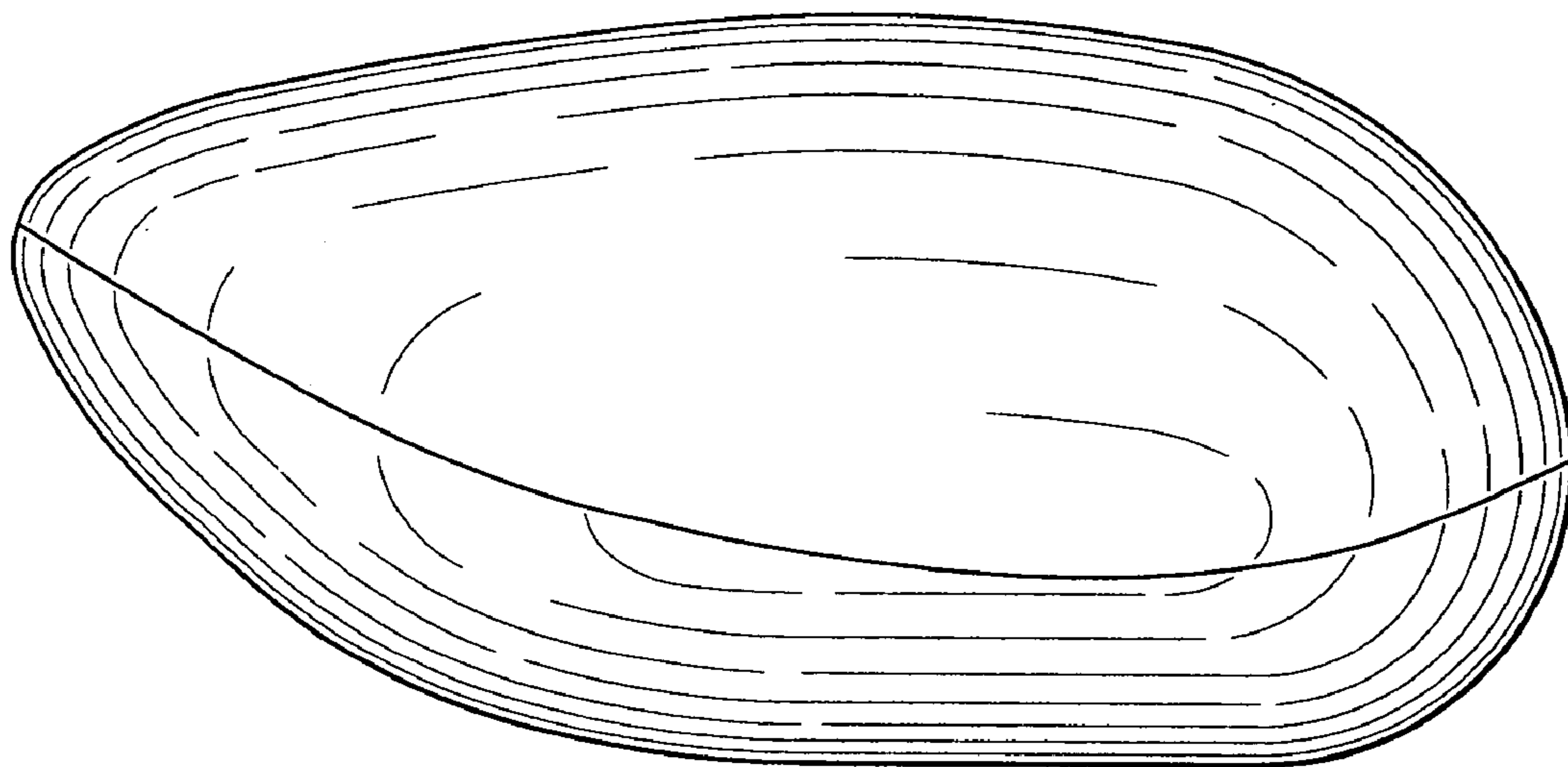

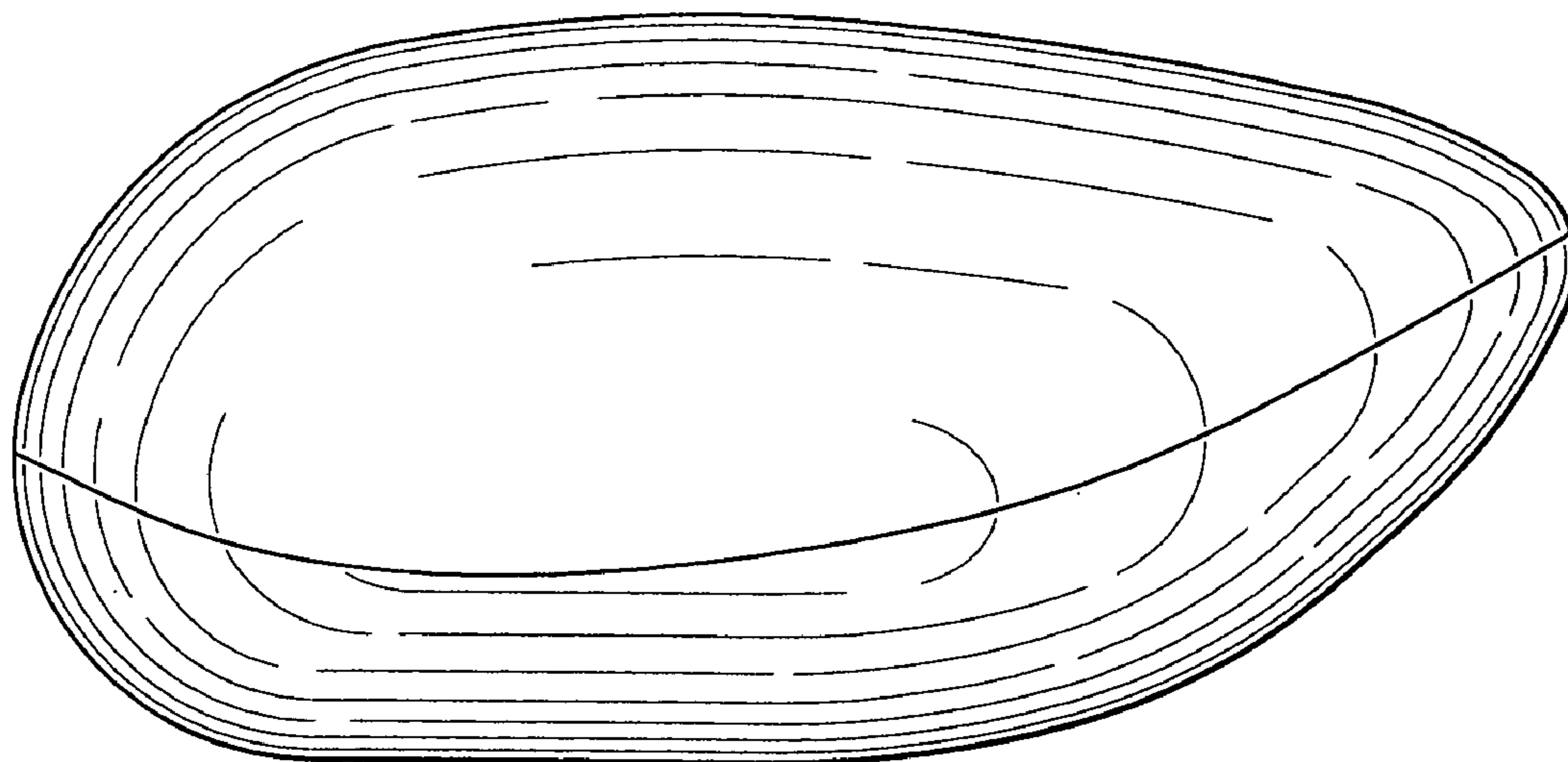

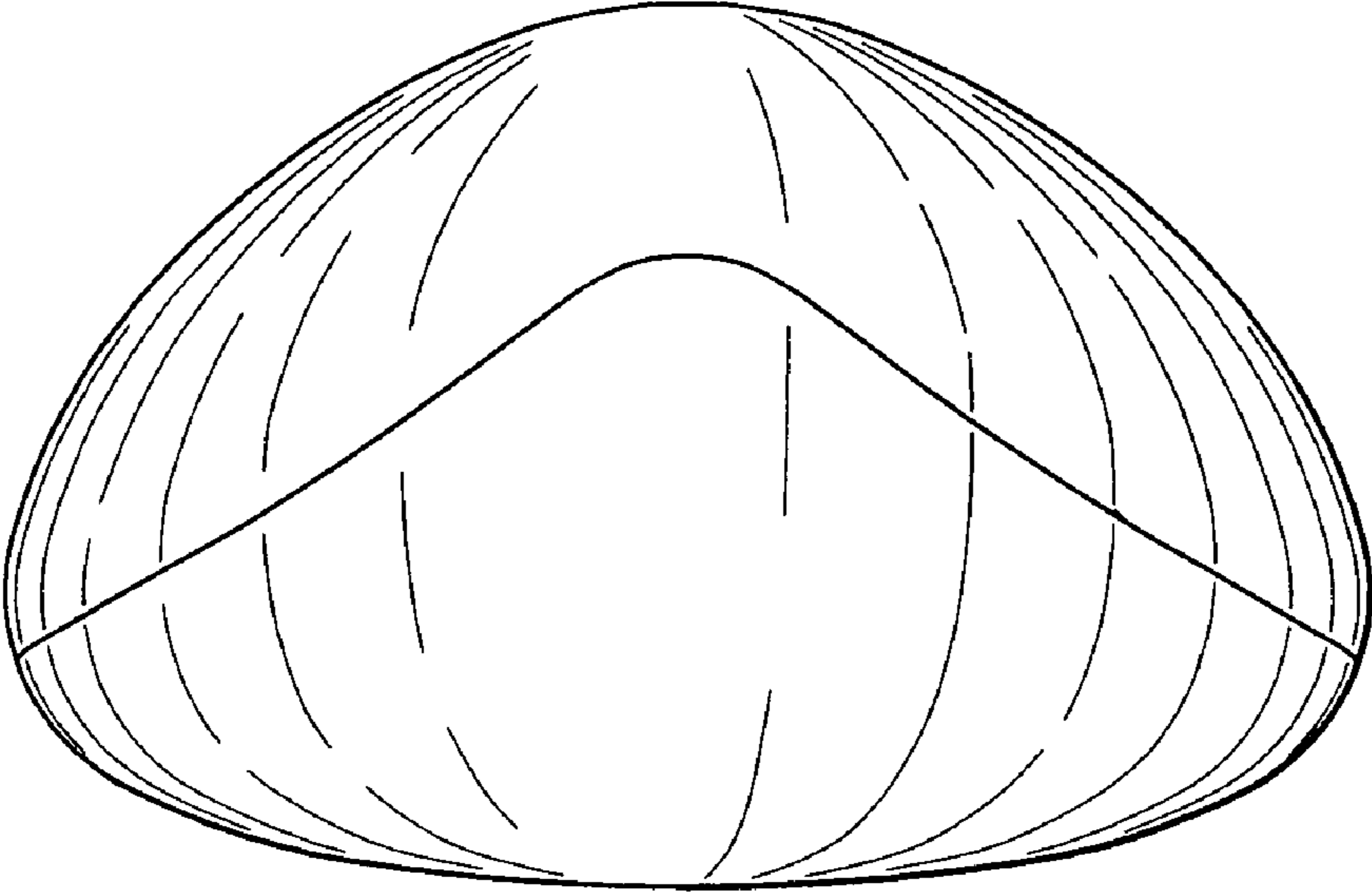

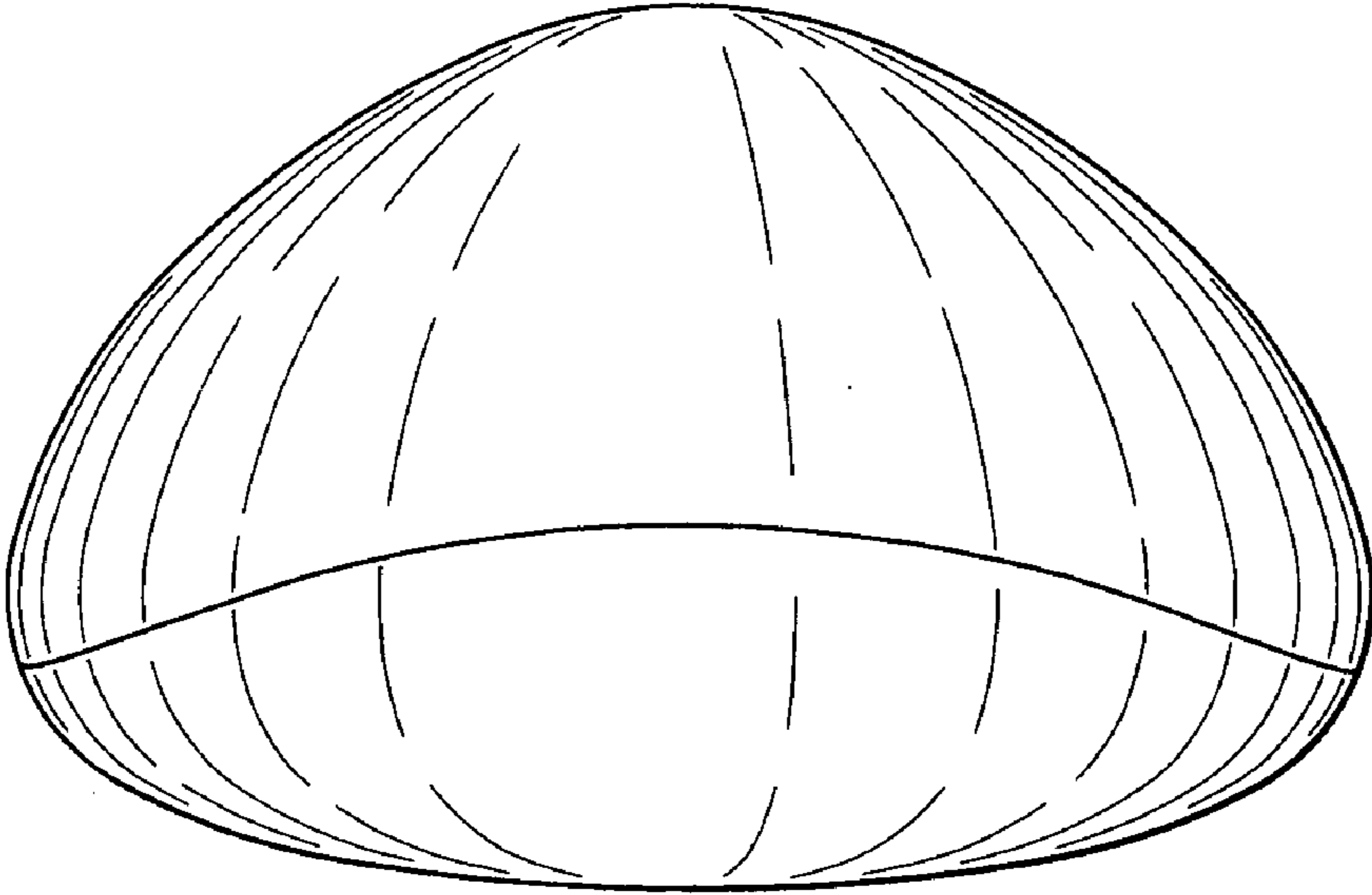

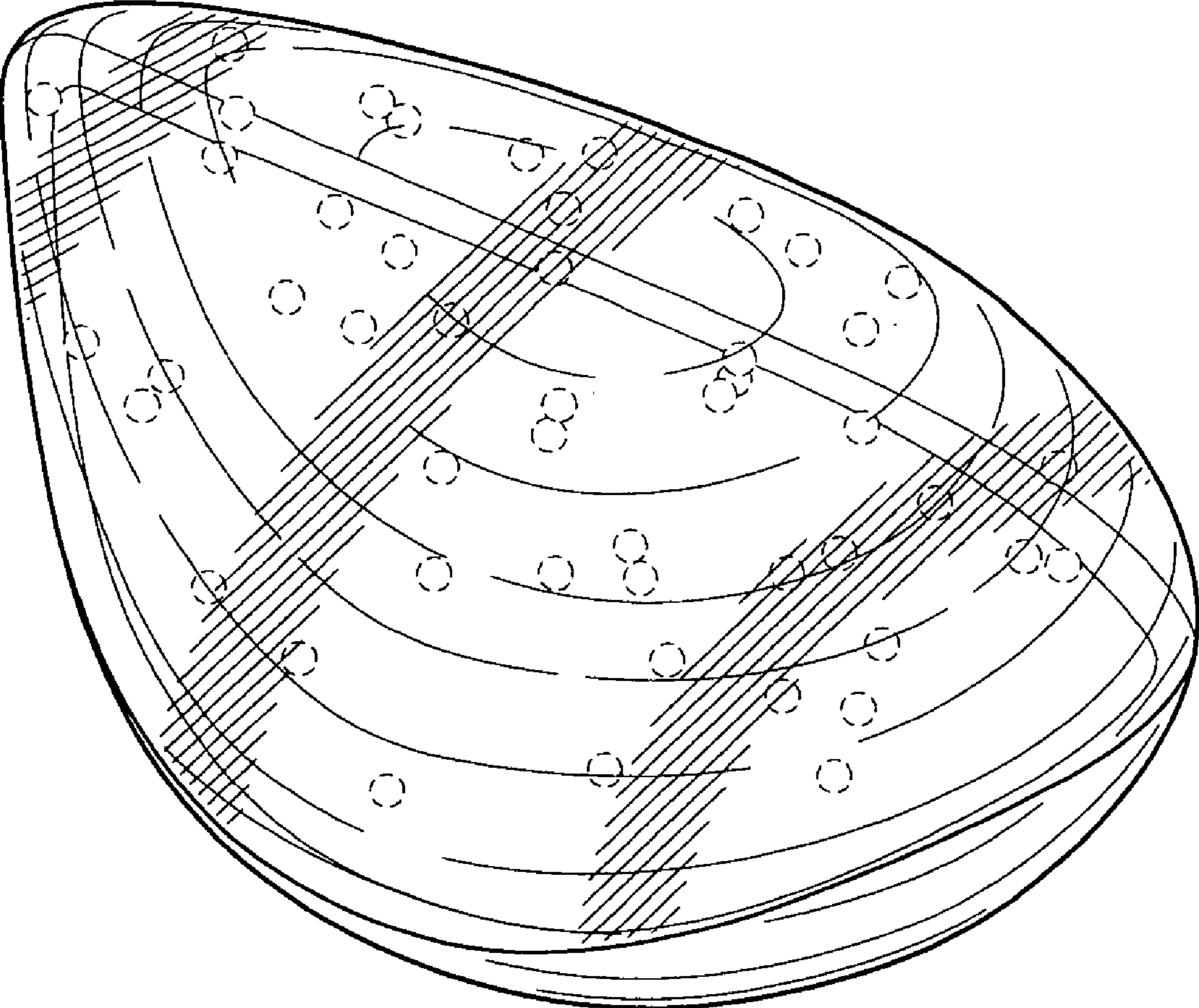

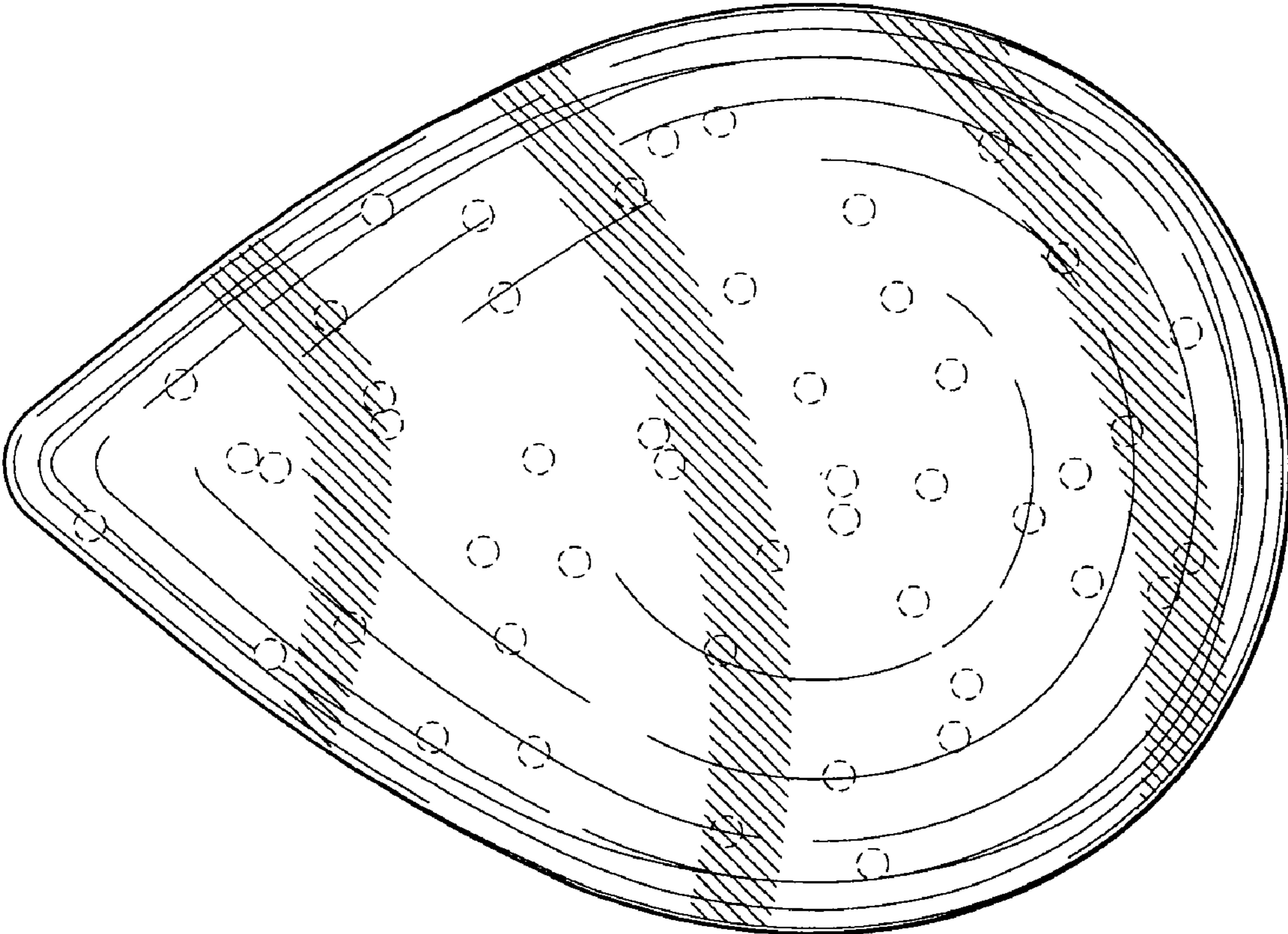

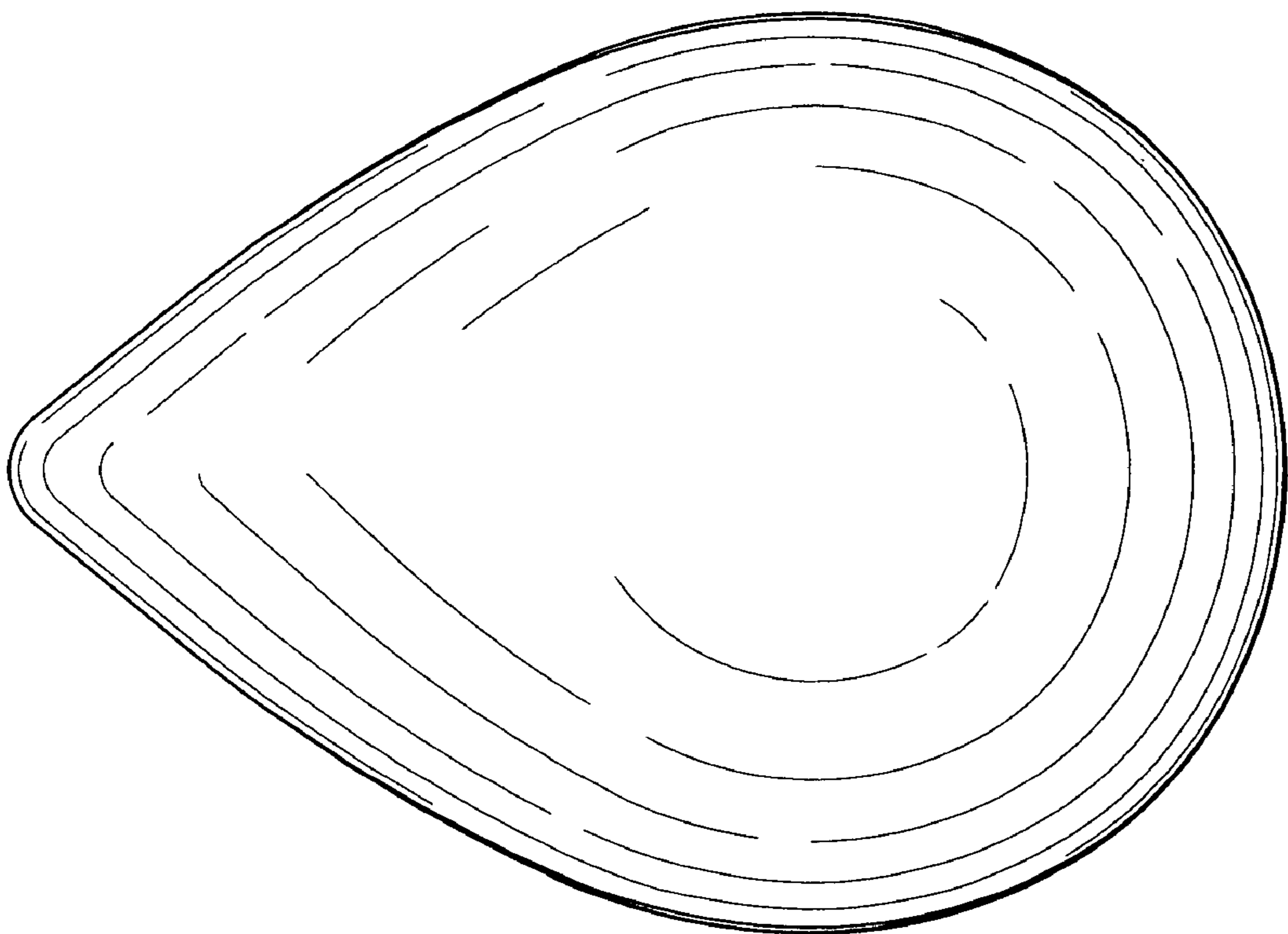

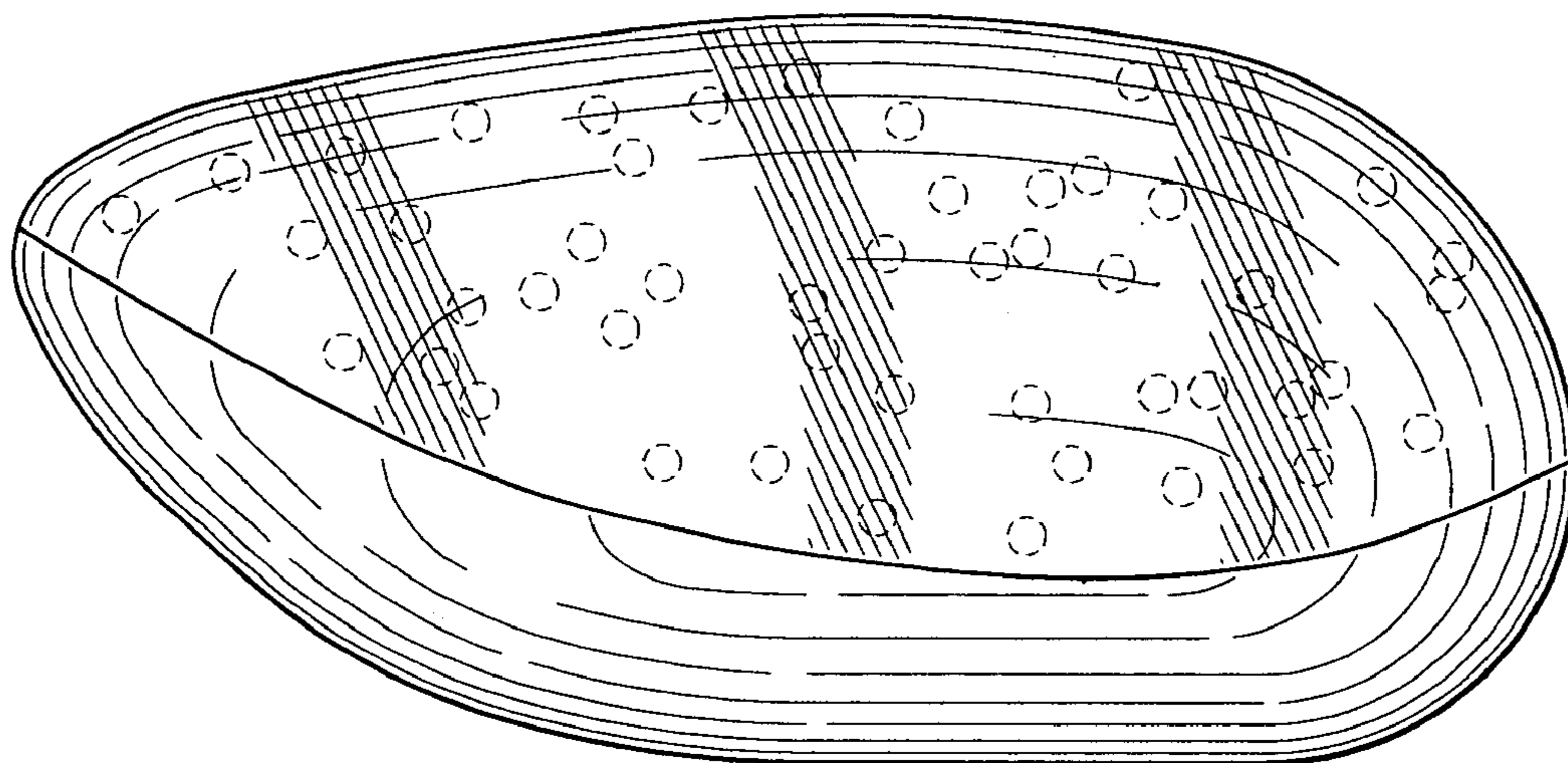

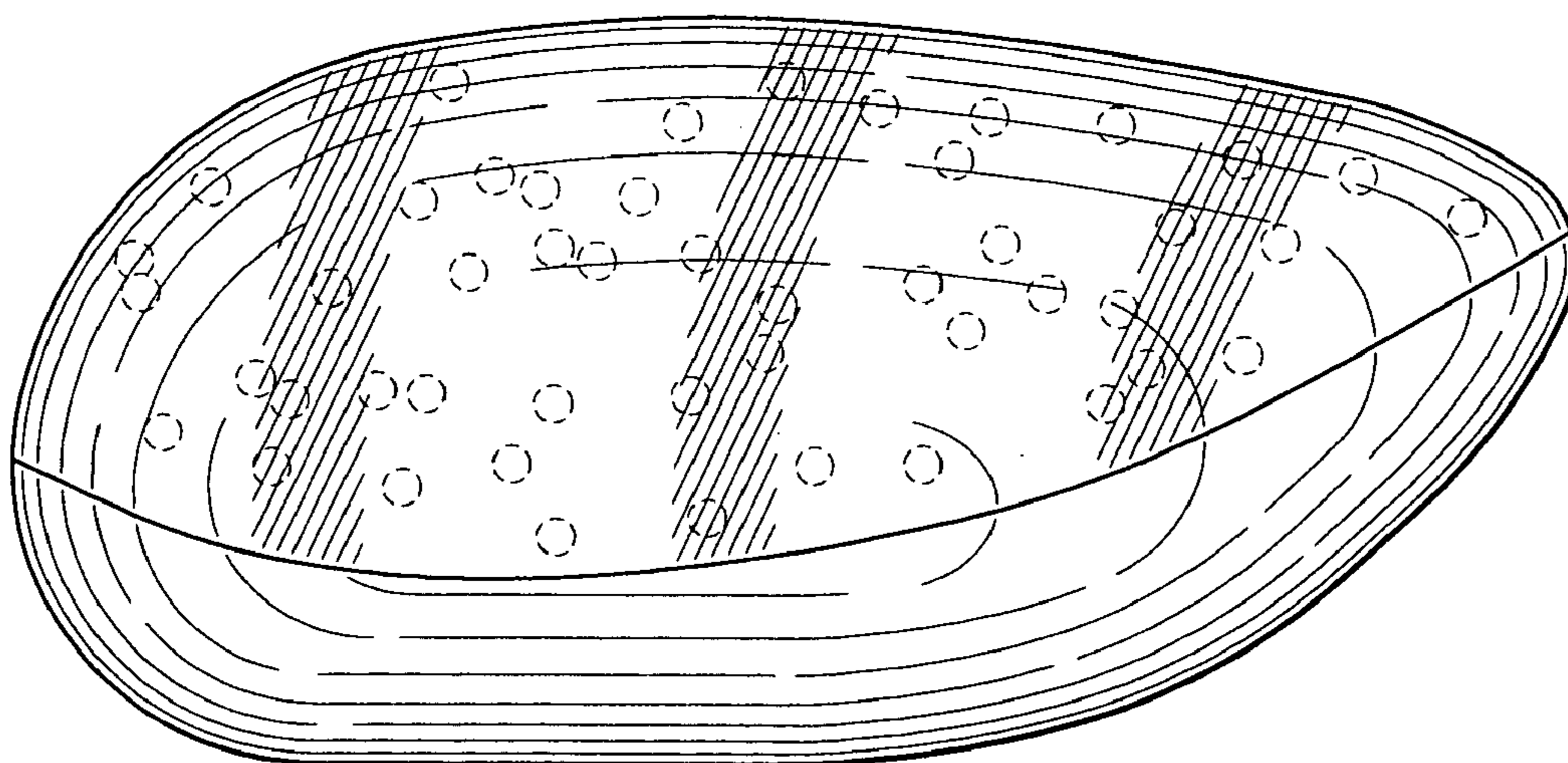

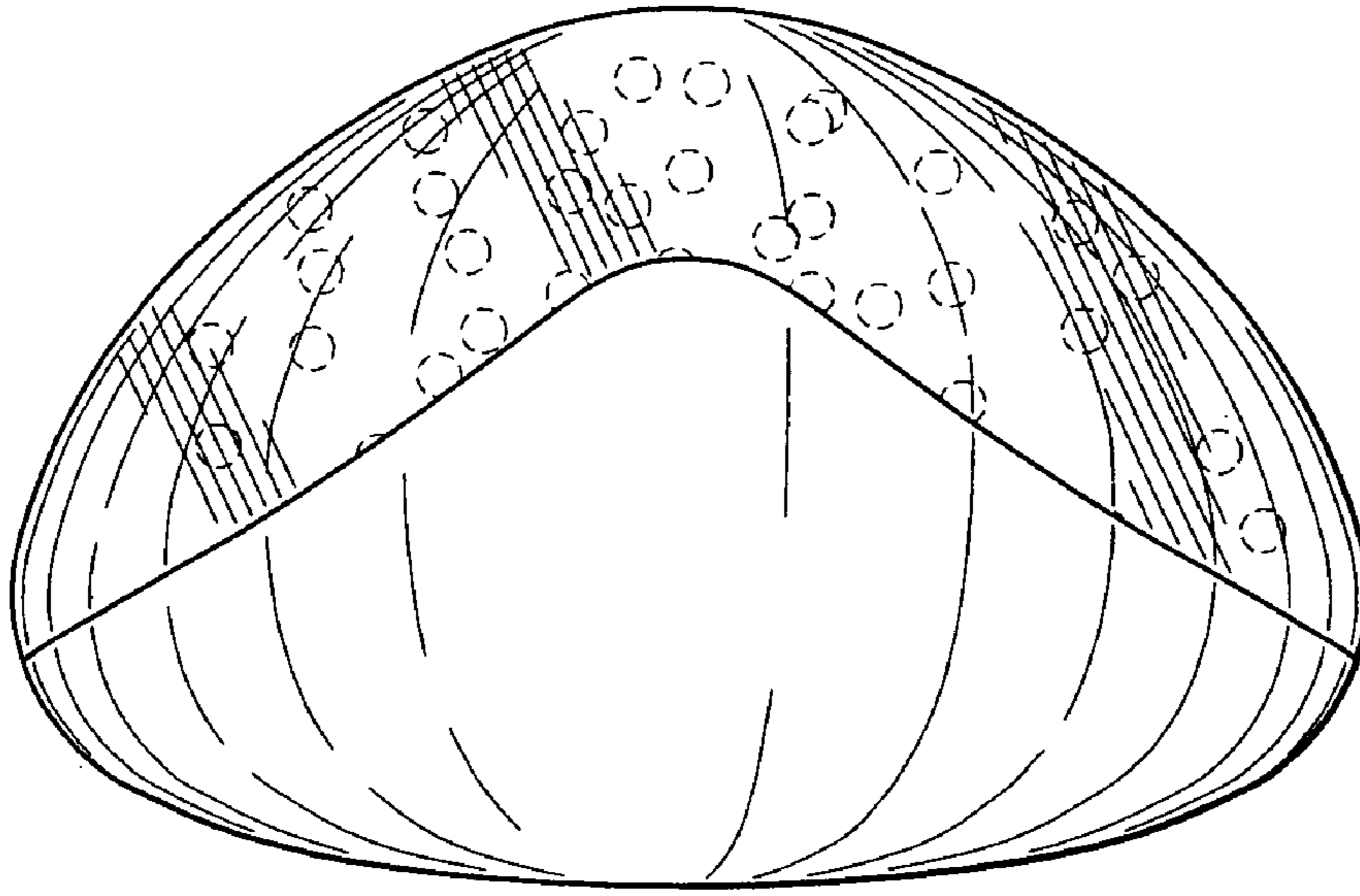

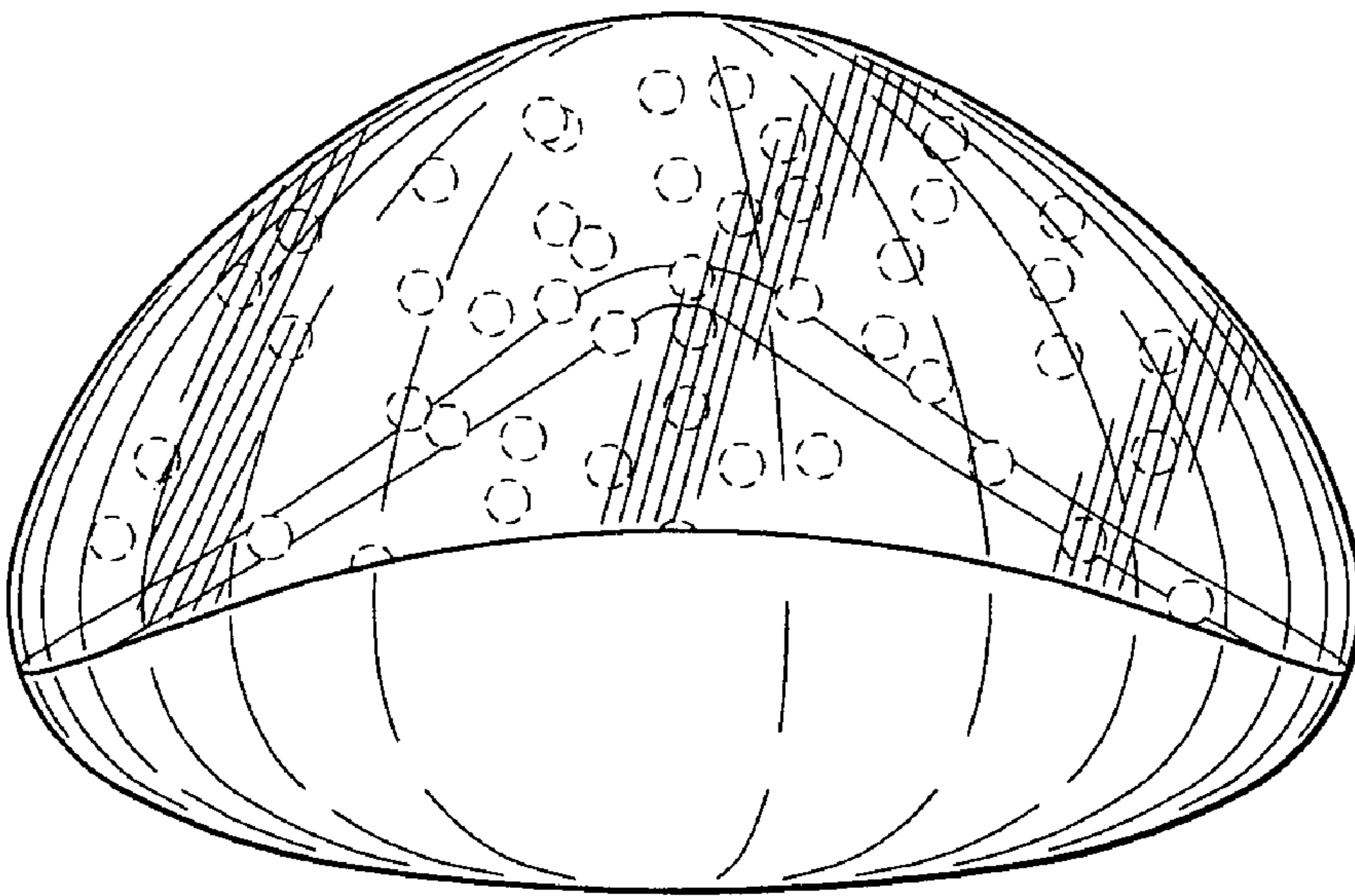

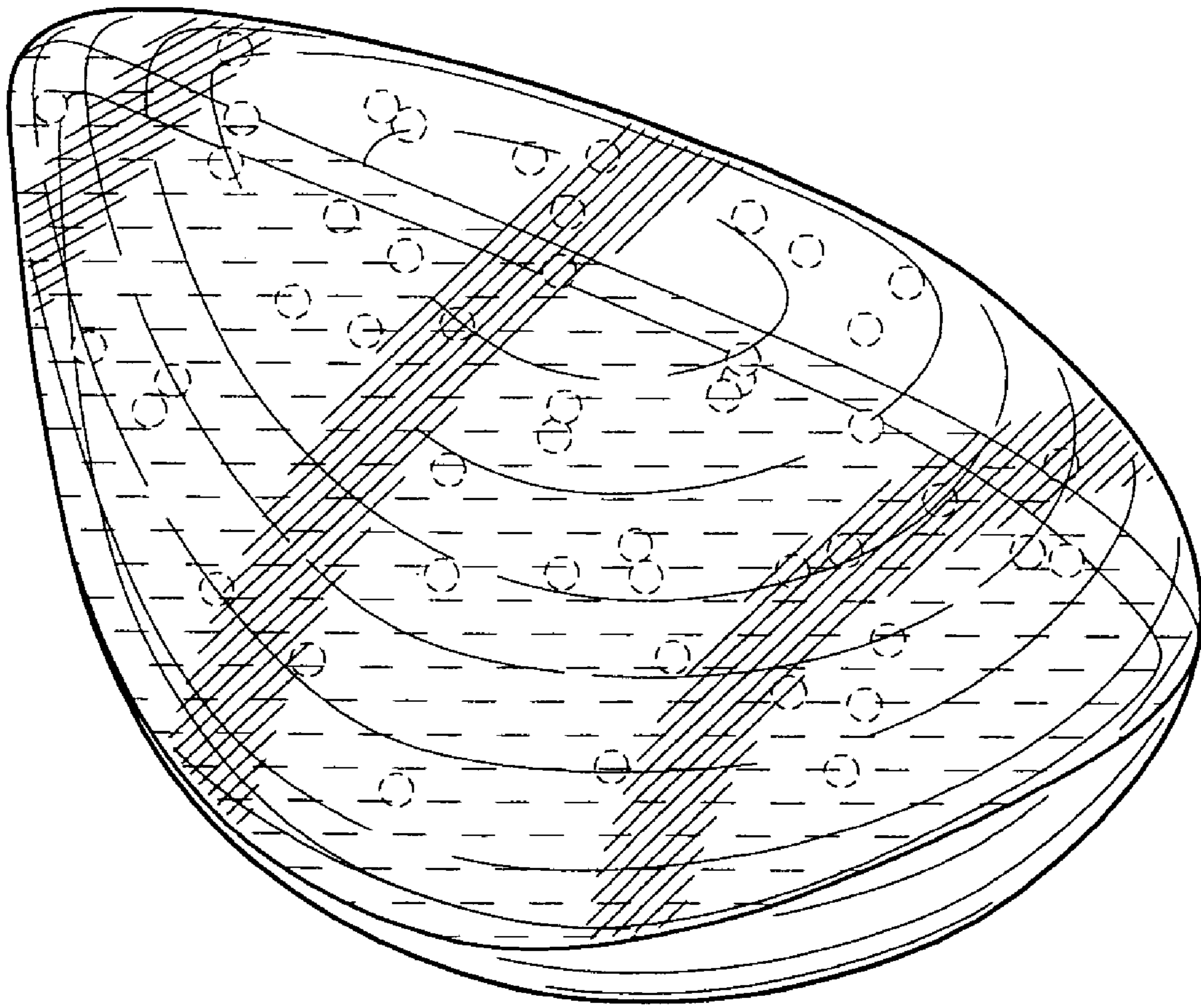

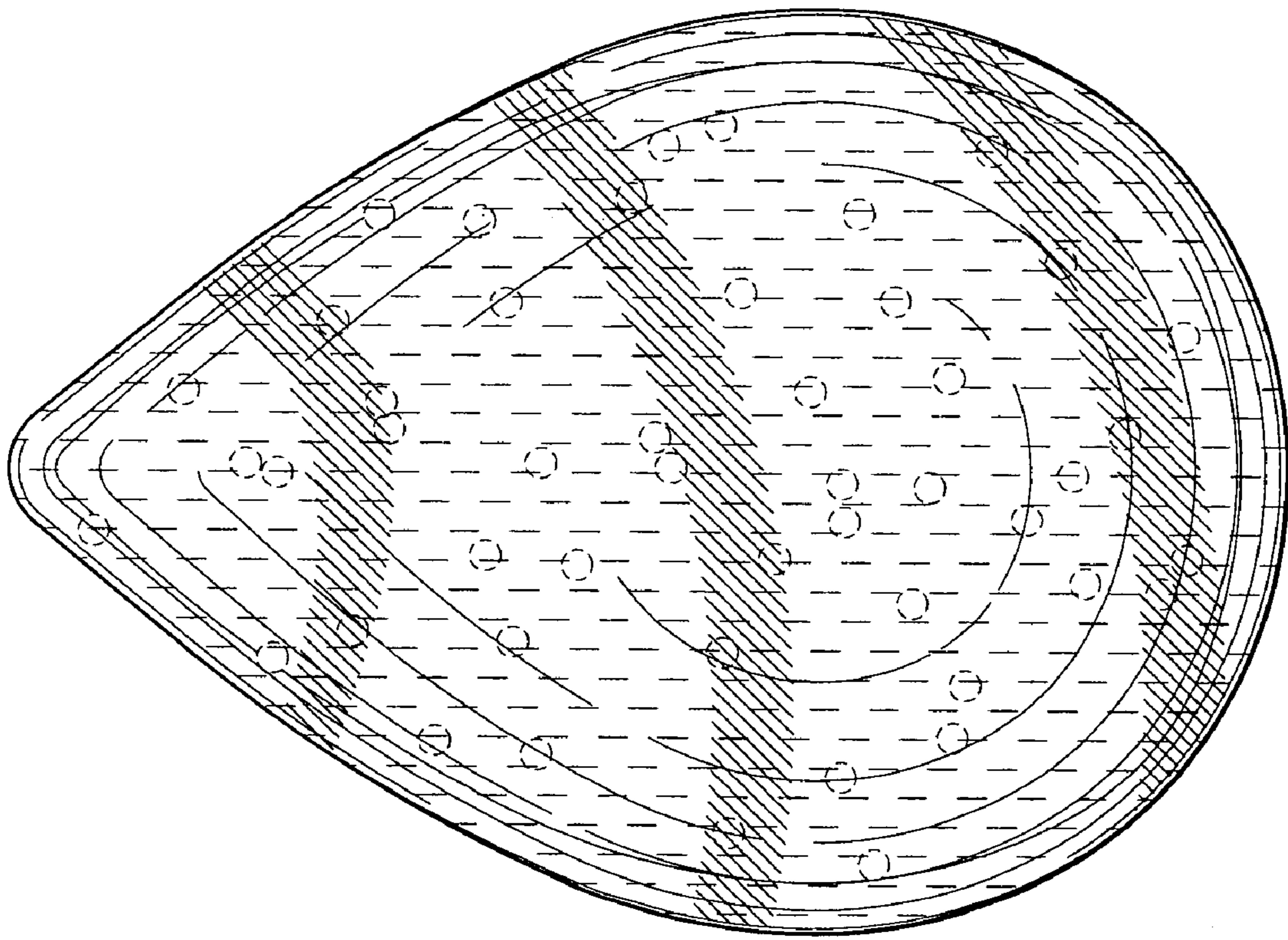

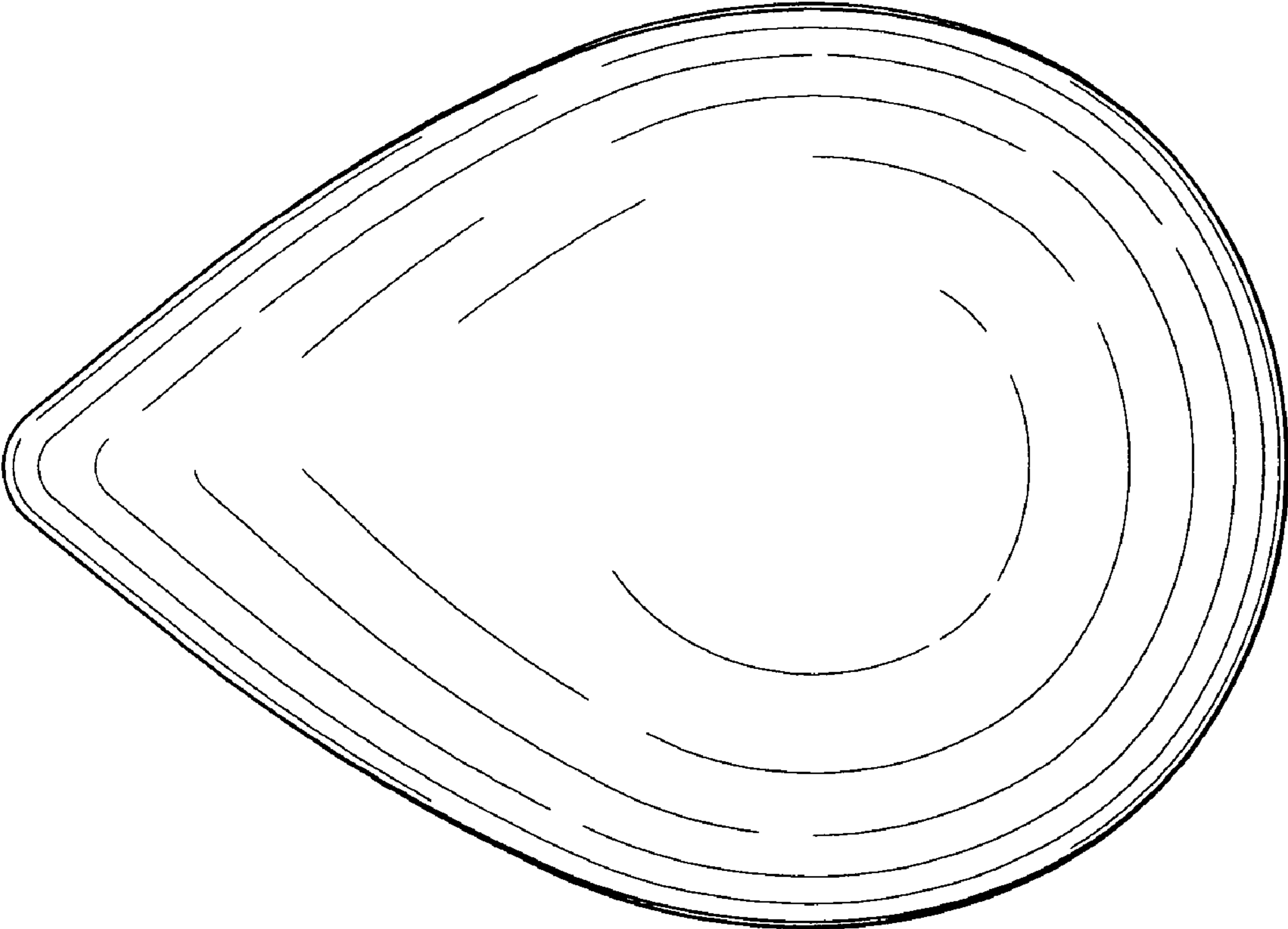

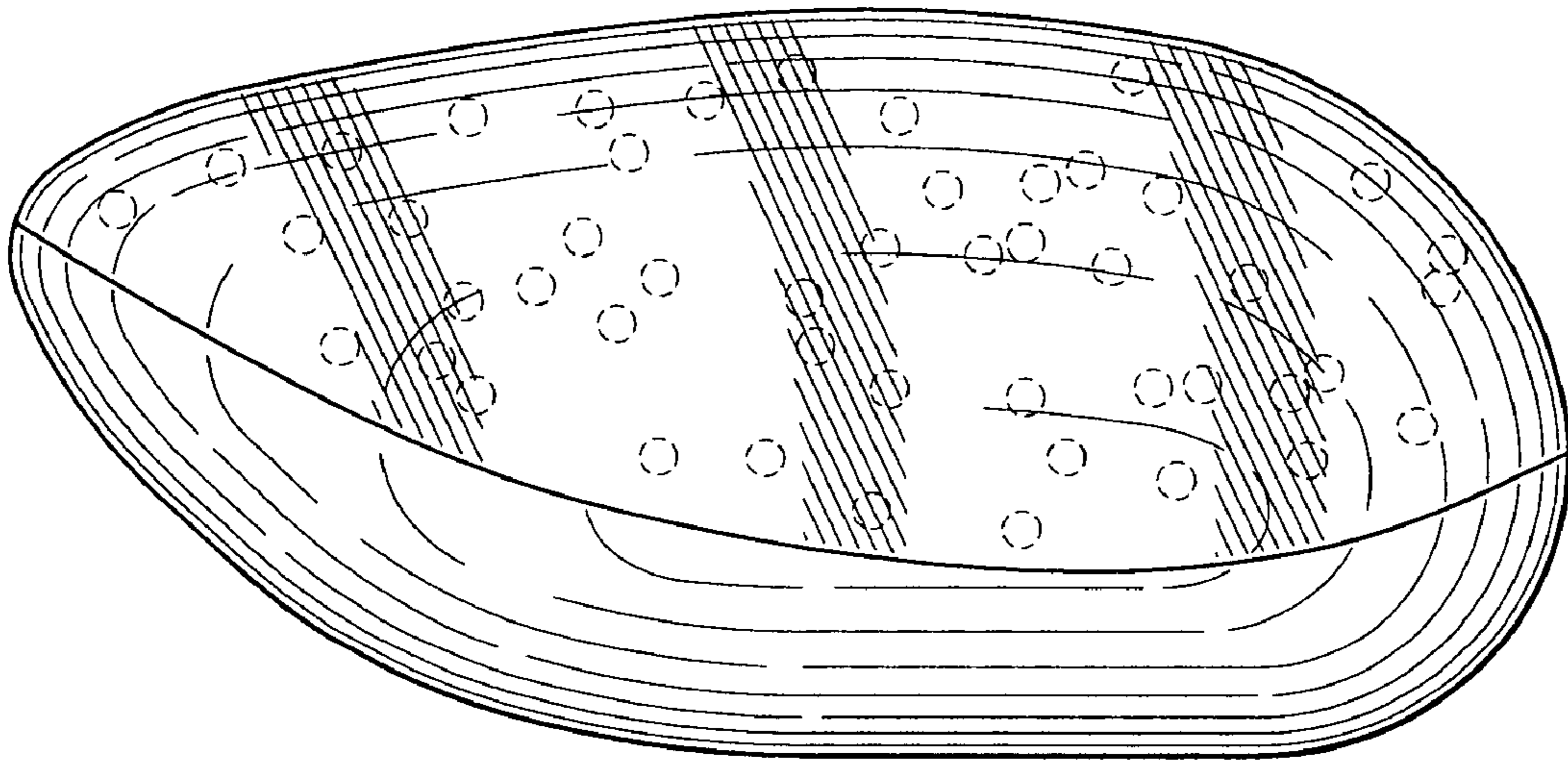

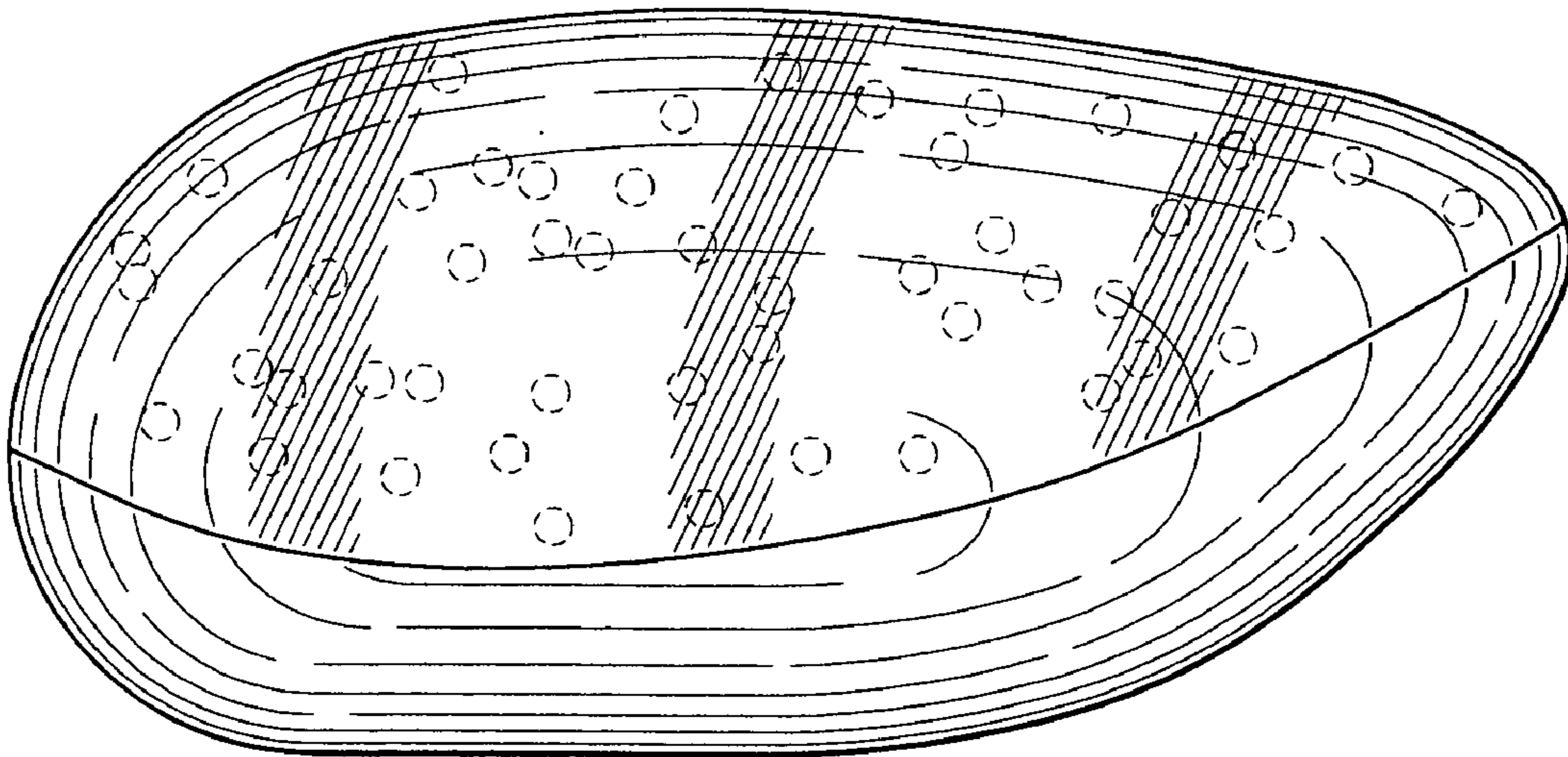

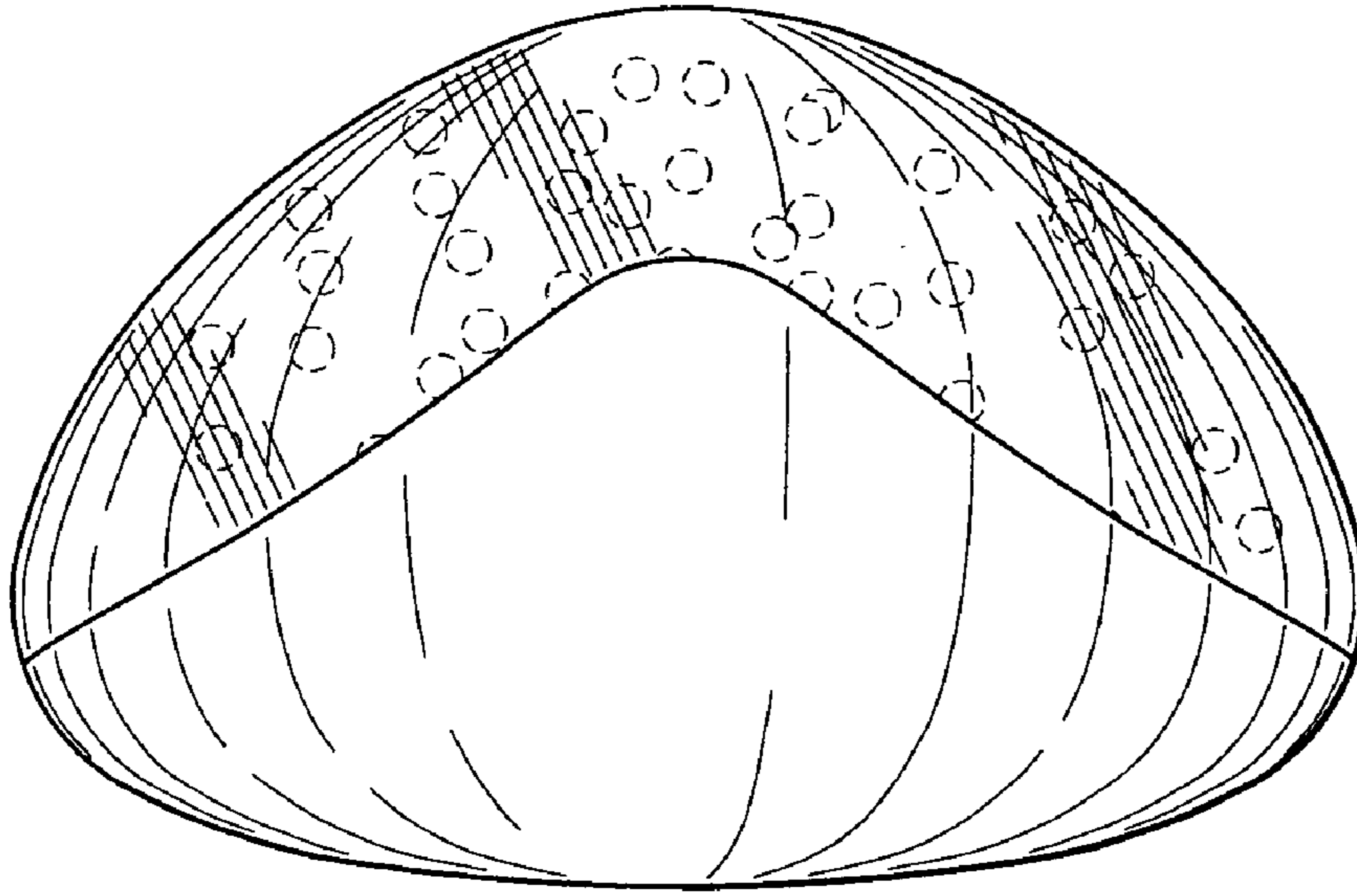

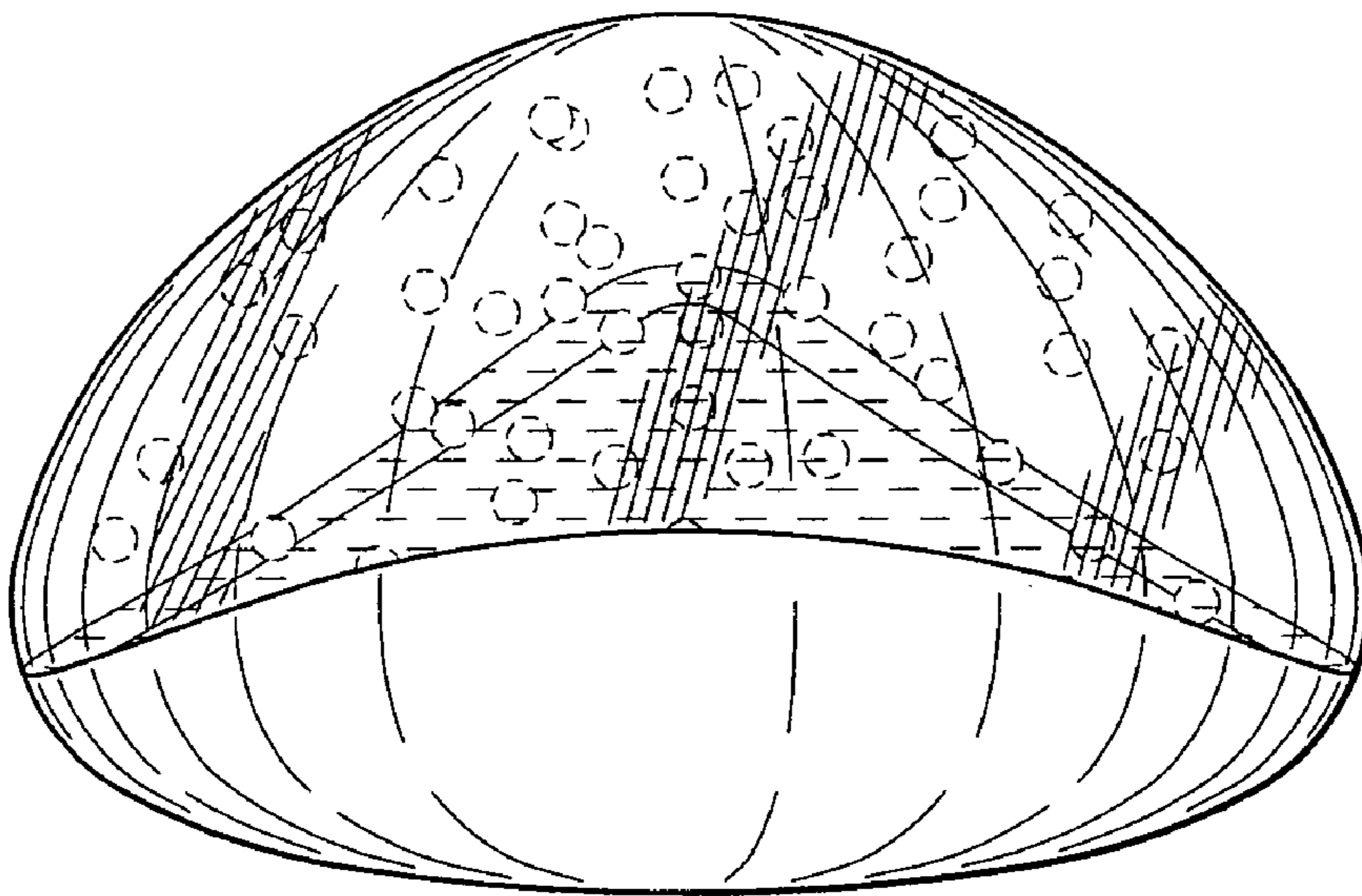
