The ornamental design for a “tweezer,” as shown and described.

**DESCRIPTION**

FIG. 10 is a bottom plan view thereof;

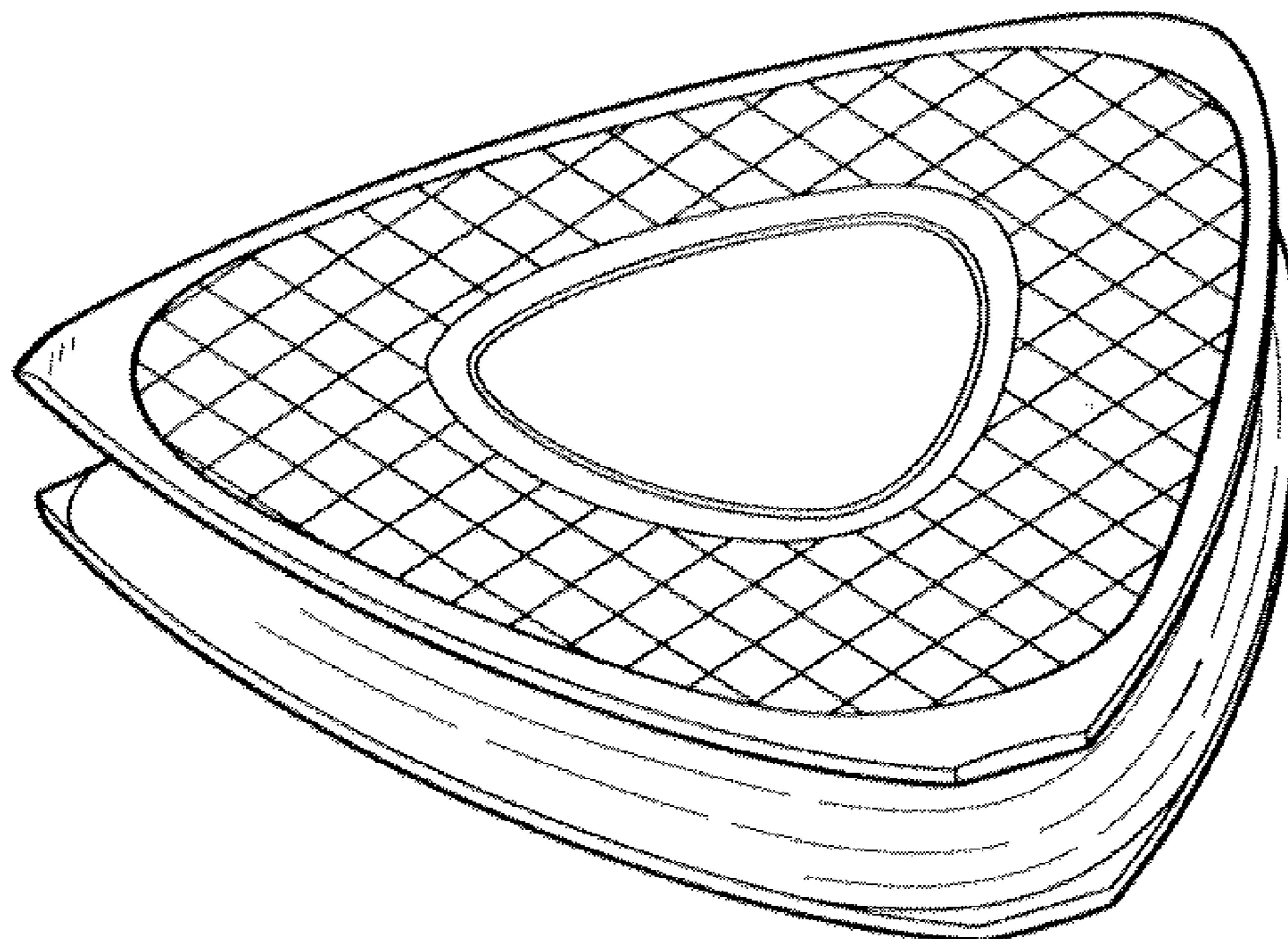
FIG. 11 is a rear view thereof;

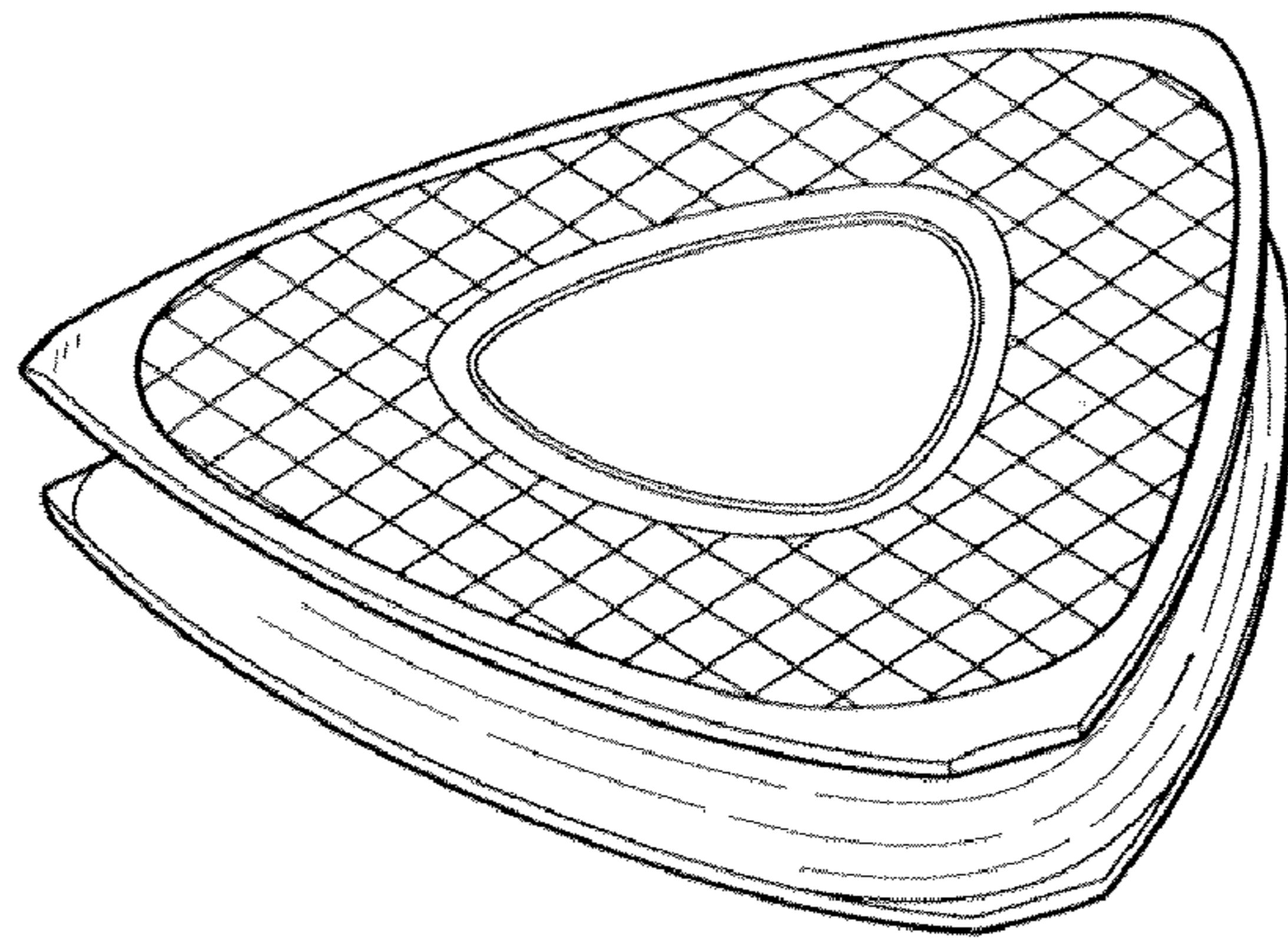
FIG. 12 is a right side elevational view thereof;

FIG. 13 is a front view thereof; and,

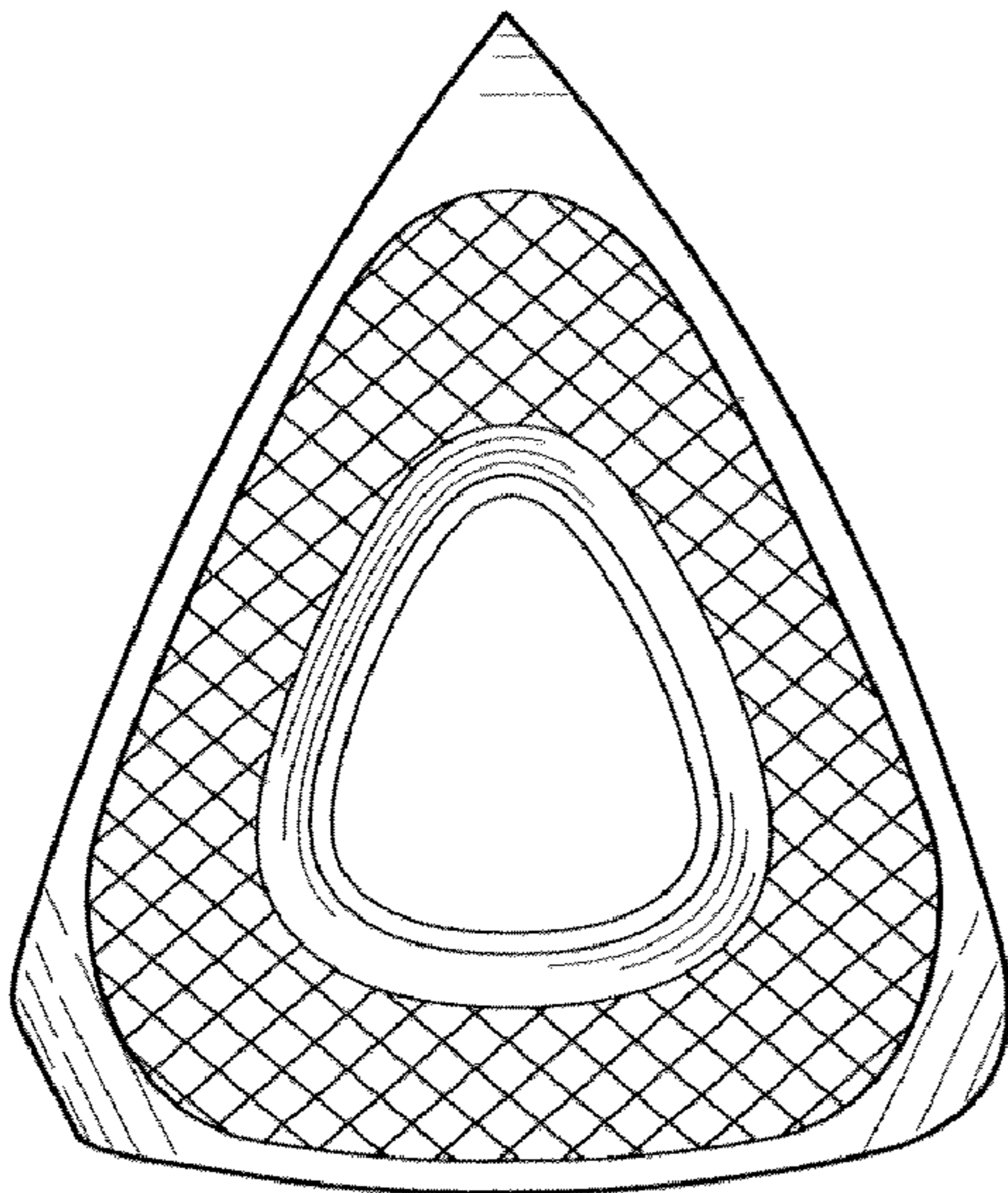
FIG. 14 is a left side elevational view thereof.

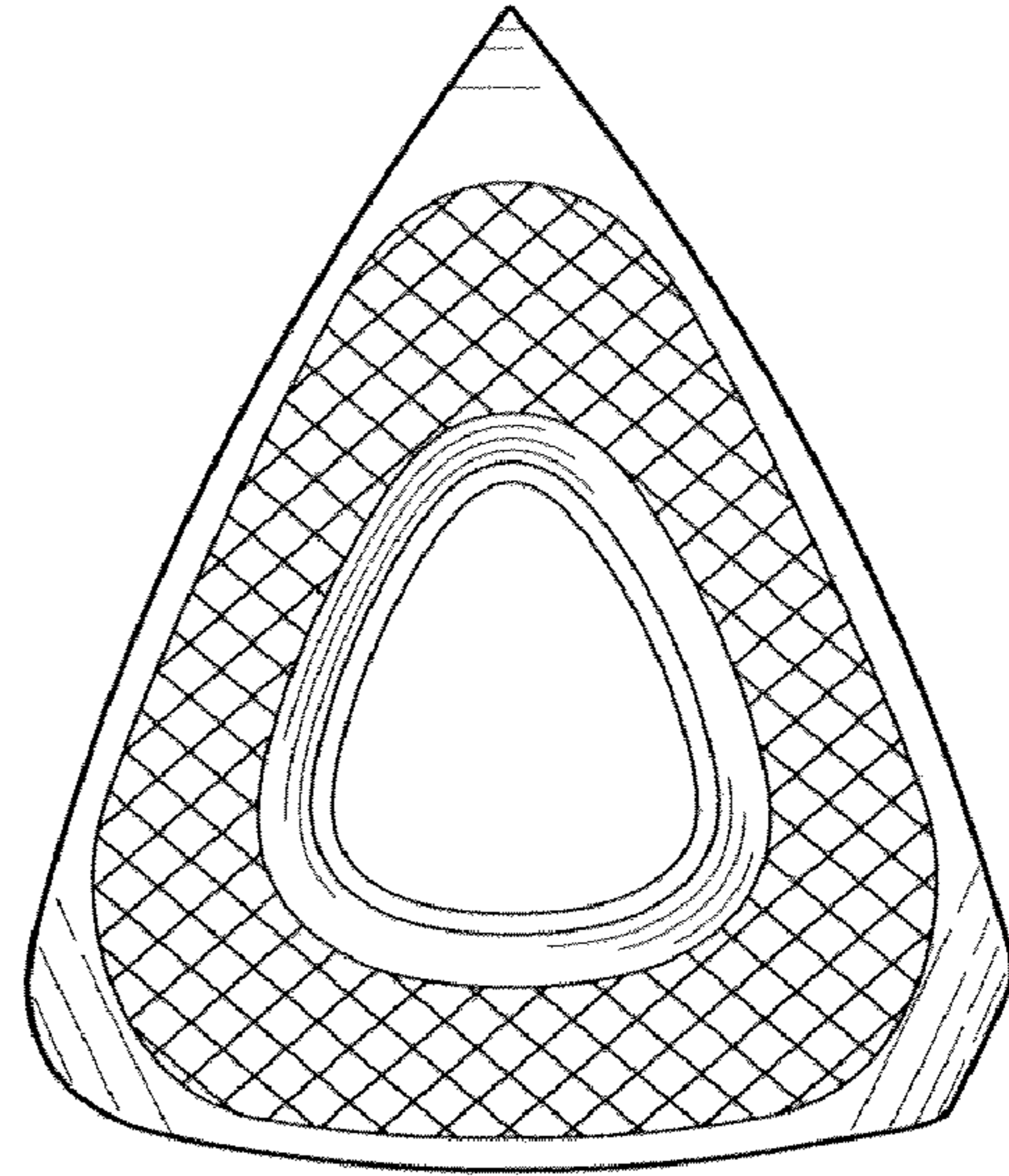




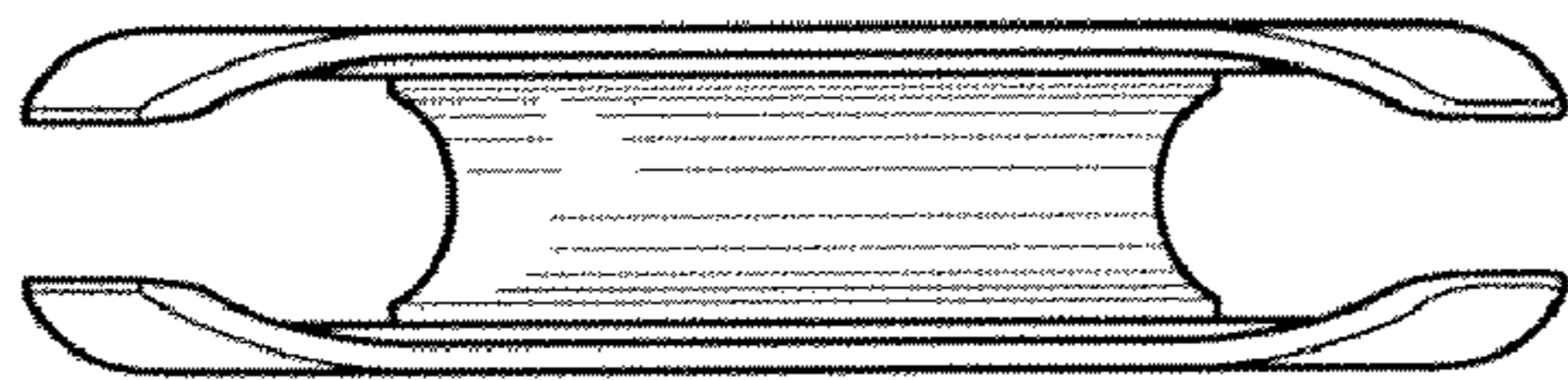

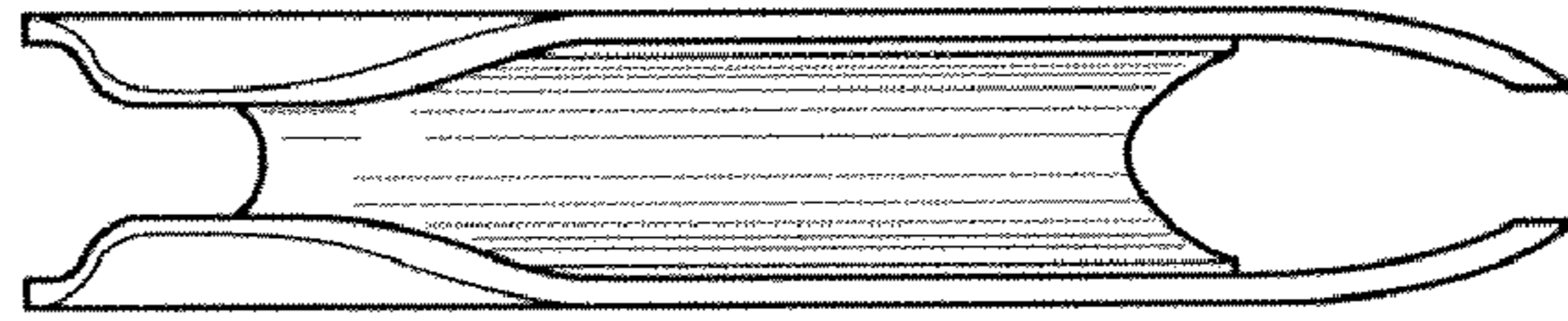

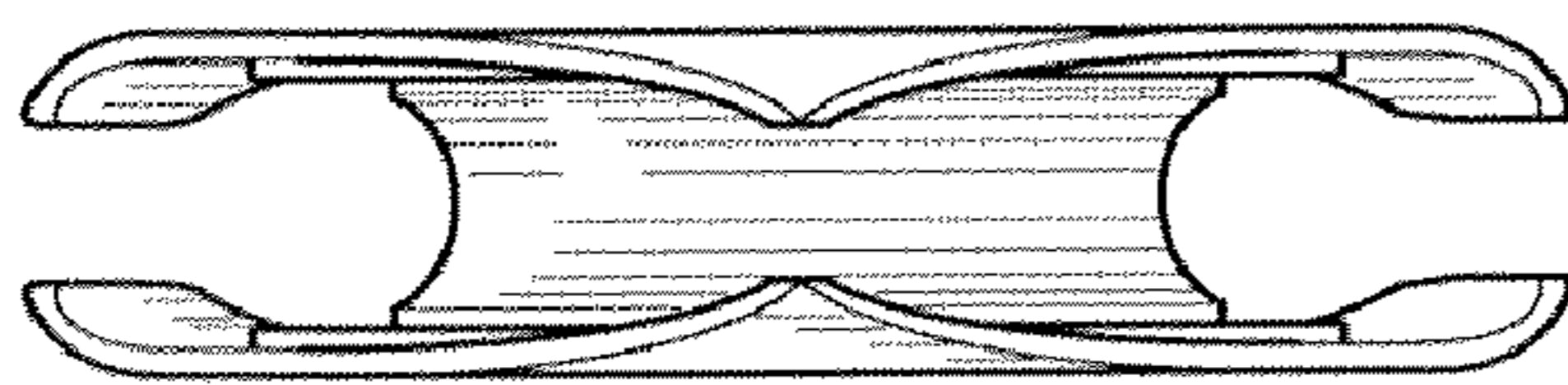

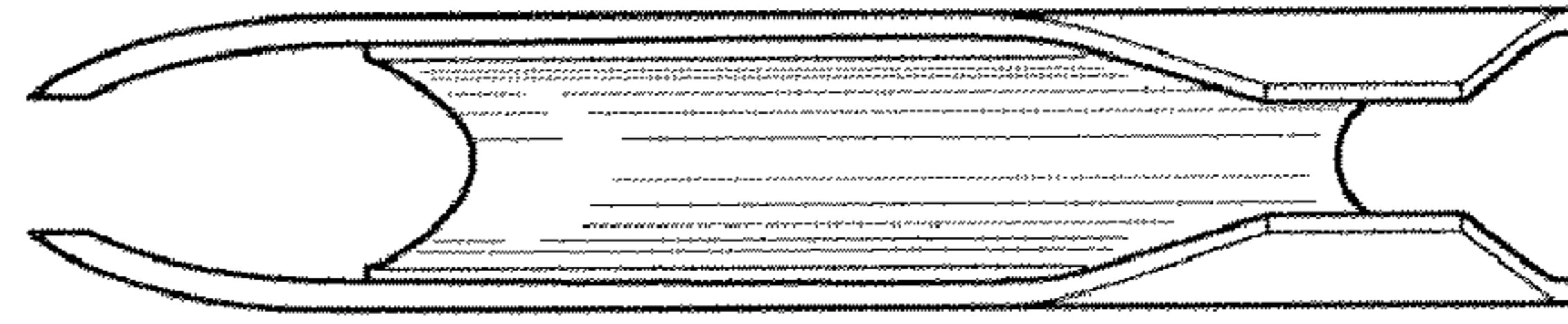

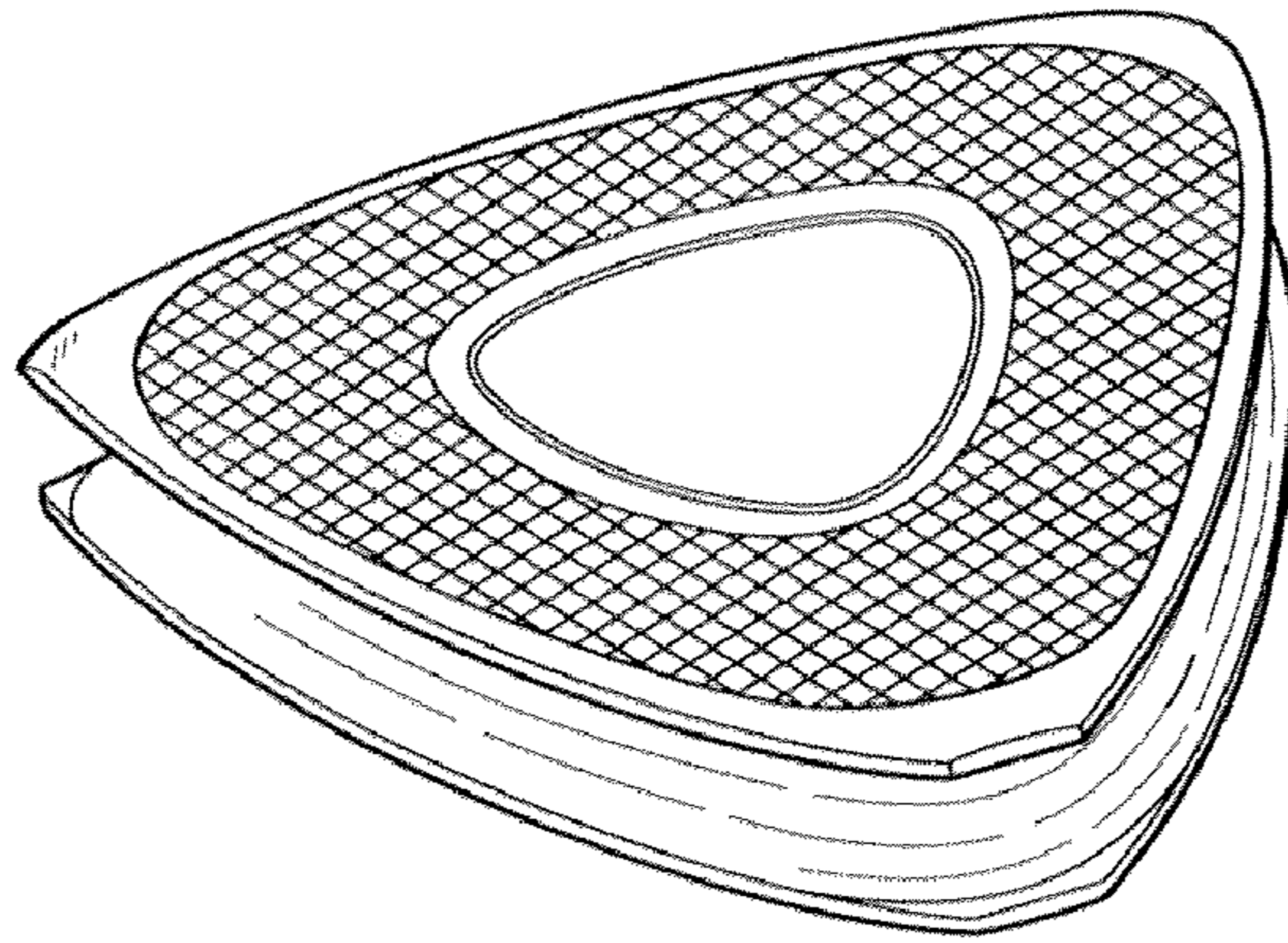

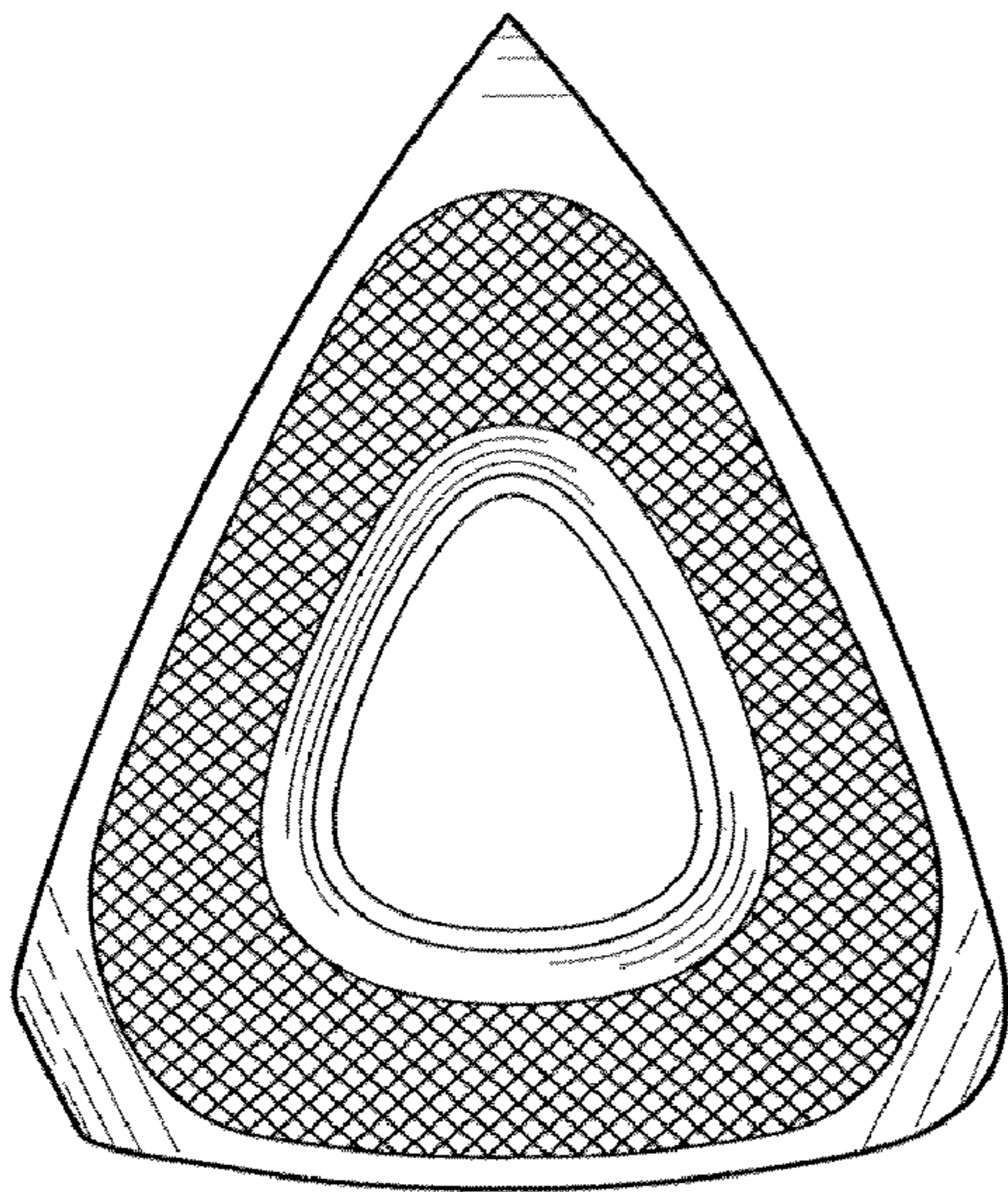

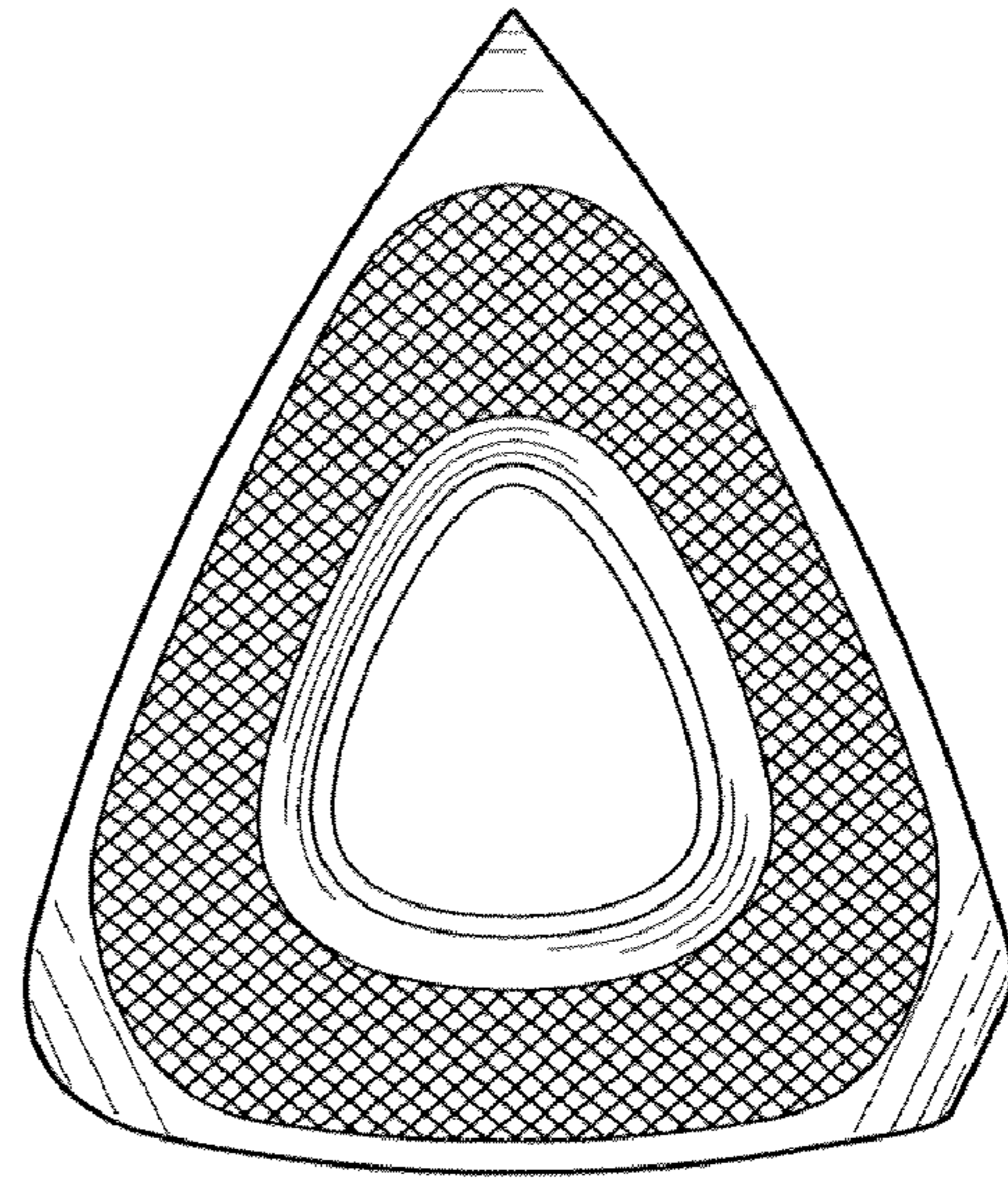

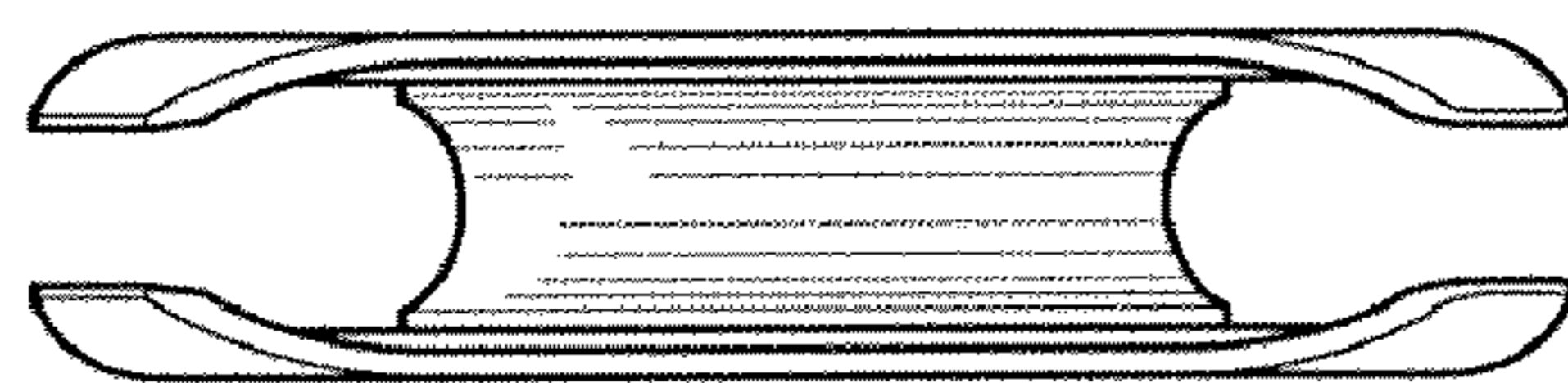

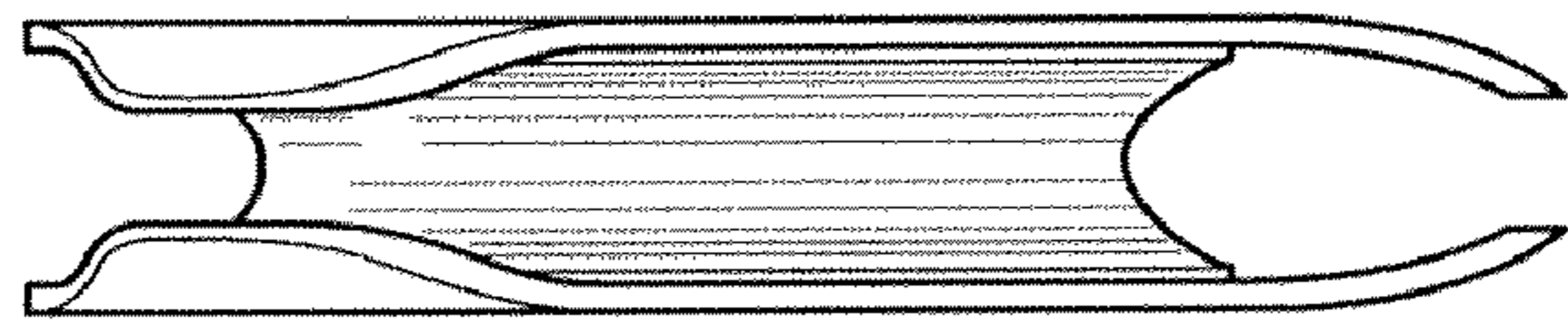

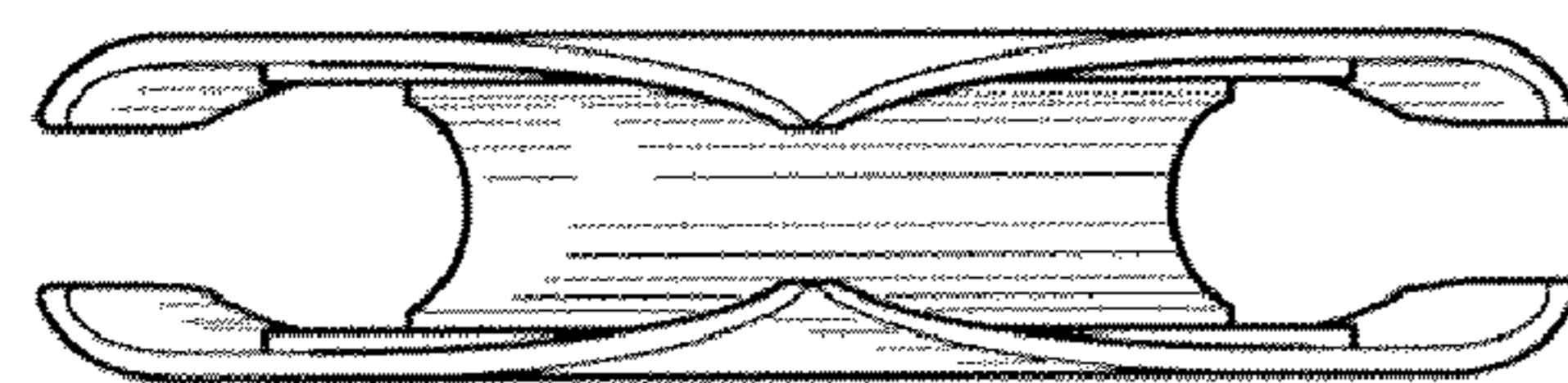

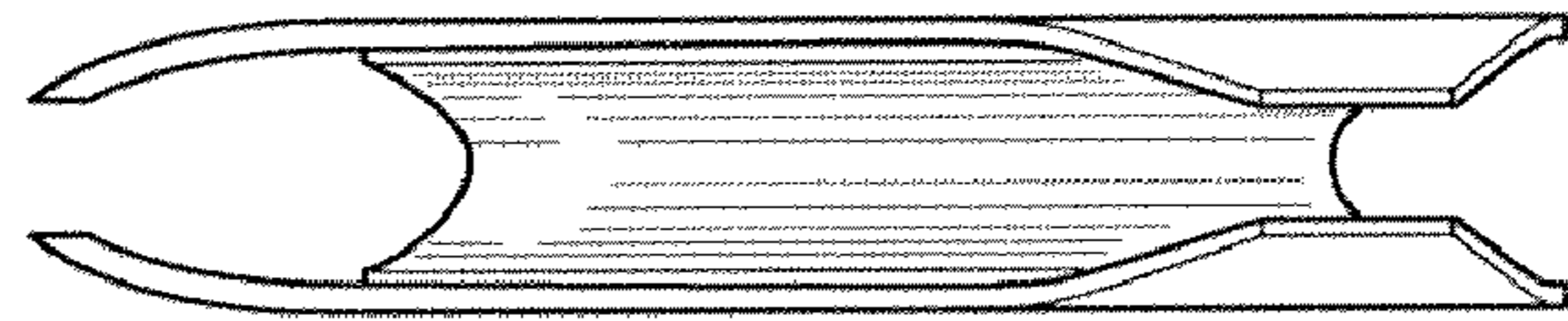
