FIG. 12 is a left view of the second embodiment thereof;

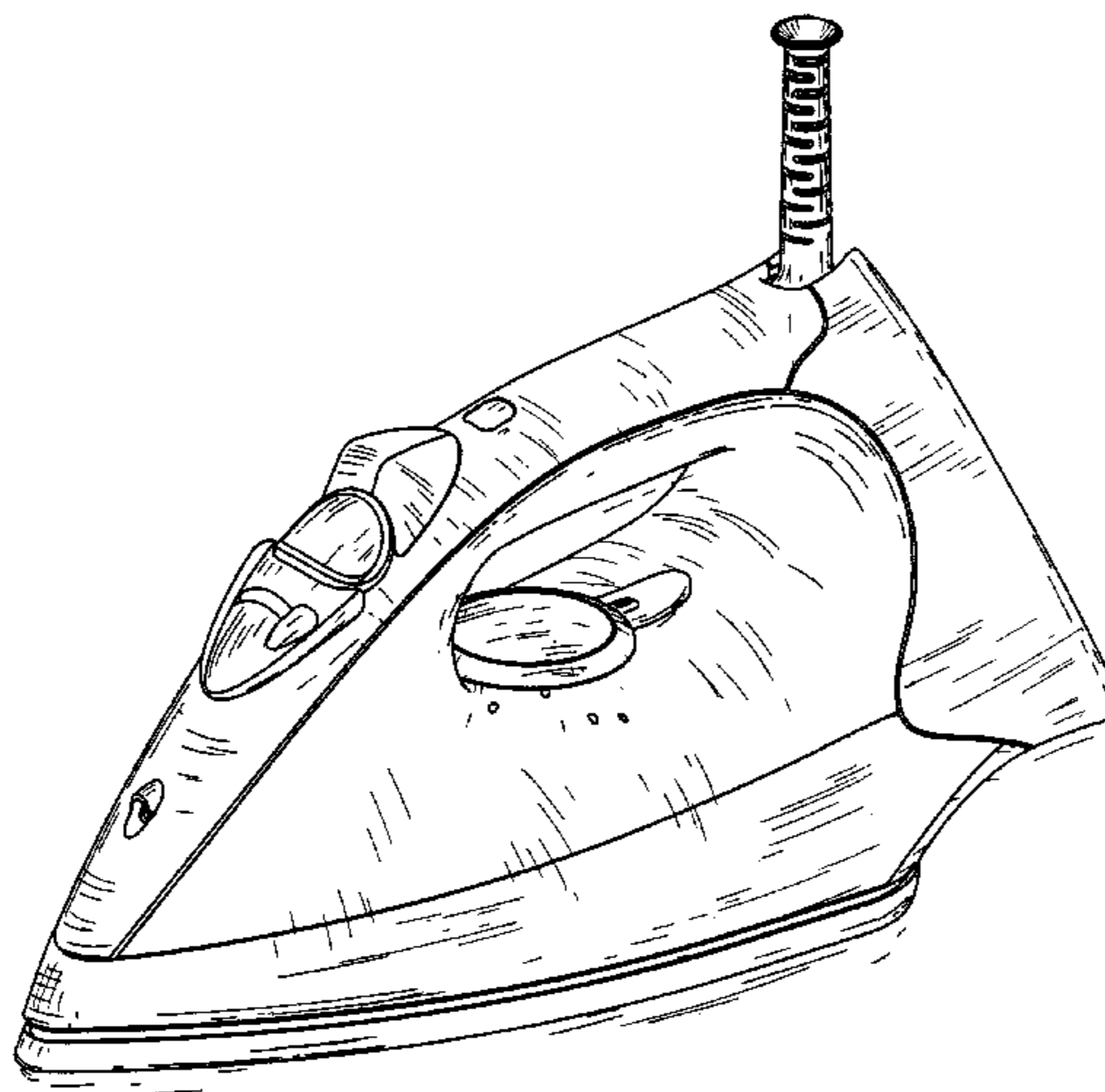
FIG. 13 is a front view of the second embodiment thereof;

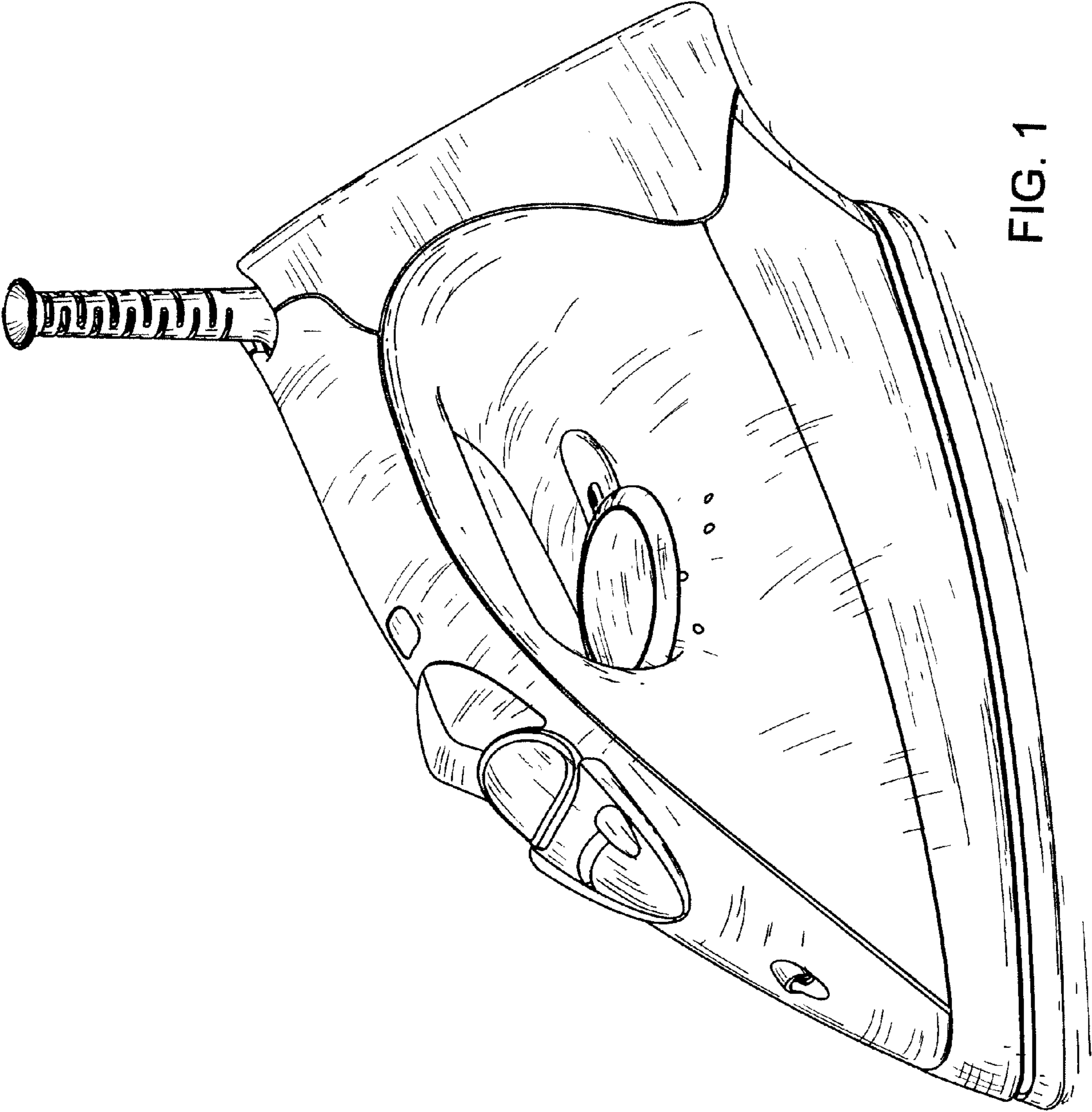

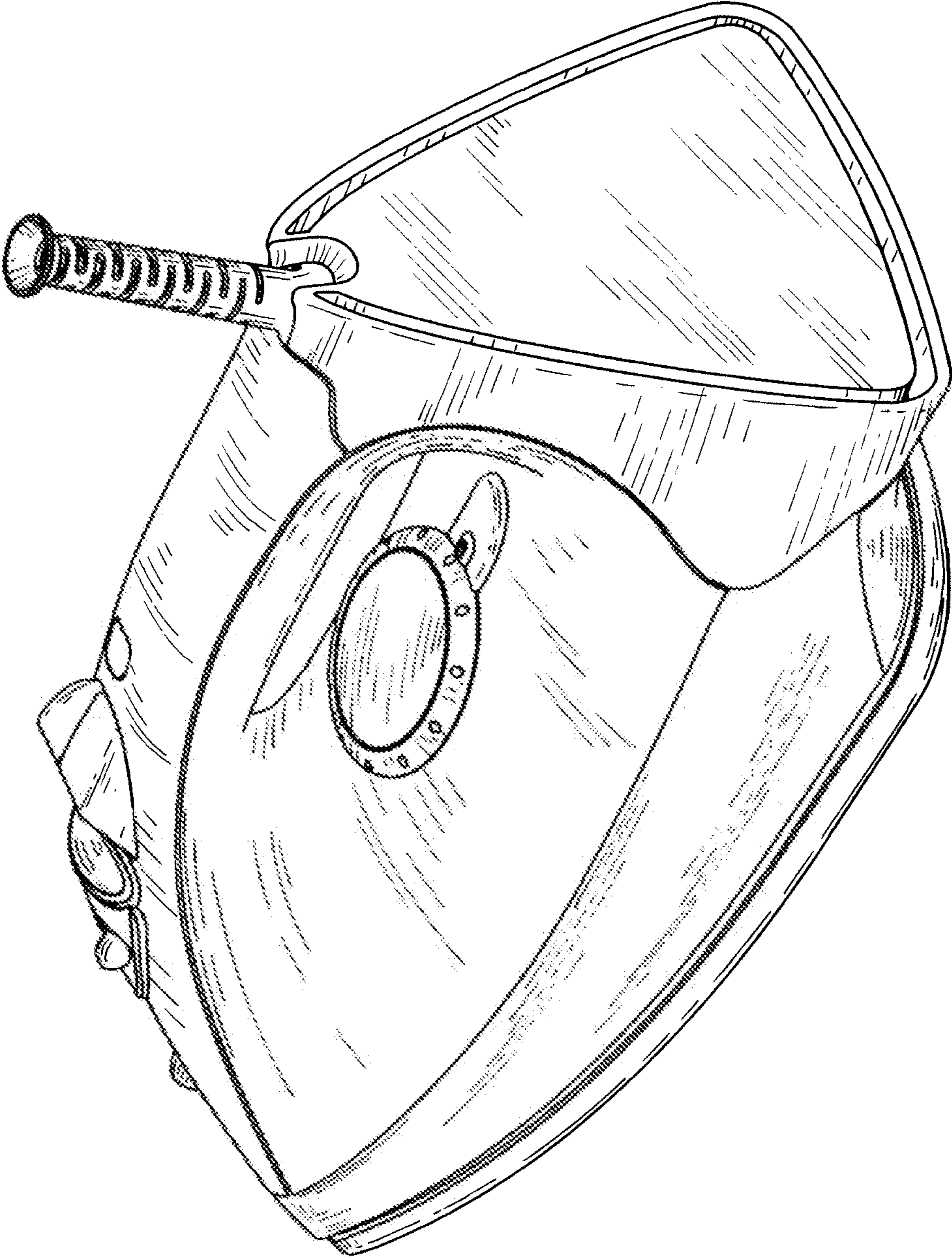

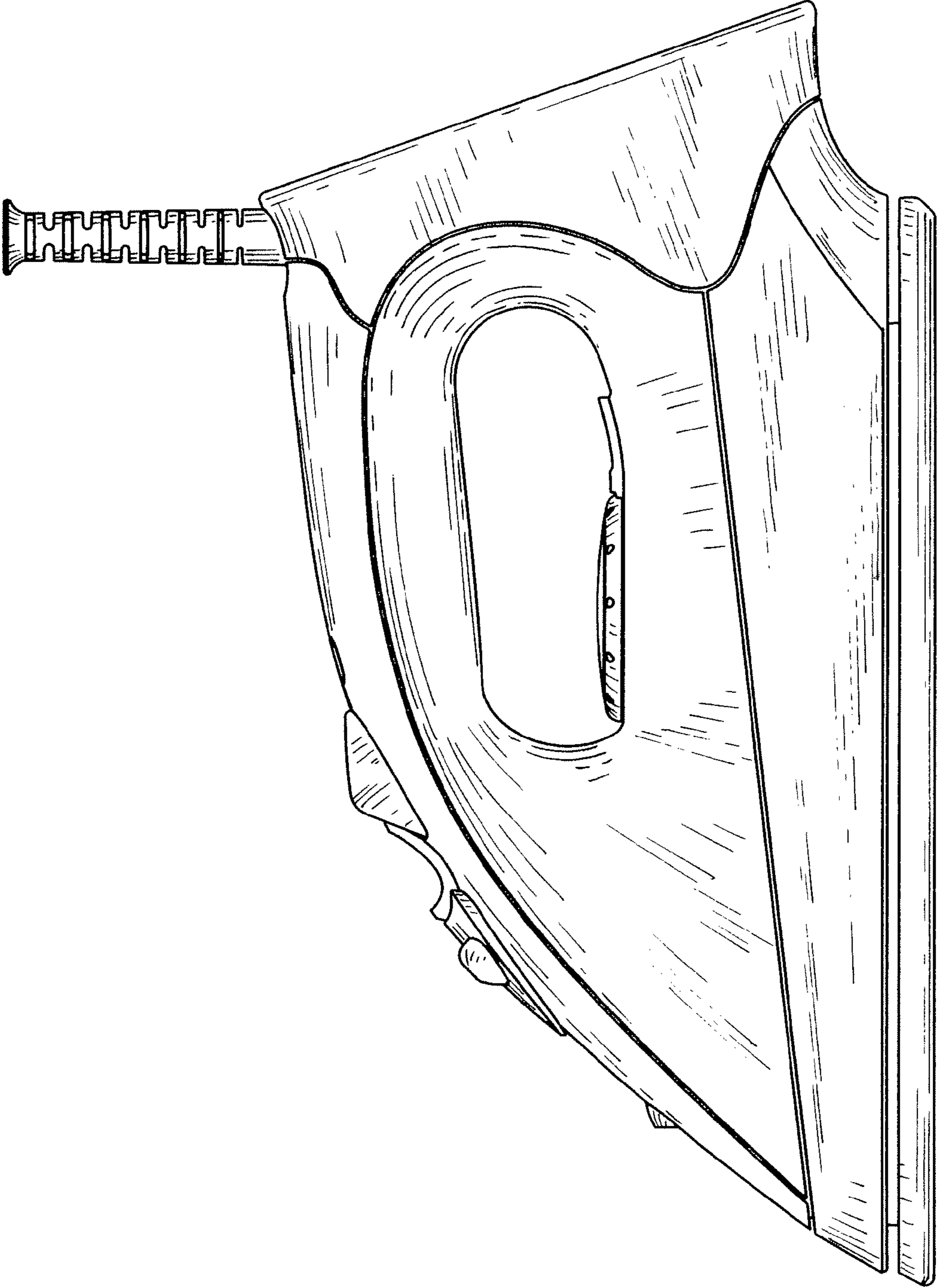

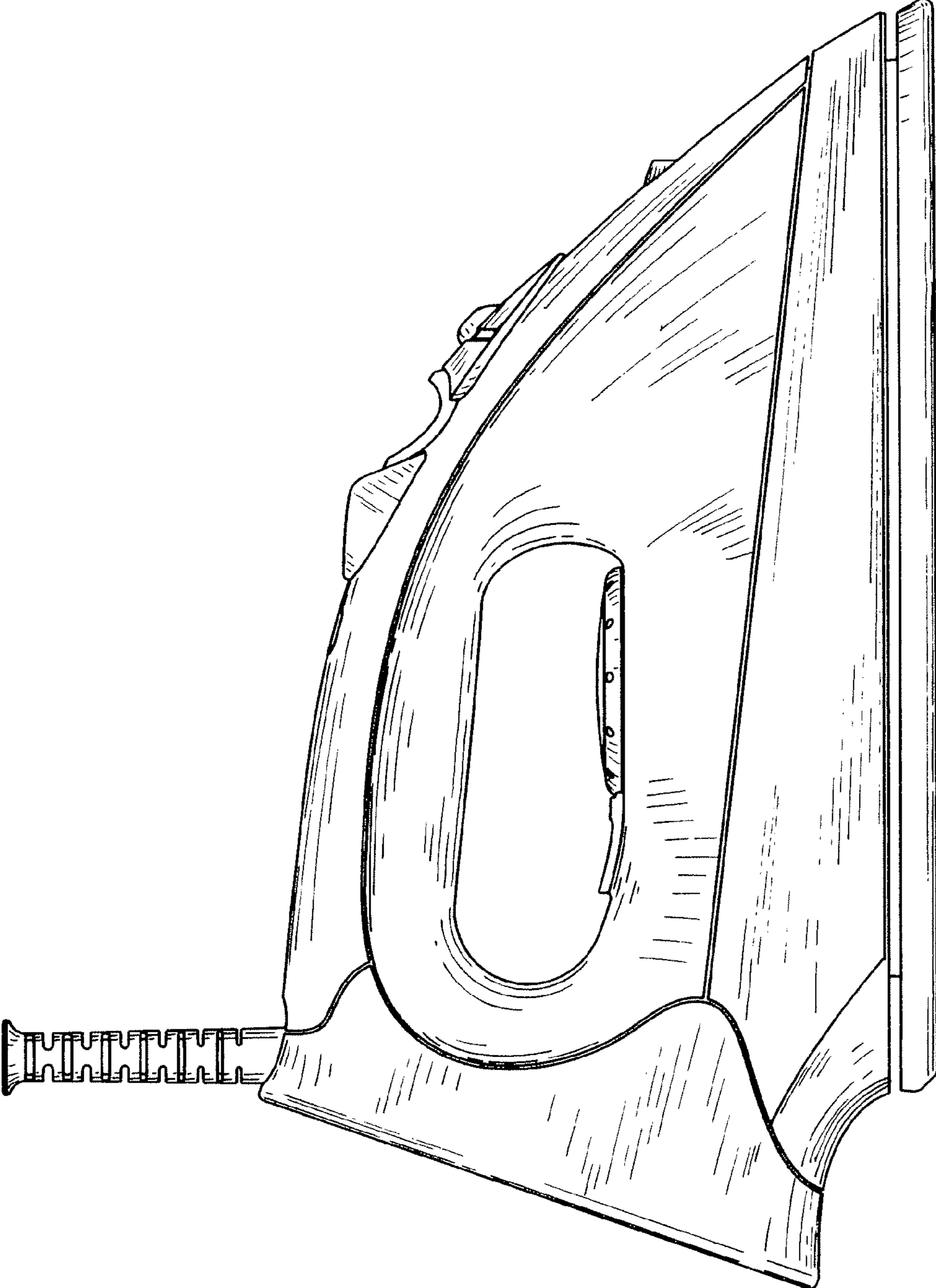

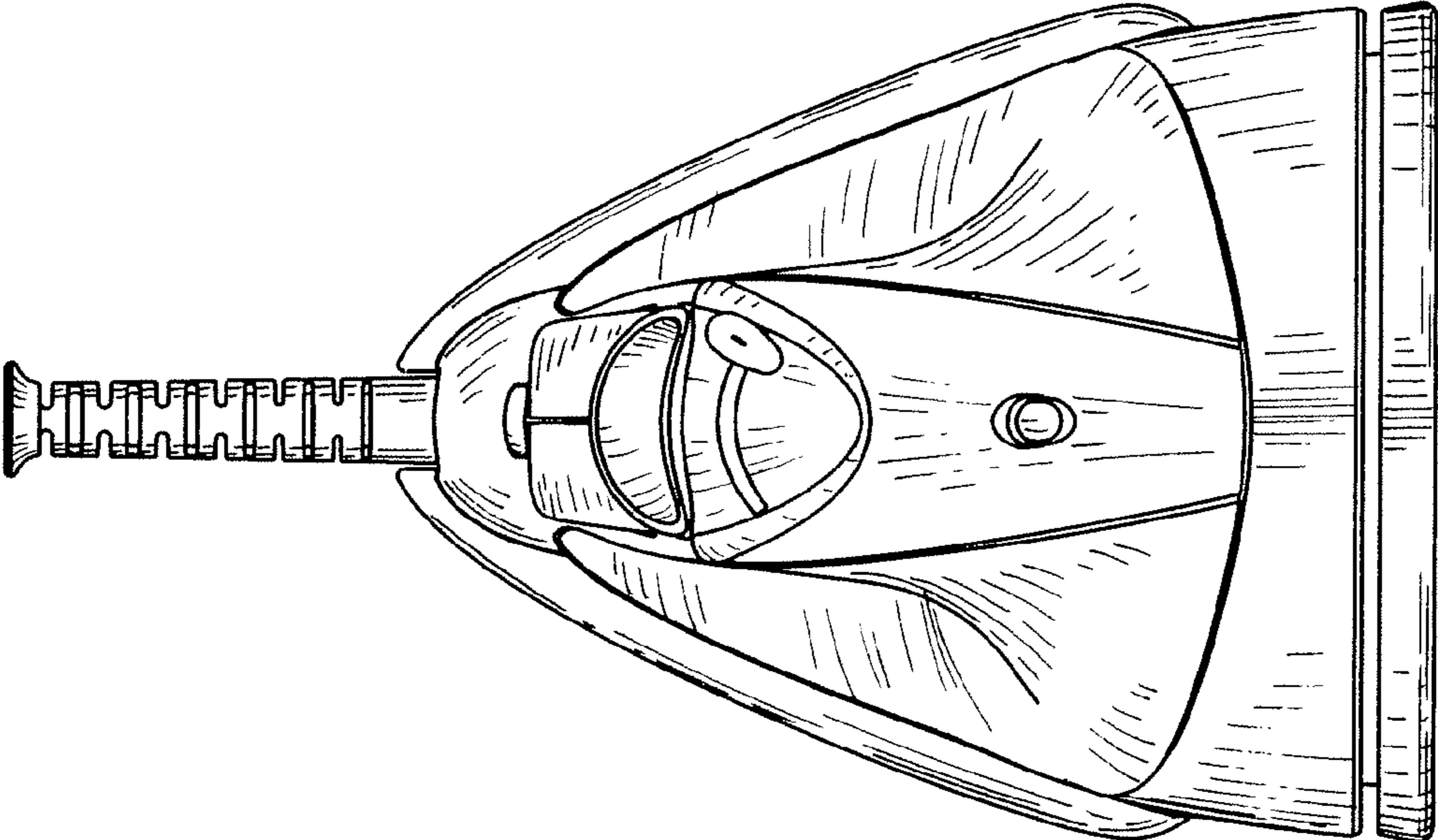

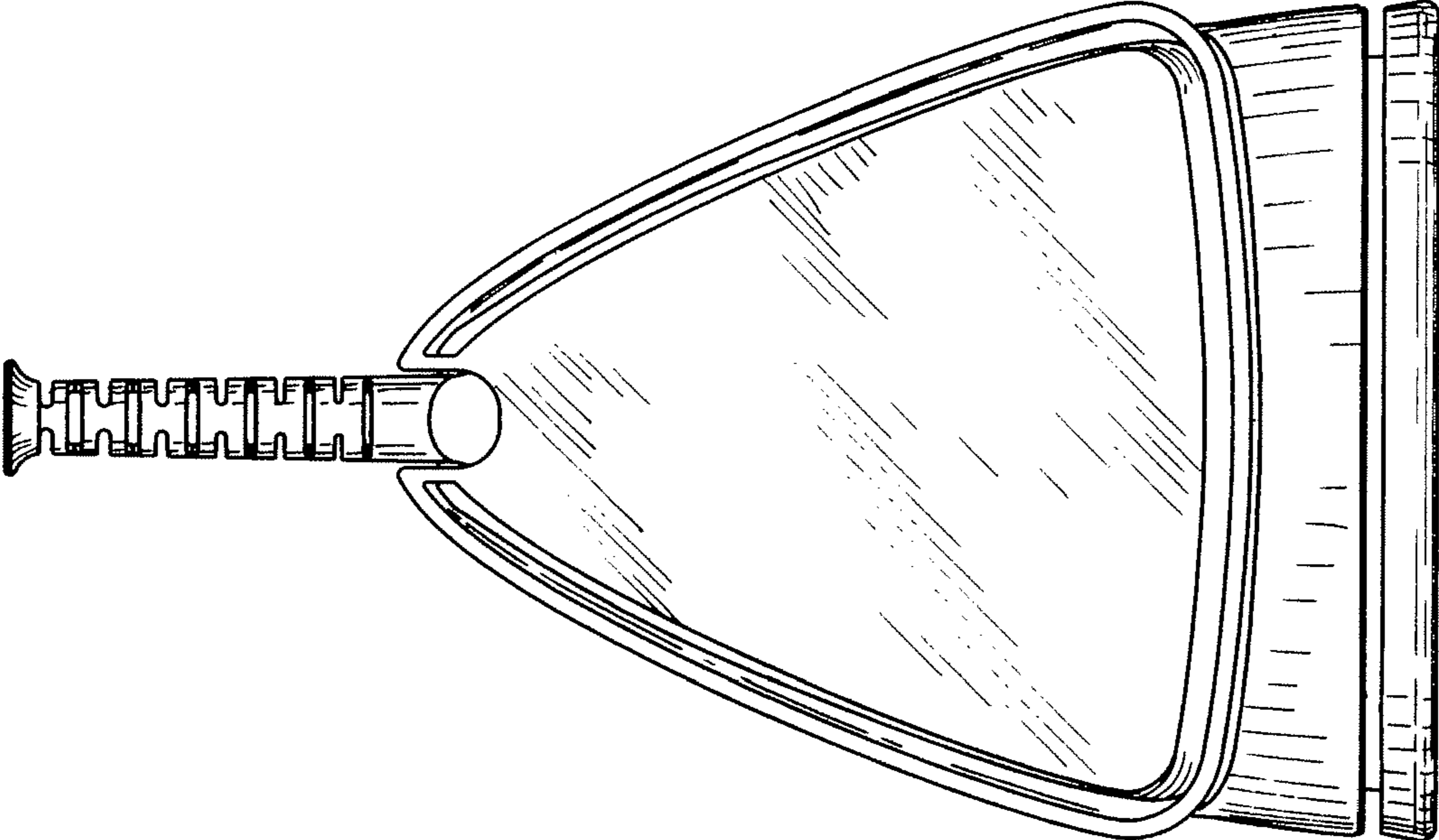

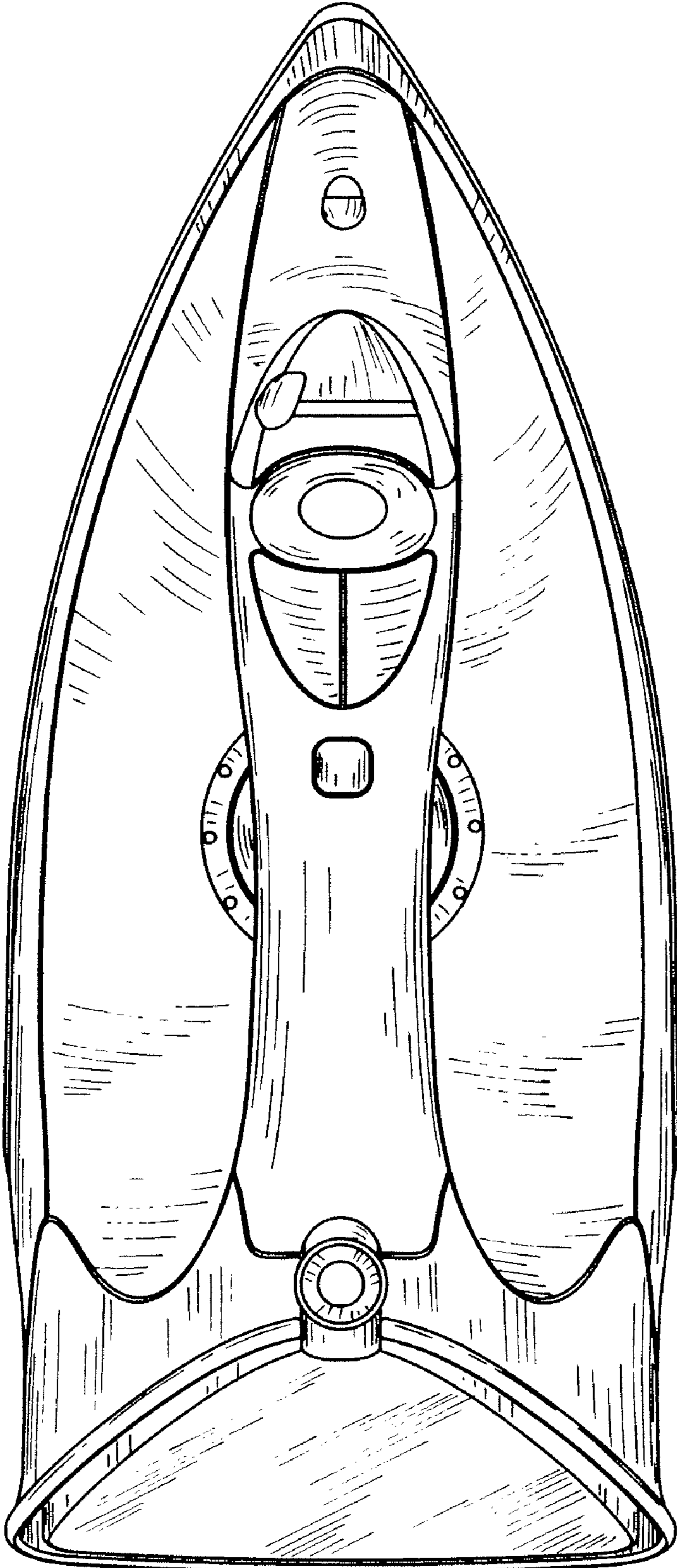

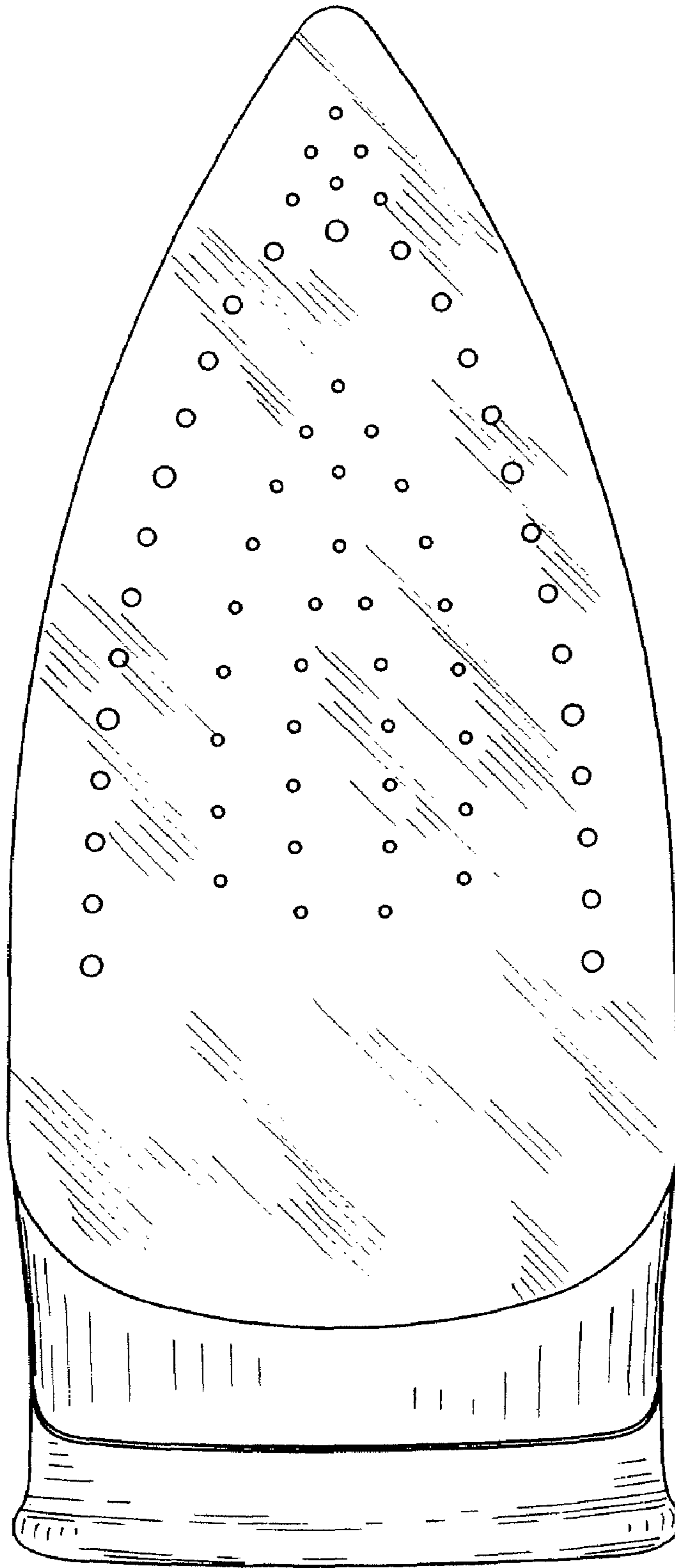

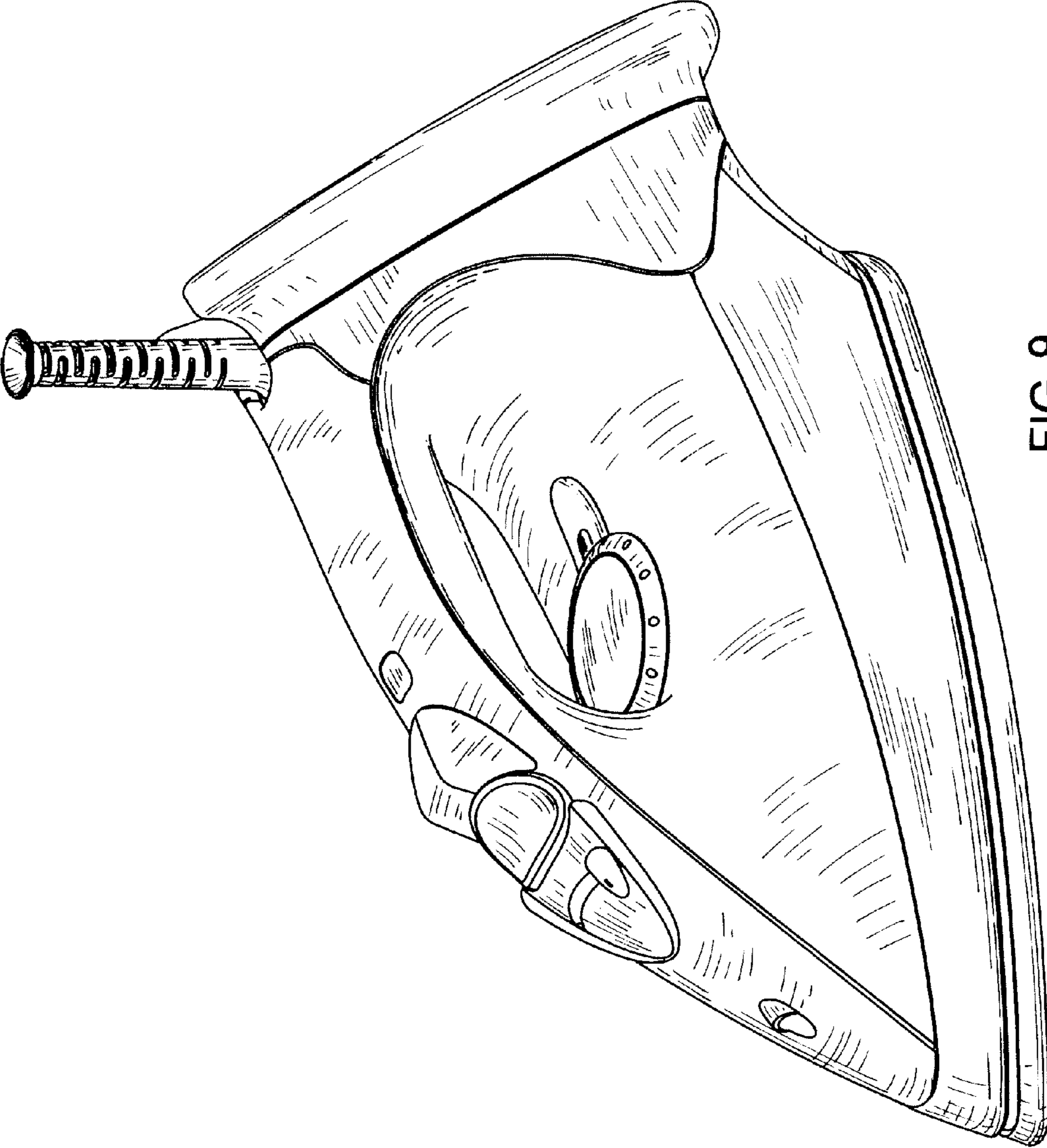

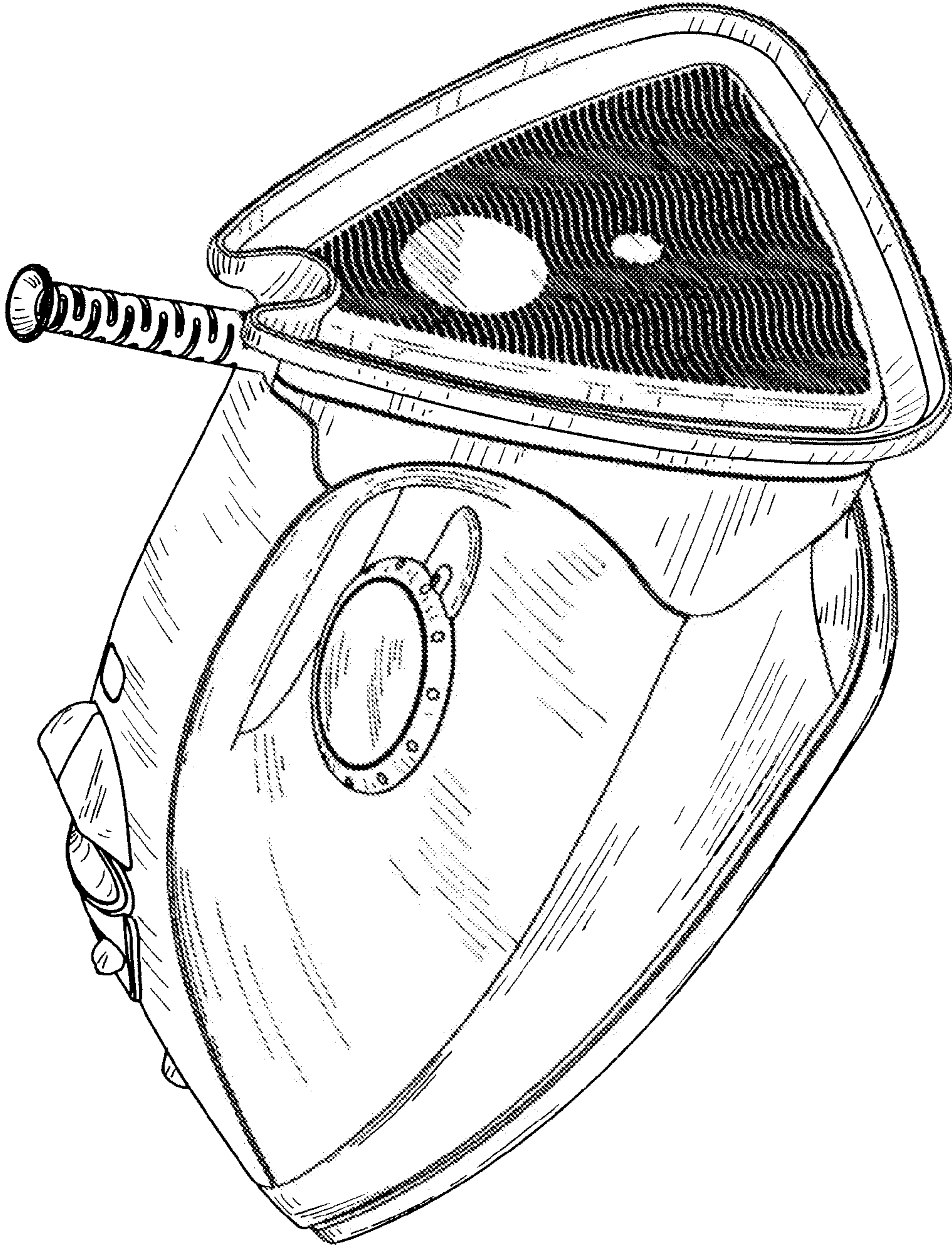

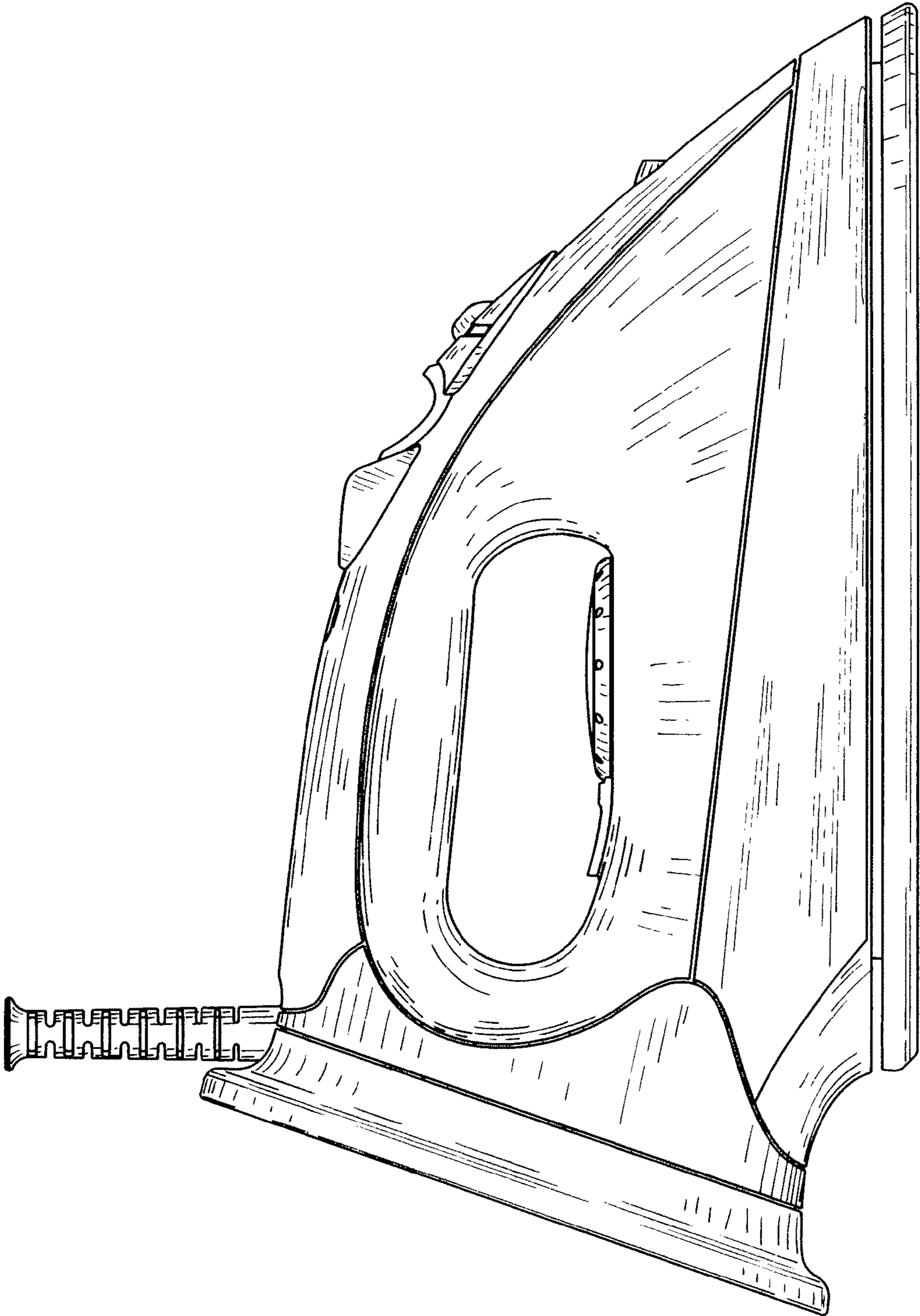

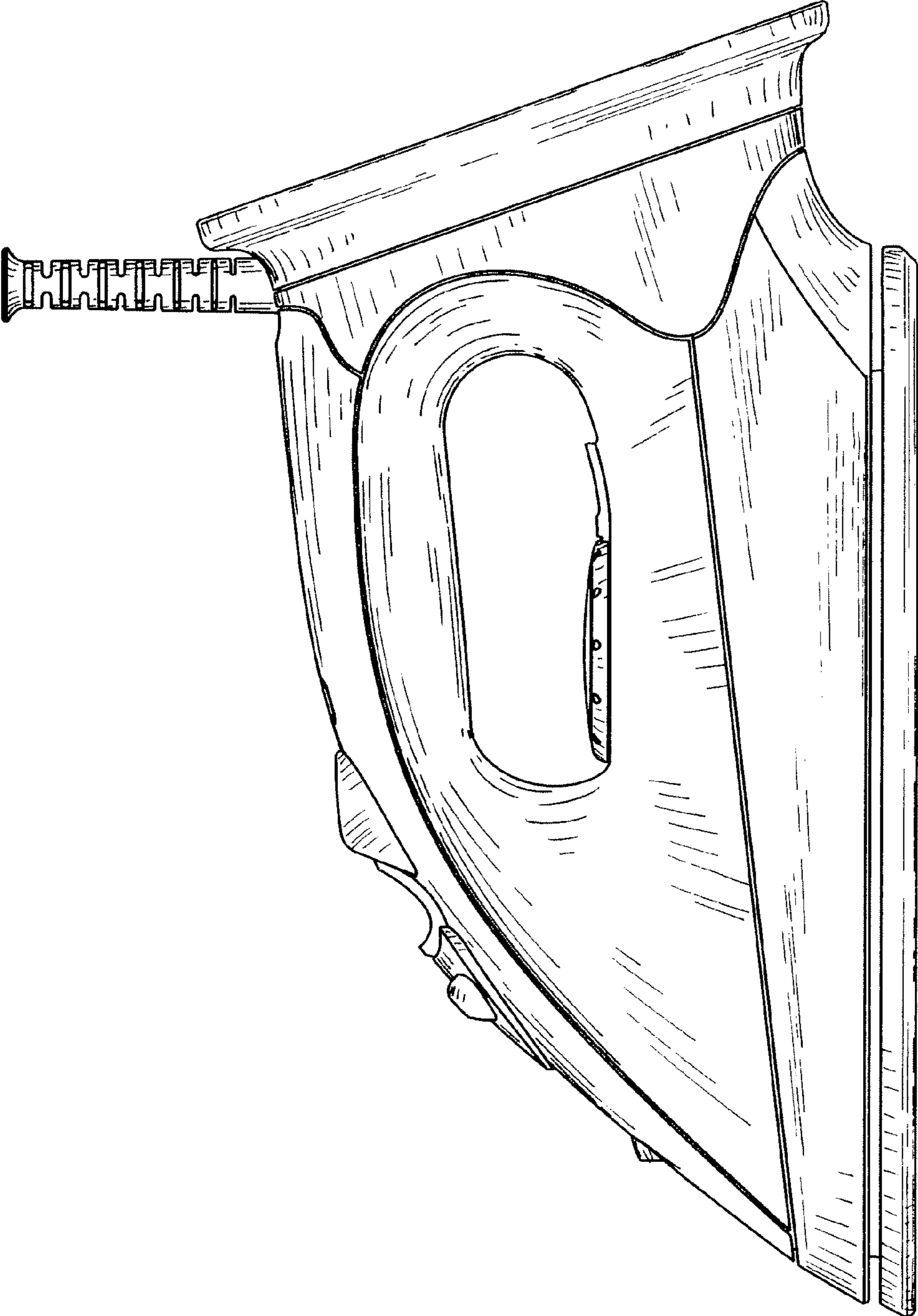

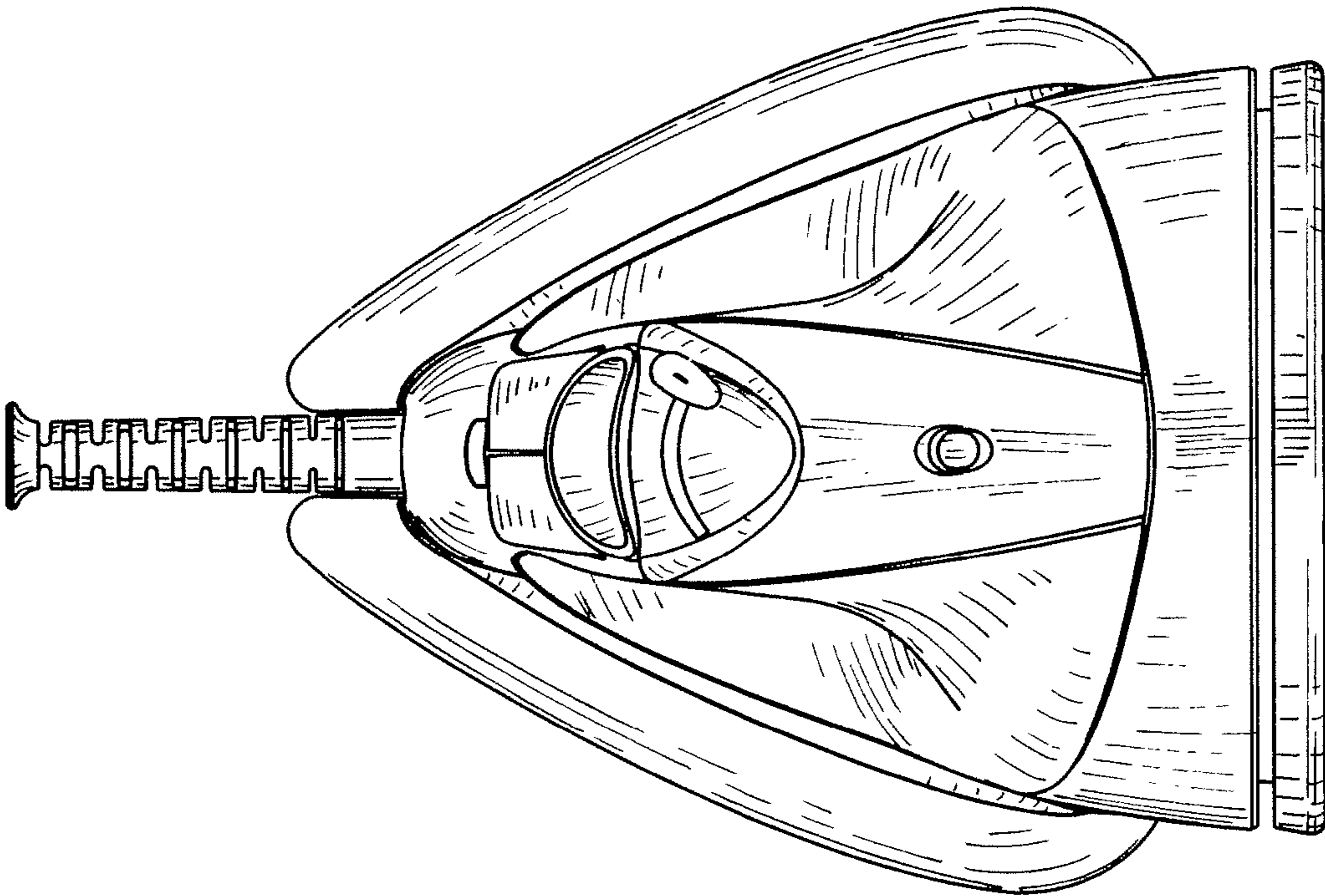

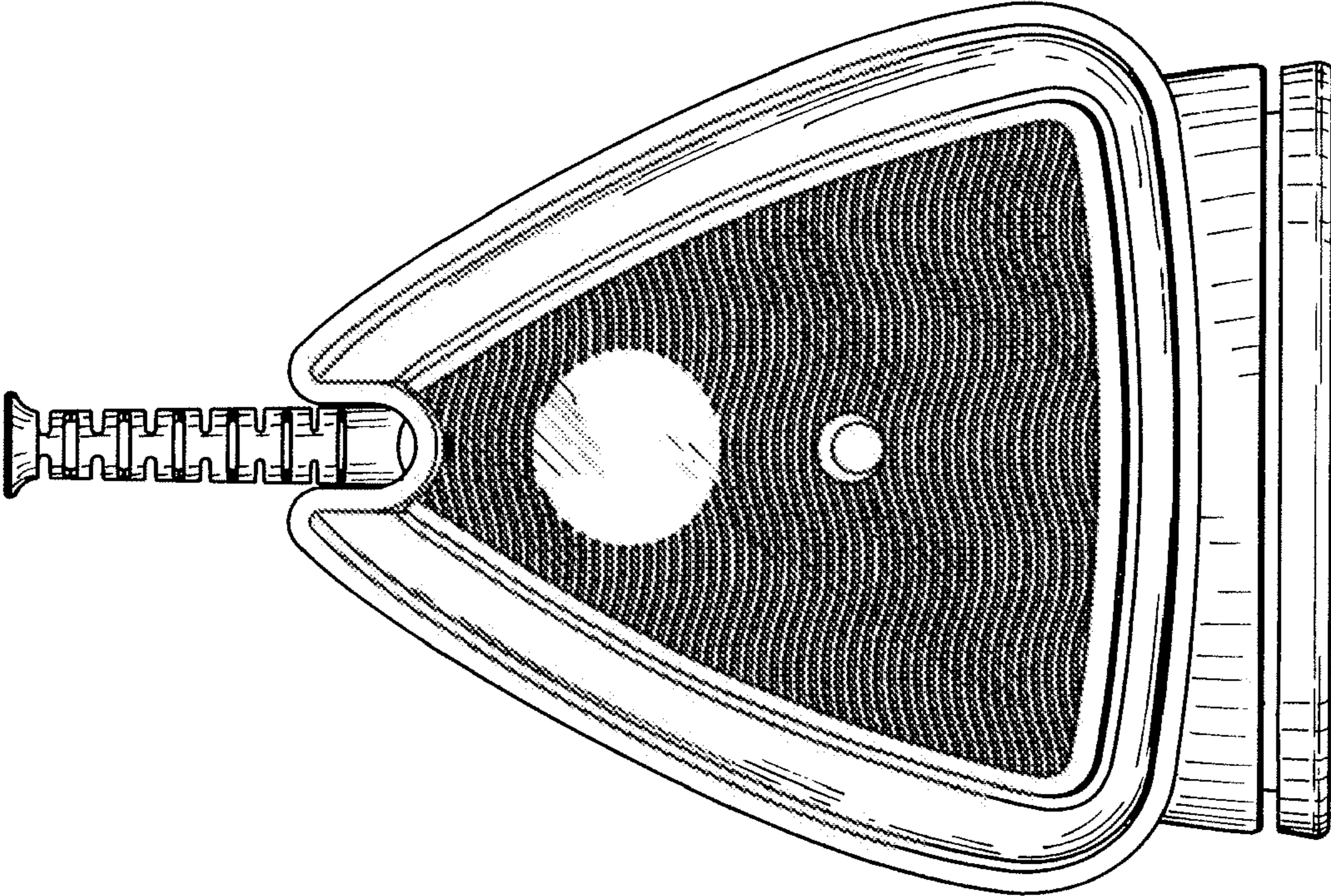

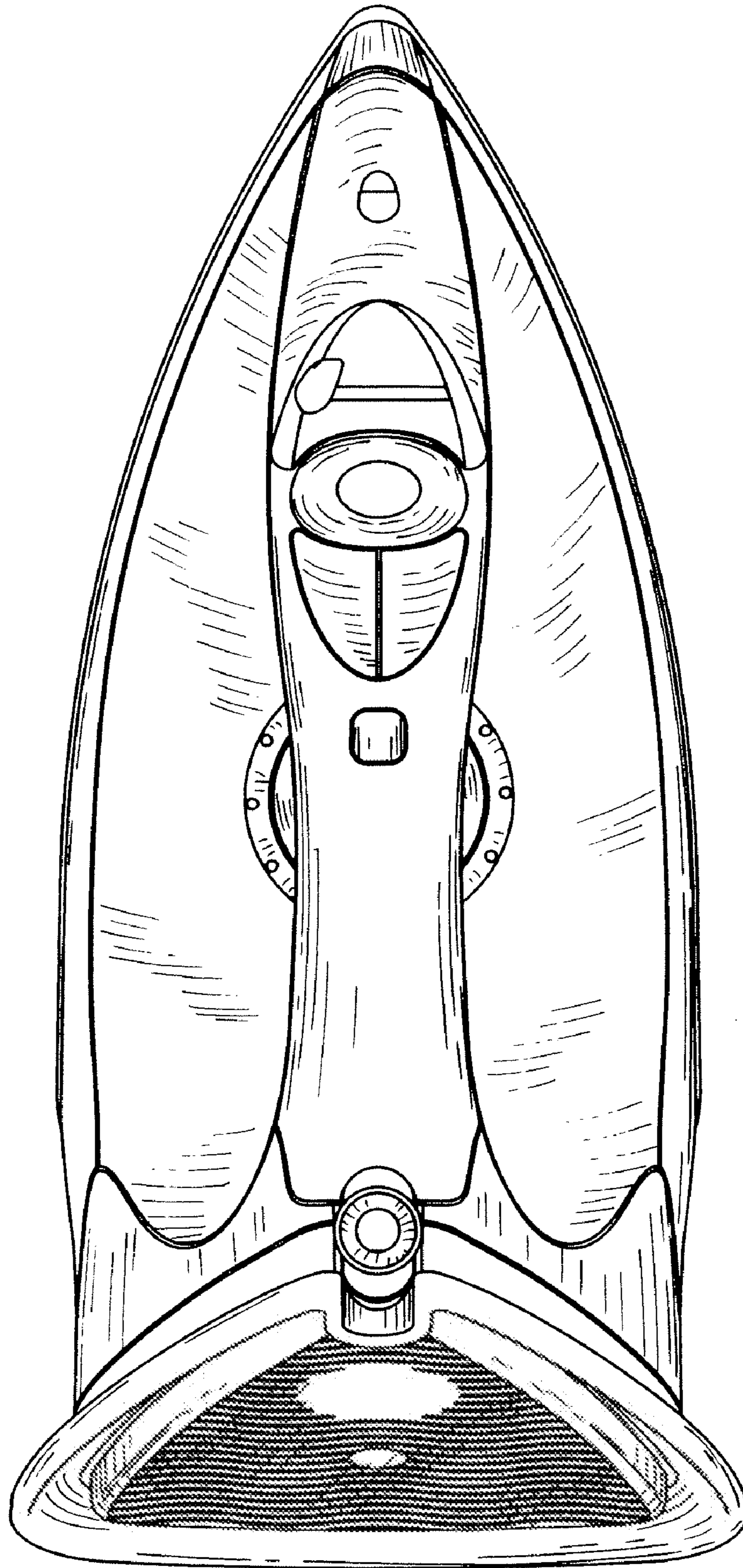

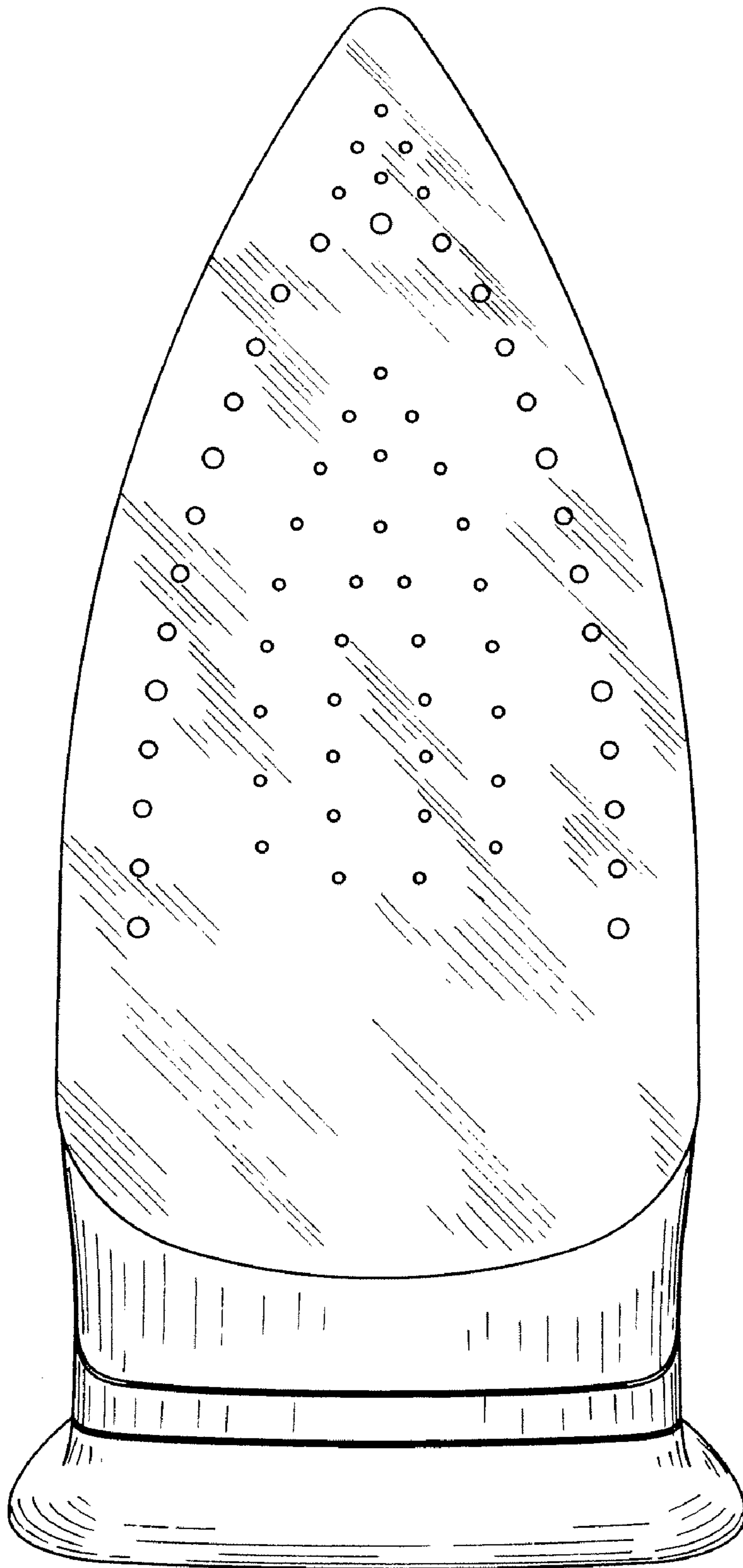
