**DESCRIPTION**

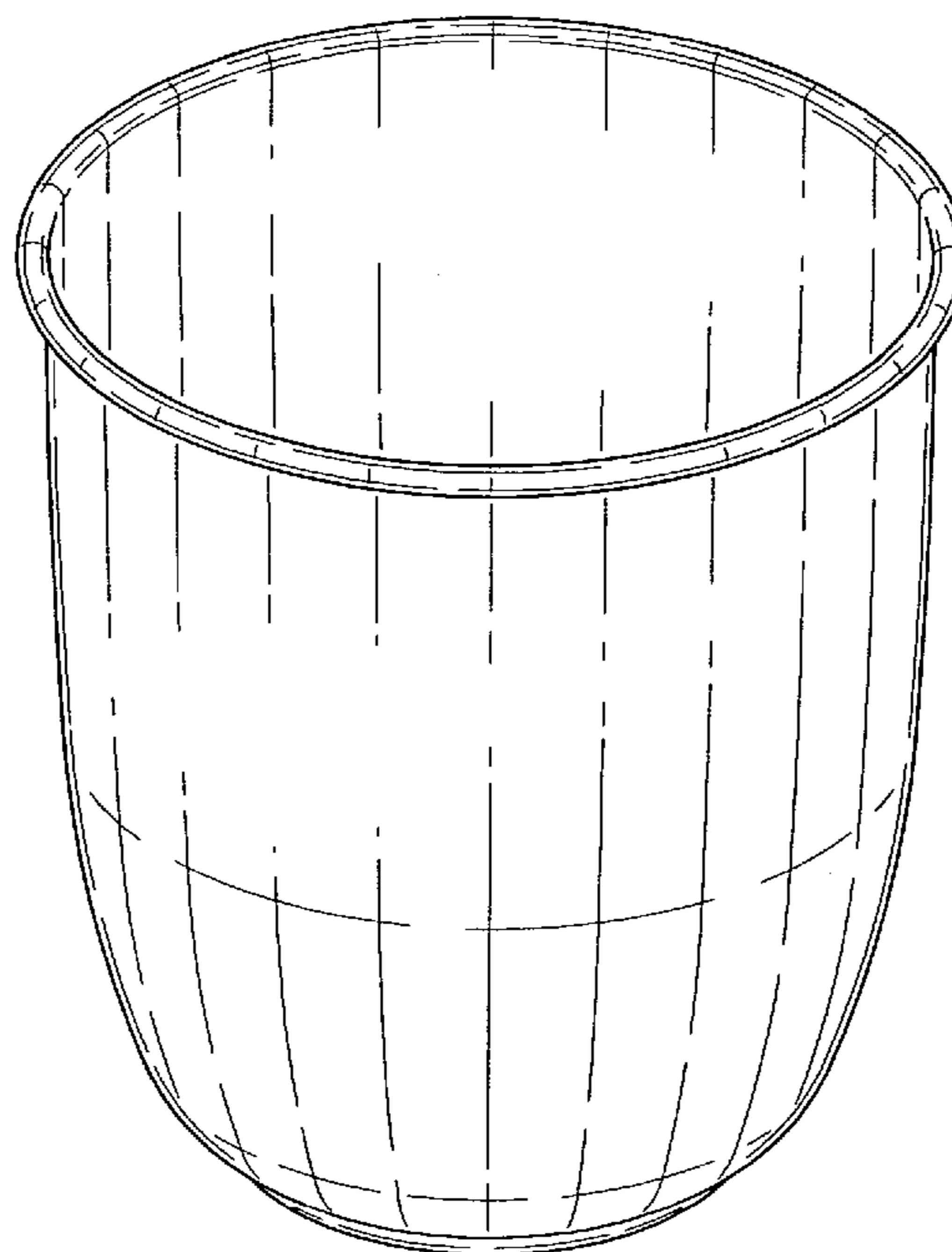
FIG. 1 is a perspective view of the waste can according to the invention;

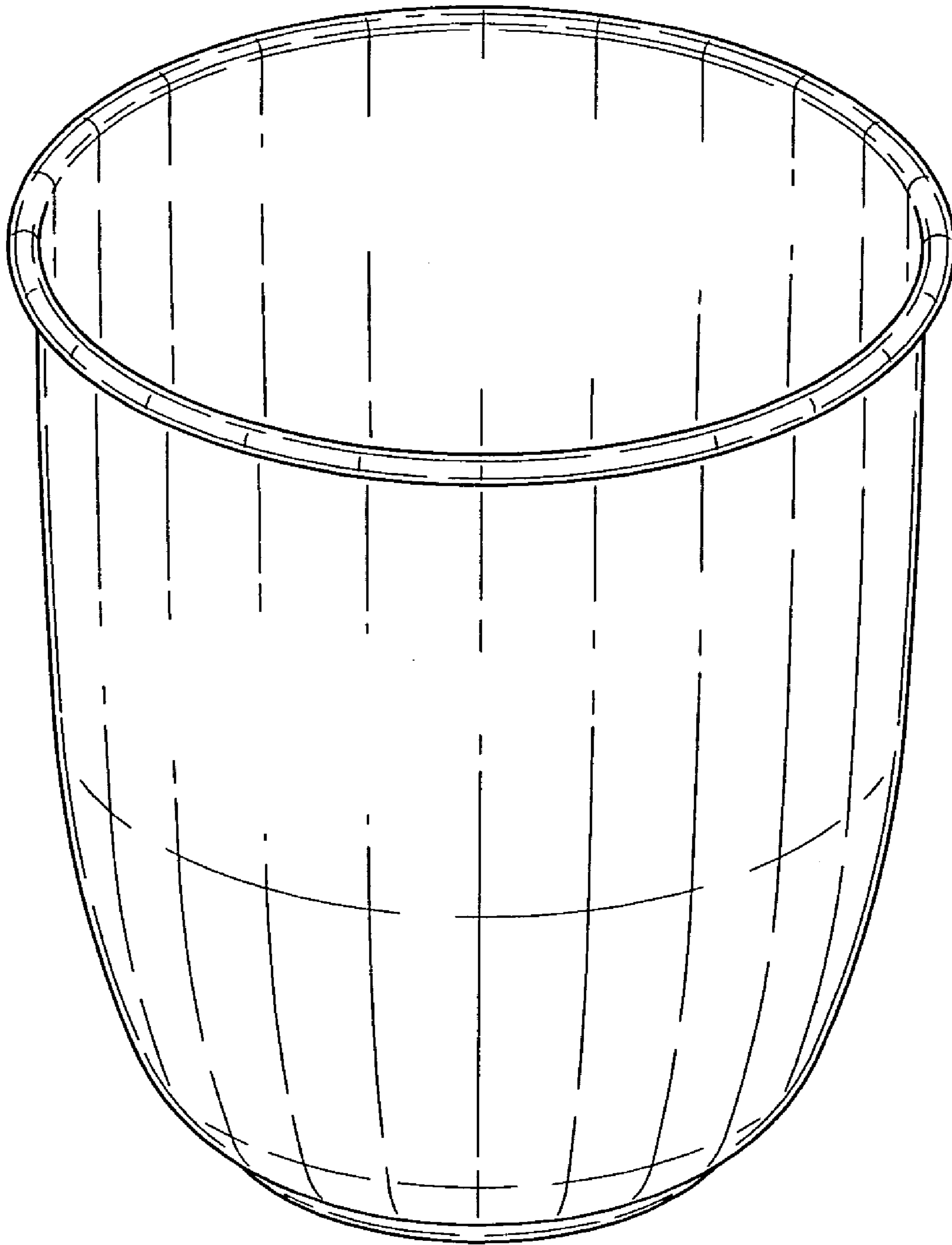

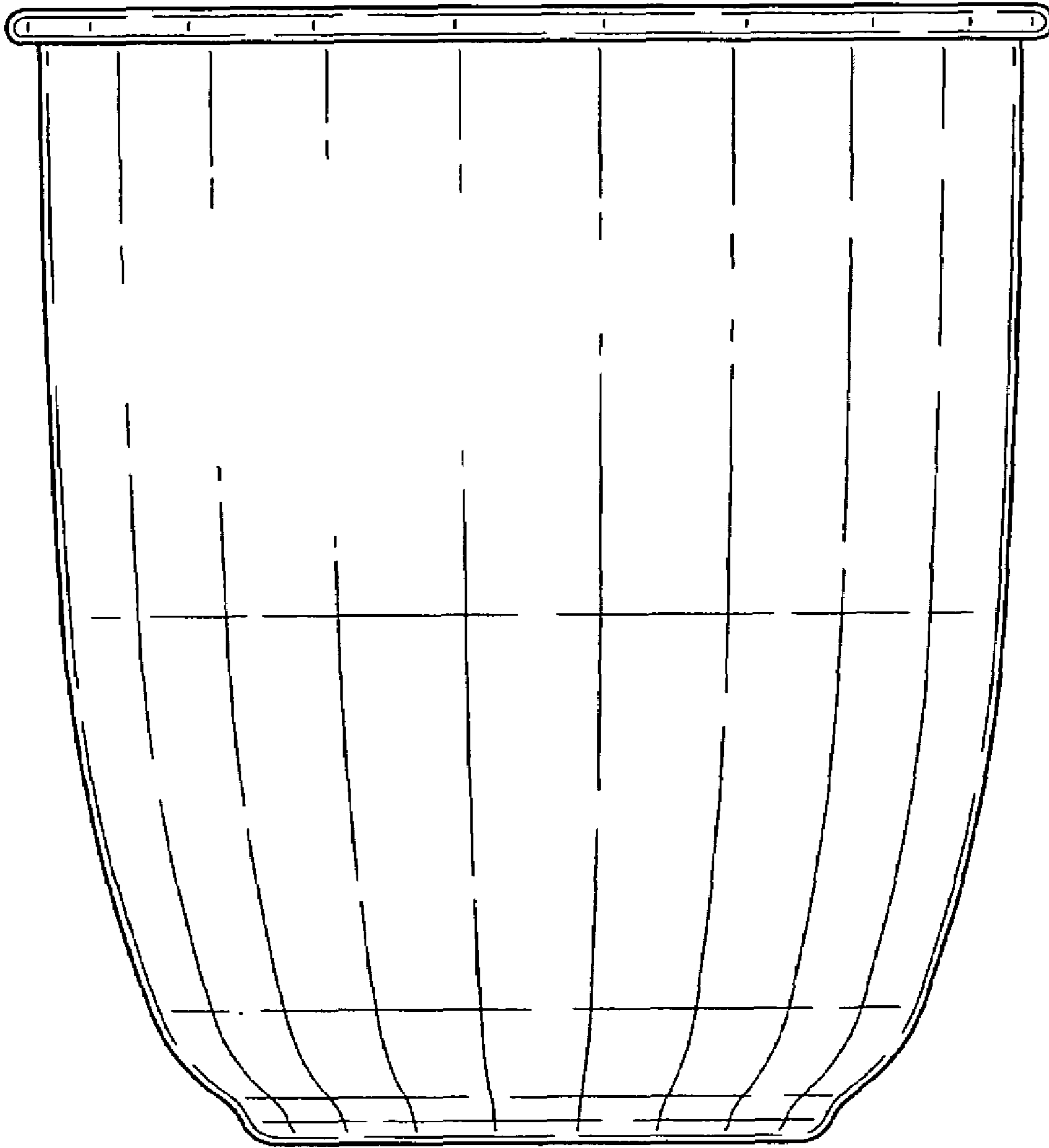

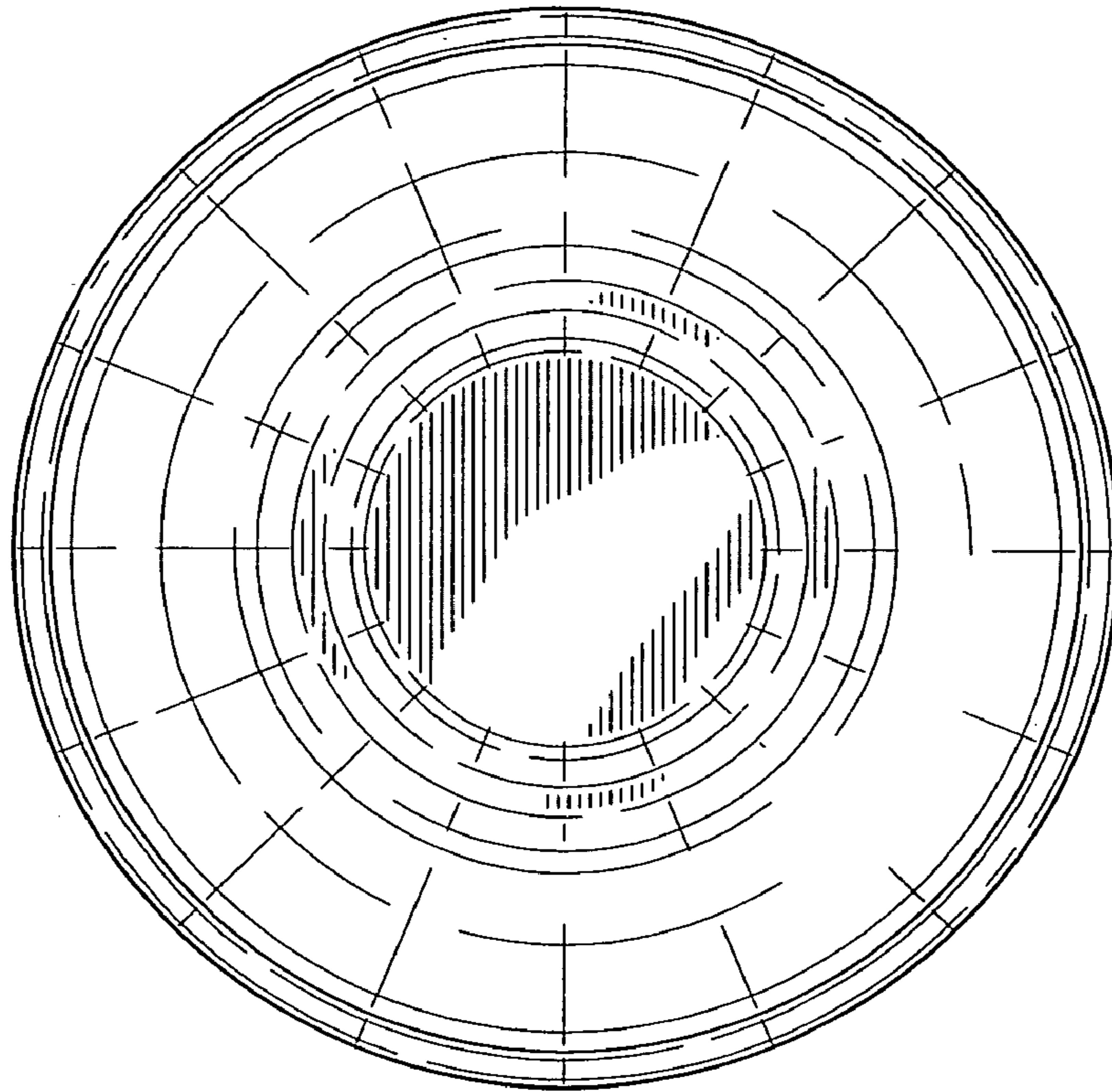

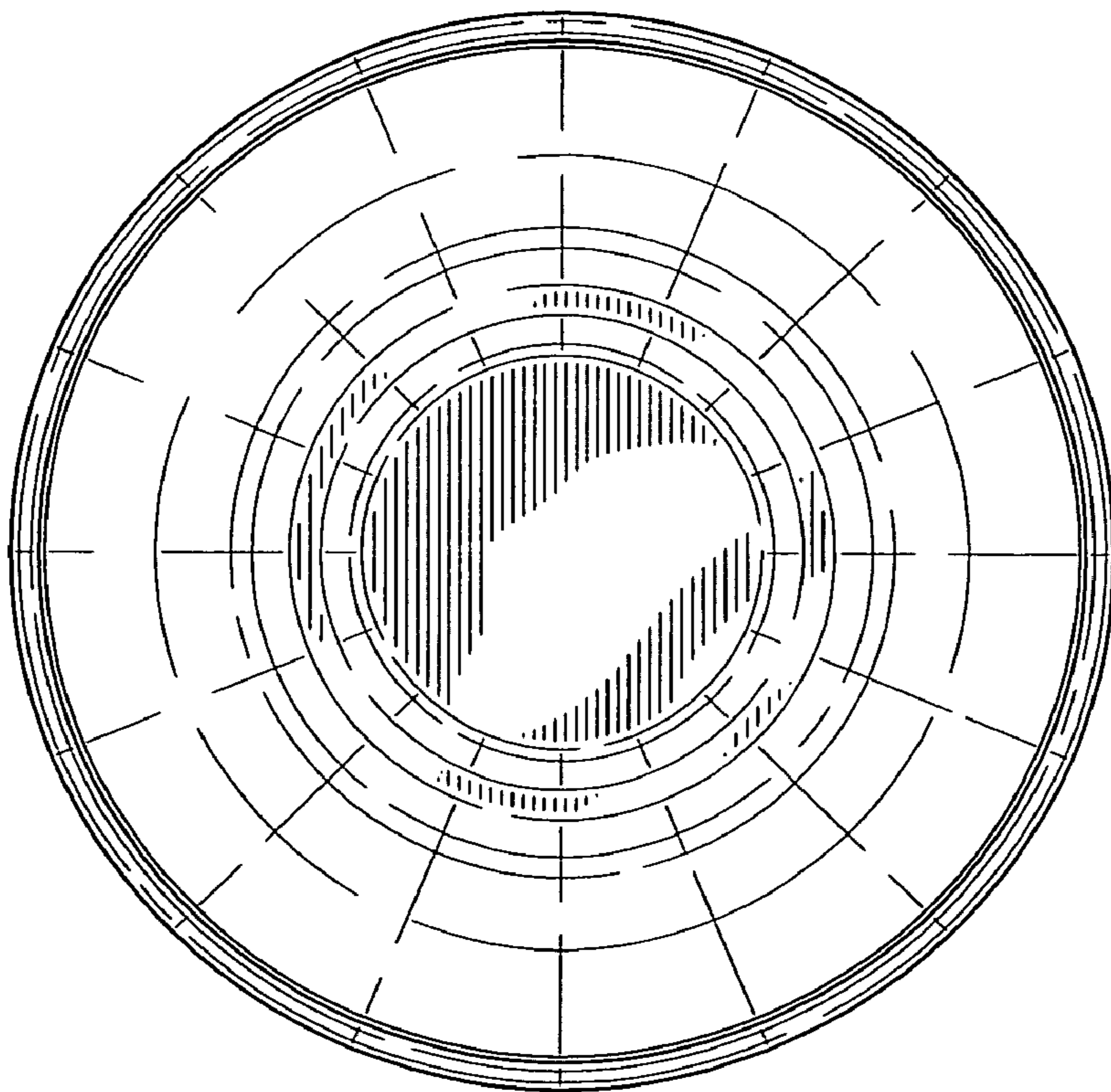
