FIG. 1 is a perspective view of the casket lid showing the new design;

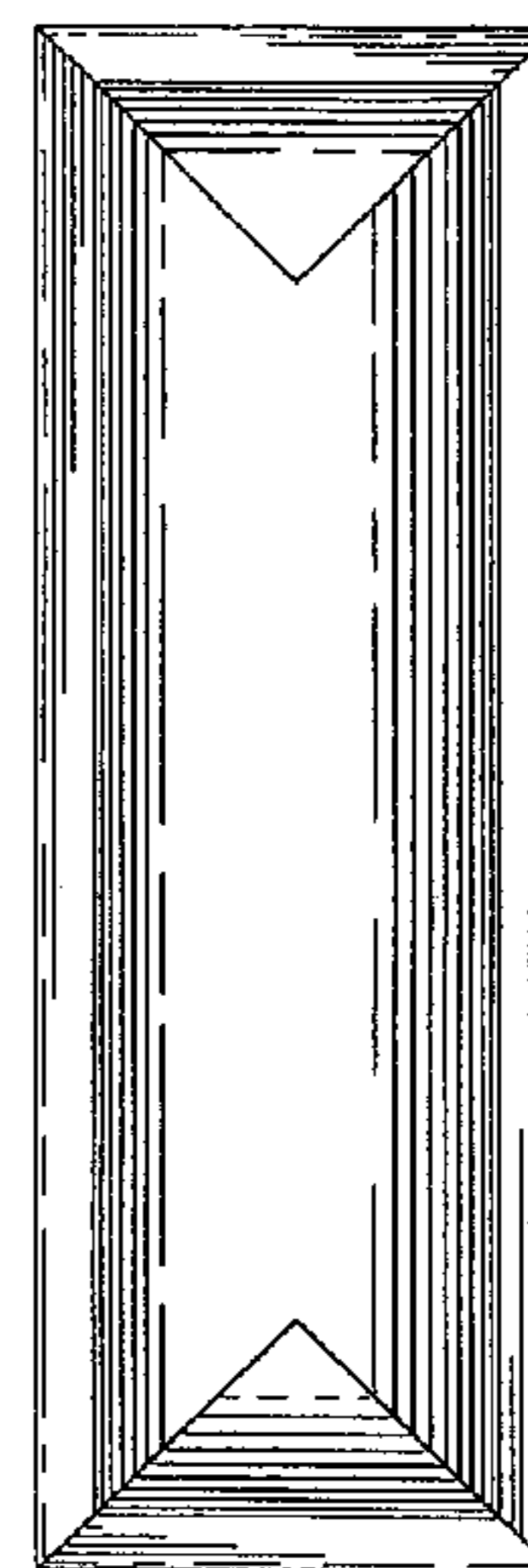
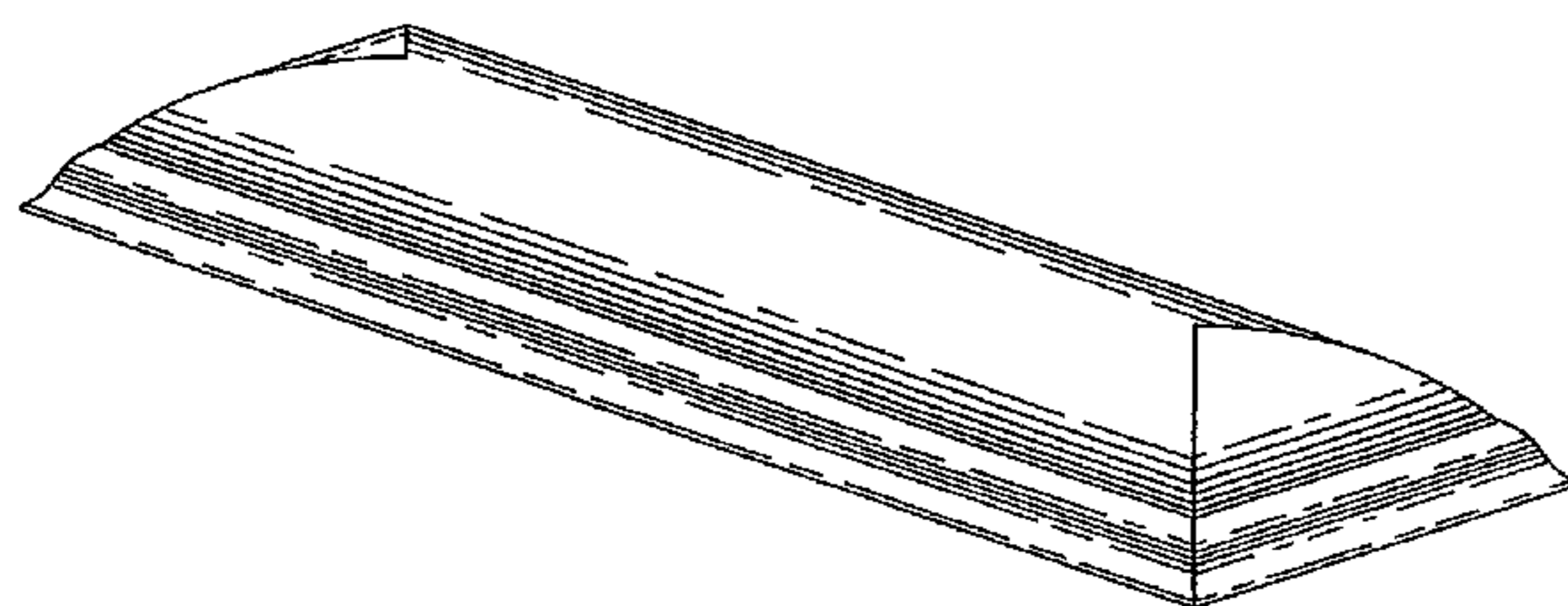
FIG. 2 is a right elevation view thereof, the left end being identical thereto;

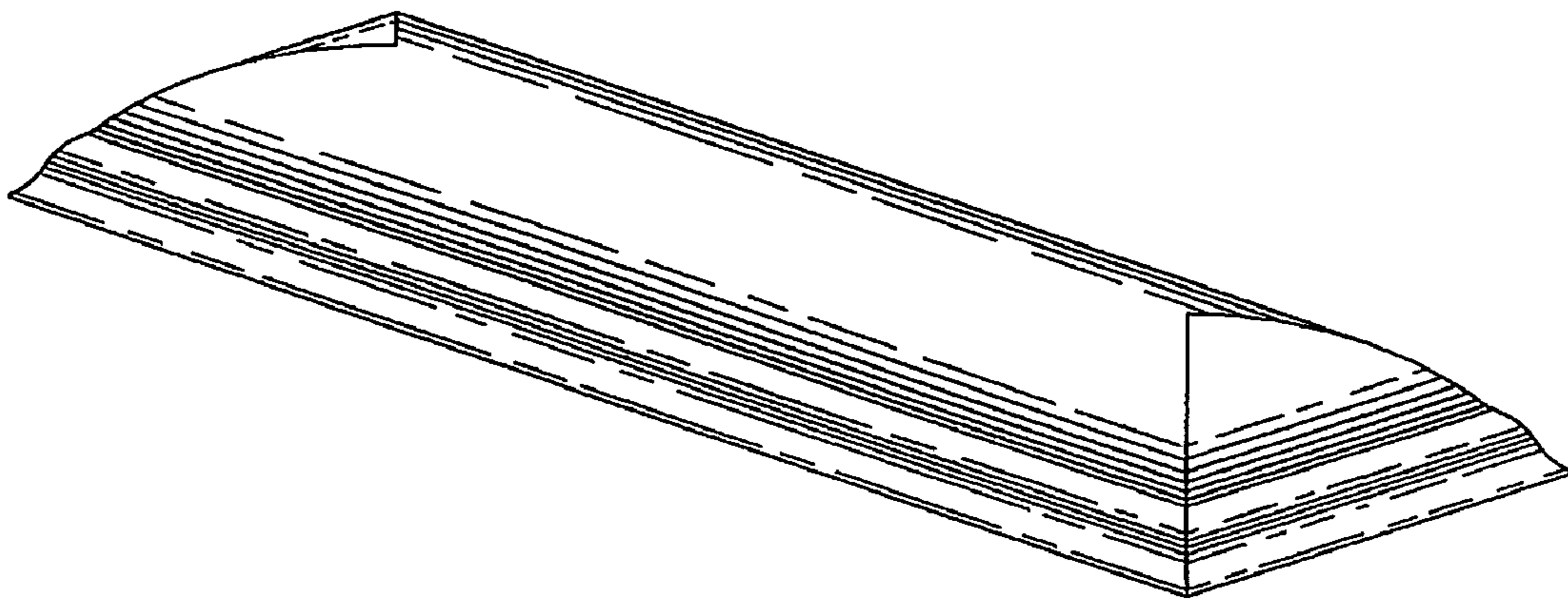

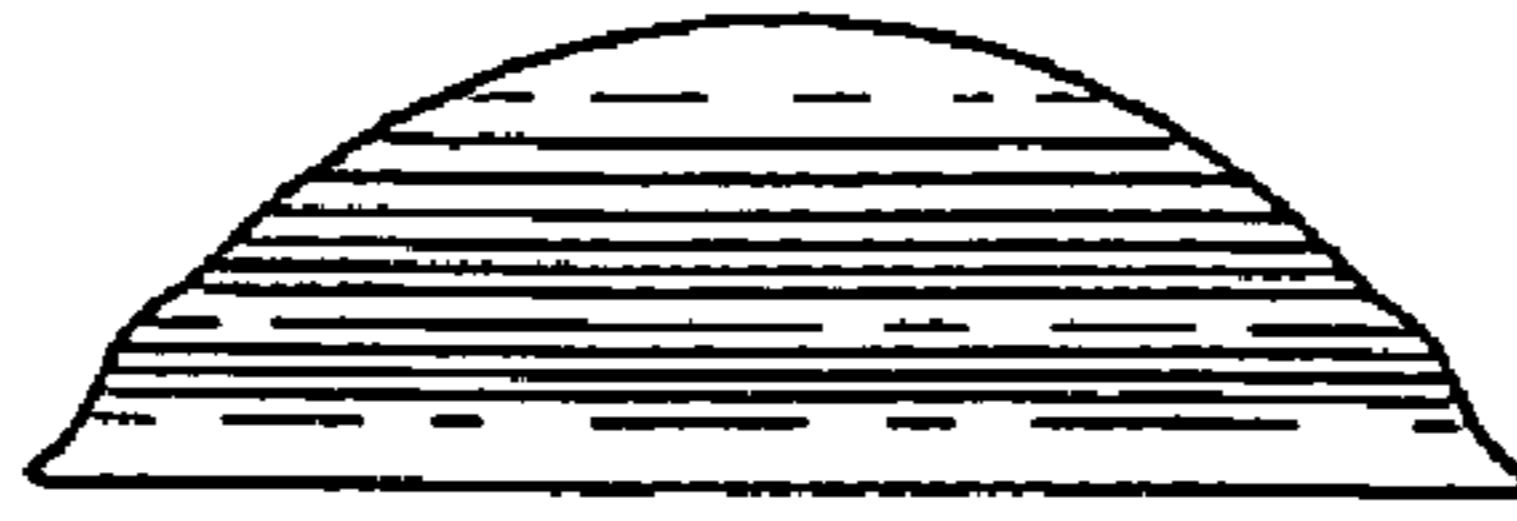

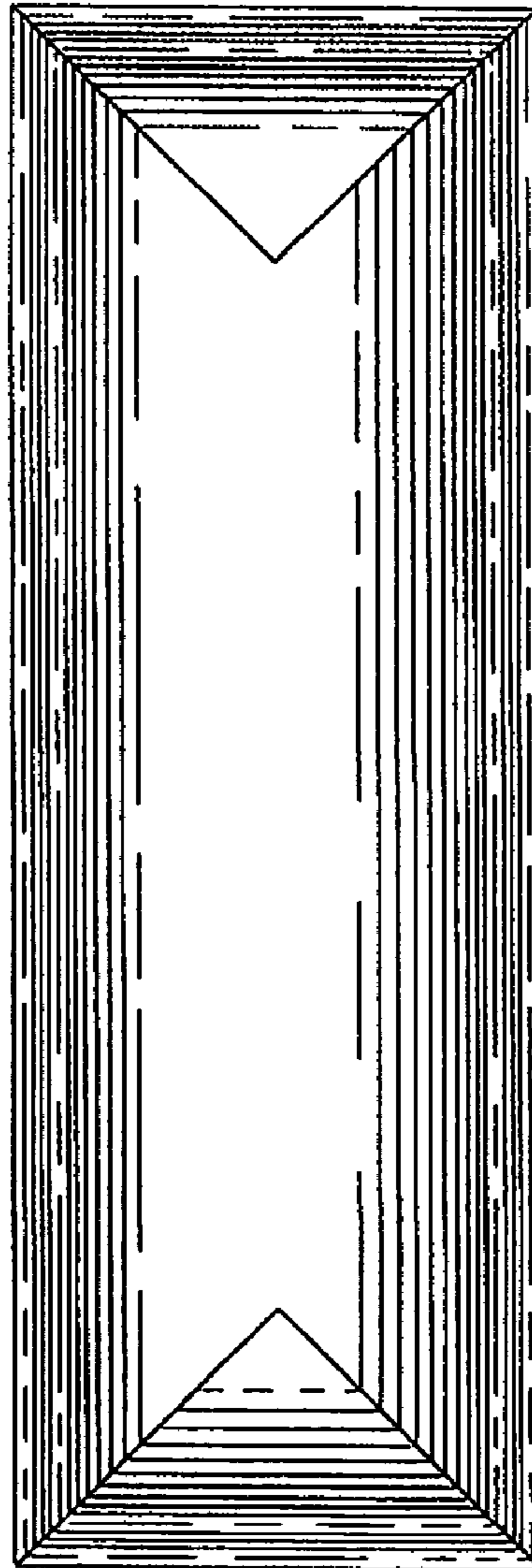

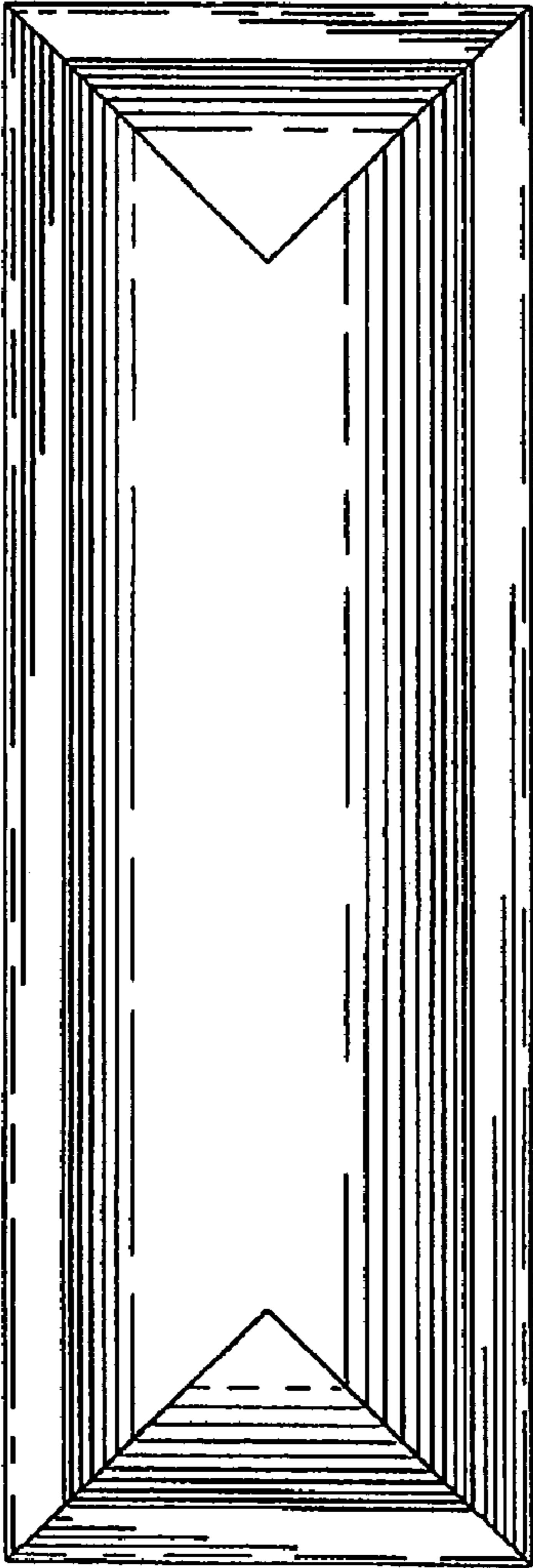

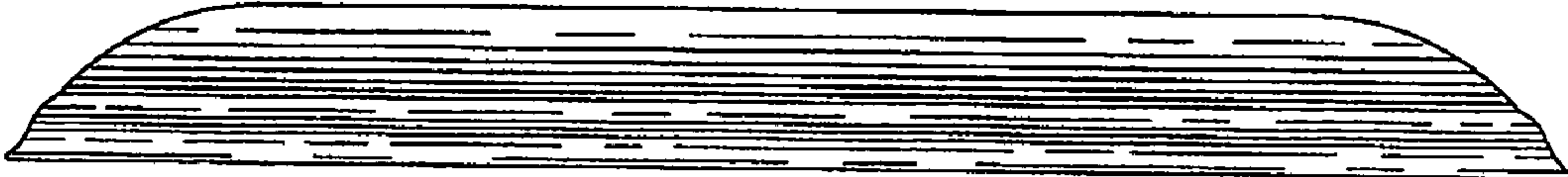
