The ornamental design for shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a shoe sole showing my new design;

FIG. 2 is a front view;

FIG. 3 is a rear view;

FIG. 4 is a right side view;

FIG. 5 is a left side view;

FIG. 6 is a bottom plan view;

FIG. 7 is an enlarged partial perspective view showing the front portion of the shoe sole; and,

FIG. 8 is an enlarged partial perspective view showing the rear portion of the shoe sole.

The broken line showing of the shoe upper is included for the purpose of illustrating and forms no part of the claimed design.

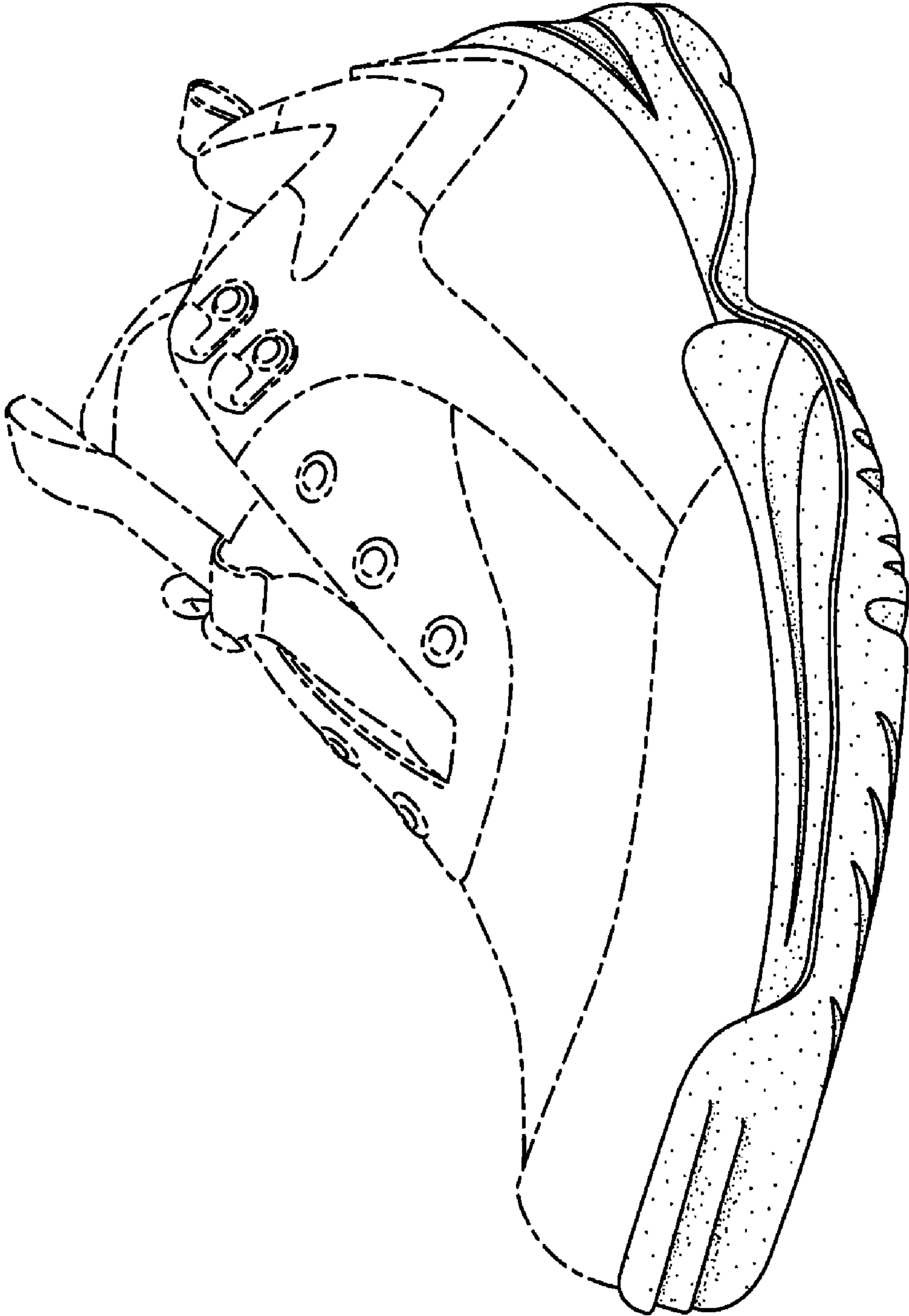

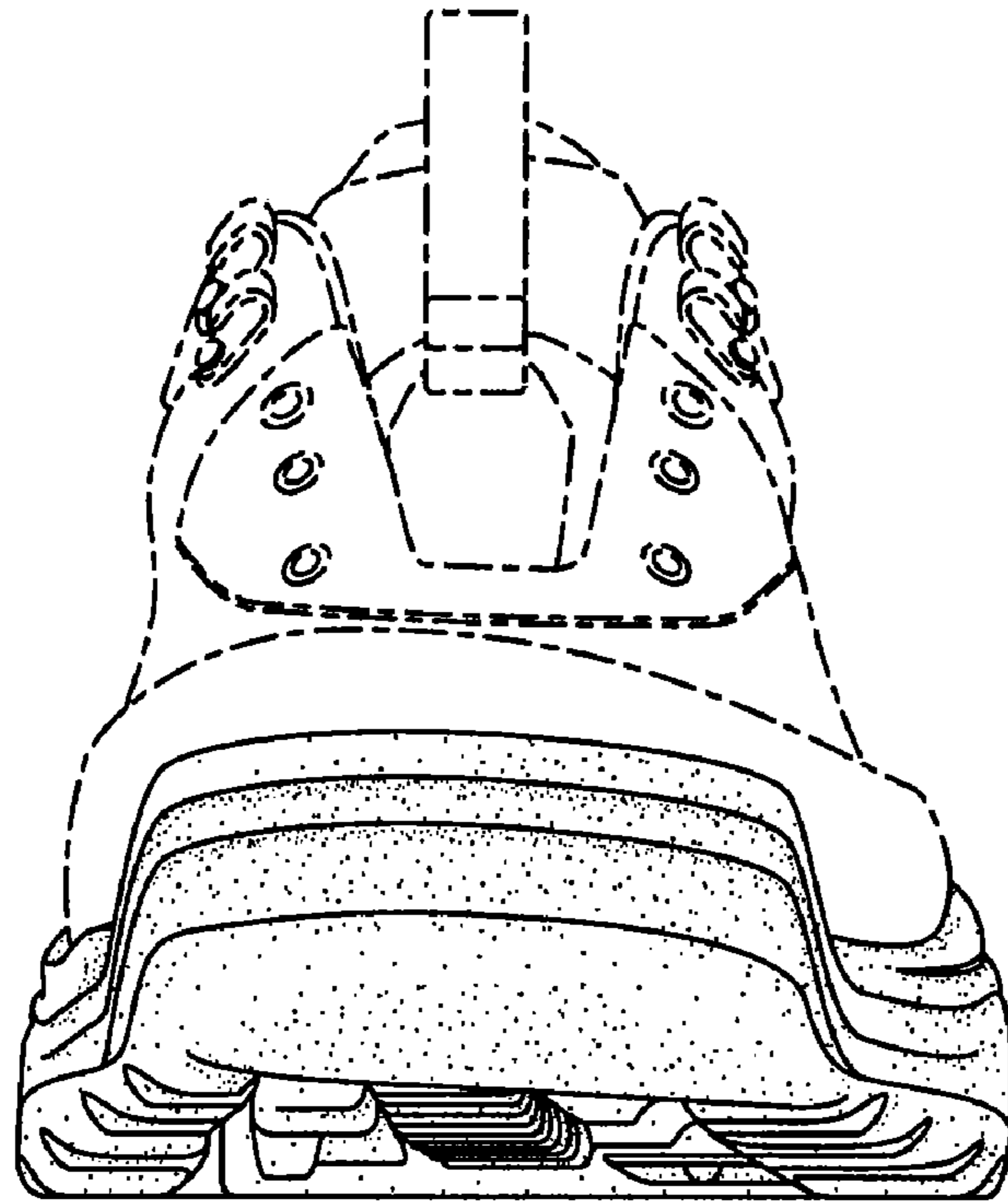

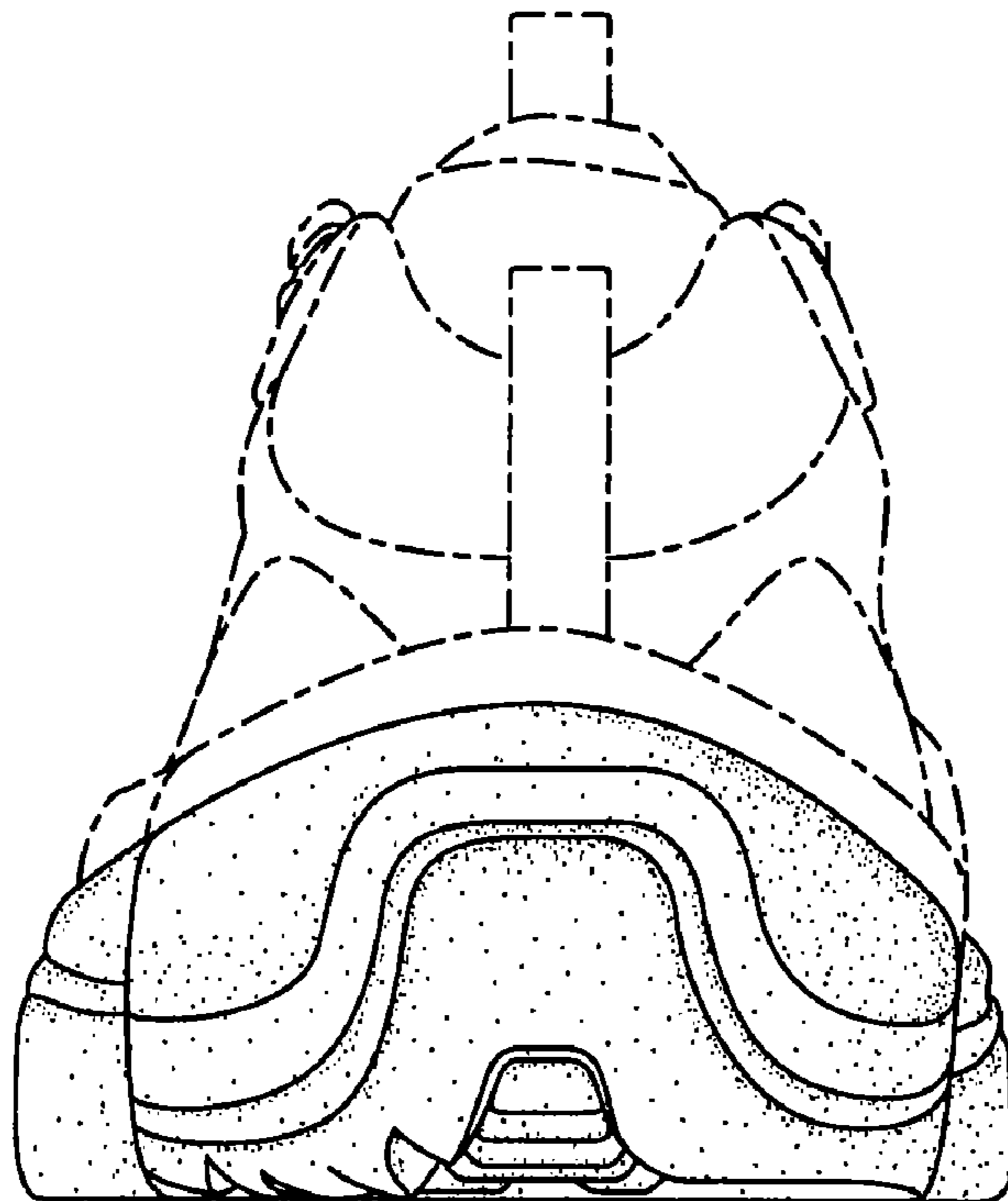

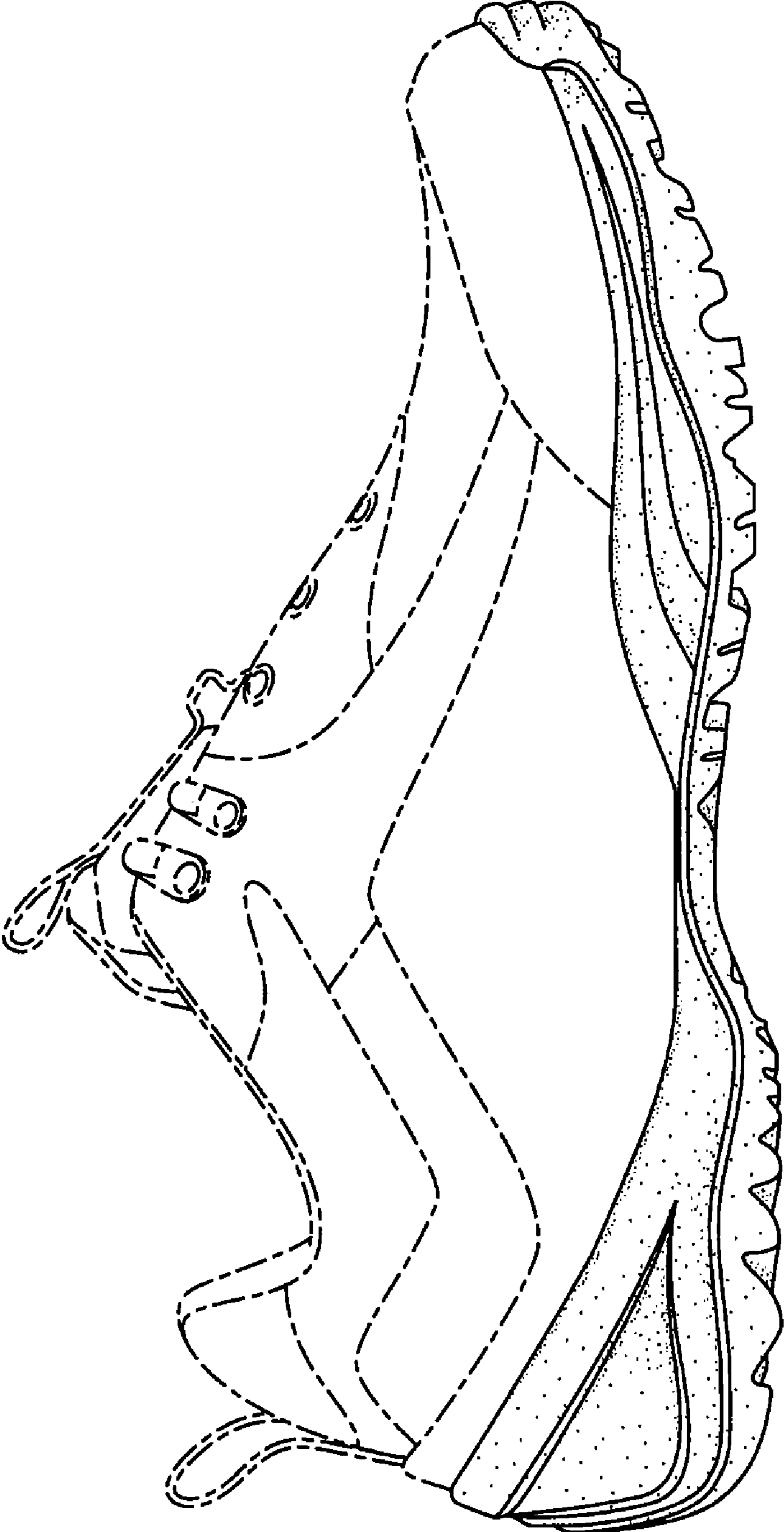

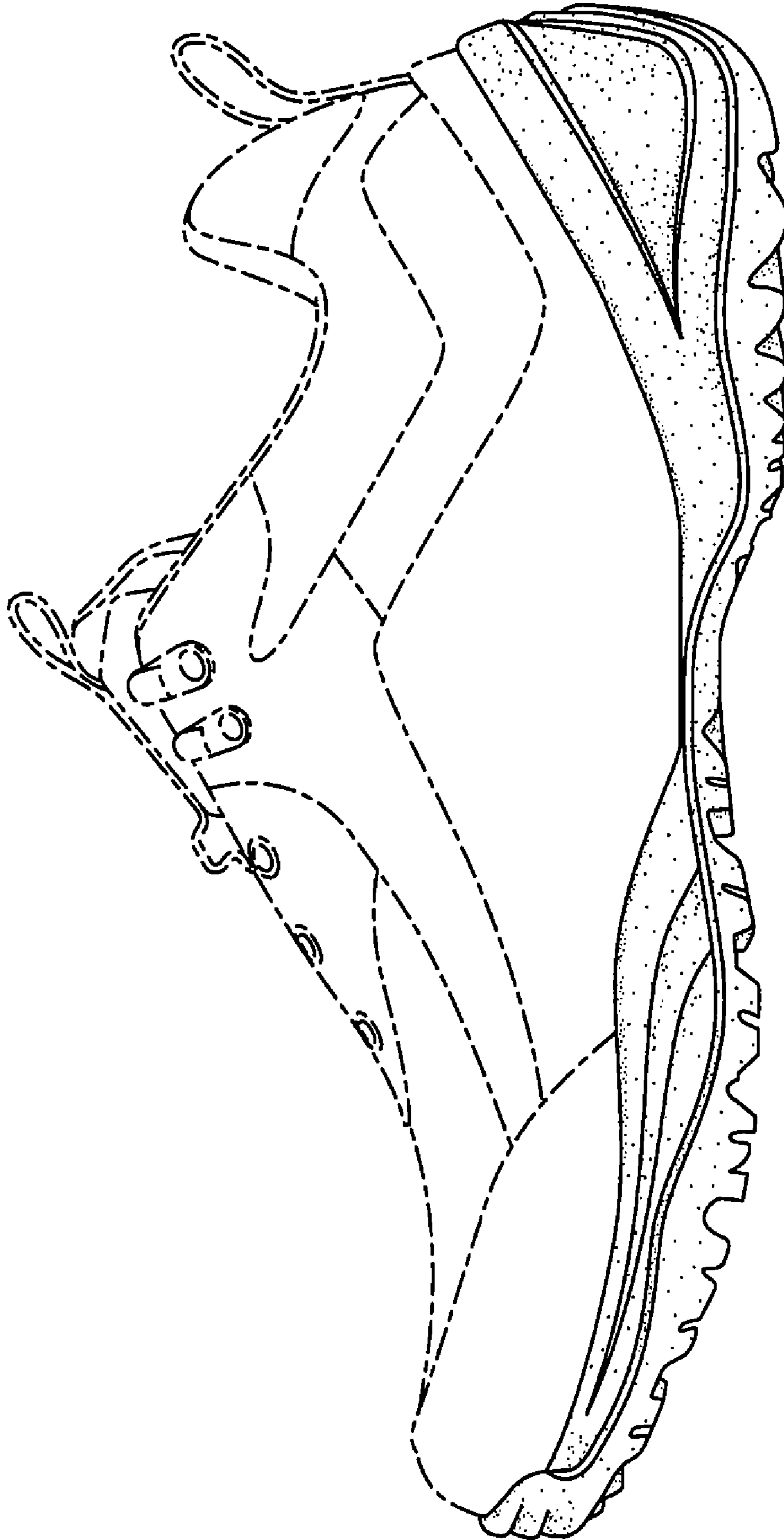

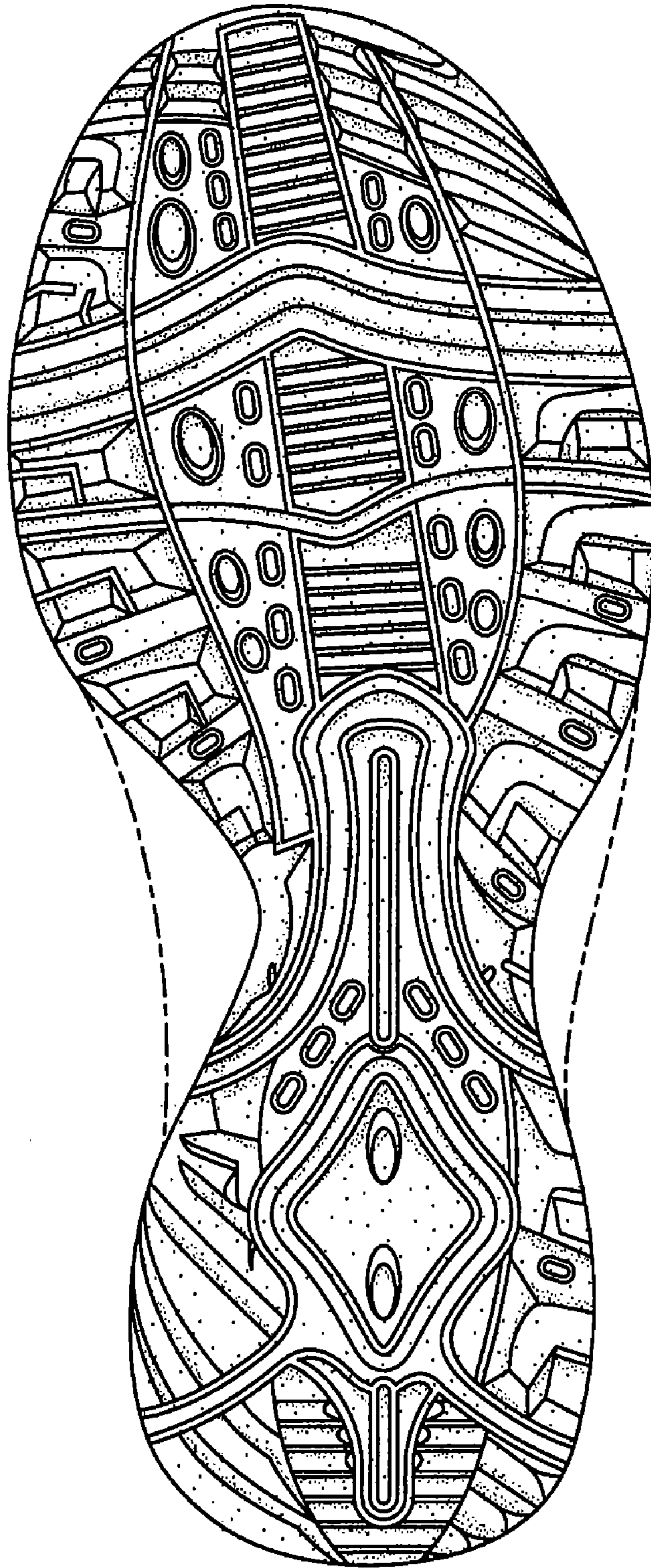

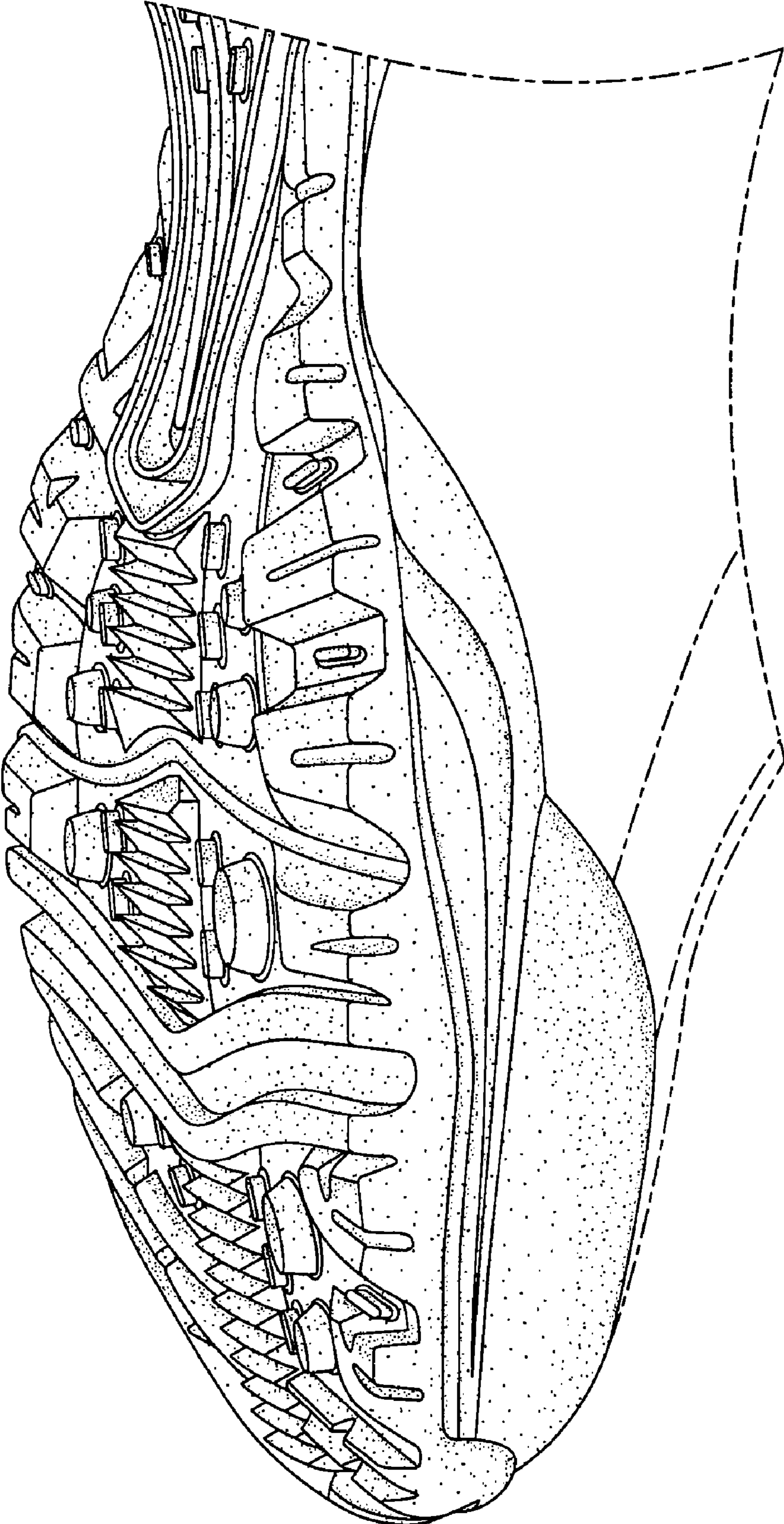

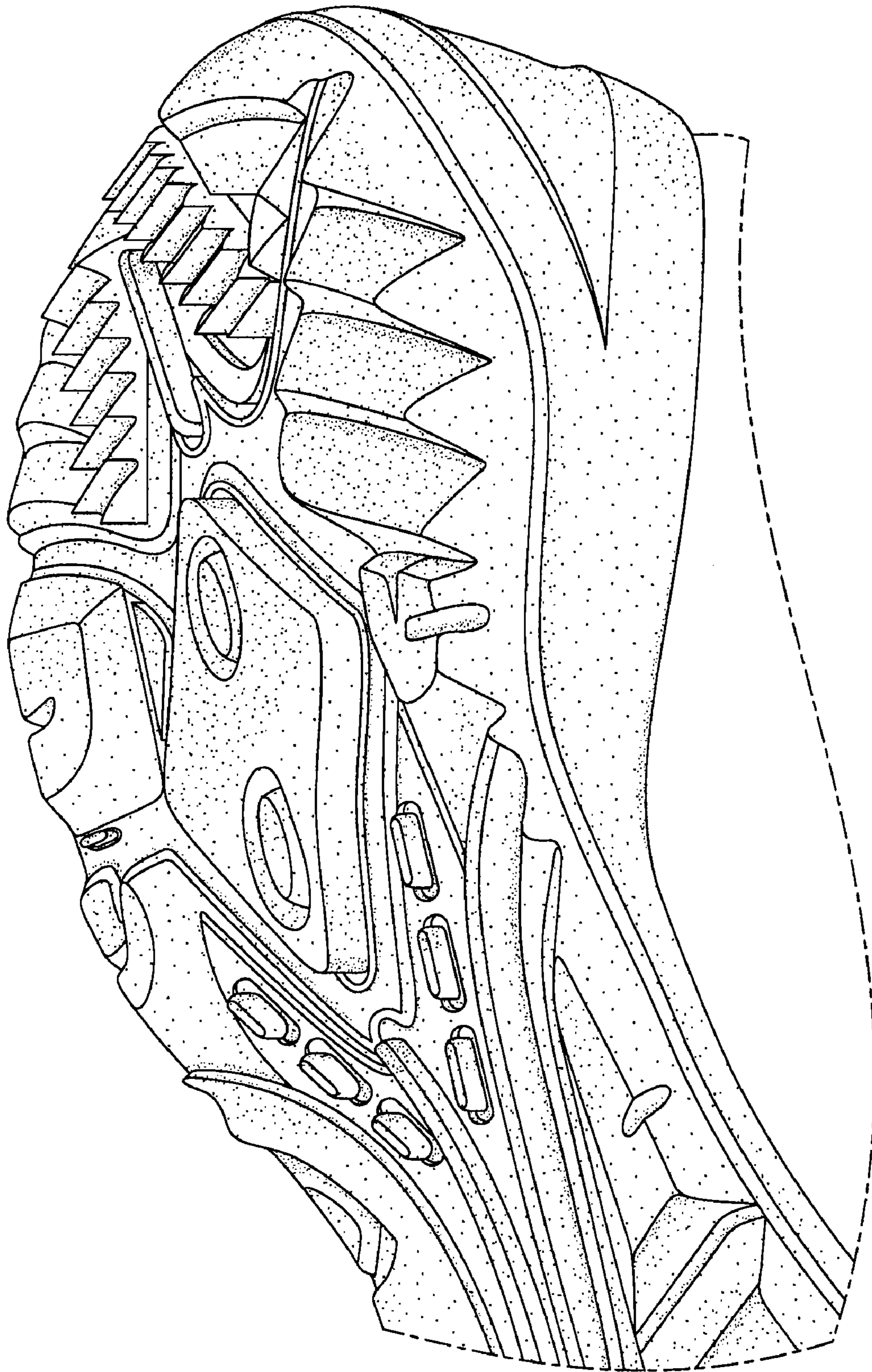
