DESCRIPTION

1;

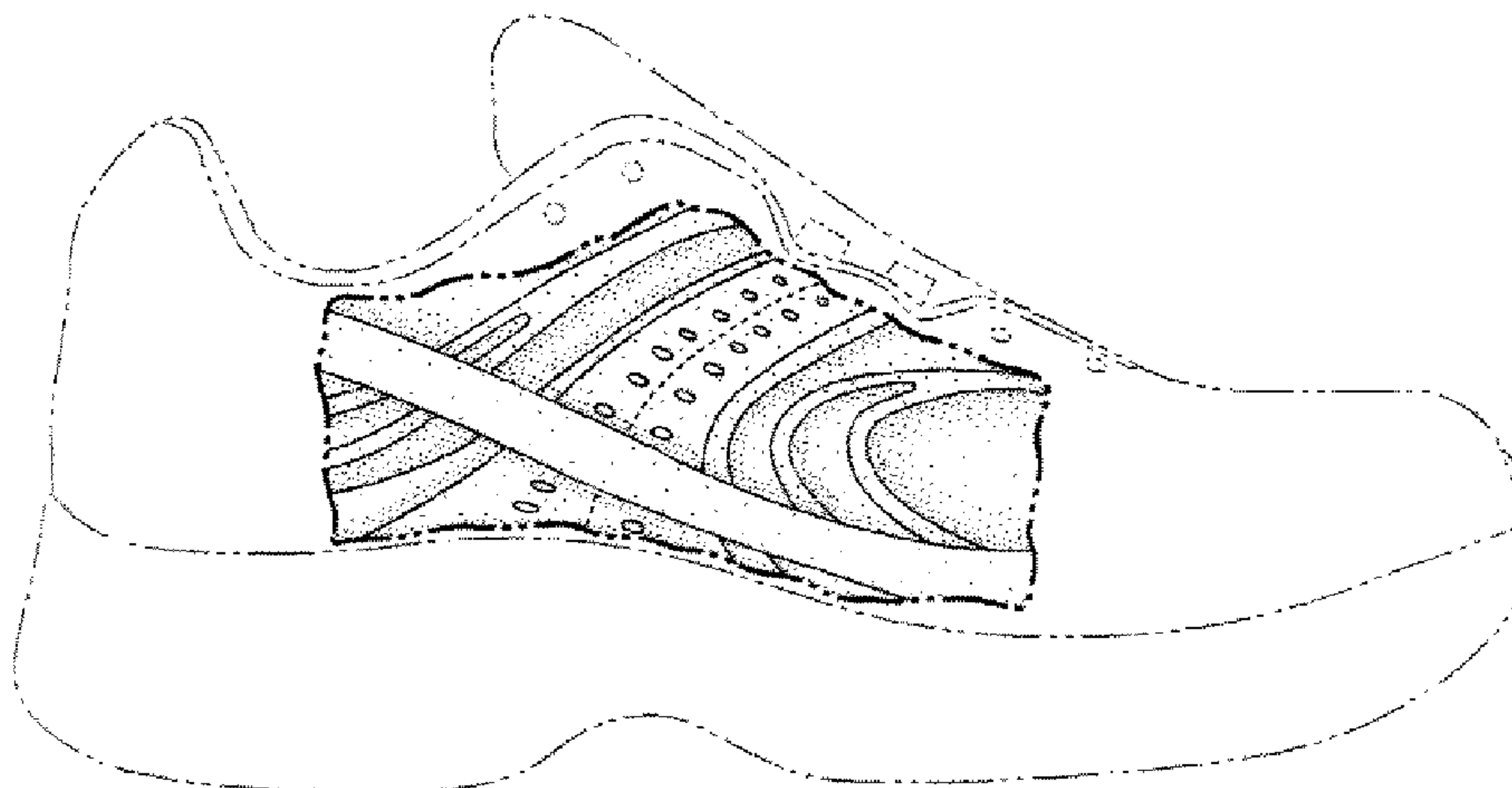
FIG. 3 is a front view of the portion of a shoe upper shown

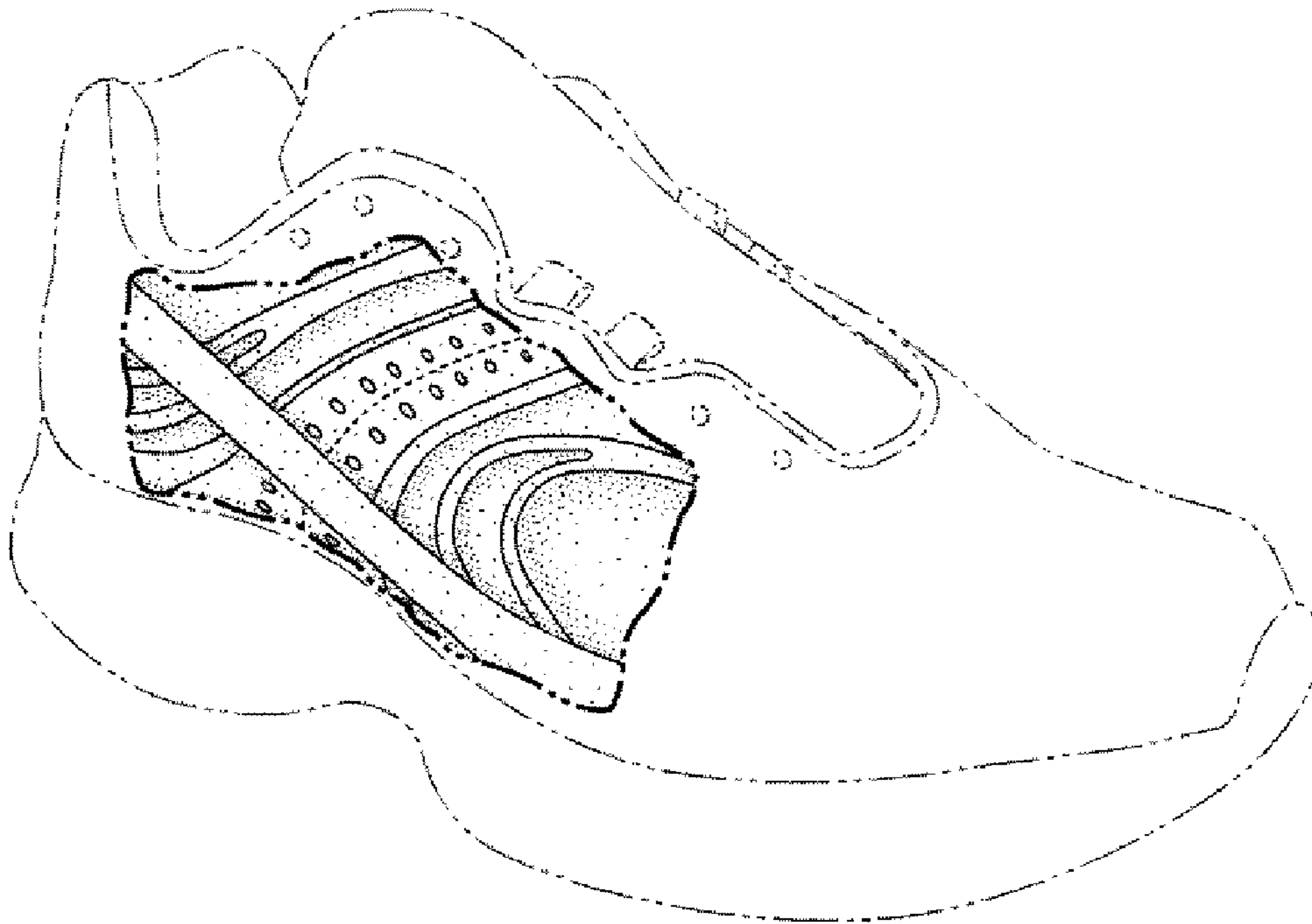

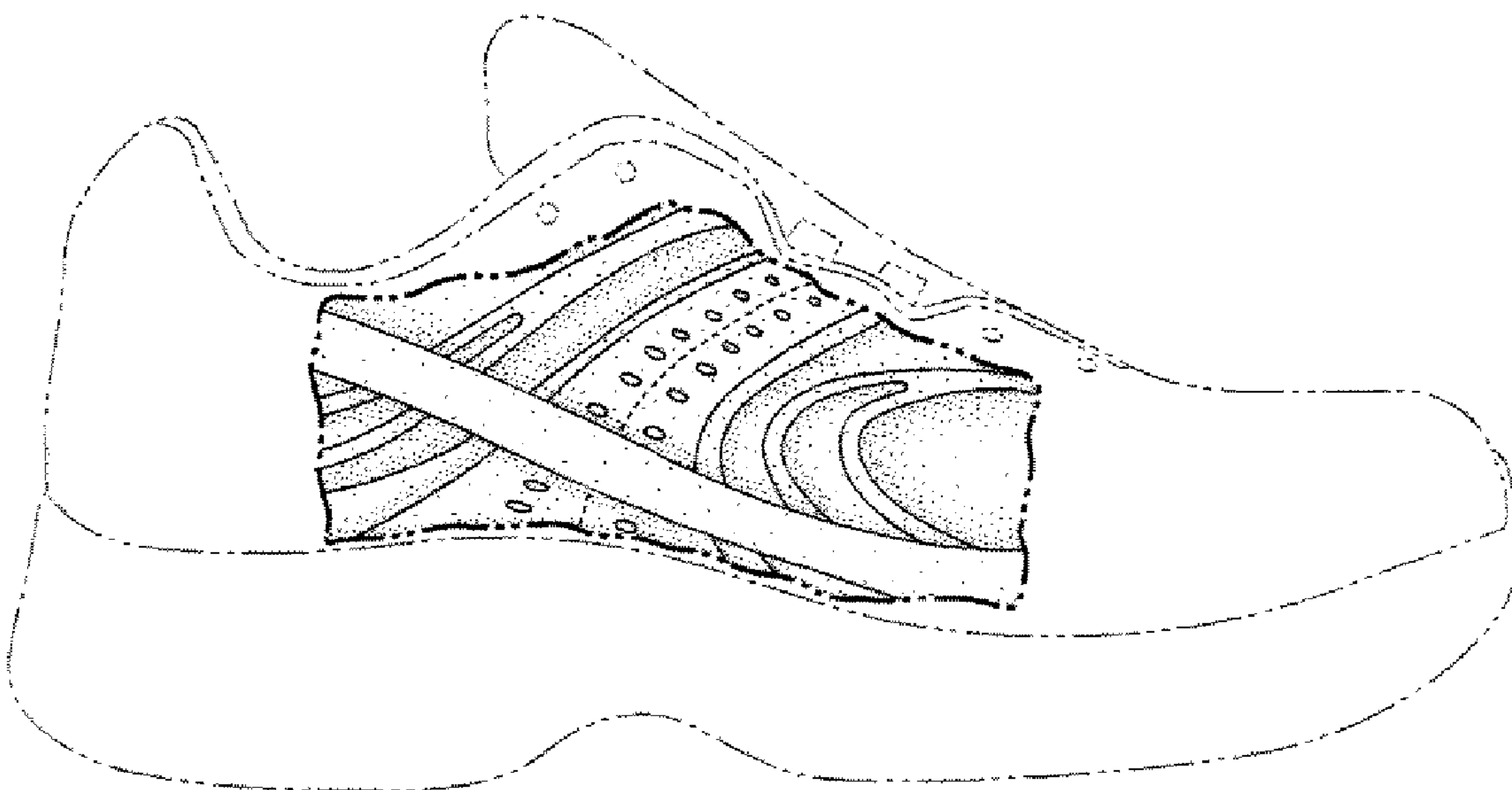

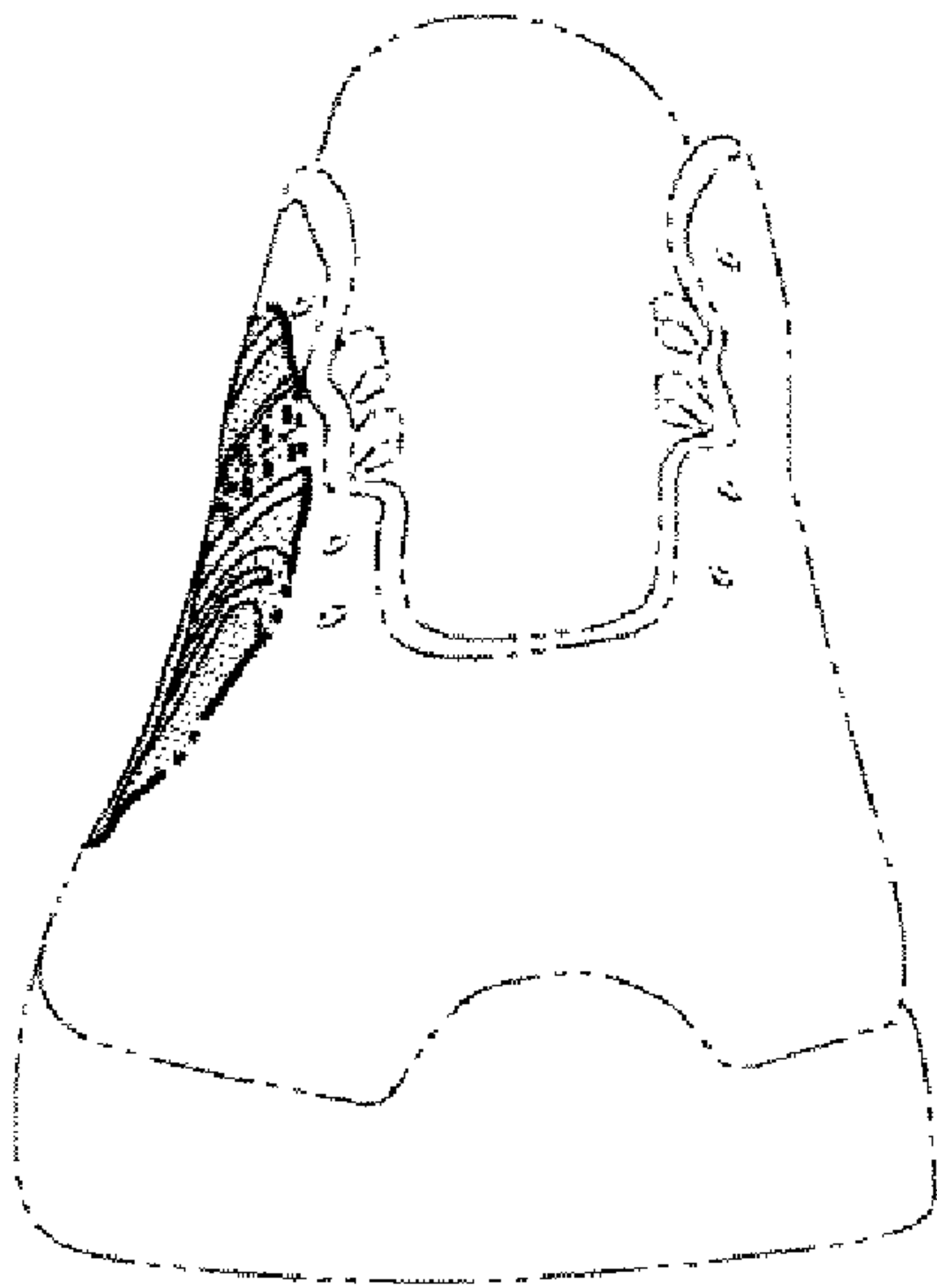

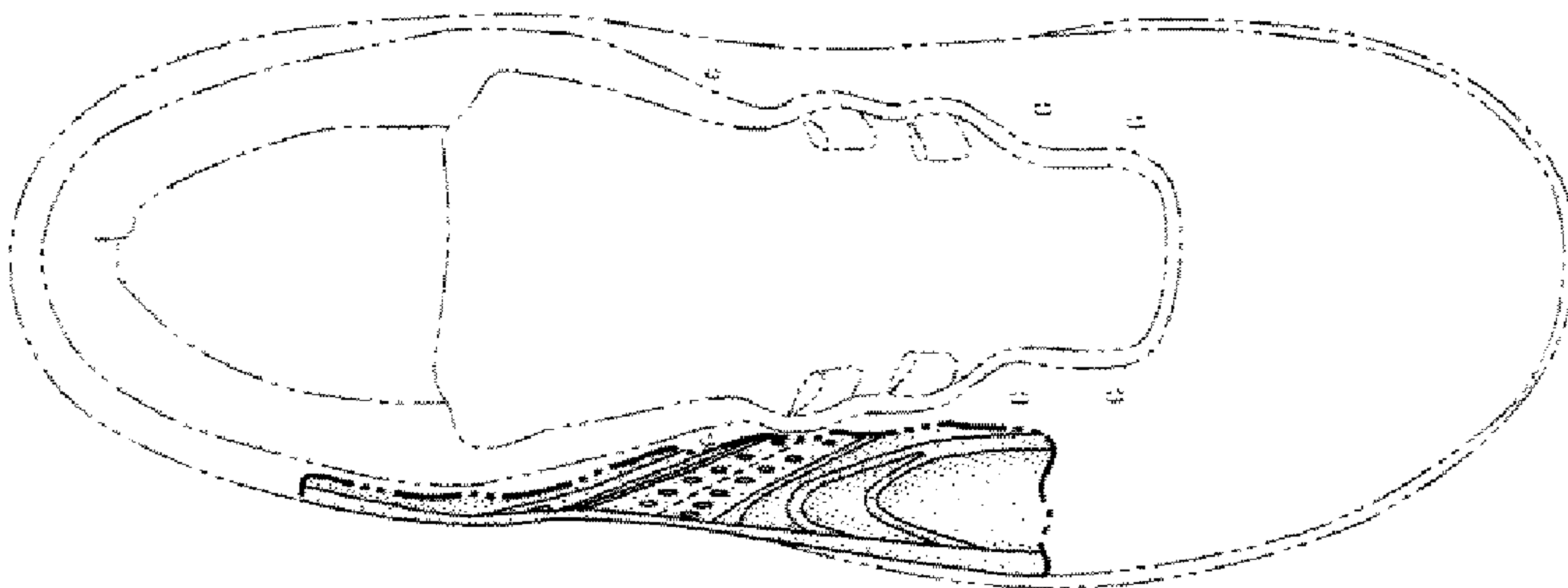
