(57) **CLAIM**

The ornamental design for handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a handbag showing my handbag design;

FIG. 2 is a front view of the handbag shown in FIG. 1;

FIG. 3 is a rear view of the handbag shown in FIG. 1;

FIG. 4 is a right side view of the handbag shown in FIG. 1 (with the left side view being a mirror image thereof);

FIG. 5 is a top view of the handbag shown in FIG. 1;

FIG. 6 is a bottom view of the handbag shown in FIG. 1;

FIG. 7 is a front perspective view of an alternative embodiment of the handbag shown in FIG. 1;

FIG. 8 is a front view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 9 is a rear view of the alternative embodiment of the handbag shown in FIG. 8;

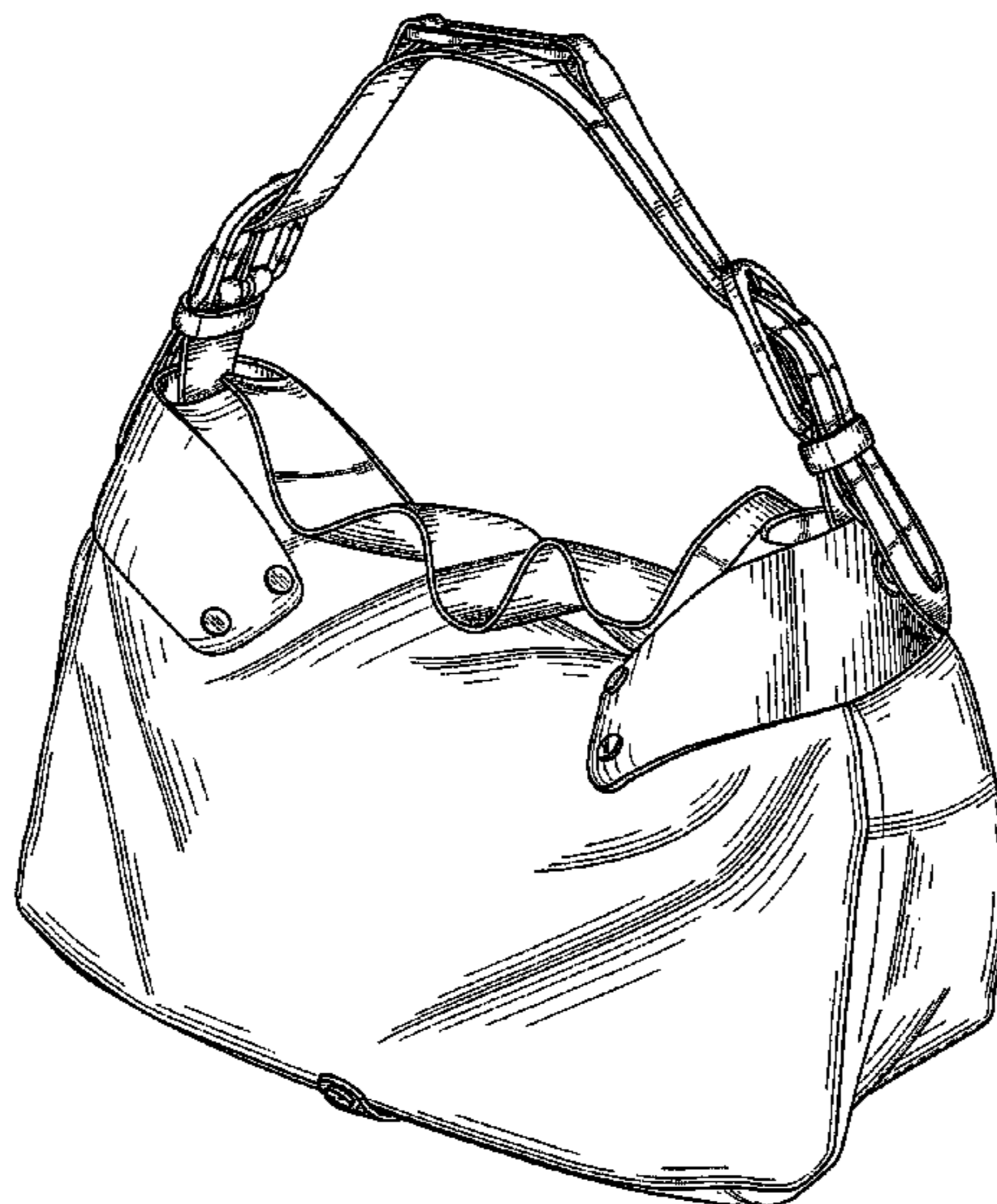
FIG. 10 is a right side view of the alternative embodiment of the handbag shown in FIG. 8 (with the left side view being a mirror image thereof);

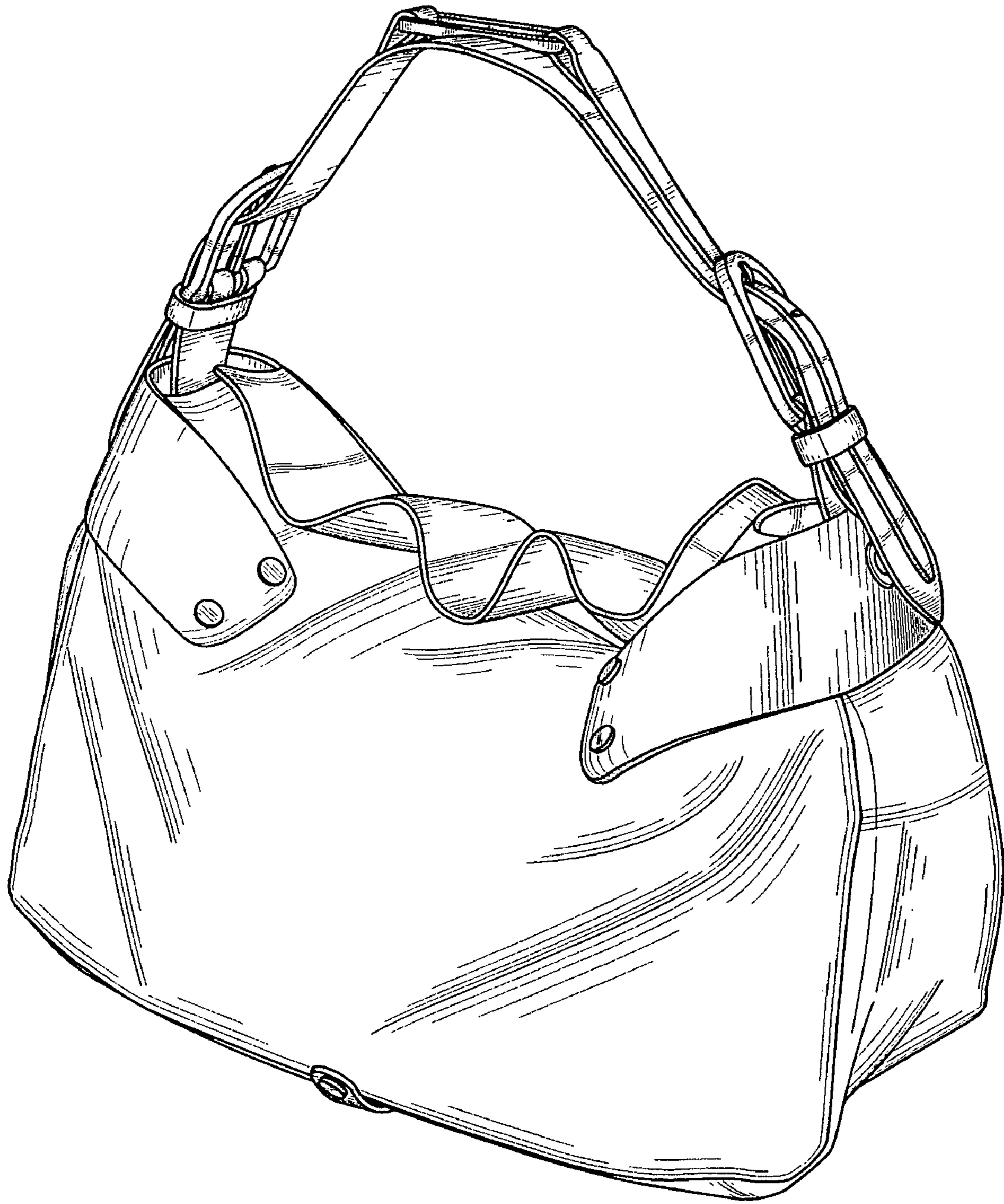

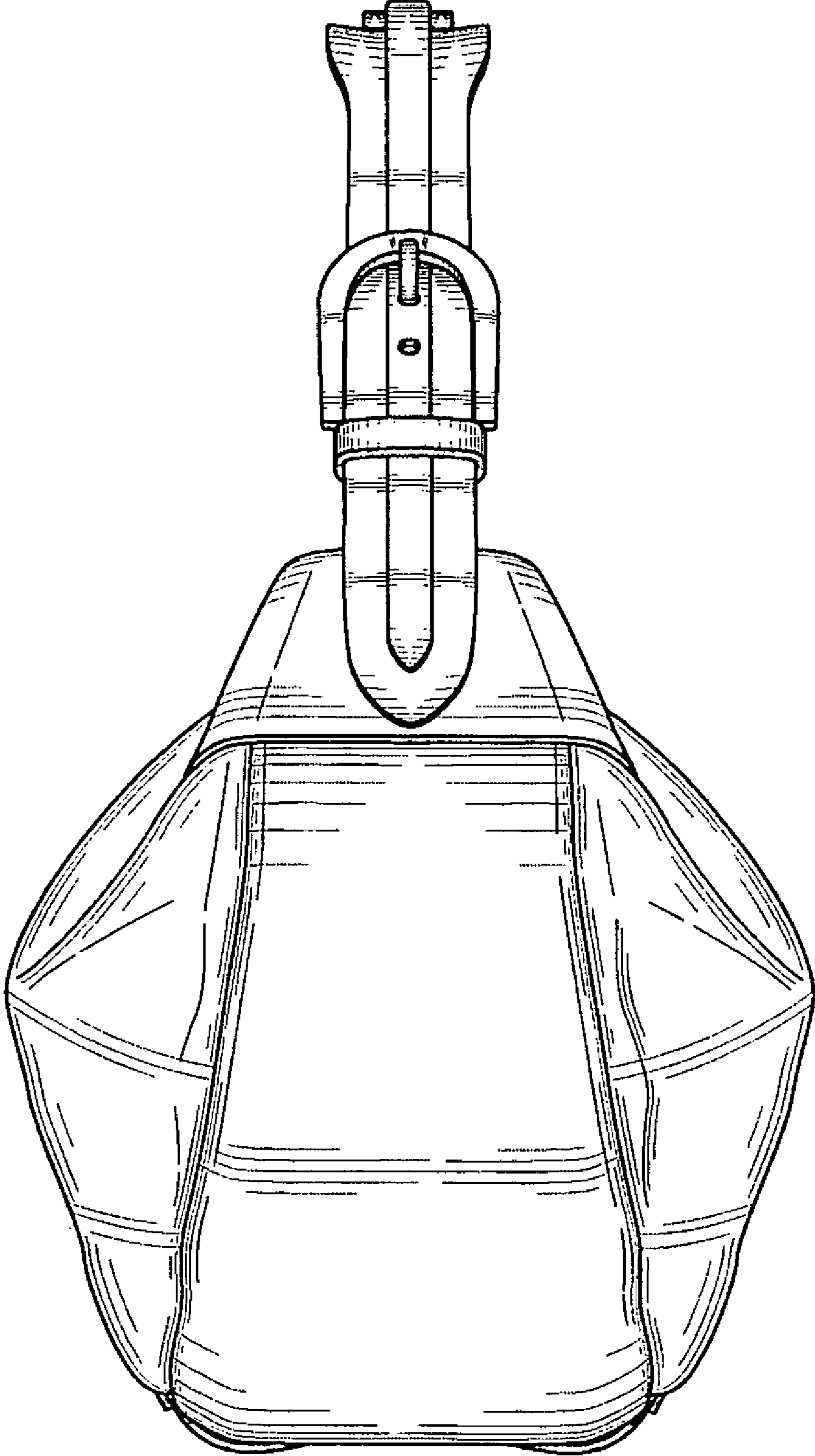

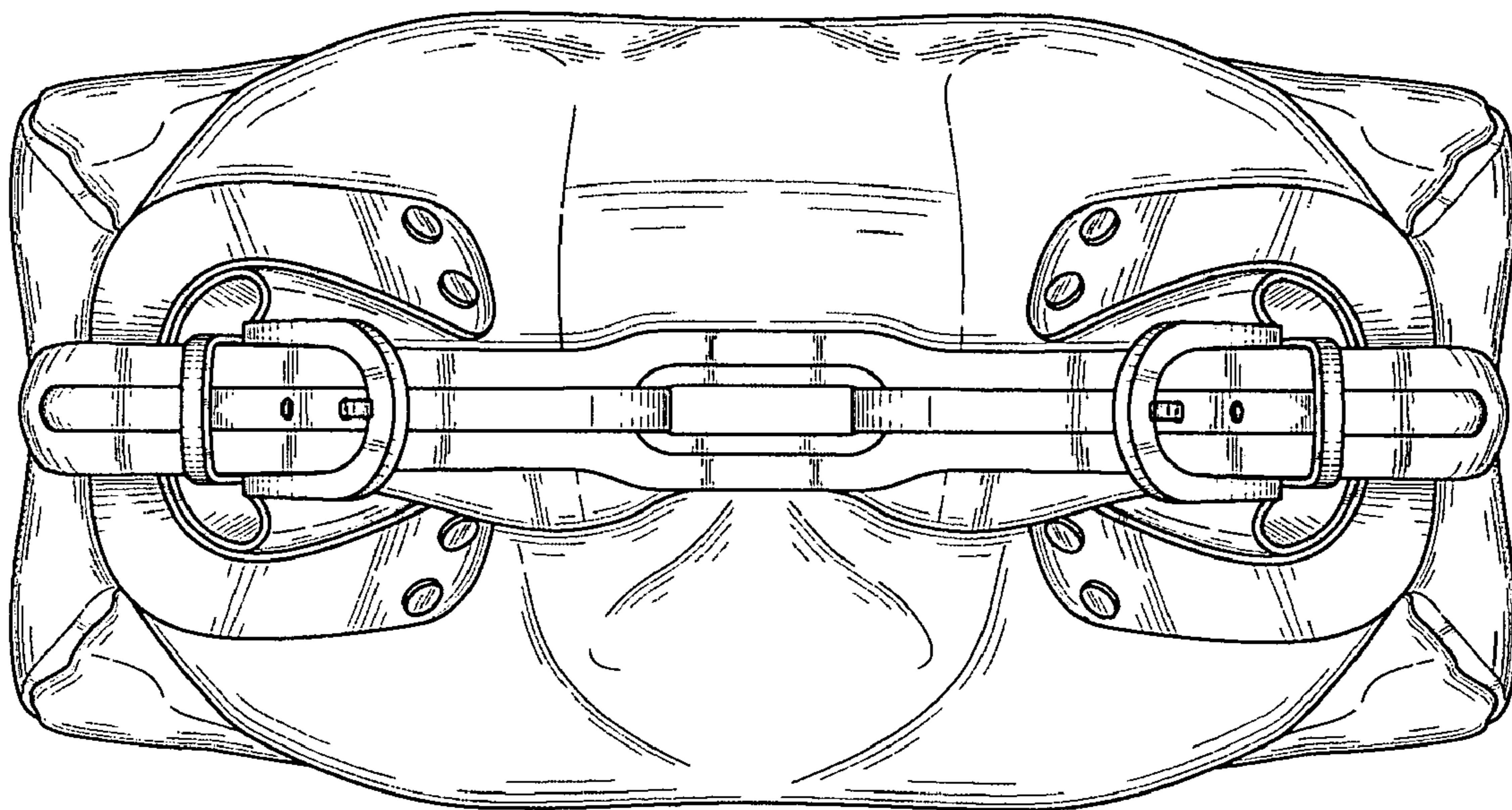

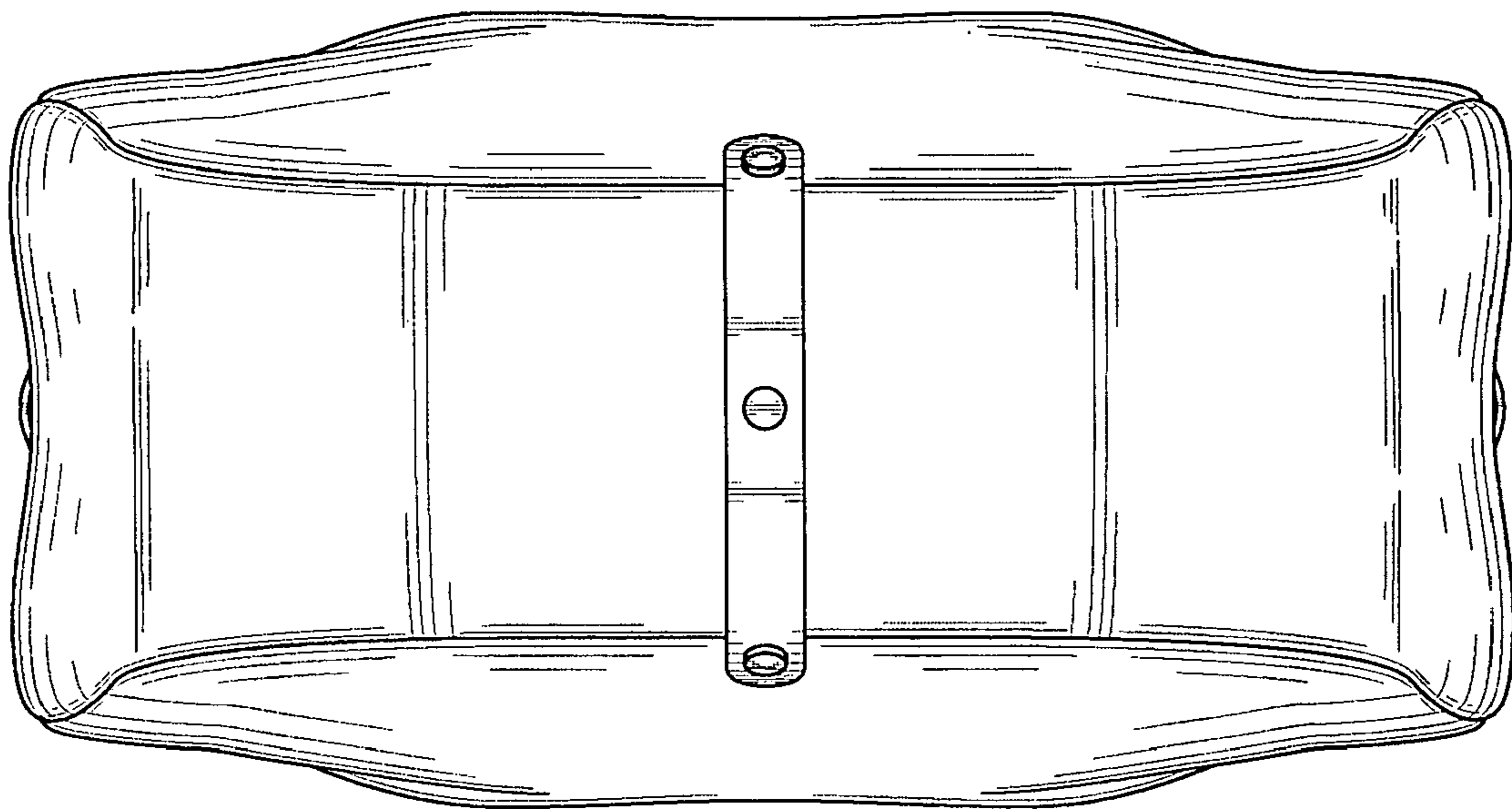

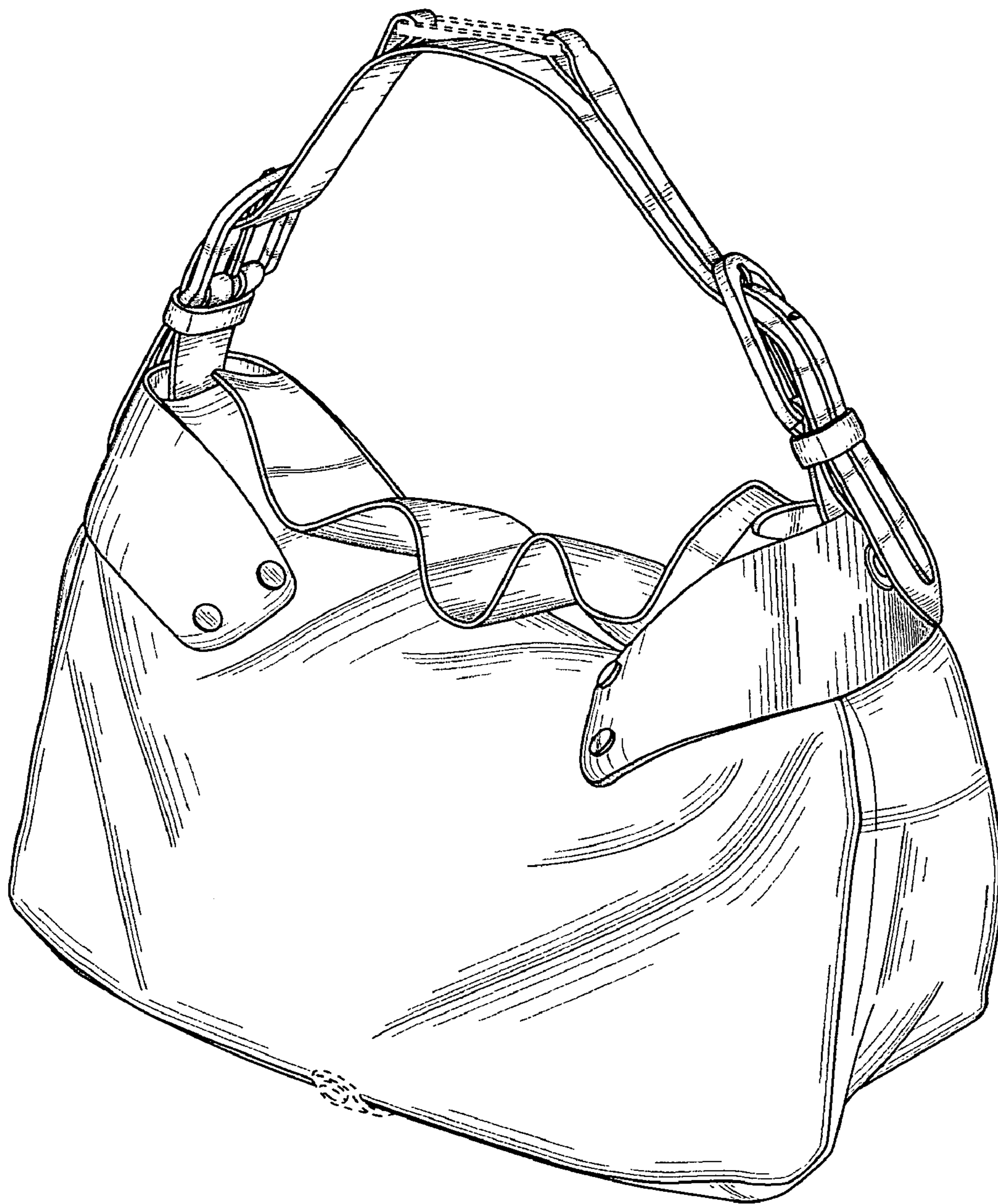

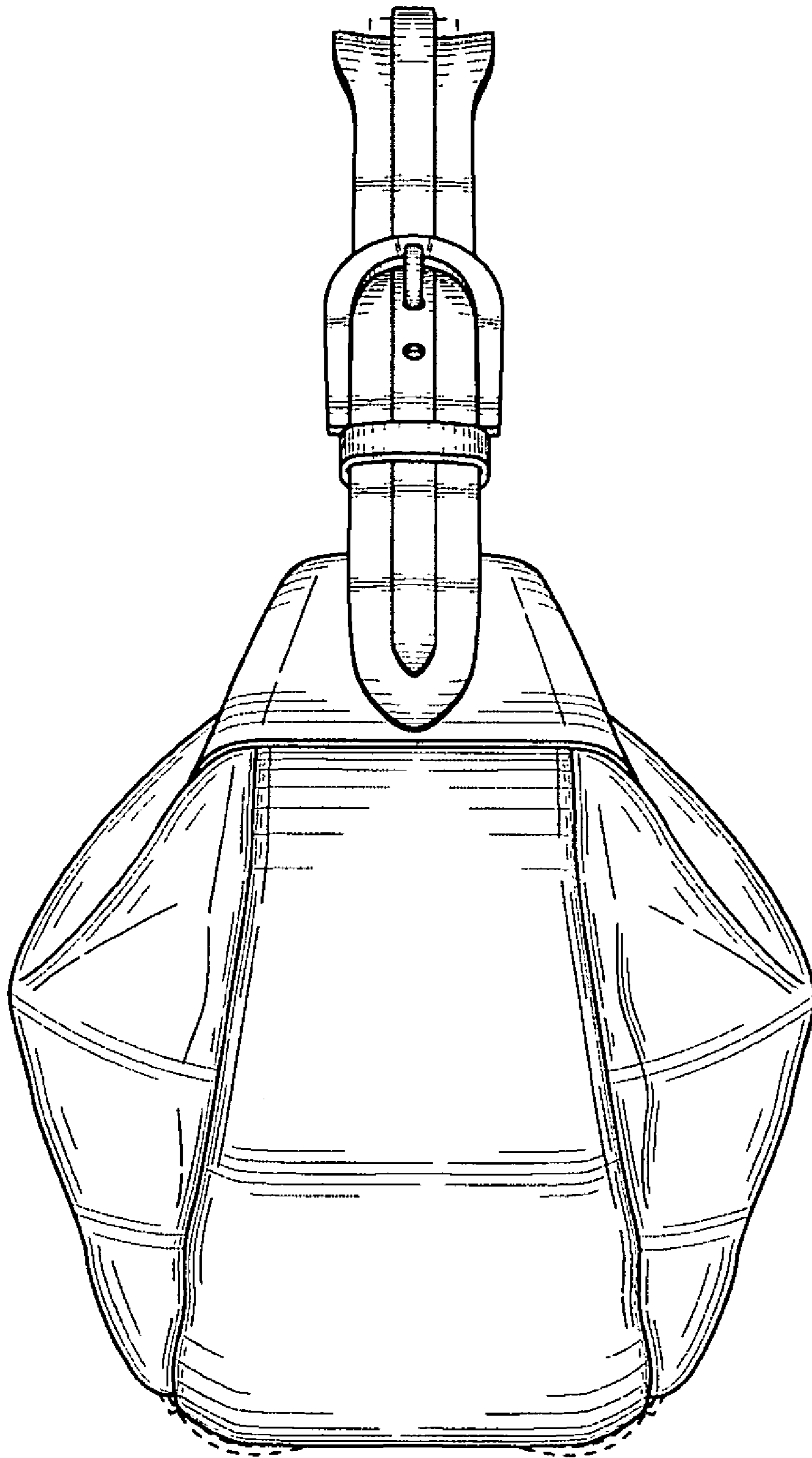

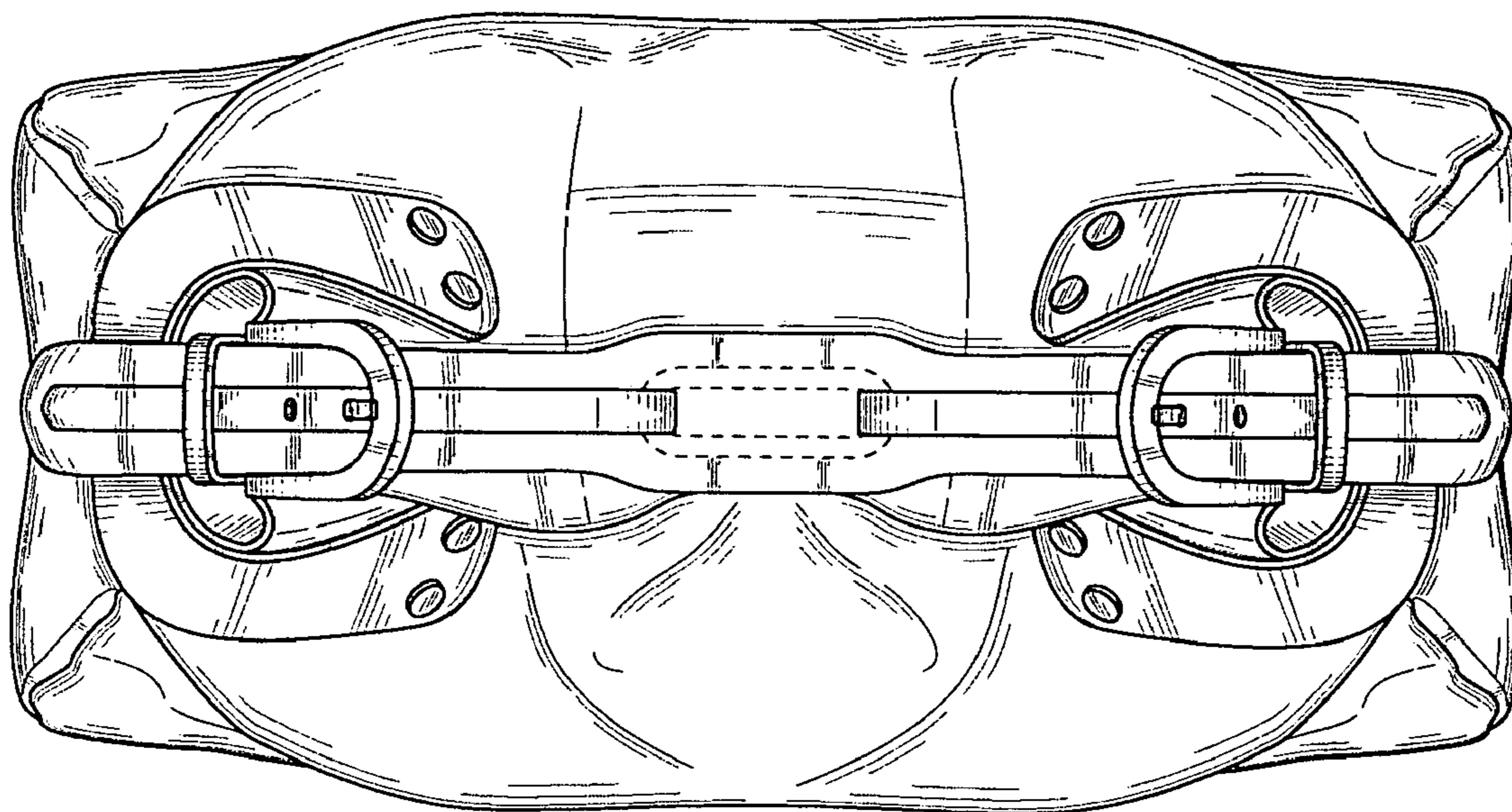

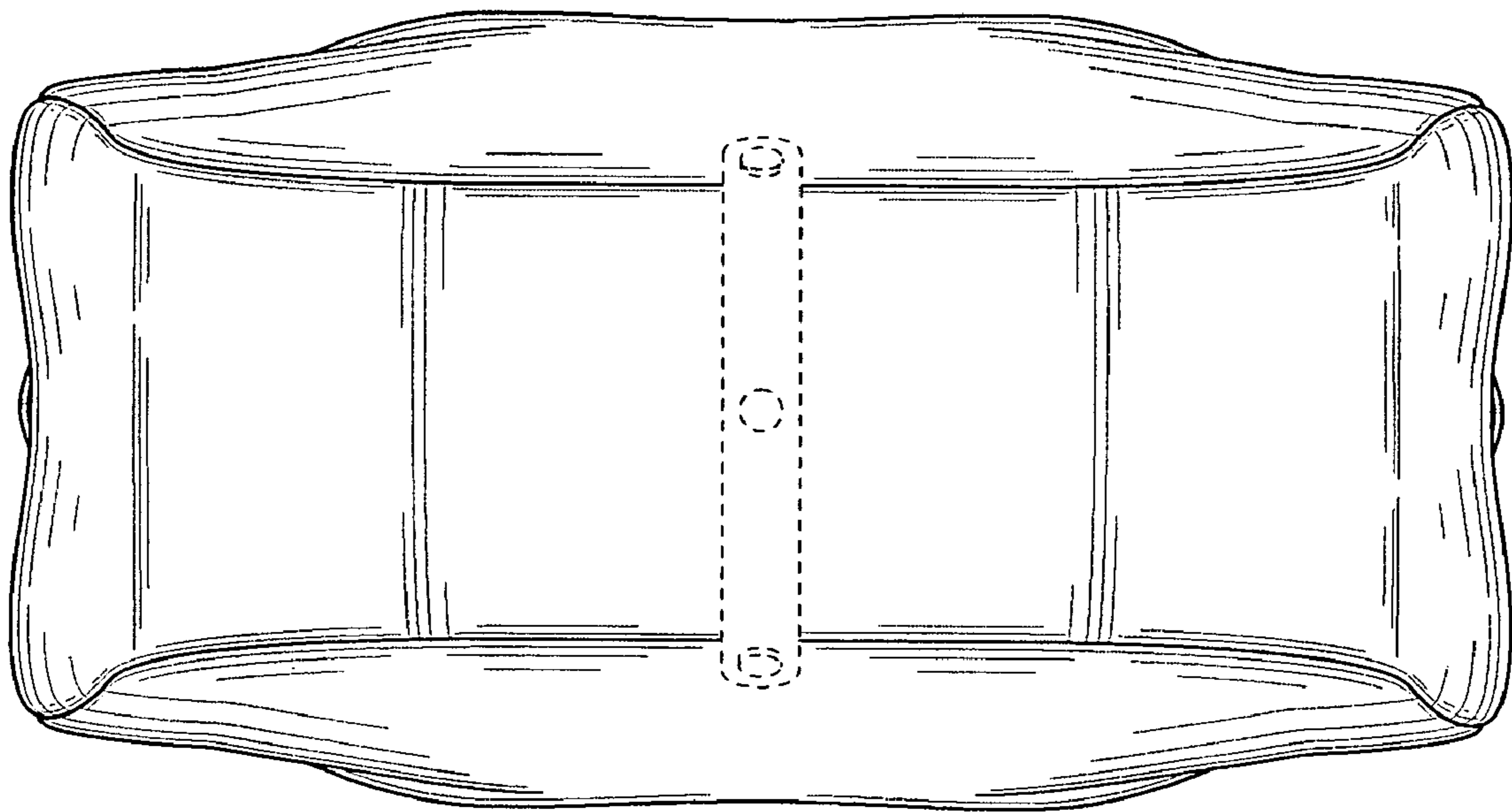
