(57) **CLAIM**

The ornamental design for handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new handbag design;

FIG. 2 is a front view of the handbag shown in FIG. 1;

FIG. 3 is a rear view of the handbag shown in FIG. 1;

FIG. 4 is a left side view of the handbag shown in FIG. 1, (with the right side view being a mirror image thereof);

FIG. 5 is a top view of the handbag shown in FIG. 1;

FIG. 6 is a bottom view of the handbag shown in FIG. 1;

FIG. 7 is a front perspective view of an alternative embodiment of the handbag shown in FIG. 1;

FIG. 8 is a front view of the alternative embodiment of the handbag shown in FIG. 7;

FIG. 9 is a rear view of the alternative embodiment of the handbag shown in FIG. 7;

FIG. 10 is a left side view of the alternative embodiment of the handbag shown in FIG. 7 (with the right side view being a mirror image thereof);

FIG. 11 is a top view of the alternative embodiment of the handbag shown in FIG. 7;

FIG. 12 is a bottom view of the alternative embodiment of the handbag shown in FIG. 7;

FIG. 13 is front perspective view of another alternative embodiment of the handbag shown in FIG. 1;

FIG. 14 is a front view of the alternative embodiment of the handbag shown in FIG. 13;

FIG. 15 is a rear view of the alternative embodiment of the handbag shown in FIG. 13;

FIG. 16 is a left side view of the alternative embodiment of the handbag shown in FIG. 13 (with the right side view being a mirror image thereof);

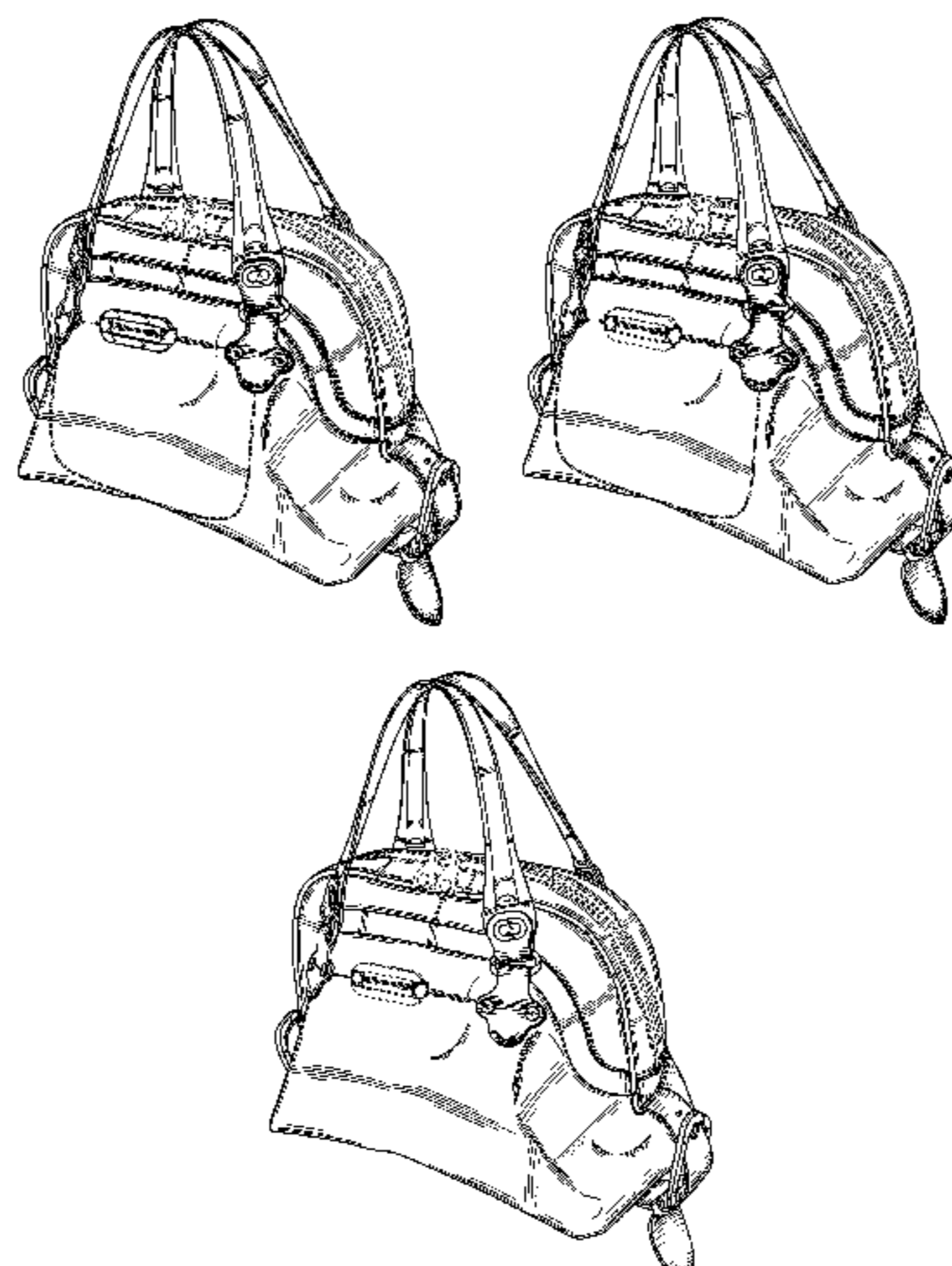
FIG. 17 is a top view of the alternative embodiment of the handbag shown in FIG. 13; and,

FIG. 18 is a bottom view of the alternative embodiment of the handbag shown in FIG. 13.

The dotted lines other than those representing the central elliptical ring, zipper, zipper track, and zipper pull are understood to represent stitching.

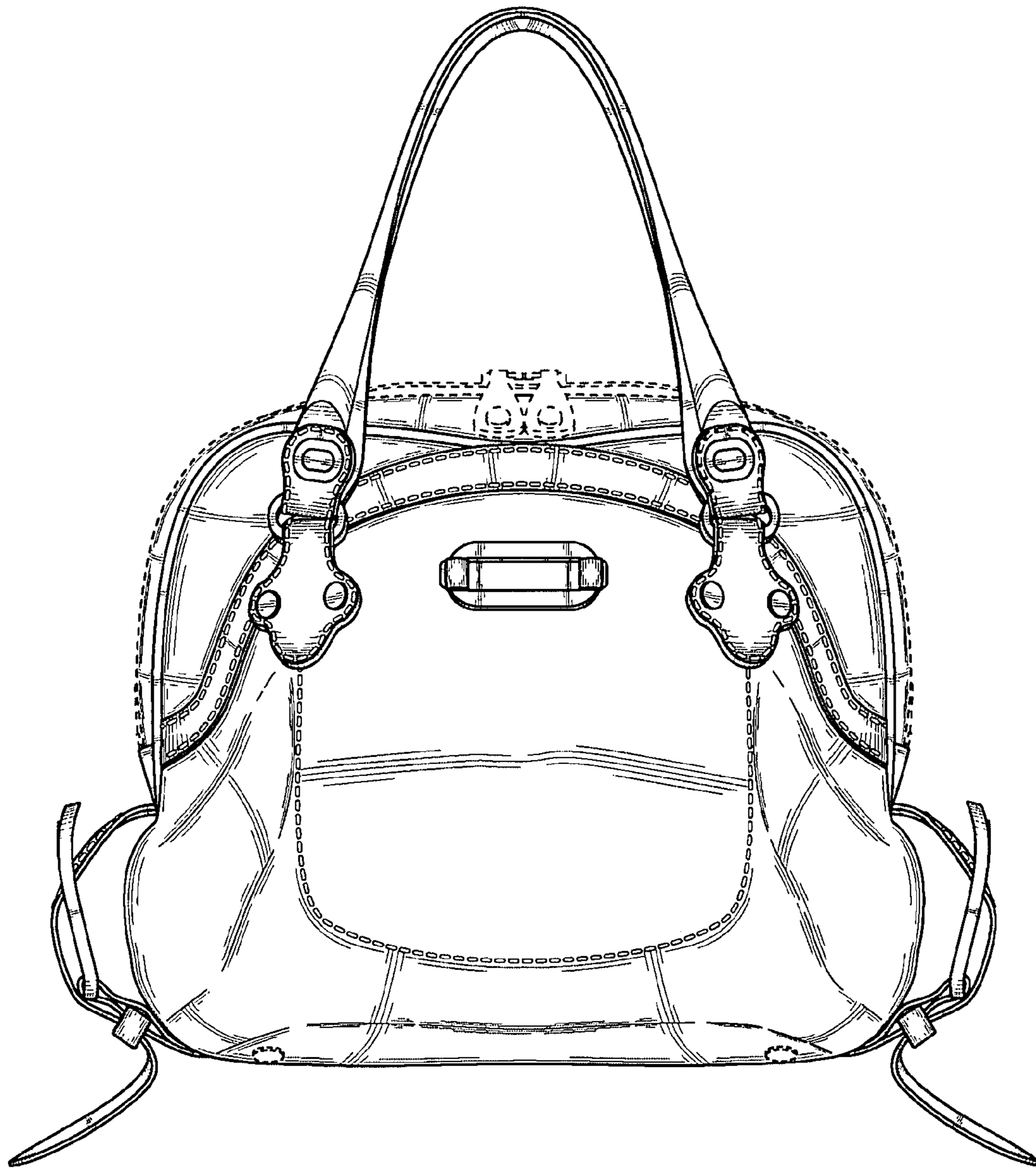

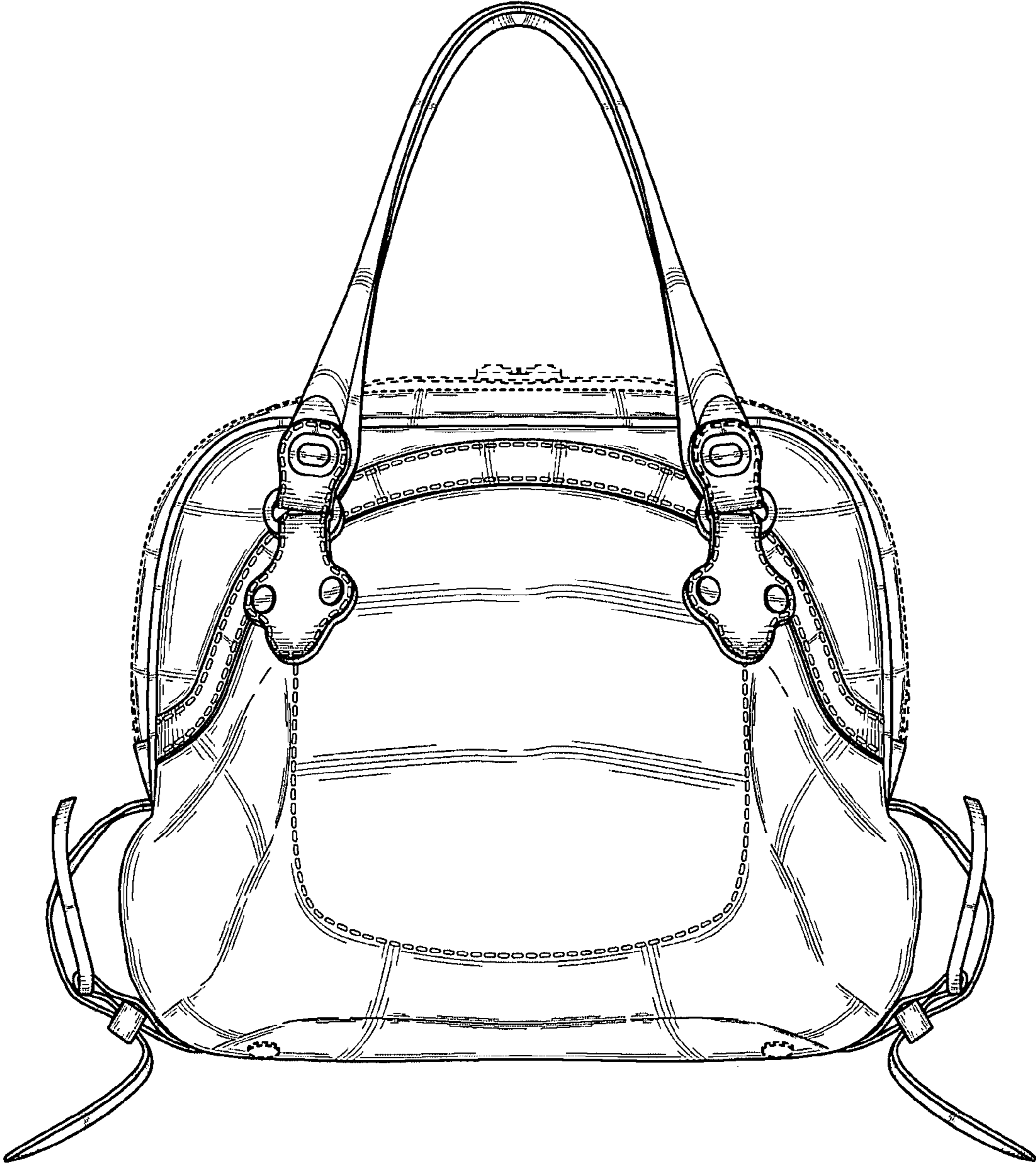

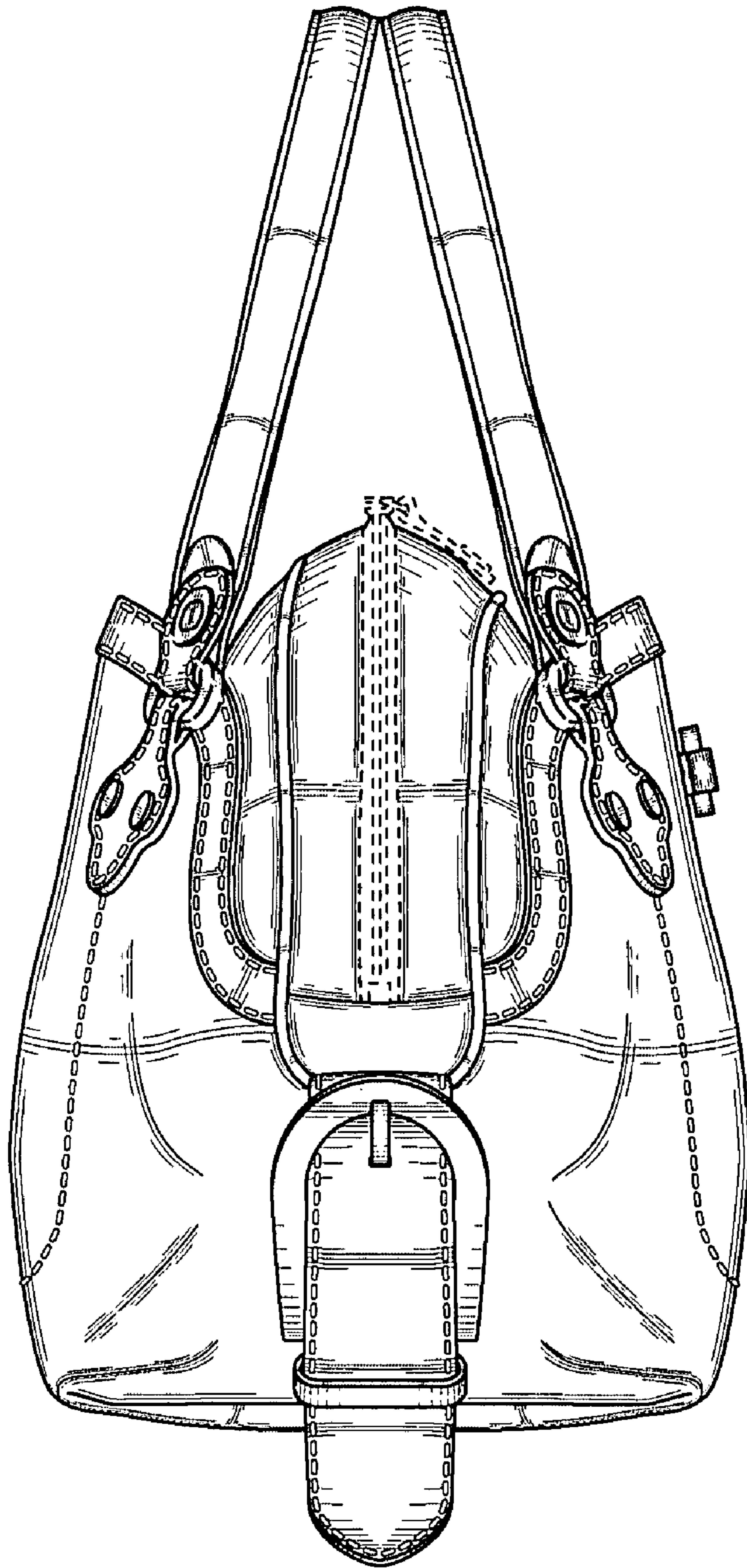

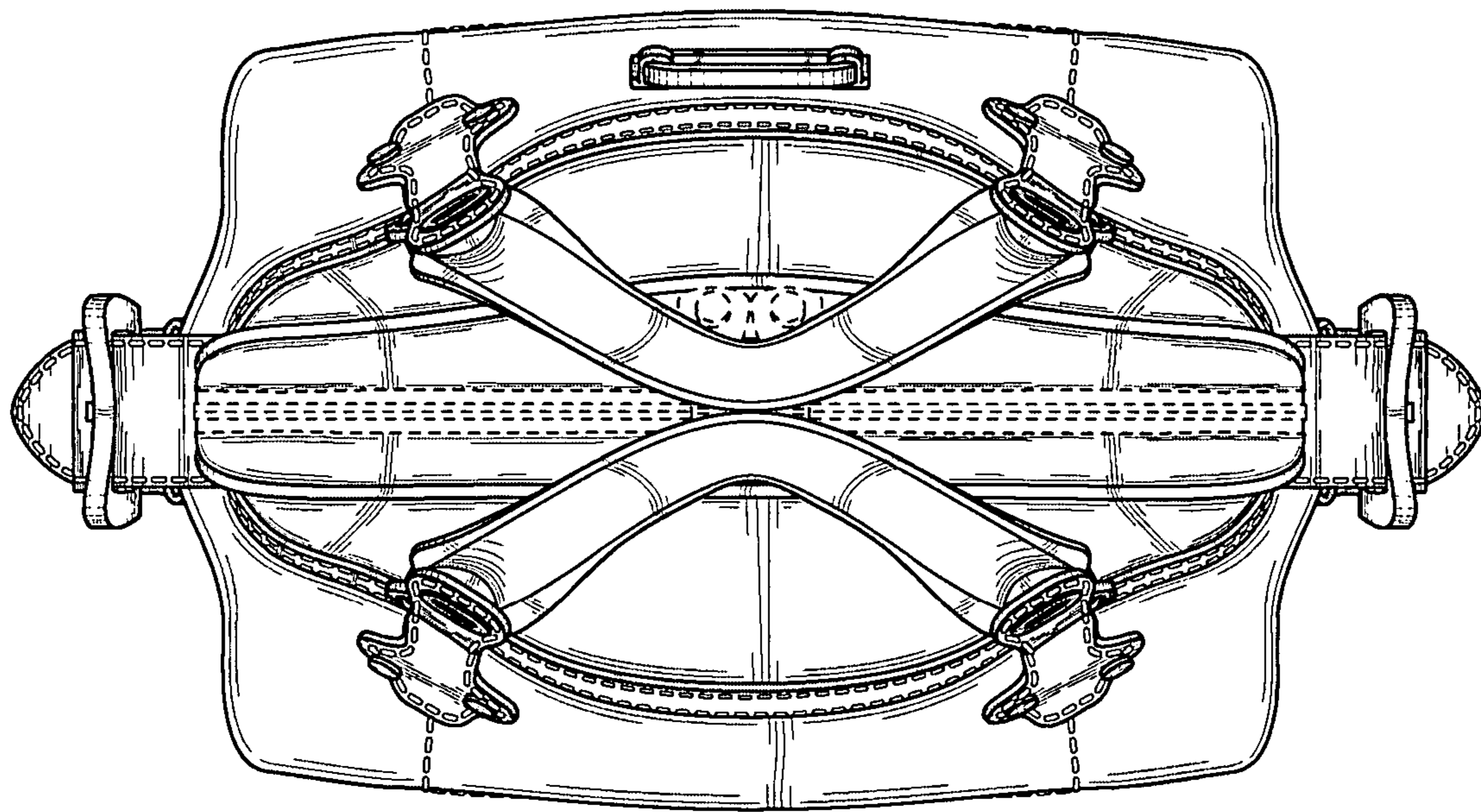

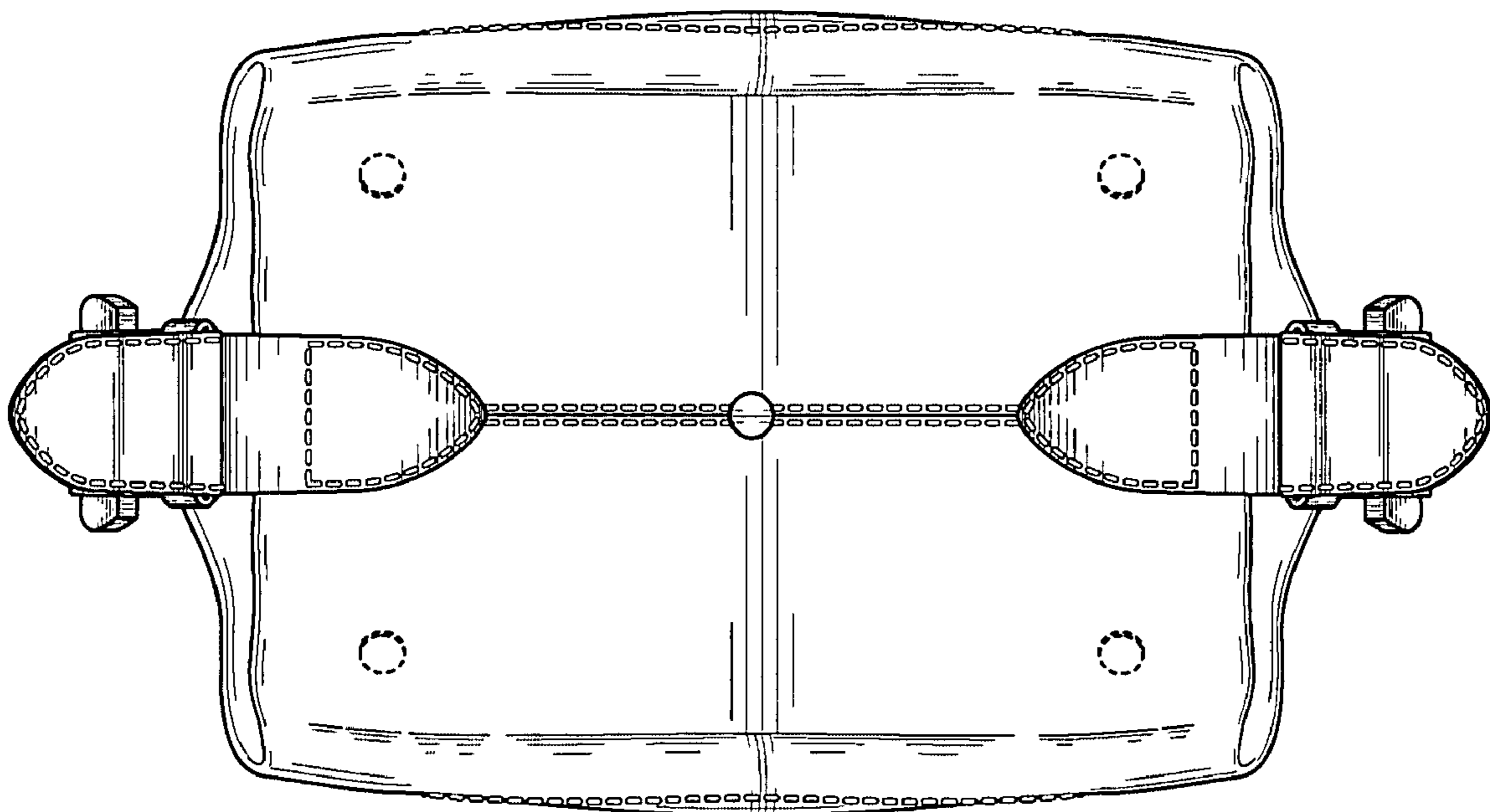

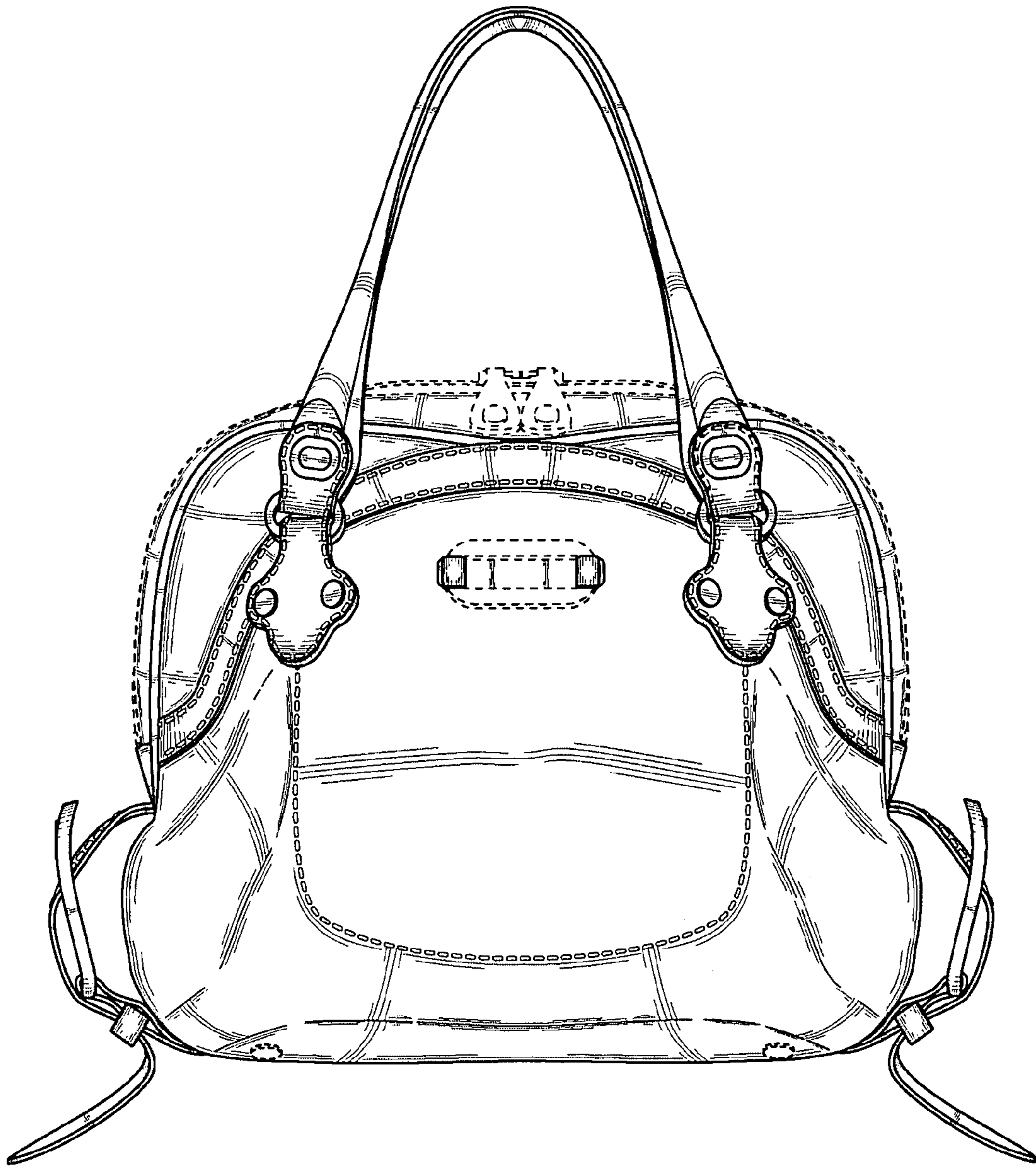

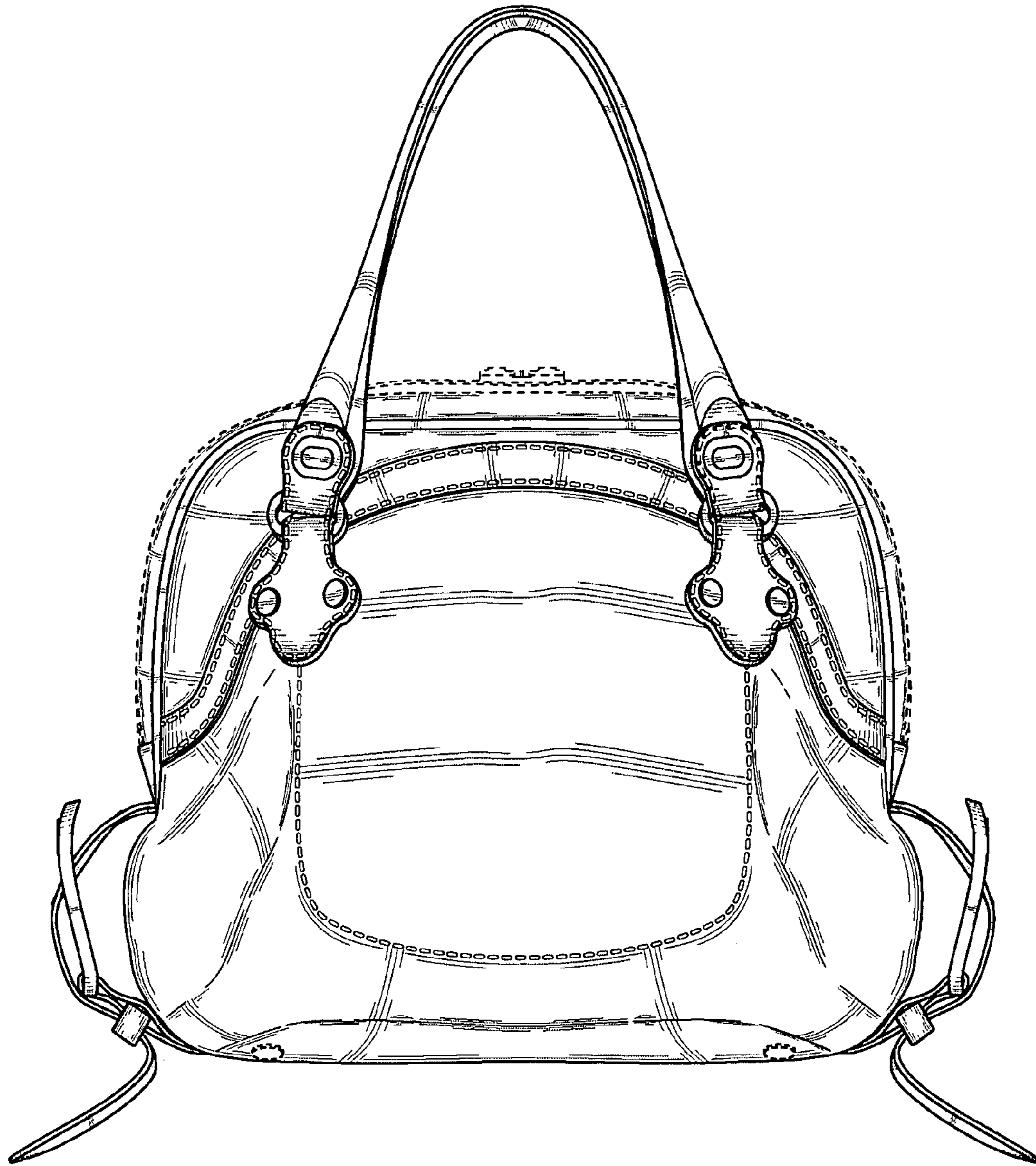

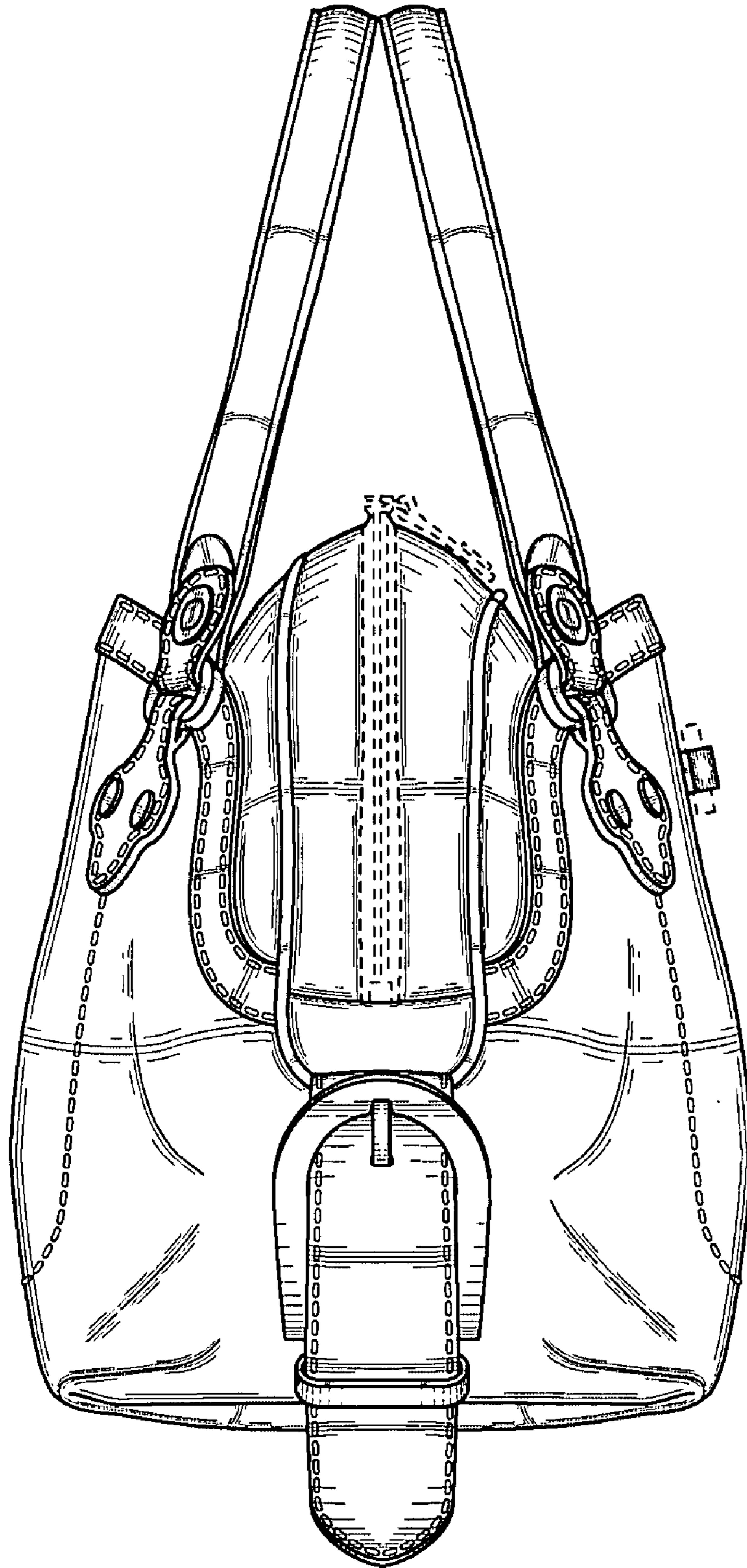

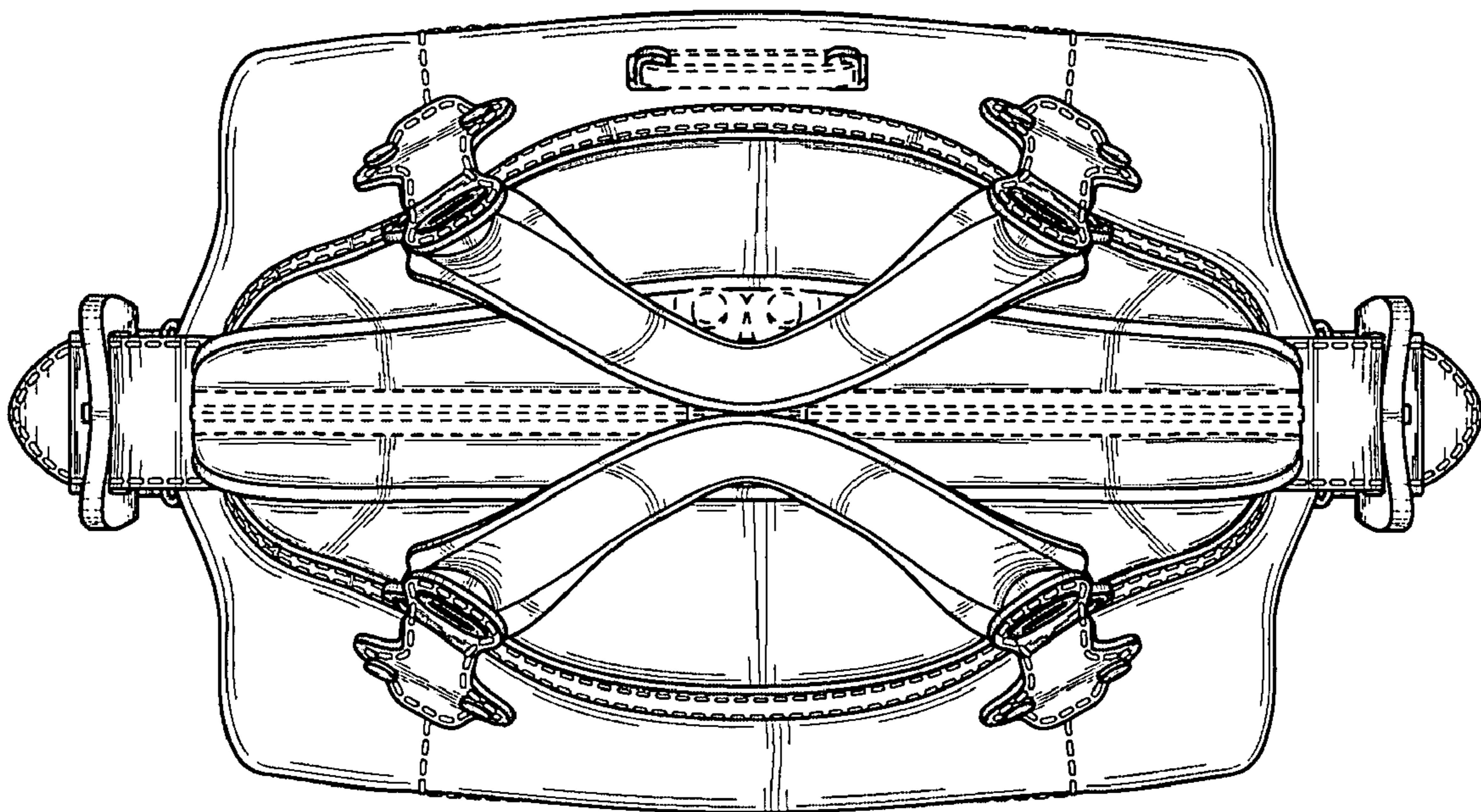

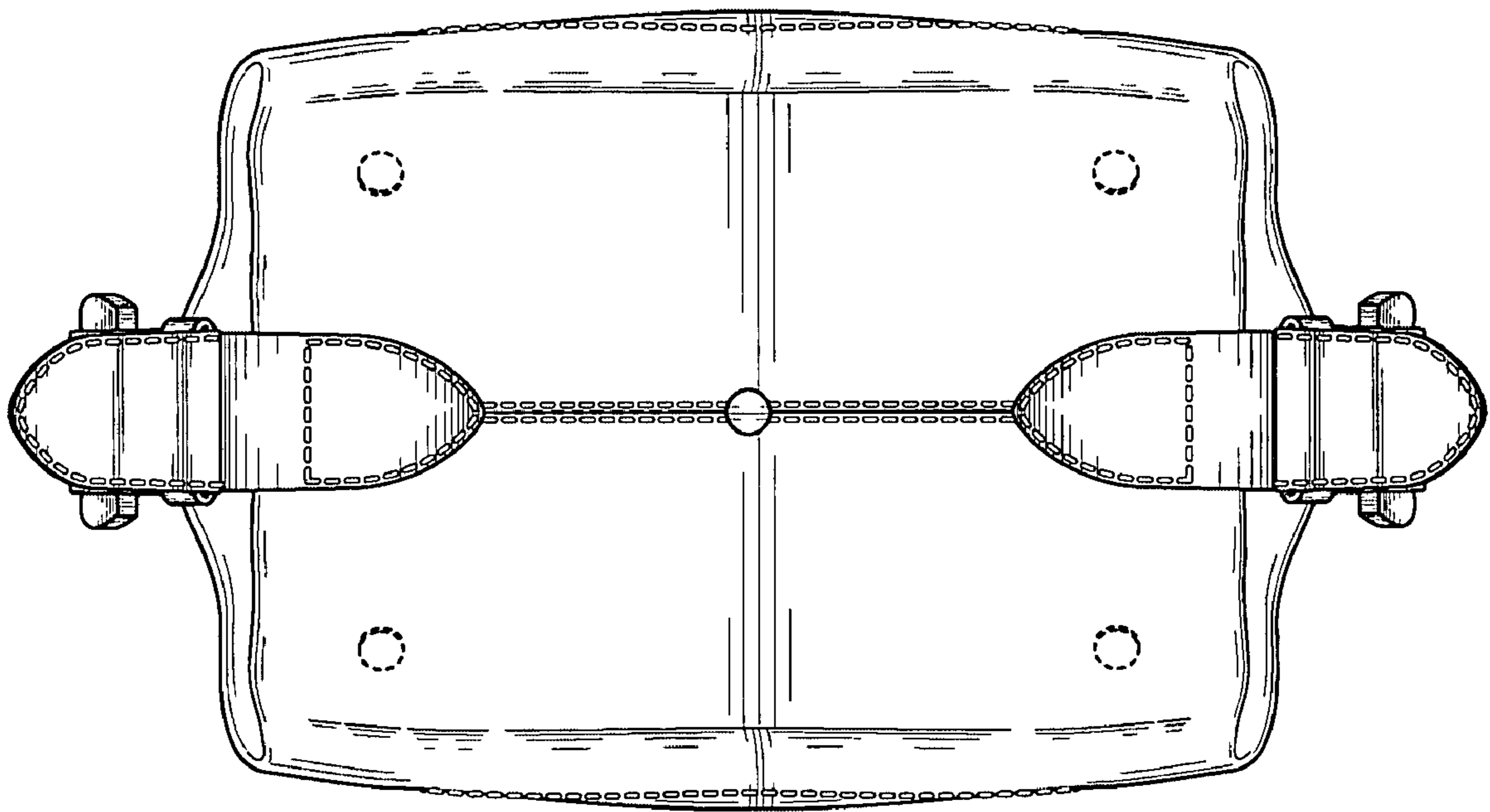

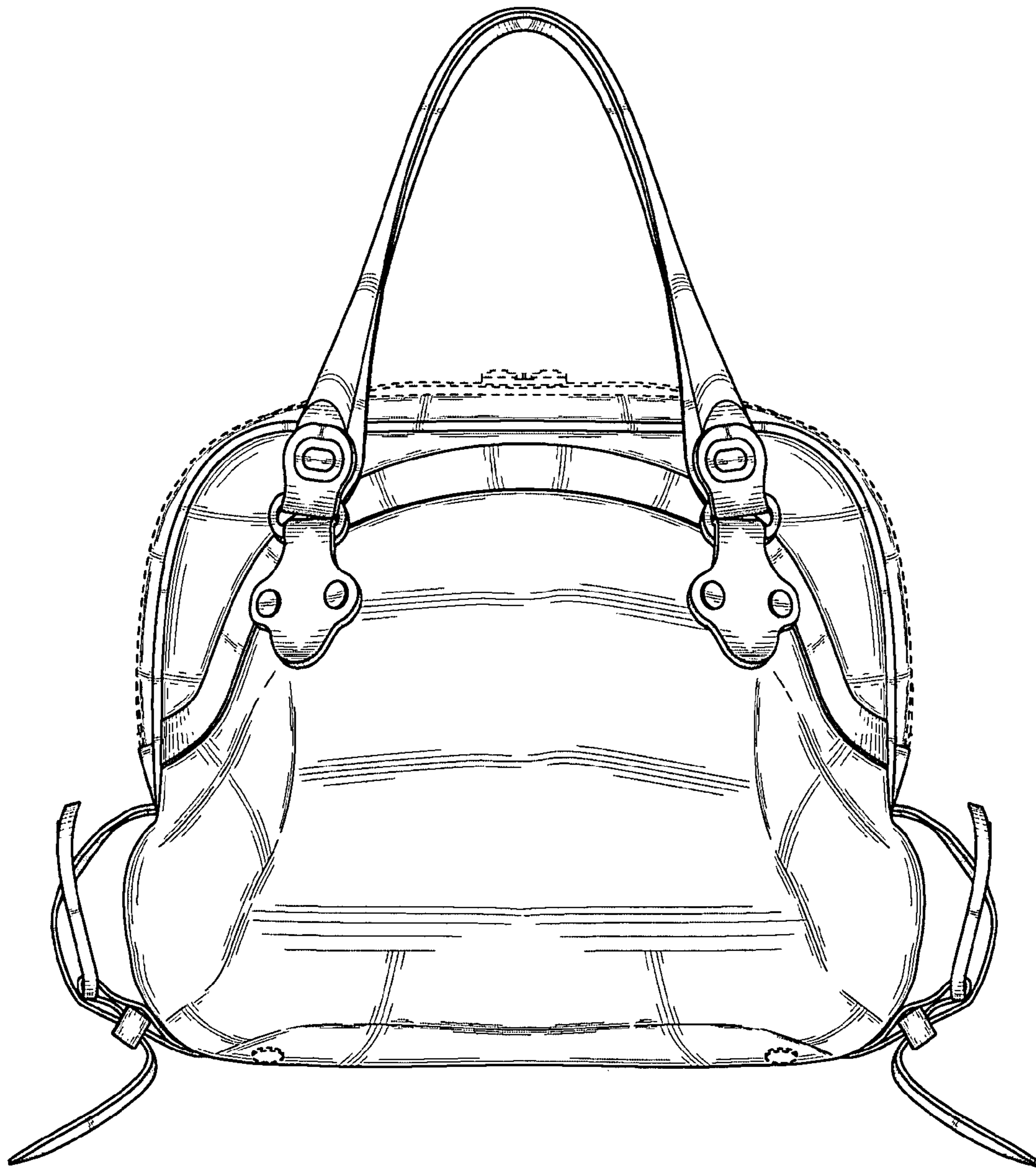

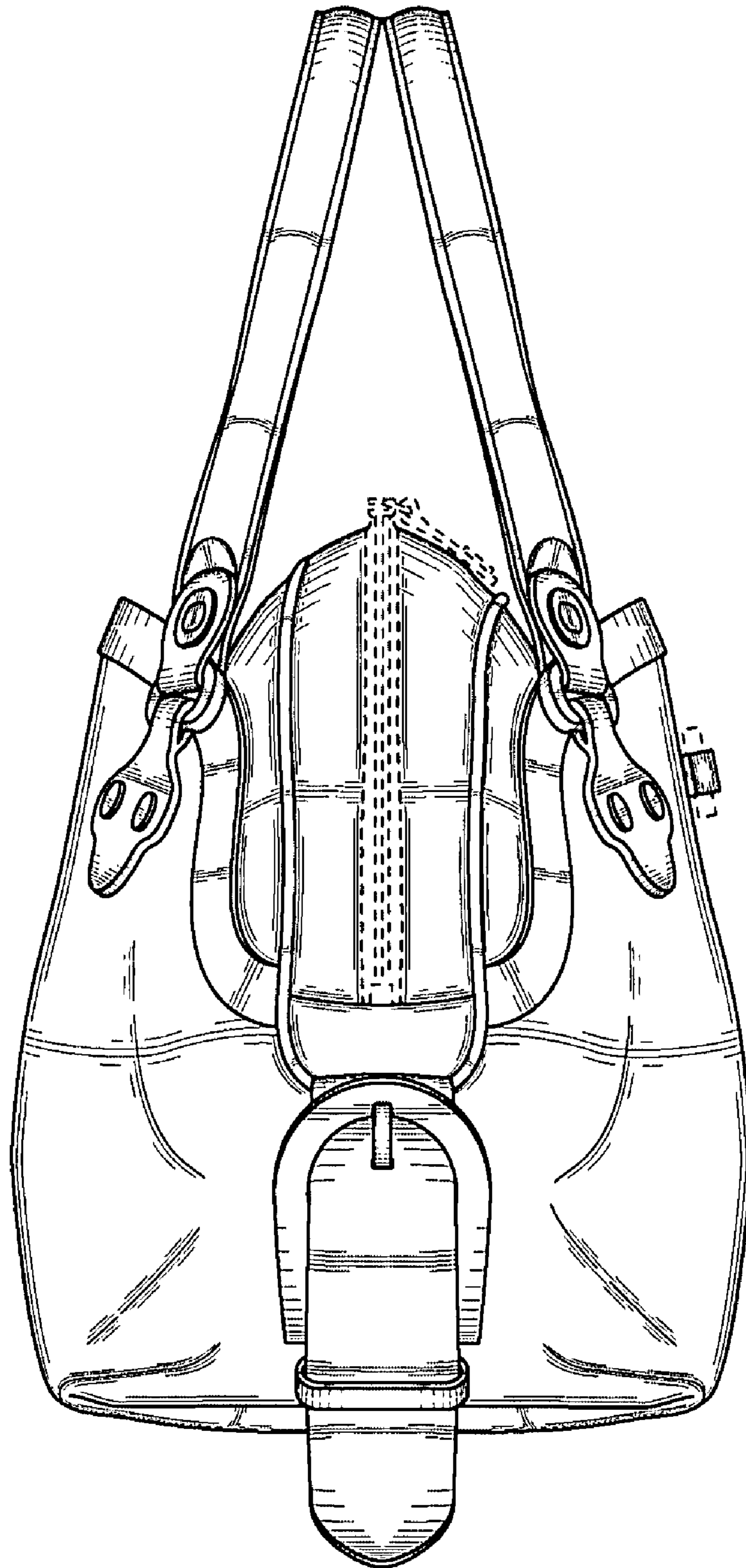

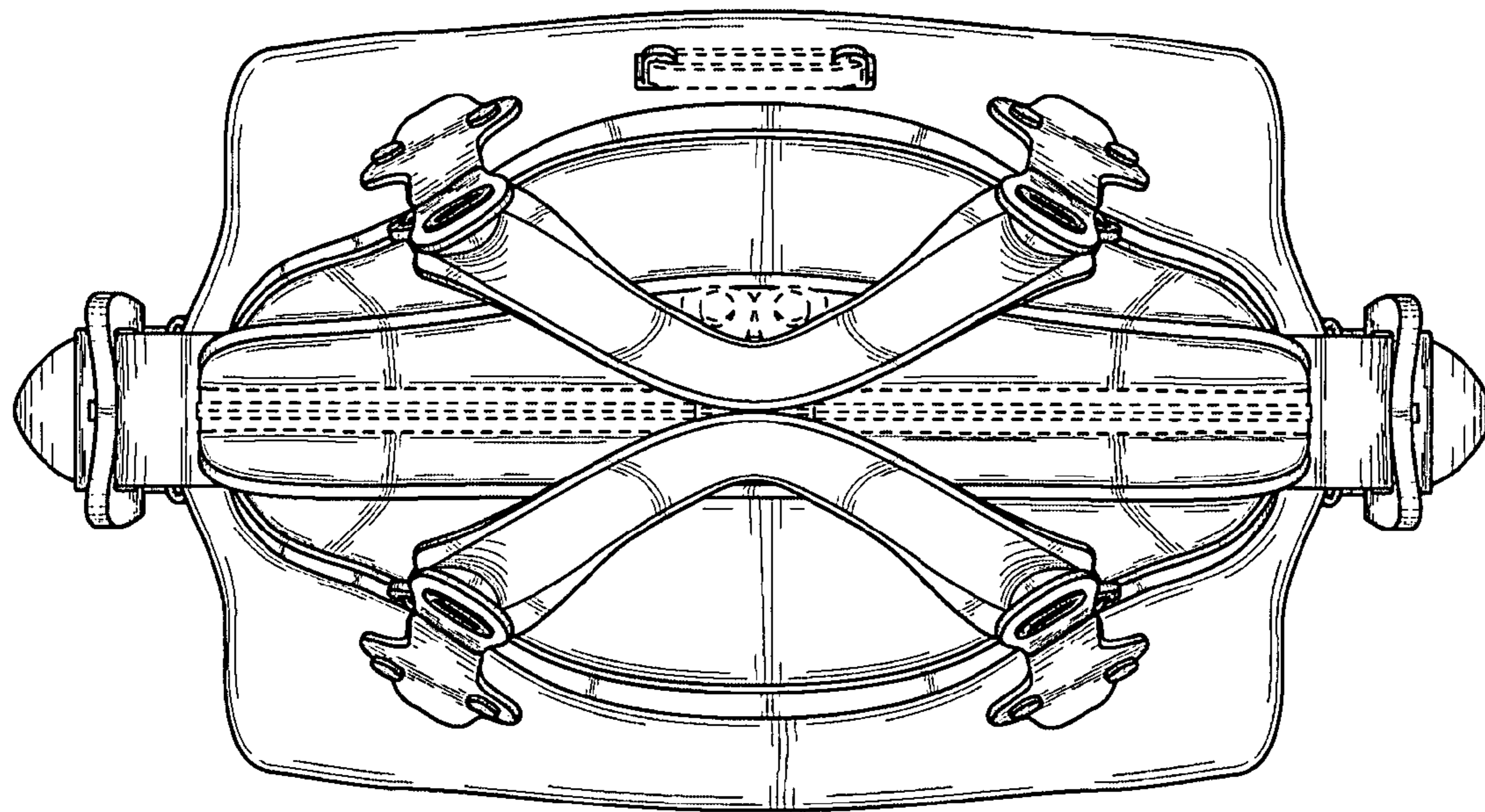

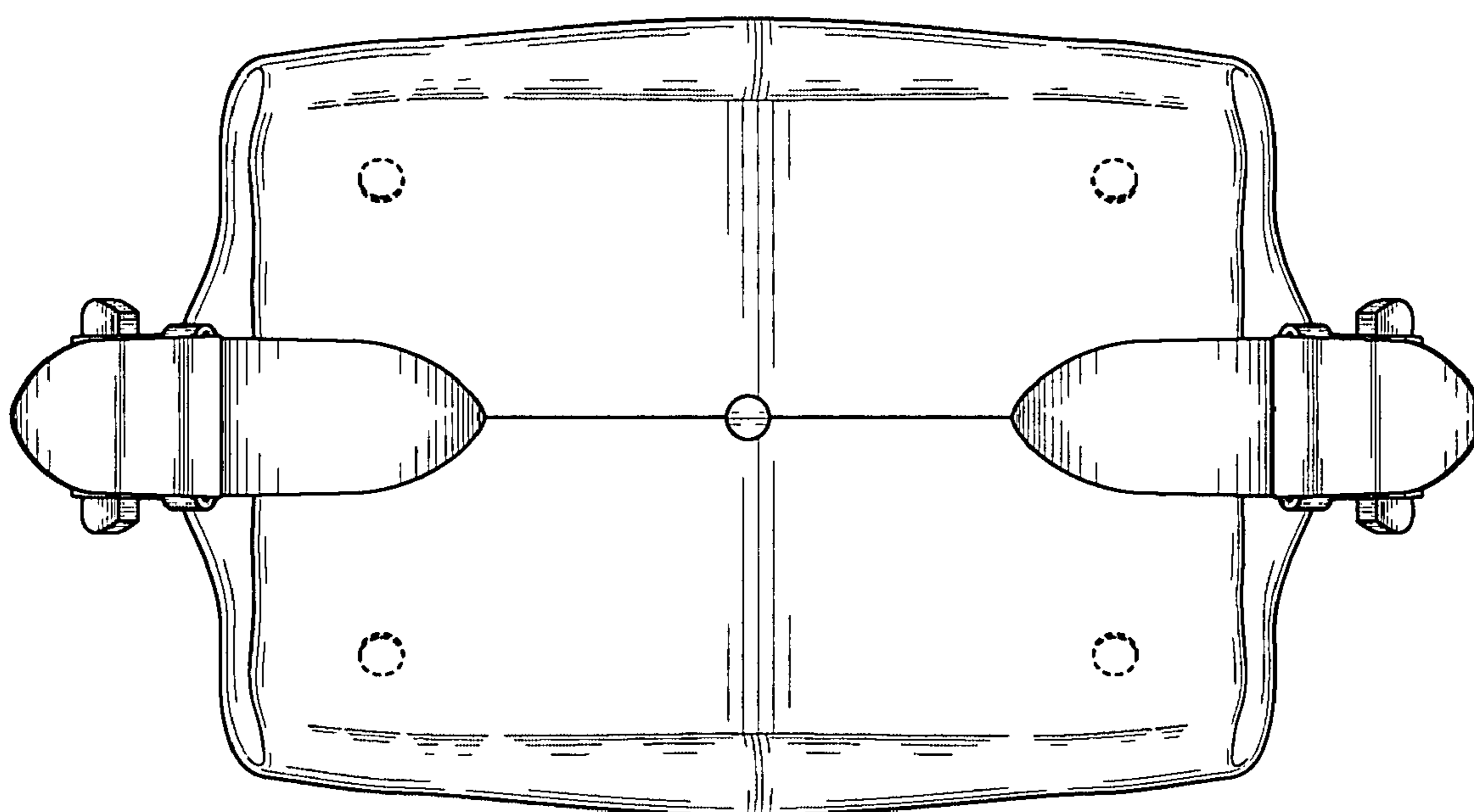
