I claim the ornamental design for a paint brush head, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a paint brush head in accordance with the present invention;

FIG. 2 is a bottom plan view thereof;

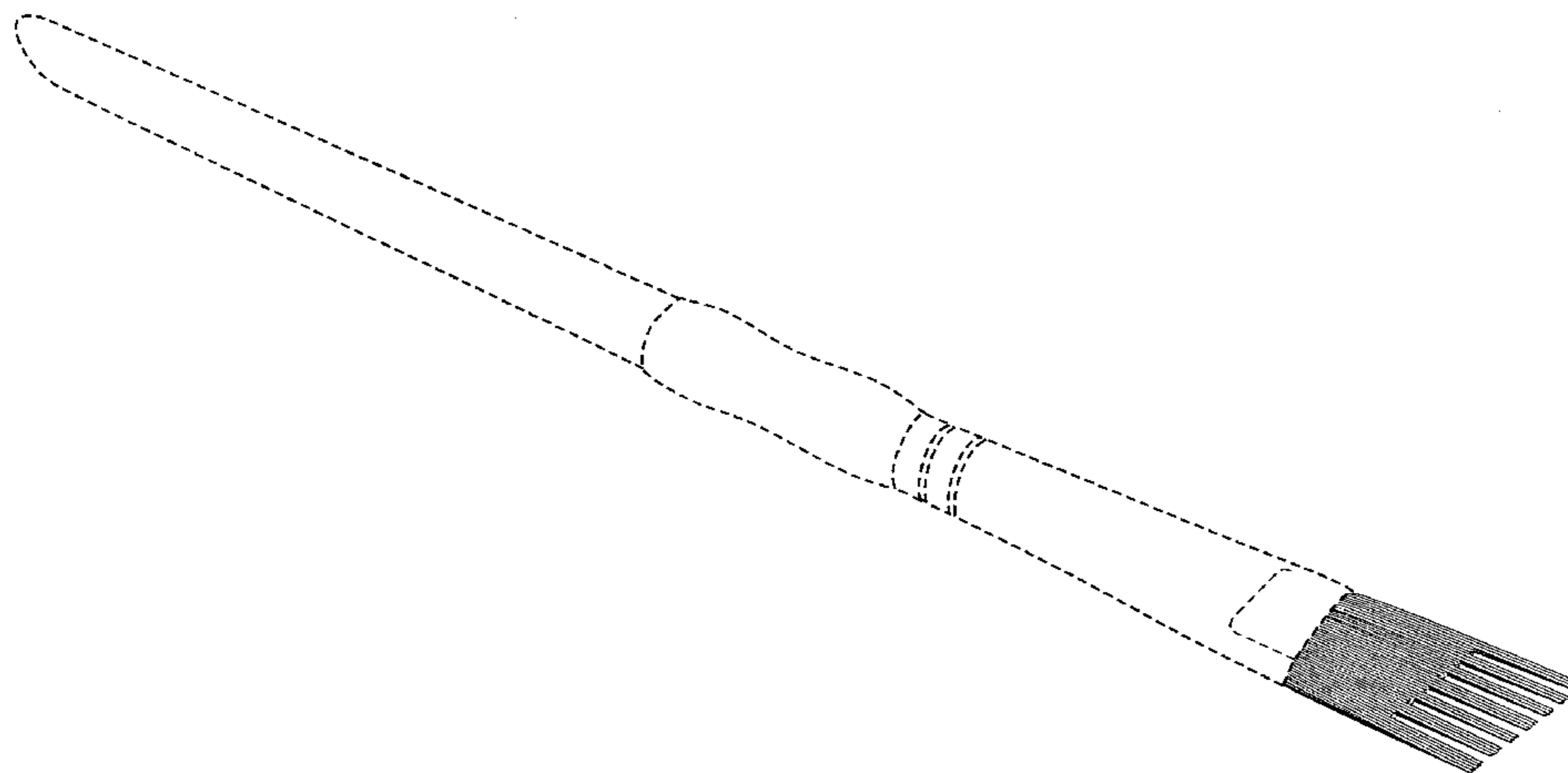
FIG. 3 is a left side elevation view thereof;

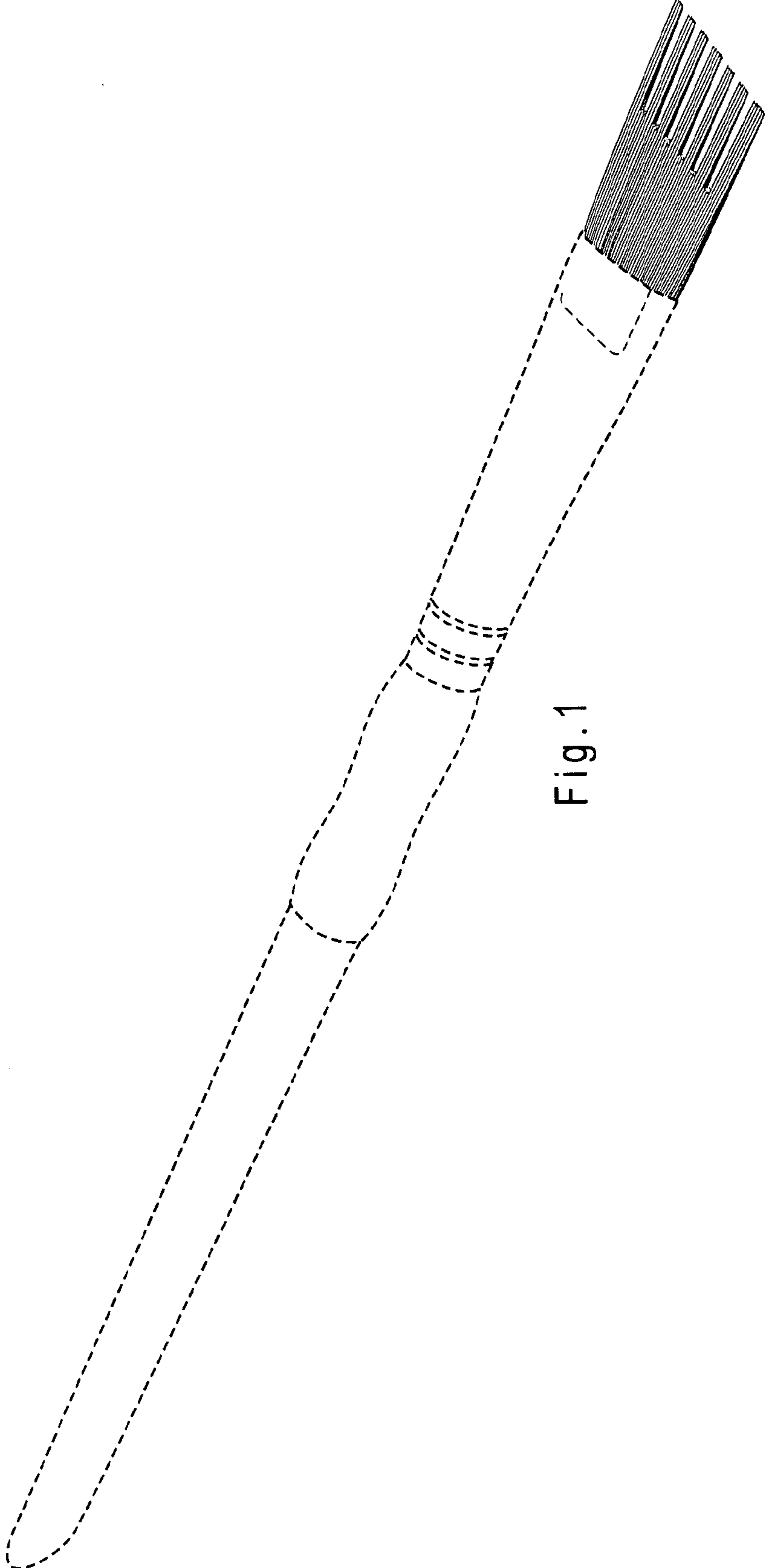

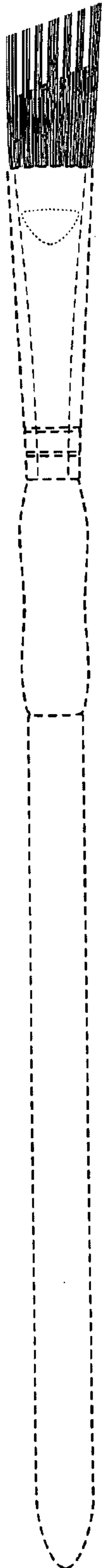

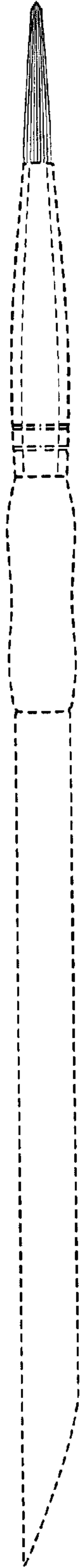

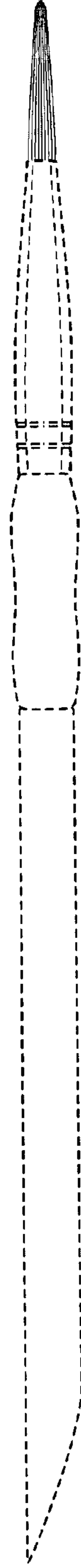
