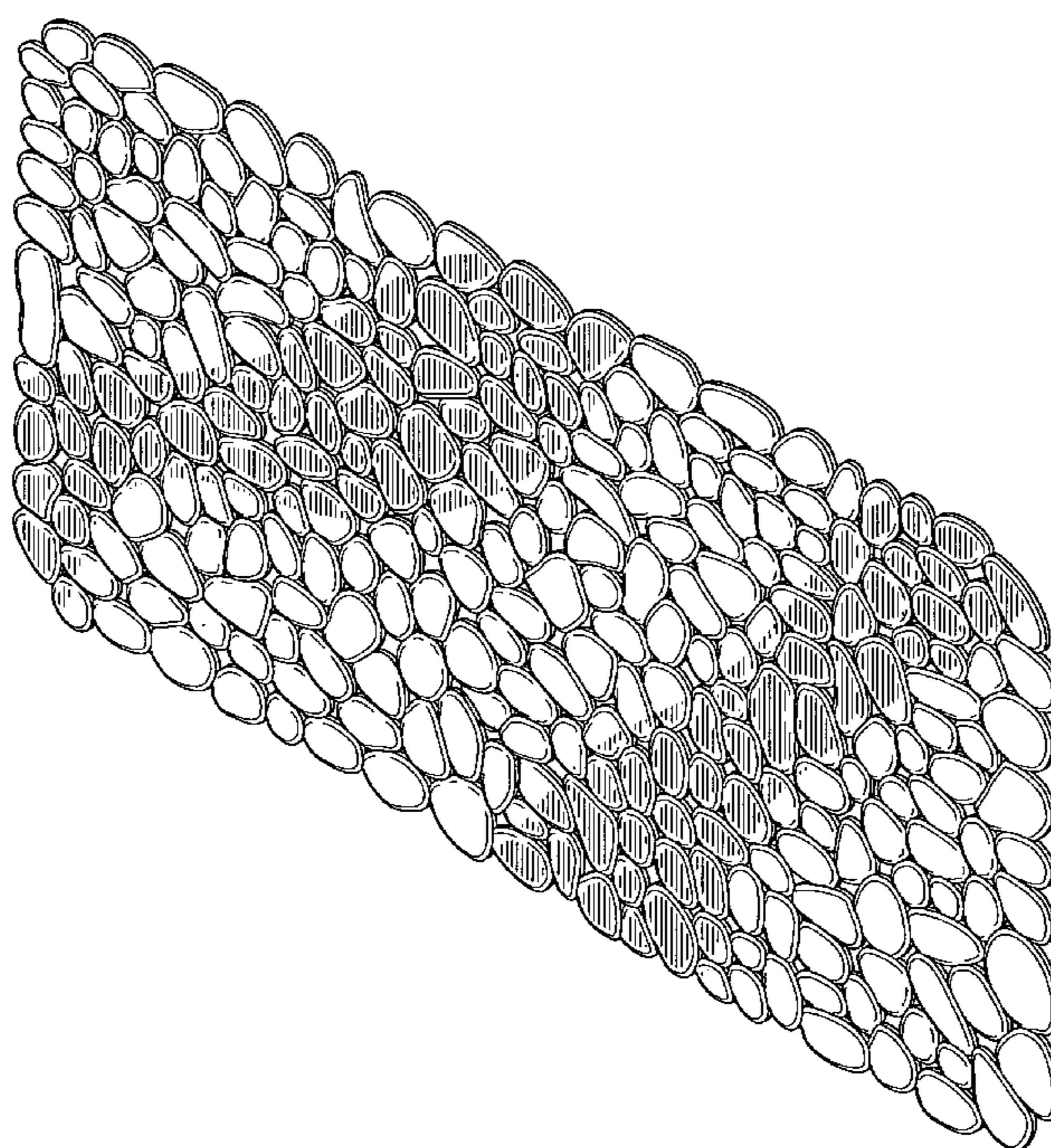
FIG. 4 is a side view of the rectangular bath mat as shown in FIG. 1;

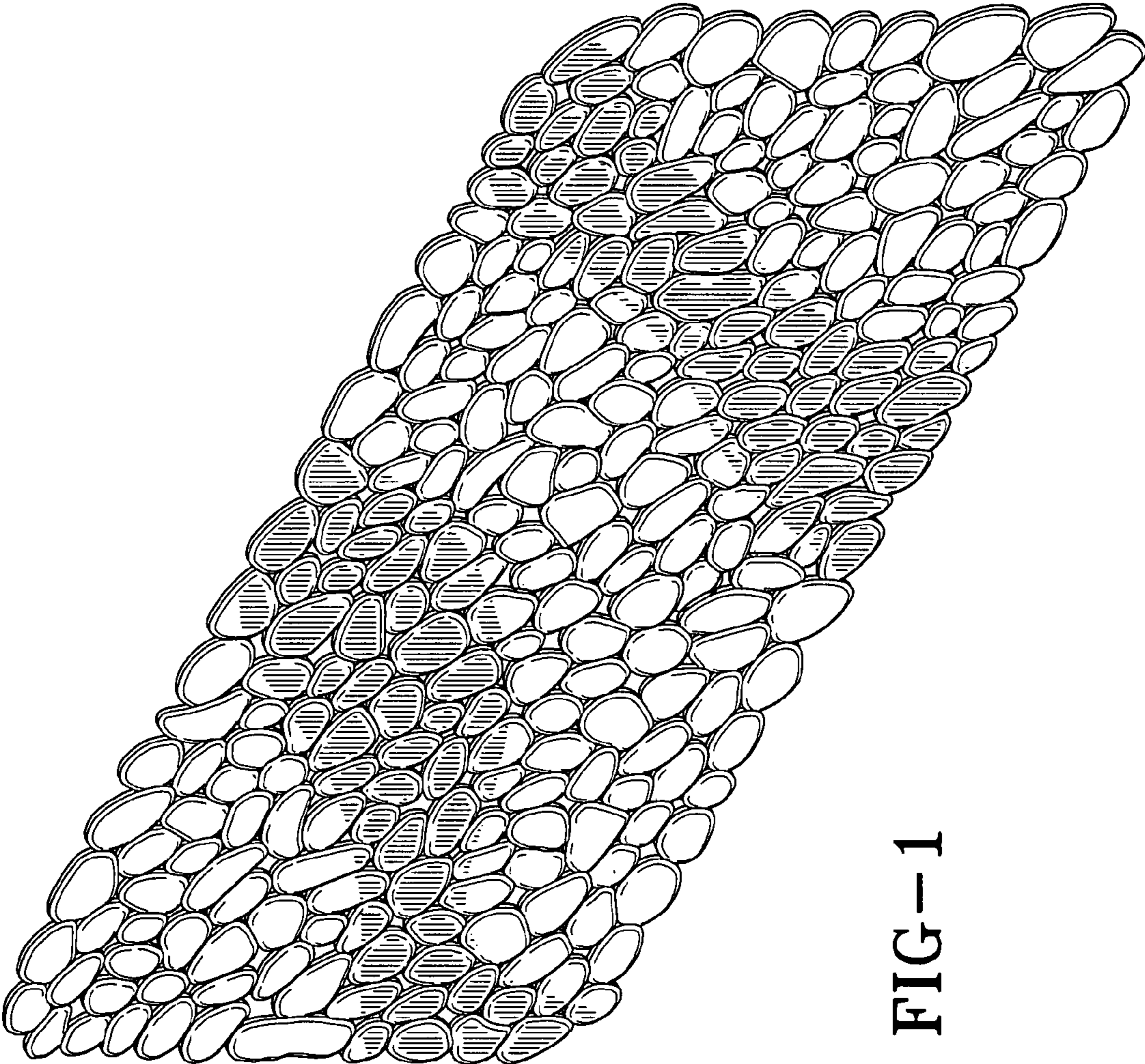

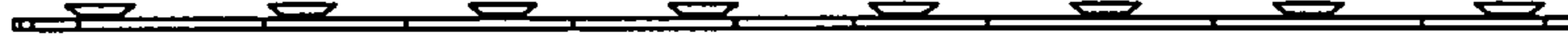
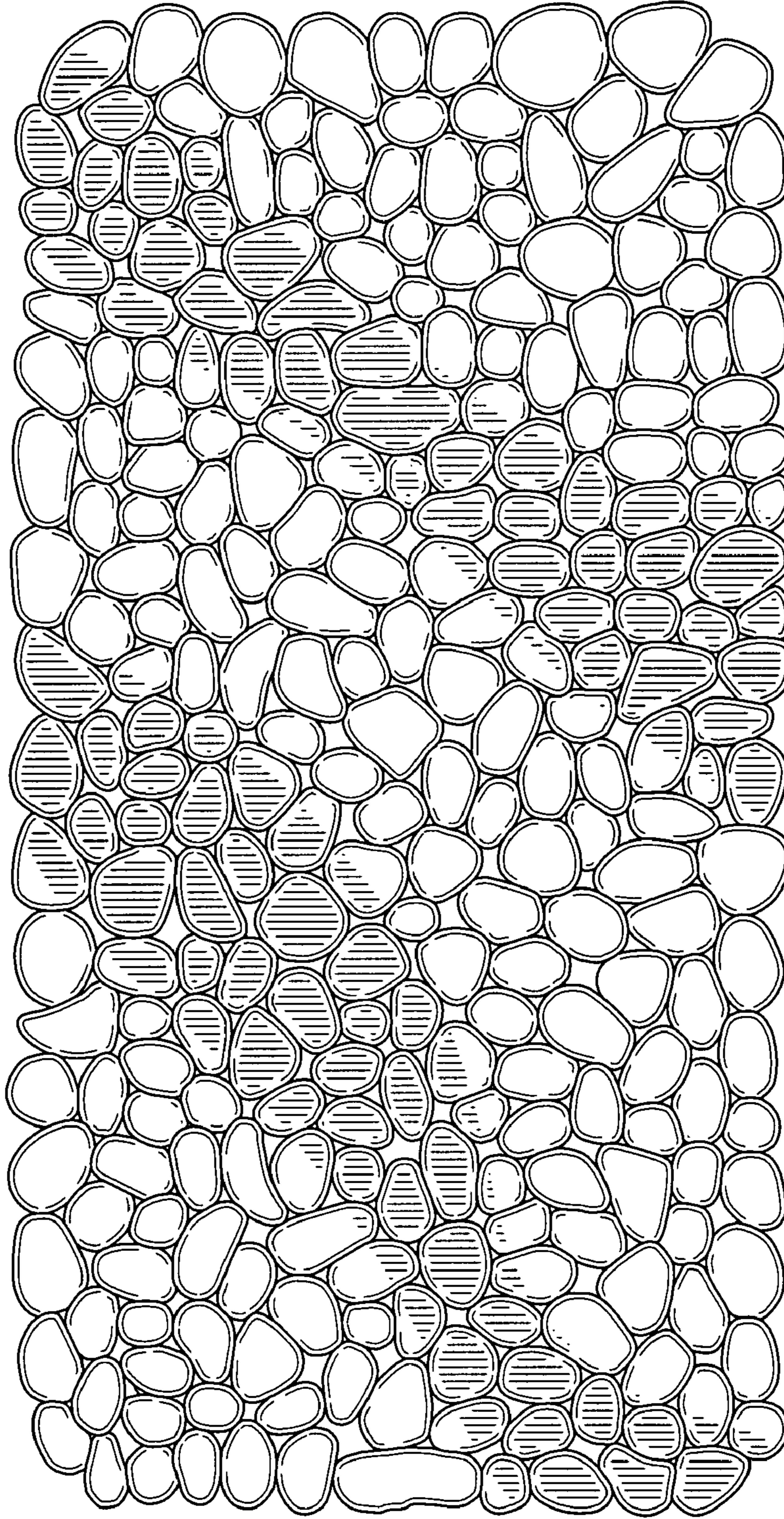

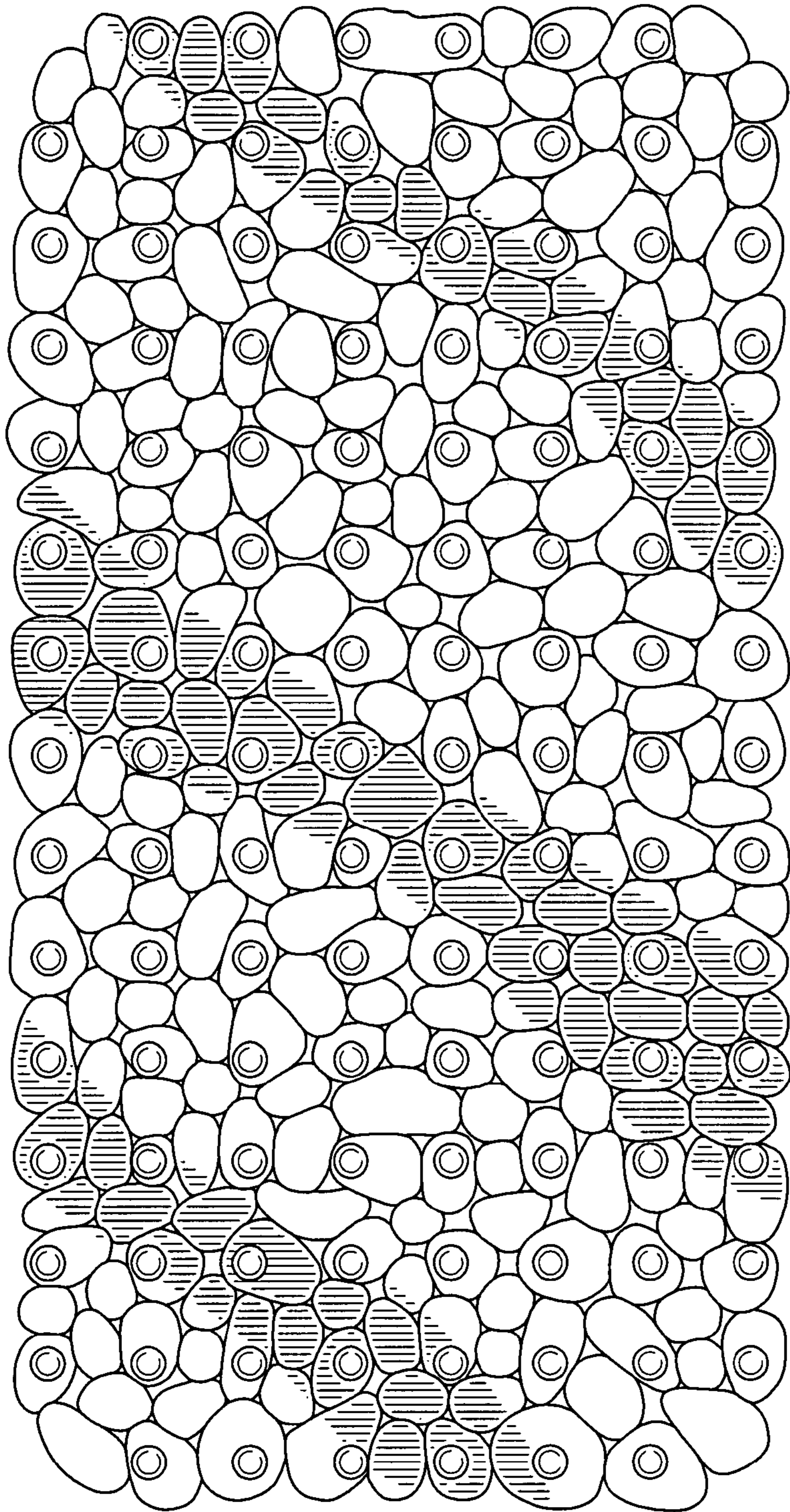
