The ornamental design for a seat, as shown and described.

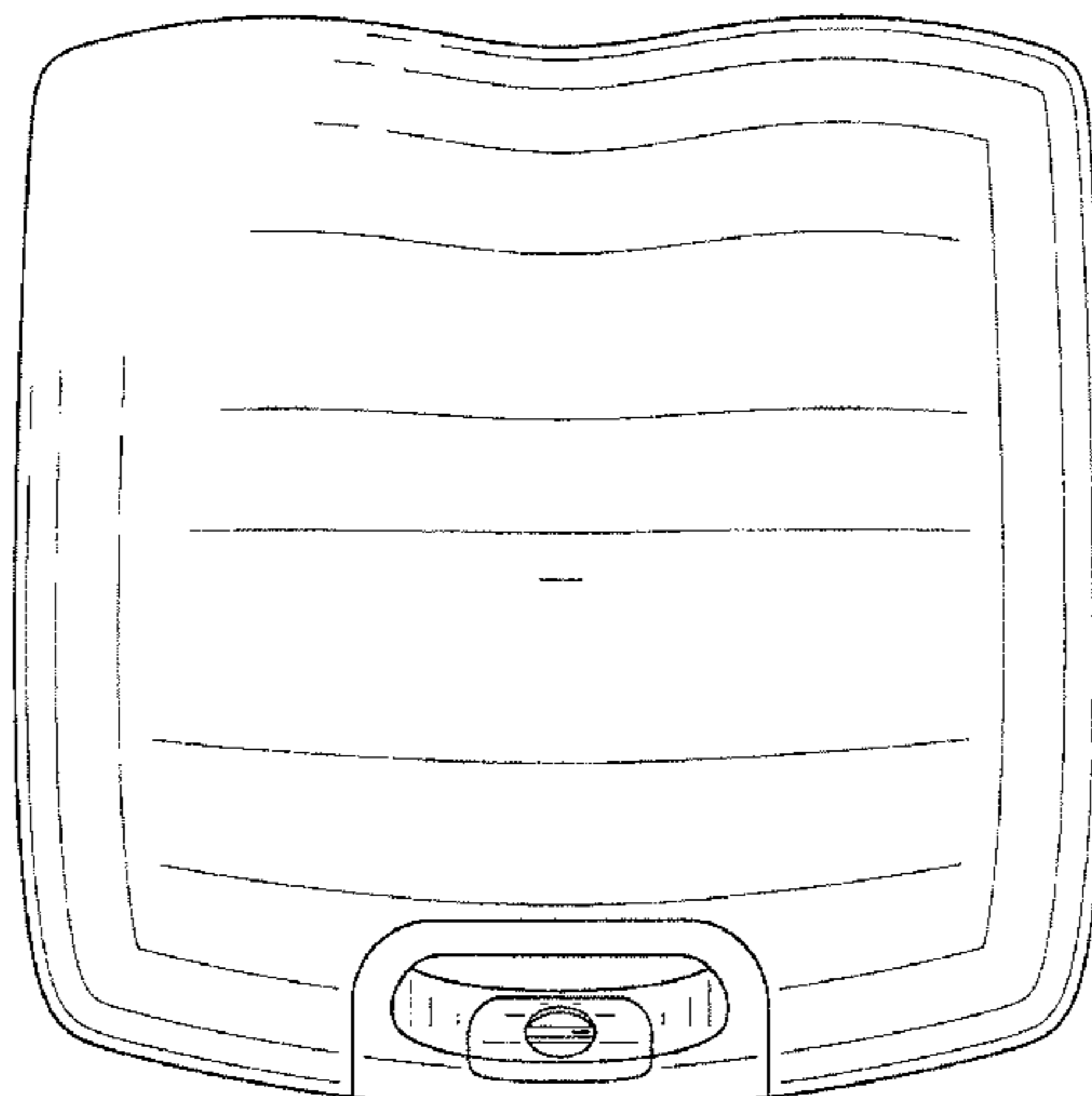
**DESCRIPTION**

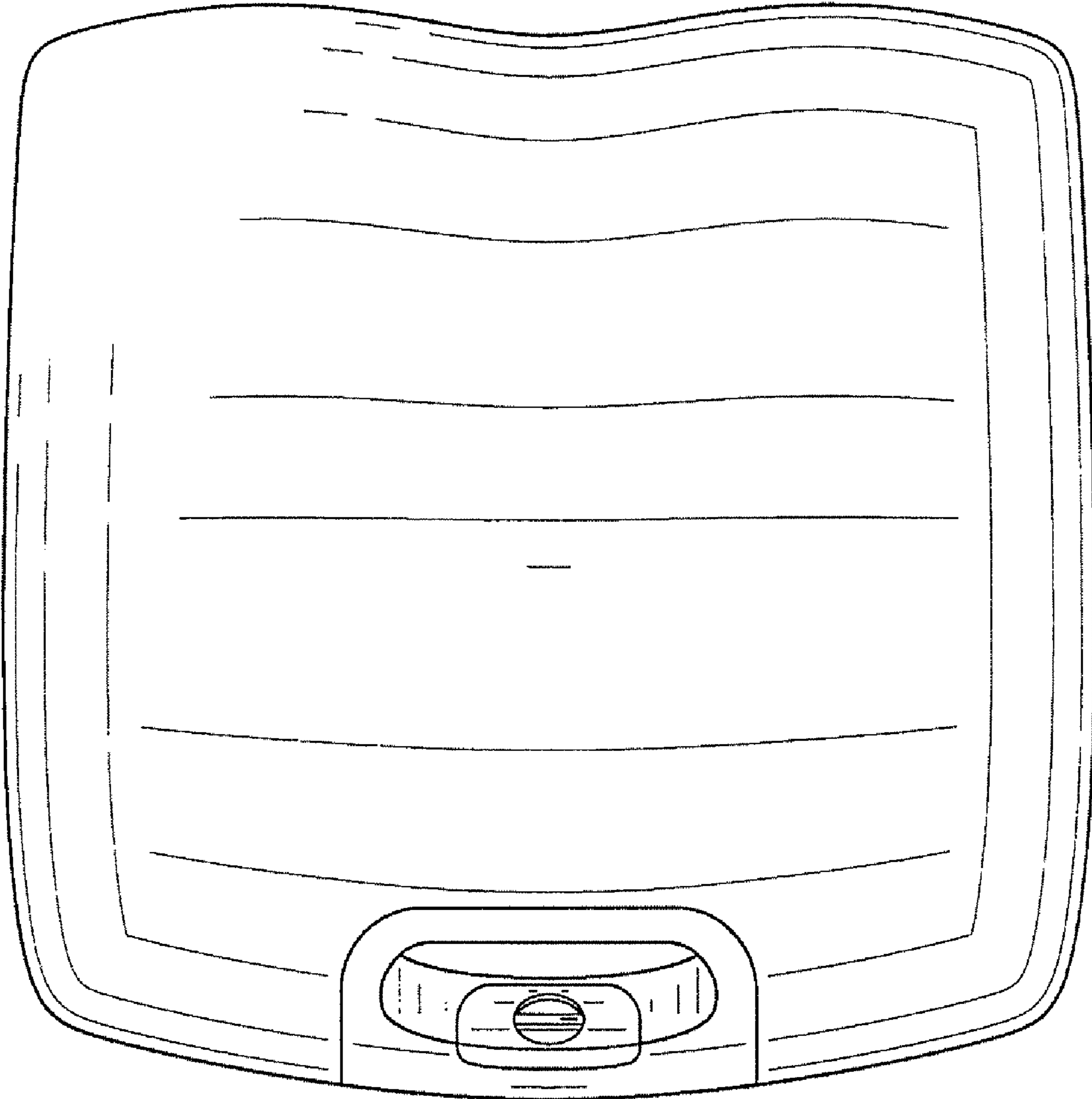

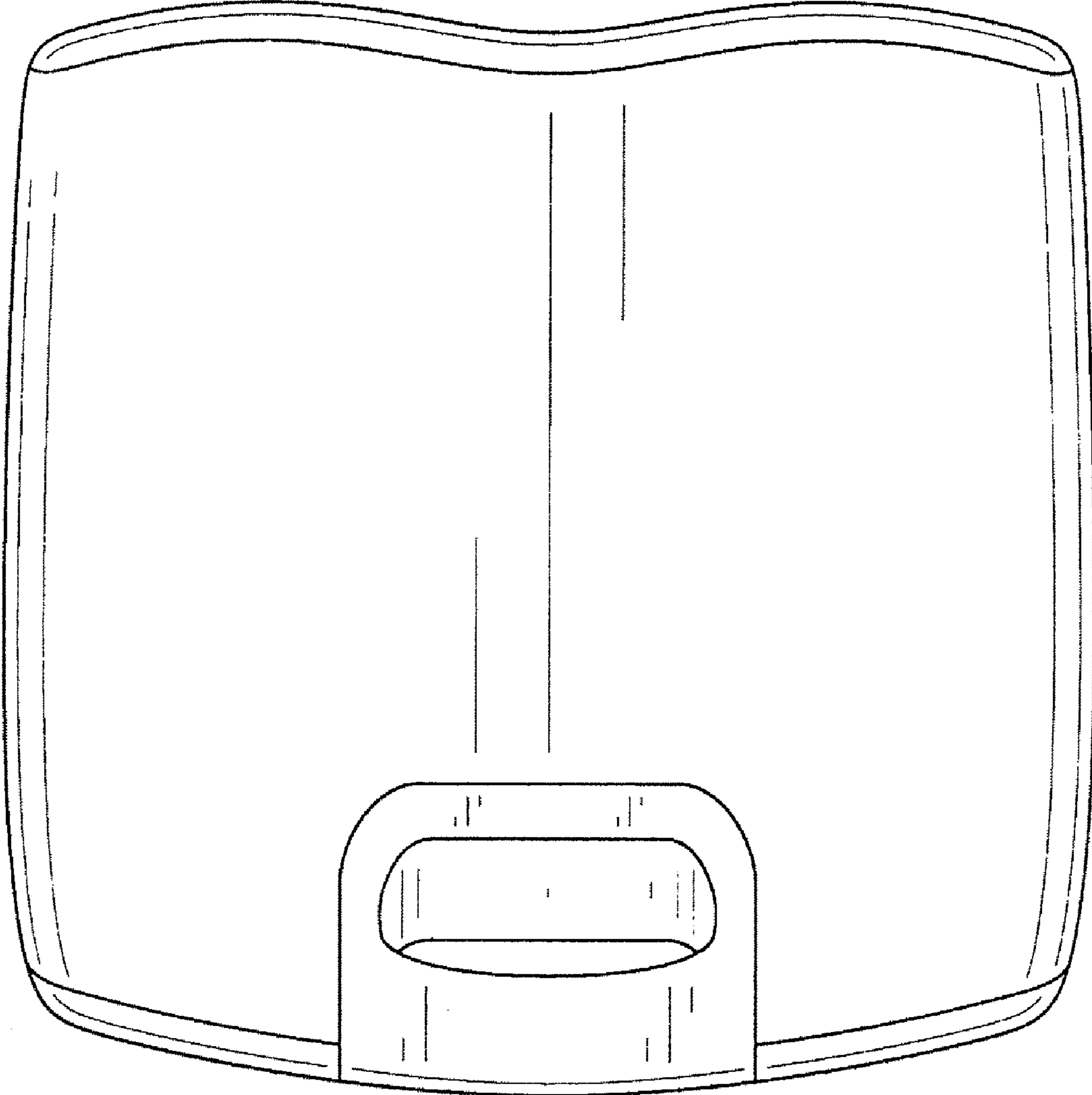

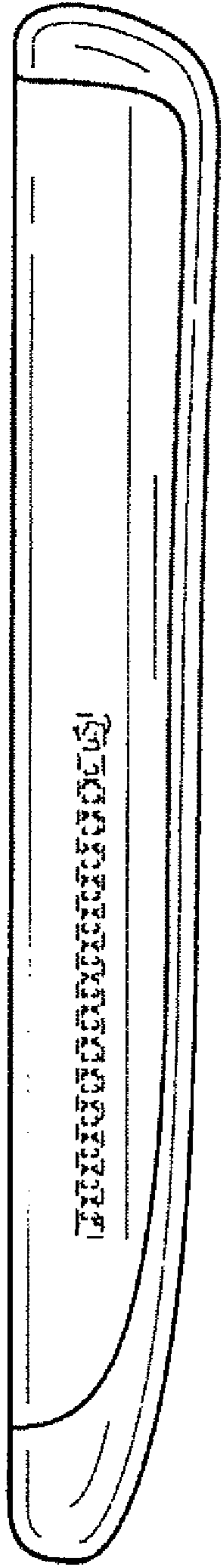

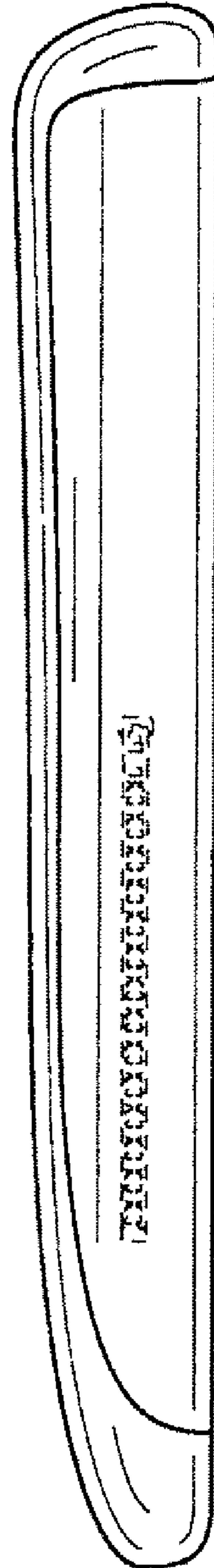

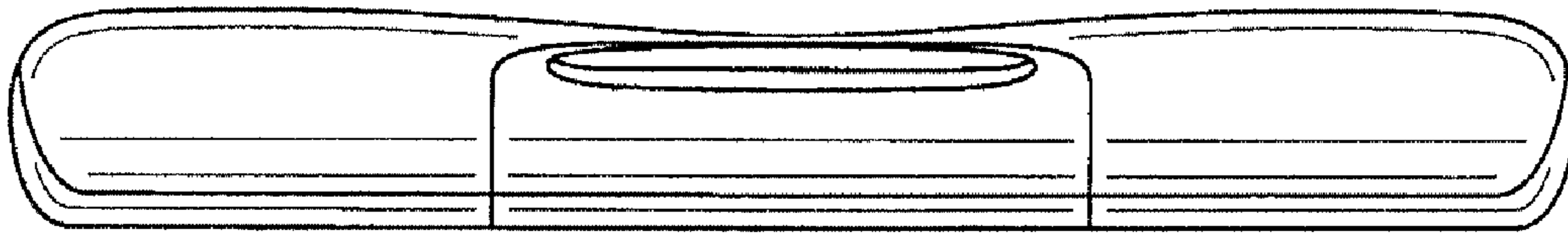

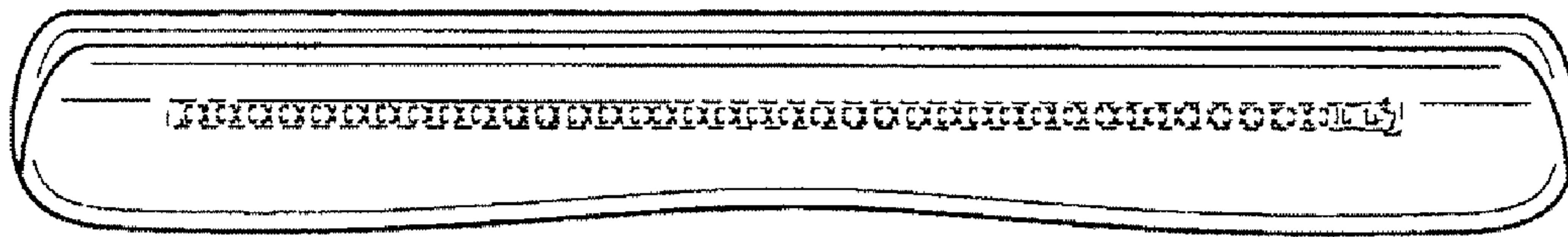

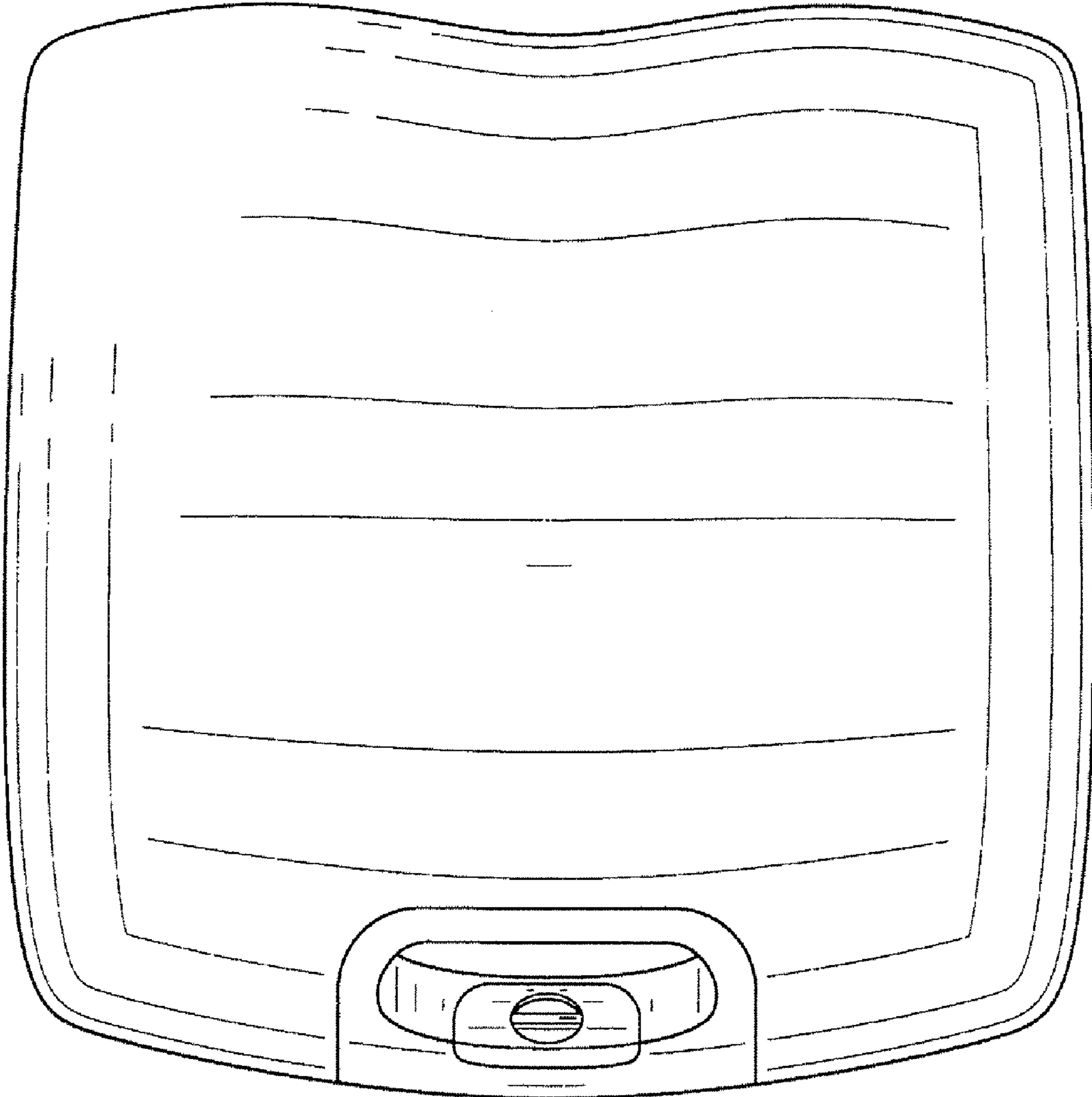

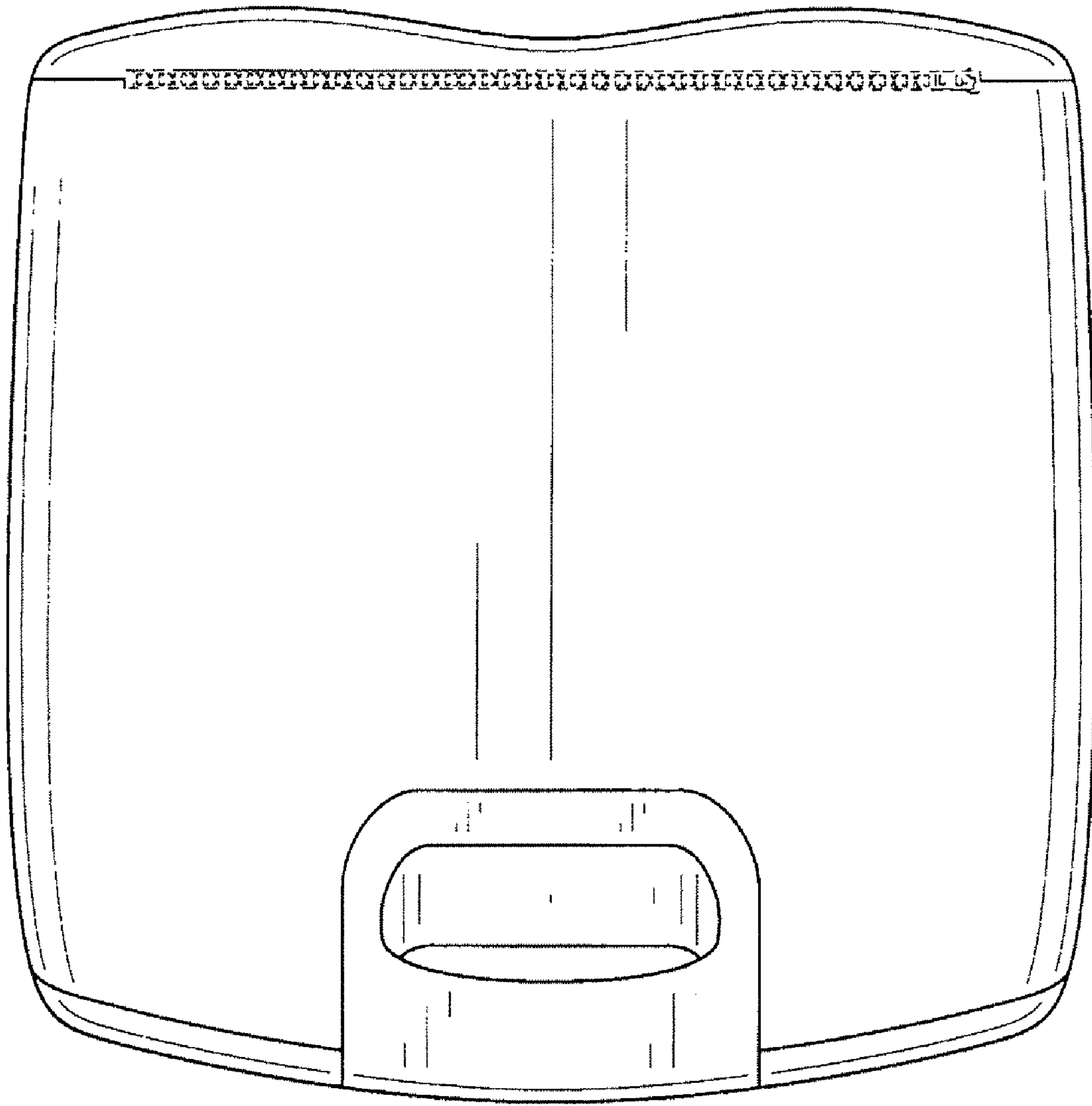

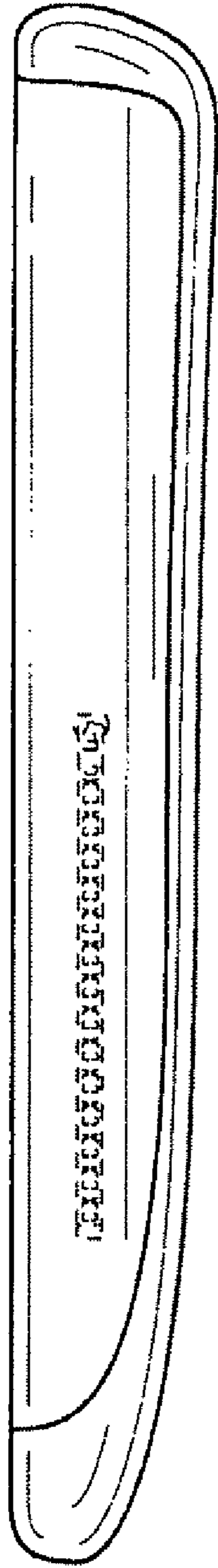

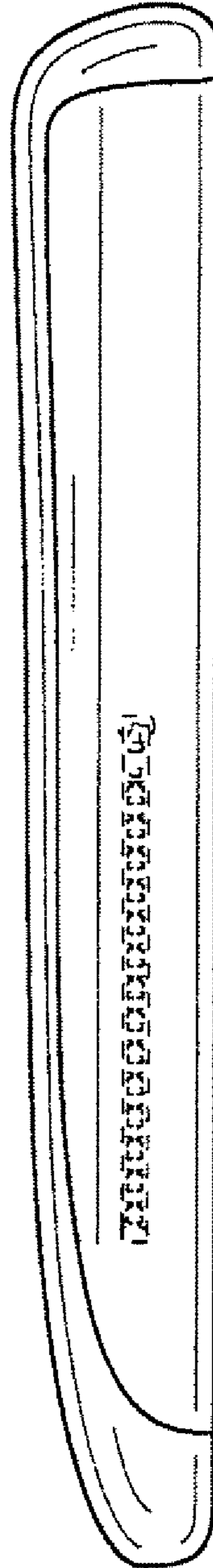

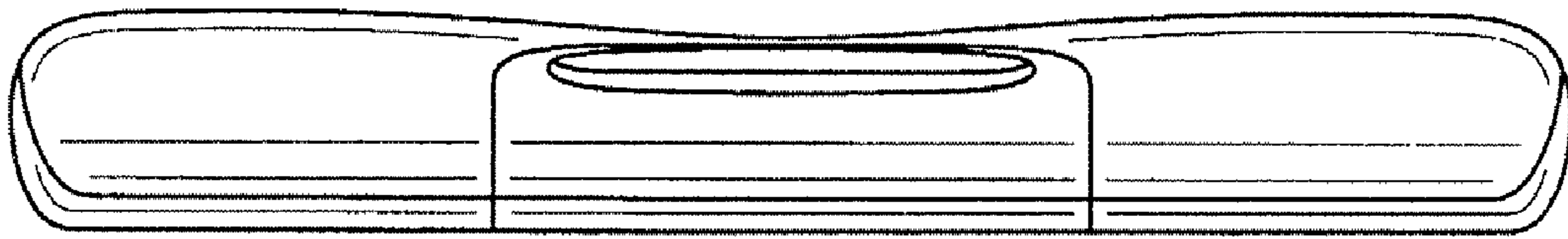

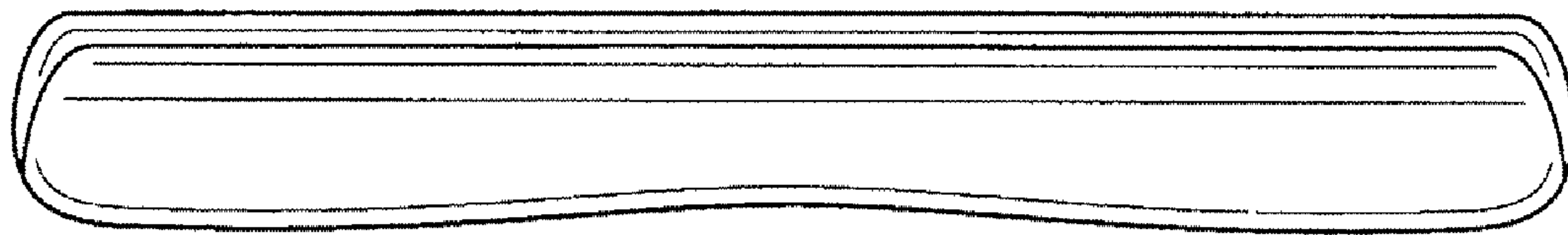

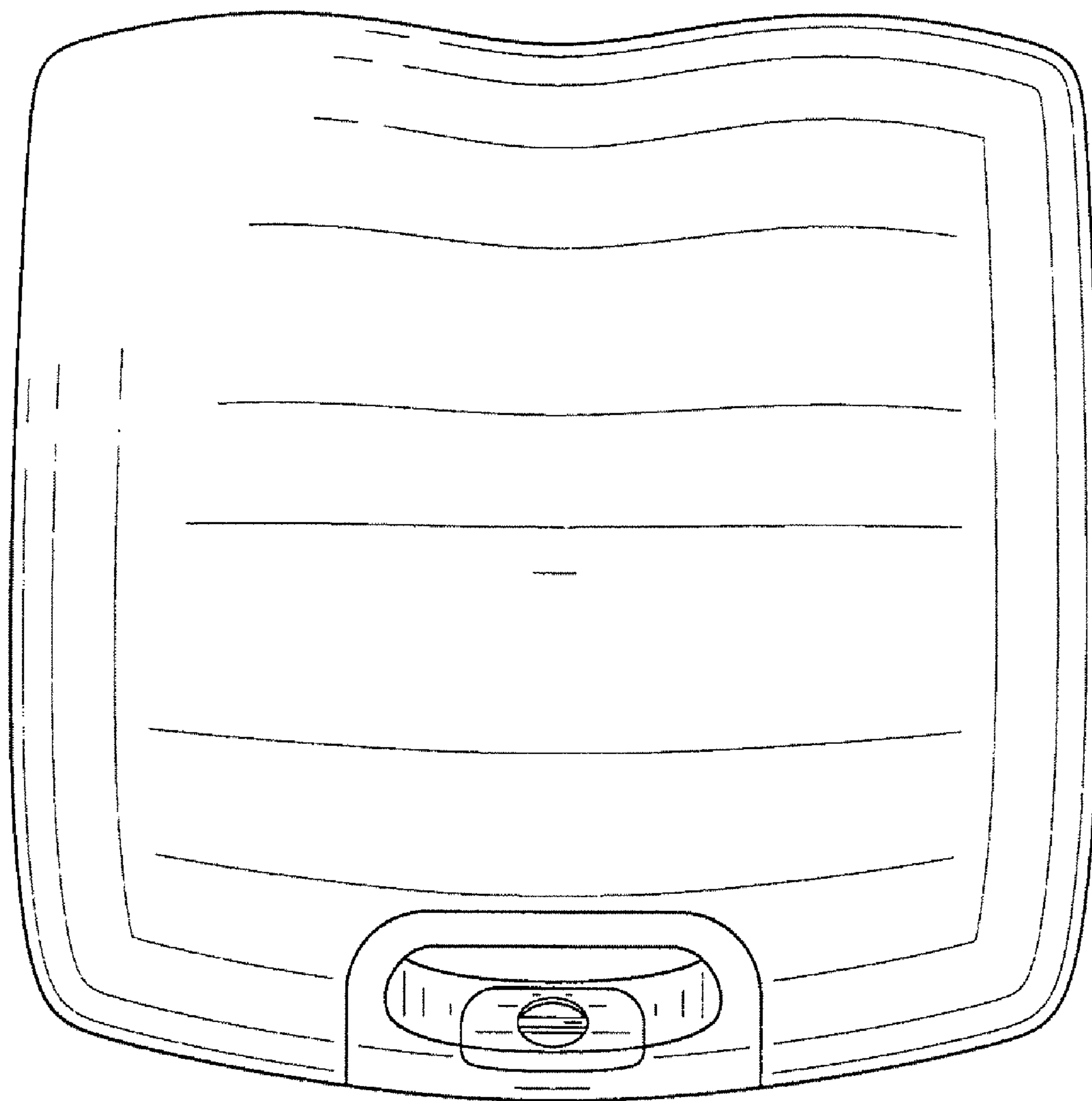

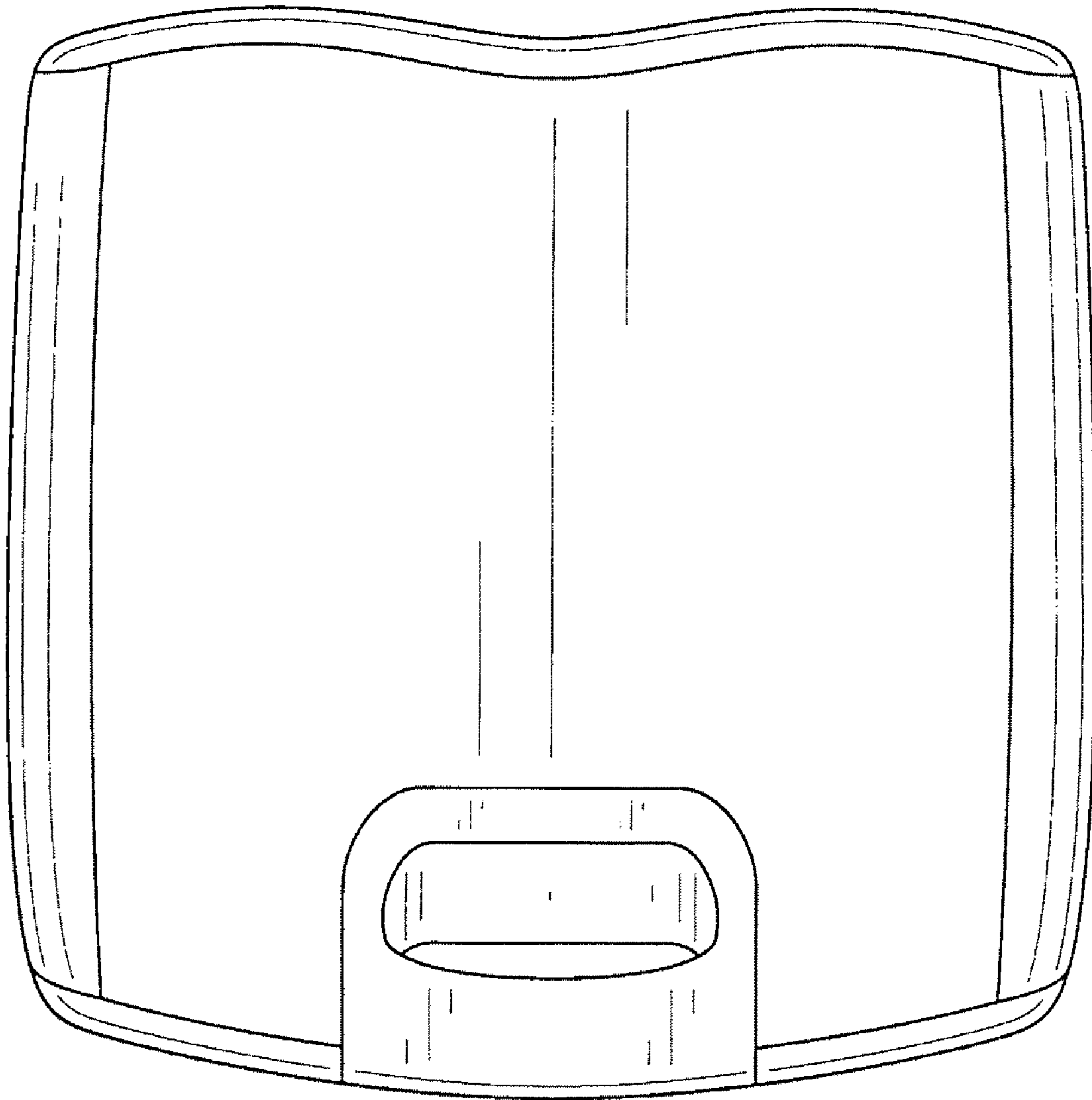

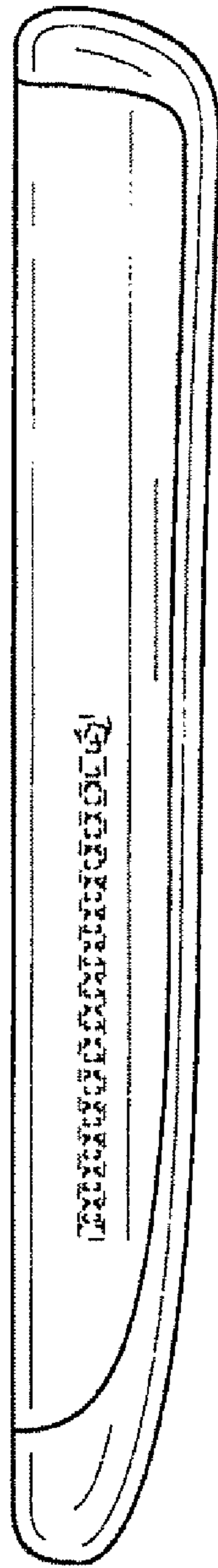

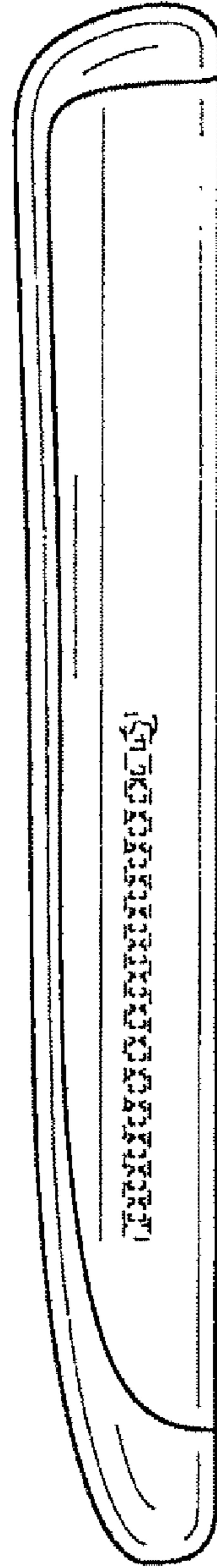

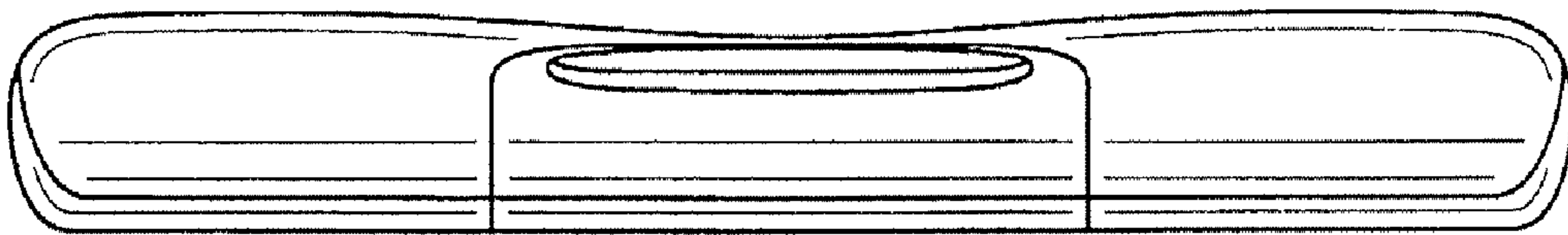

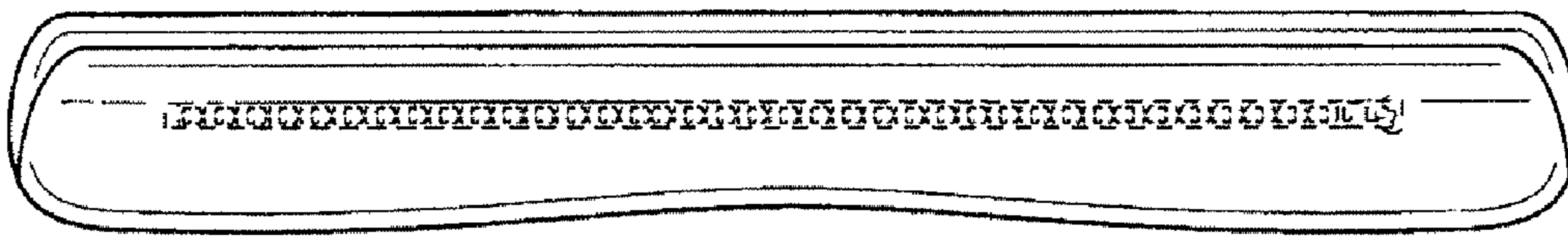

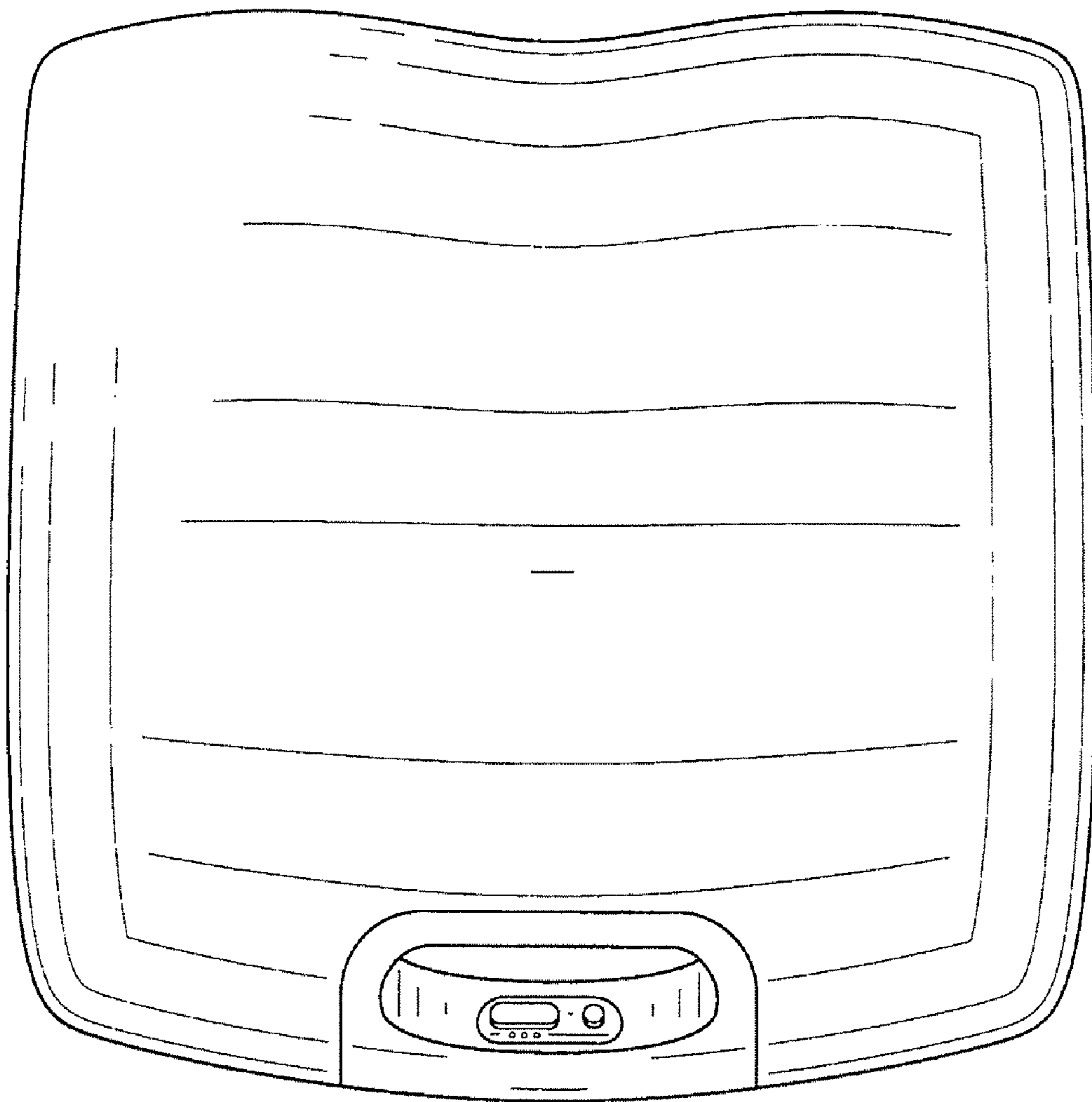

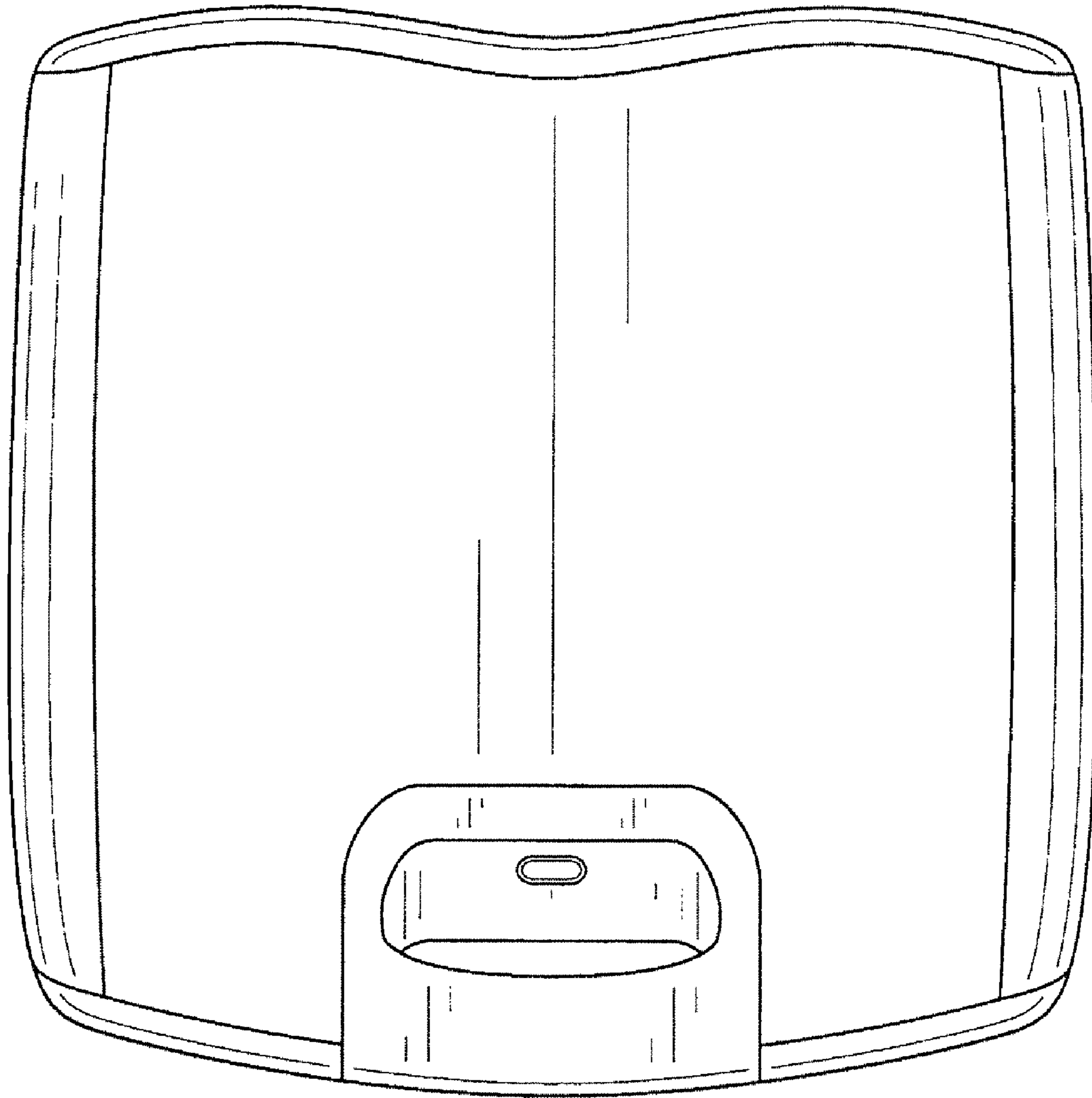

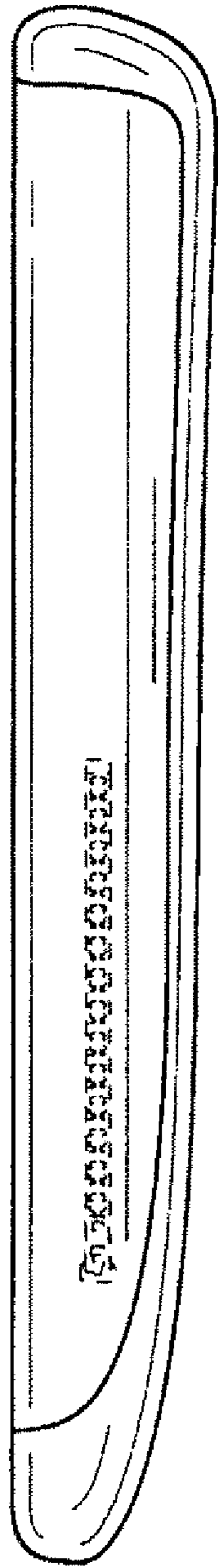

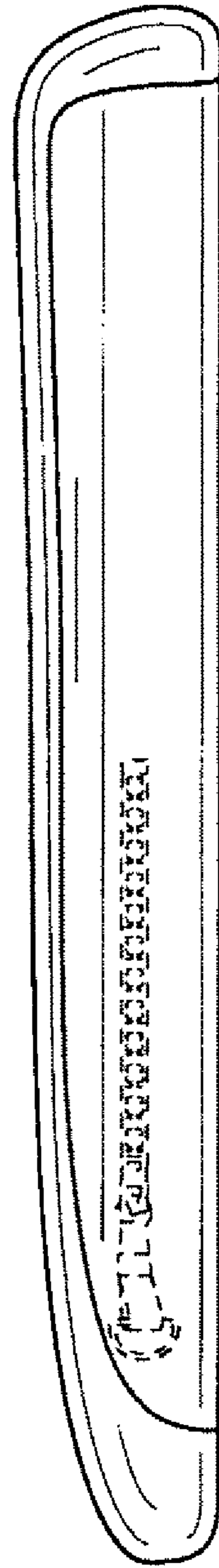

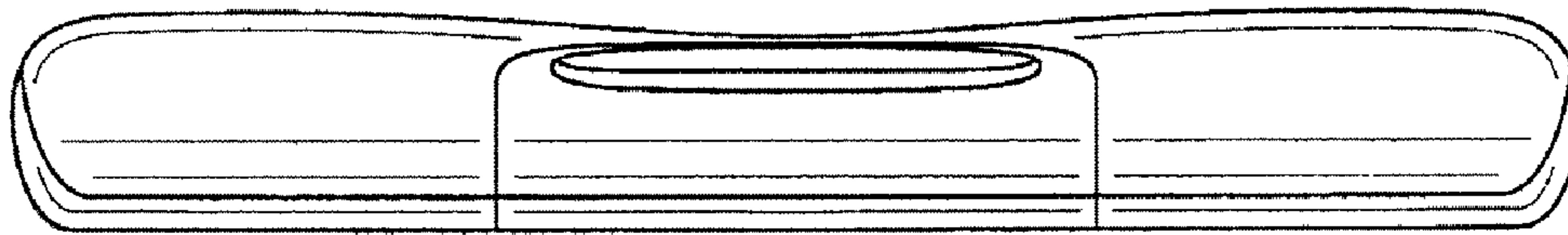

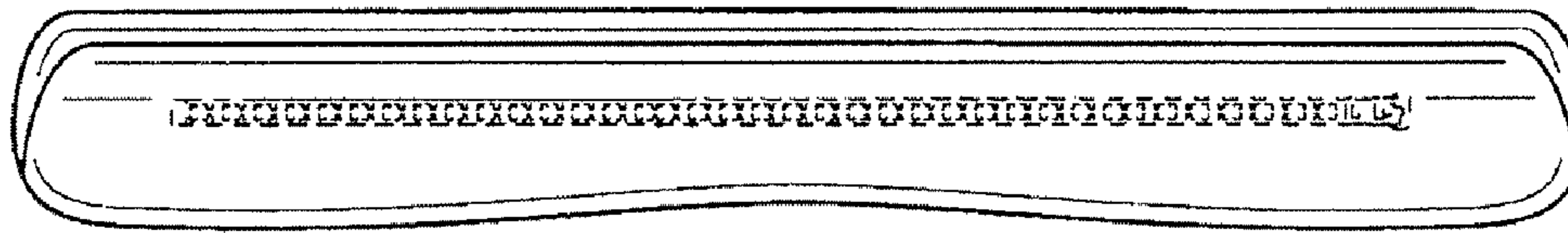

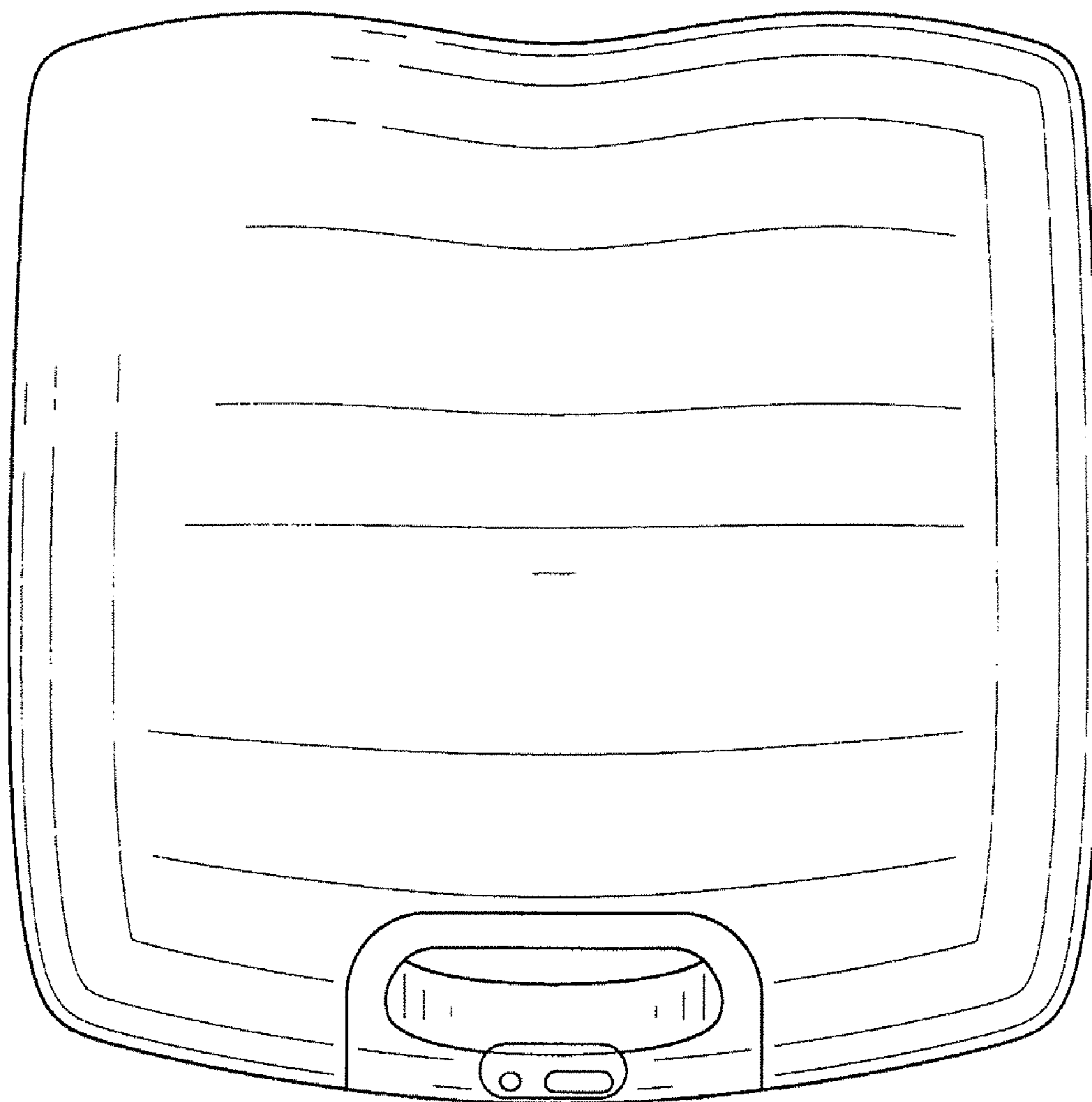

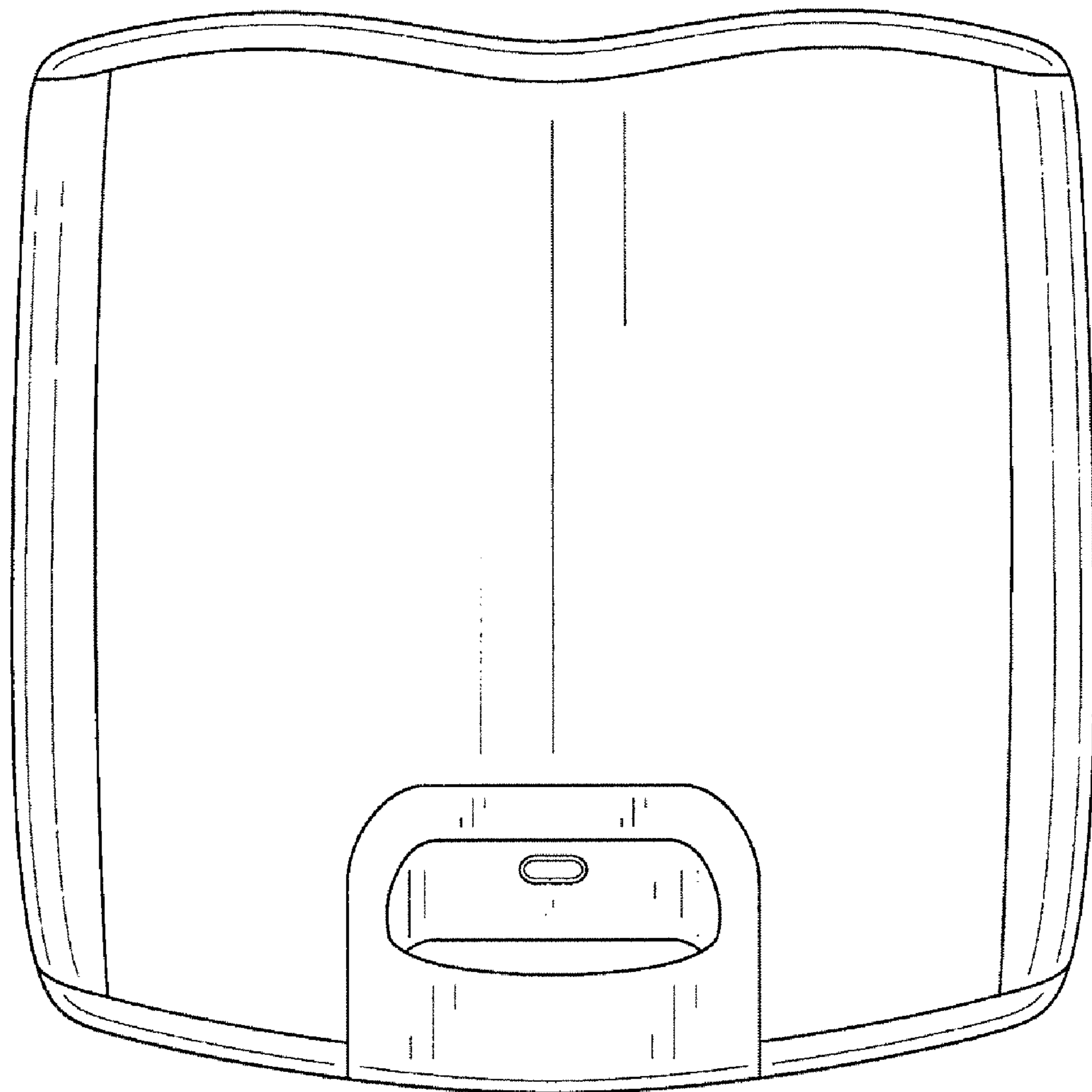

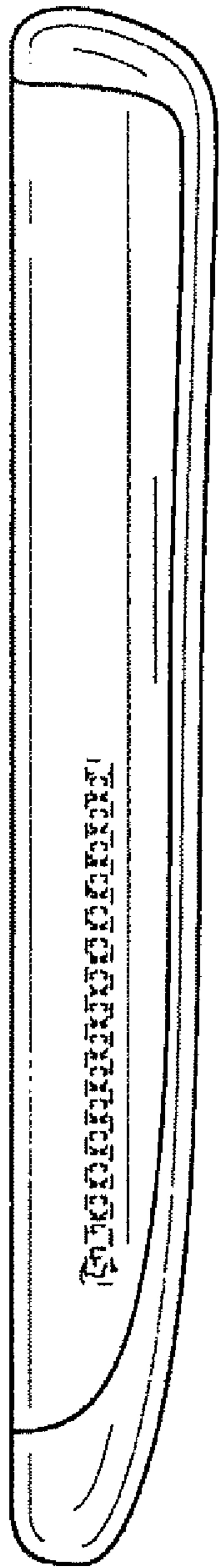

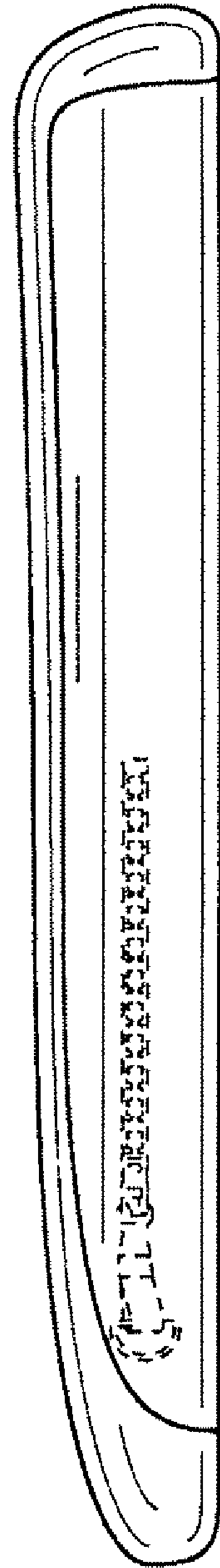

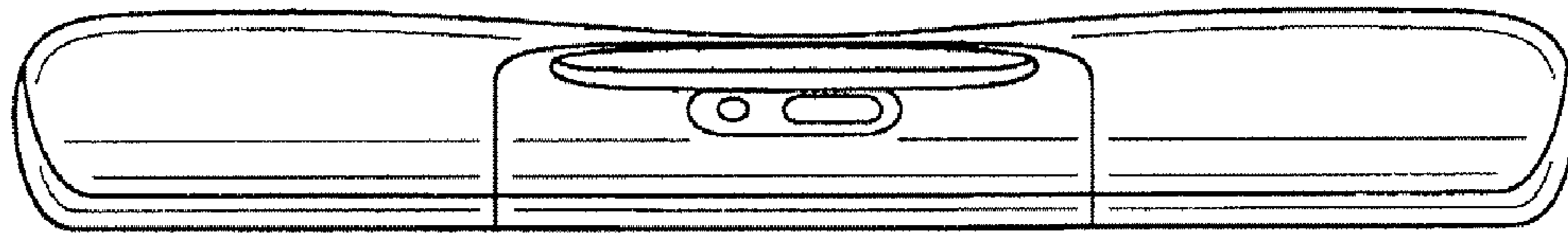

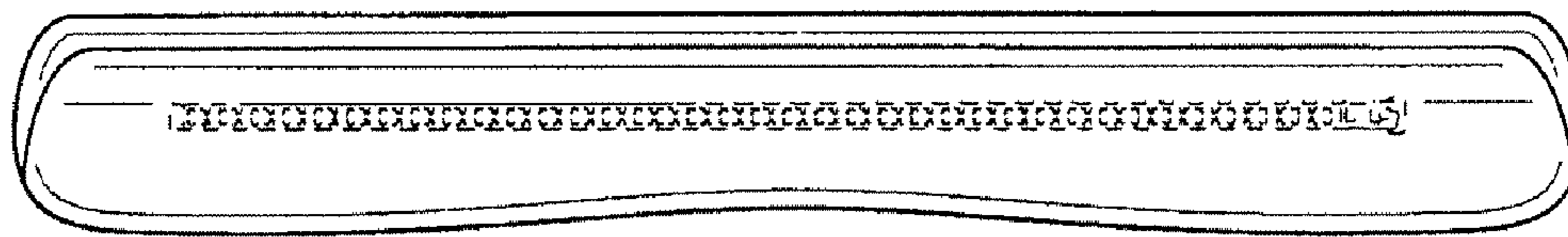
