(57) **CLAIM**

The ornamental design for a grinding wheel shank, as shown and described.

DESCRIPTION

FIG. 1 is the perspective view of a grinding wheel shank of the invention;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a cross-sectional perspective front view of the grinding wheel shank, taken along line 8—8 of FIG. 2;

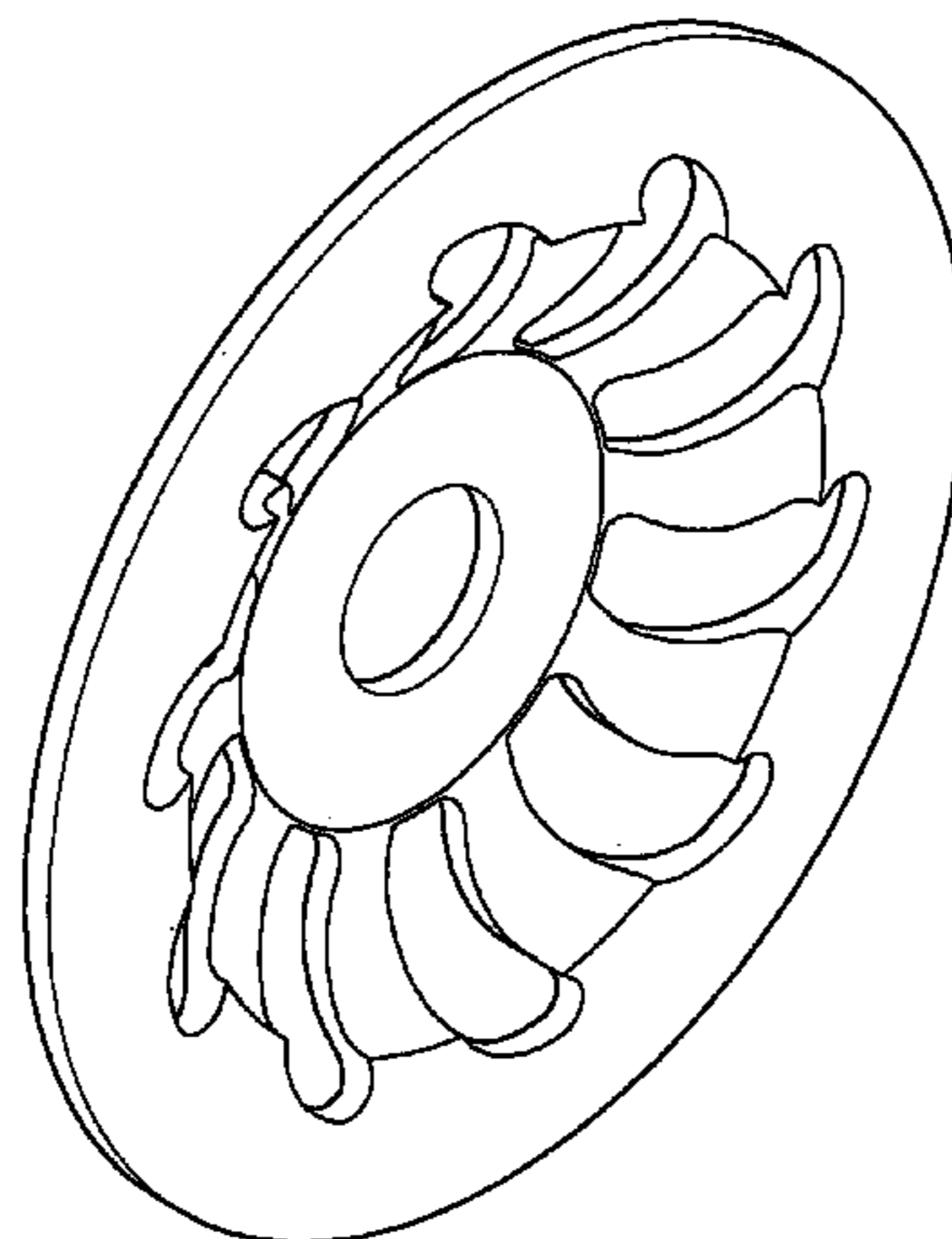
FIG. 9 is a cross-sectional perspective front view of the grinding wheel shank, taken along line 9—9 of FIG. 2;

FIG. 10 is a rear perspective view; and,

FIG. 11 is a front view of the grinding wheel shank of the invention showing a plurality of diamond grinding tips rendered in broken line attached thereto.

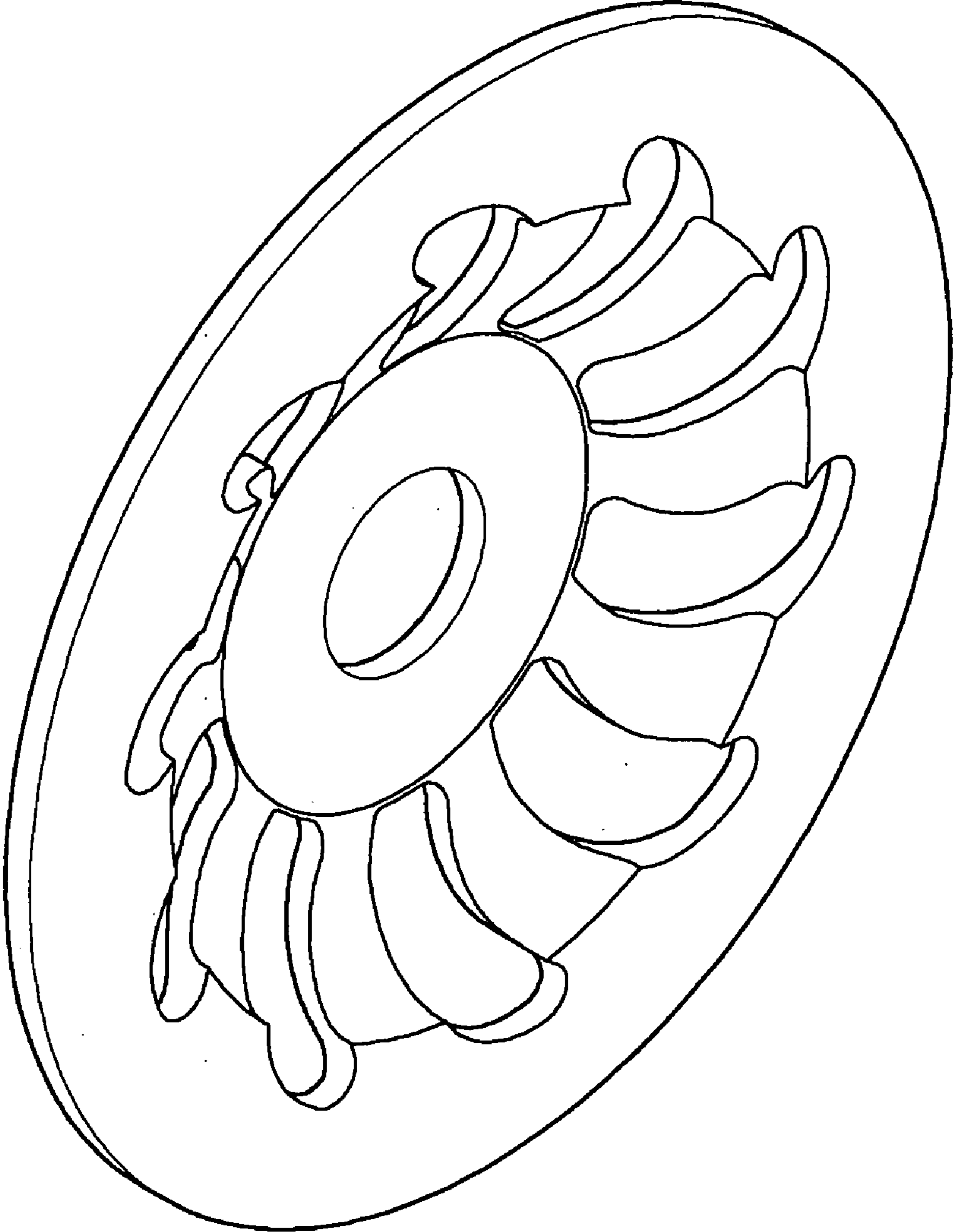

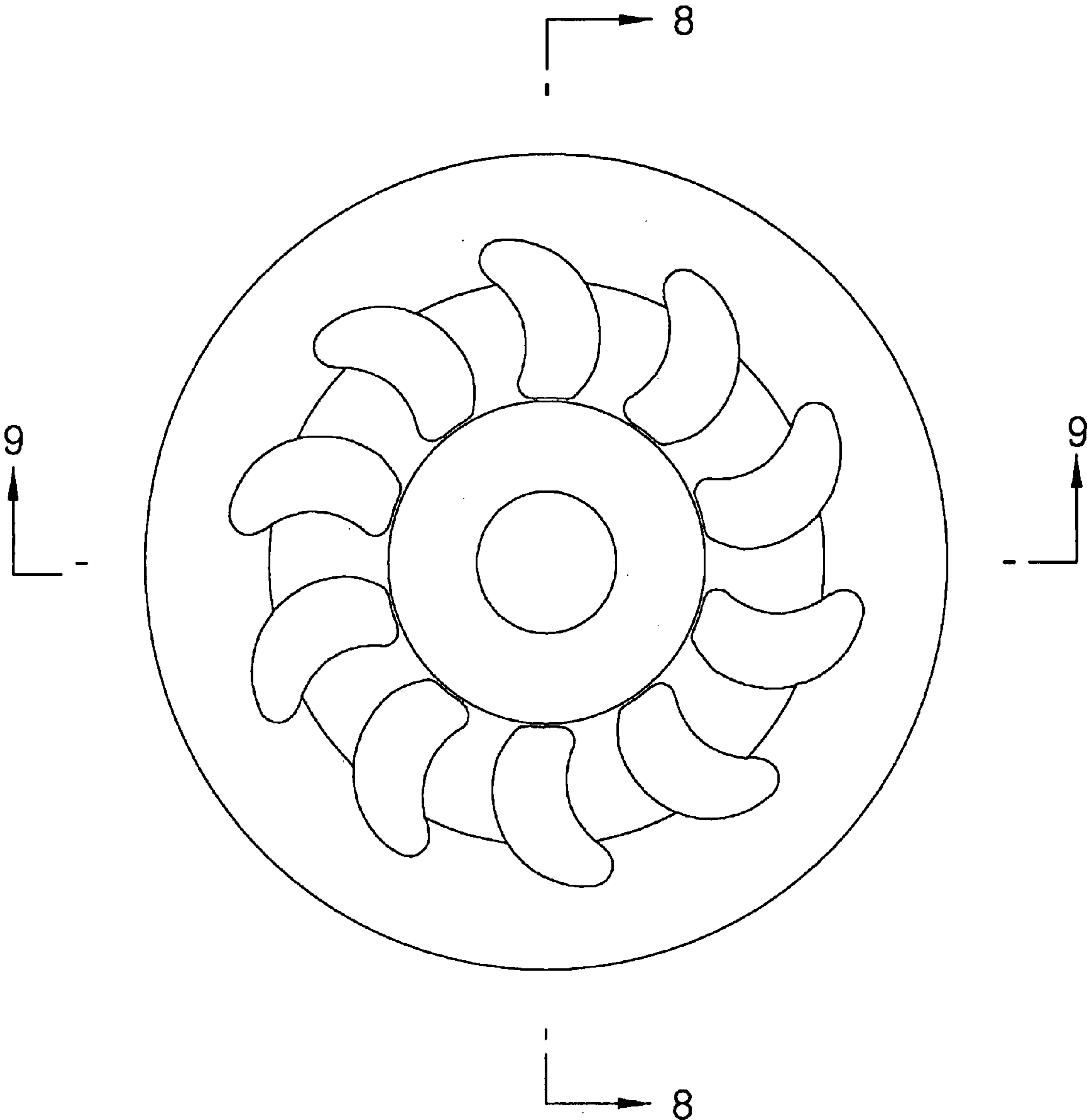

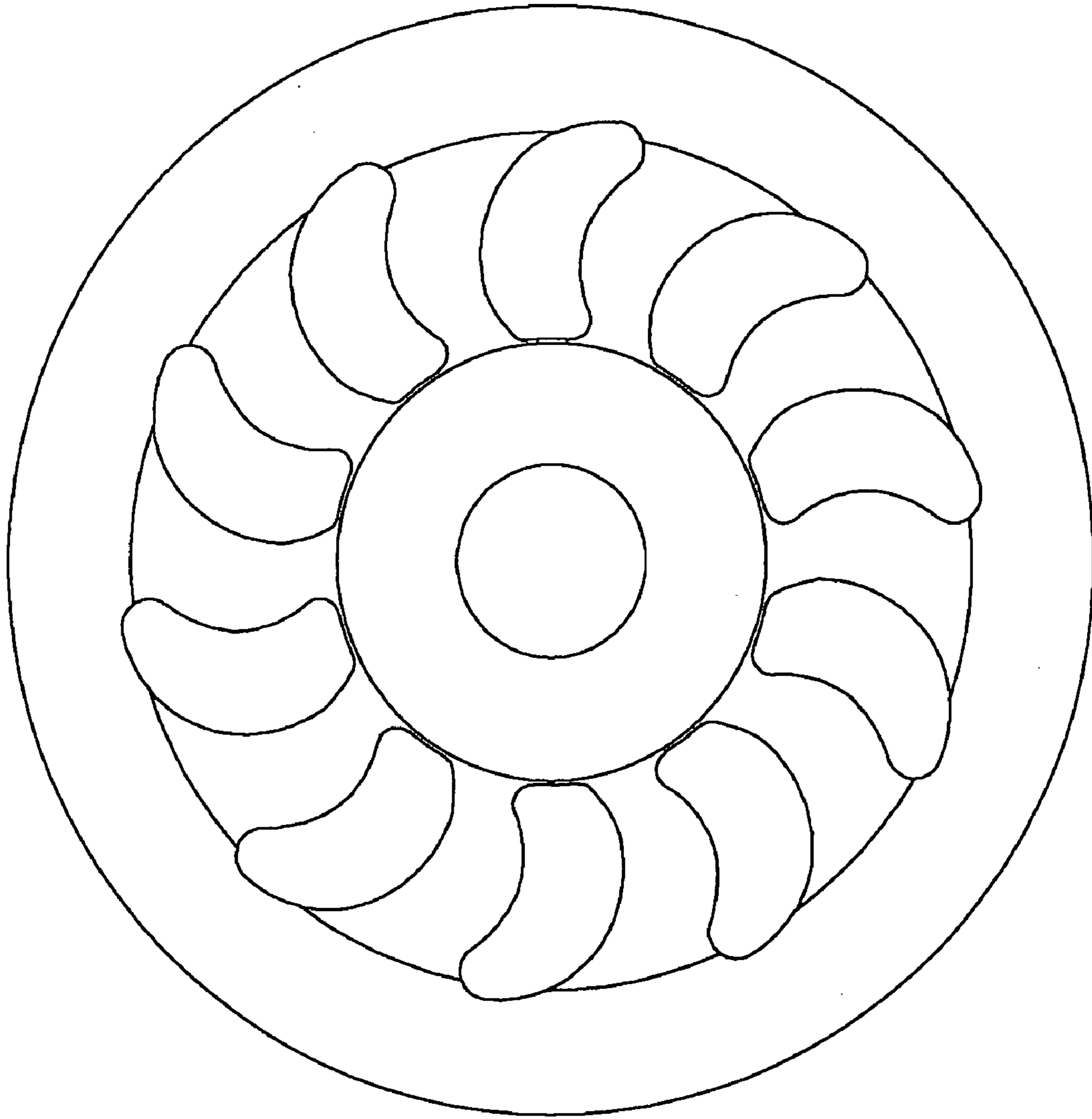

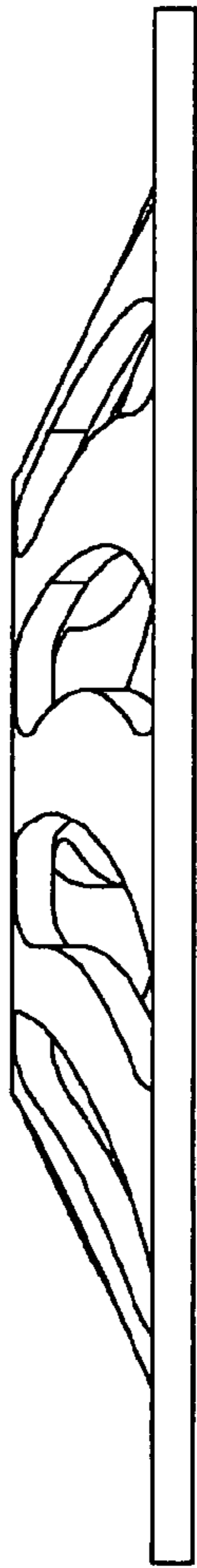

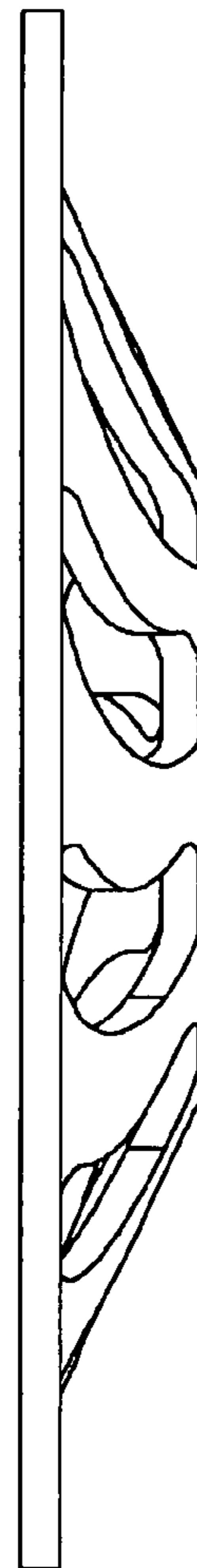

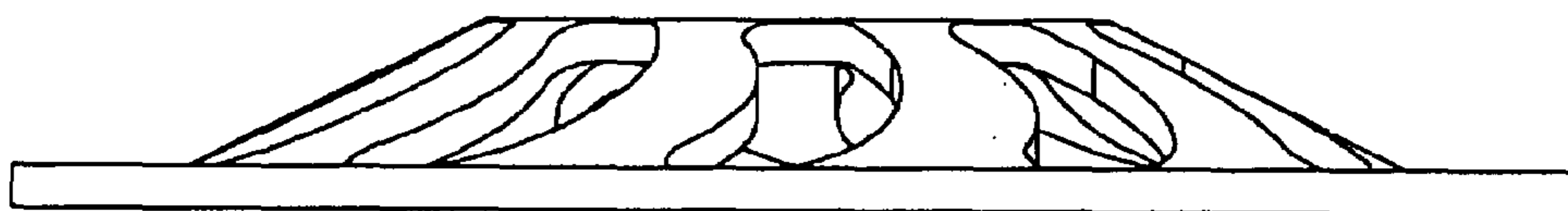

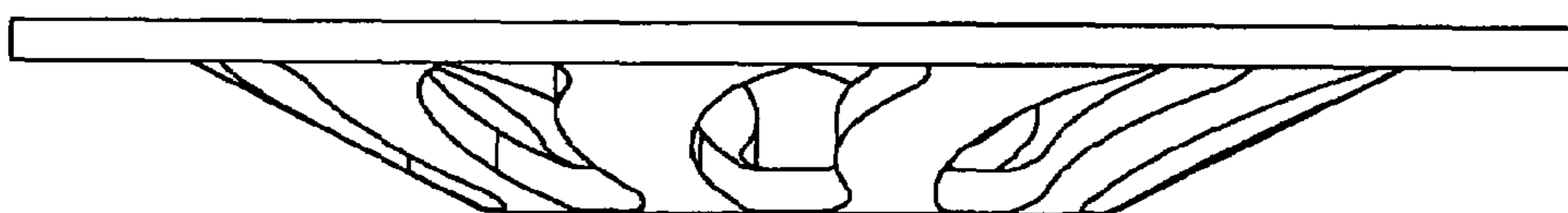

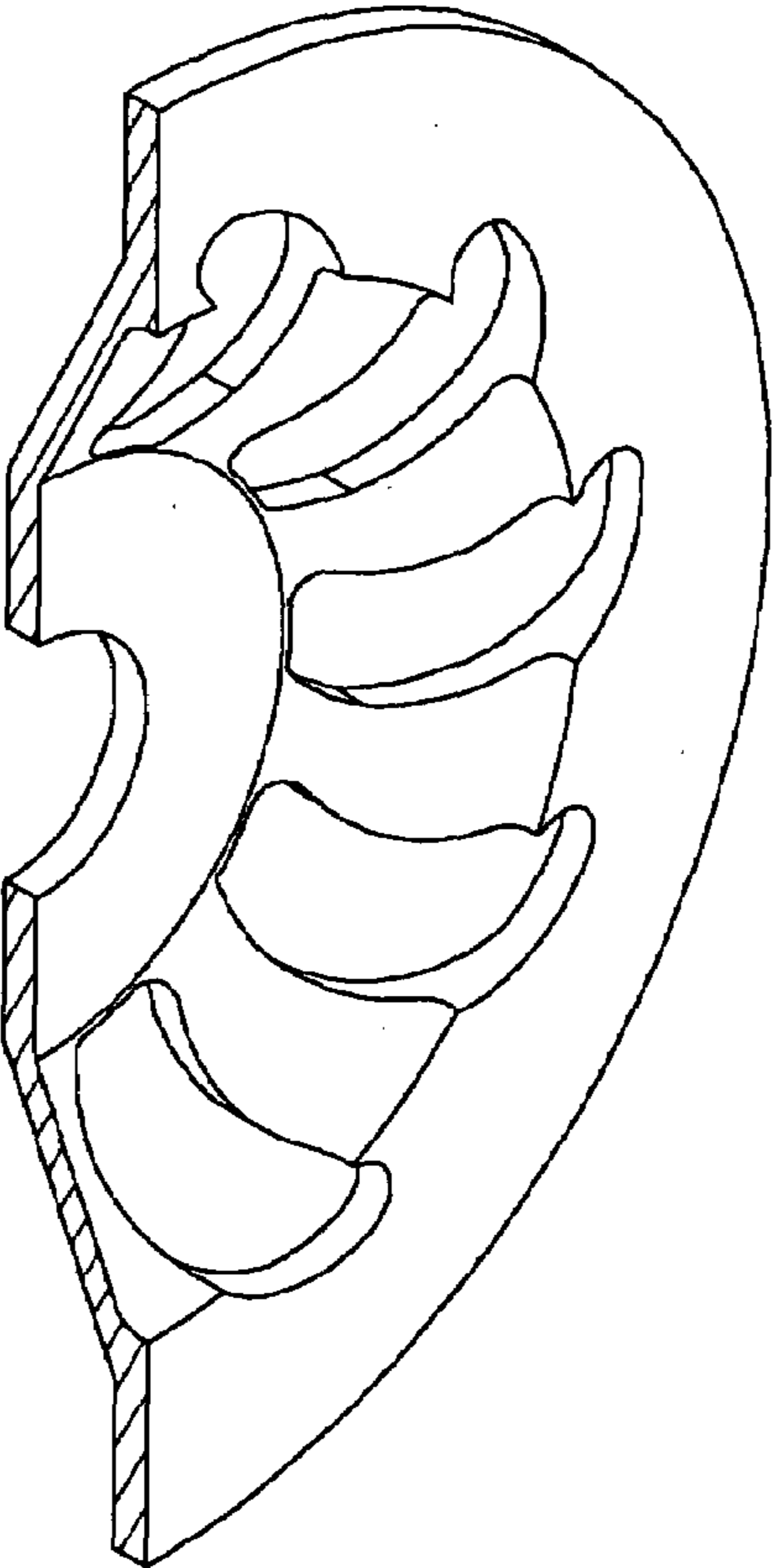

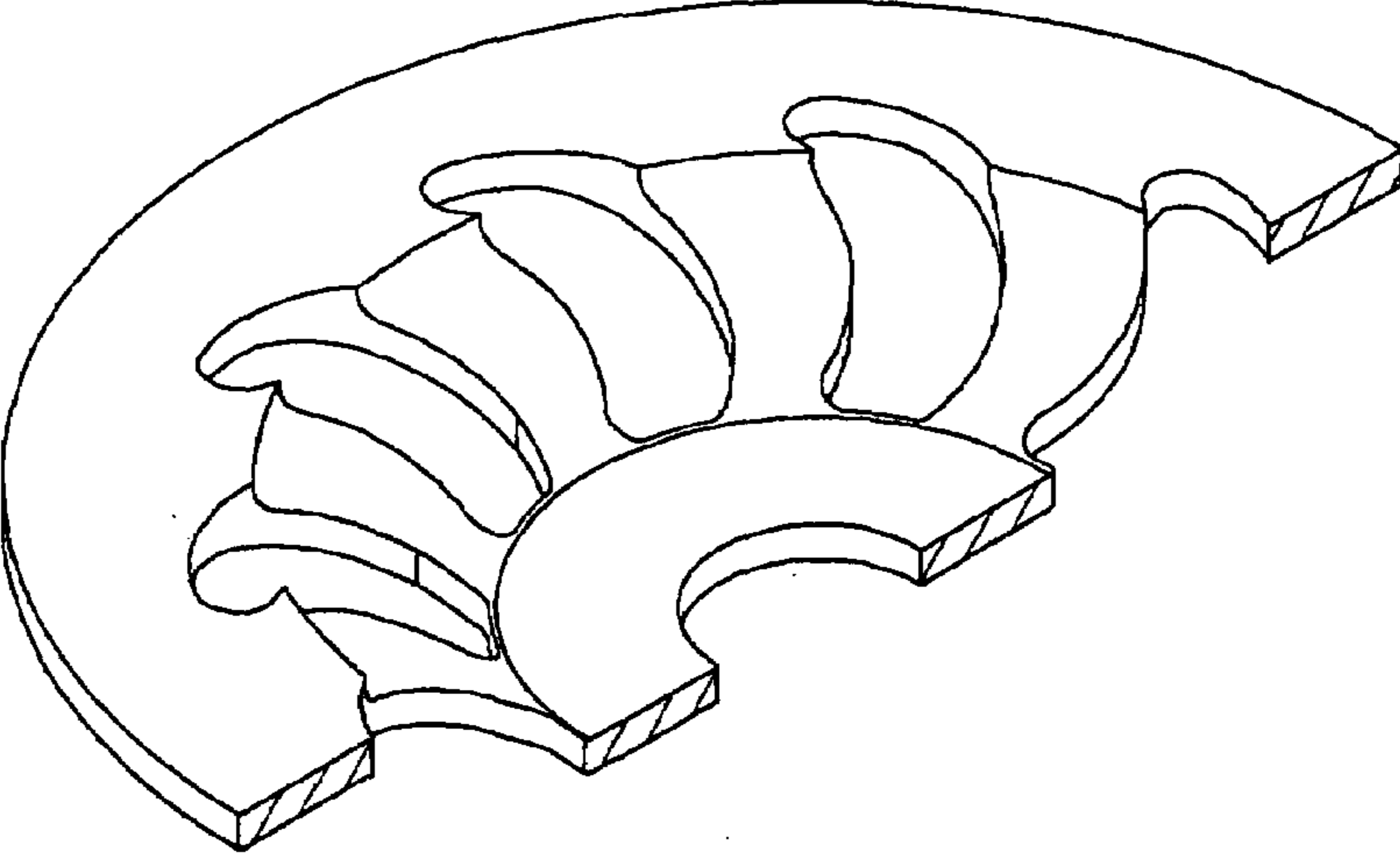

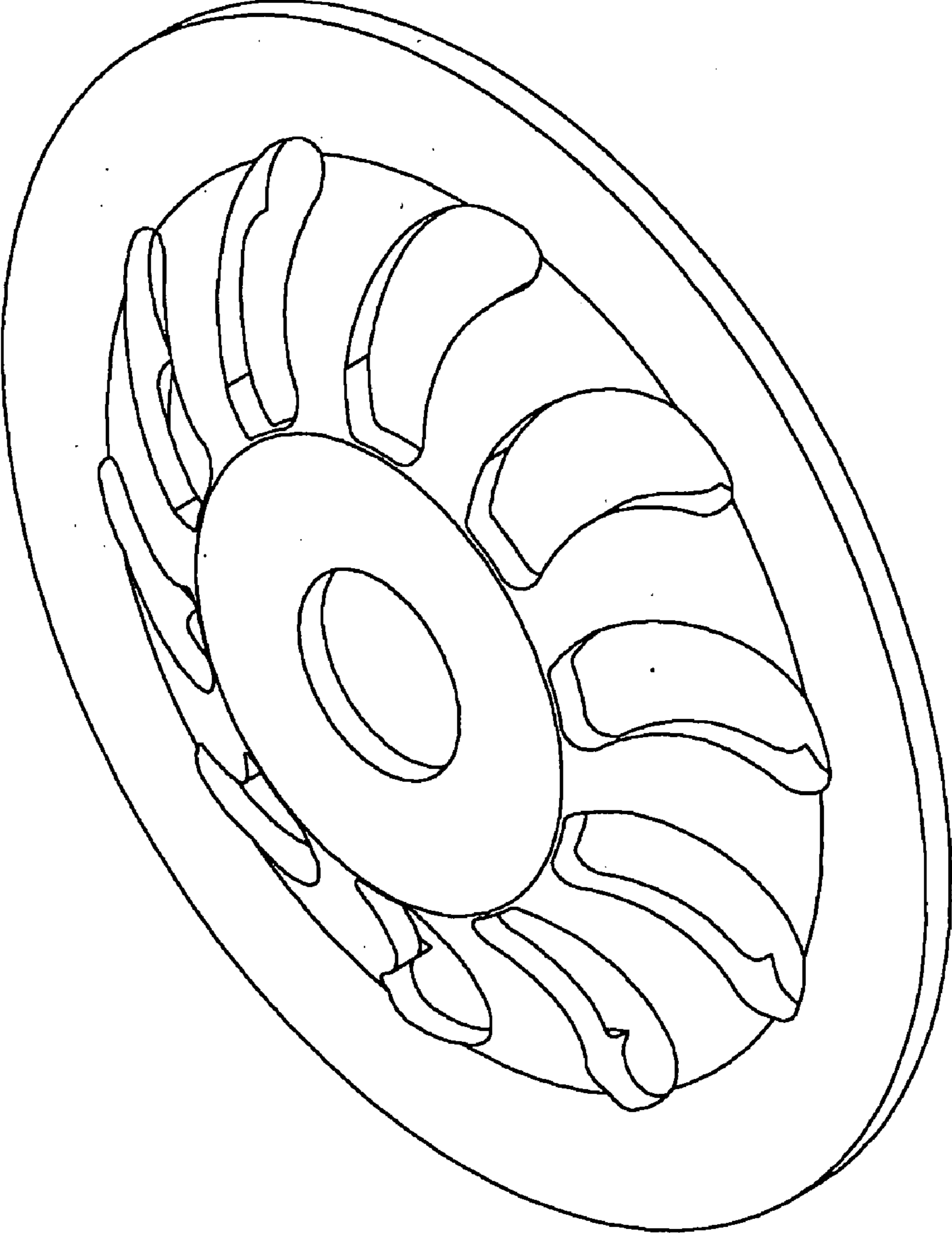

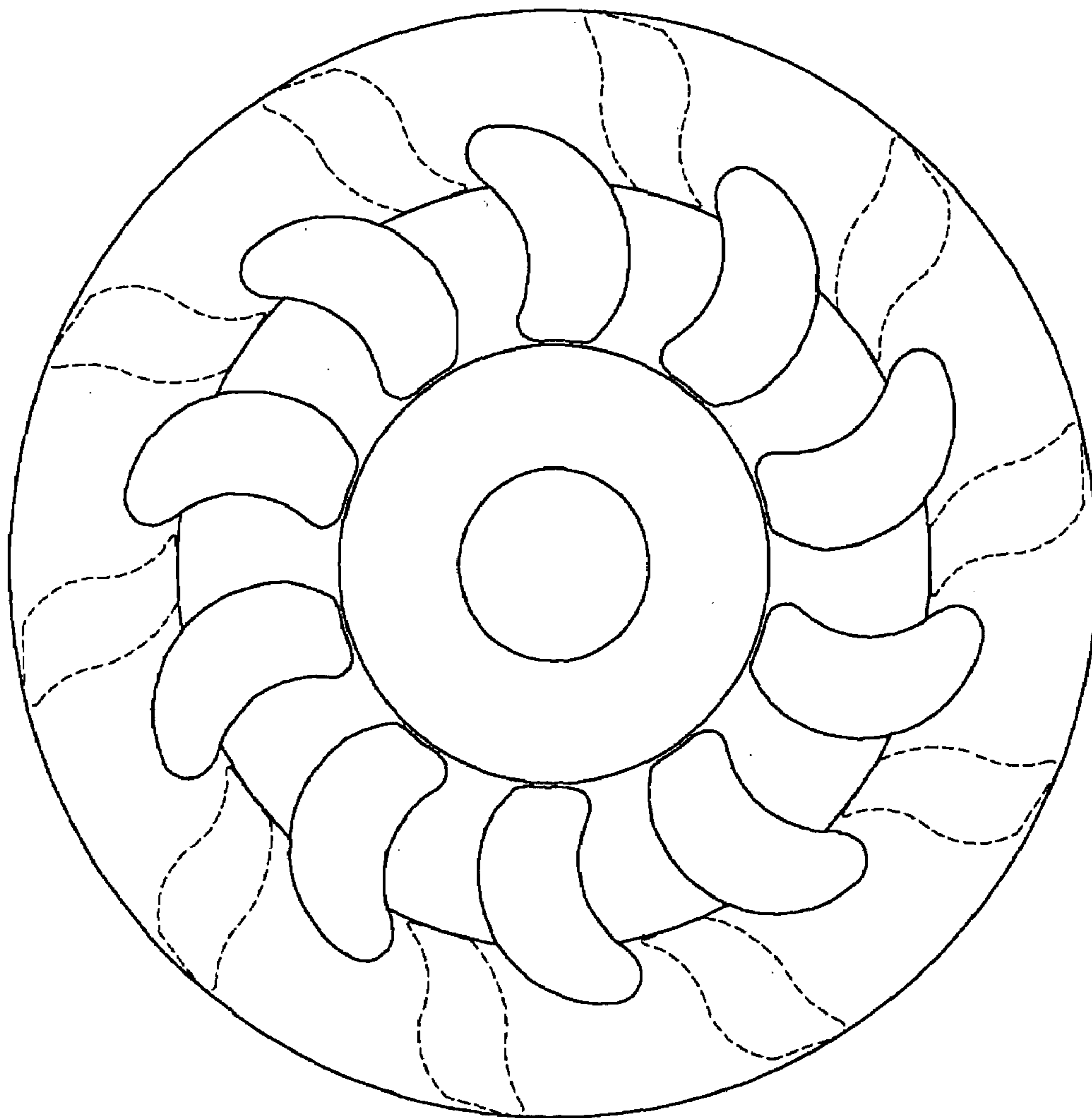
