DESCRIPTION

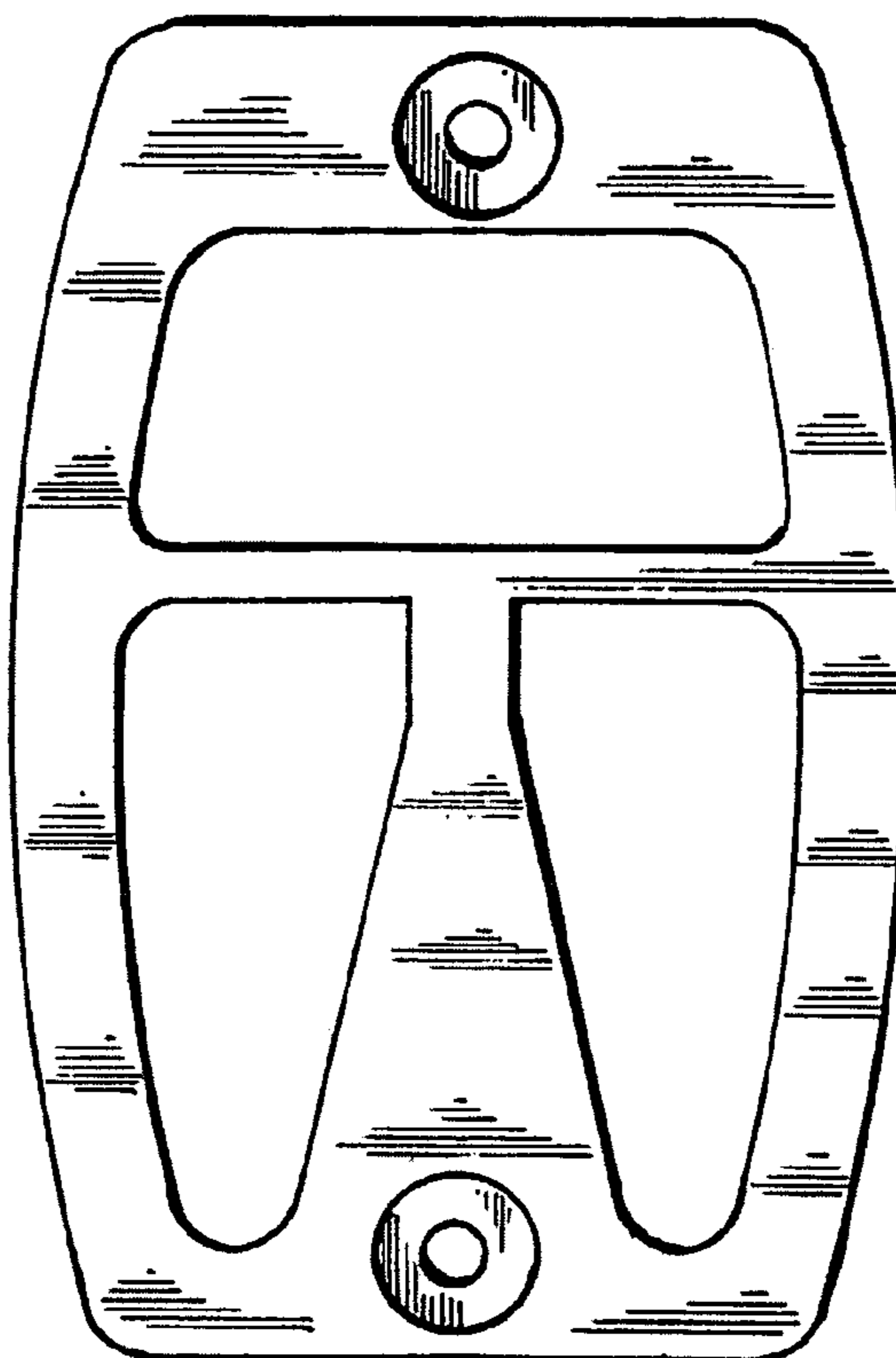
FIG. 1 is a front elevation view of a wall interface for mounting device according to an embodiment of the invention;

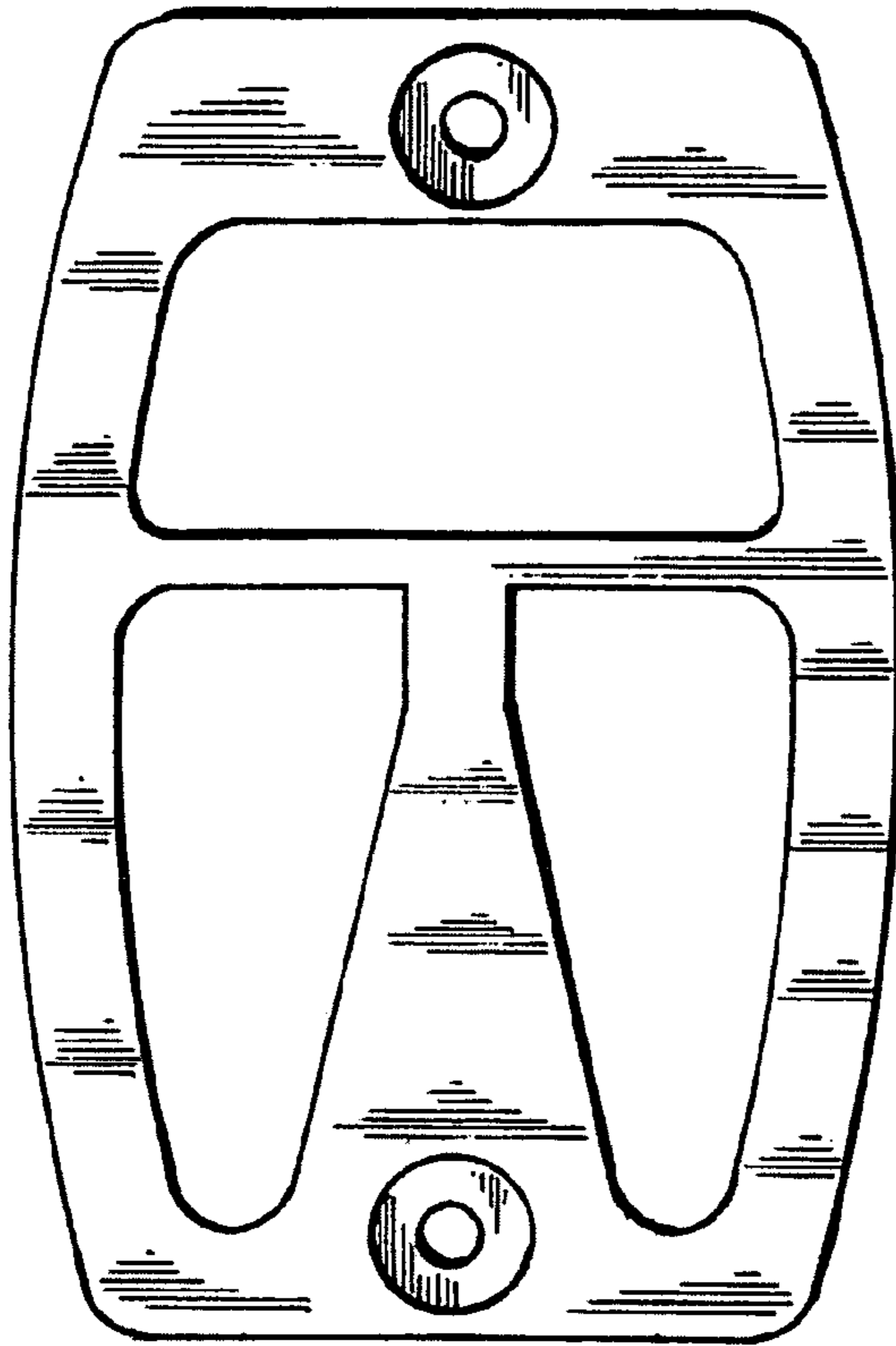

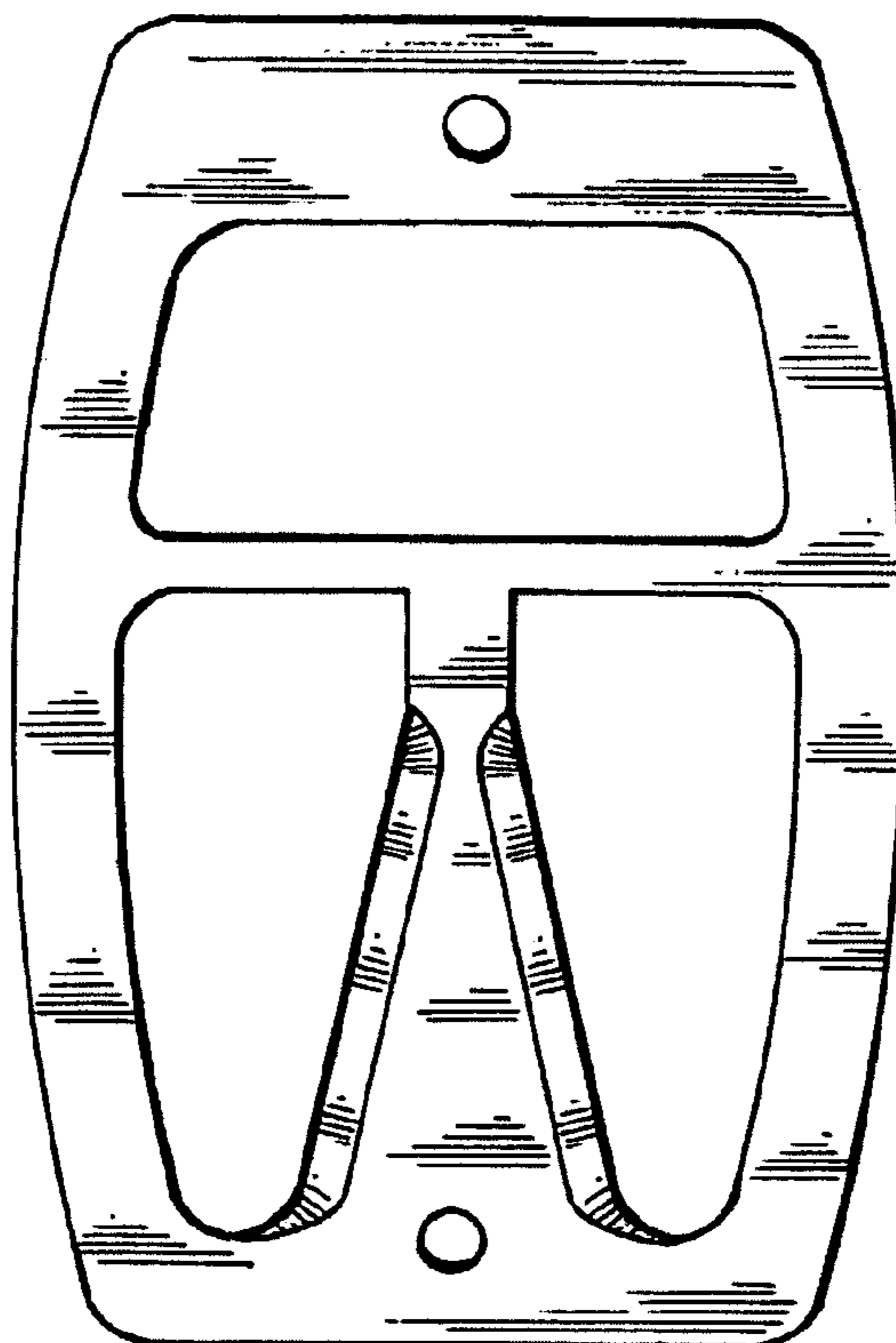
