FIG. 3 is a back view of the strap.

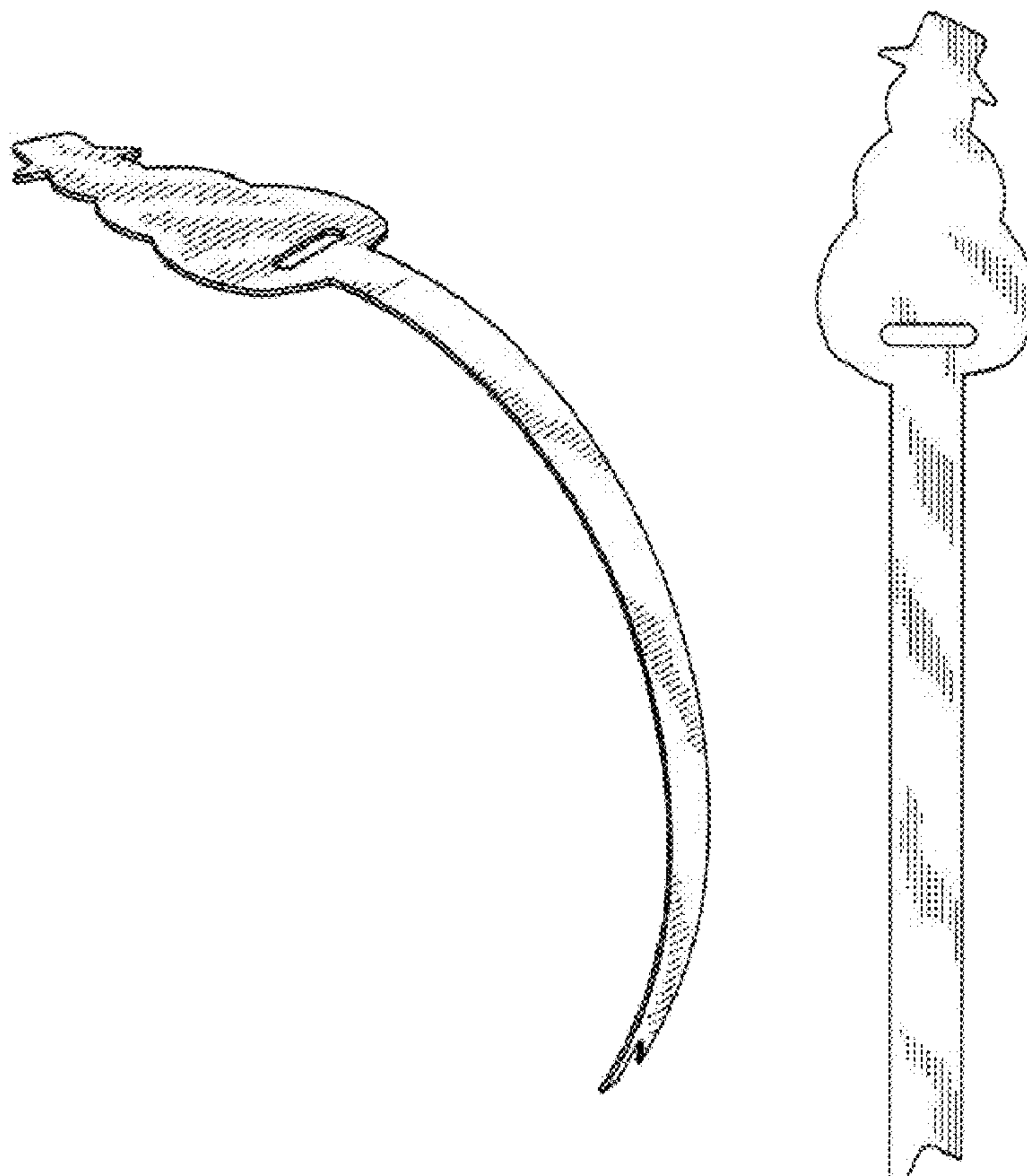
FIG. 4 is a left side view of the strap.

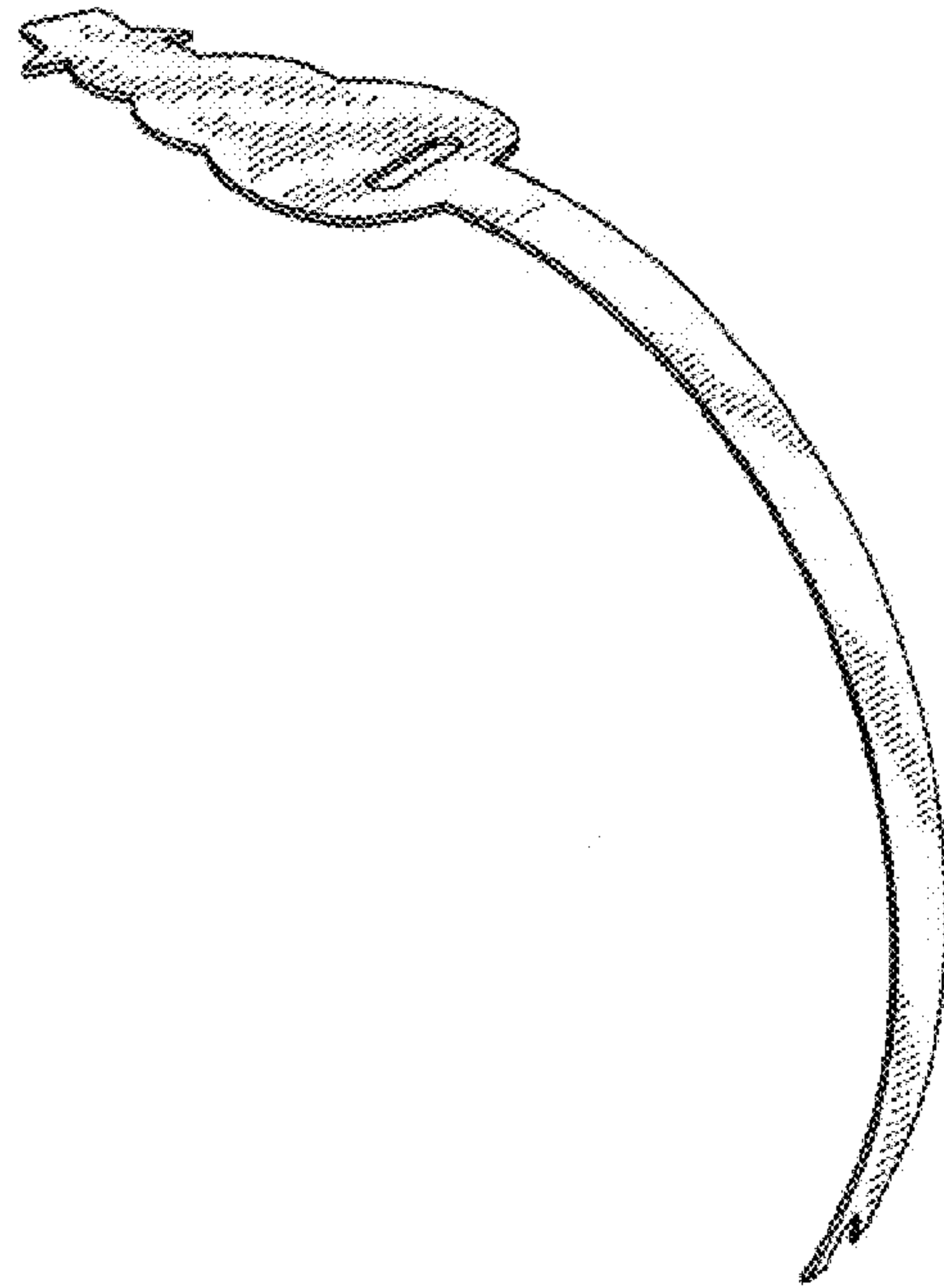

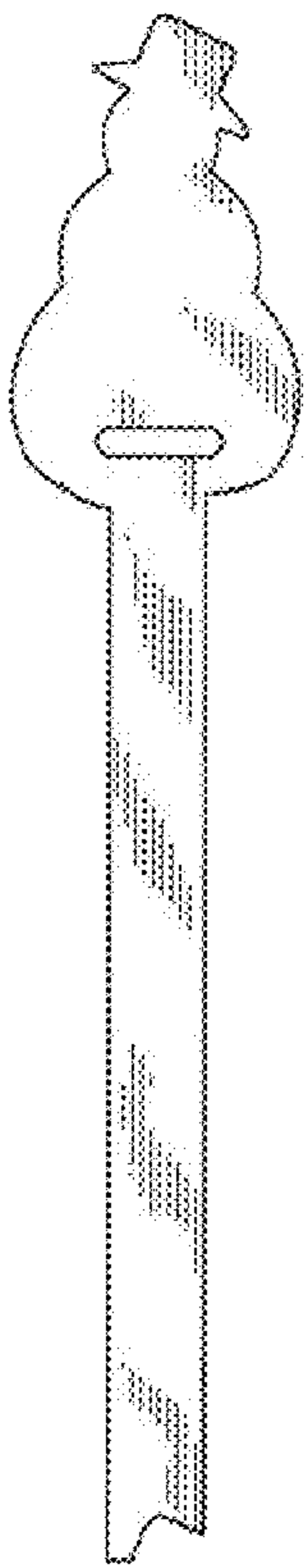

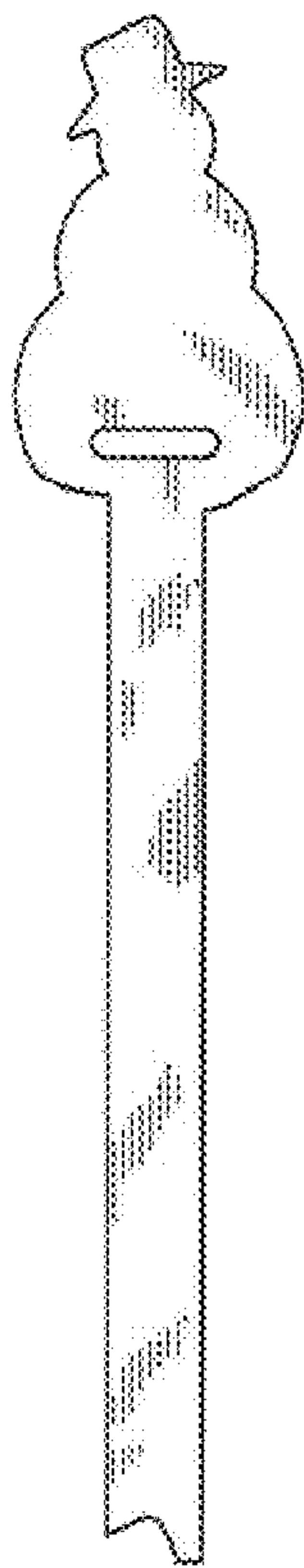
