The ornamental design for a clip with dial display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a clip with dial display showing my new design;

FIG. 2 is a front view of the clip with dial display of FIG. 1;

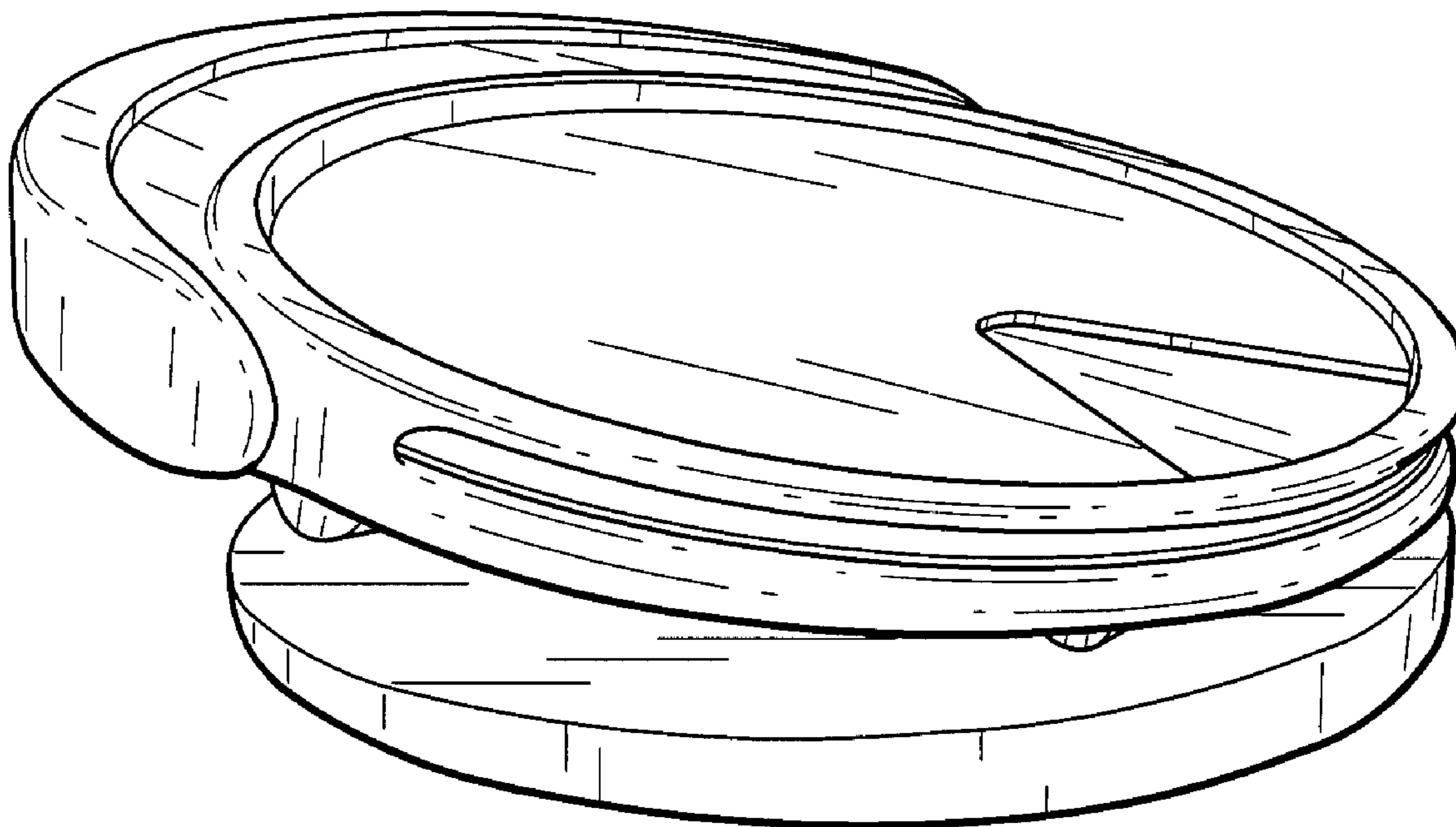
FIG. 3 is a top view of the clip with dial display of FIG. 1;

FIG. 4 is a left side view of the clip with dial display of FIG. 1; the right side view is a mirror image of the left side view and is therefore not shown;

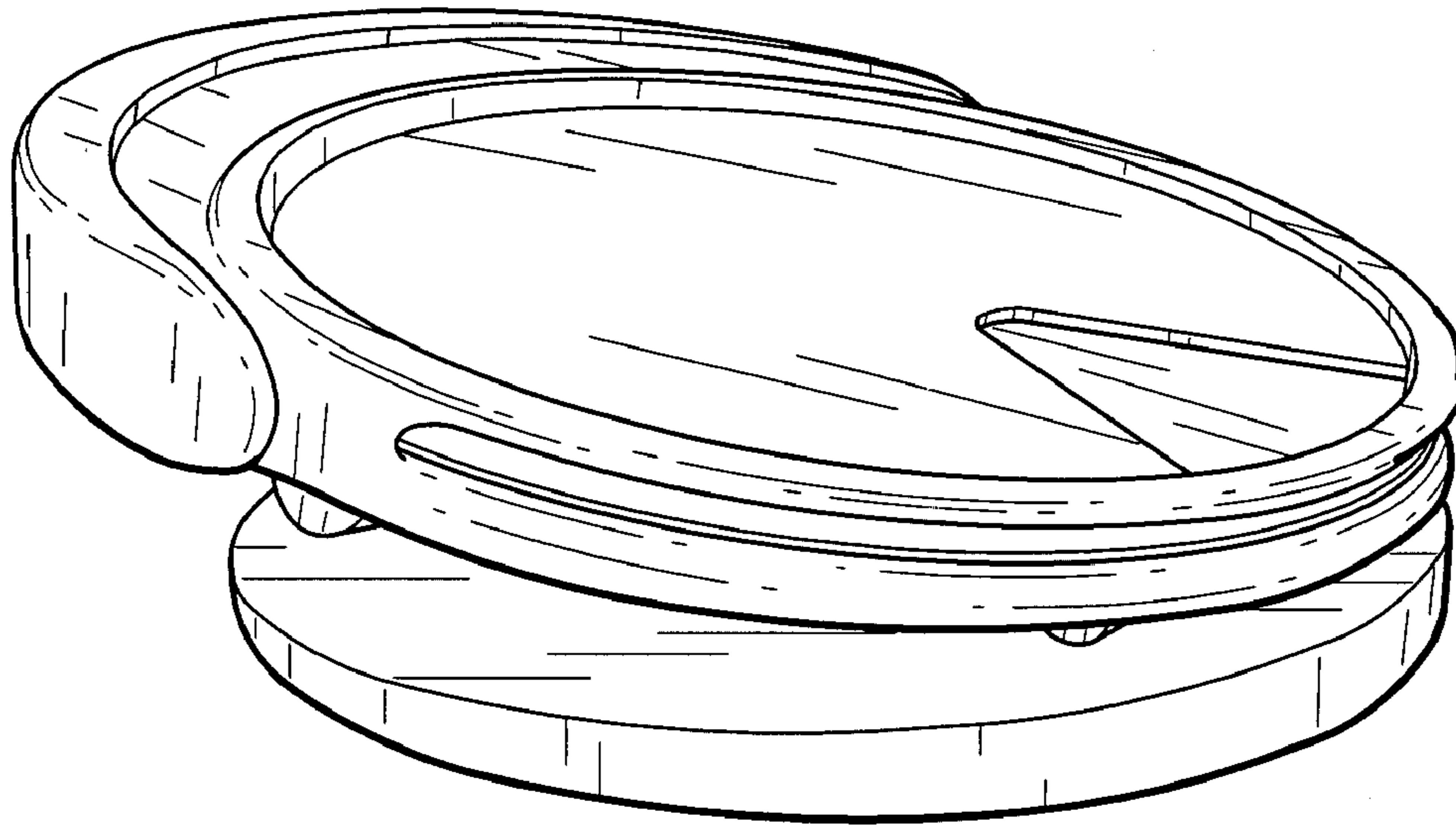

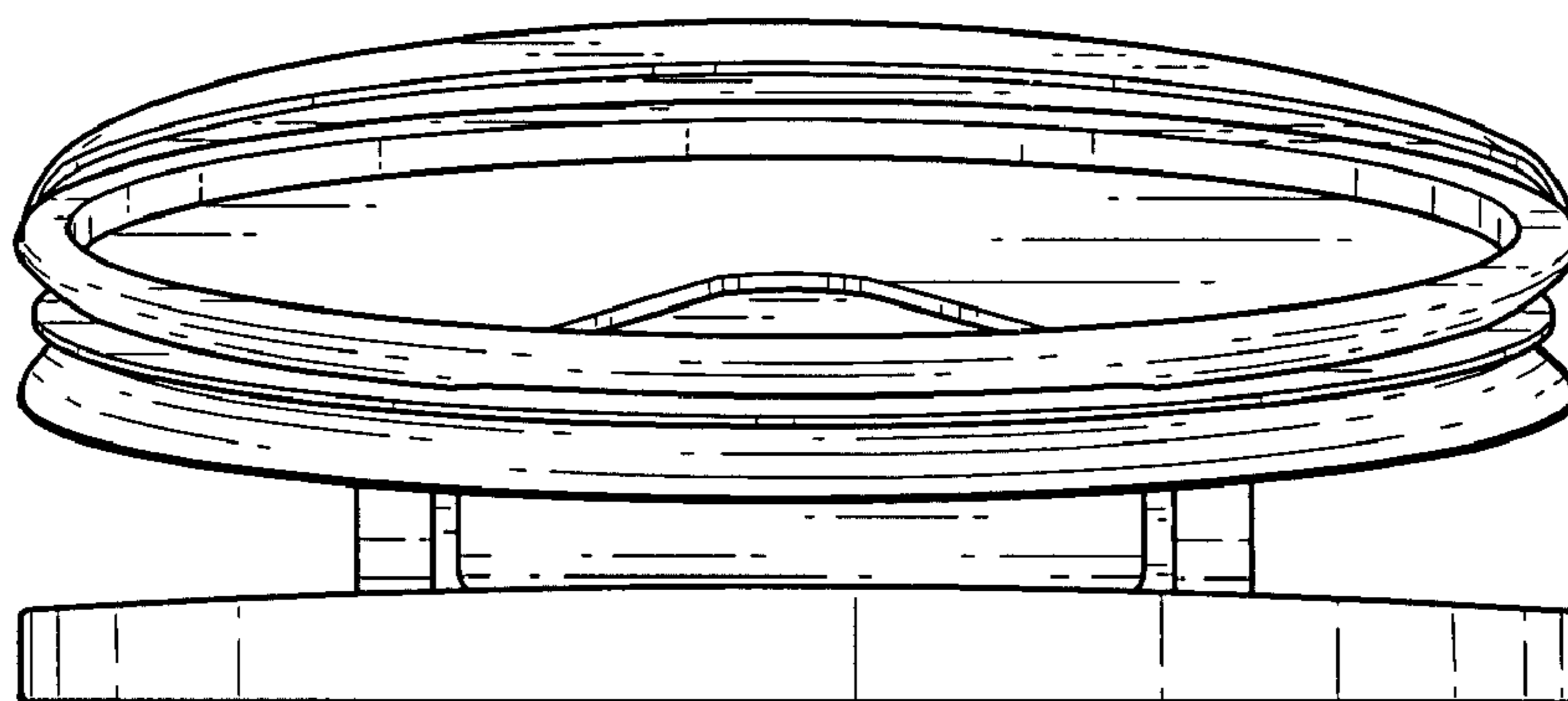

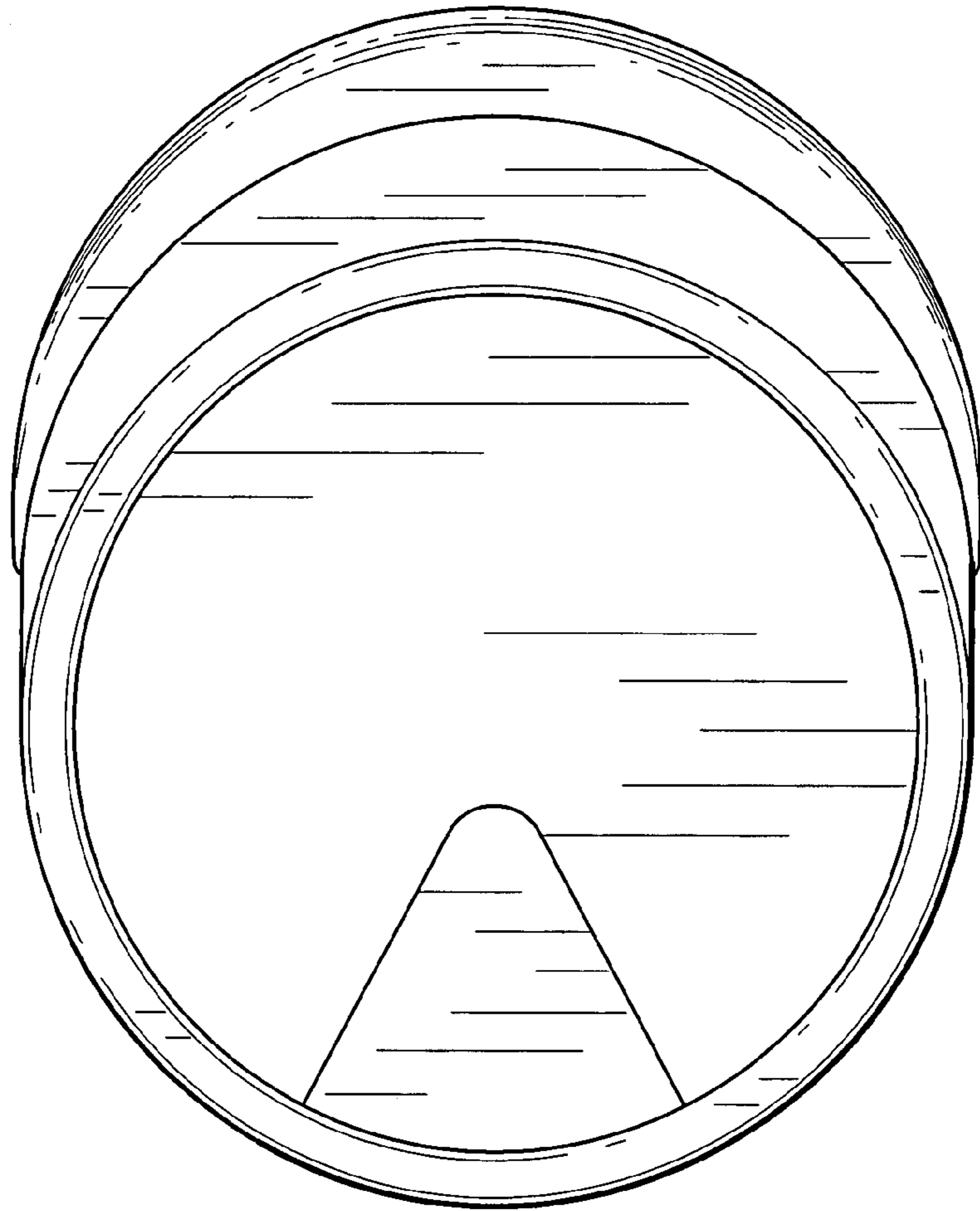

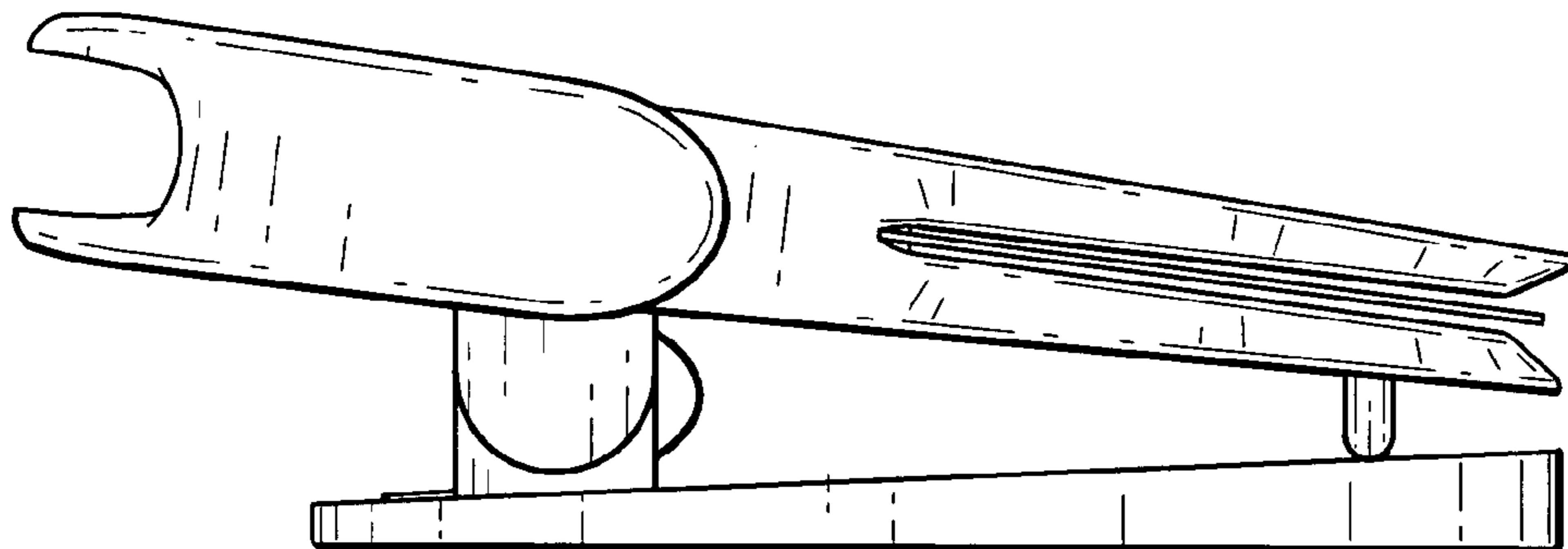

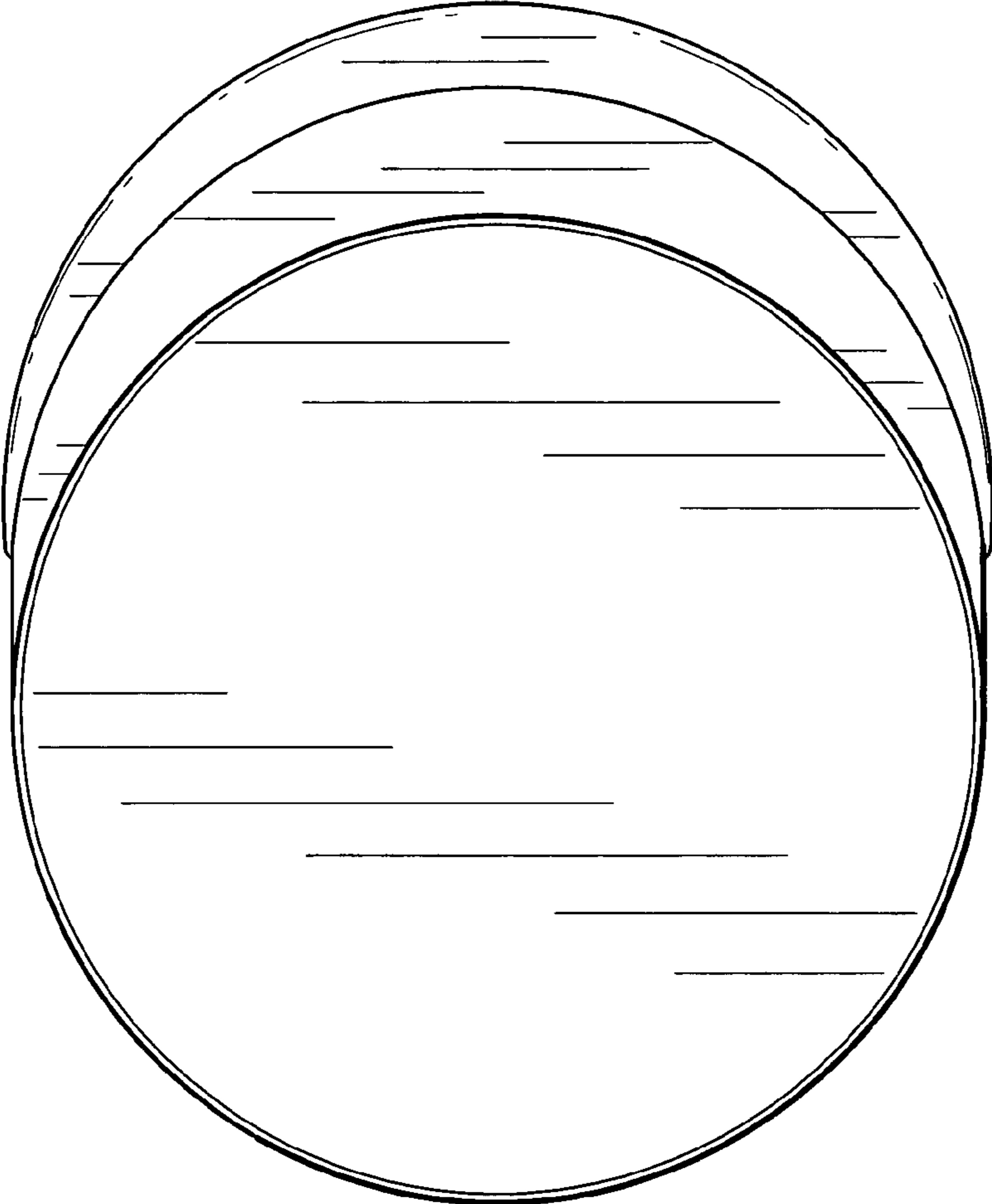

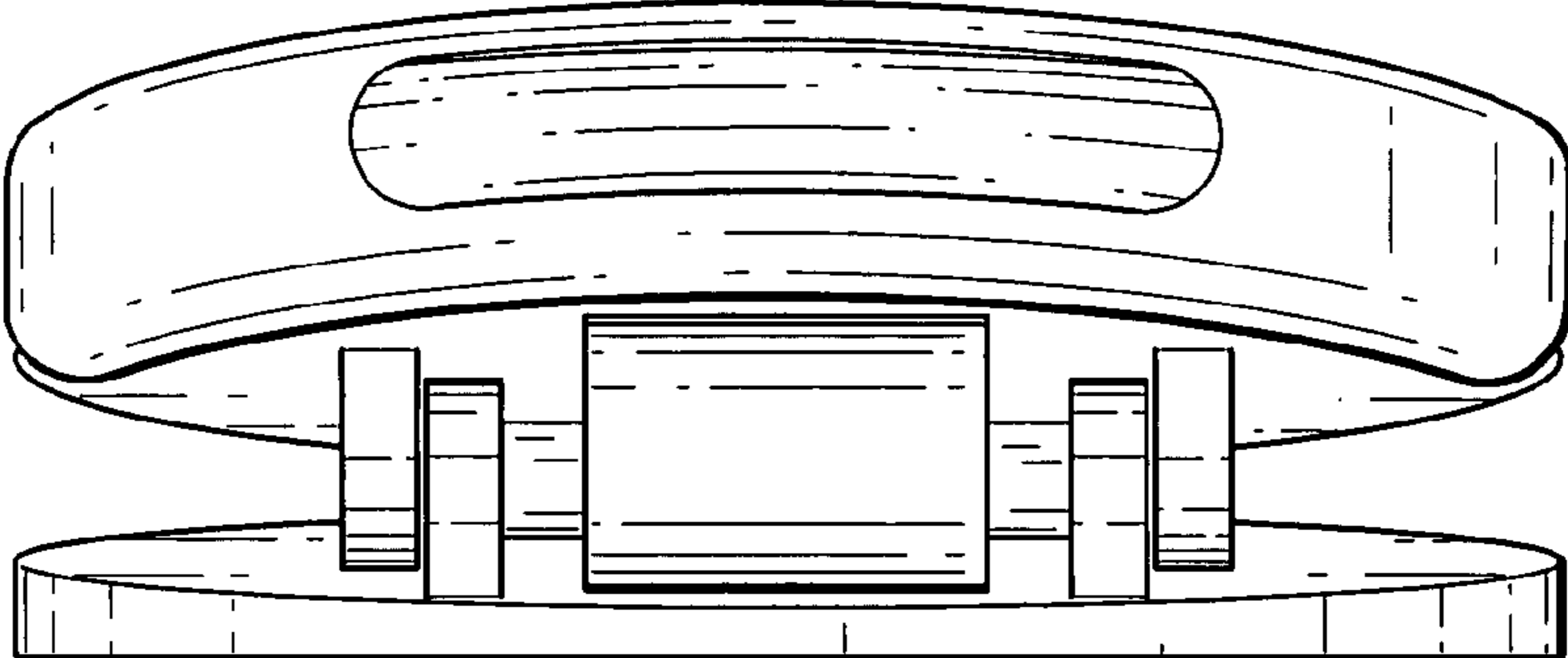
