DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a new design for a bottle;
 FIG. 2 is a rear elevational view thereof;

 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a front elevational view thereof.

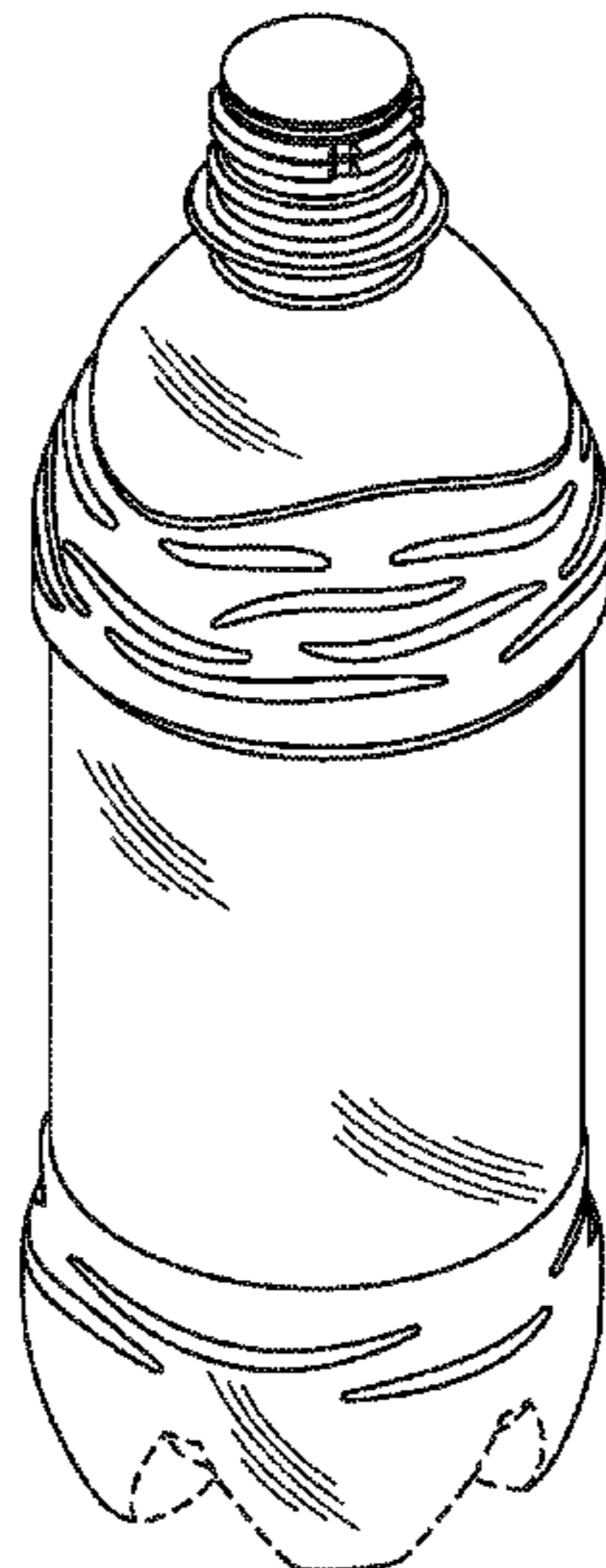

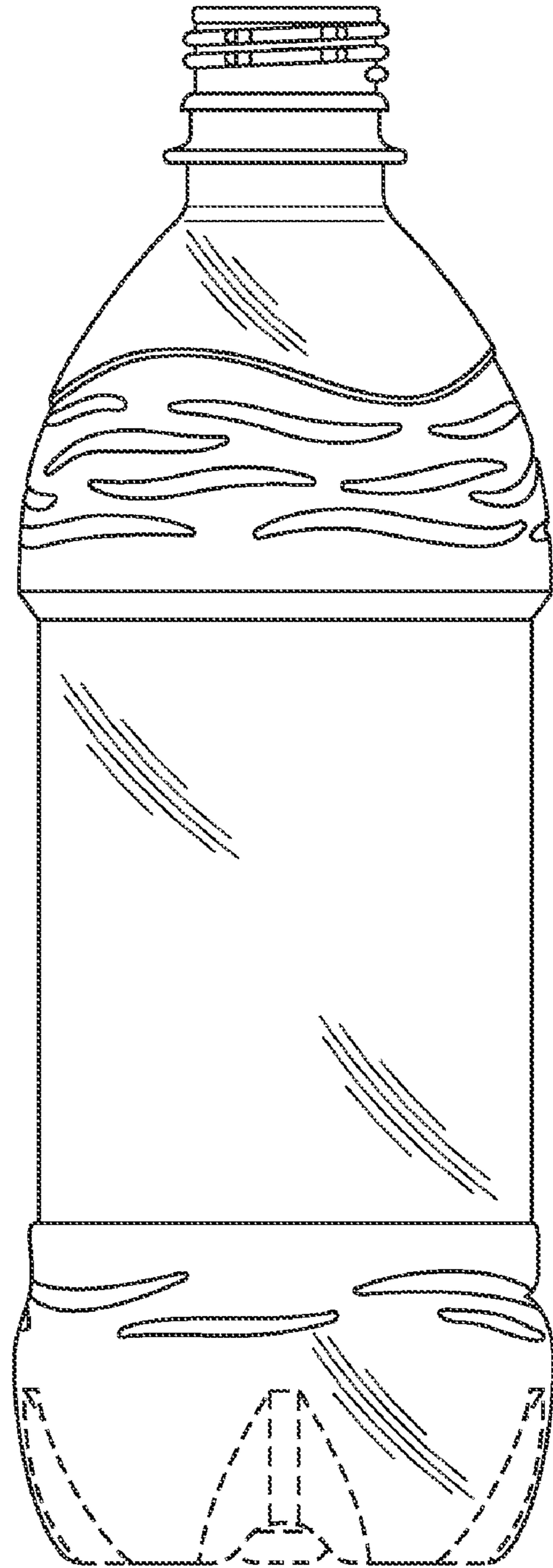

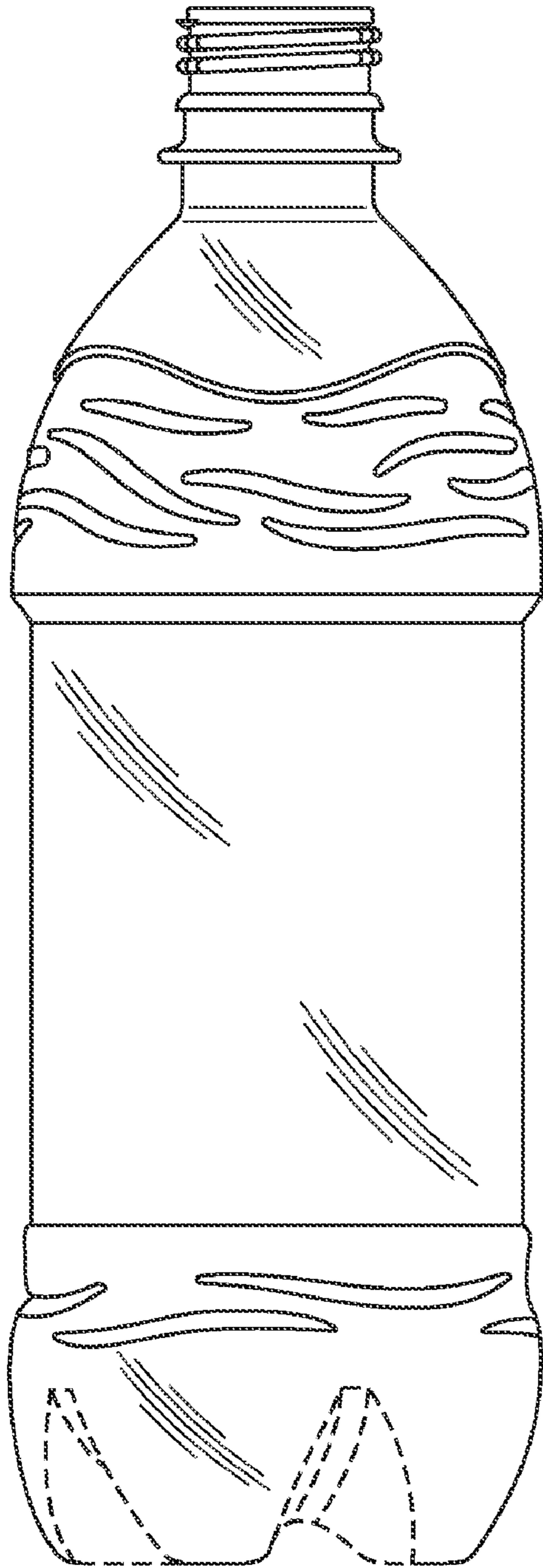

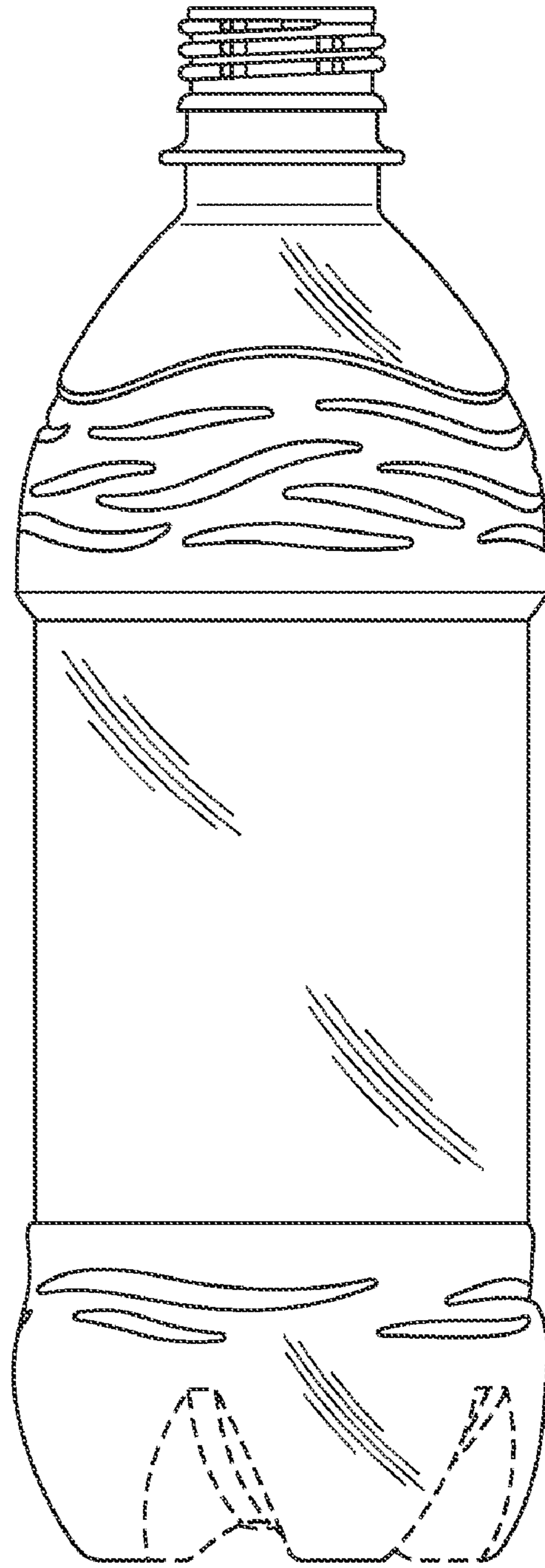

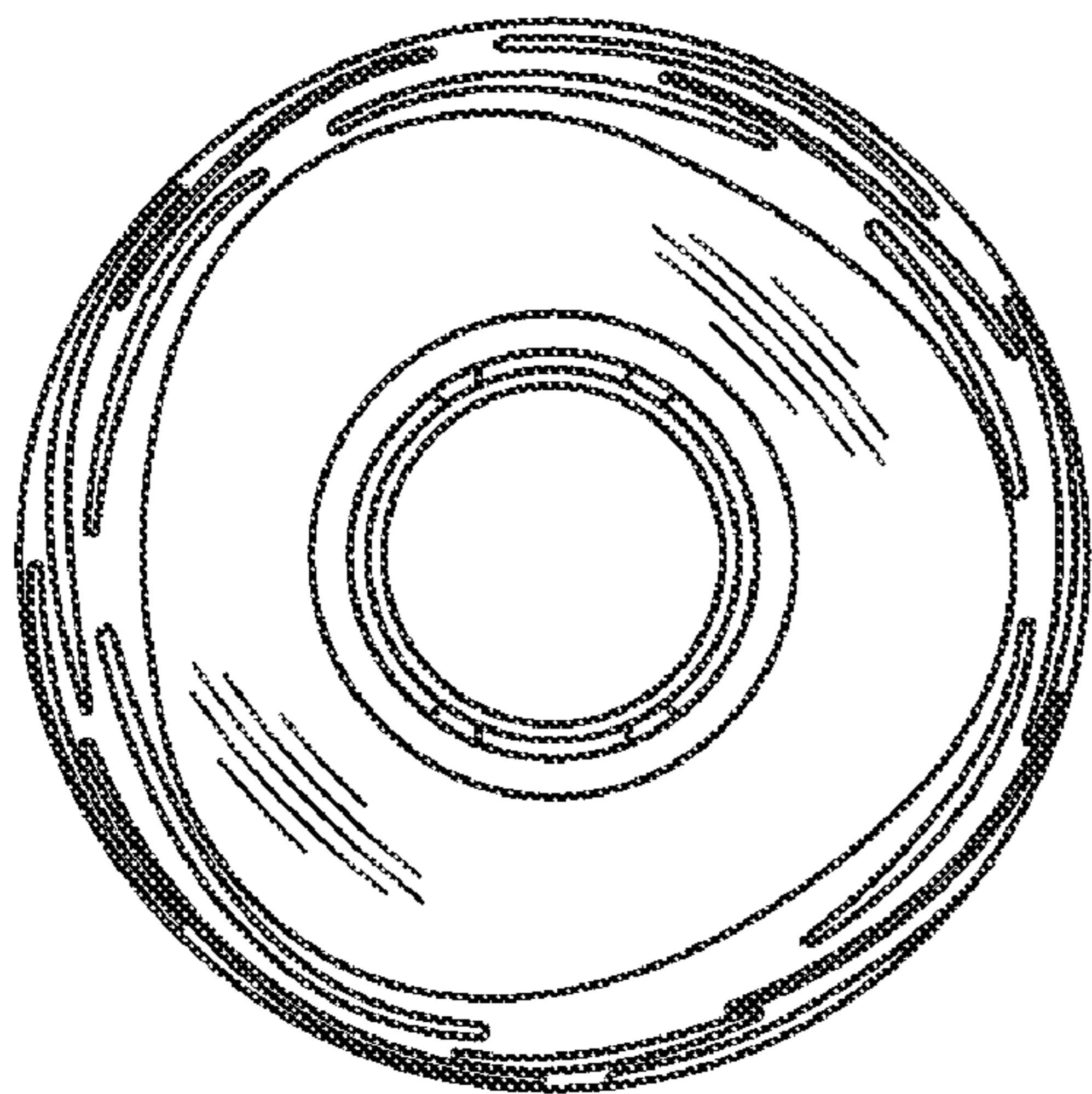

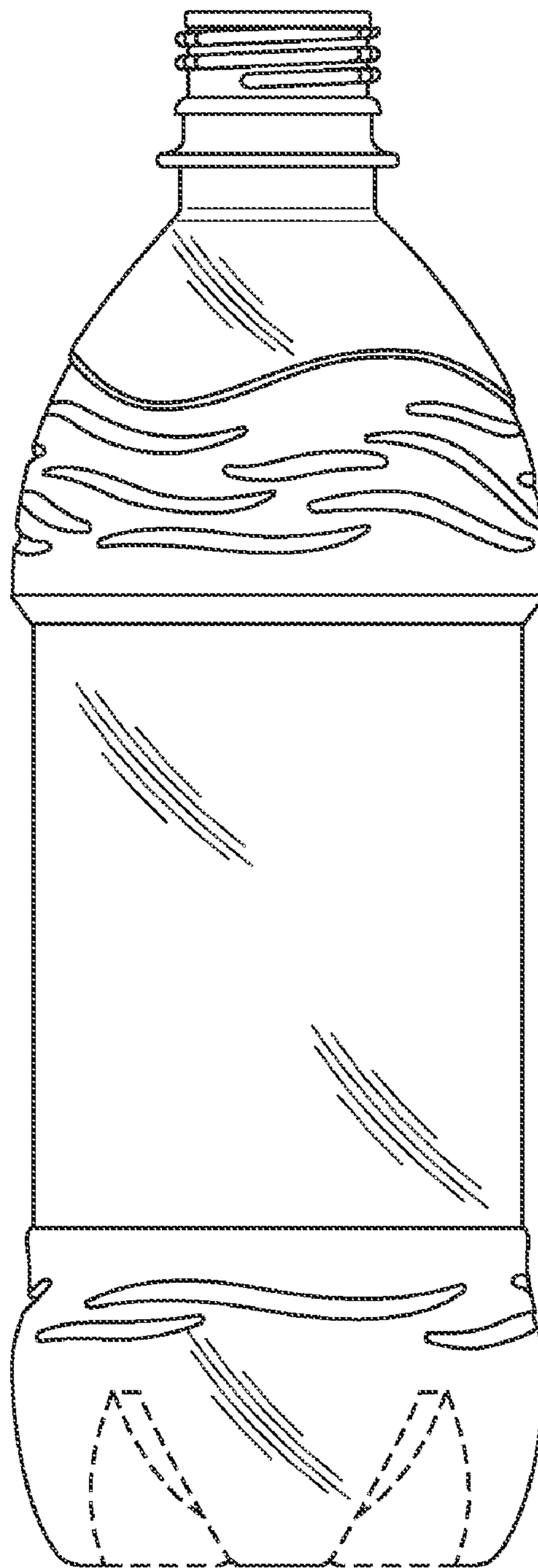
