(57) **CLAIM**

The ornamental design for a dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a dispenser showing the new design;

FIG. 2 is a side elevational view thereof rotated clockwise 90° from FIG. 1;

FIG. 3 is a side elevational view thereof rotated counter clockwise 90° from FIG. 1;

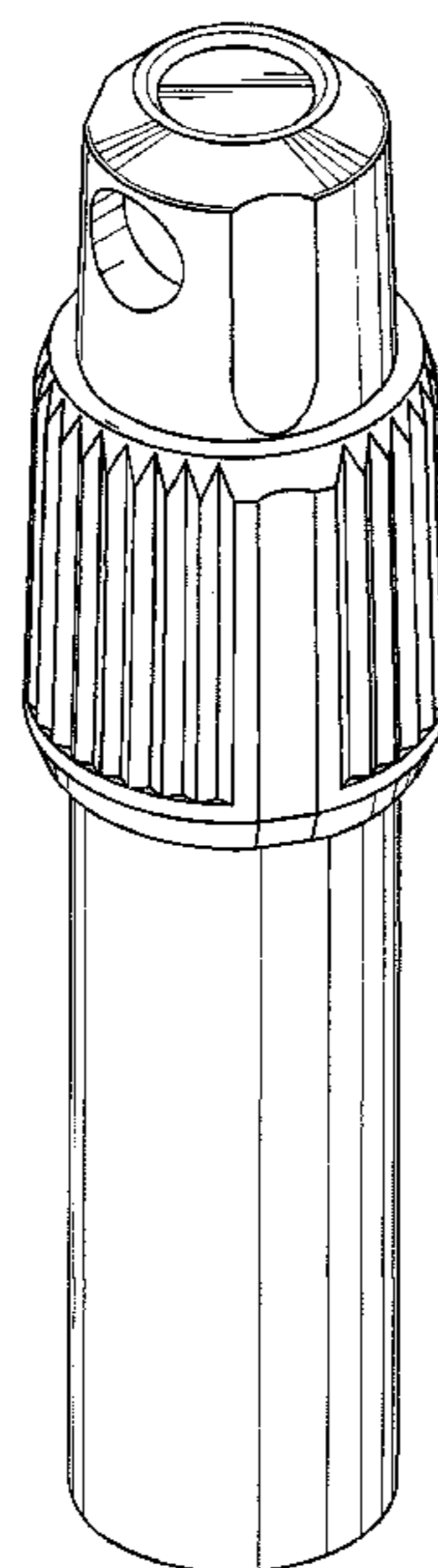
FIG. 4 is a side elevational view thereof rotated clockwise 180° from FIG. 1;

FIG. 5 is a top plan view thereof;

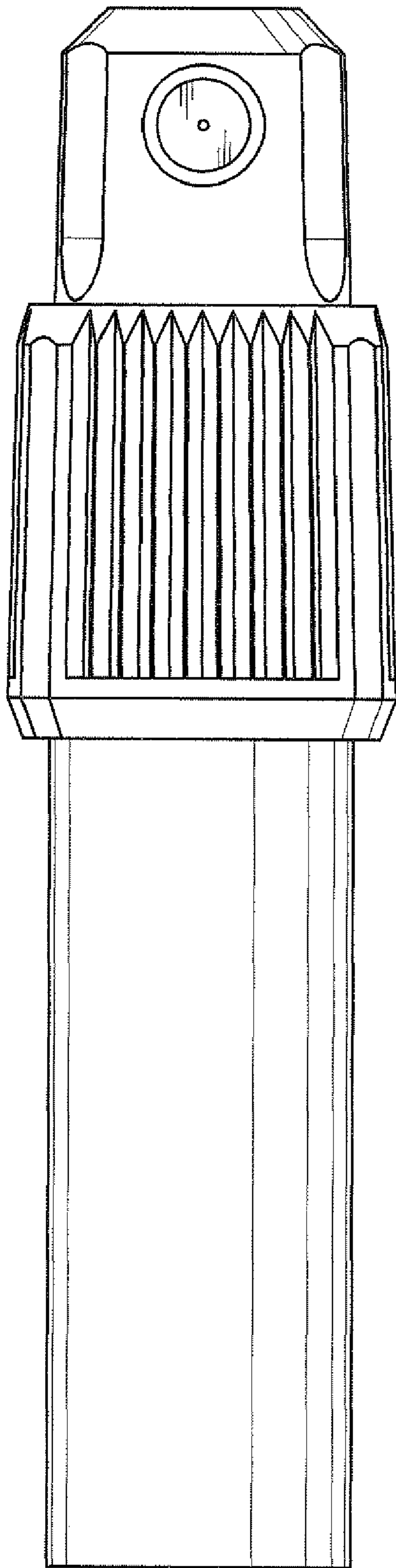

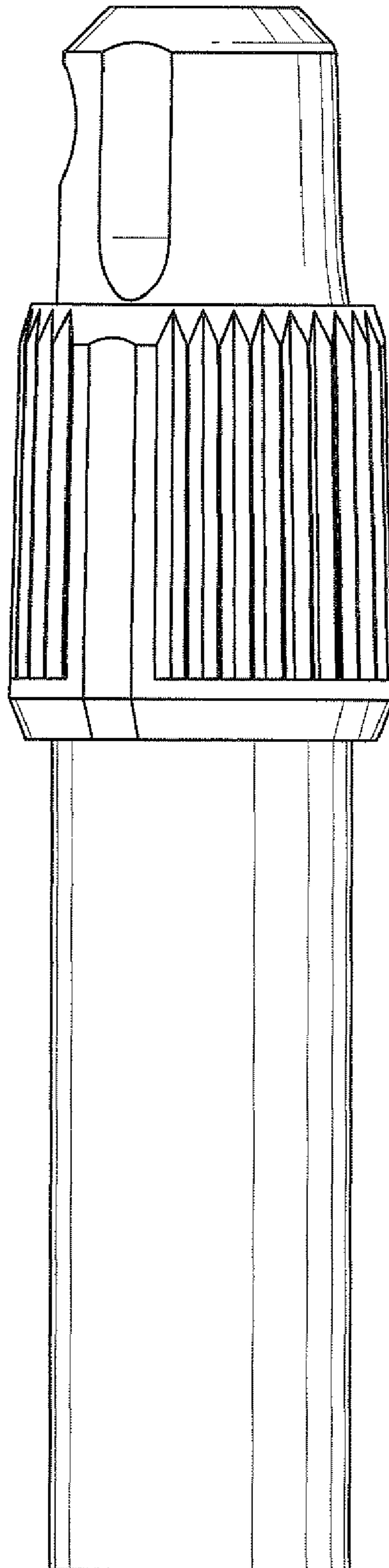

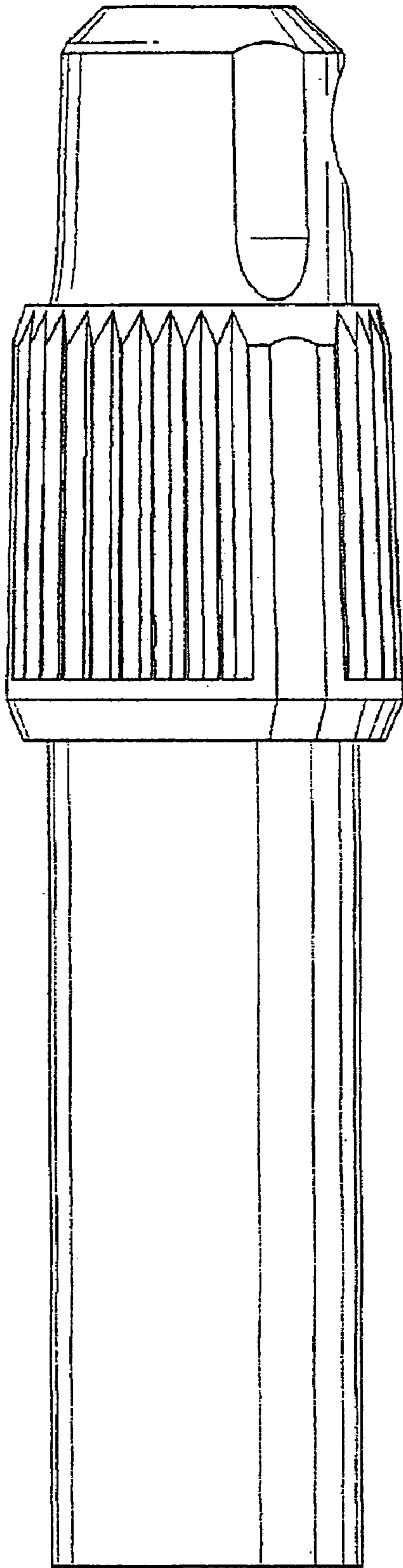

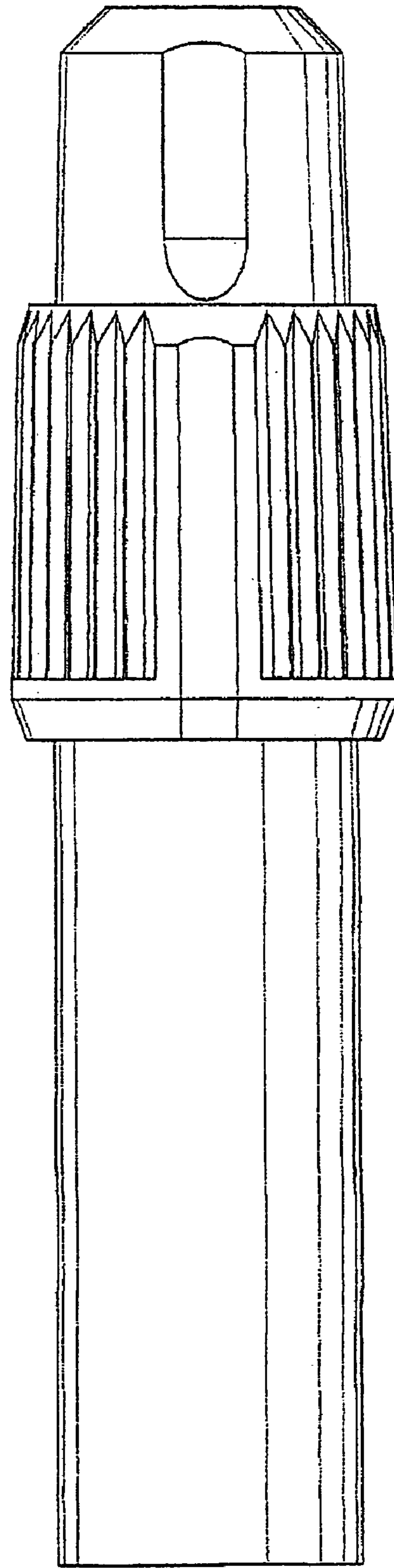

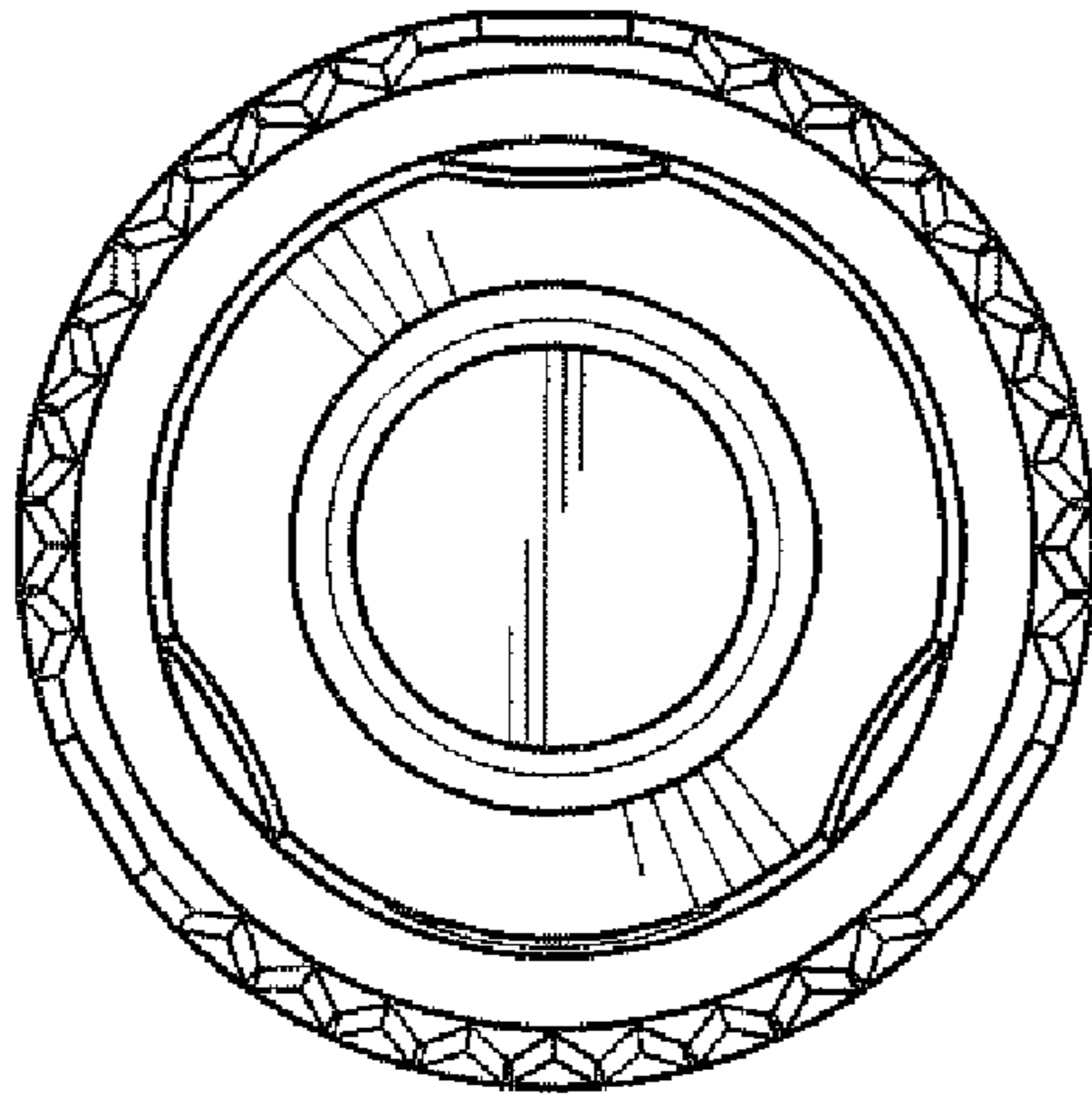
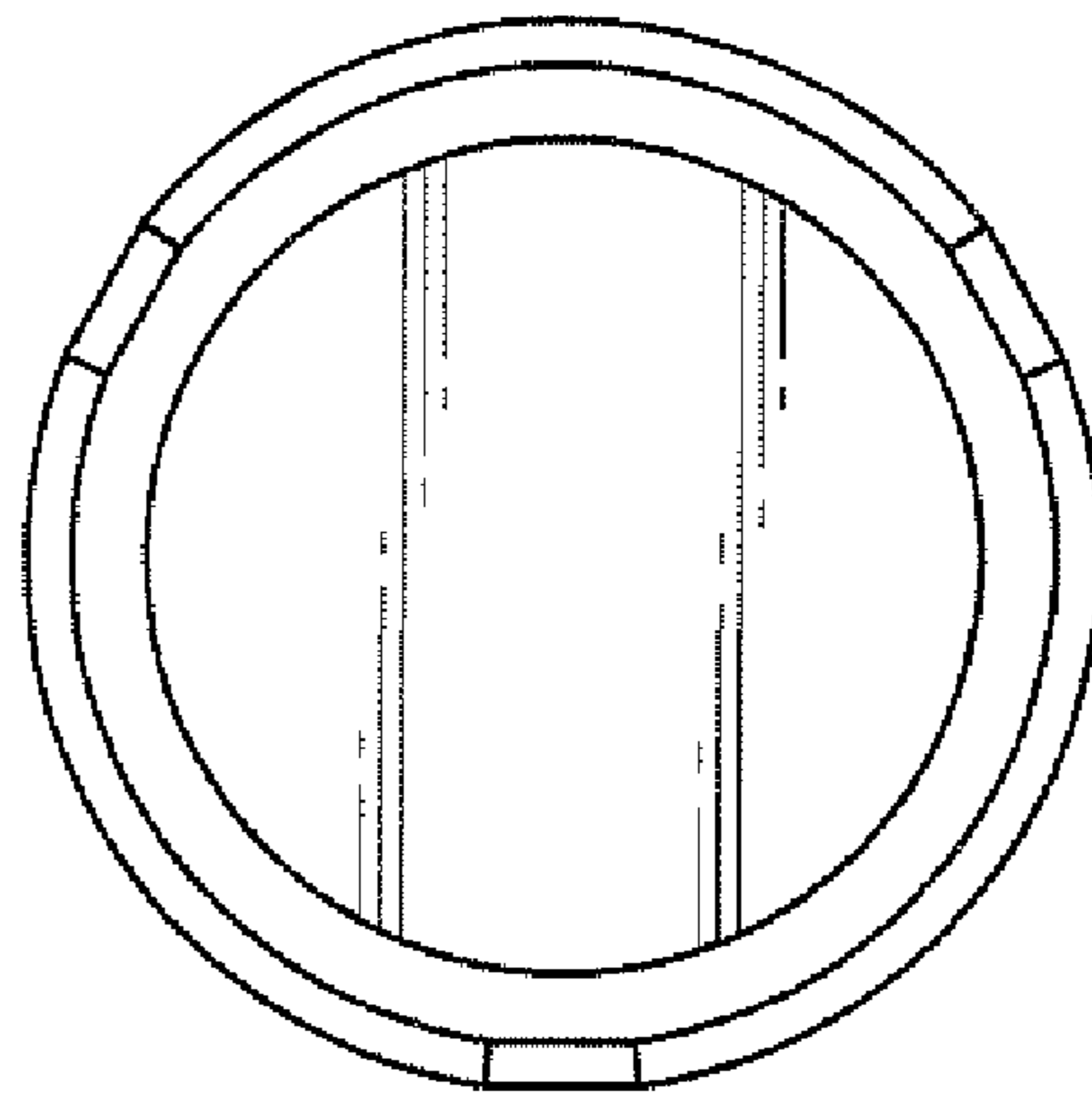

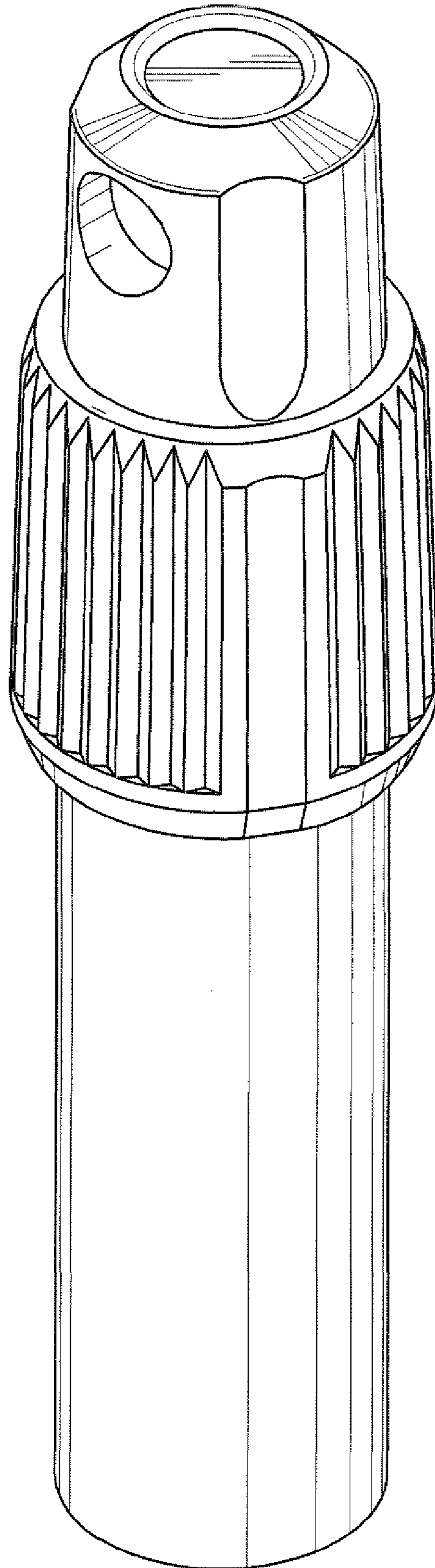
