(57) **CLAIM**

I claim the ornamental design for a USB hub, as shown and described.

DESCRIPTION

FIG. 1 is a top, back, and right side perspective view of the USB hub.

FIG. 2 is a bottom, front, and right side perspective view.

FIG. 3 is a top, front, and left side perspective view.

FIG. 4 is a bottom, back, and left side perspective view.

FIG. 5 is a reduced back view.

FIG. 6 is a reduced top view.

FIG. 7 is a reduced front view.

FIG. 8 is a reduced bottom view.

FIG. 9 is a reduced left side view.

FIG. 10 is a reduced right side view.

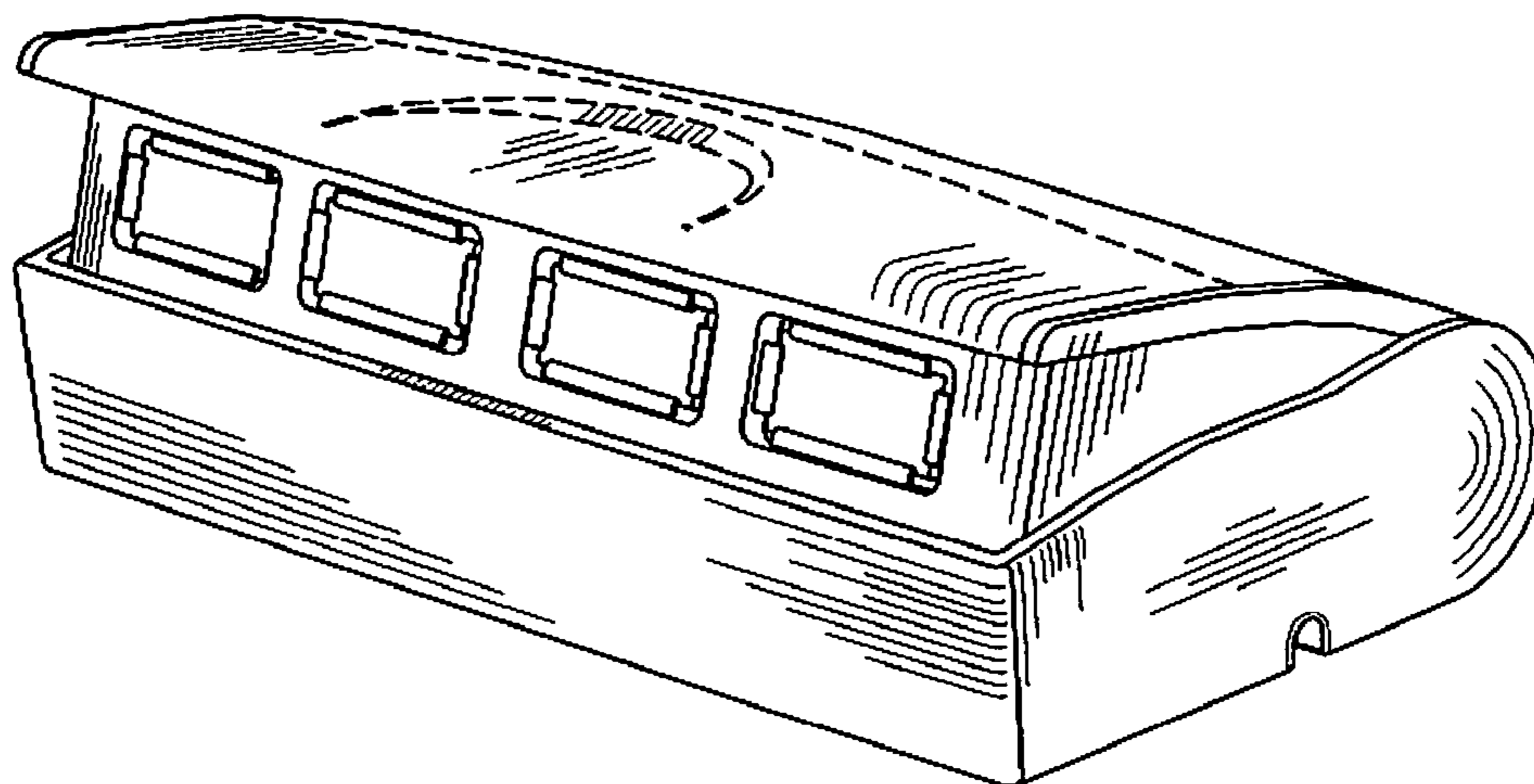
FIG. 11 is a top, back, and right side perspective view showing the USB hub in an open position; and,

FIG. 12 is a top, front, and left side perspective view showing the USB hub in an open position.

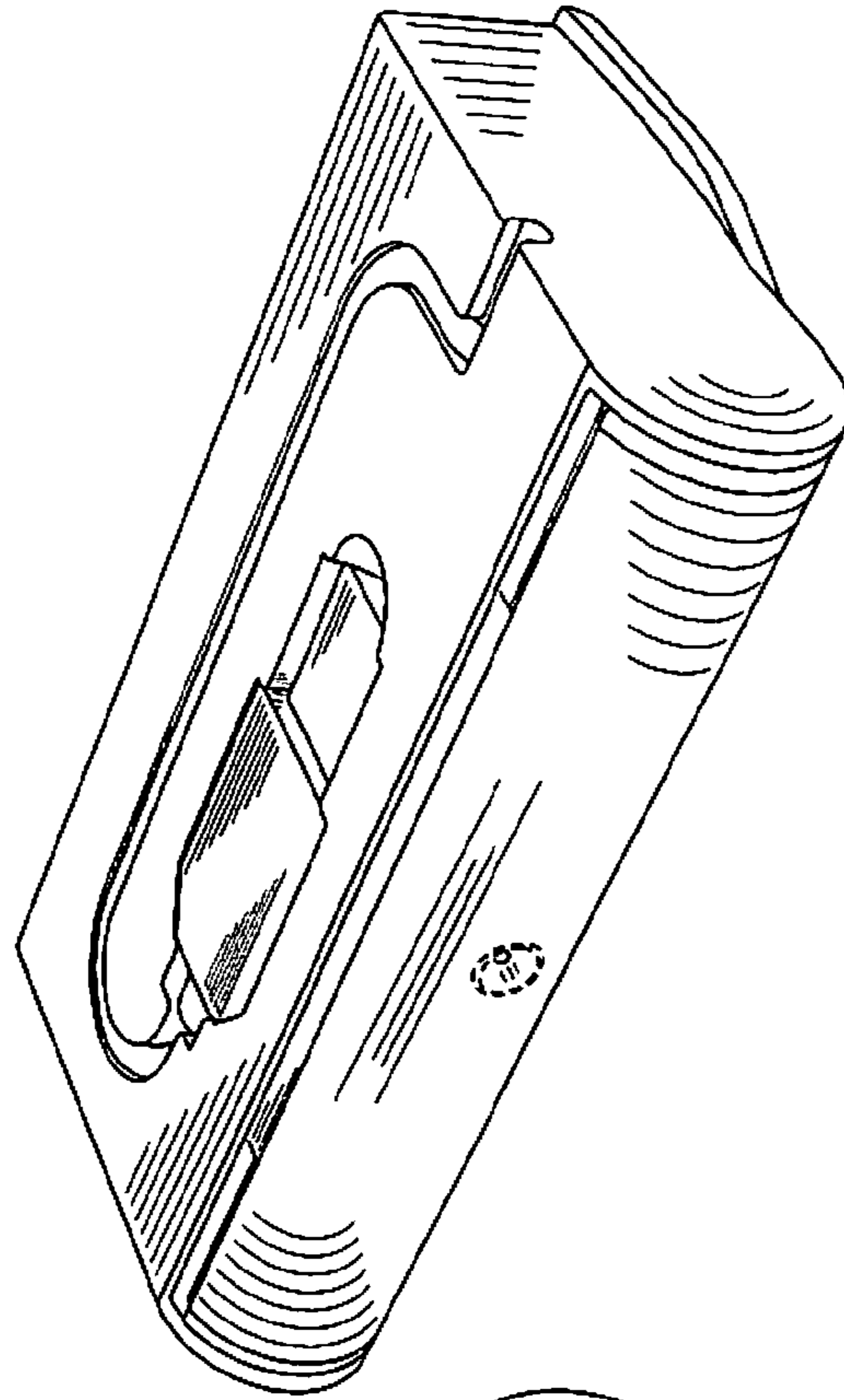

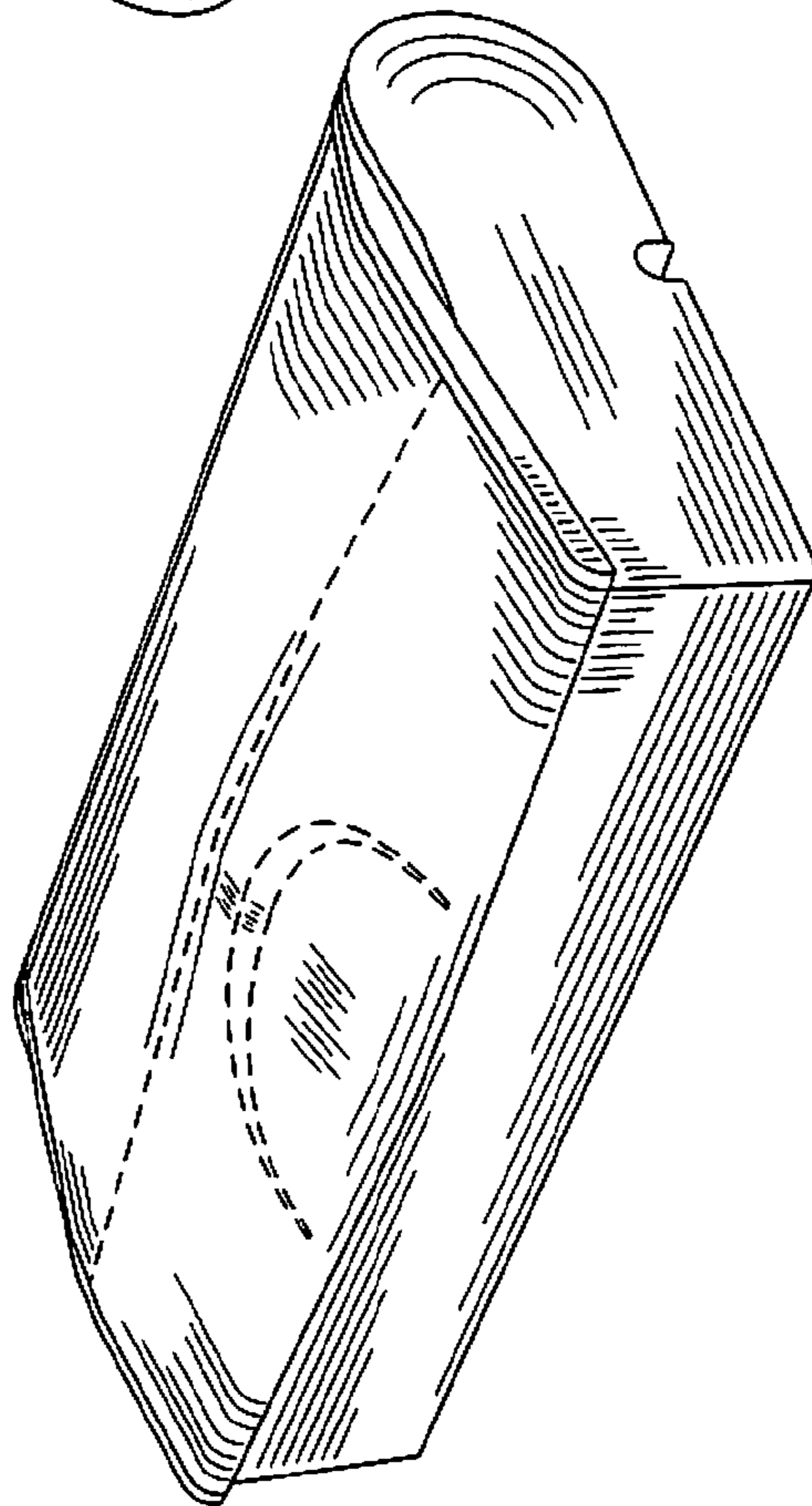

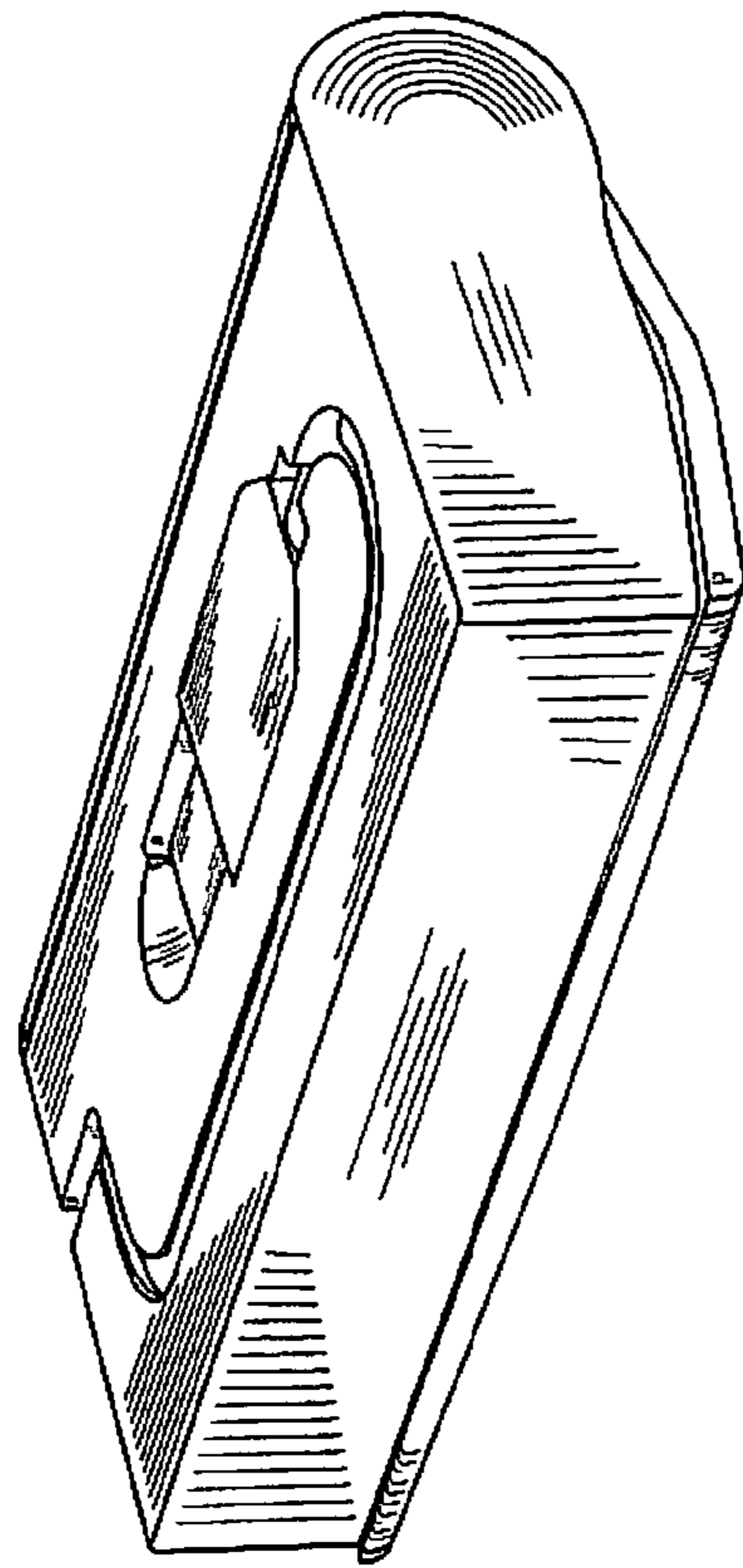

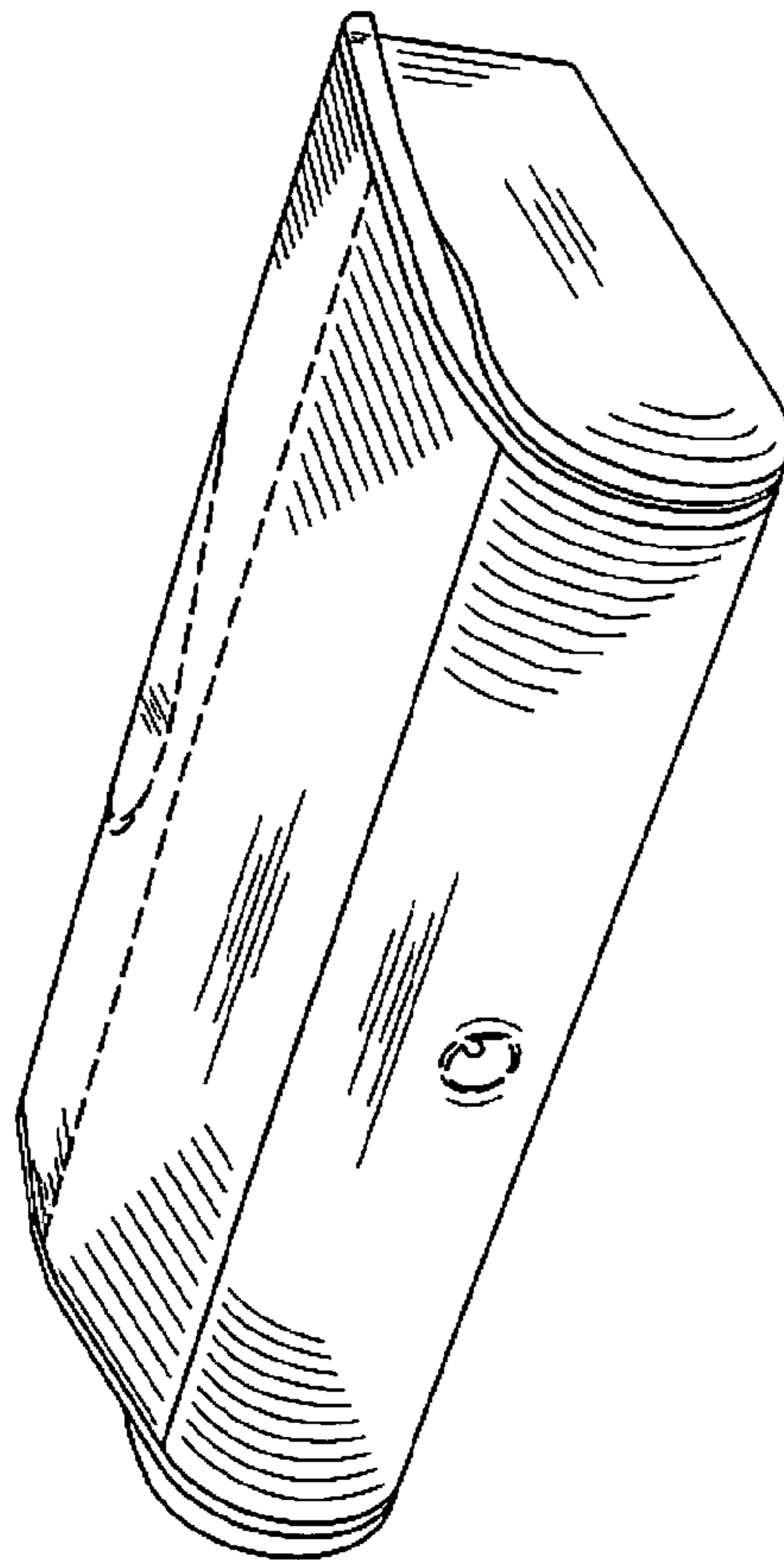

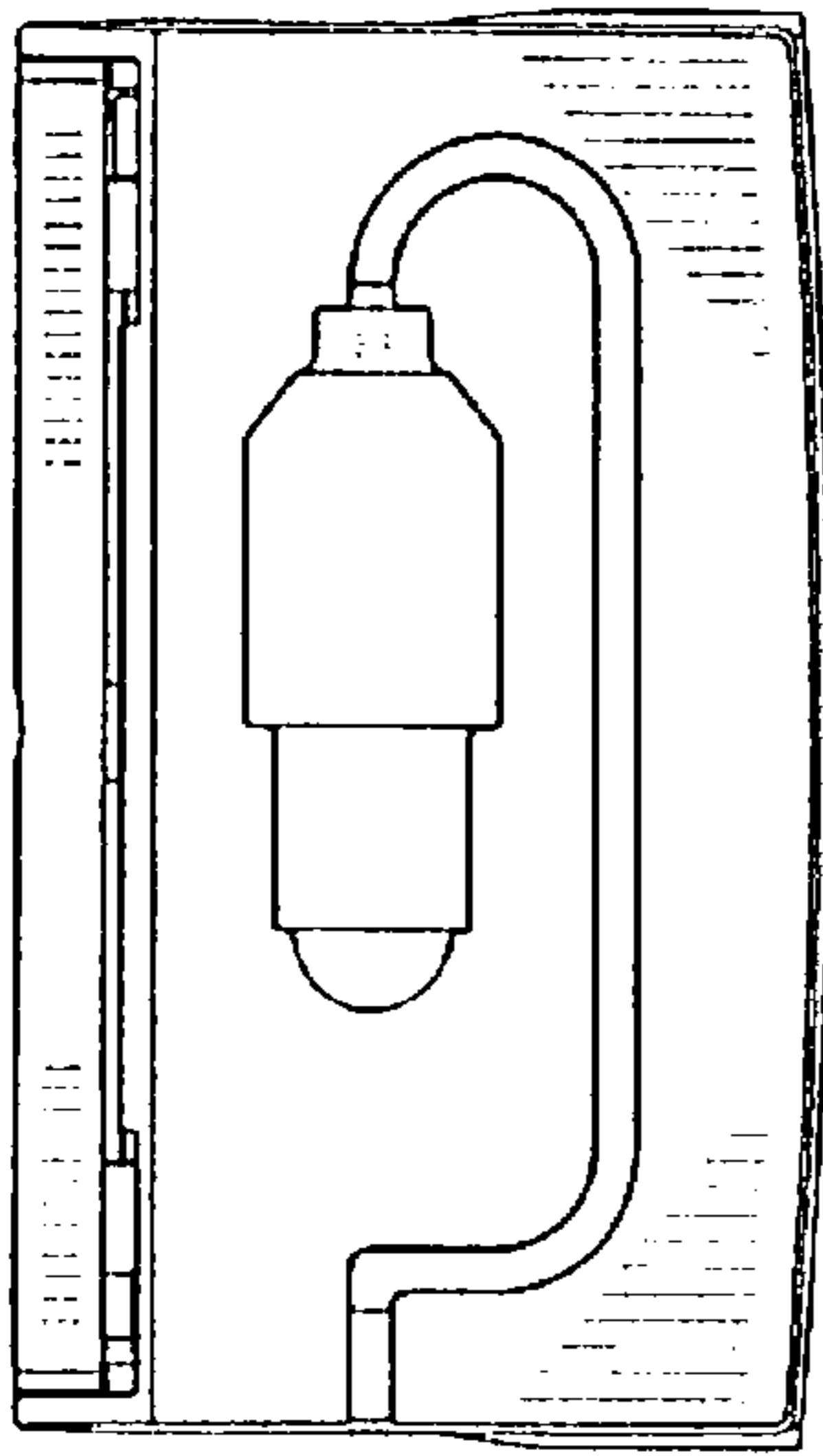

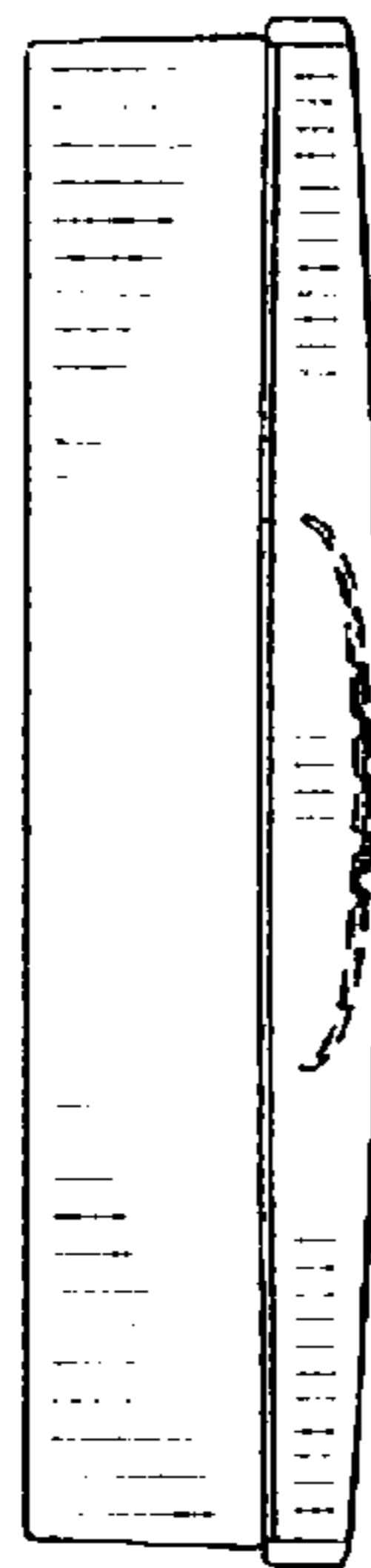

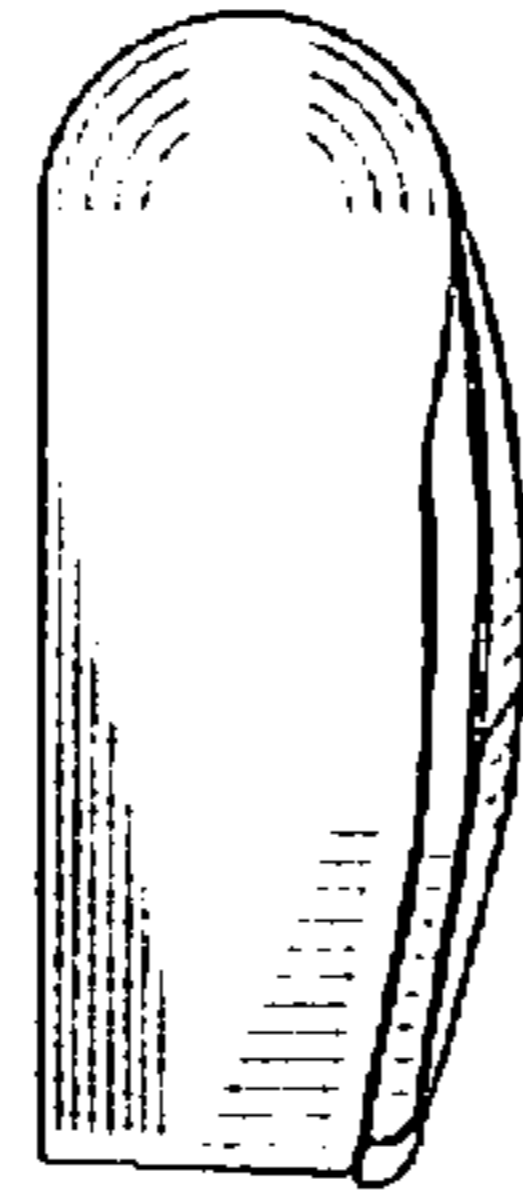

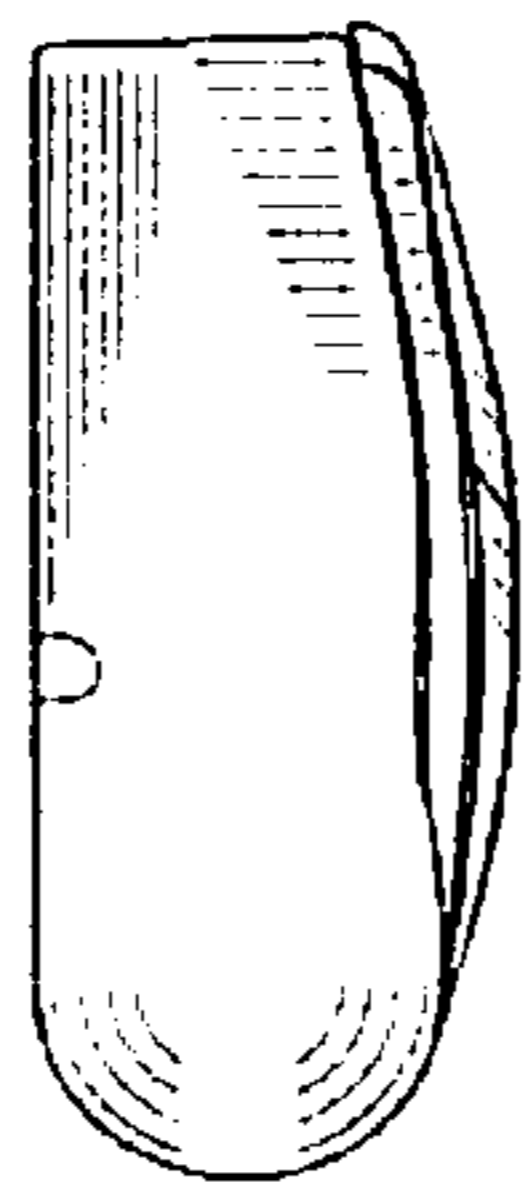

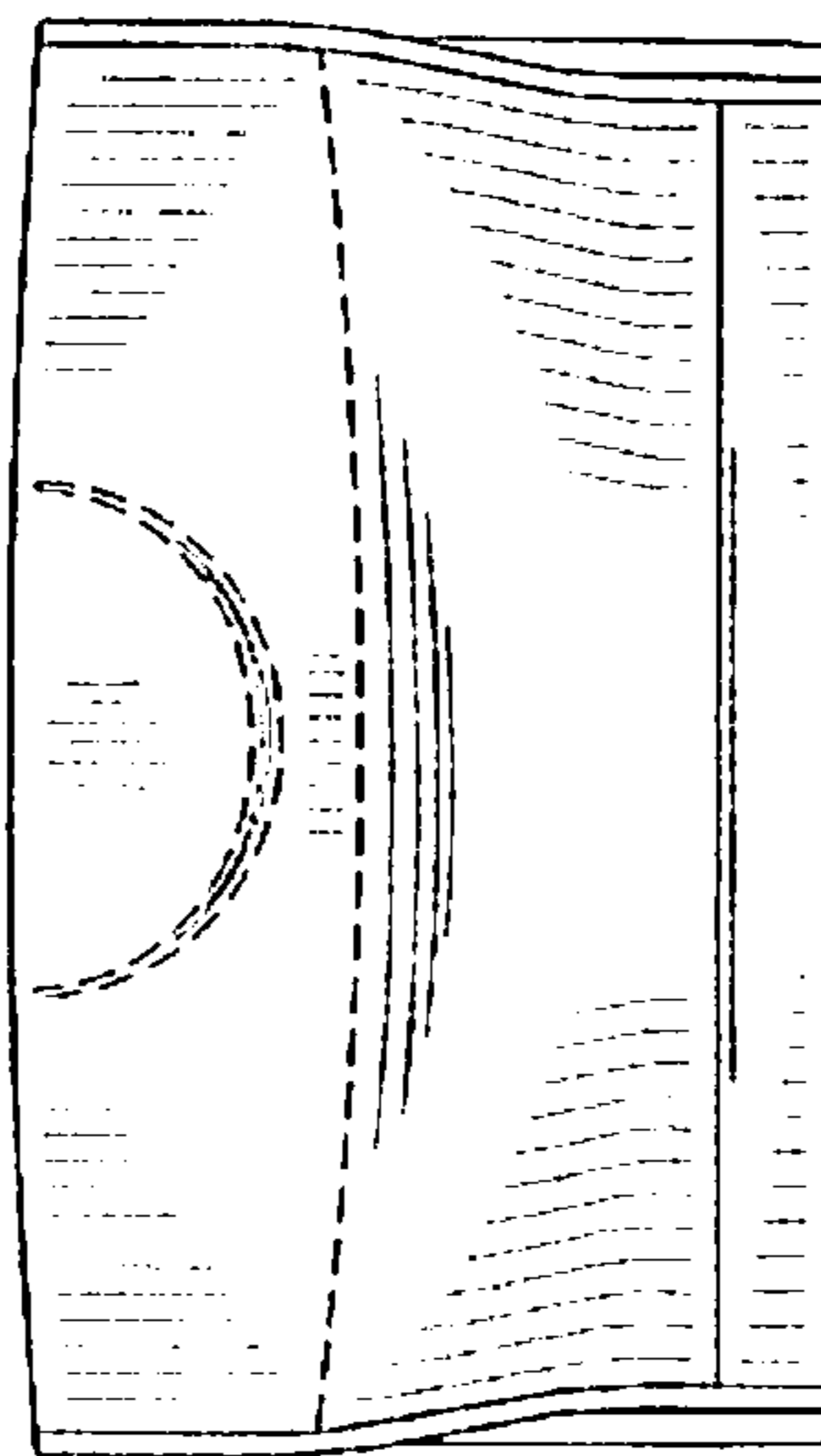

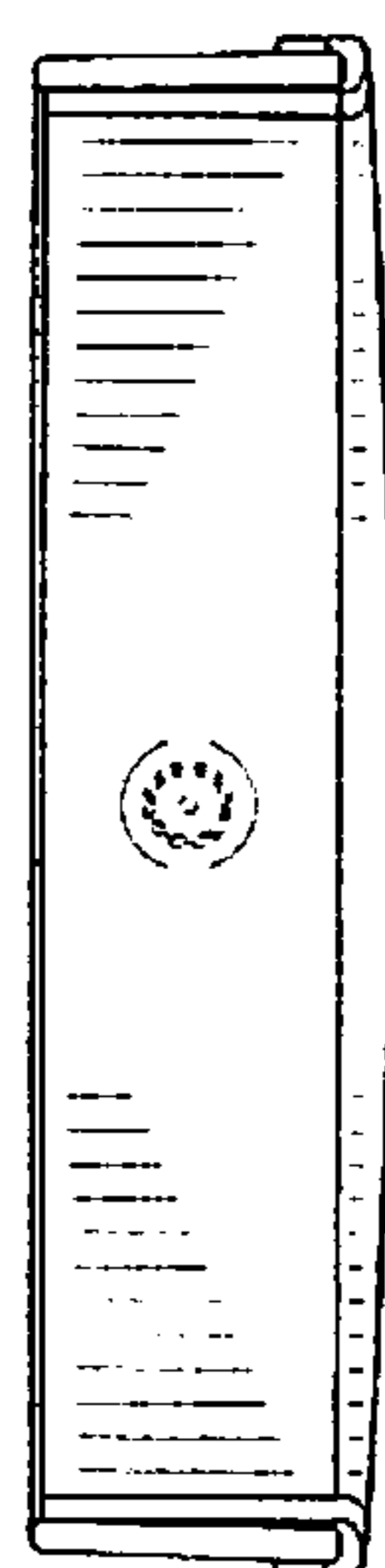

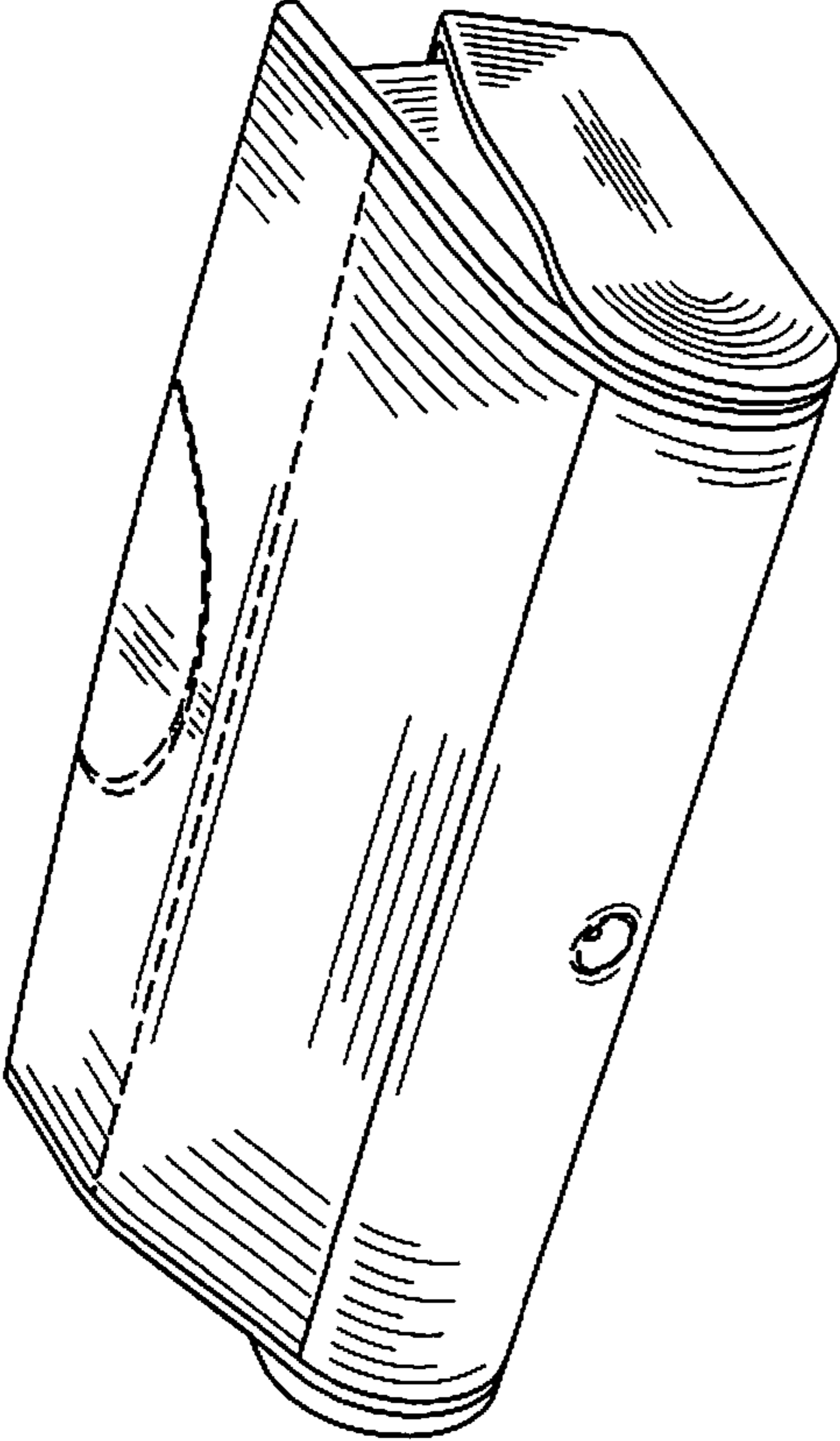
