(57) **CLAIM**

The ornamental design for a woodworking drill bit, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the woodworking drill bit showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is bottom plan view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is an enlarged right side elevational view thereof;

FIG. 6 is an enlarged left side elevational view thereof;

FIG. 7 is an enlarged perspective view taken from the top, front and right side of the woodworking drill;

FIG. 8 is an enlarged partial view in the direction of arrows 8—8 in FIG. 1;

FIG. 9 is an enlarged partial view in the direction of arrows 9—9 in FIG. 2;

FIG. 10 is an enlarged partial view in the direction of arrows 10—10 in FIG. 3; and,

FIG. 11 is an enlarged partial view in the direction of arrows 11—11 in FIG. 4.

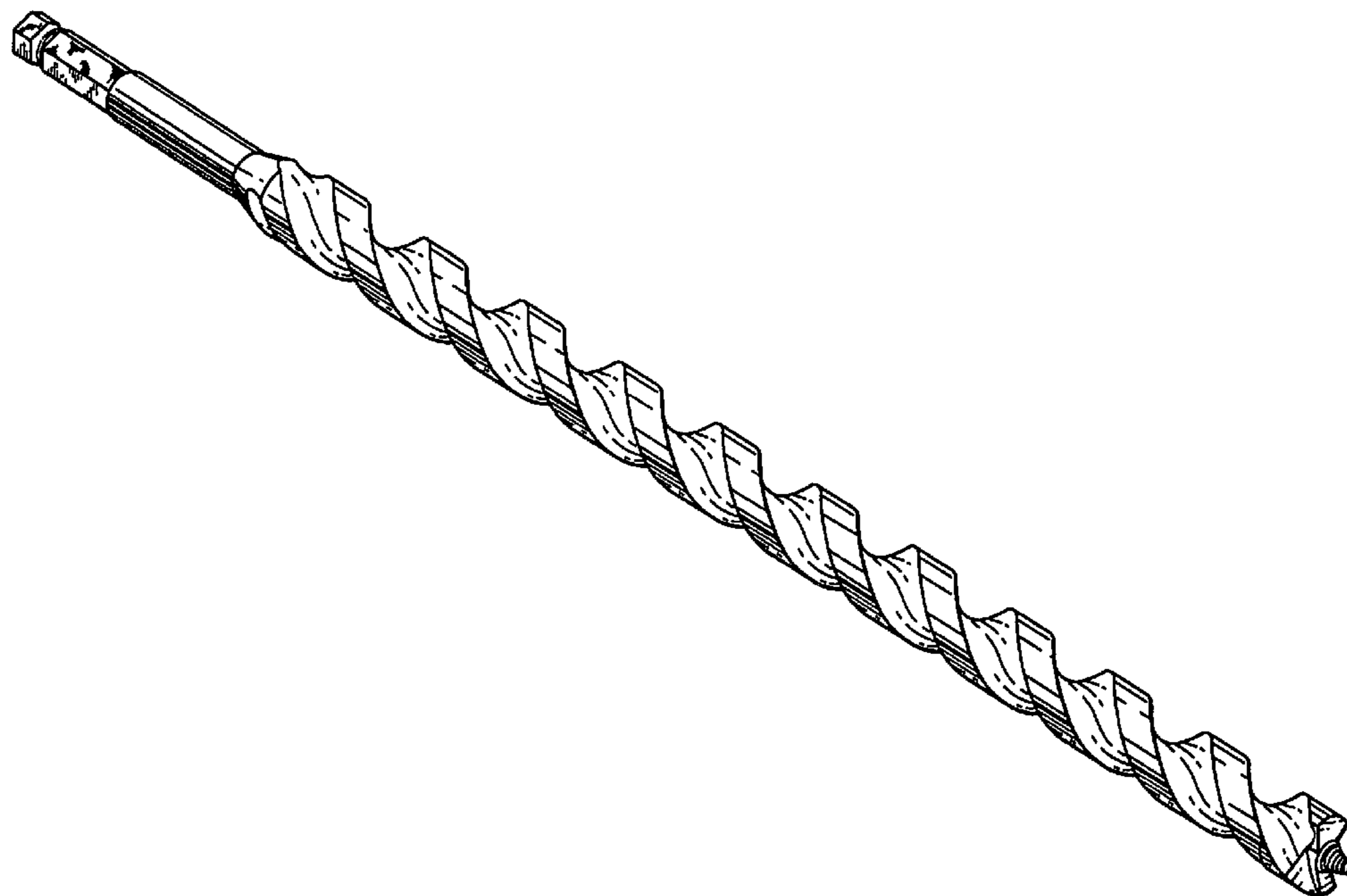

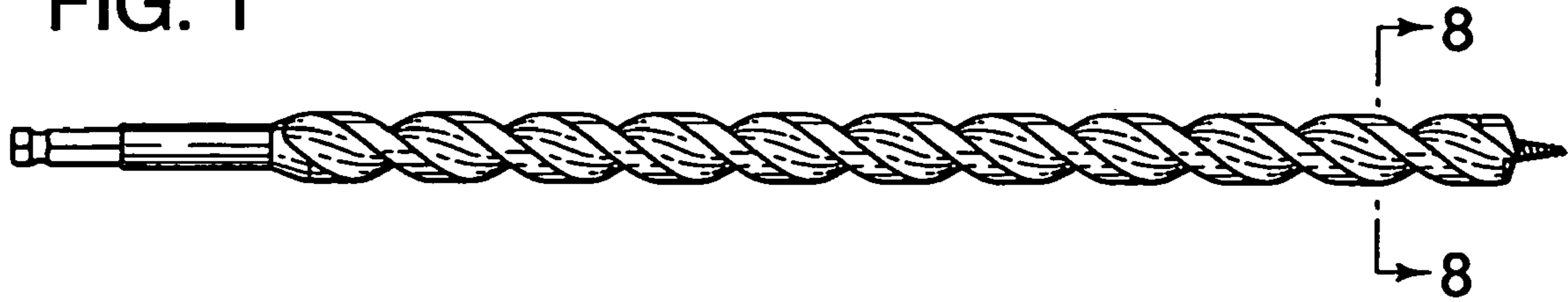

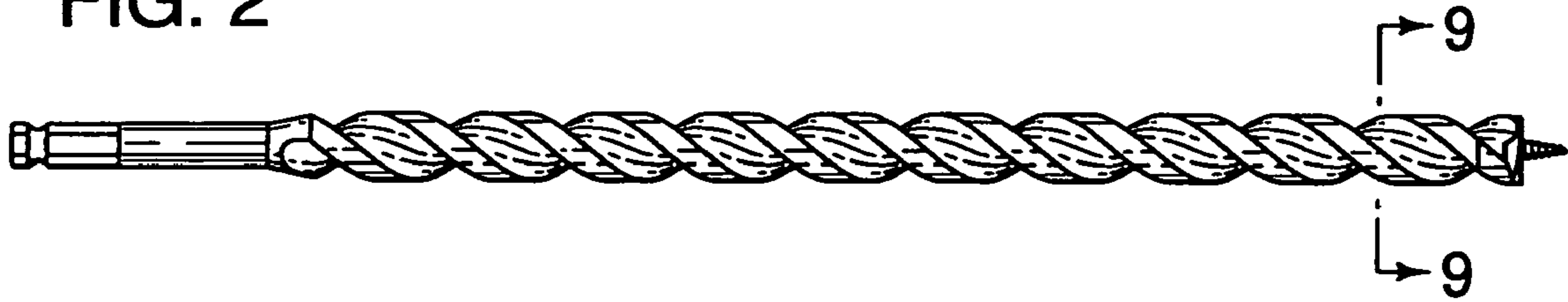

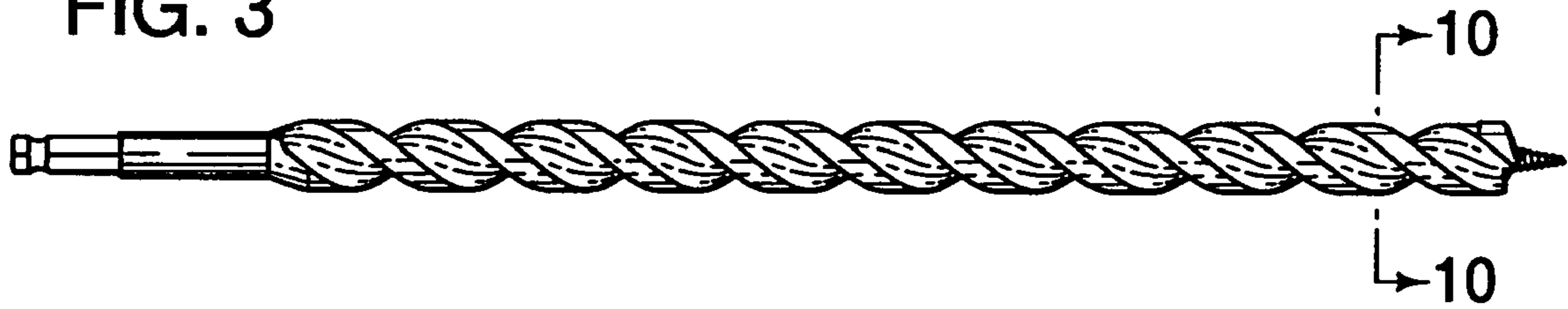

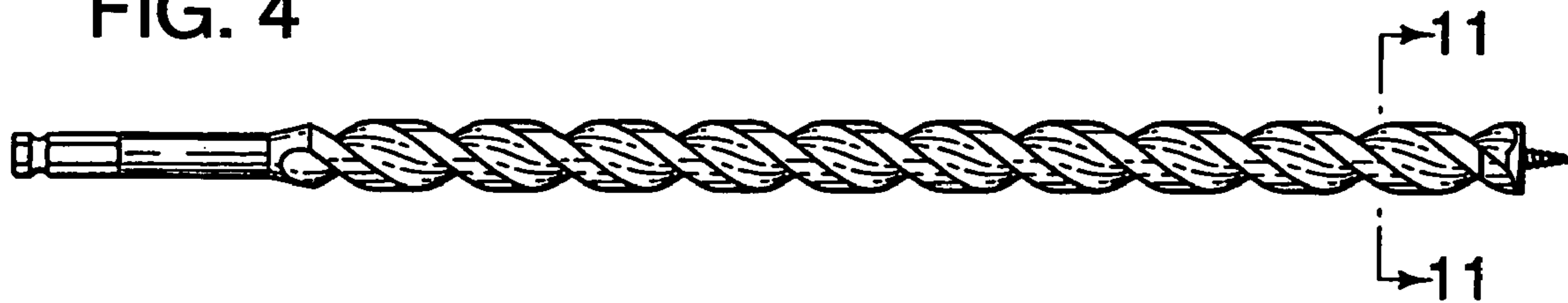

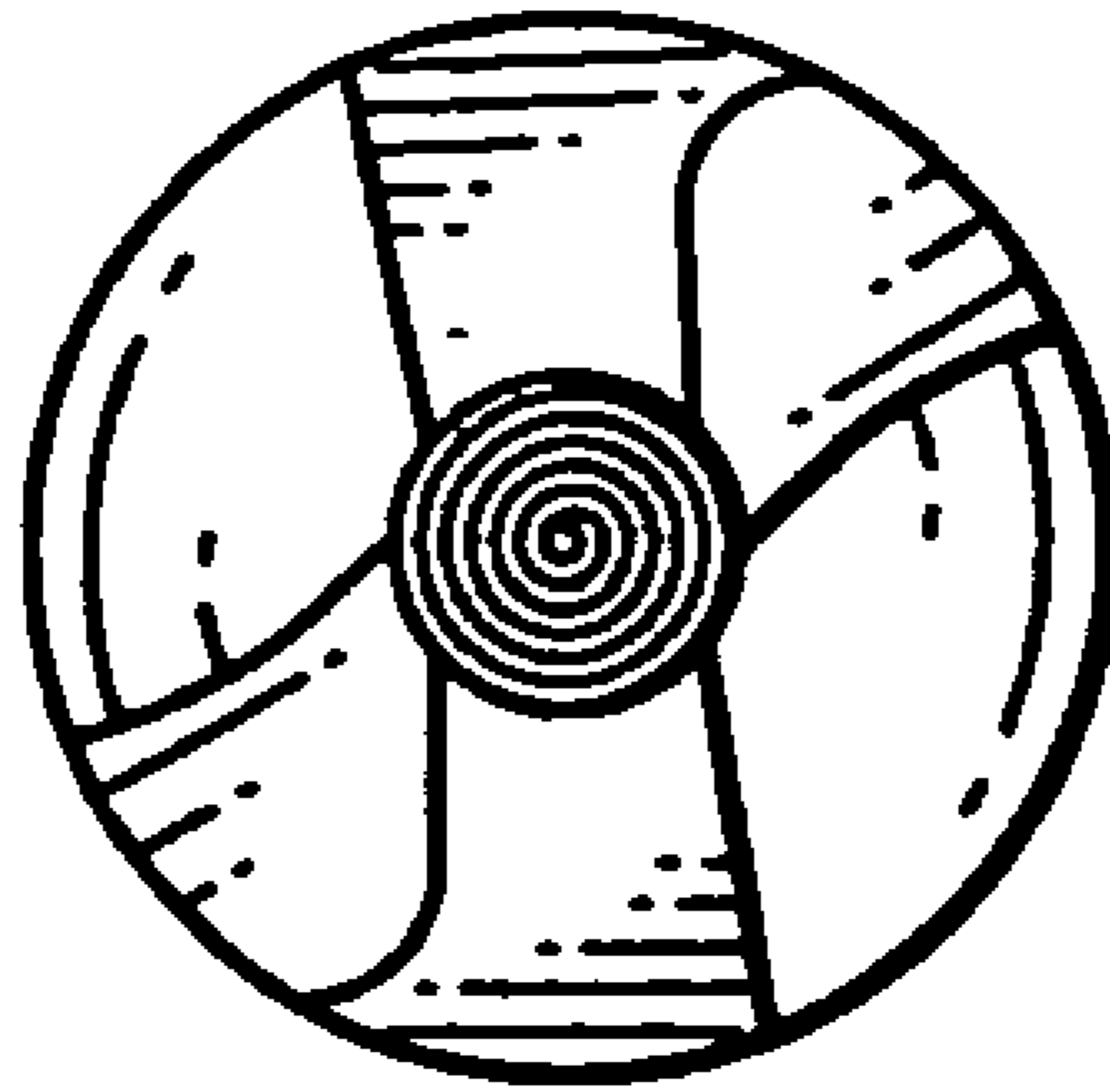
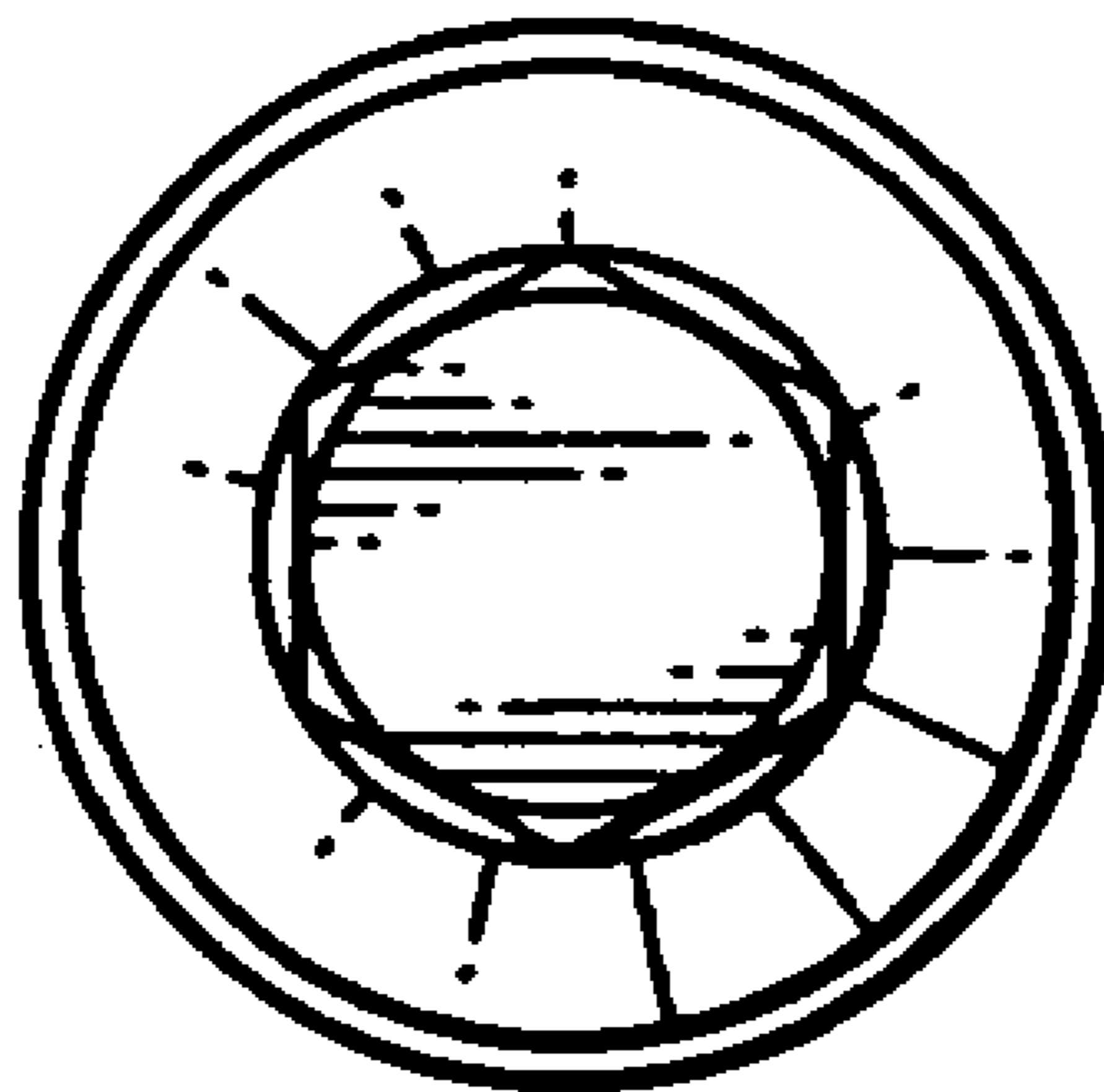

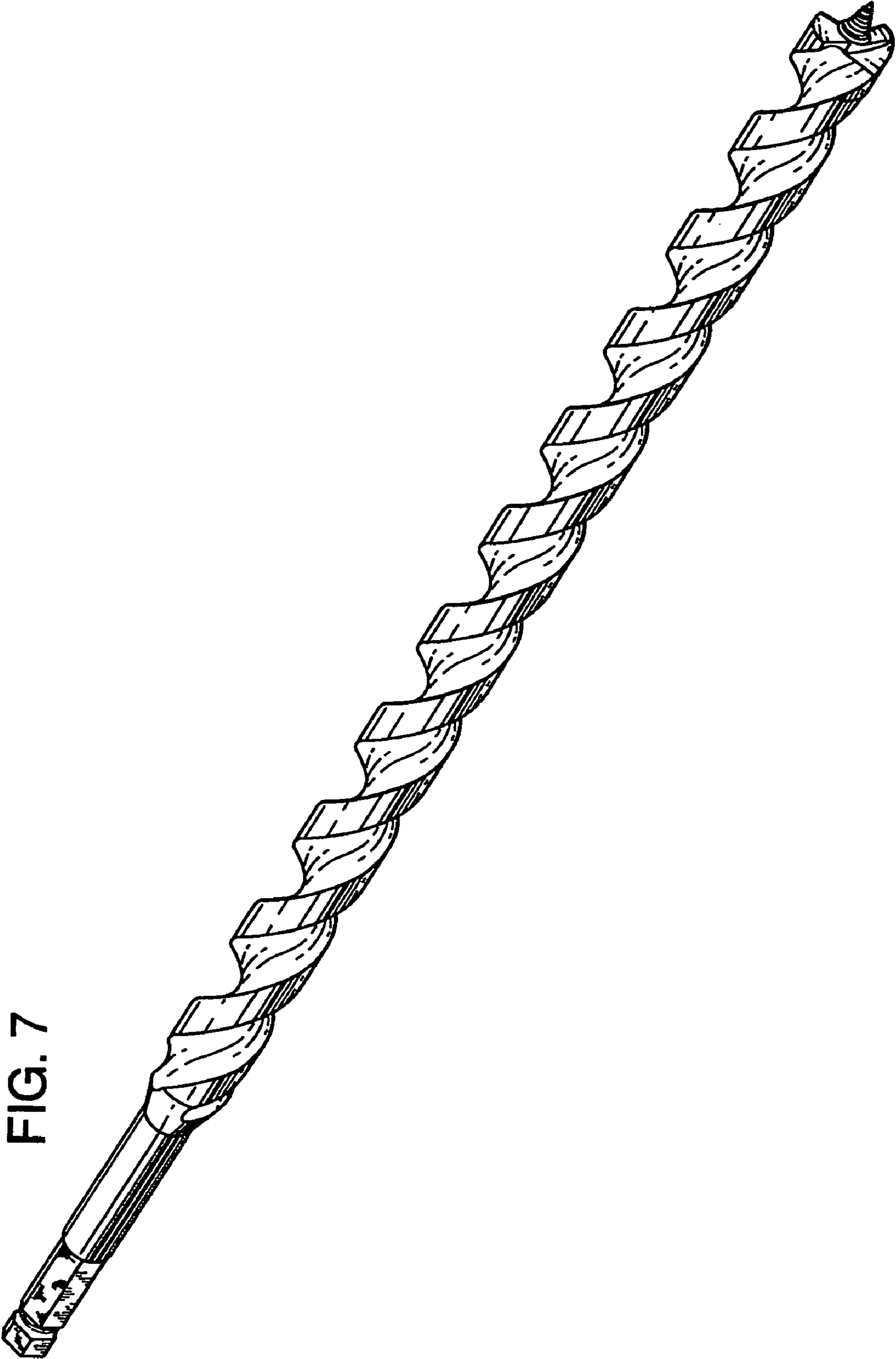

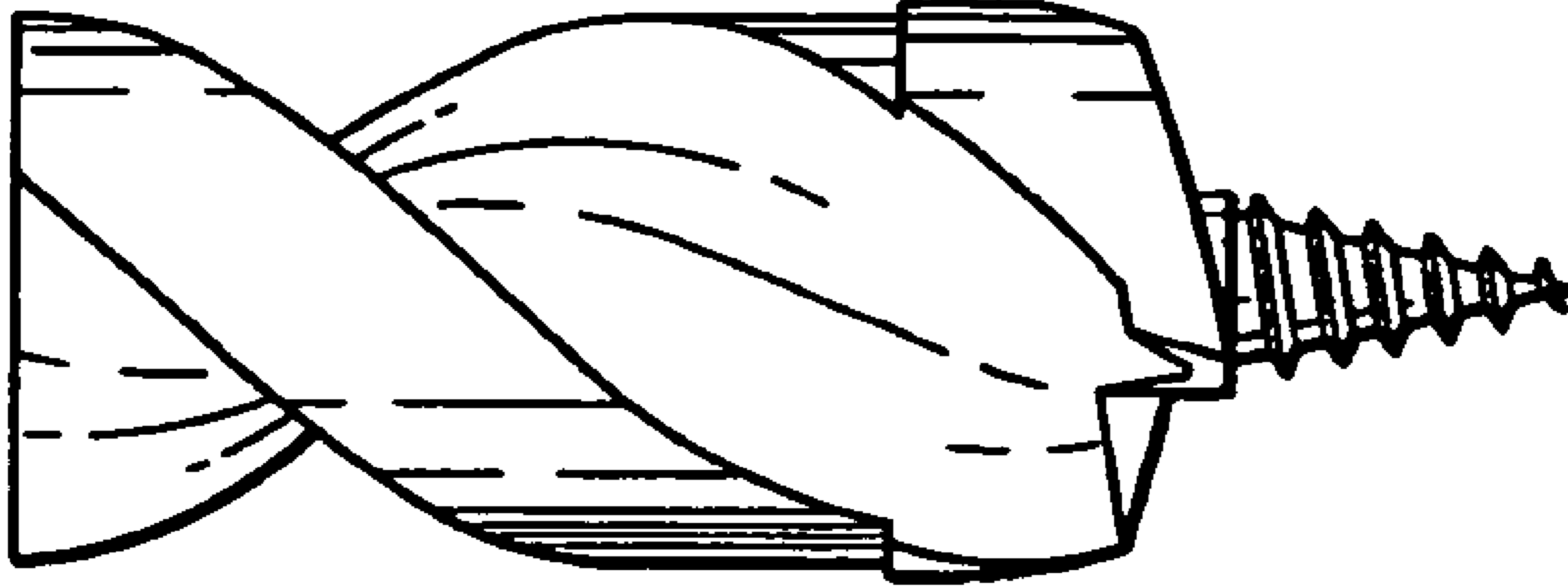

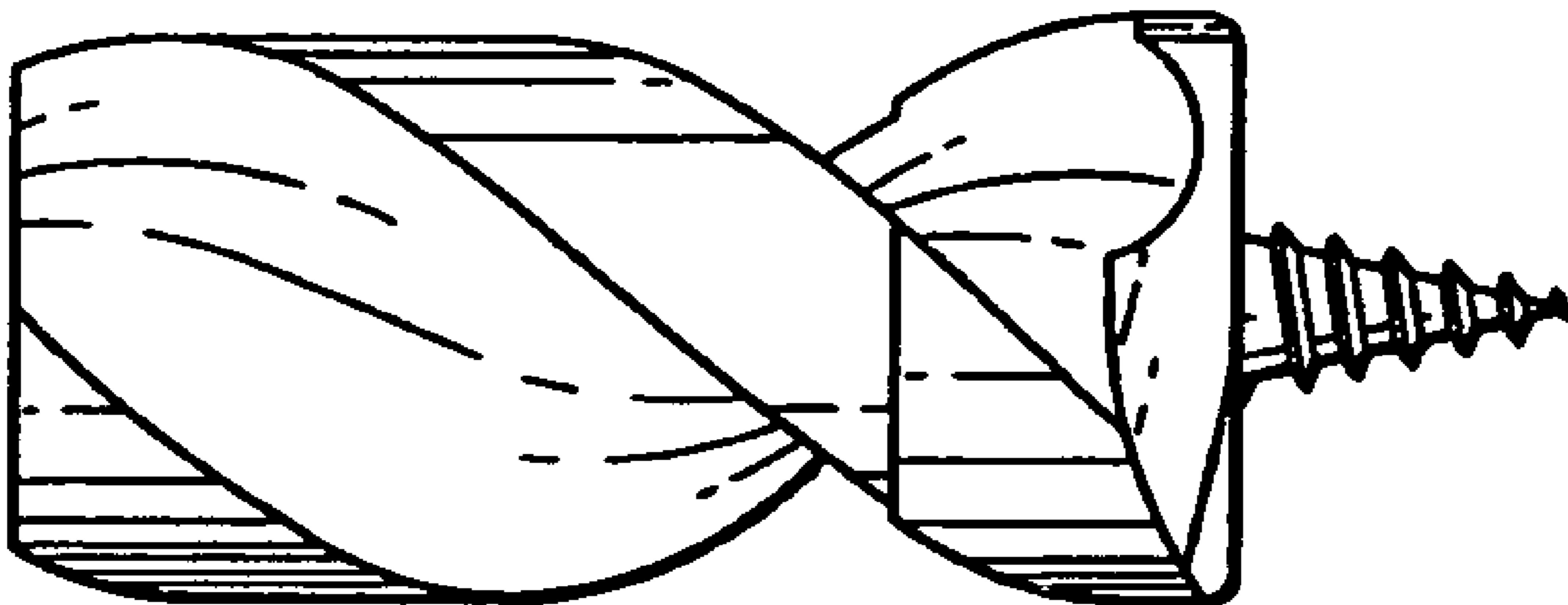

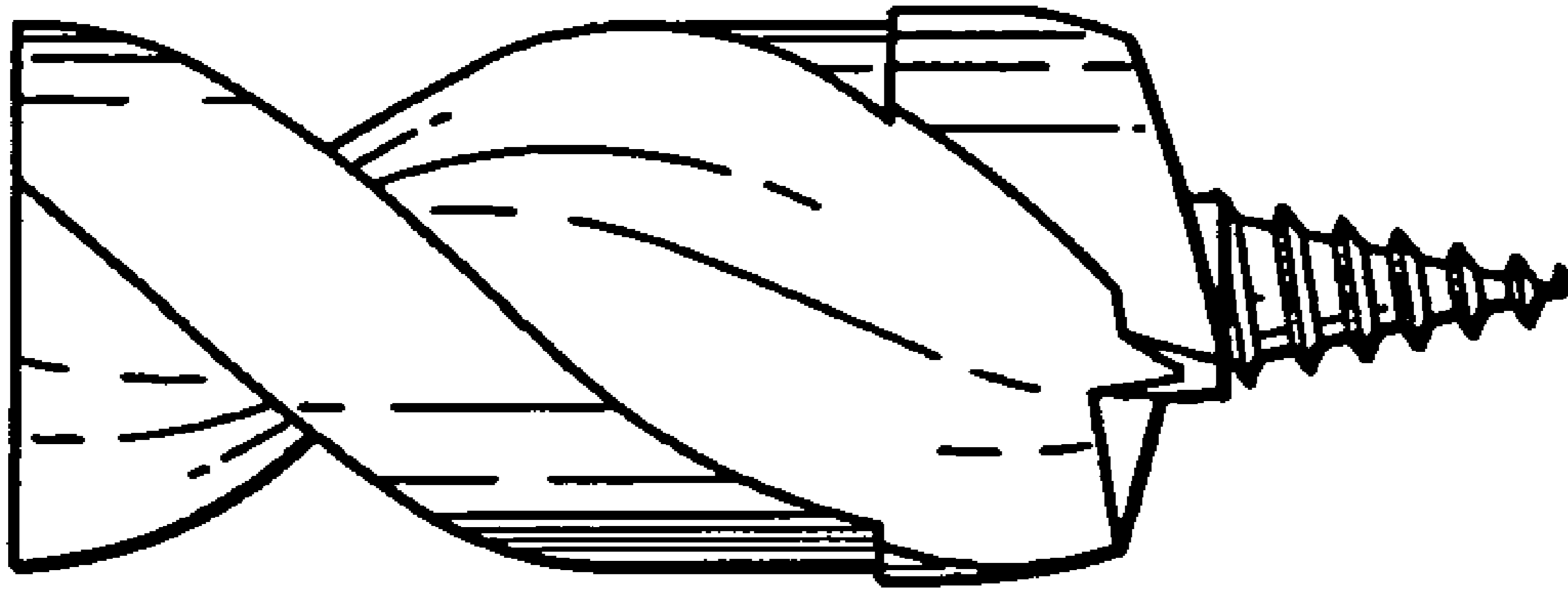
