**DESCRIPTION**

FIG. 1 is a front, right side perspective view of a digital camera showing my new design;

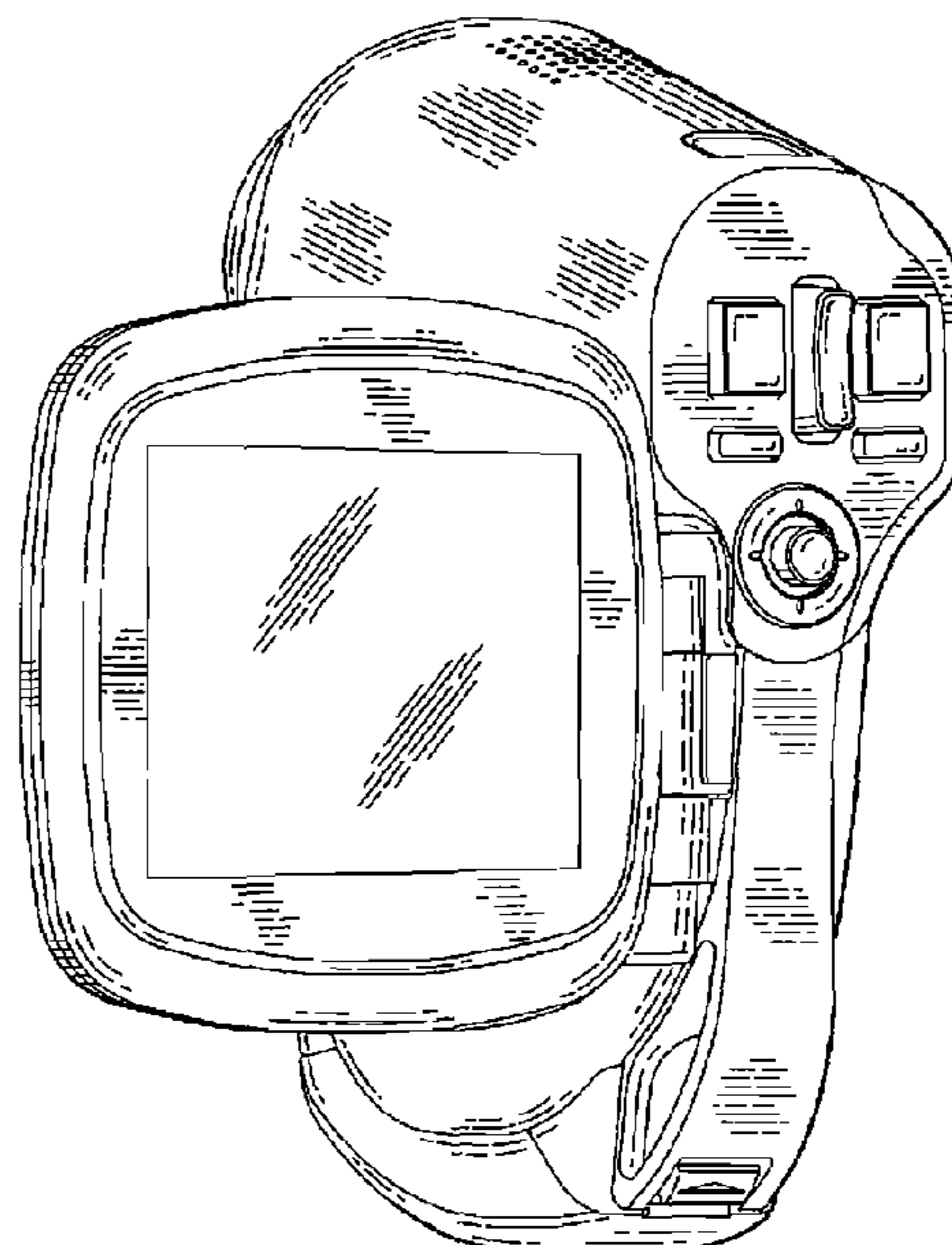
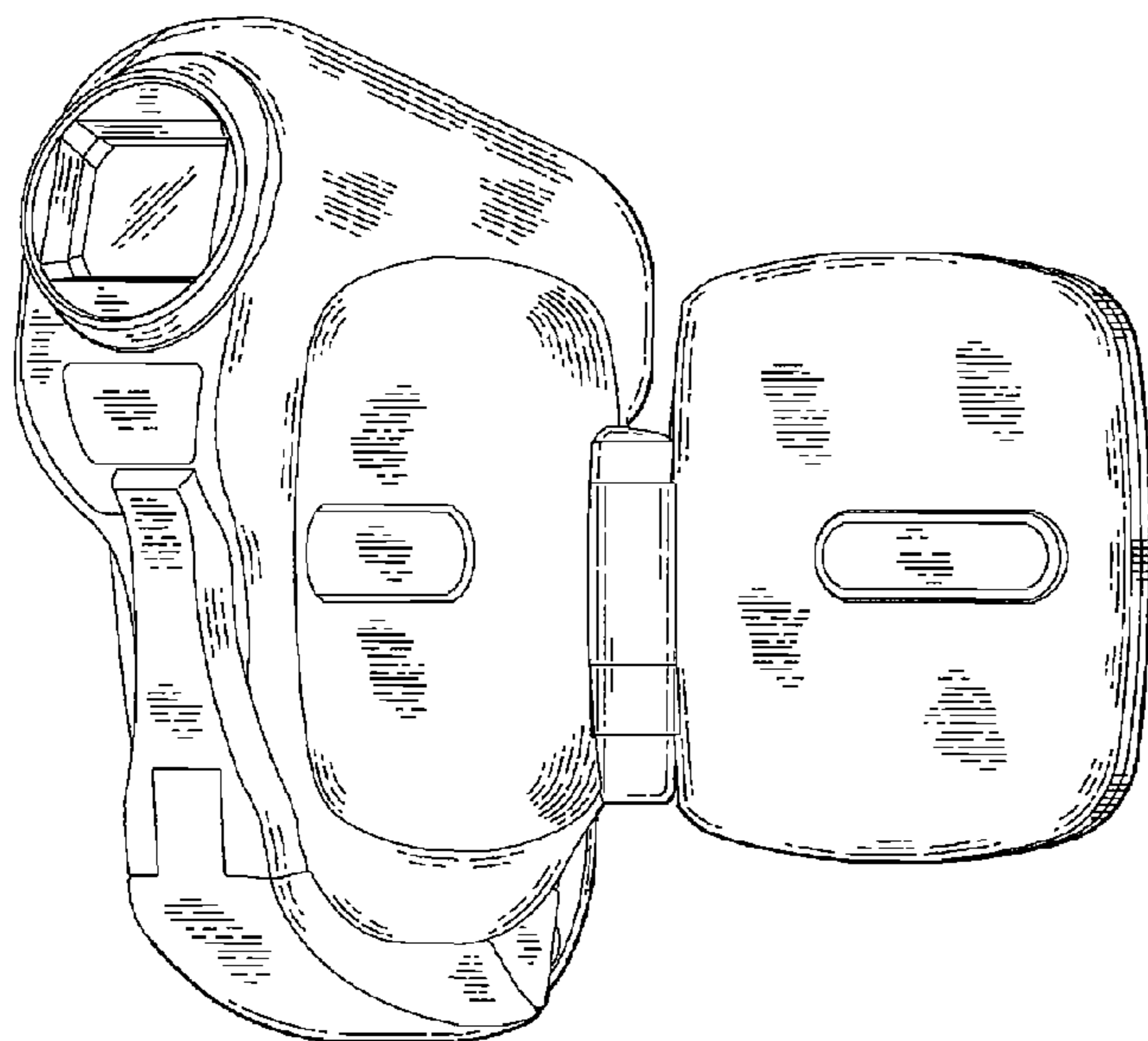

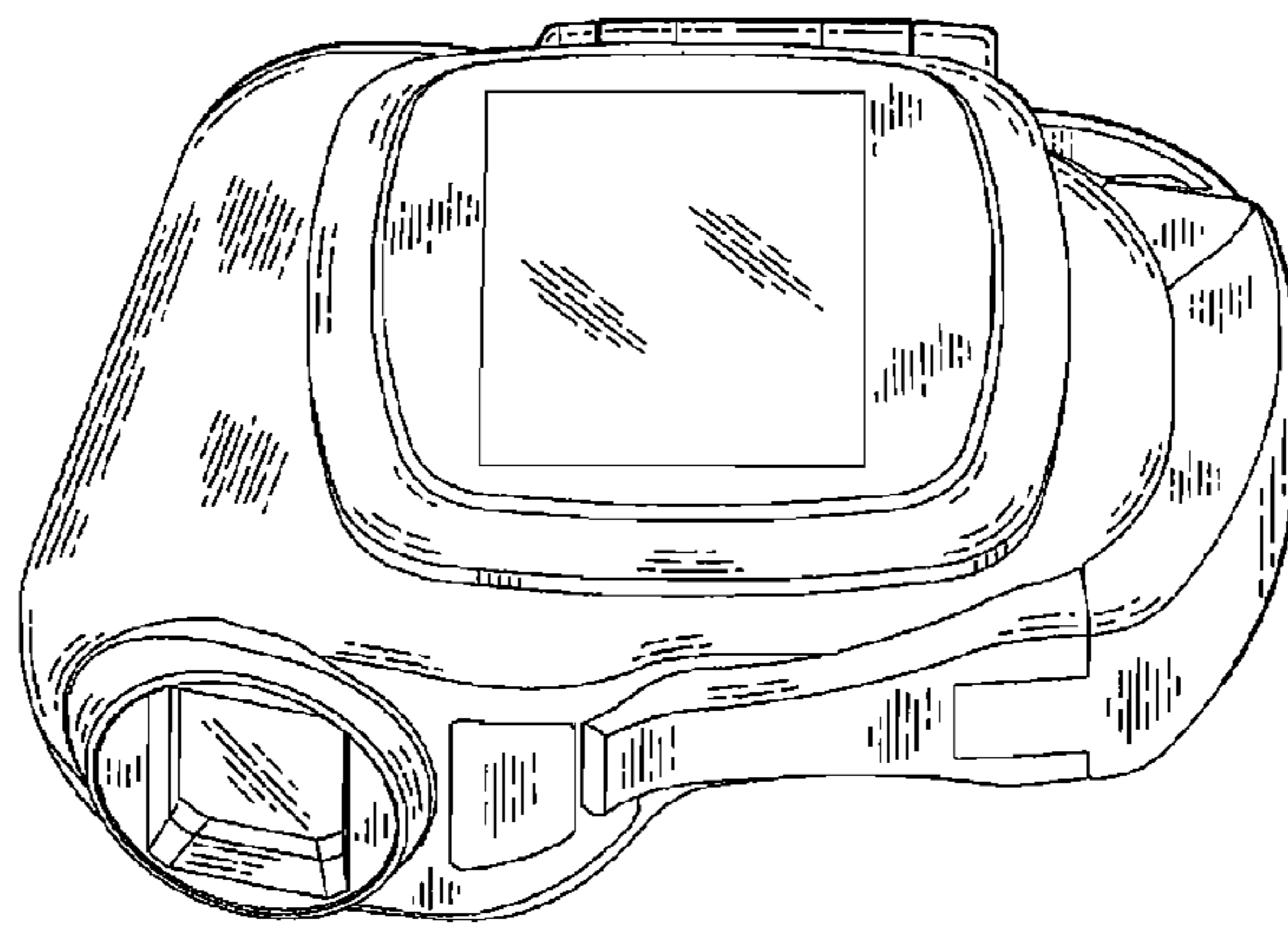

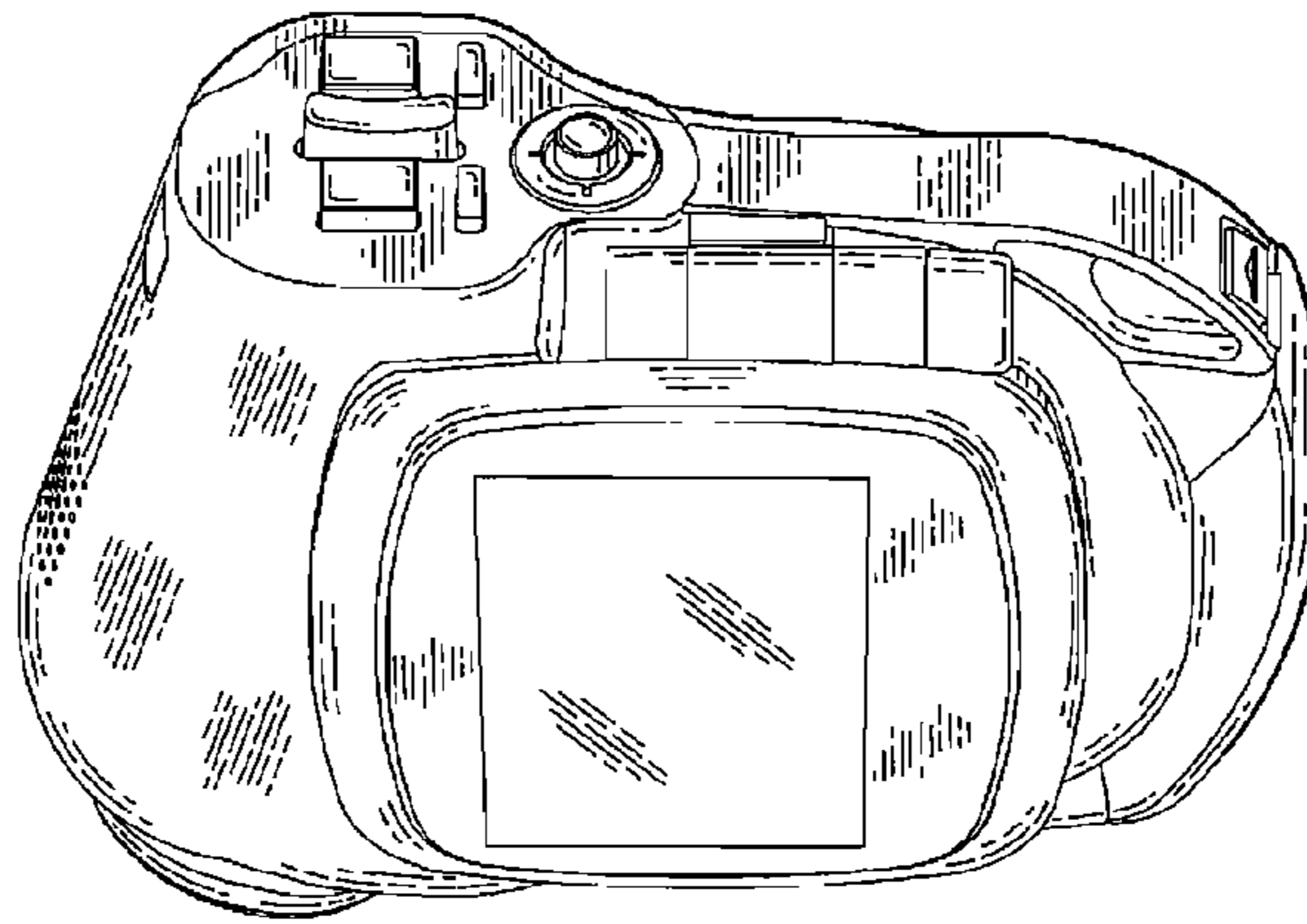

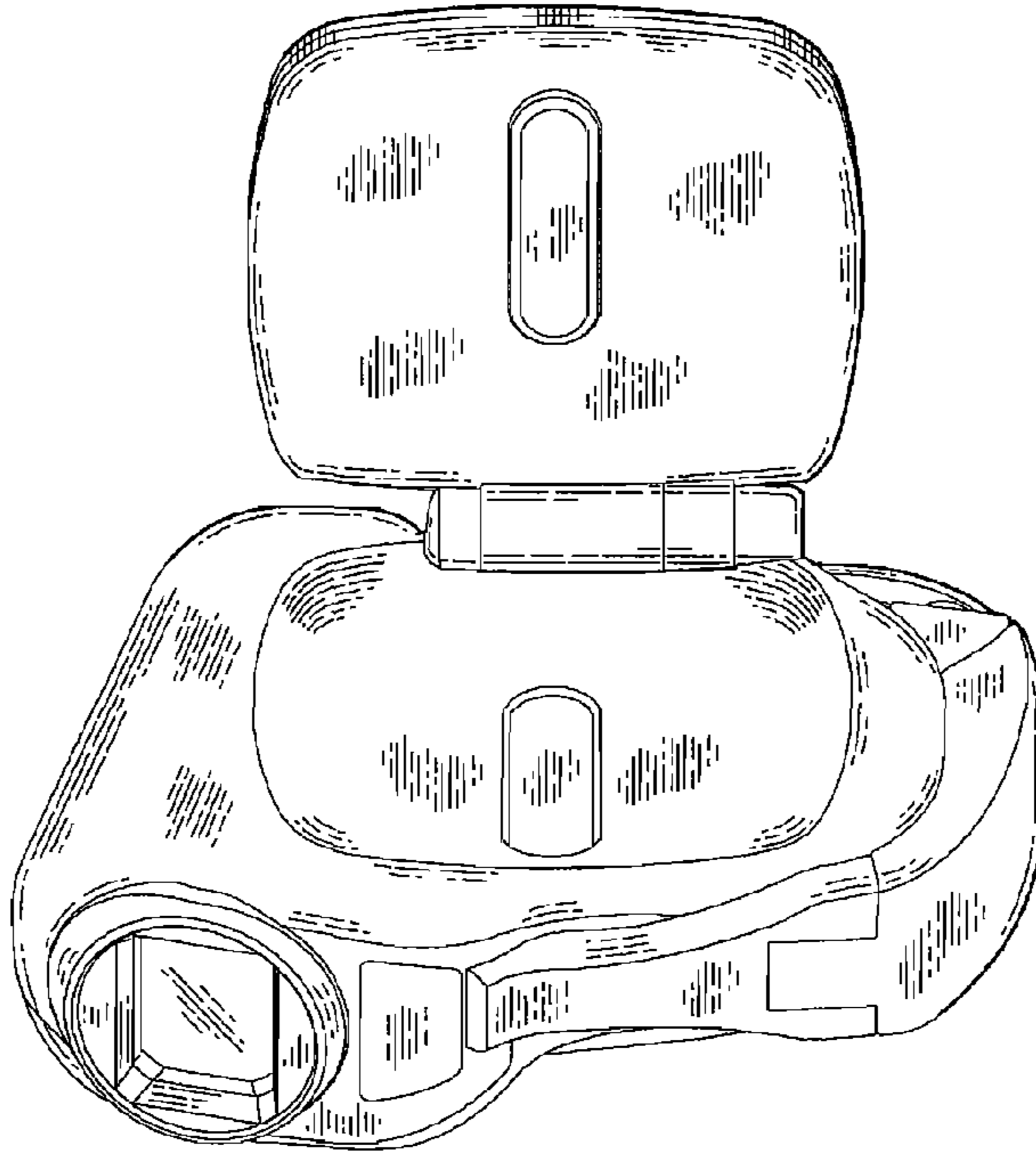

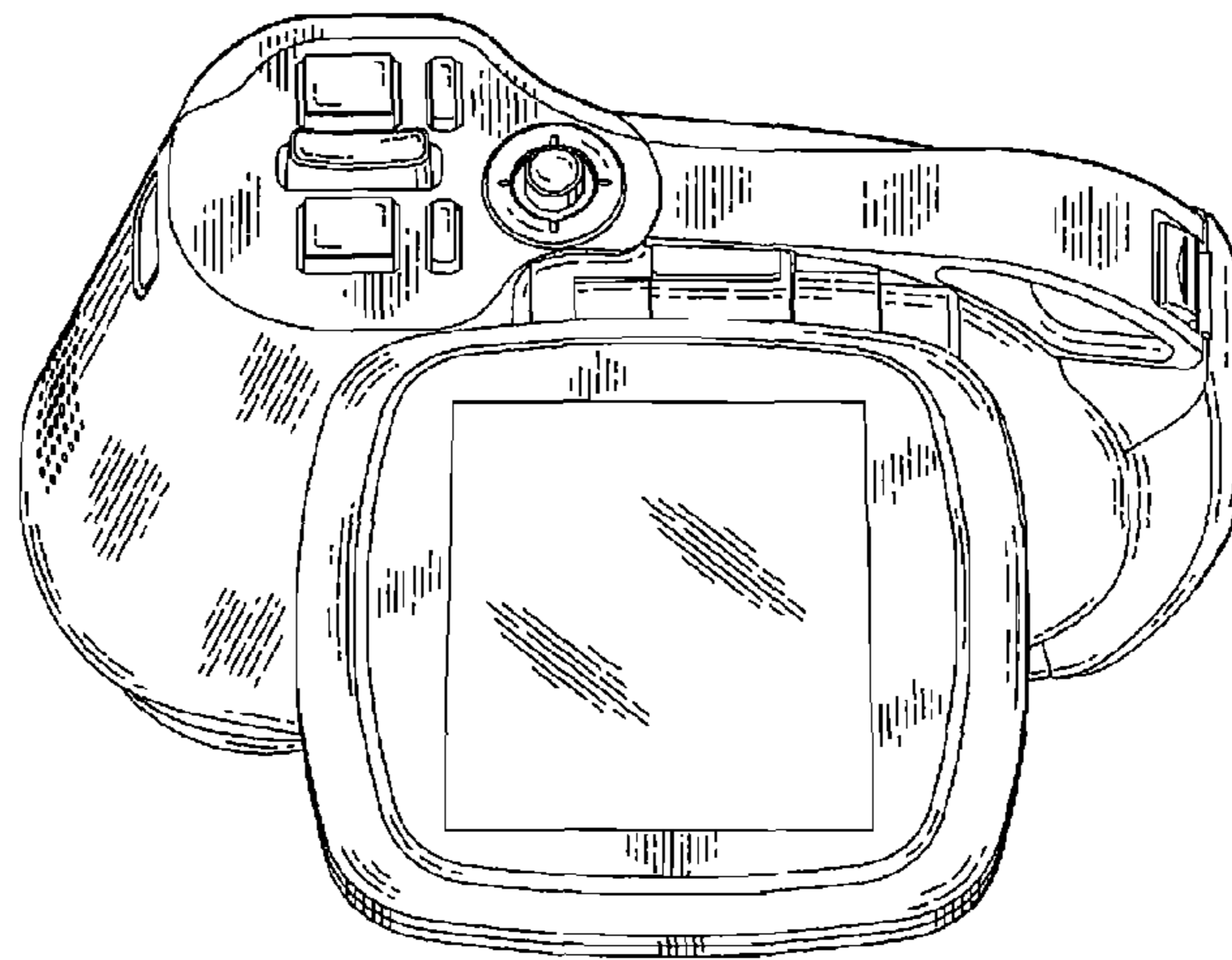

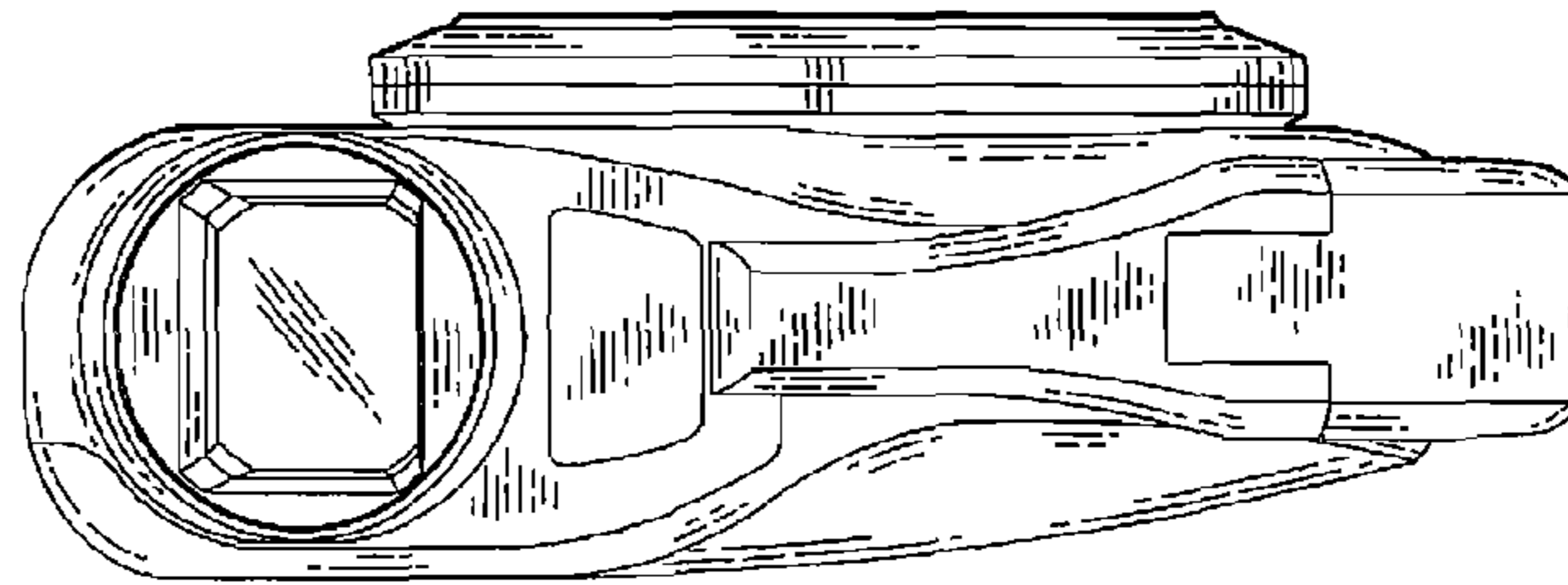

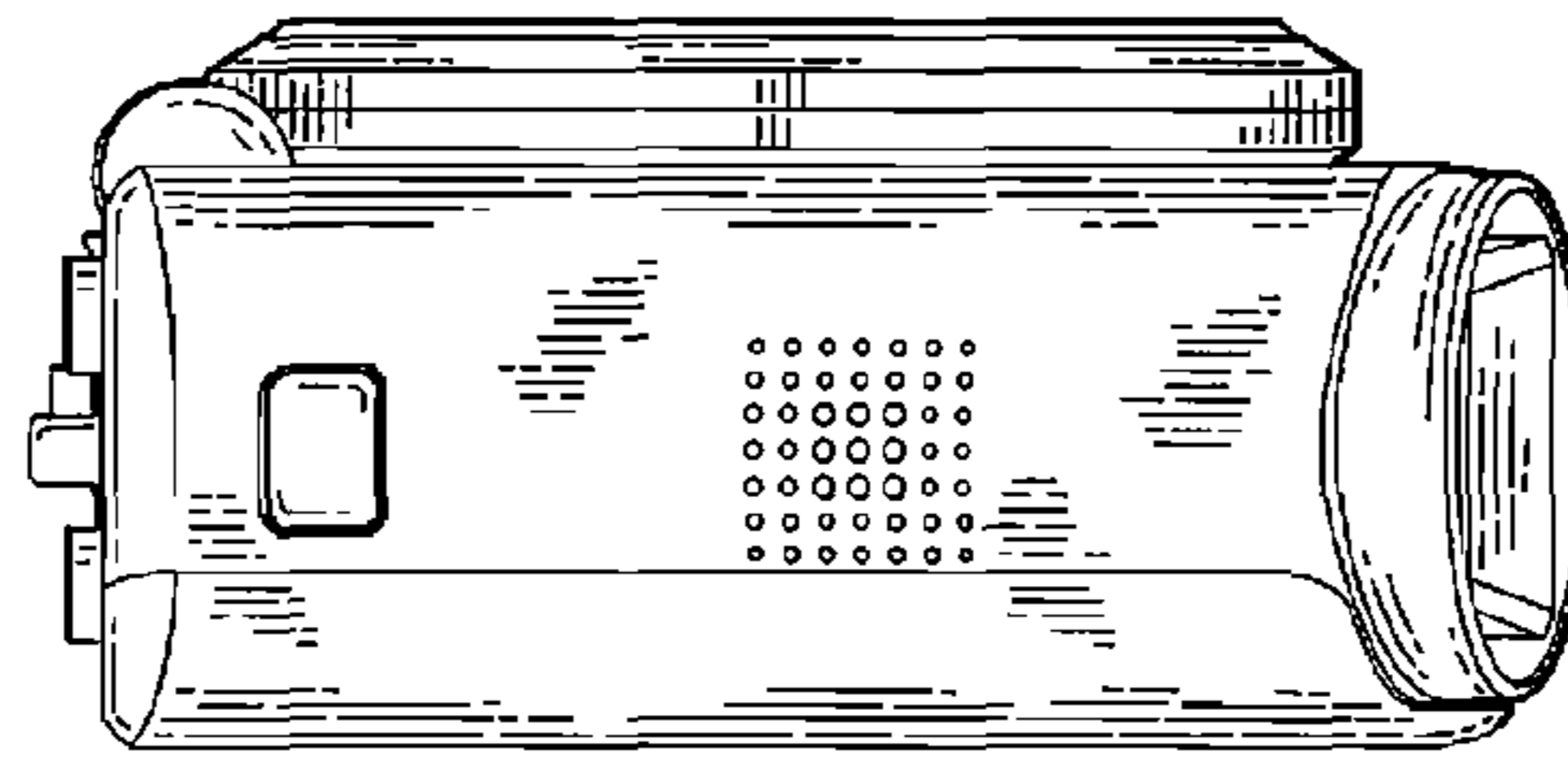

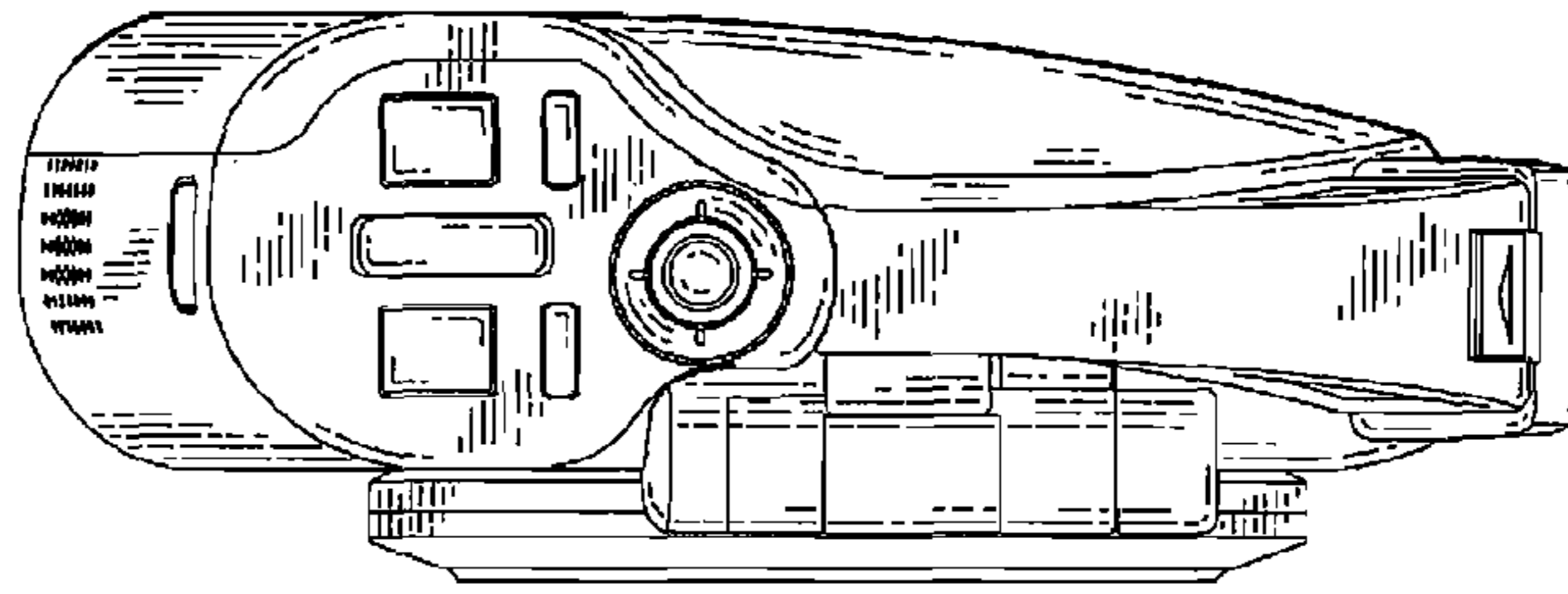

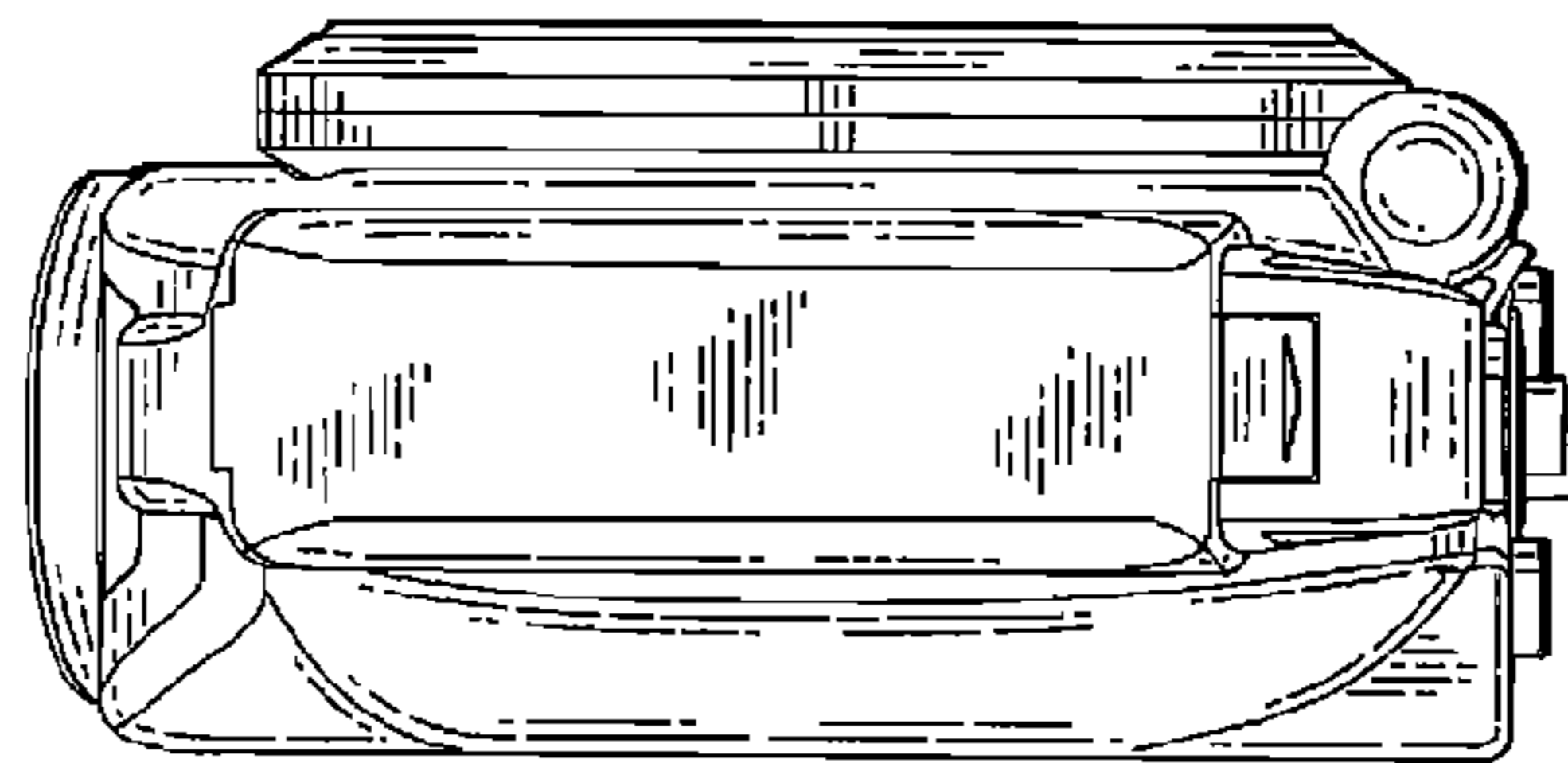

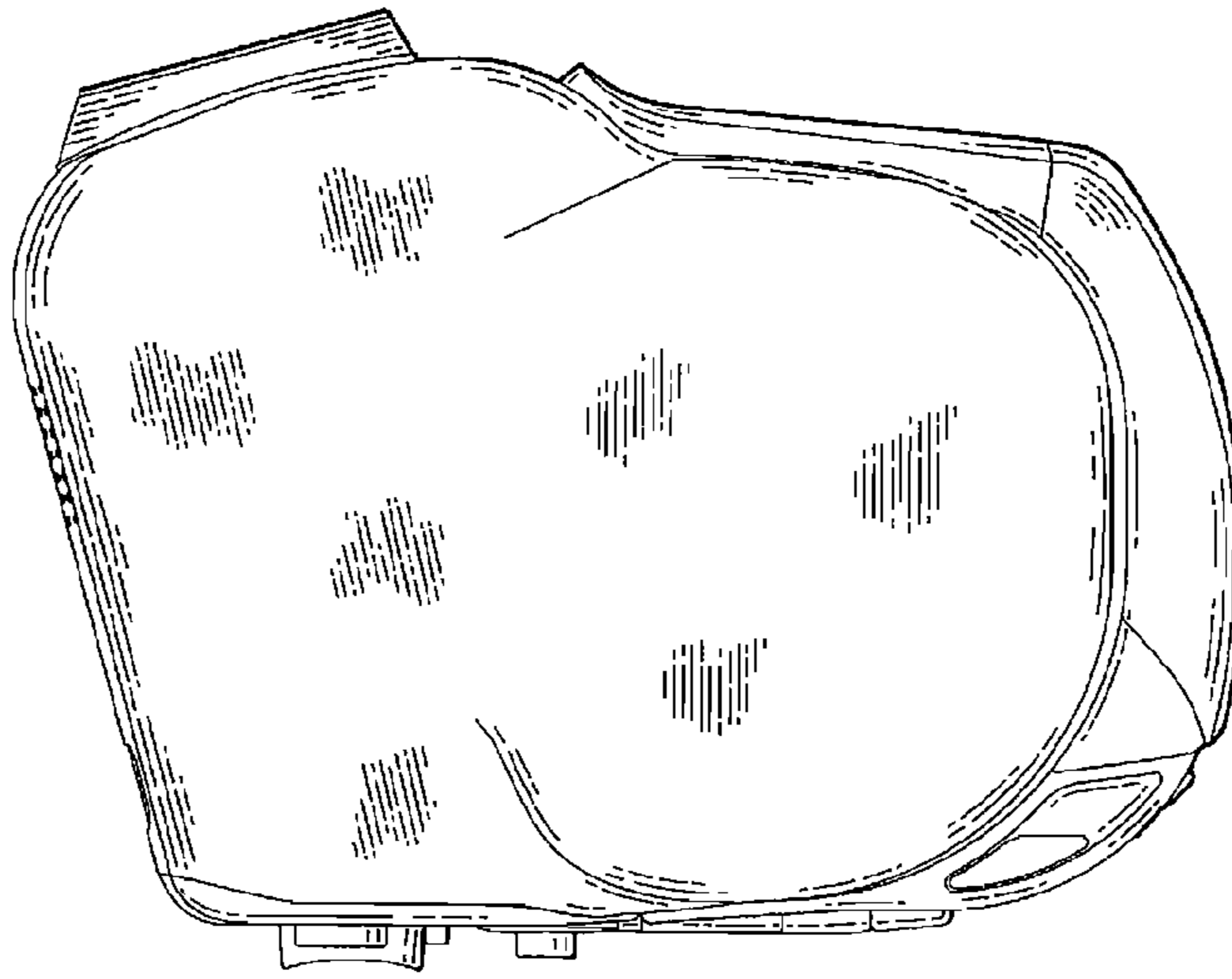
