FIG. 7 is a bottom plan view thereof; and,

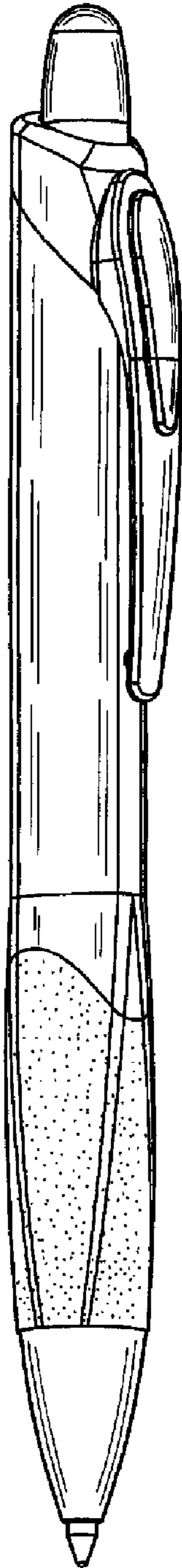
FIG. 8 is a rear elevational view thereof.

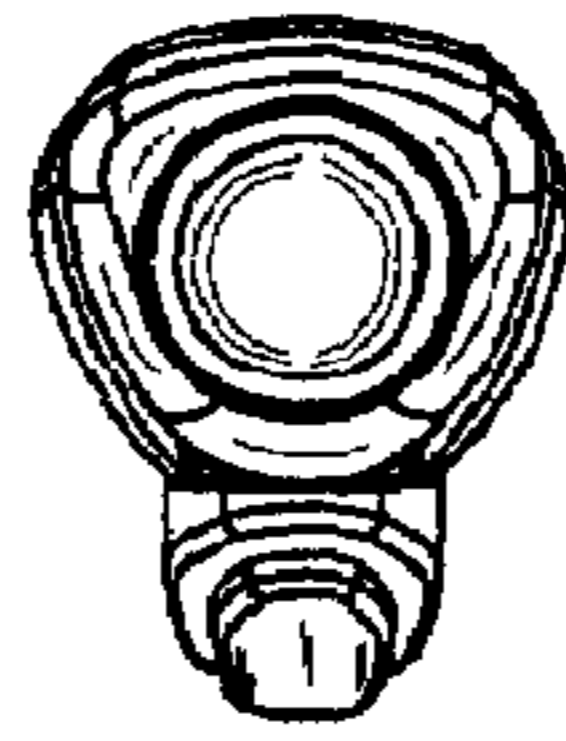
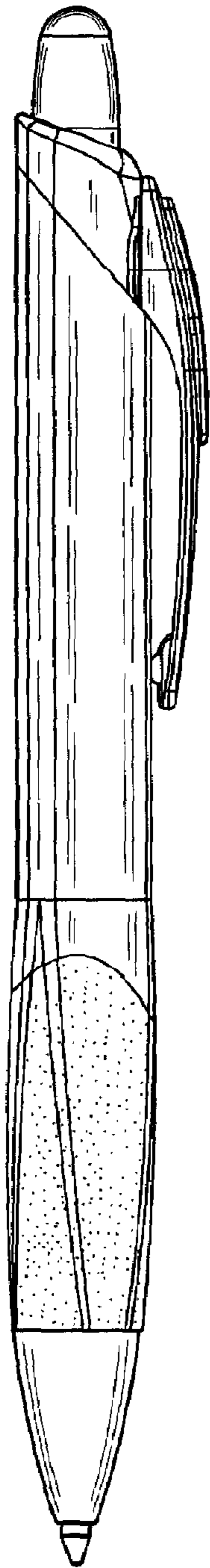

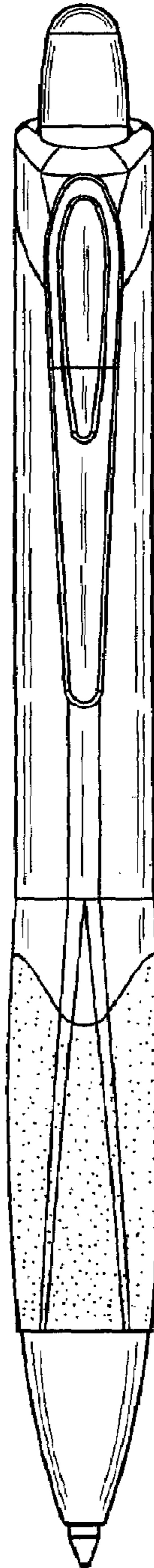


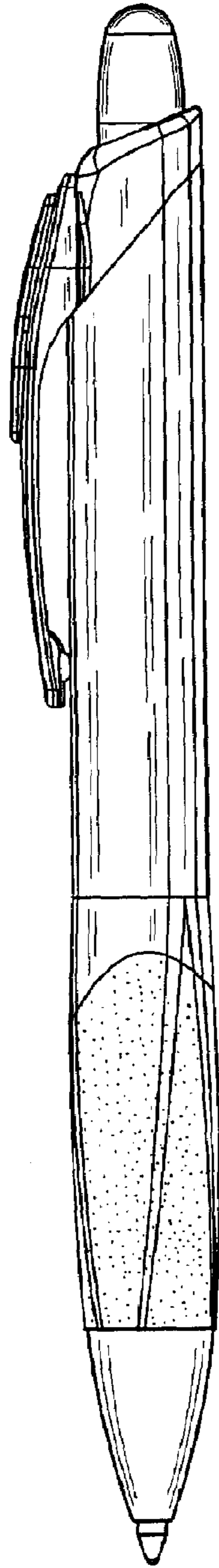

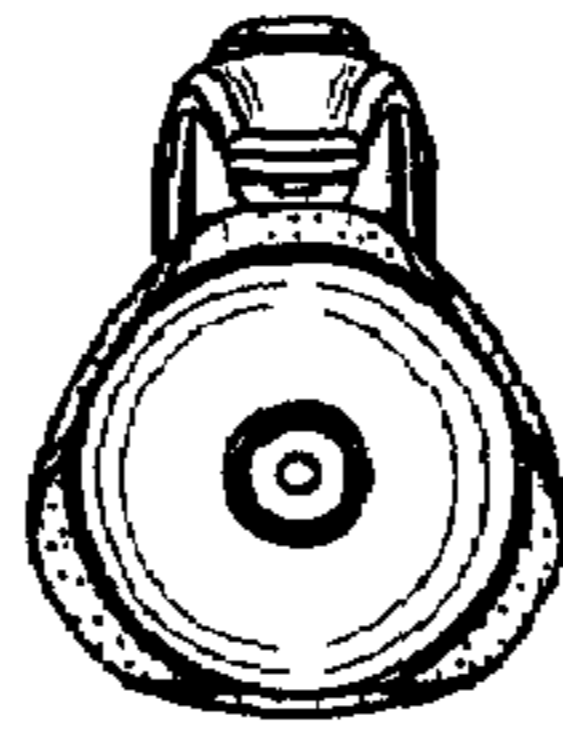

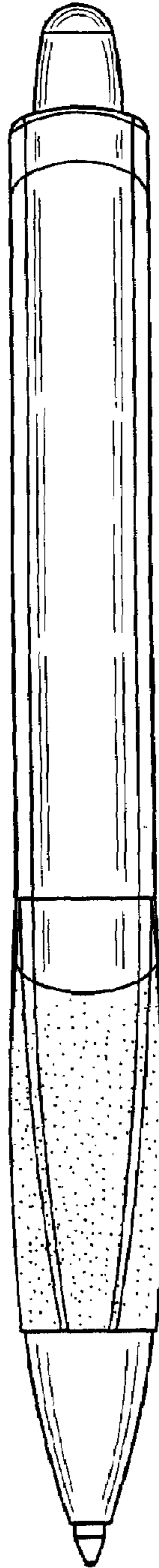
