racquet of FIG. 1;

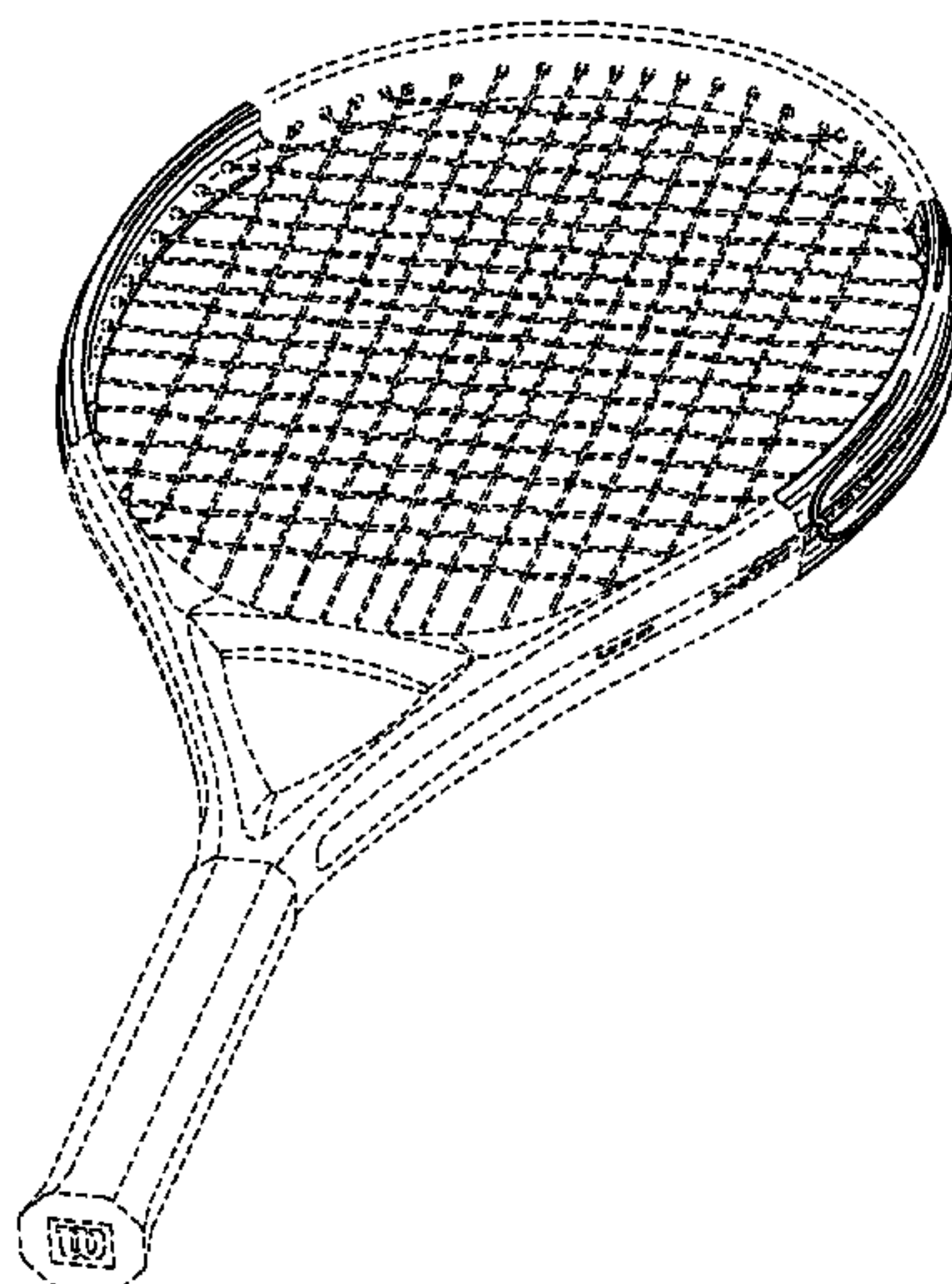
FIG. 4 is a second side view of the hoop portions of a sports

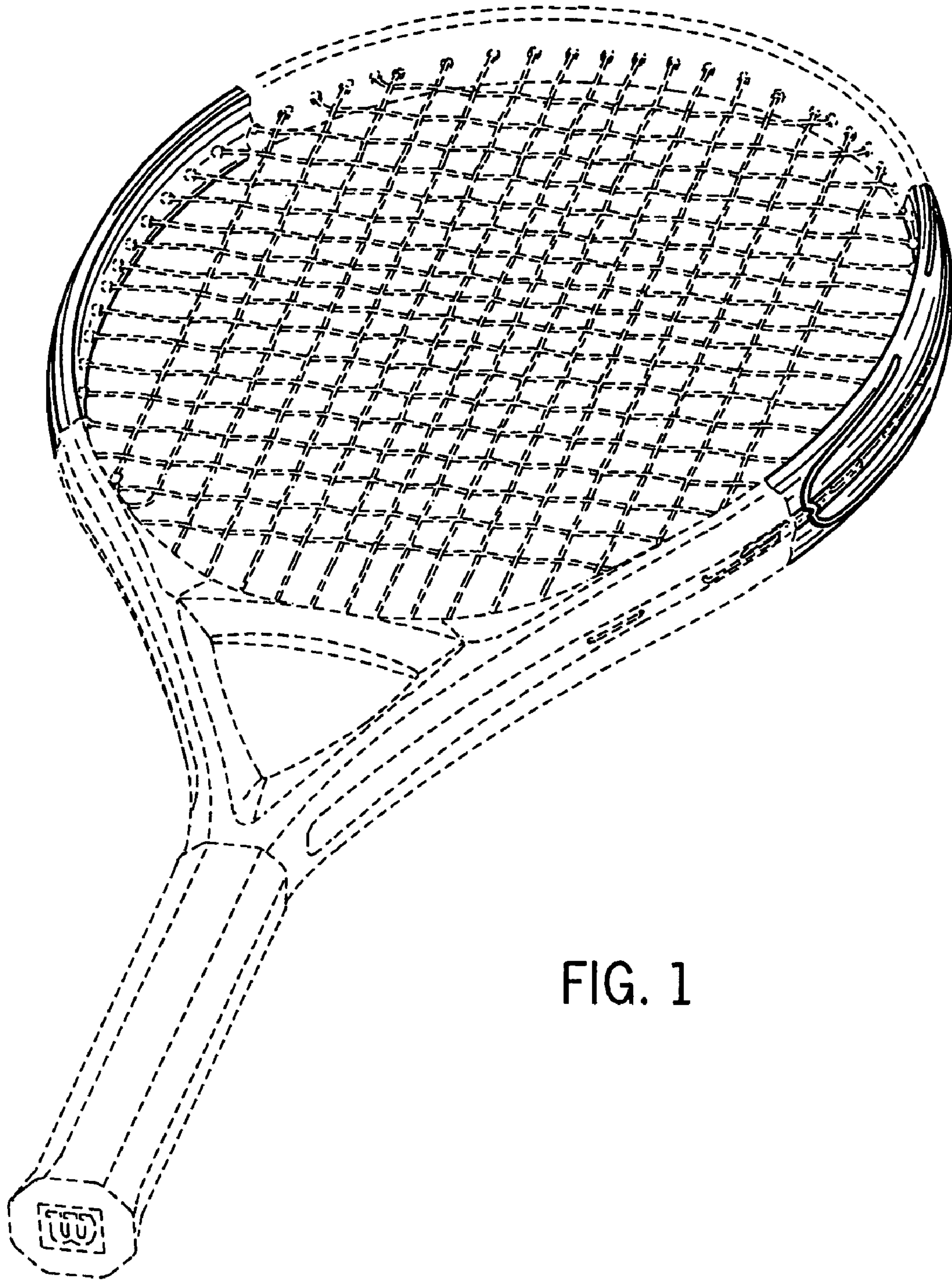

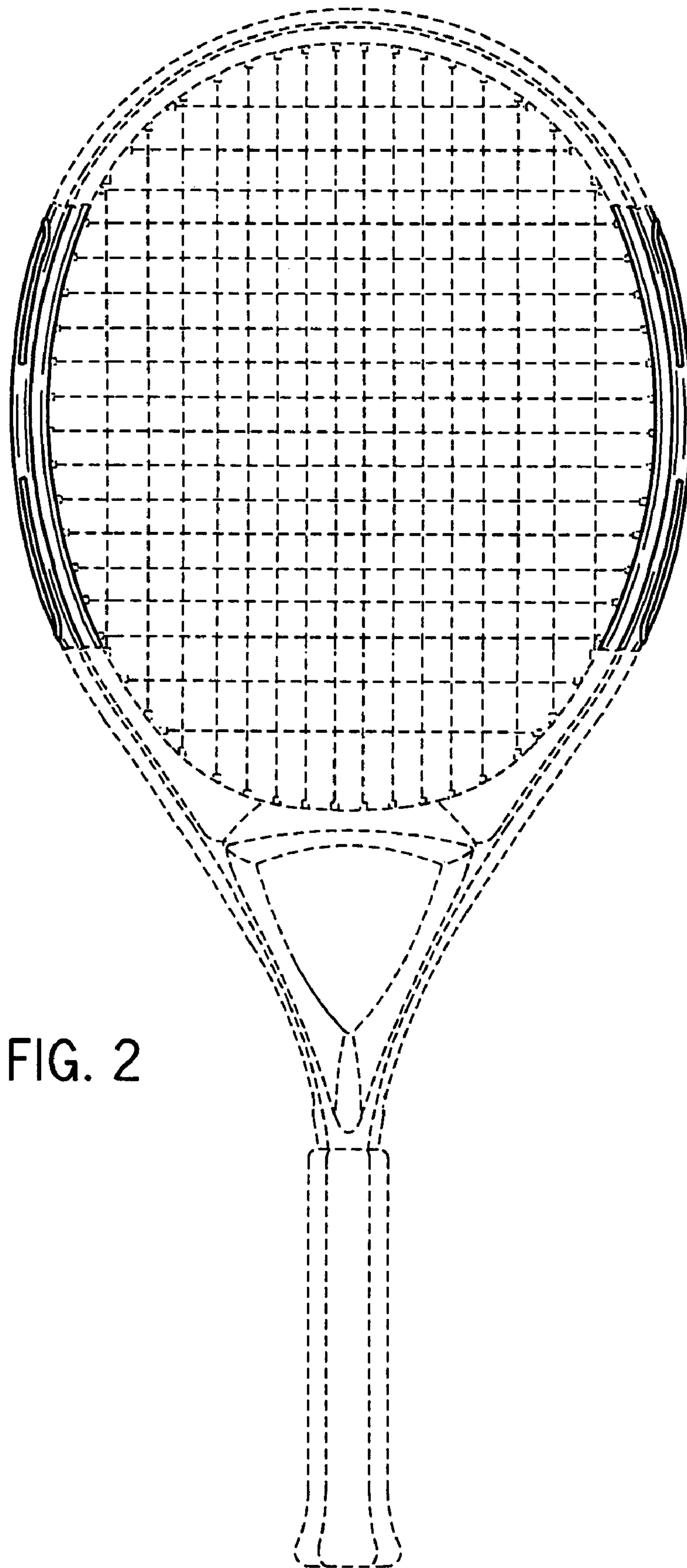

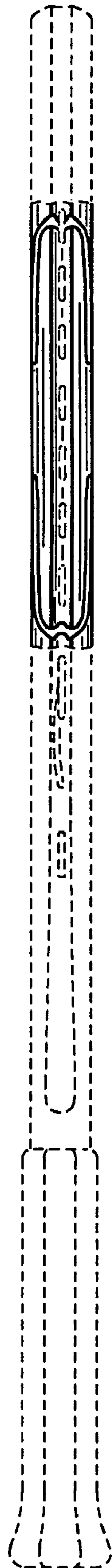
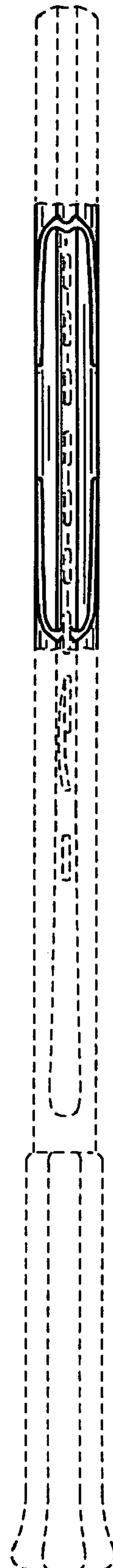

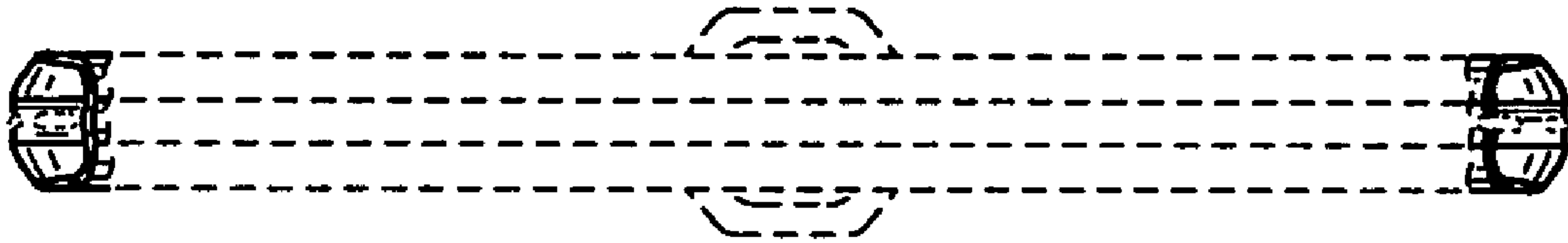
