The ornamental design for an iron golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a back side perspective view of our new iron golf club head;

FIG. 7 is a heel side view thereof;

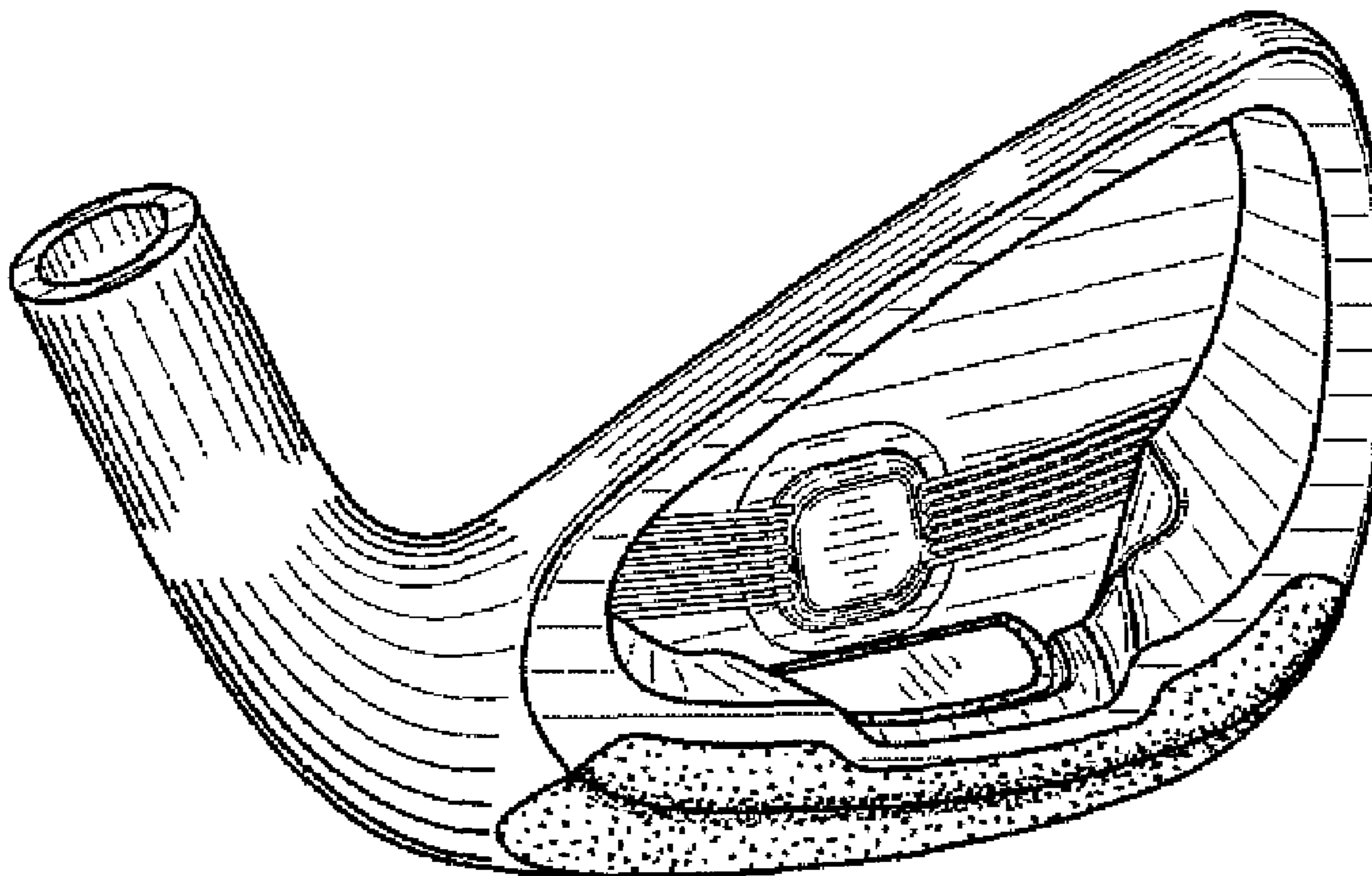
FIG. 8 is a bottom view thereof;

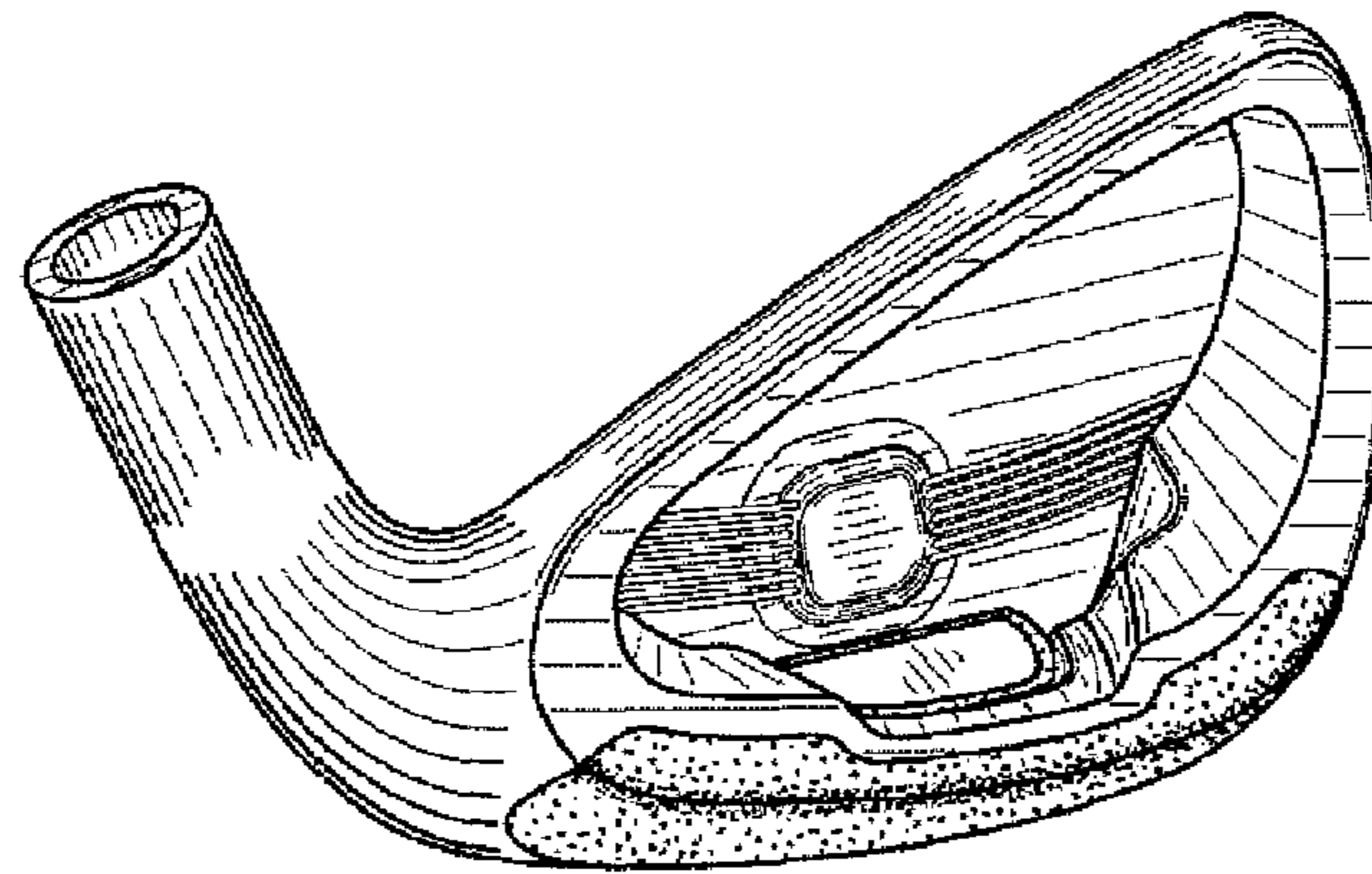

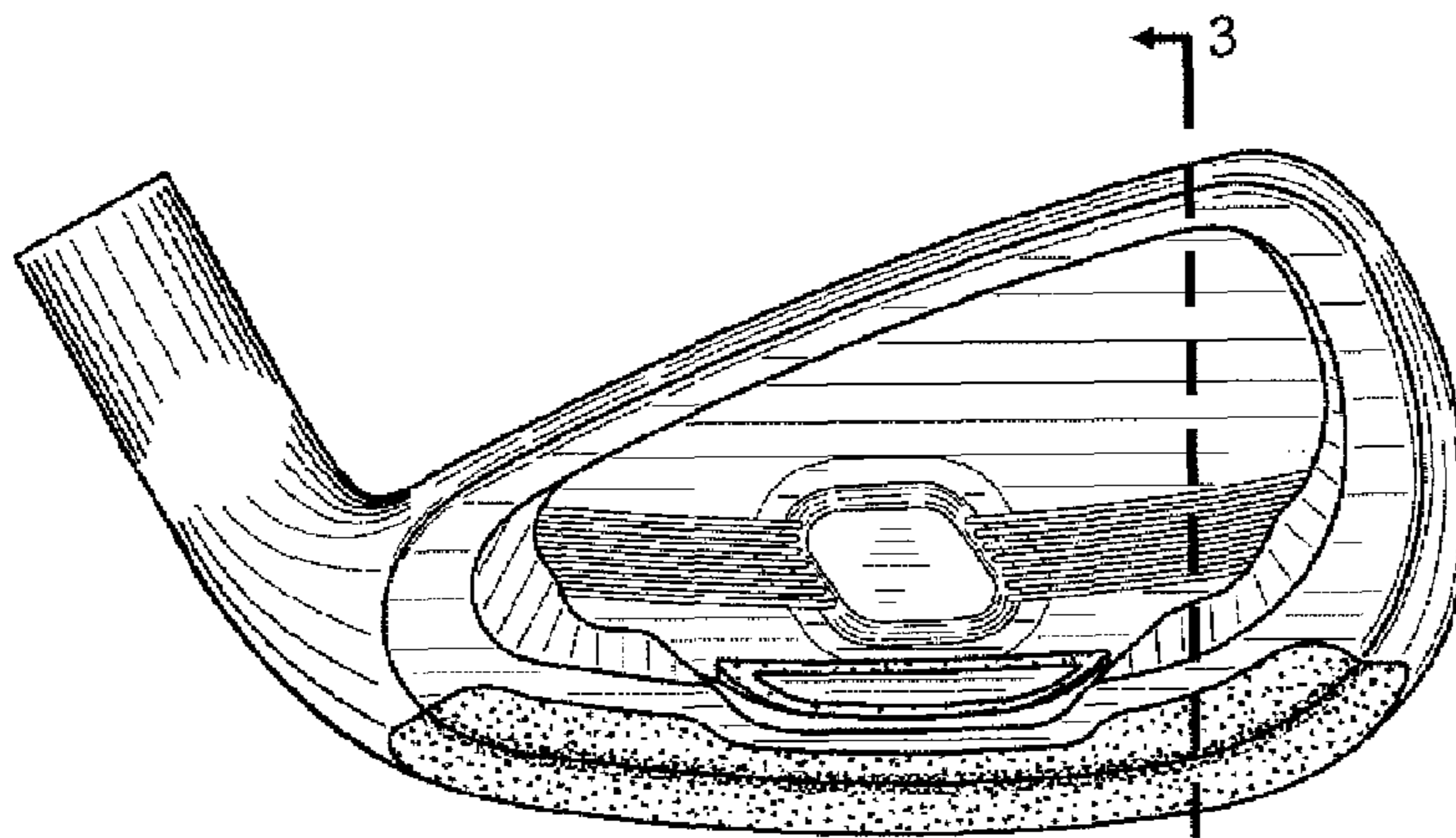

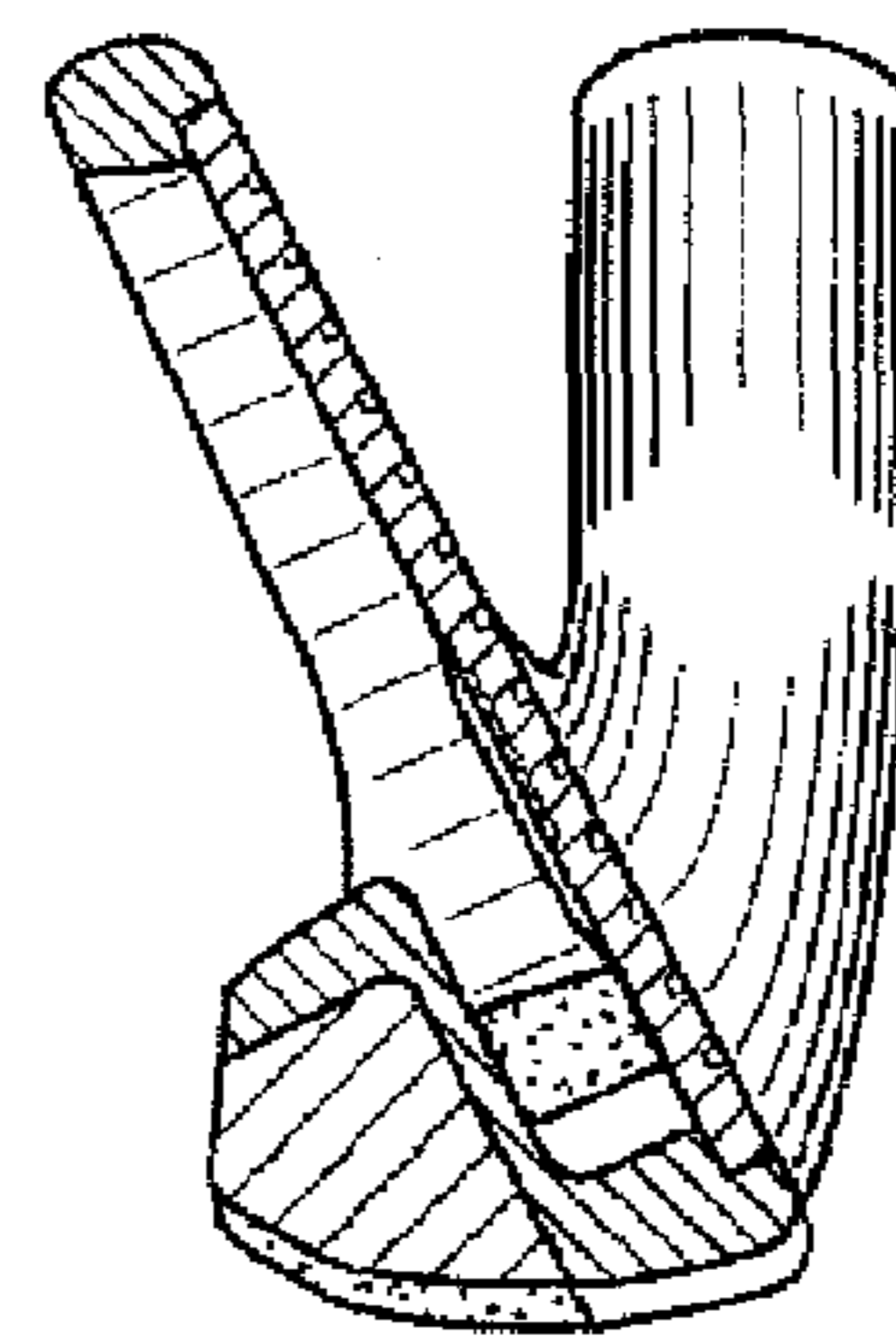

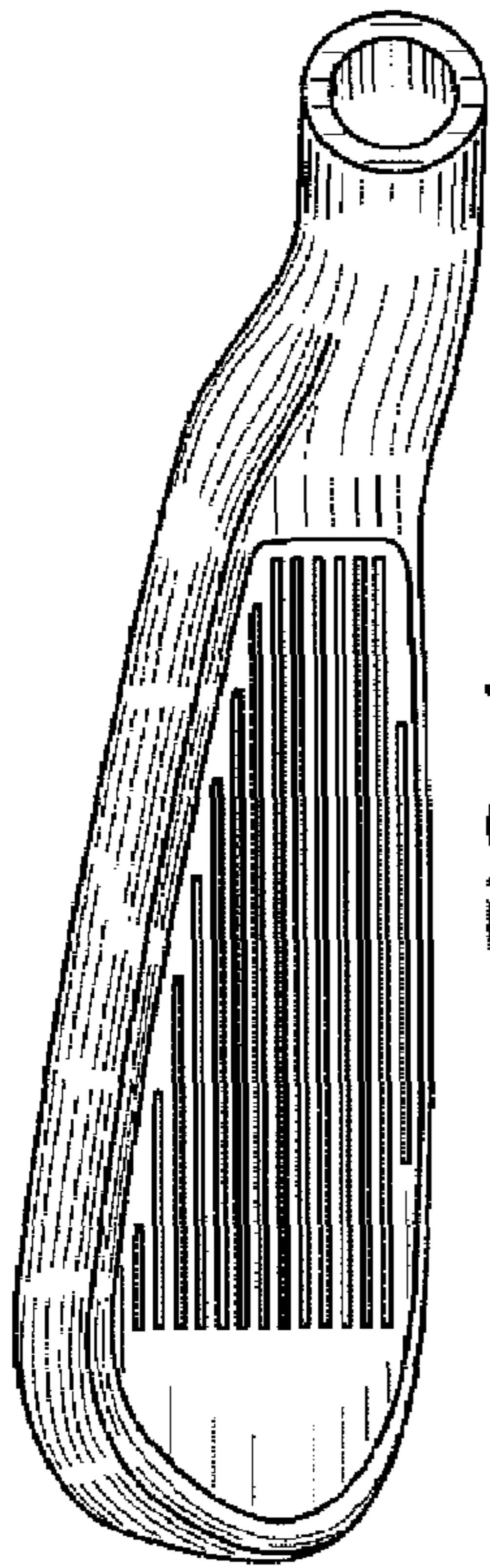

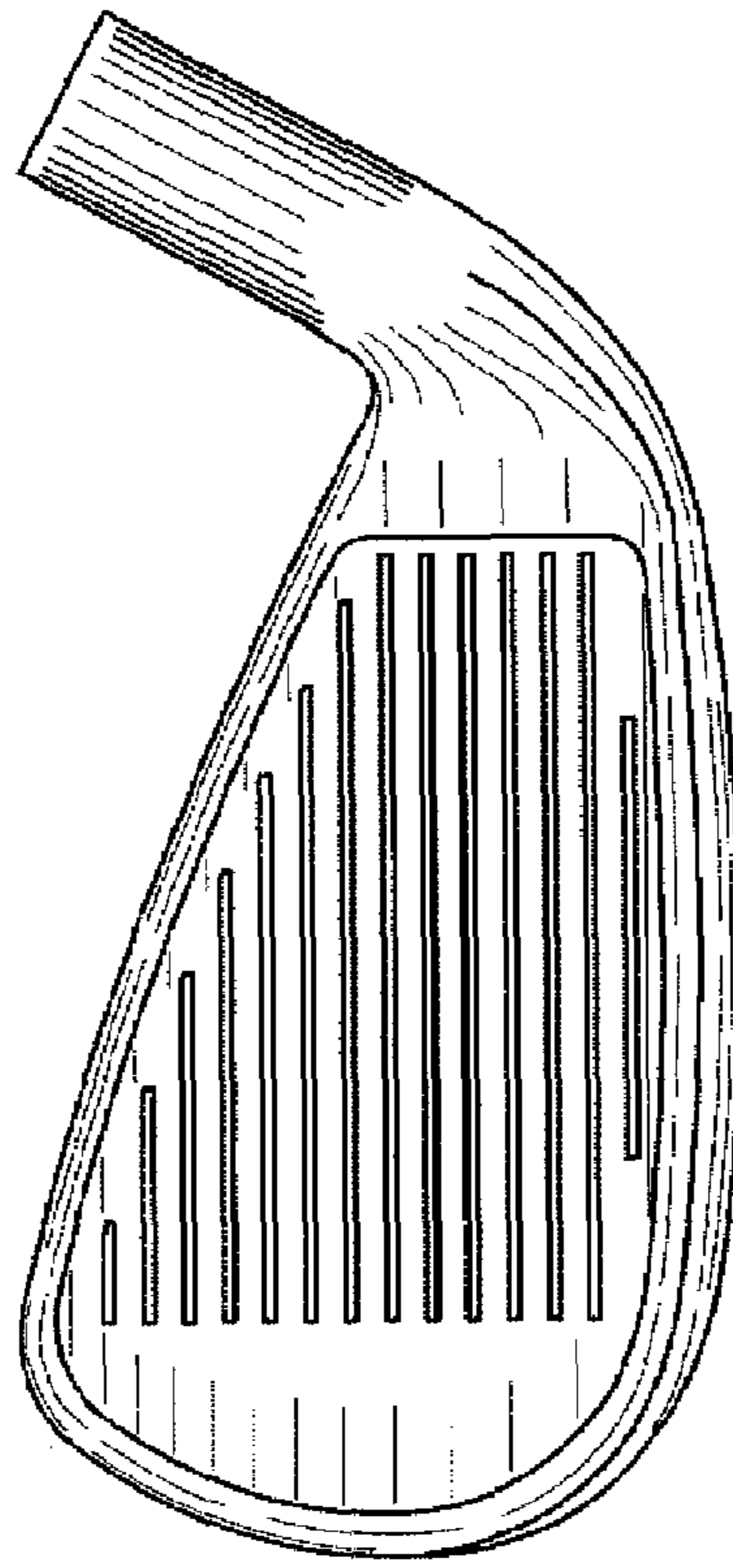

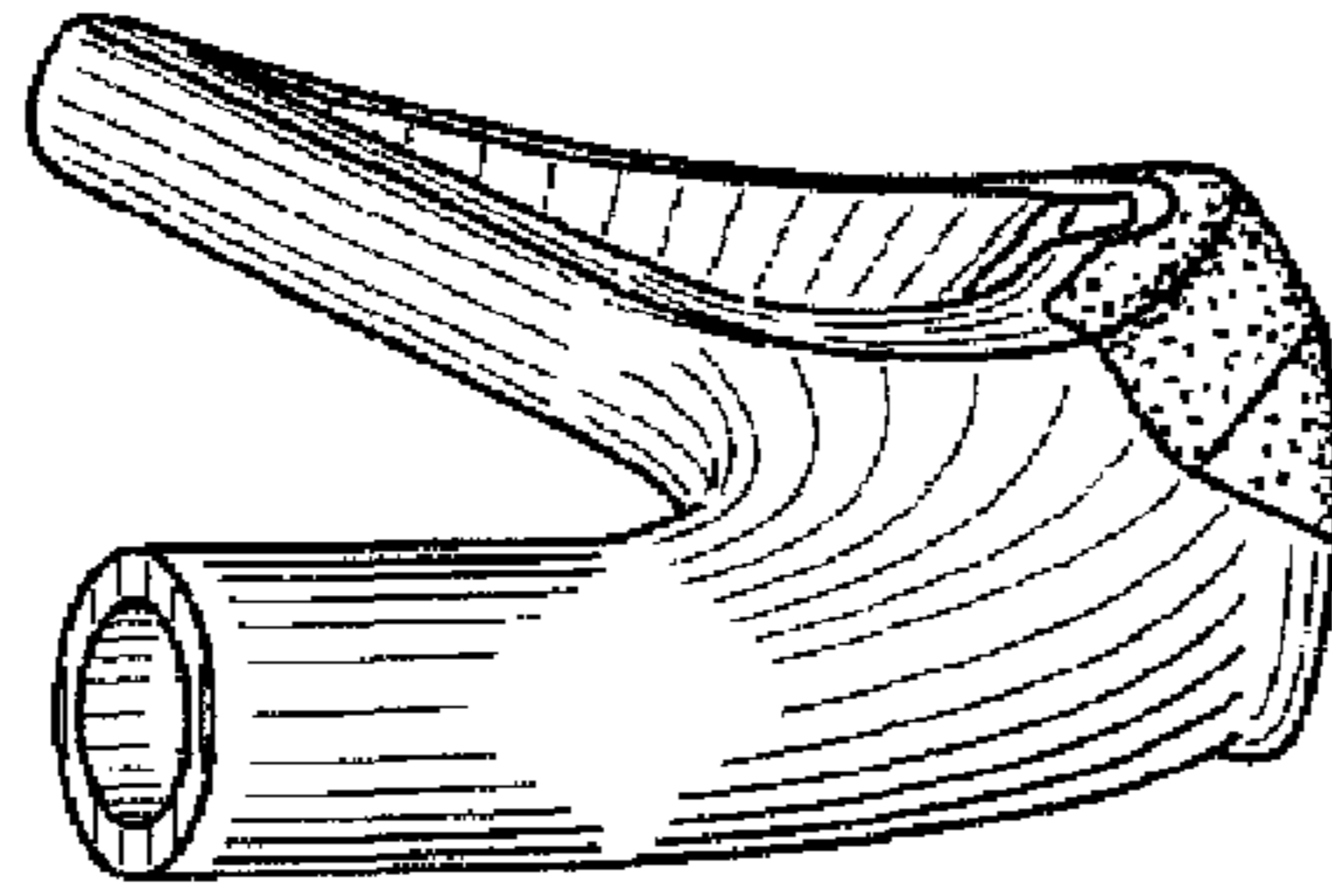

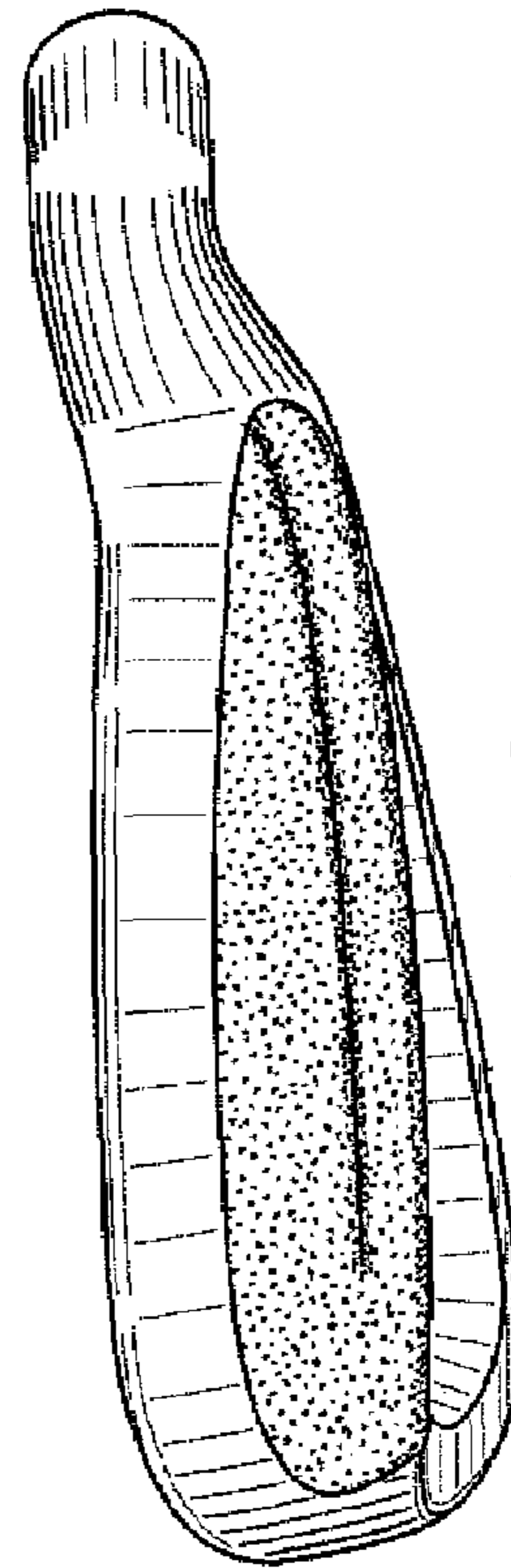

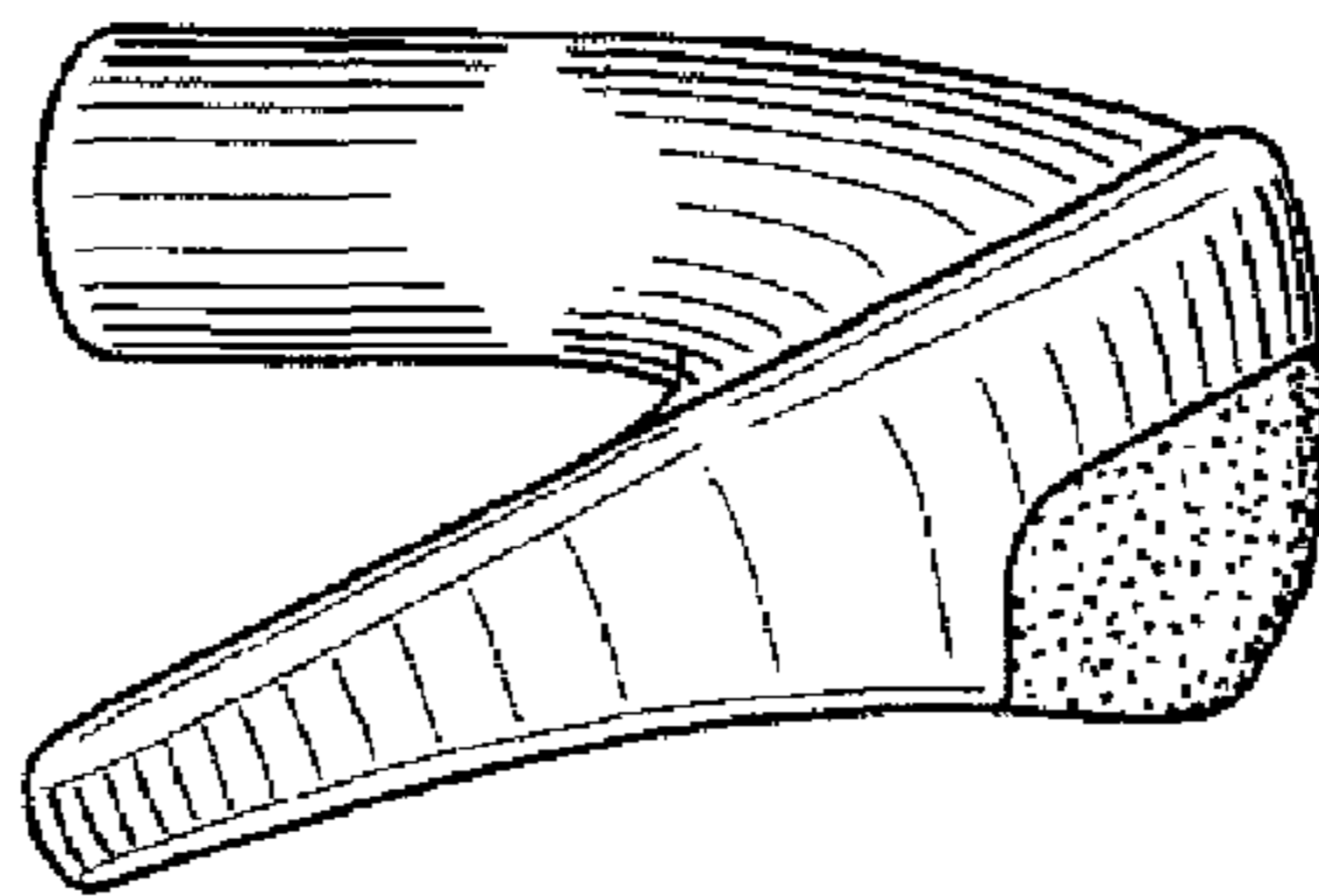

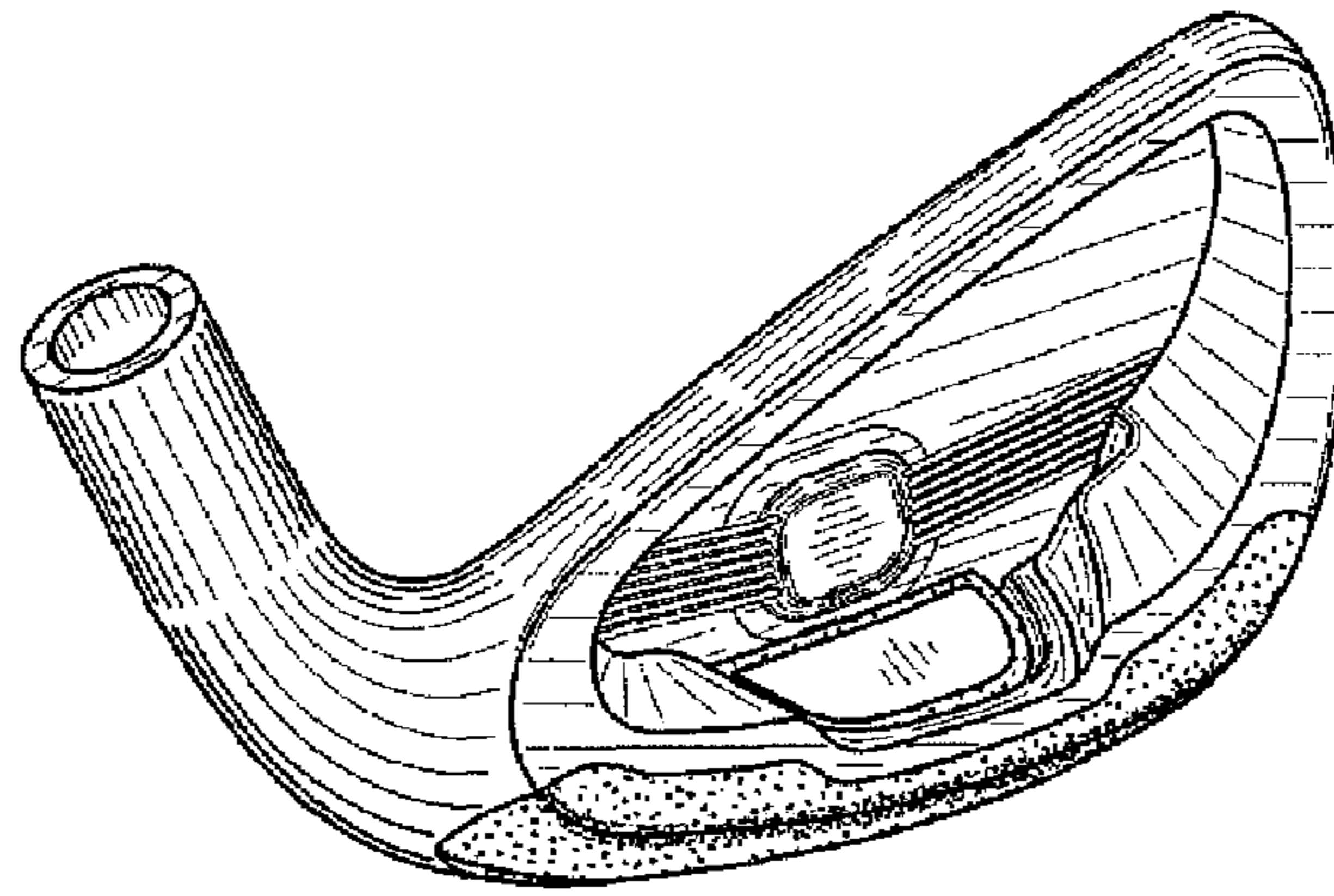

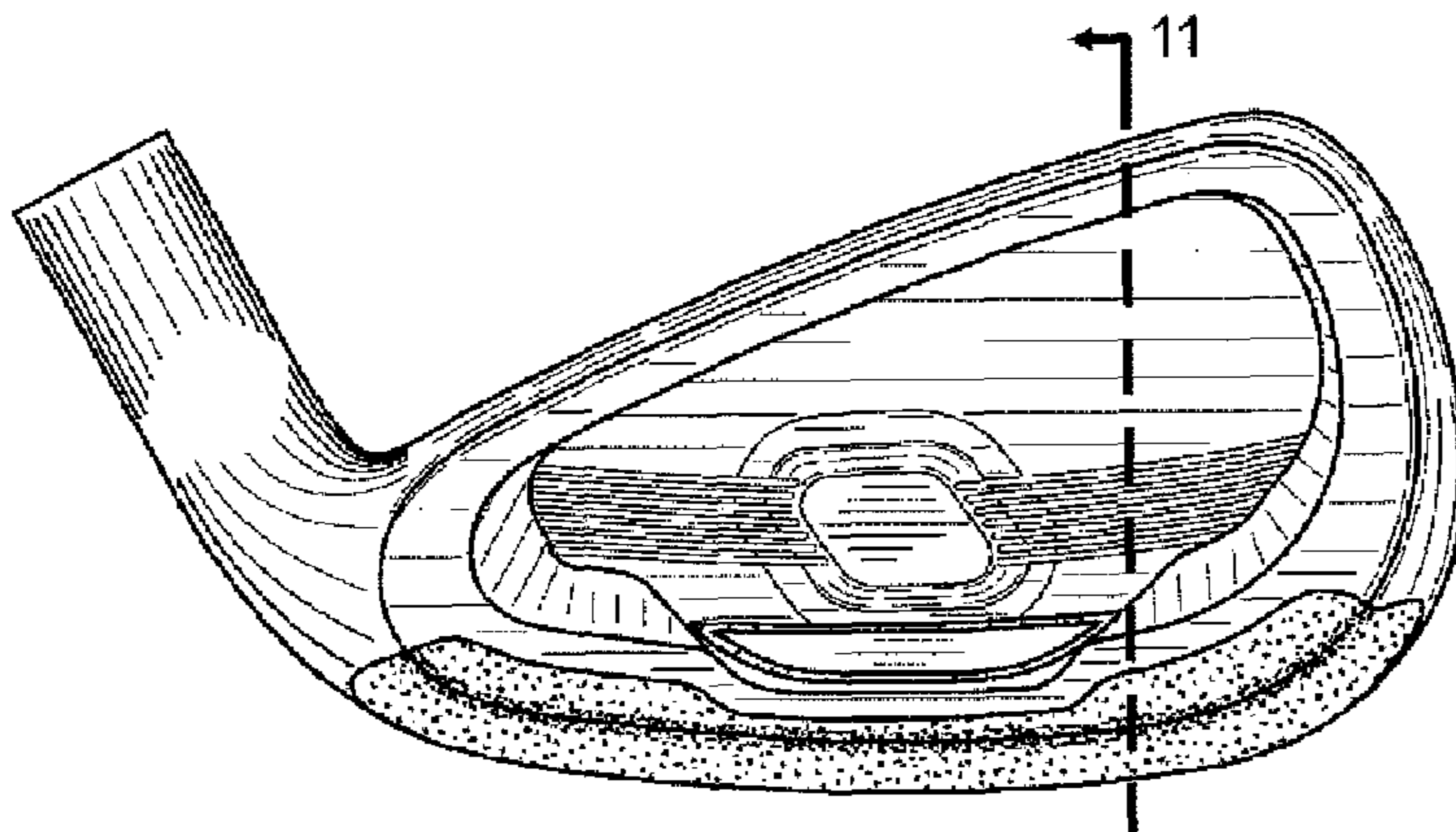

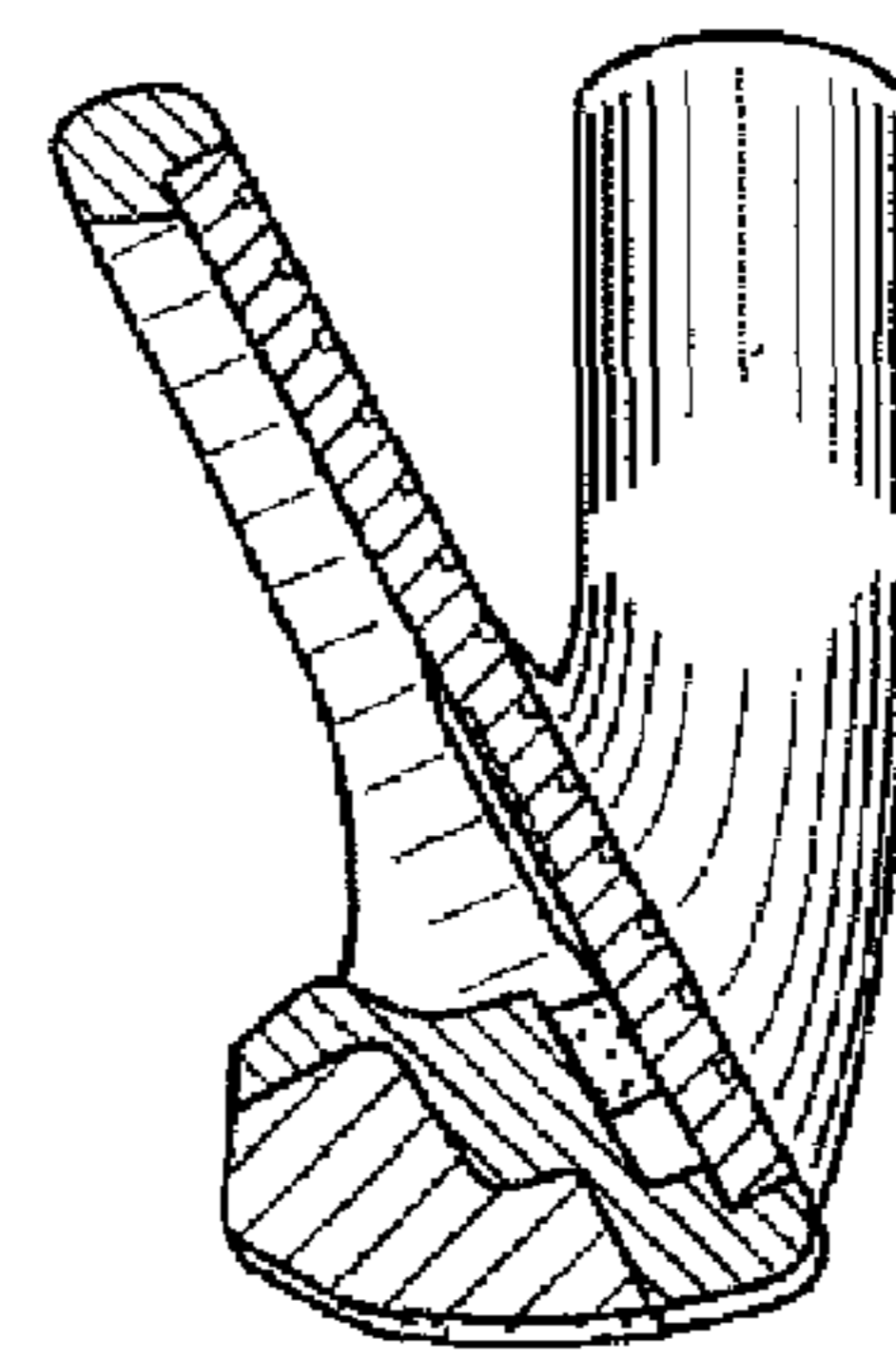
