FIG. 2 is a first side view of the housing shown in FIG. 1;

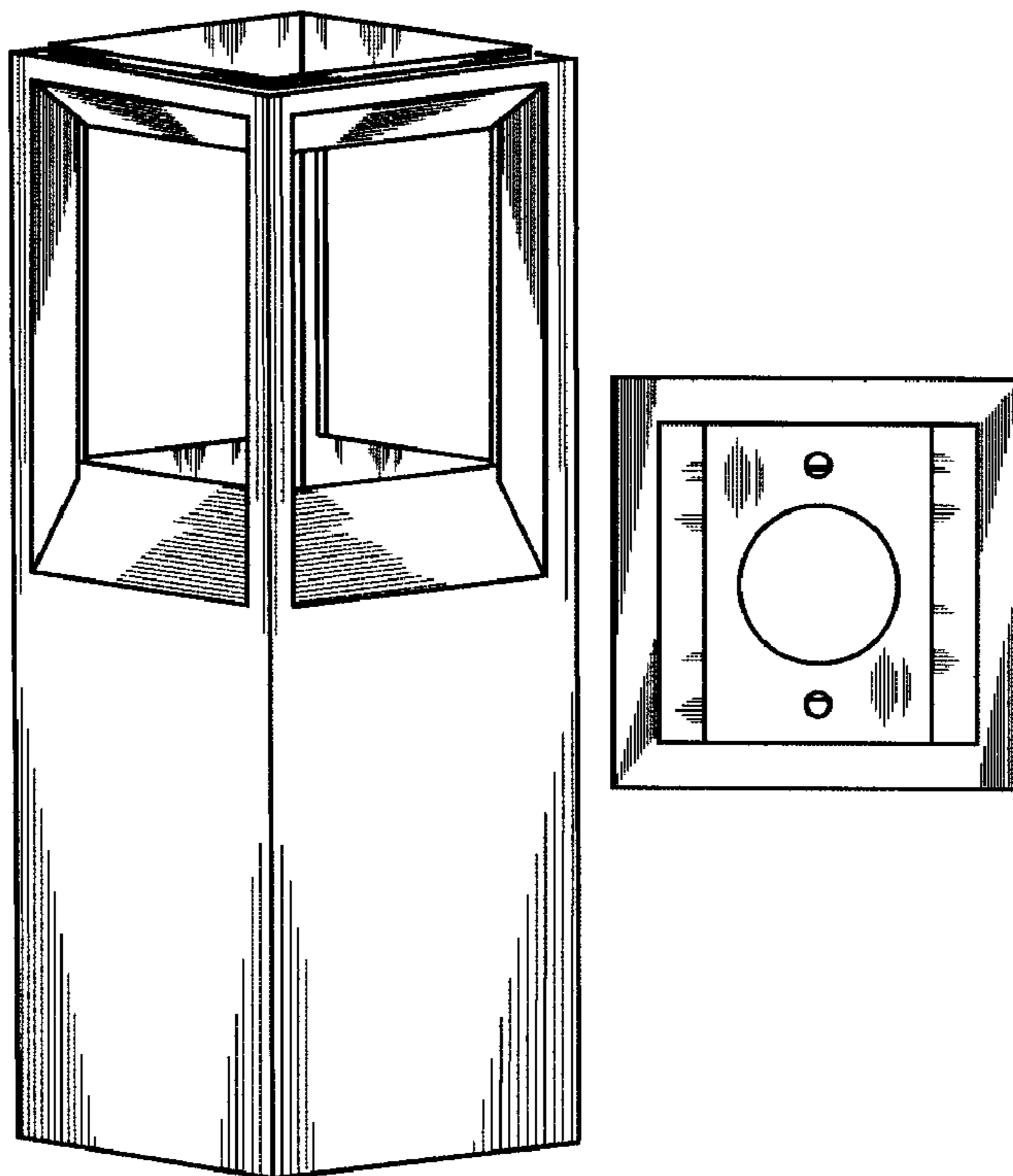
FIG. 3 is a second side view of the housing shown in FIG. 1;

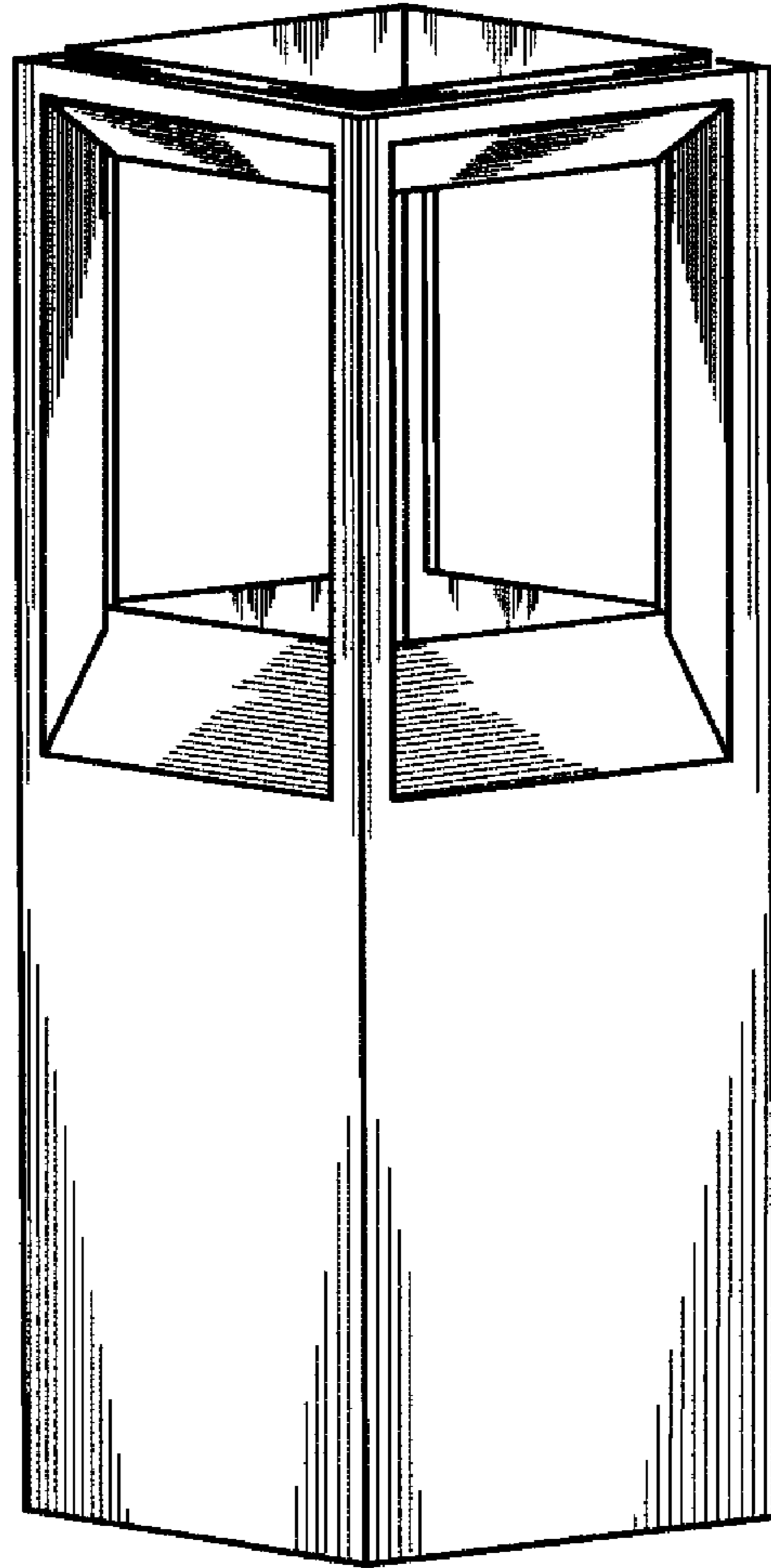

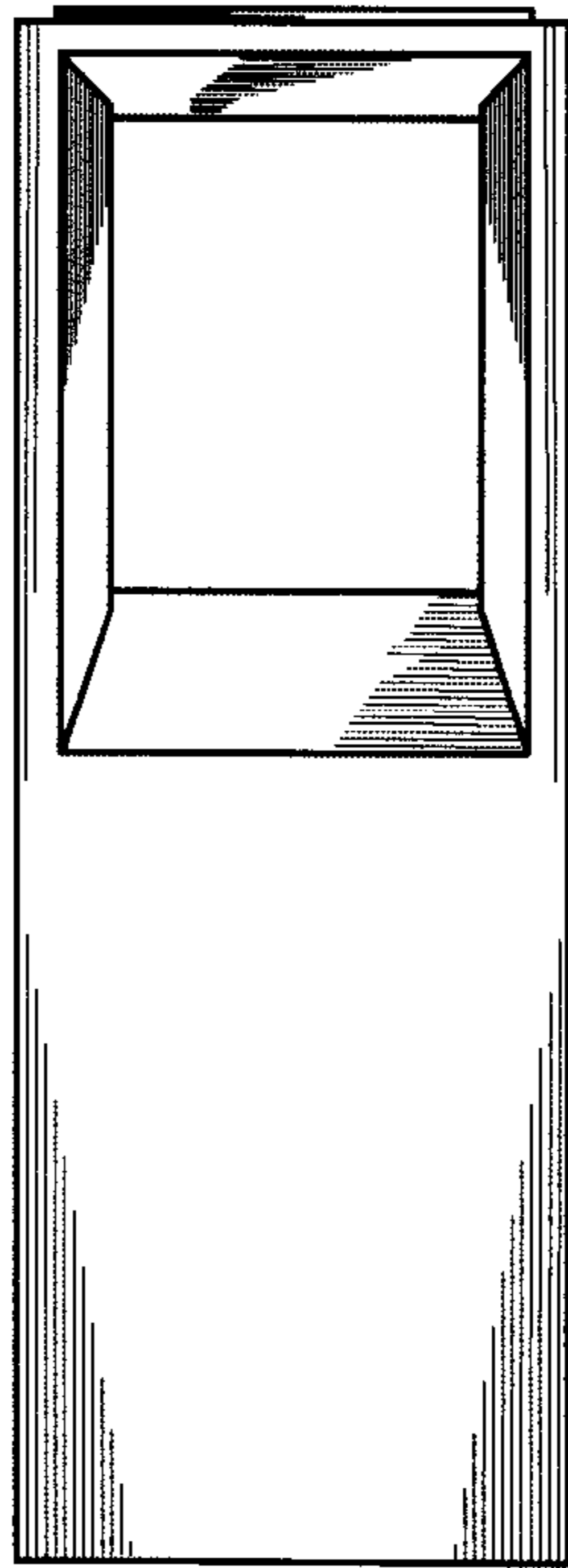

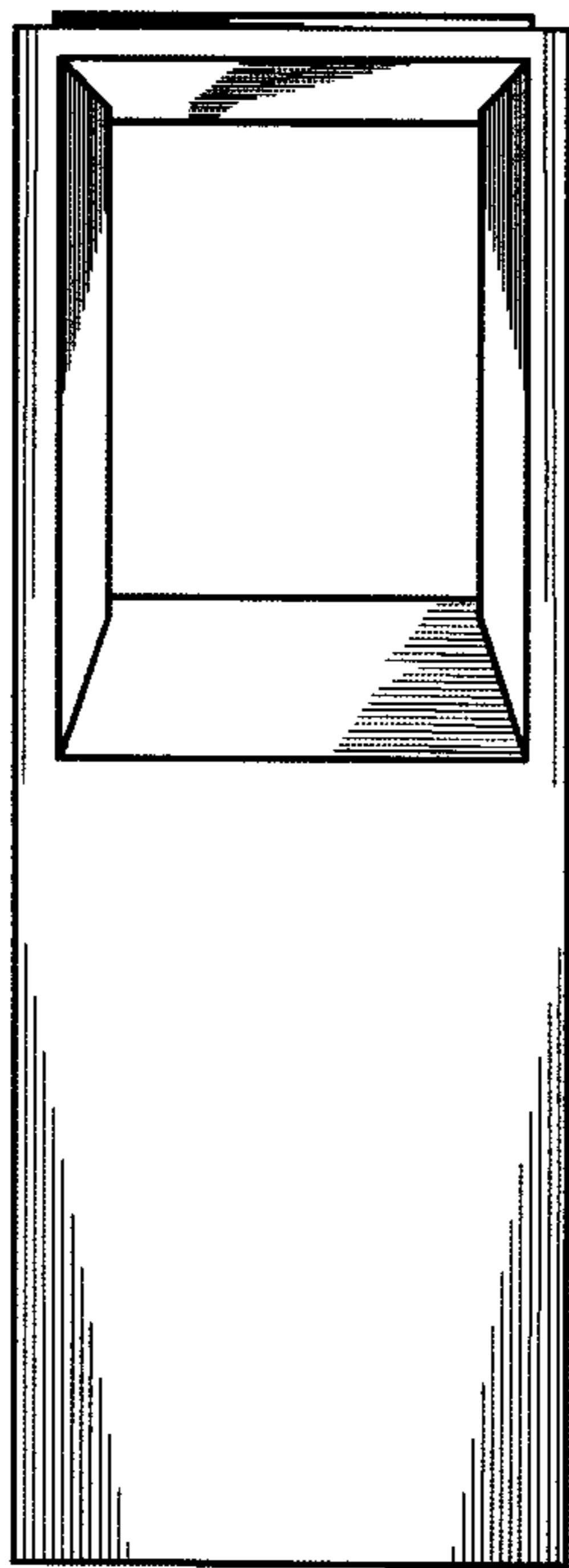

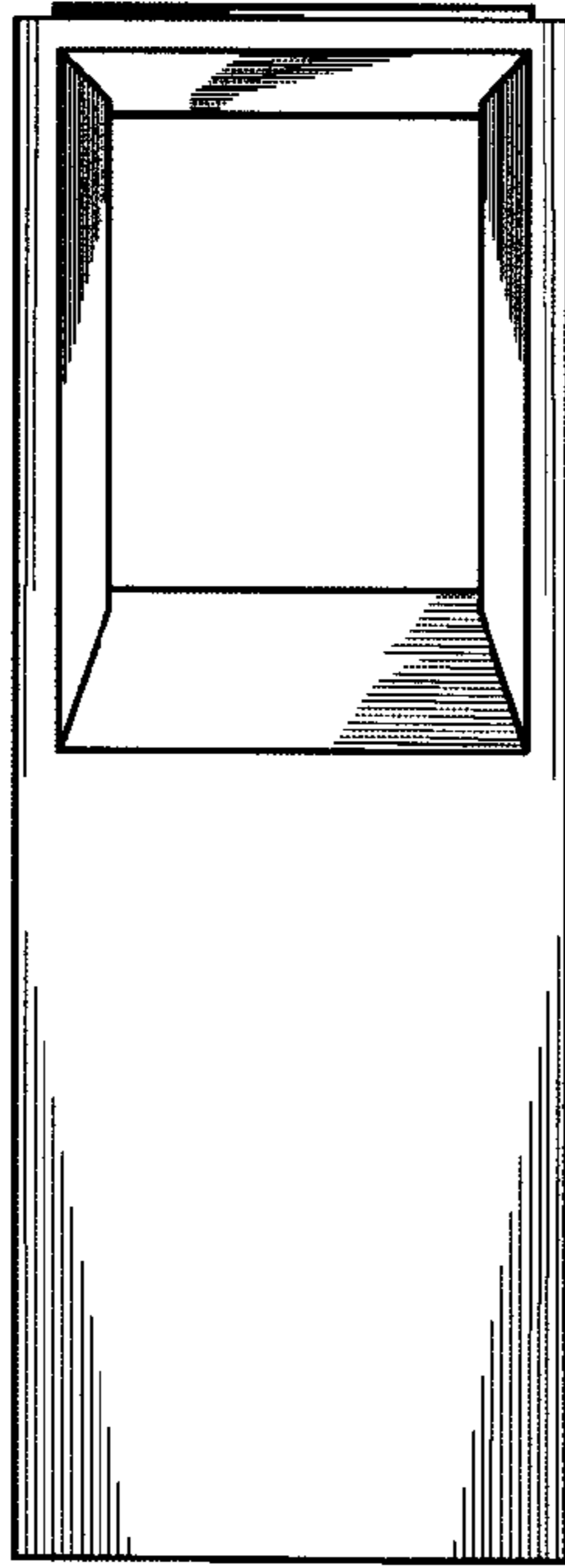

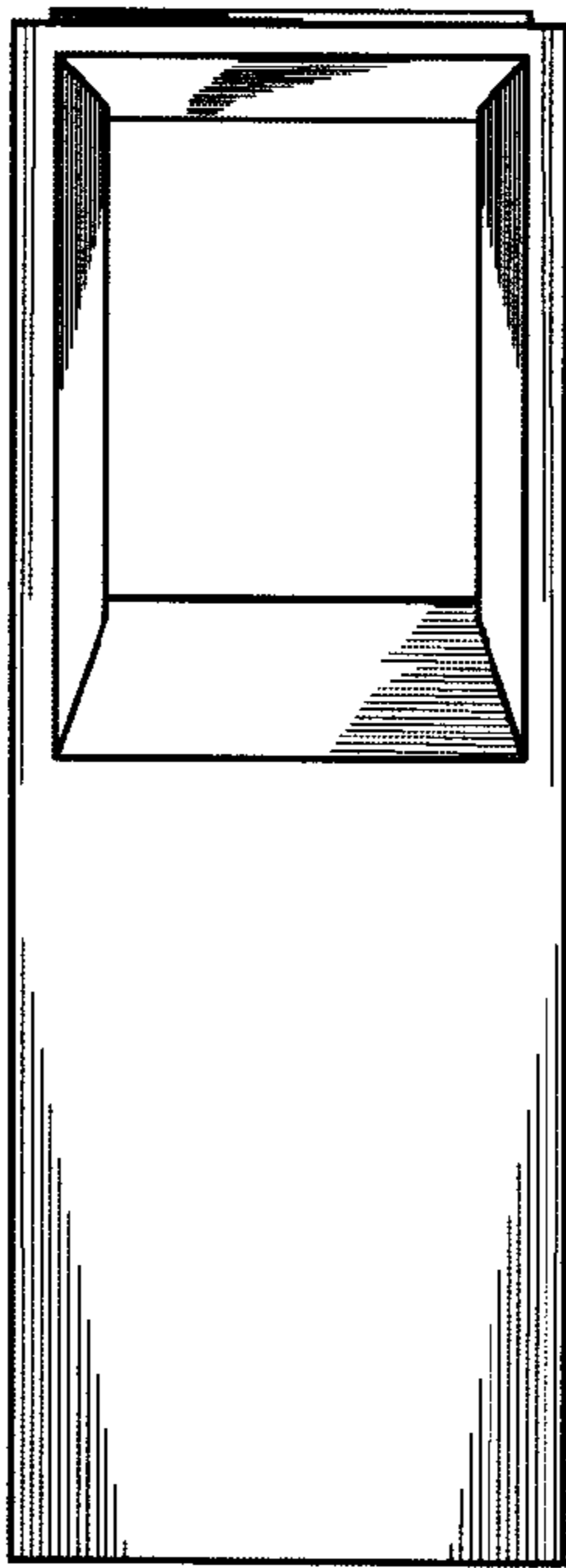

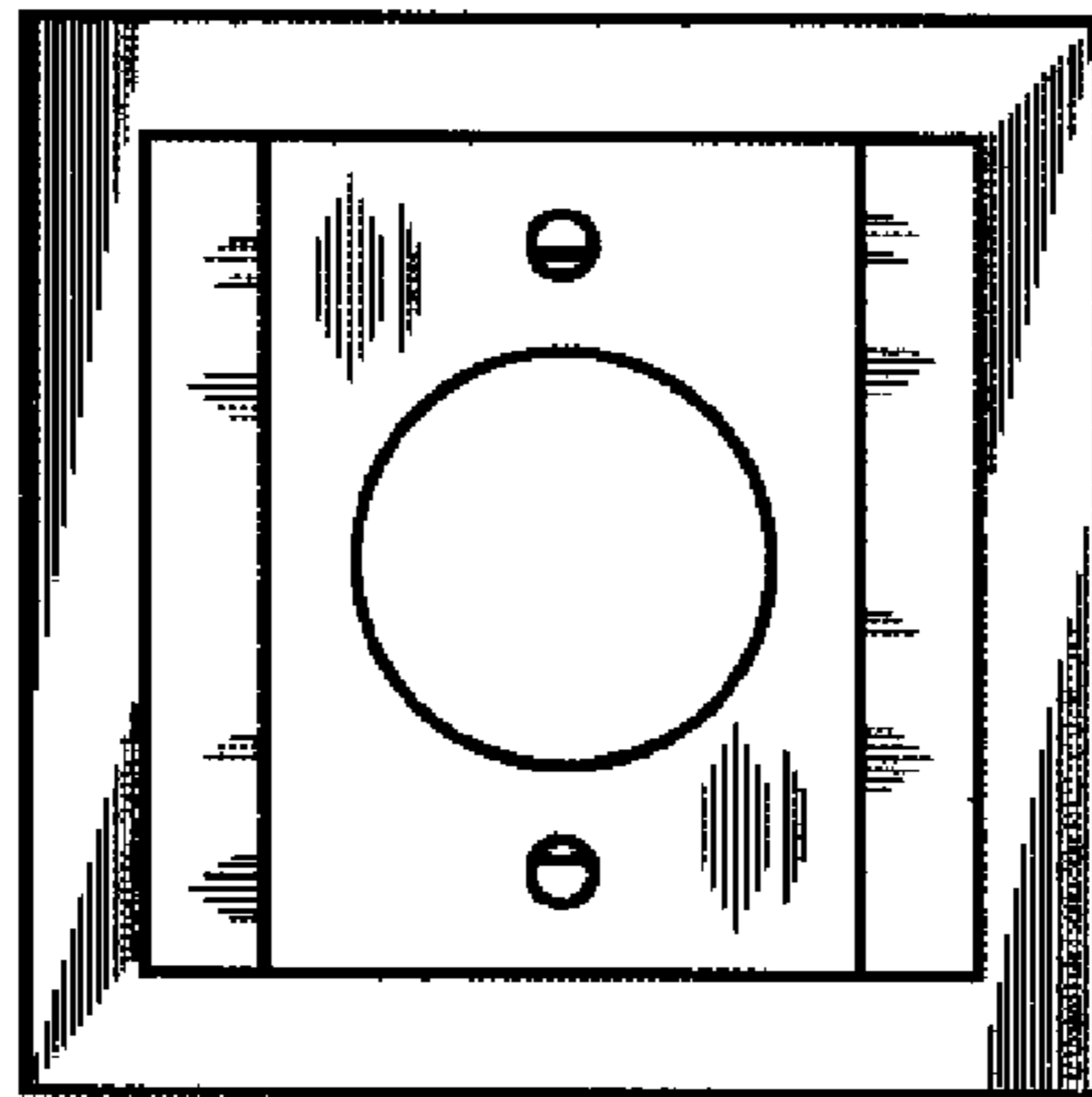
