(57) **CLAIM**

The ornamental design for a chandelier component, as
shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a chandelier com-
ponent in accordance with my design;

FIG. 2 is a bottom plan view of the chandelier component in
accordance with my design; and,

FIG. 3 is a side elevation view of the chandelier component
in accordance with my design, the opposite side, front and
back being mirror images of that shown.

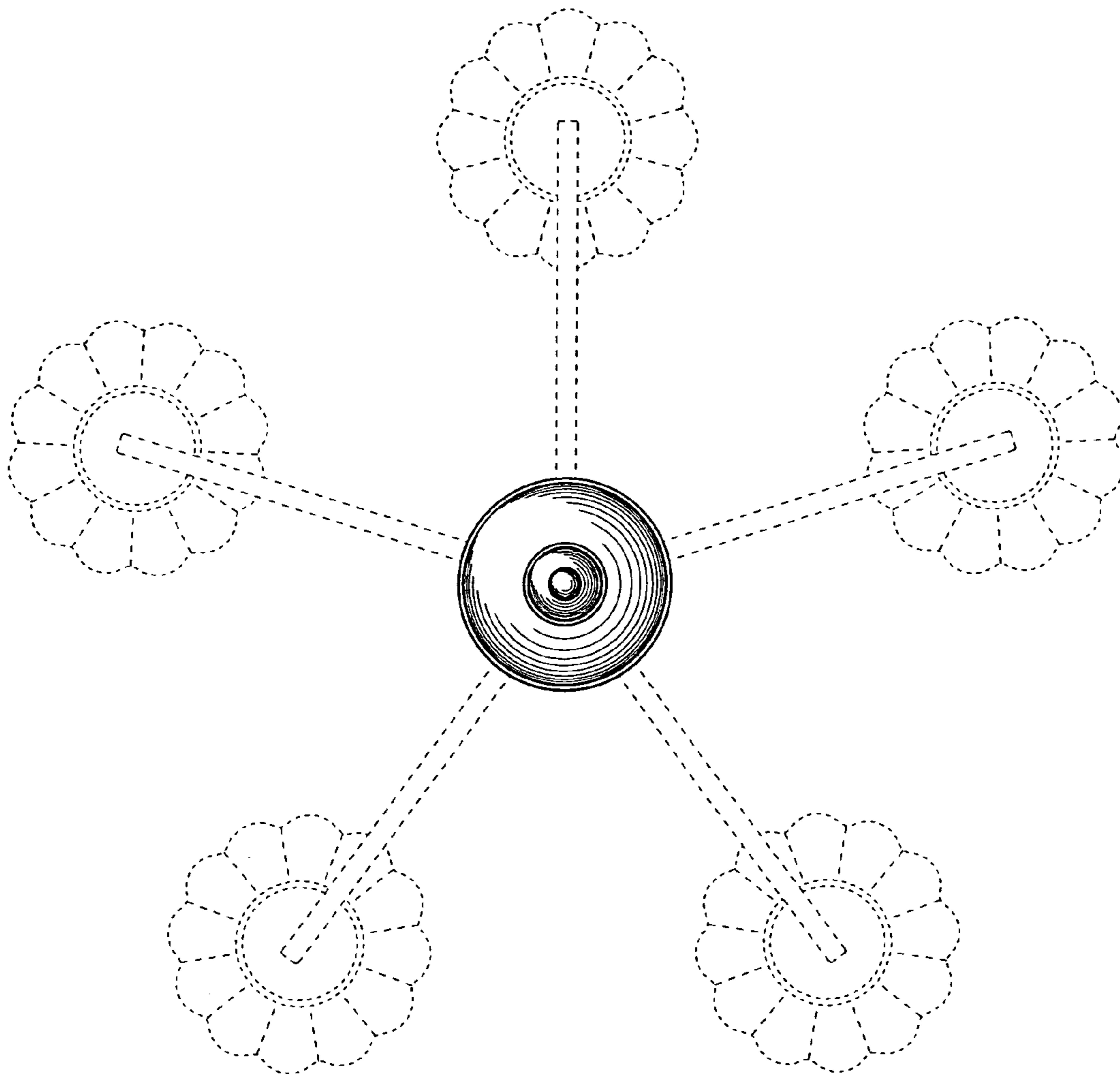

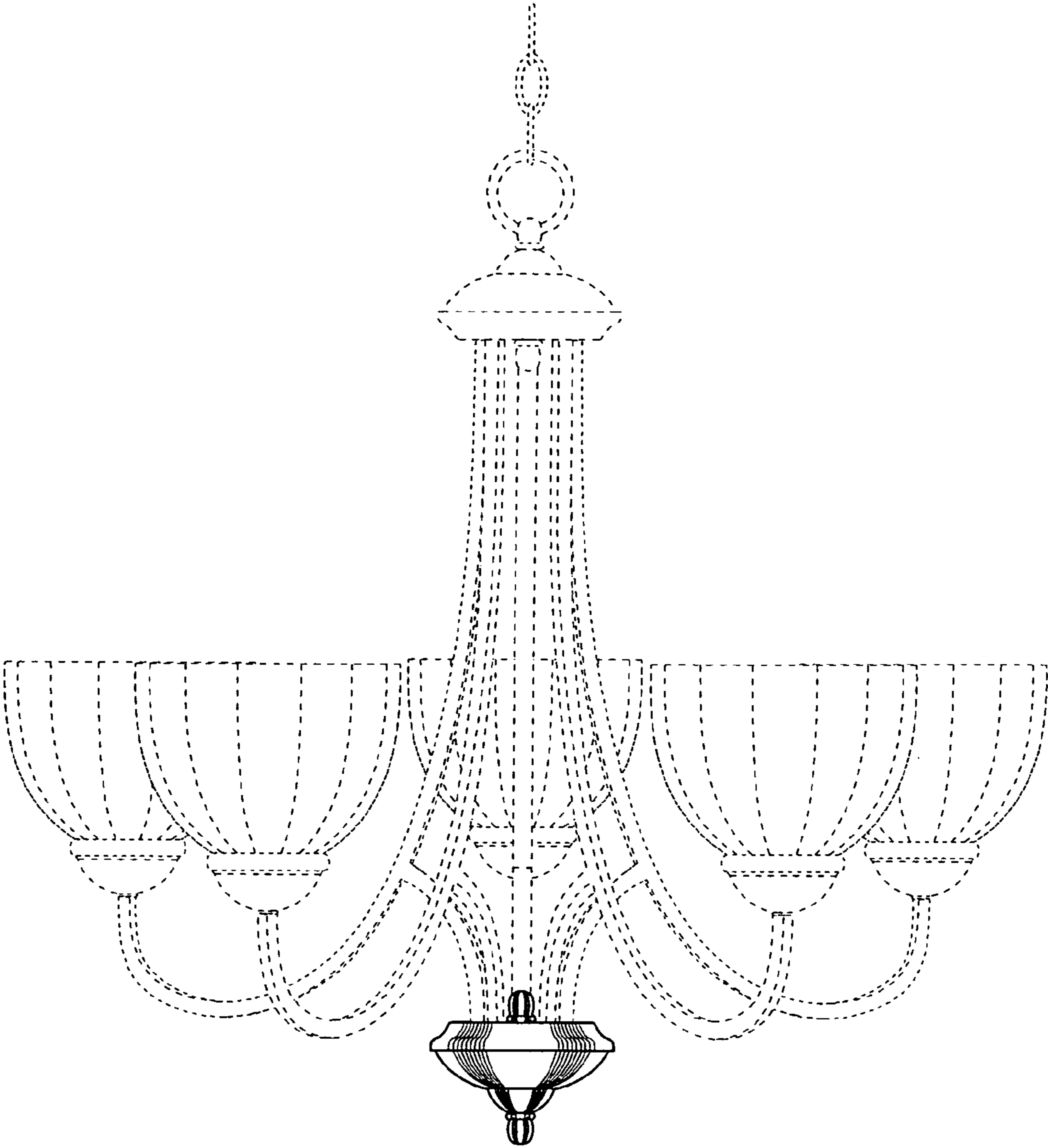
