The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole showing the new design;

FIG. 2 is a front elevational plan view of the shoe sole depicted in FIG. 1;

FIG. 9 is a left side elevational plan view of the shoe sole depicted in FIG. 6;

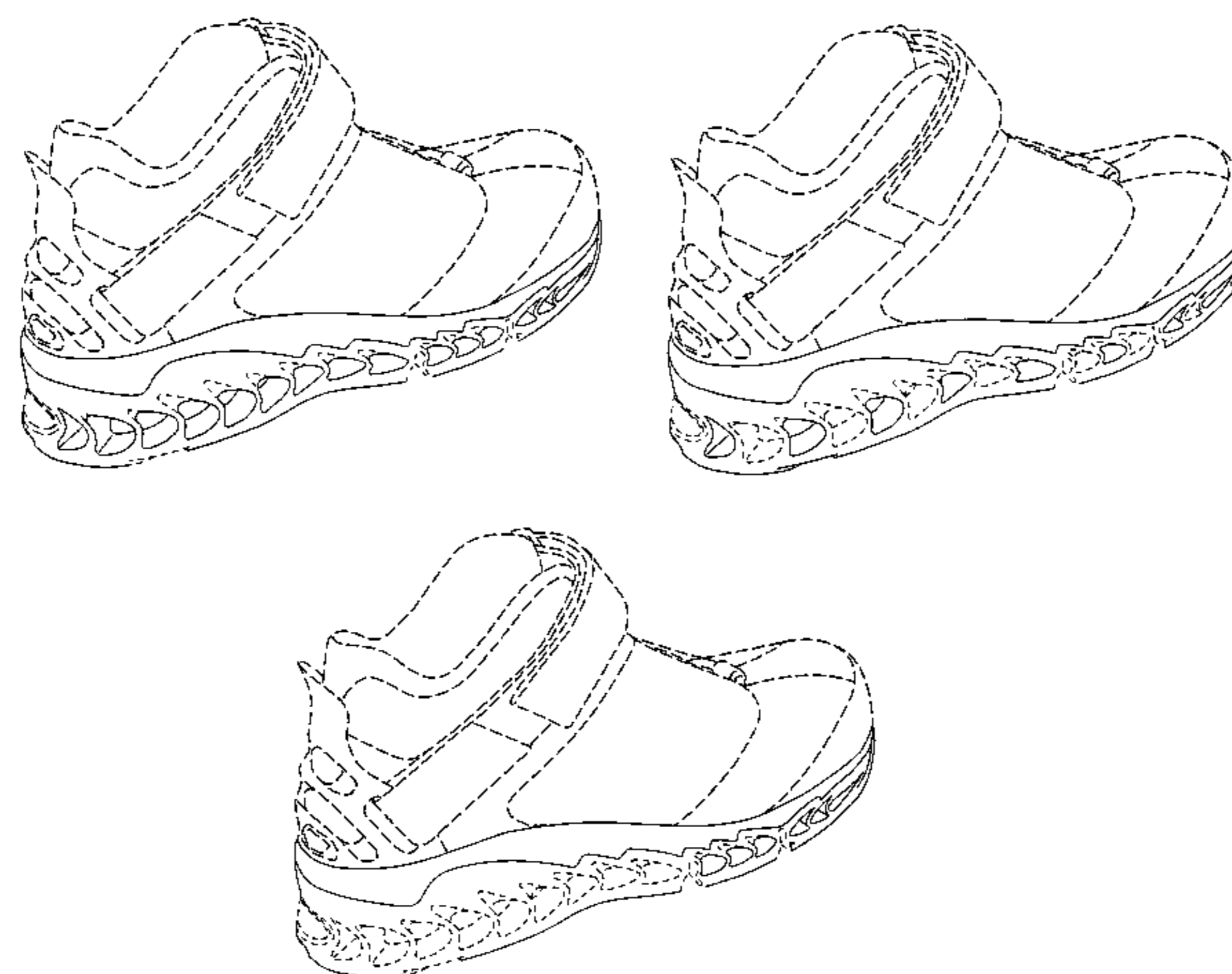


FIG. 10 is a right side elevational plan view of the shoe sole depicted in FIG. 6;

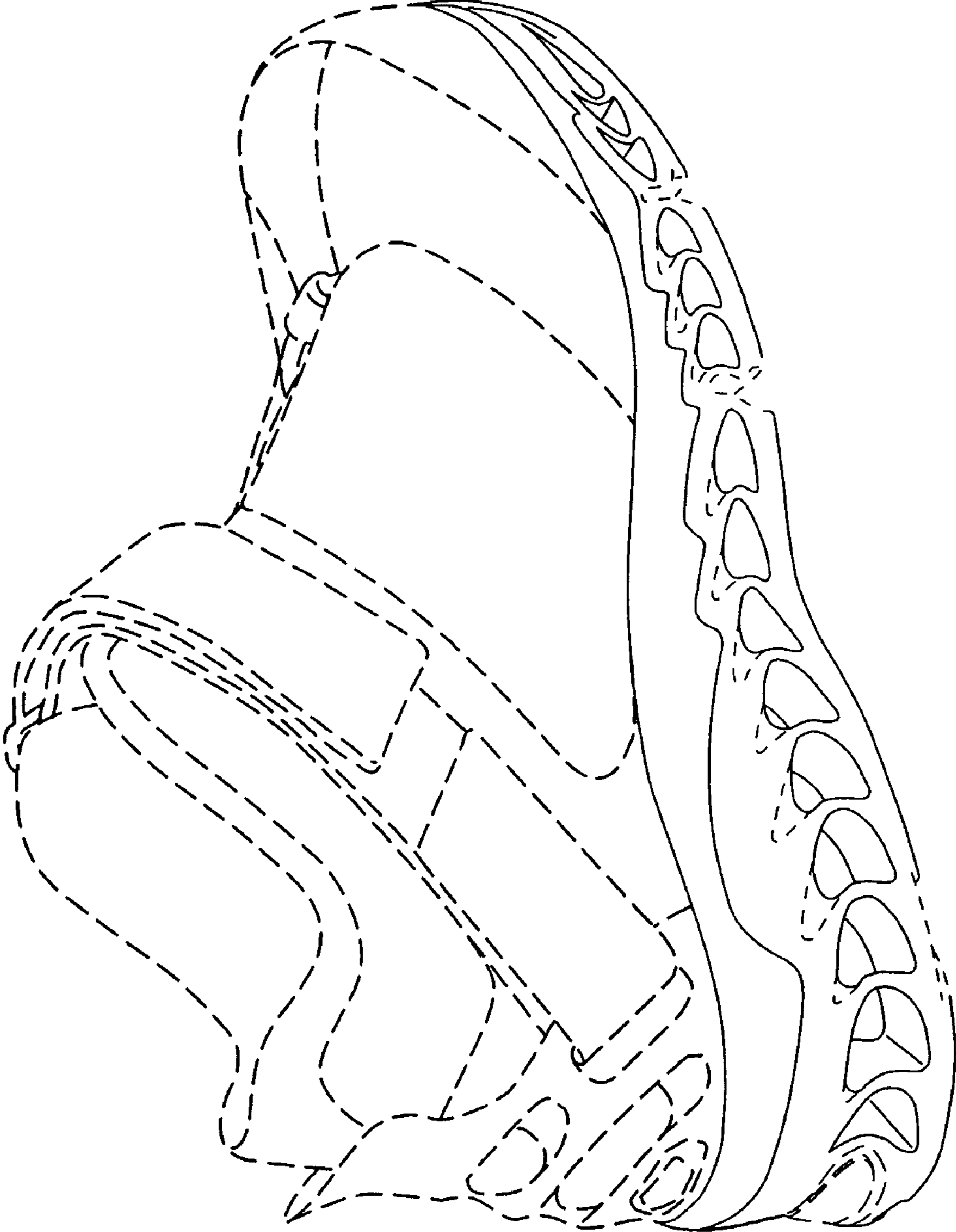

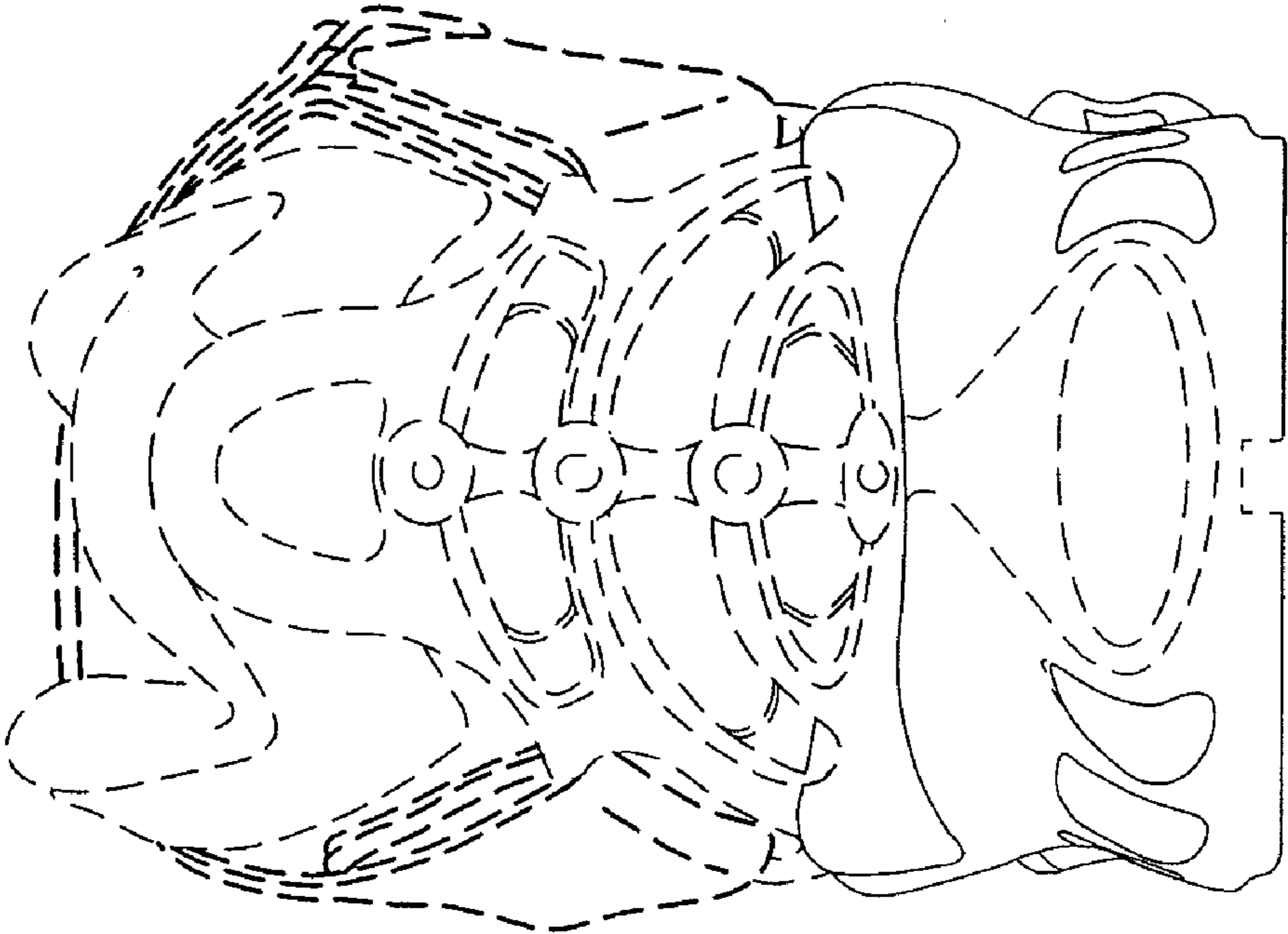

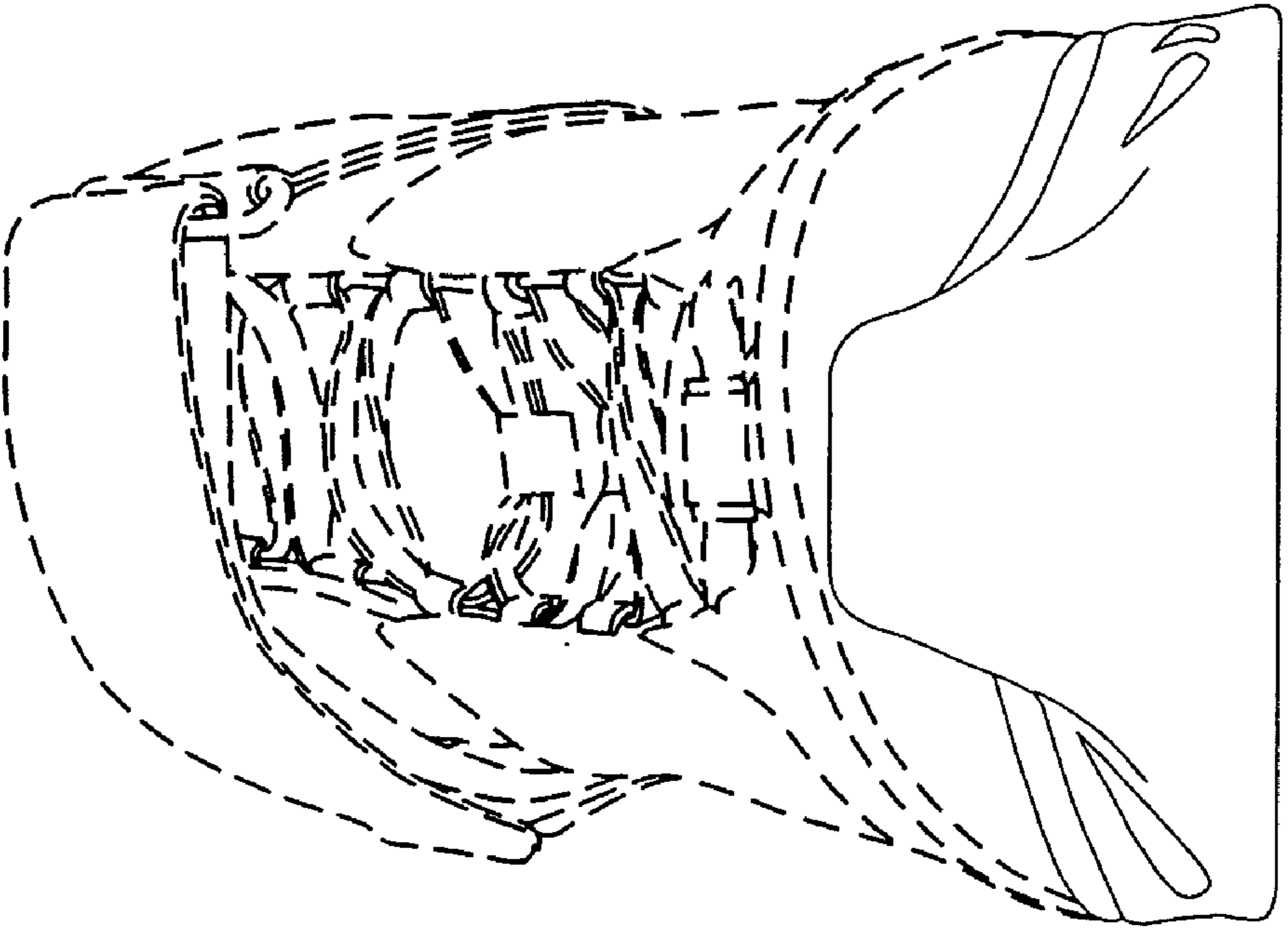
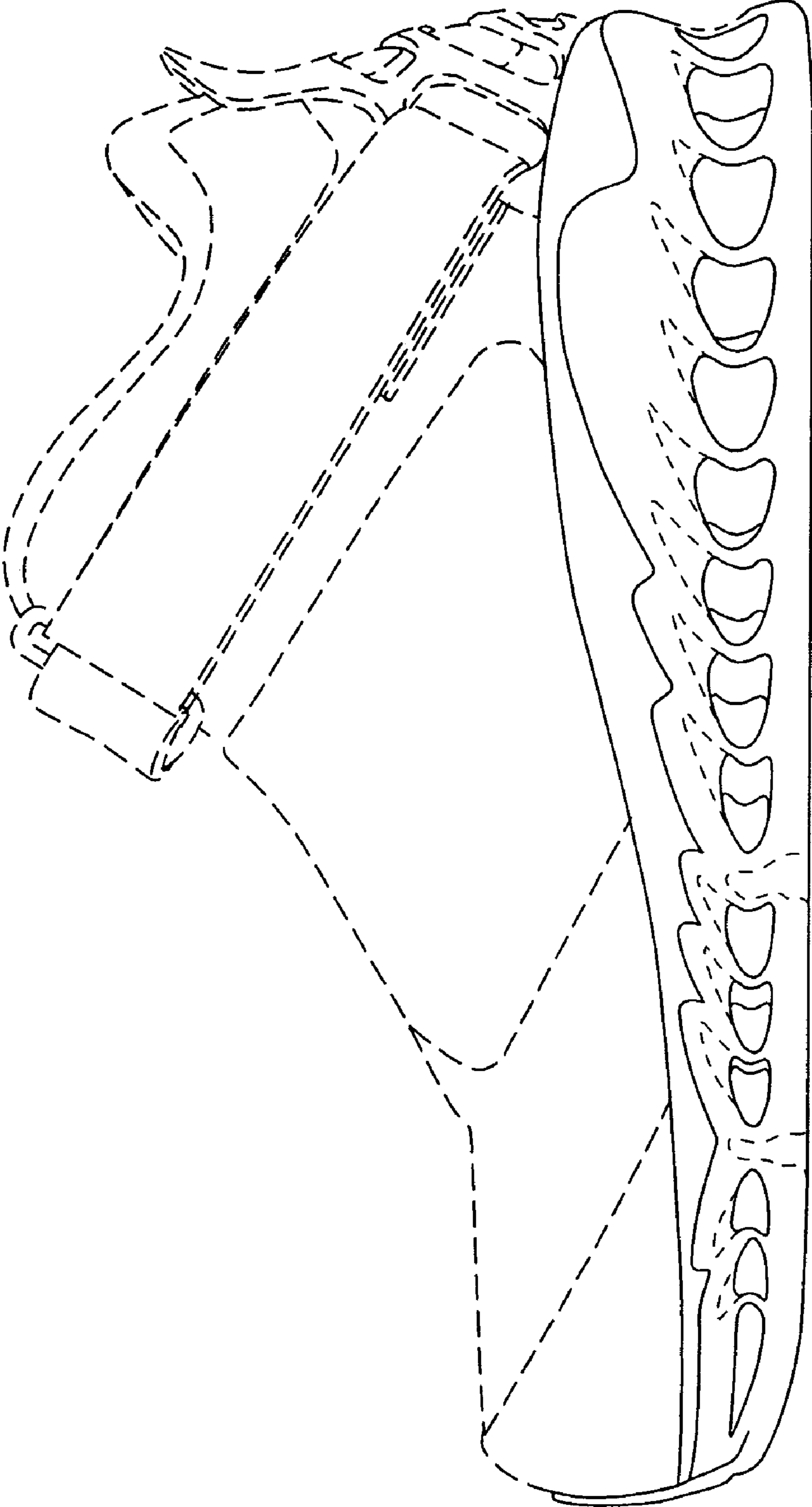

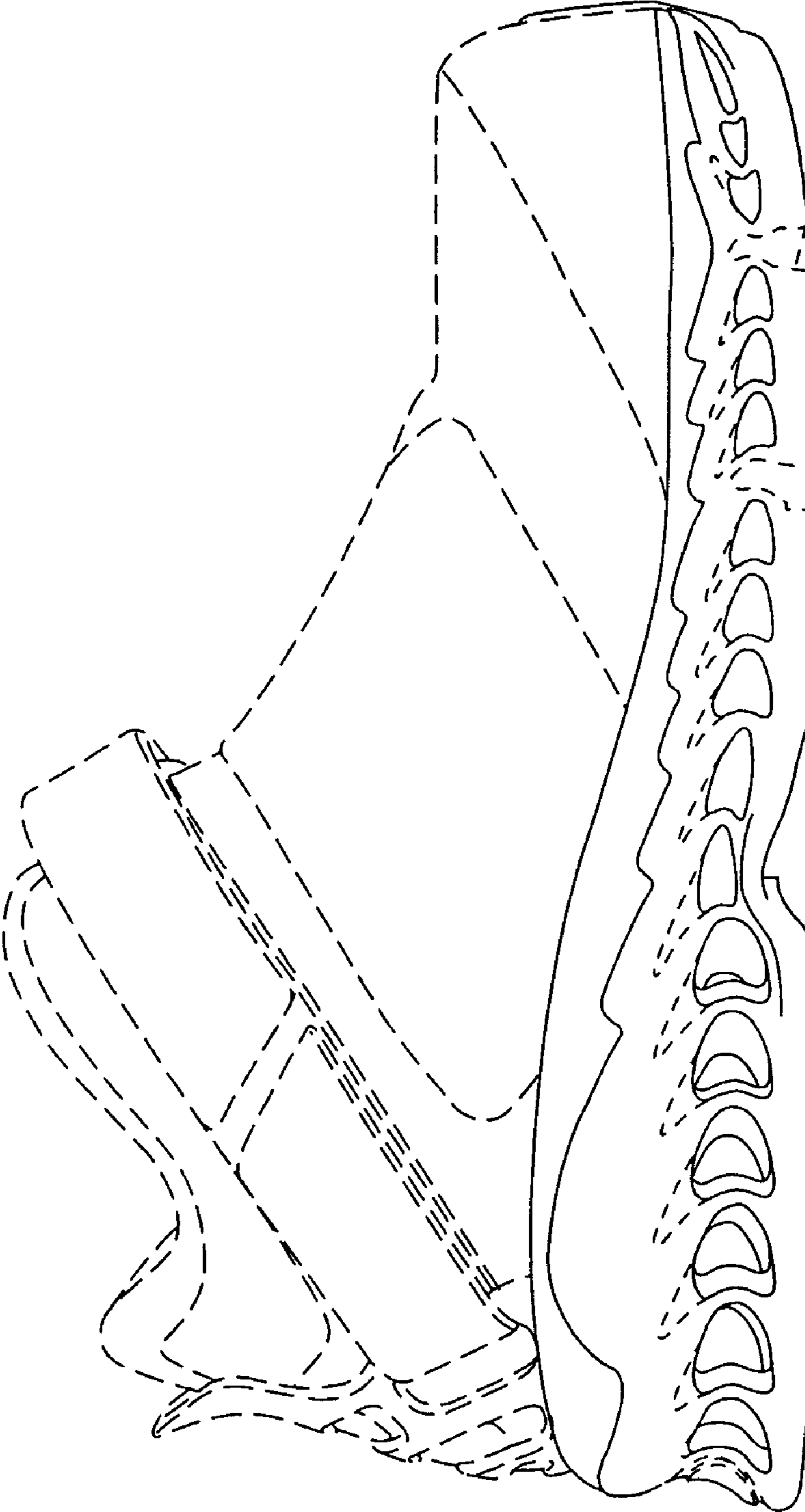

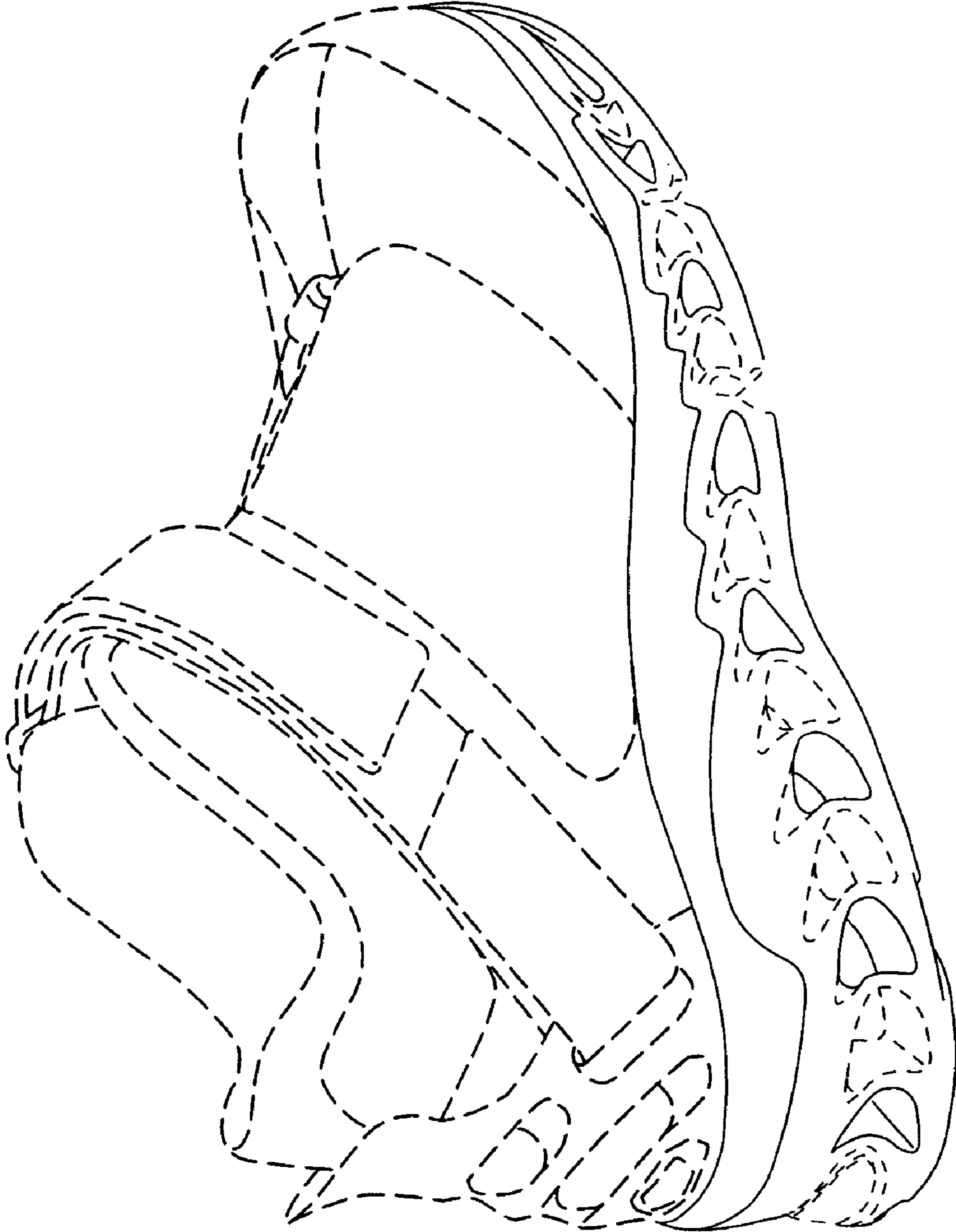

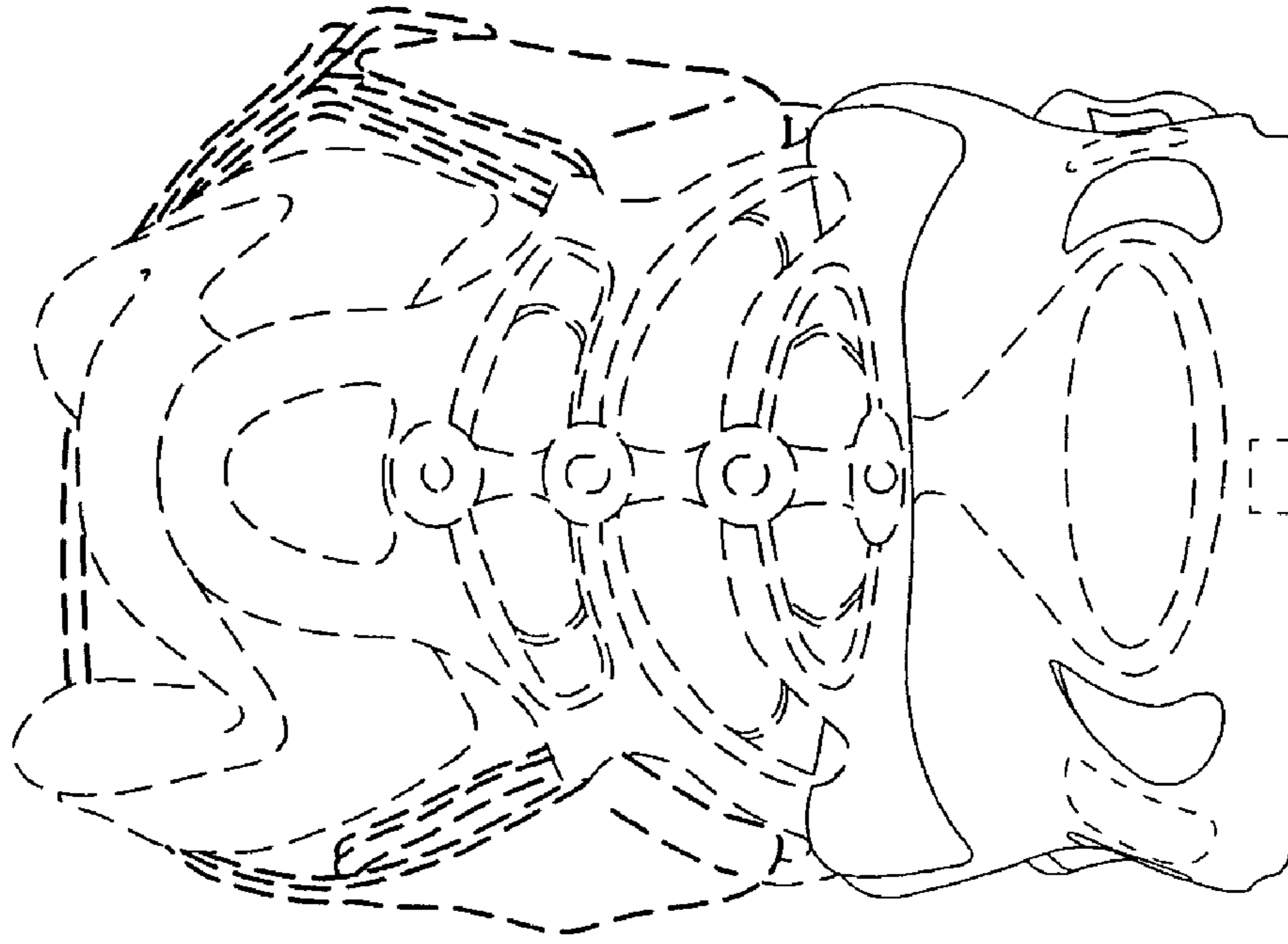
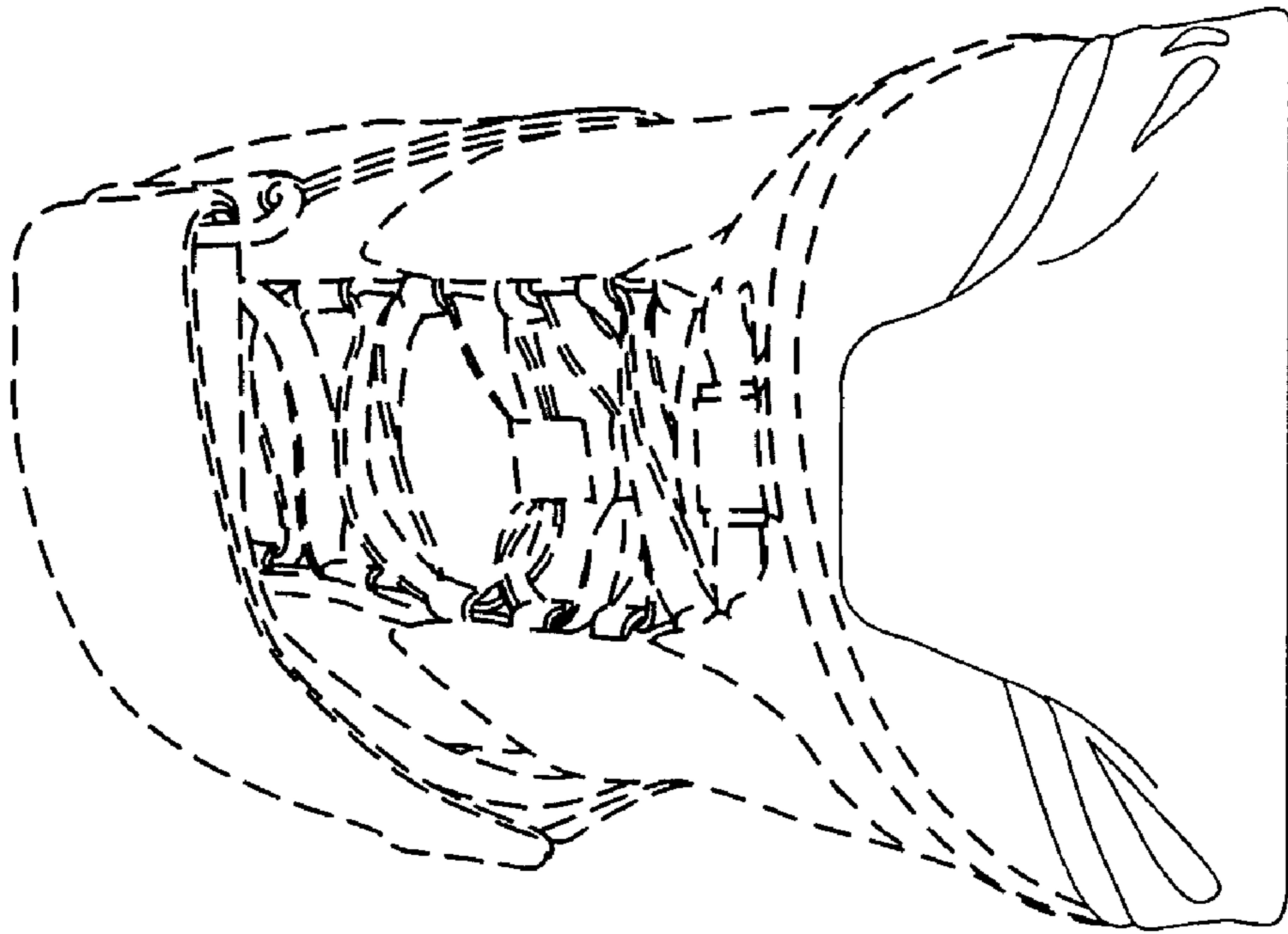

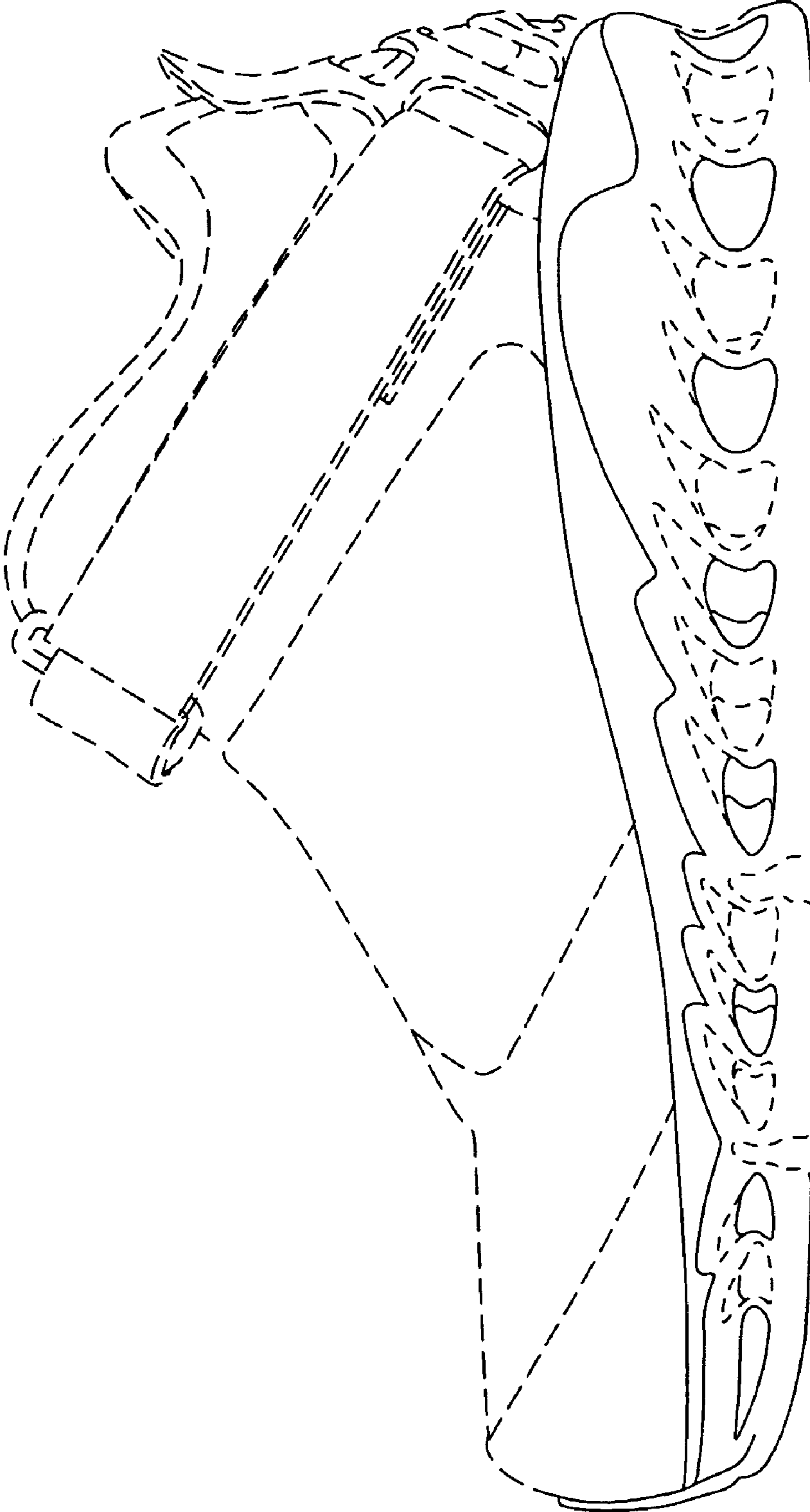
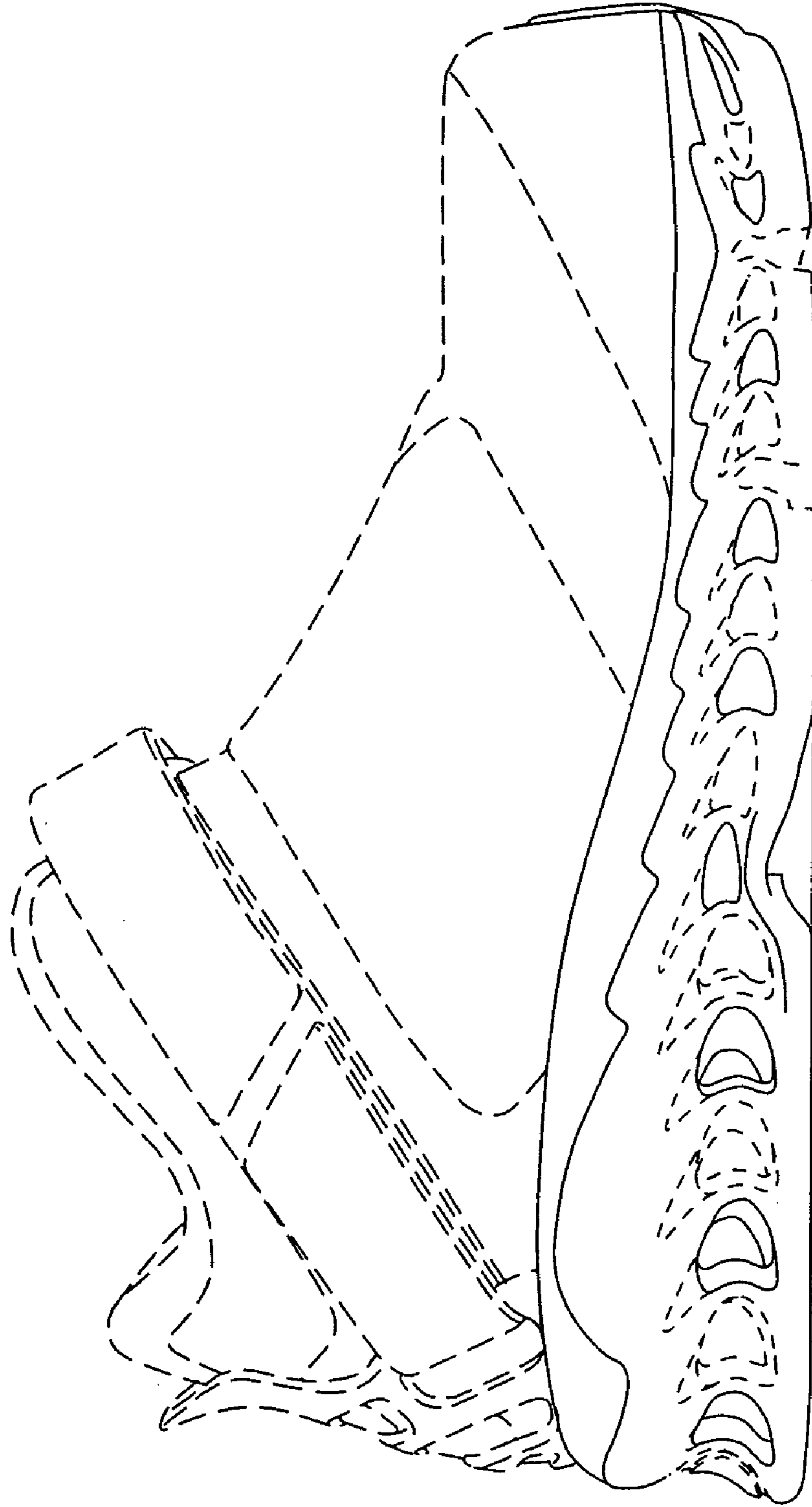

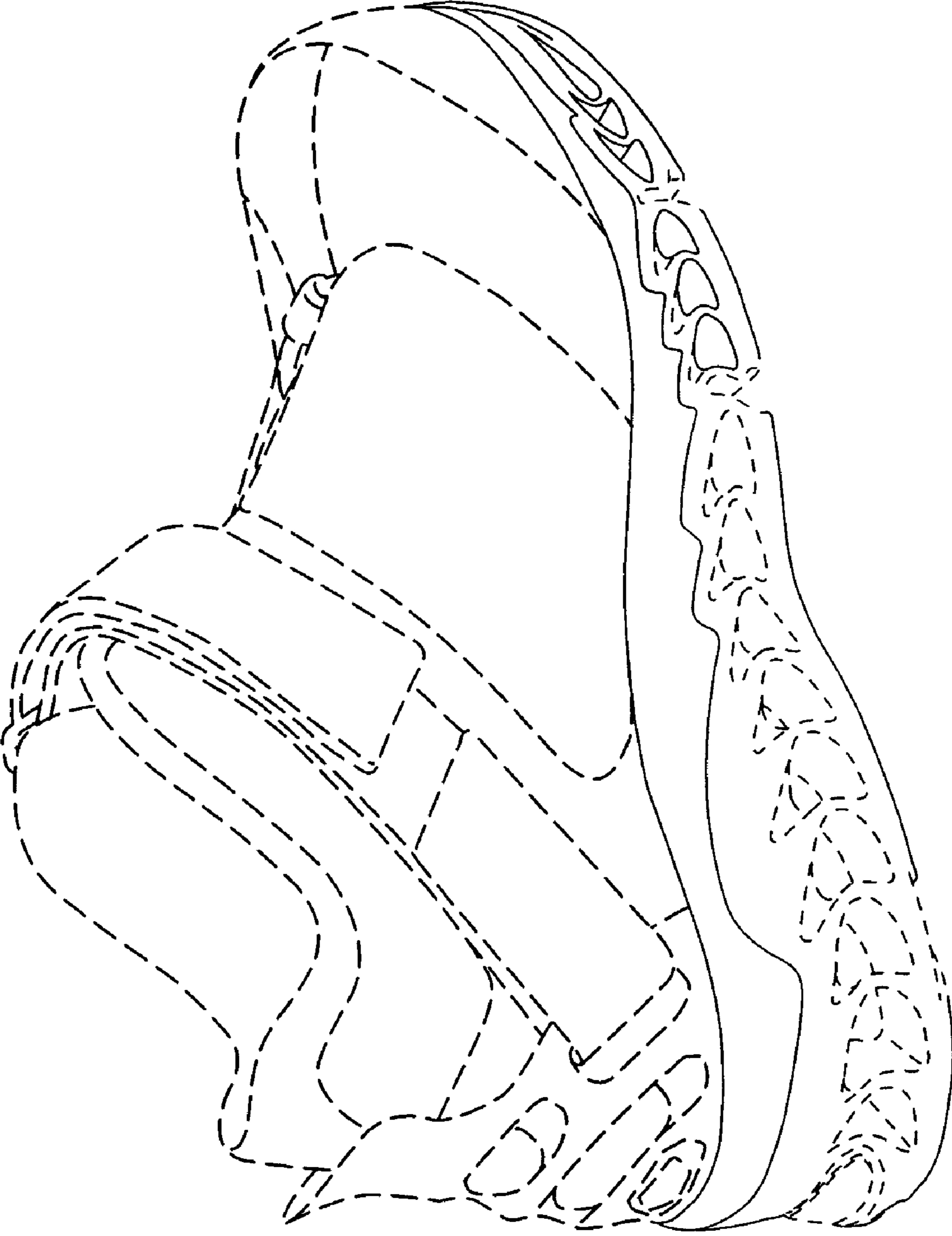

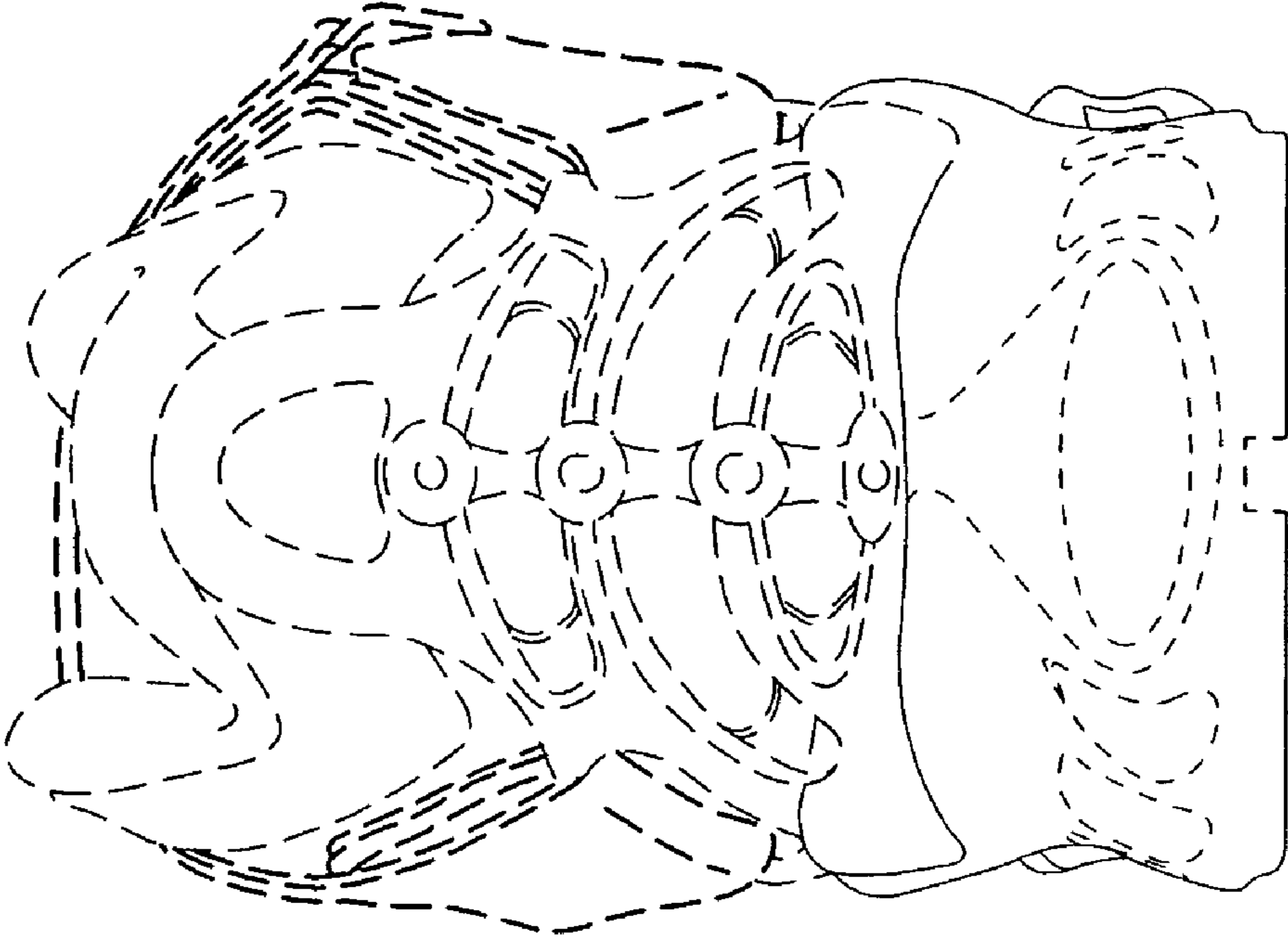

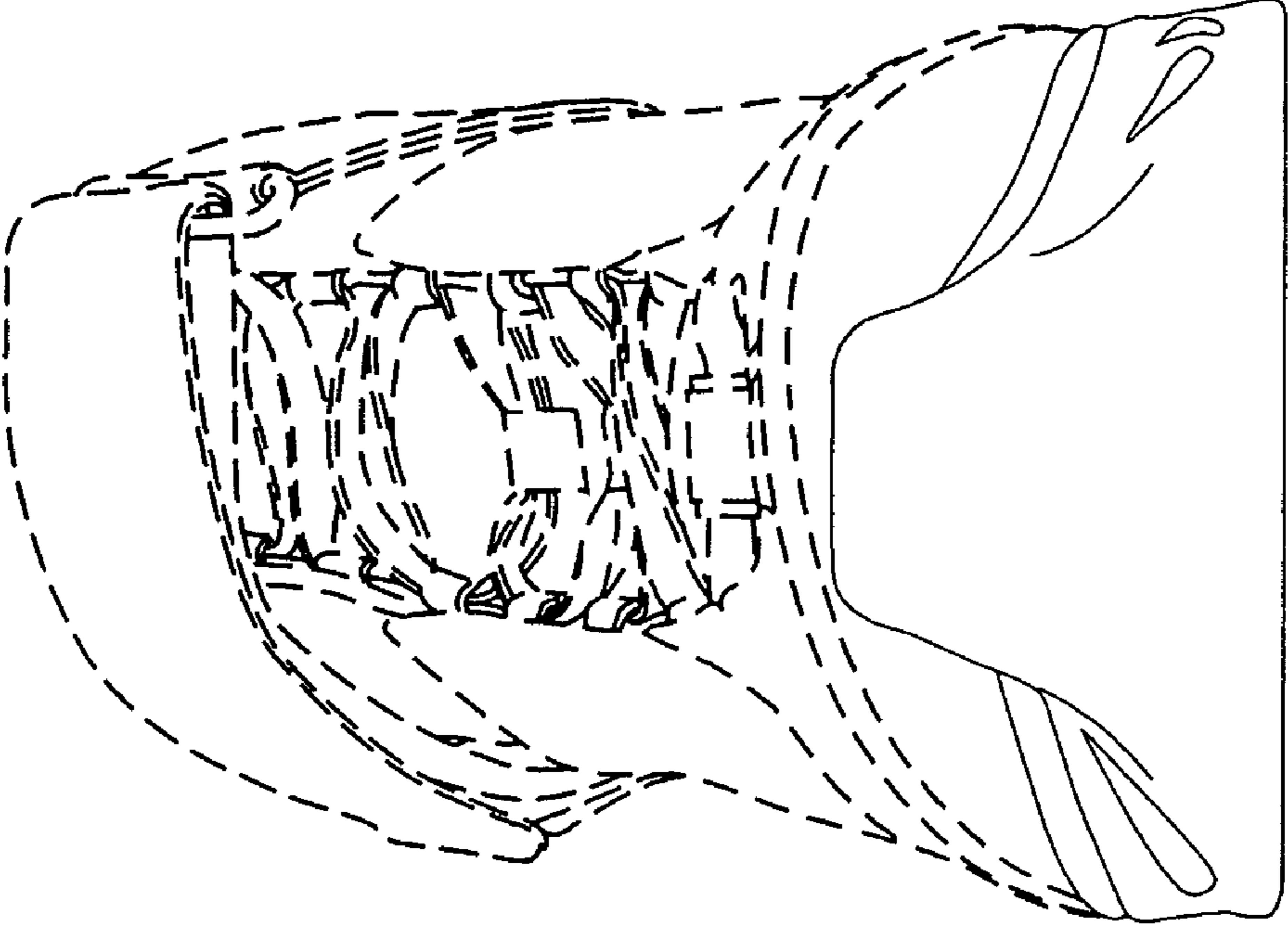
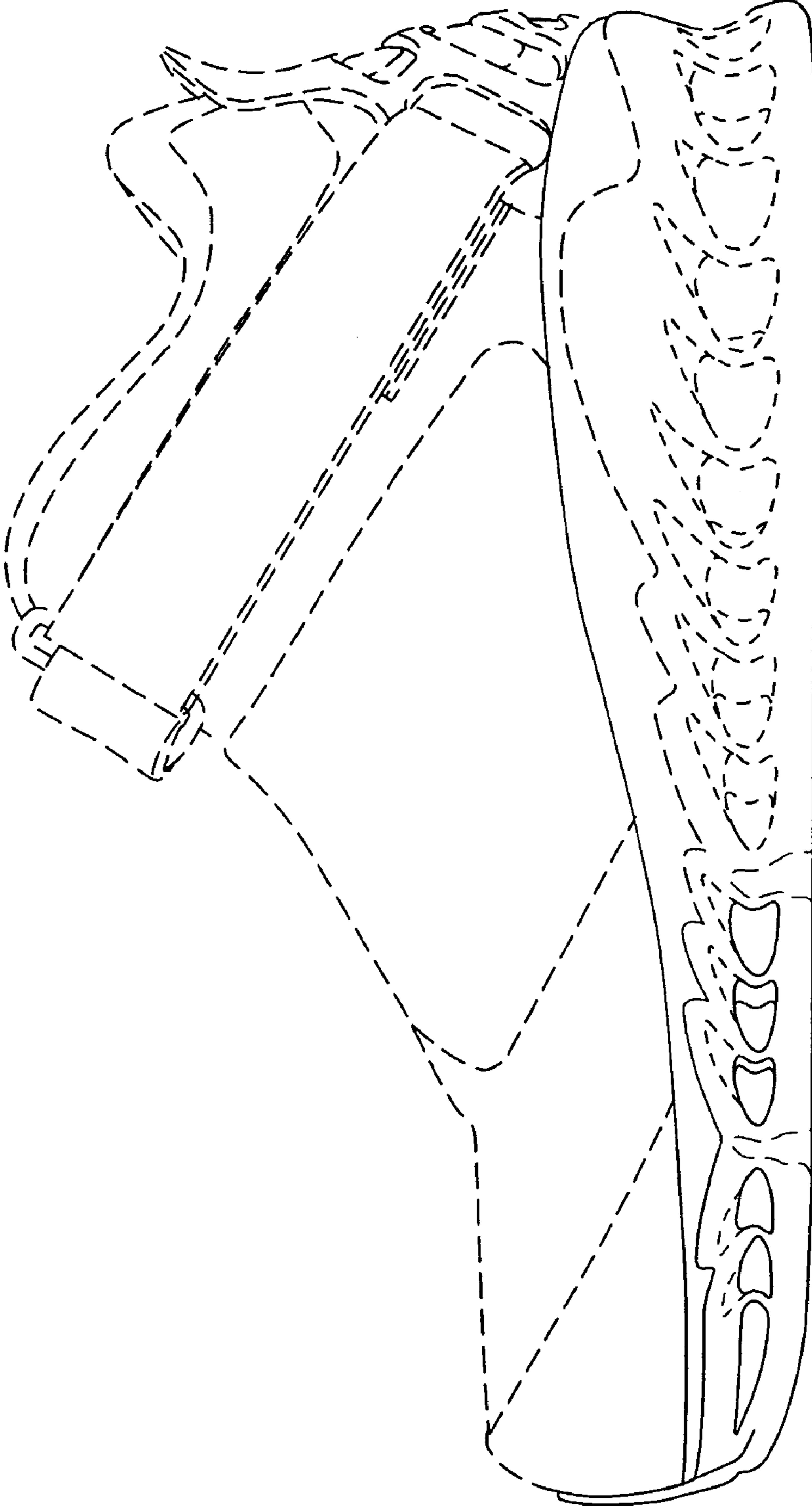

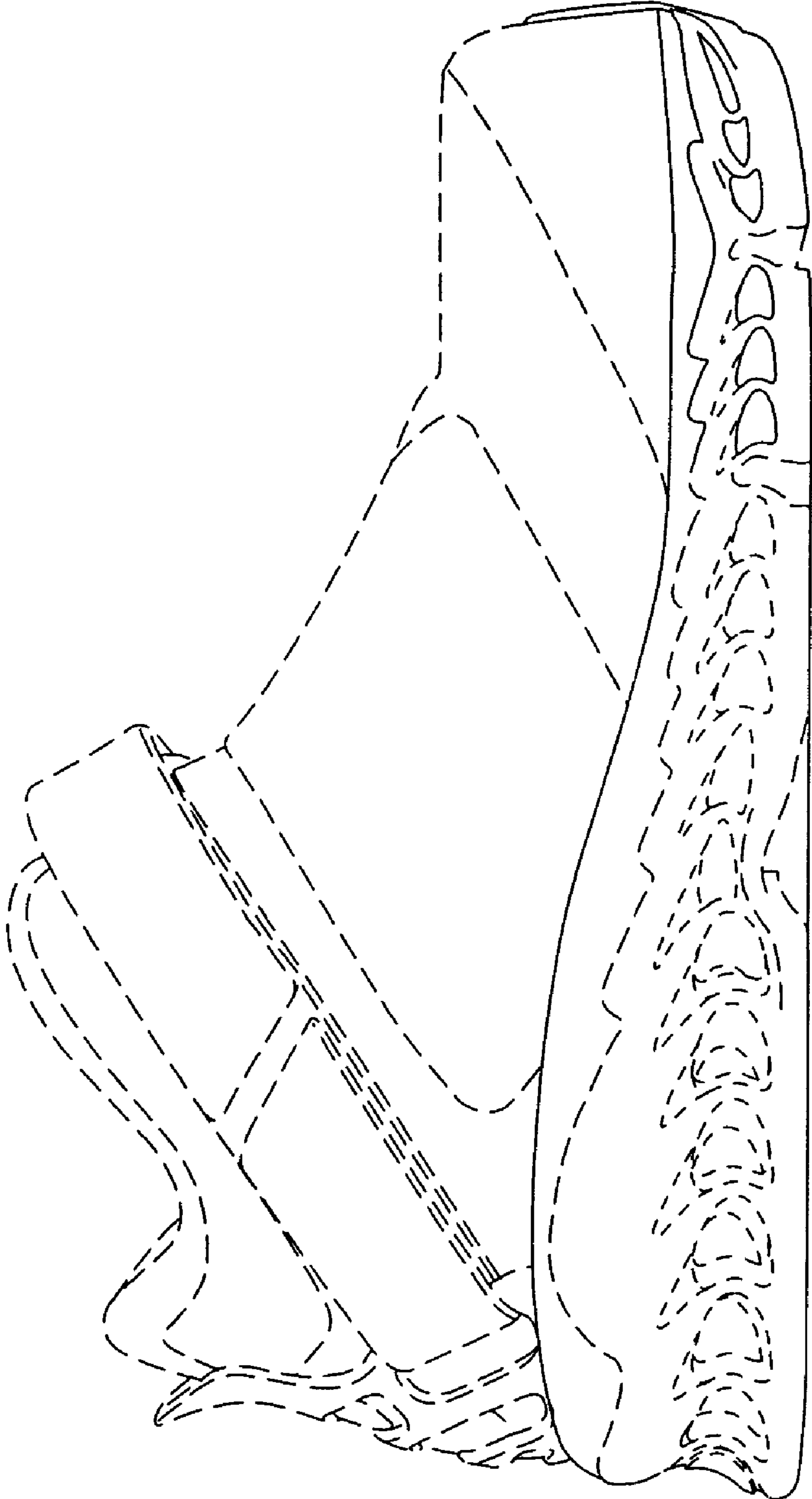

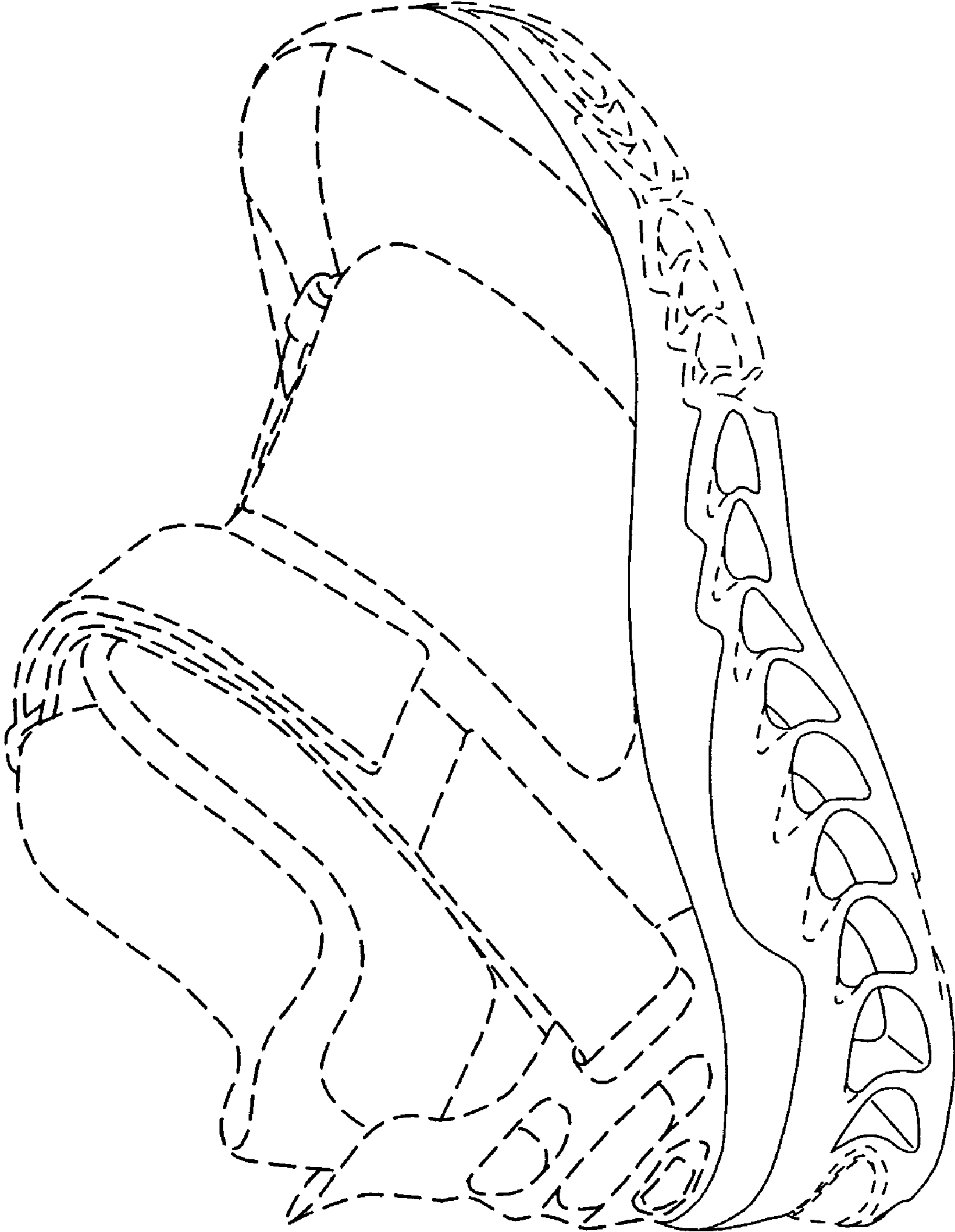

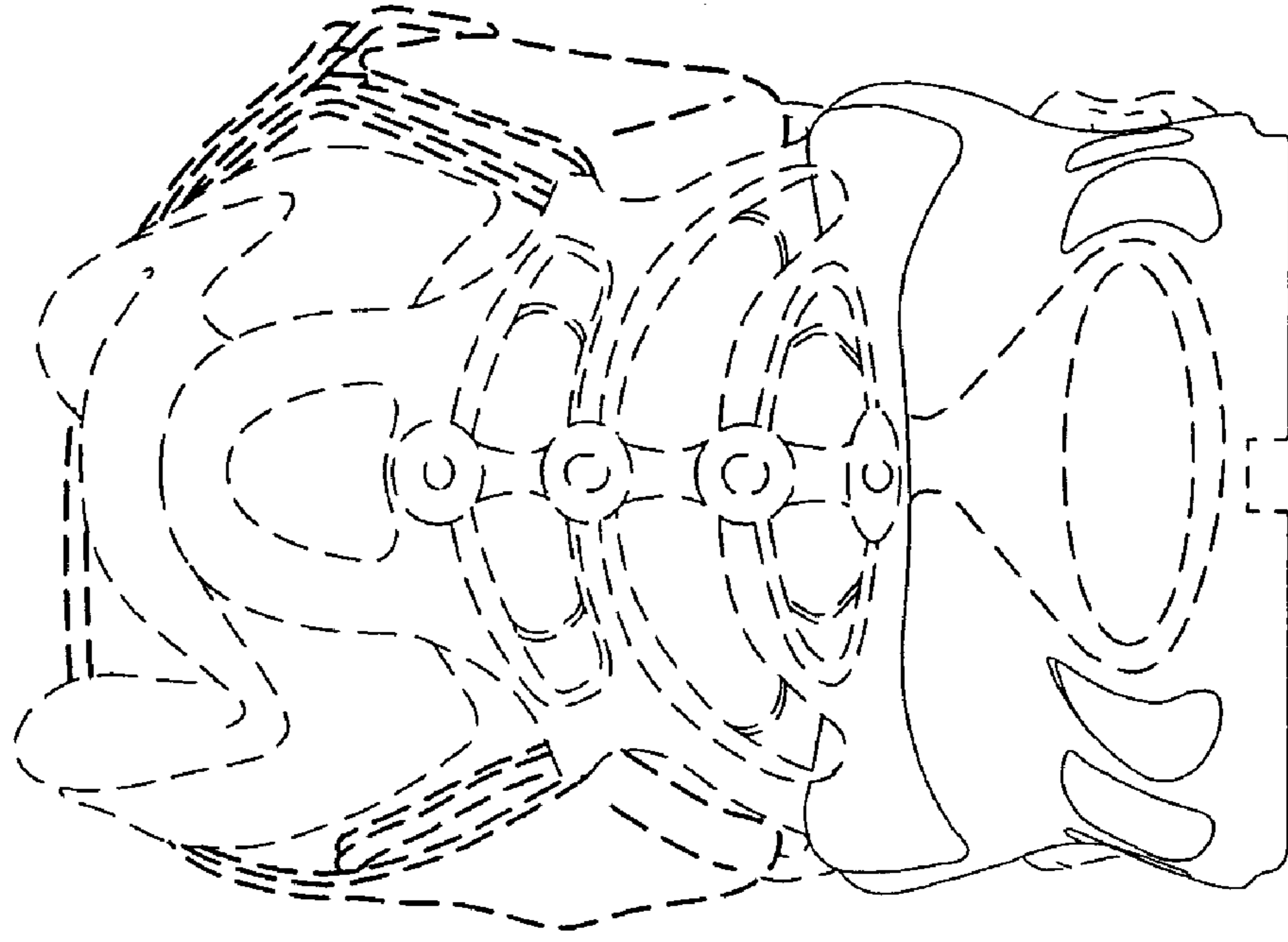

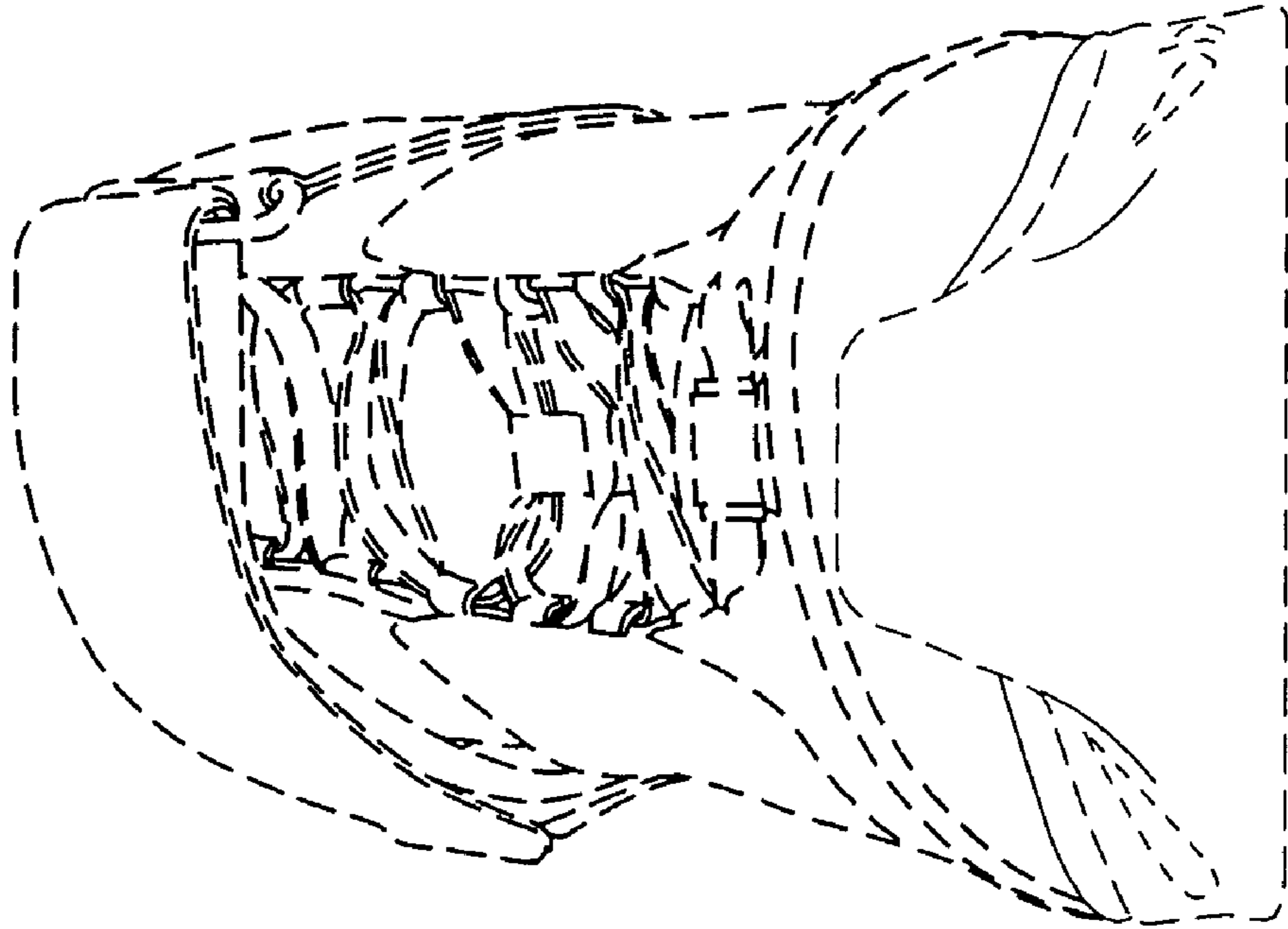
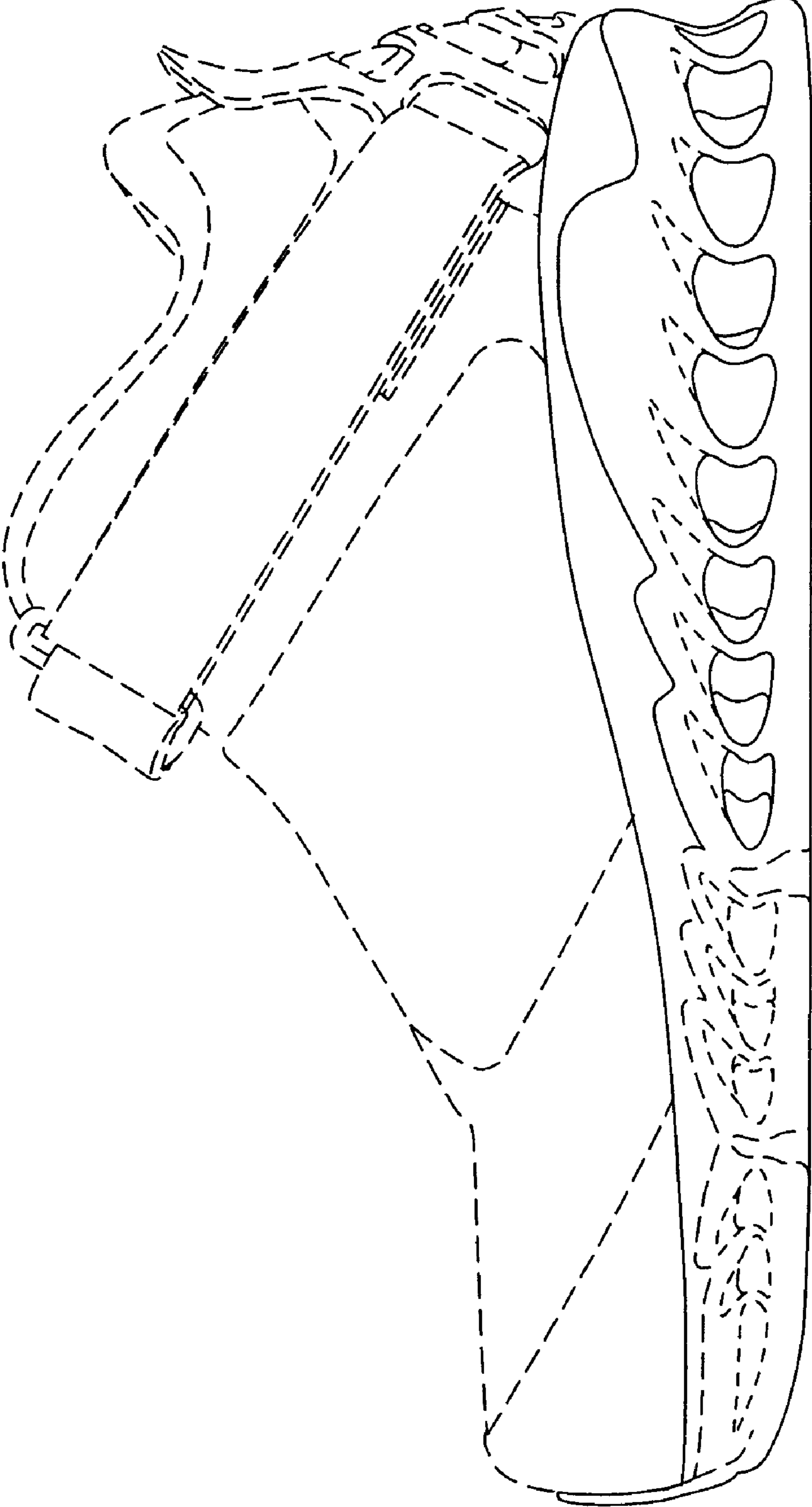

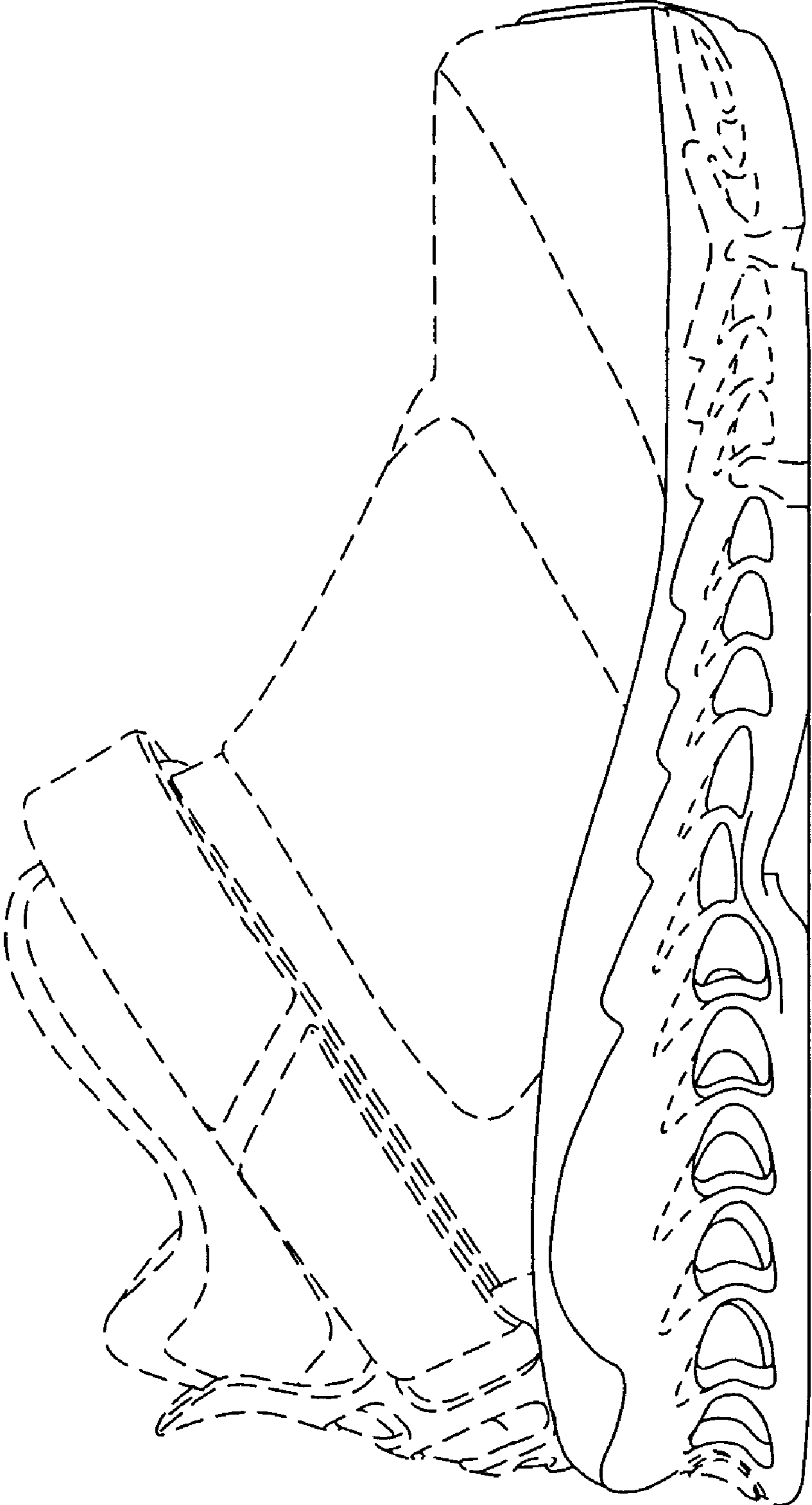

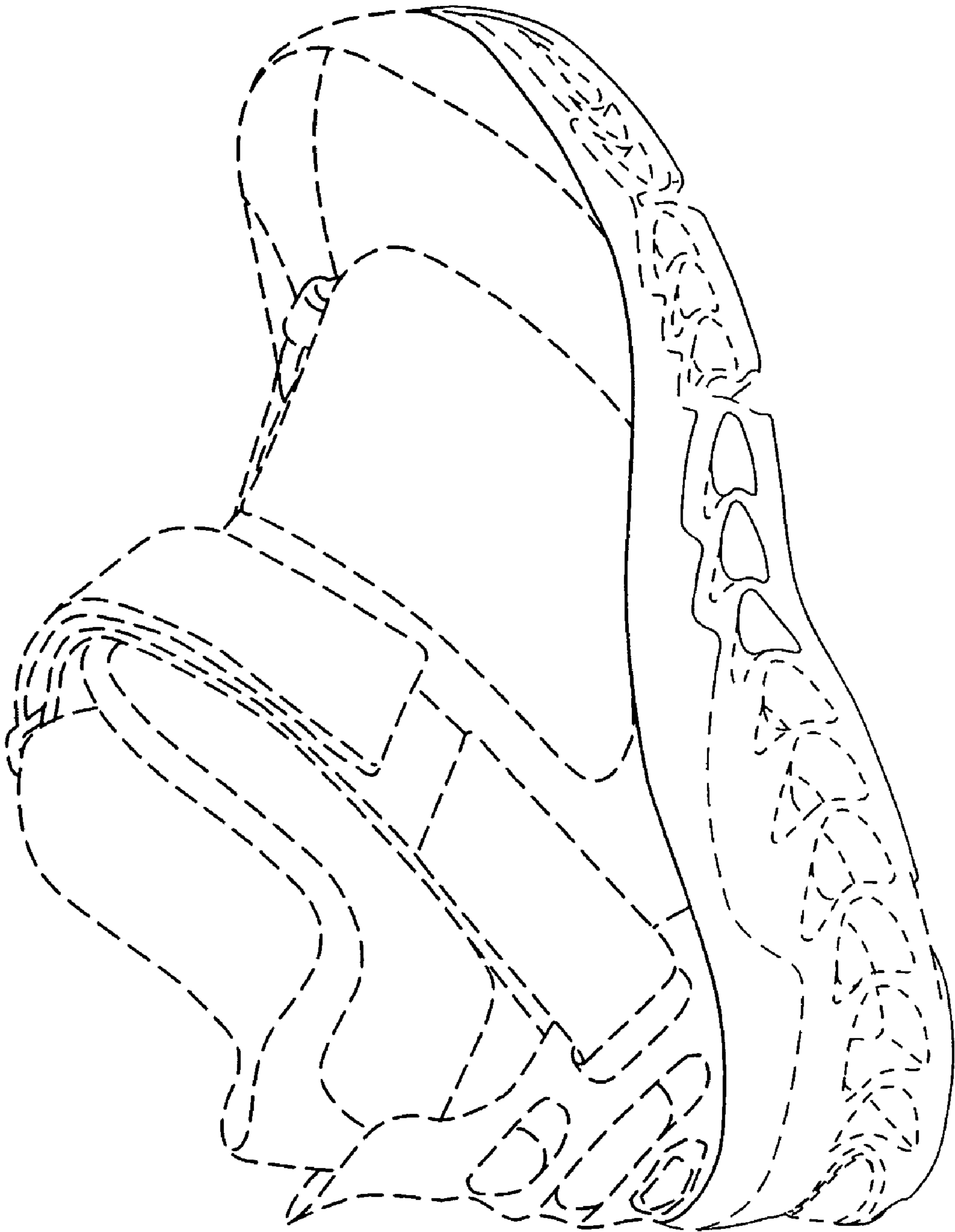

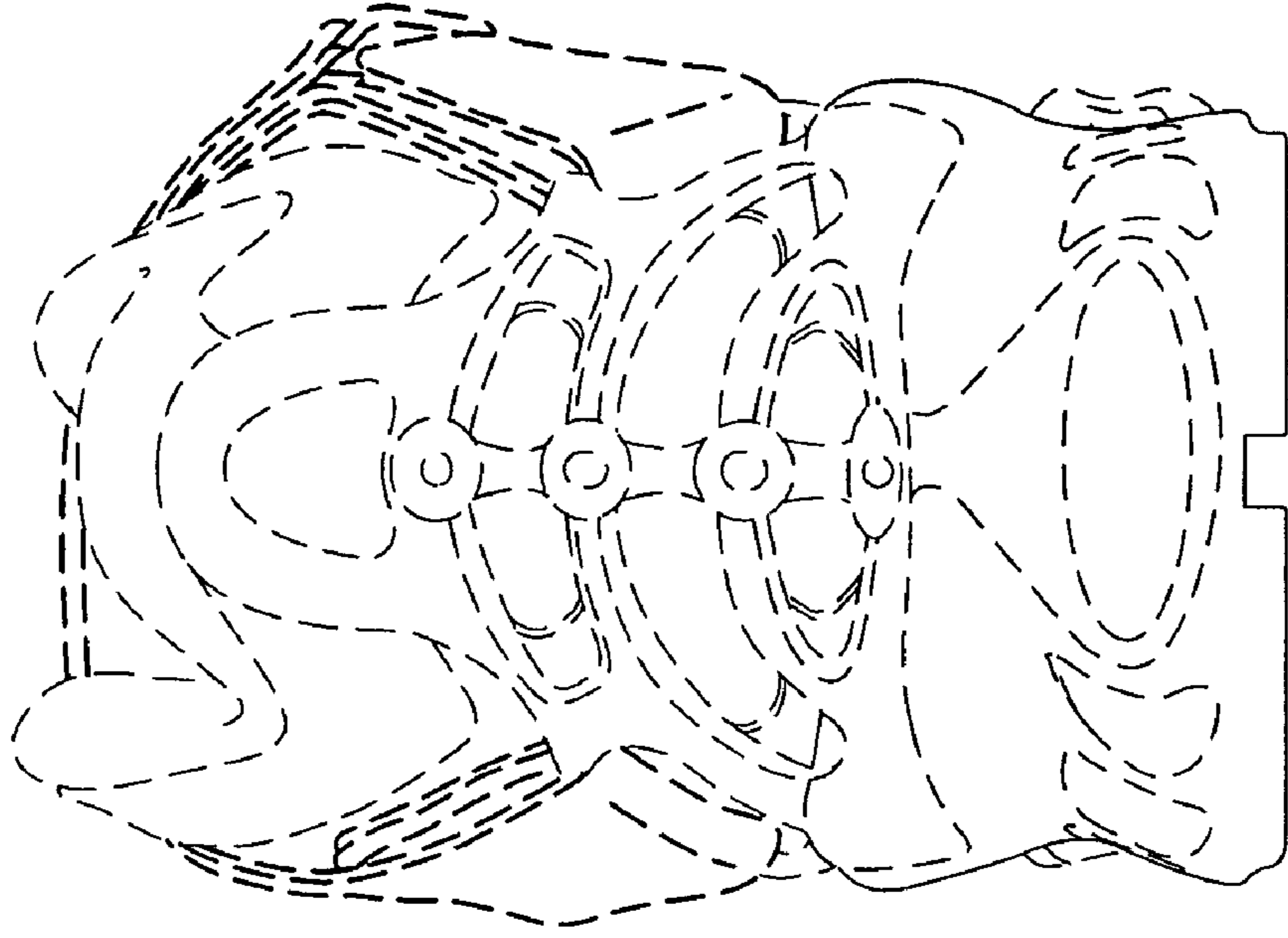

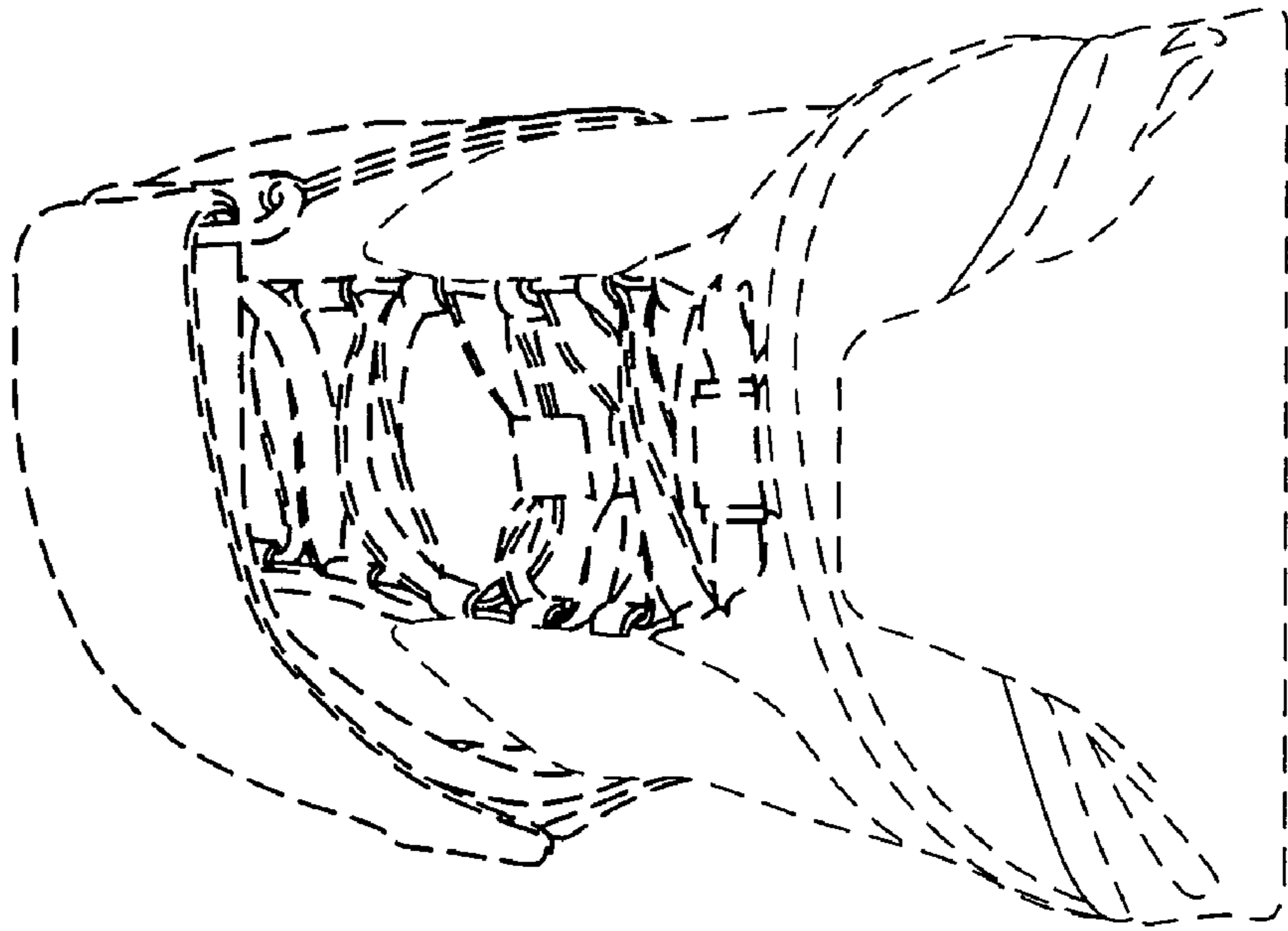

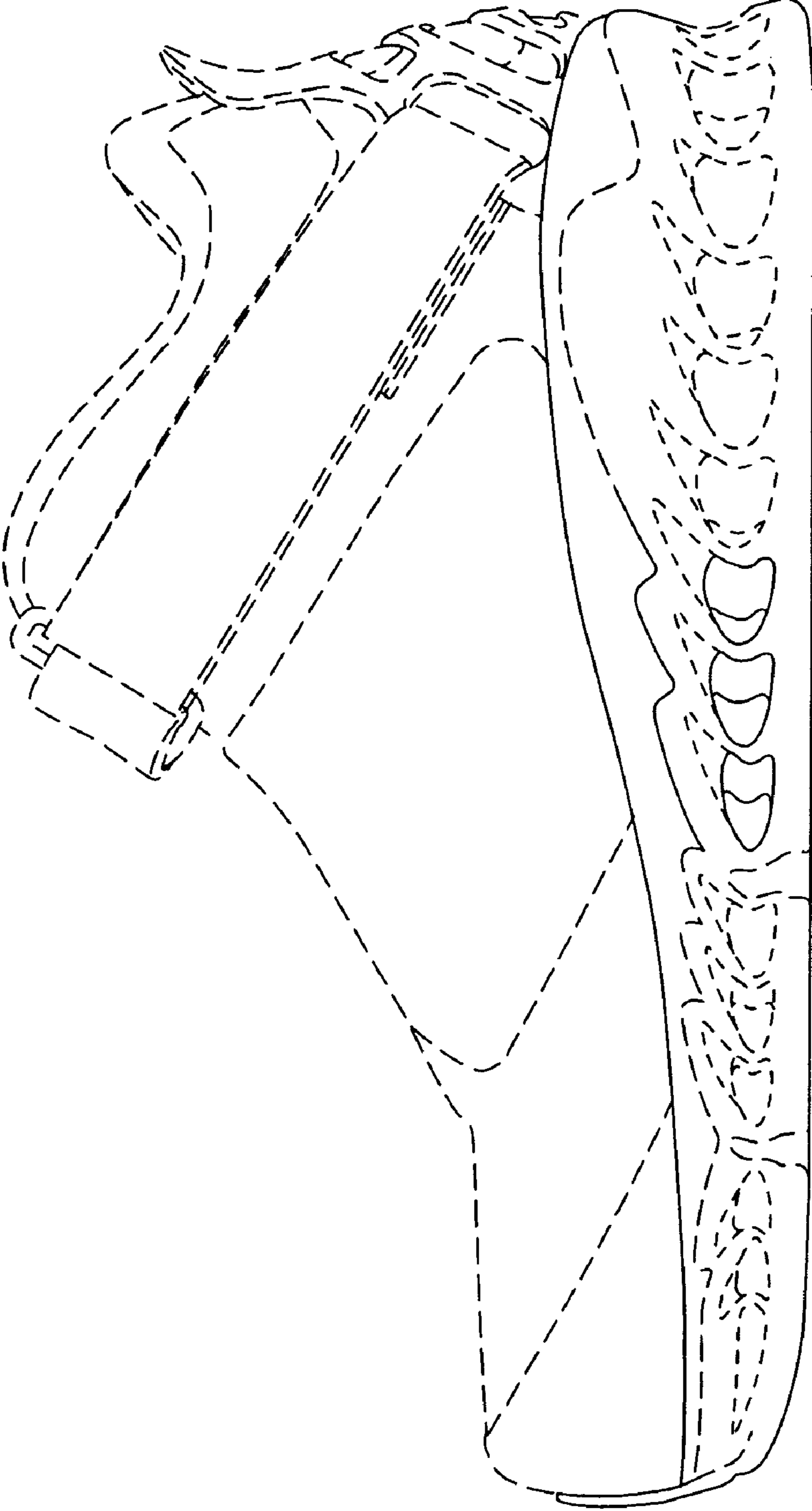
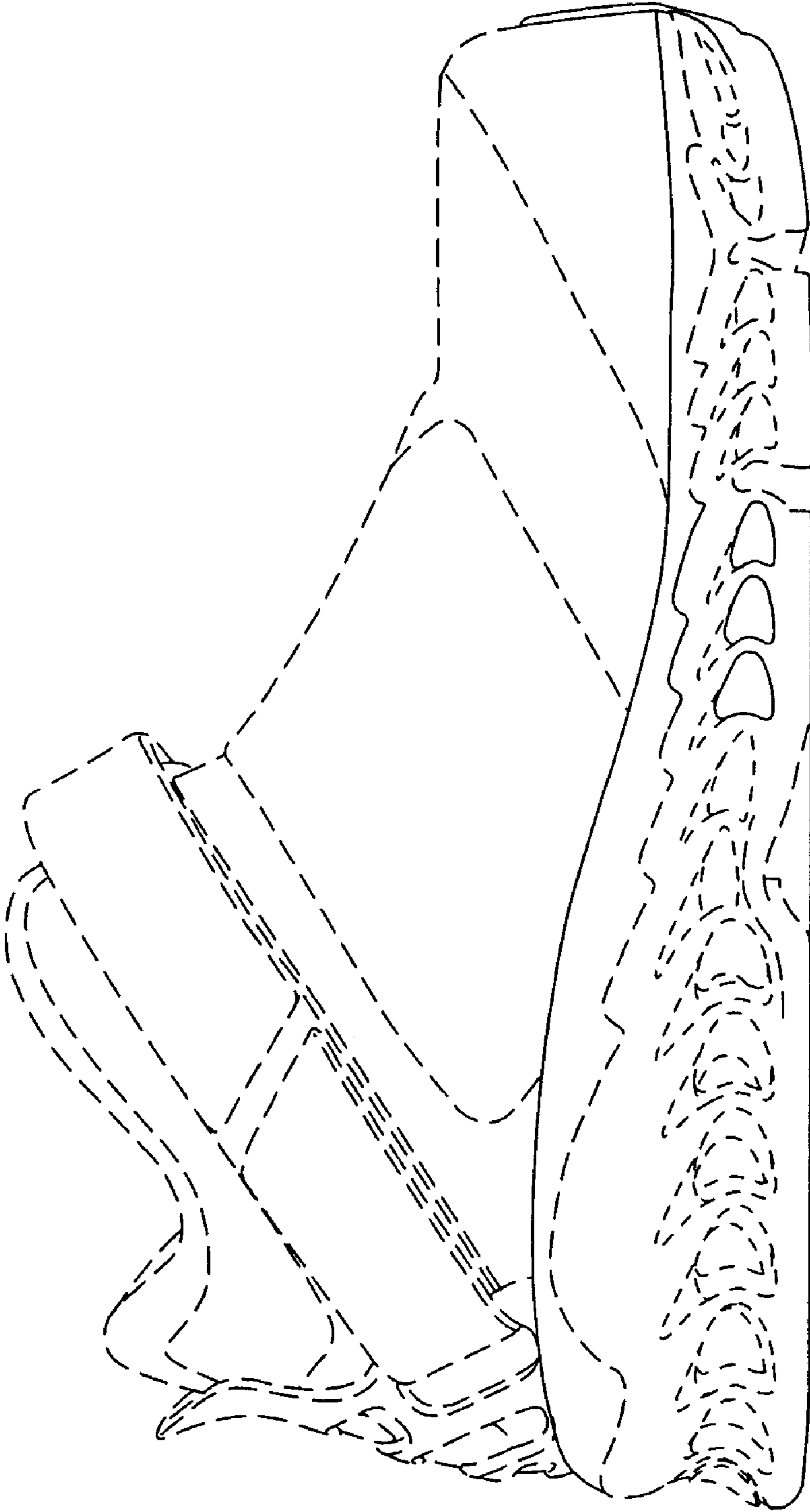

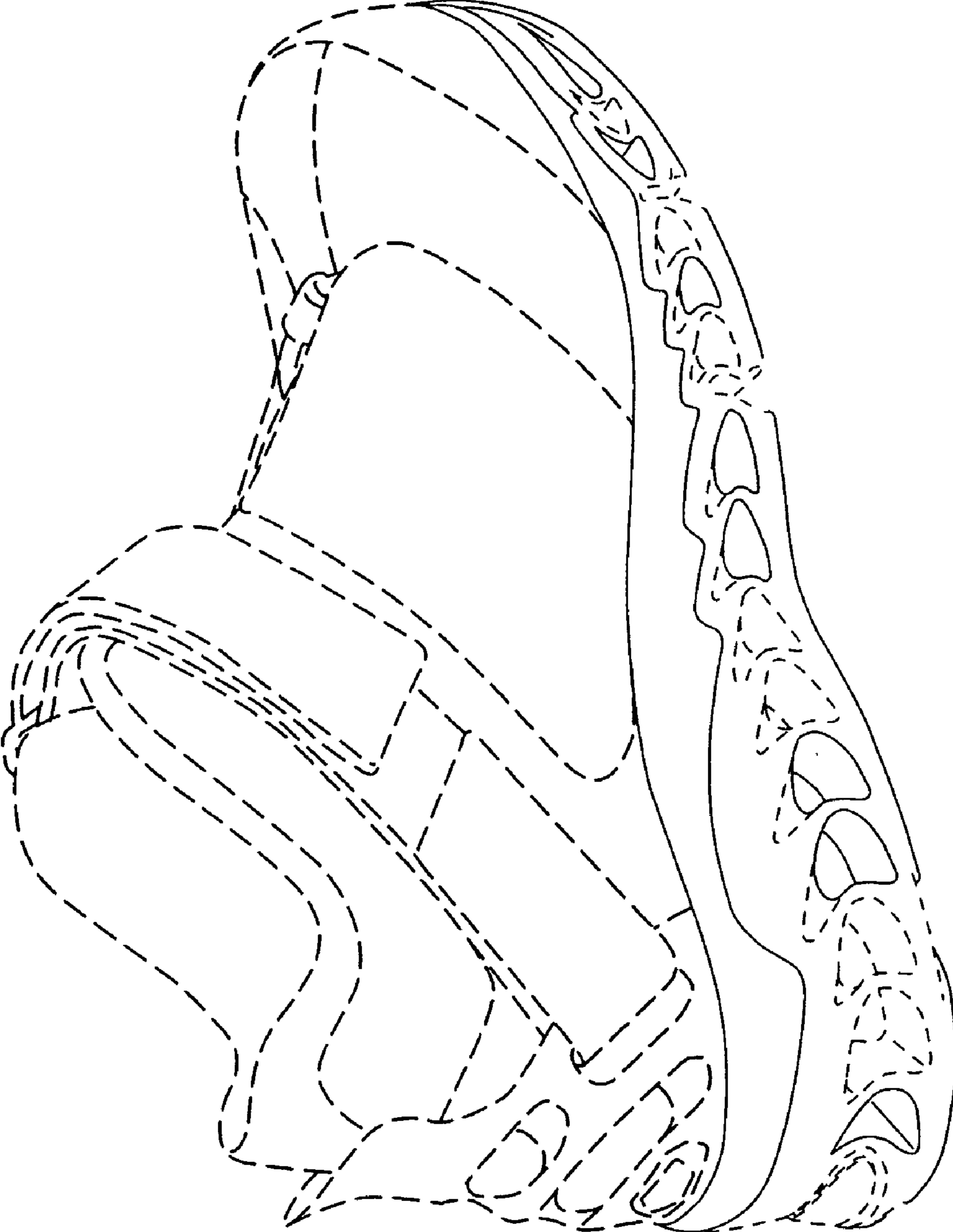

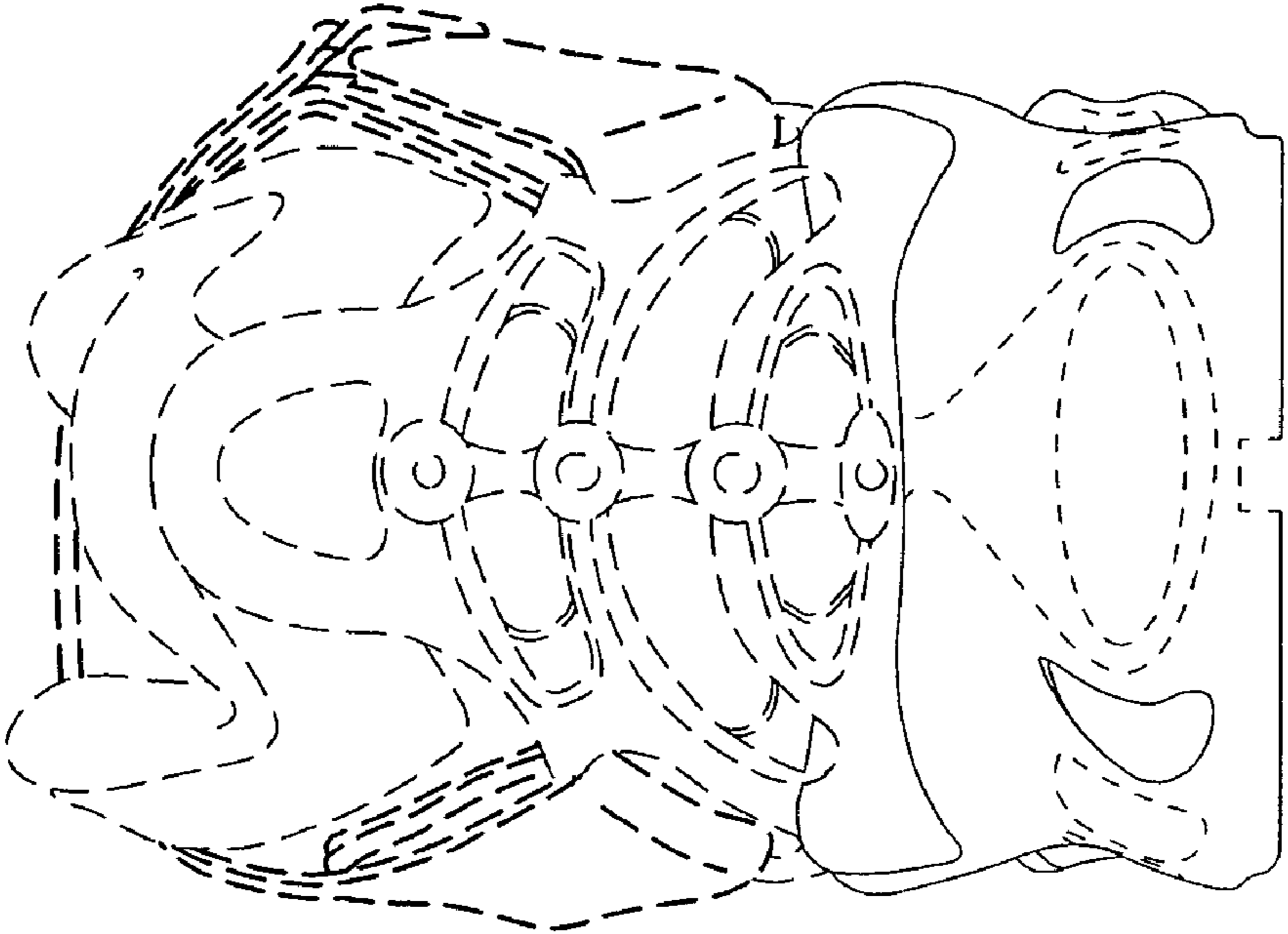

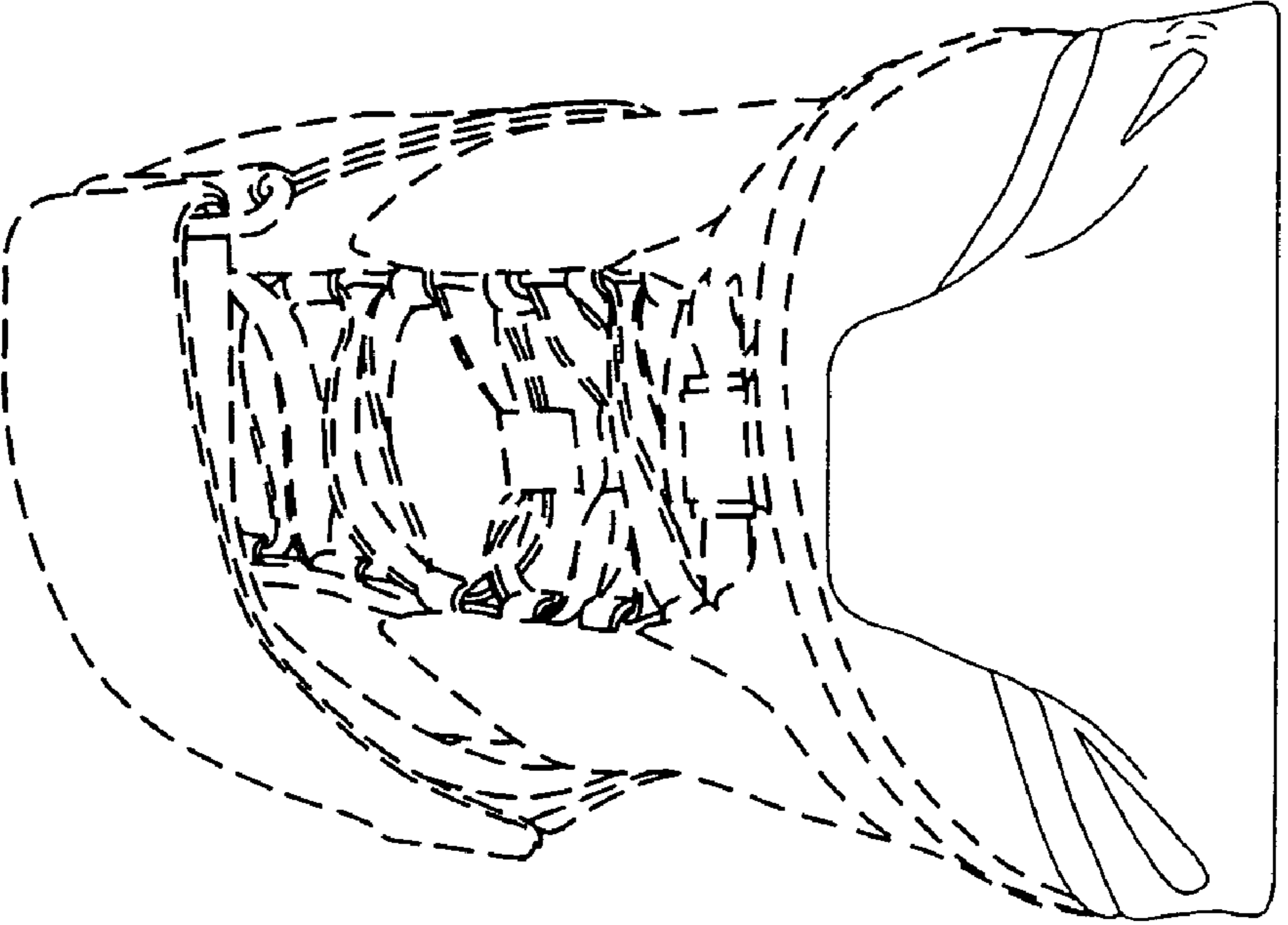

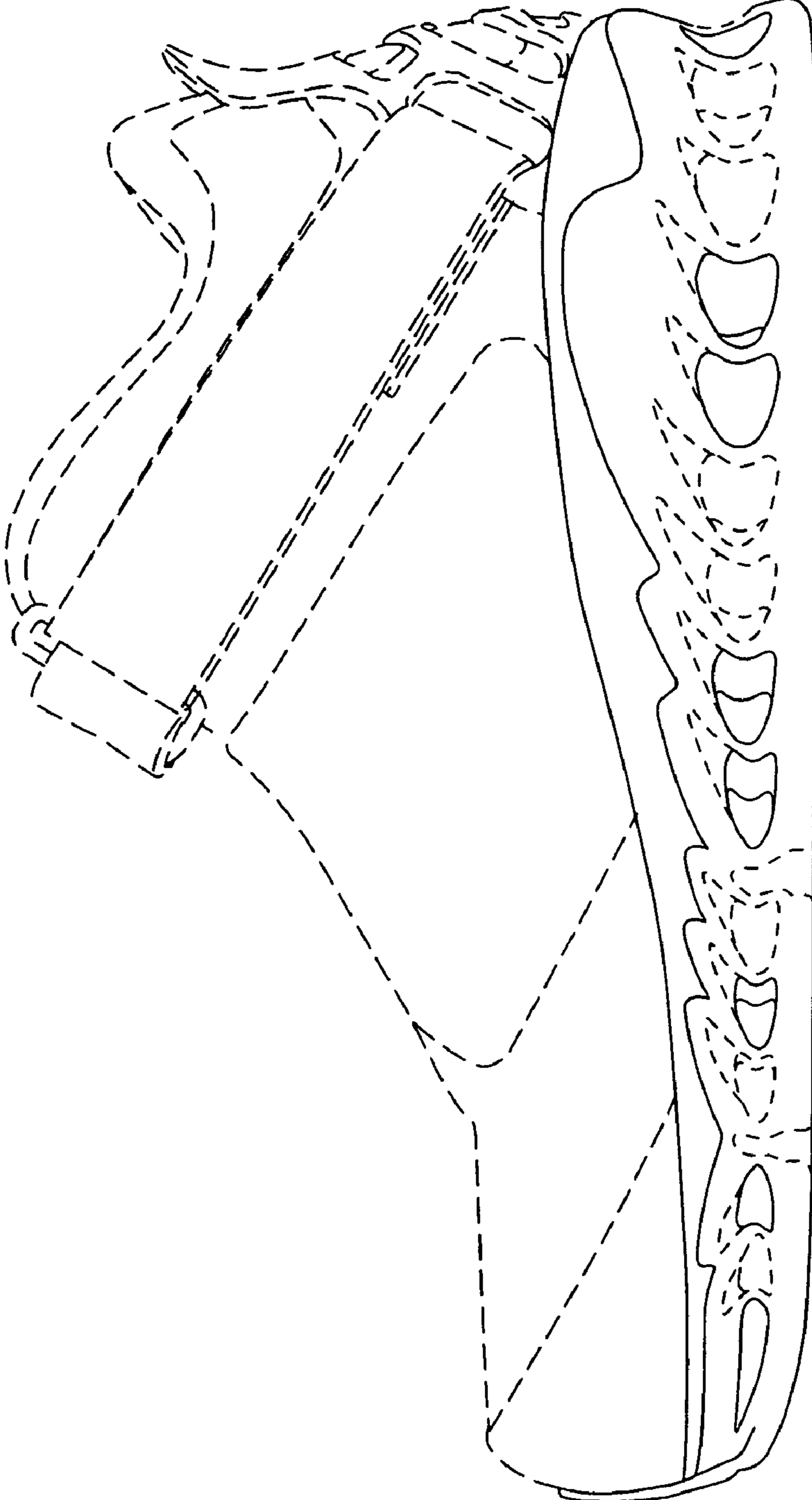
