FIG. 4 is a top plan view of the design illustrated in FIG. 1.

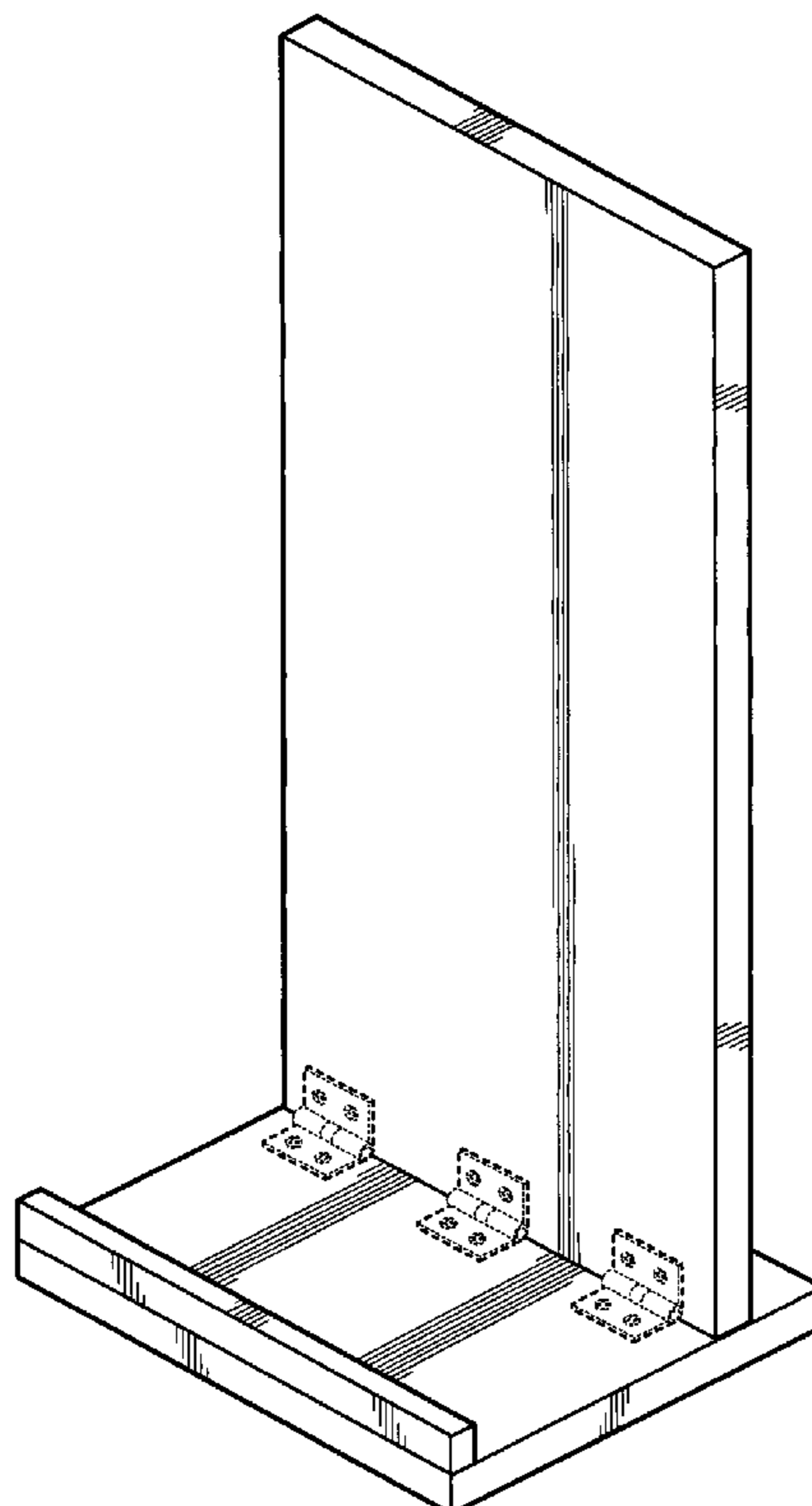
FIG. 5 is a bottom view of the design illustrated in FIG. 1.

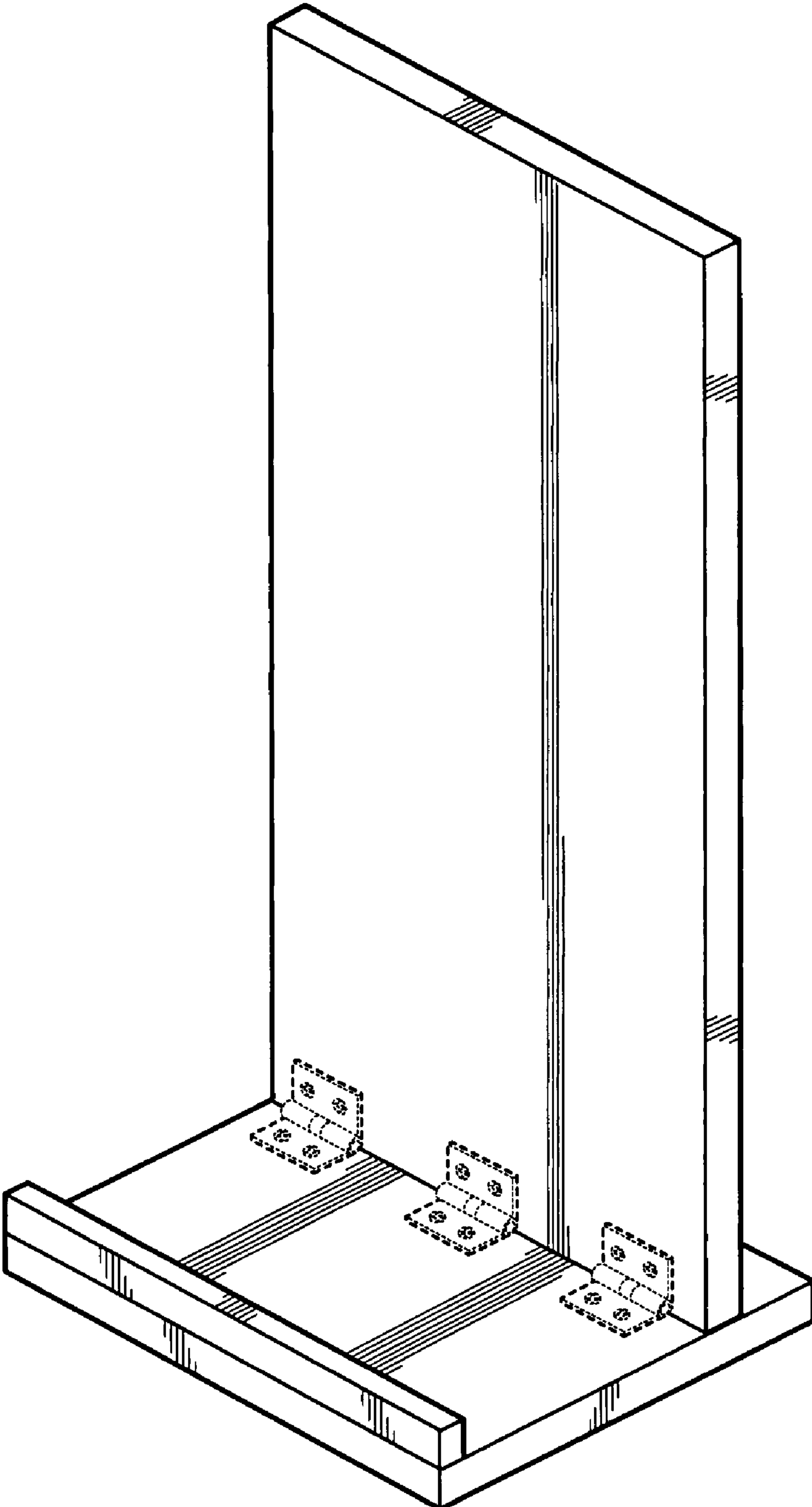

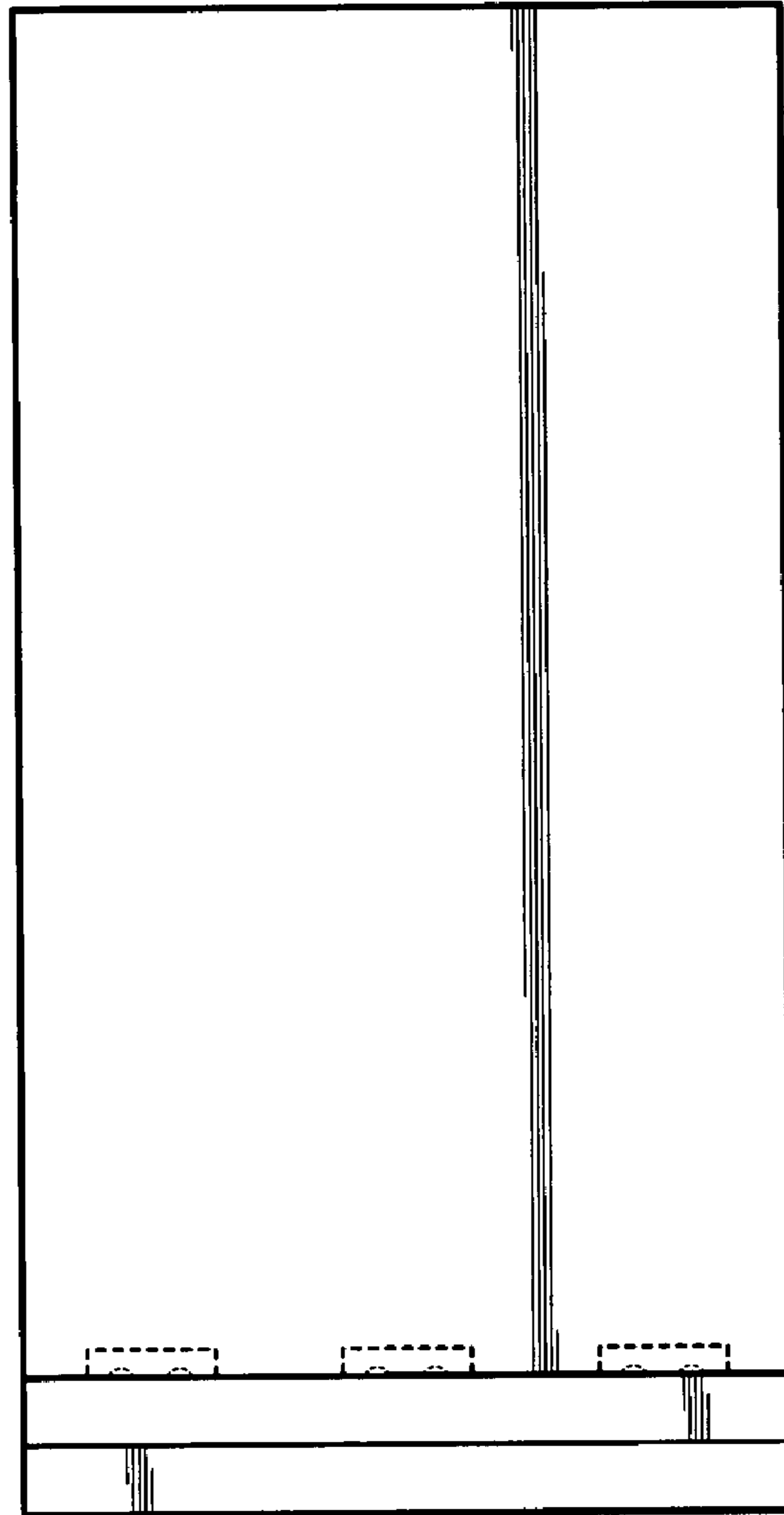

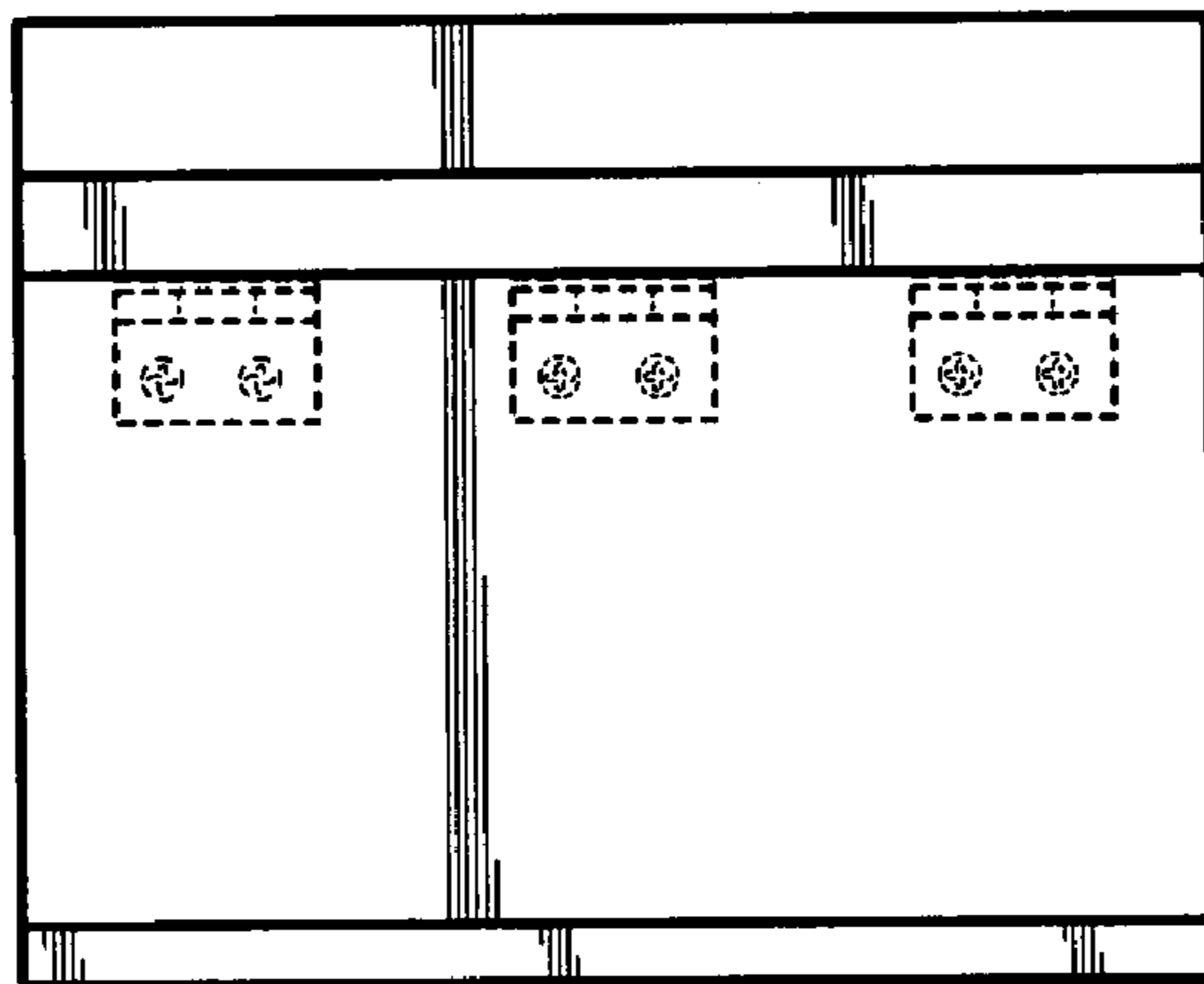

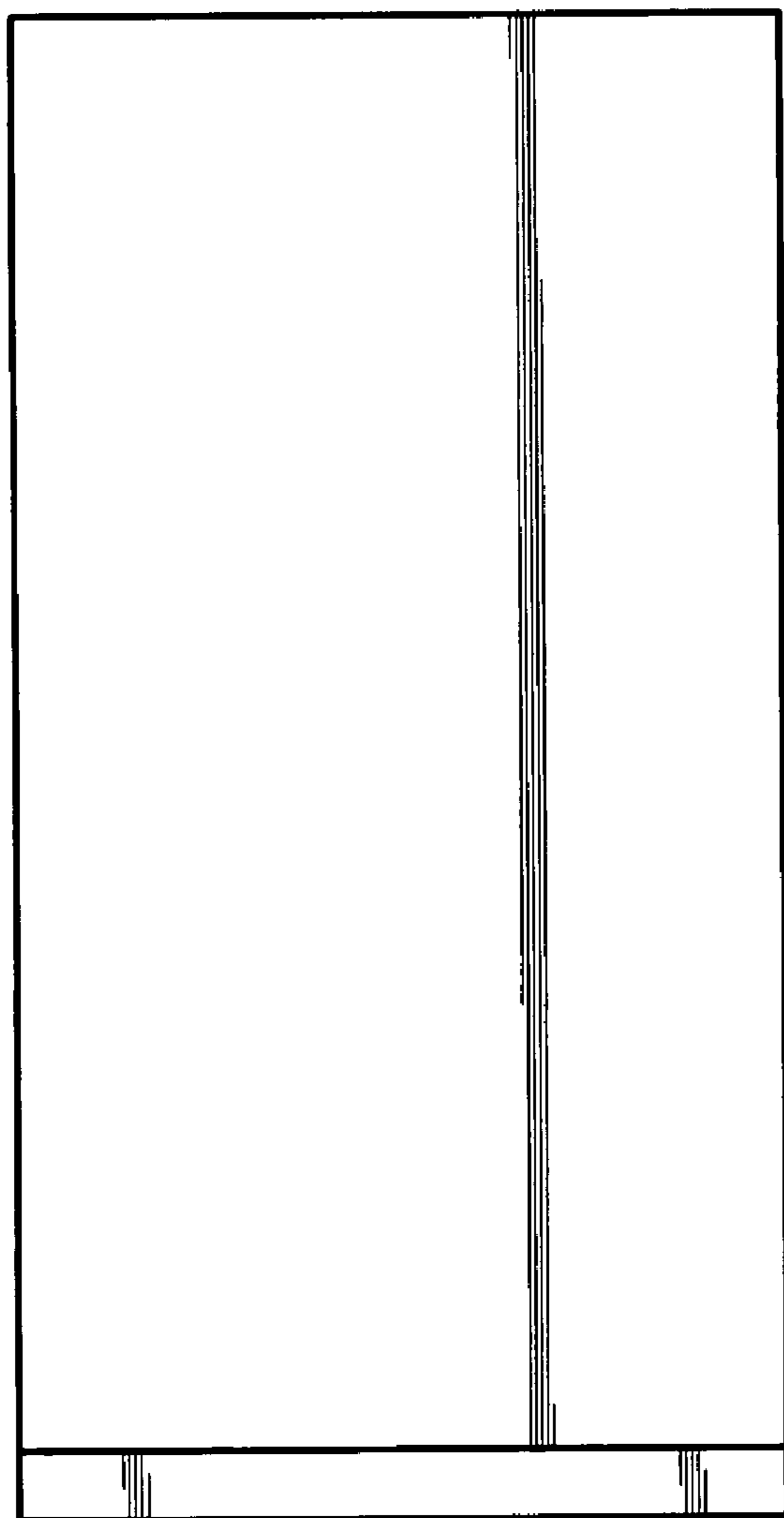

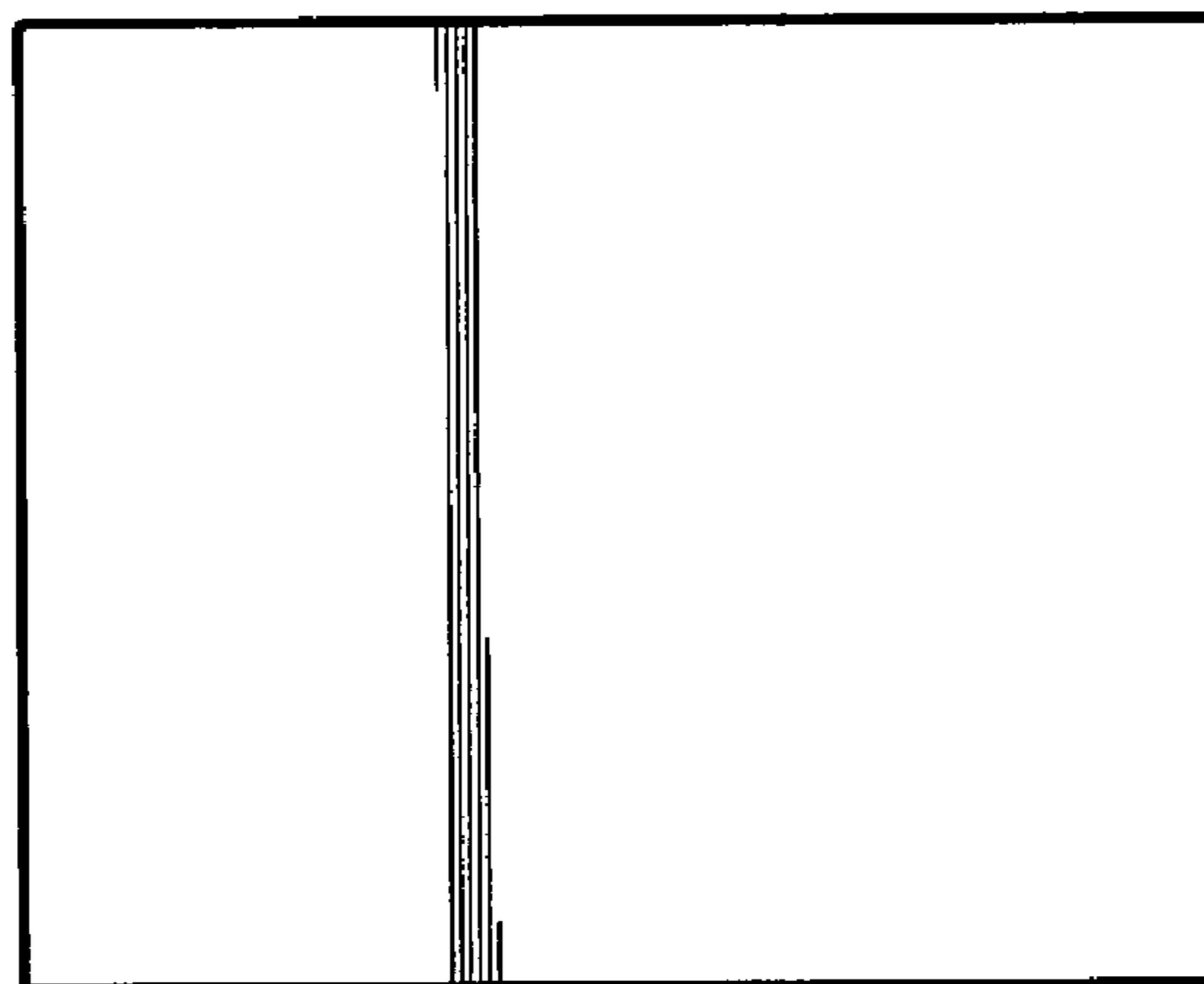

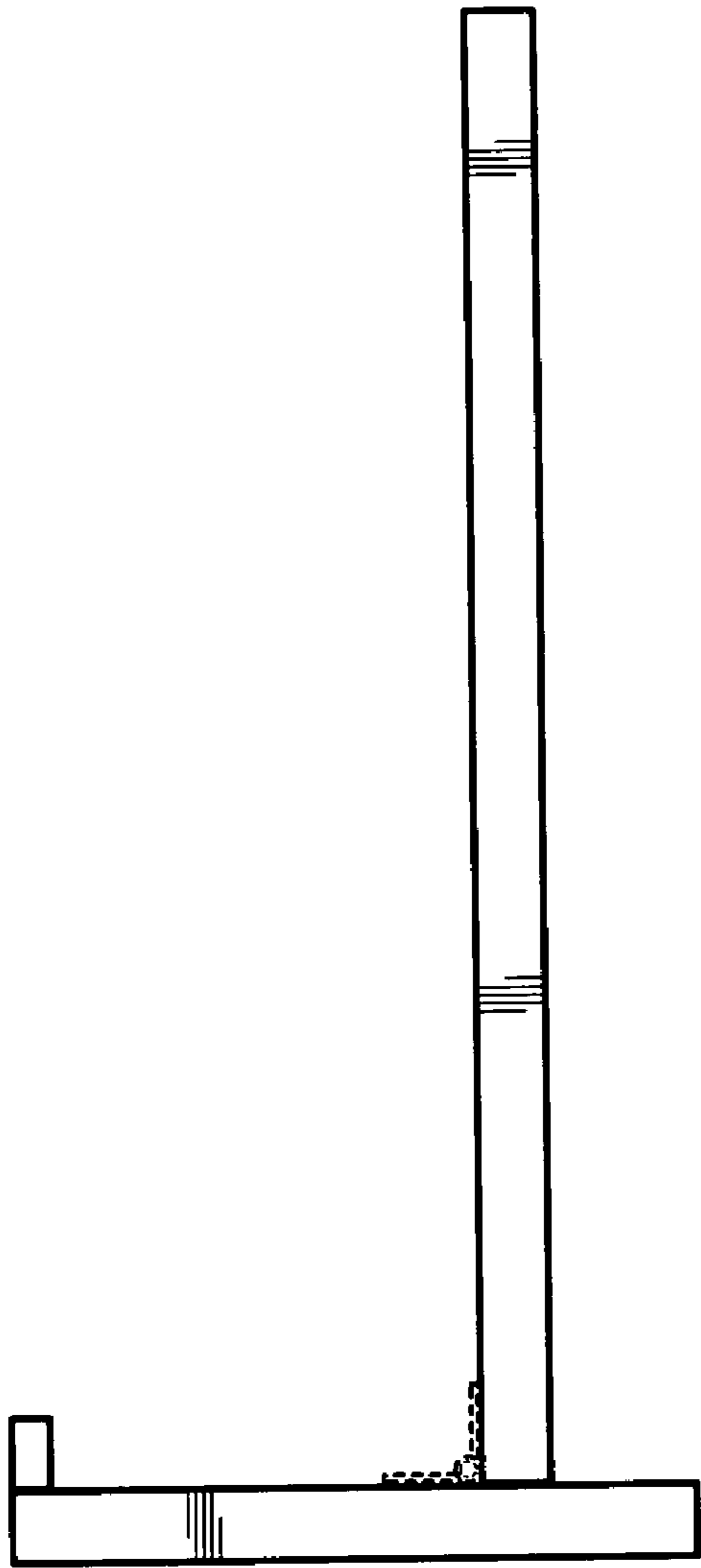

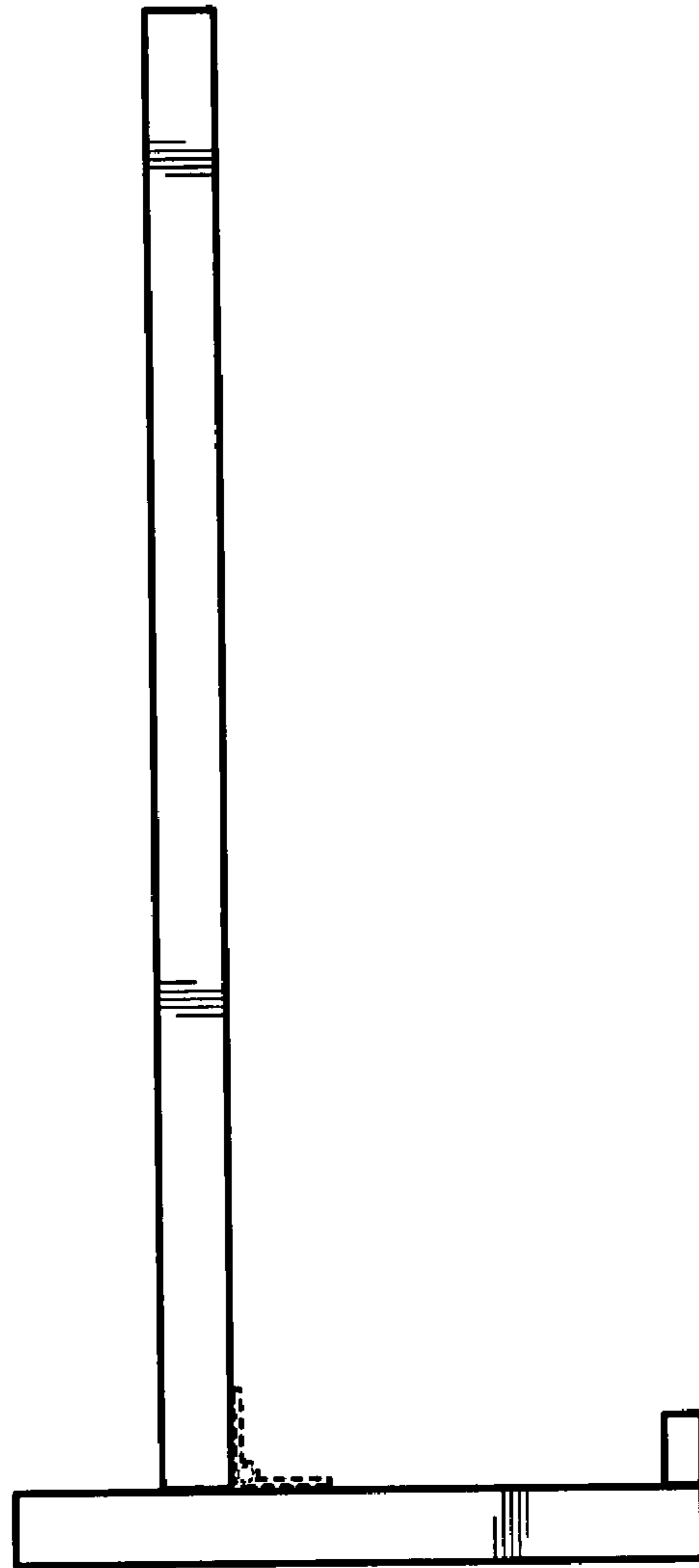
