(57) **CLAIM**

The ornamental design for the telephone with video display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a telephone with video display;

FIG. 2 is a front view of the telephone with video display of FIG. 1;

FIG. 3 is a top plan view of the telephone with video display of FIG. 1; and,

FIG. 4 is an enlarged front view of the telephone with video display of FIG. 1.

The broken line showing of the telephone and areas of the image is included for the purpose of illustrating portions of the article and forms no part of the claimed design. The broken line outline of the time “12:35 PM” included in FIGS. 1-3 is too small to be seen, but is shown in the enlarged view FIG. 4. The time “12:35 PM” is shown in FIGS. 1-4 in broken line and forms no part of the claimed design.

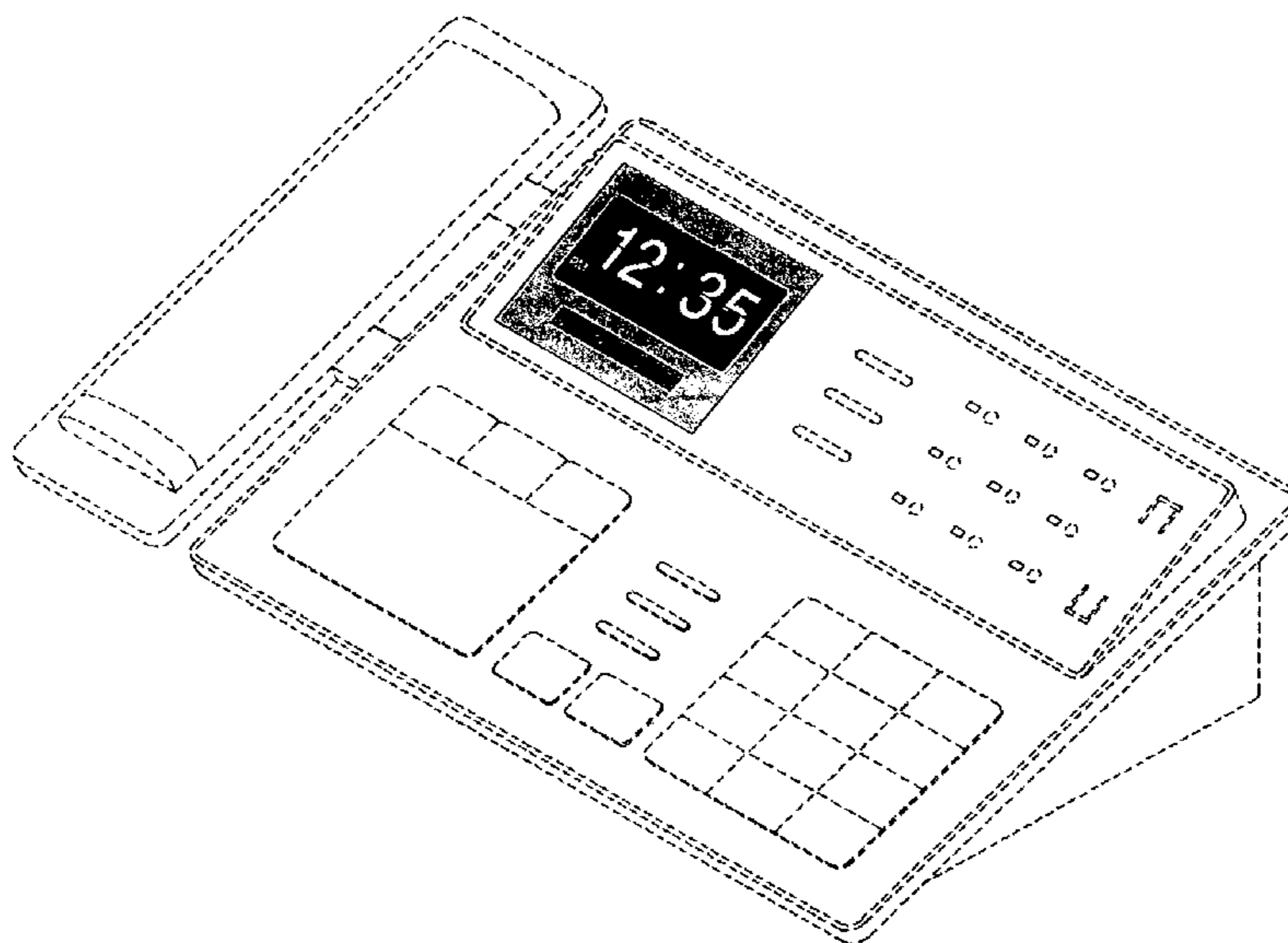

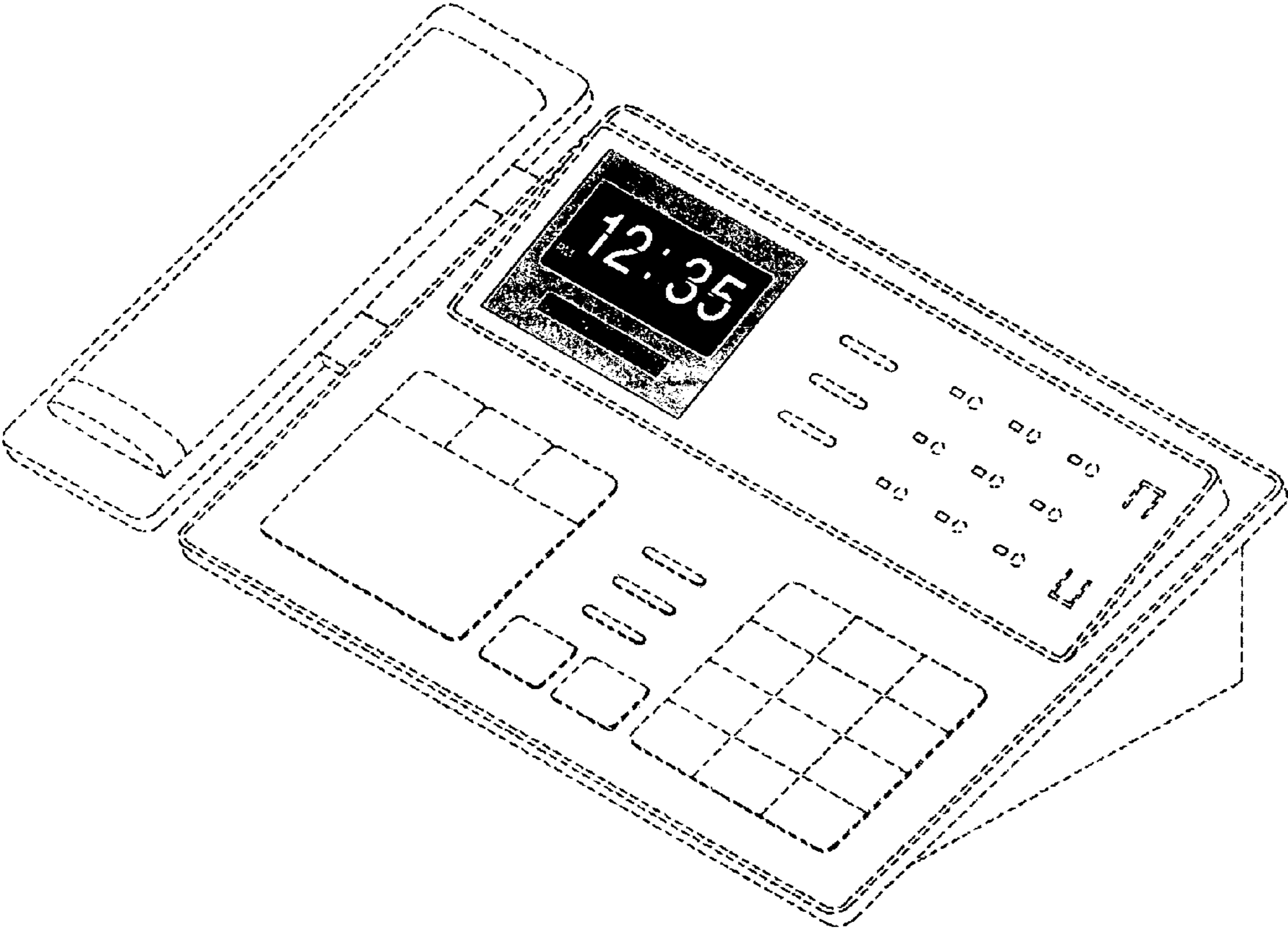

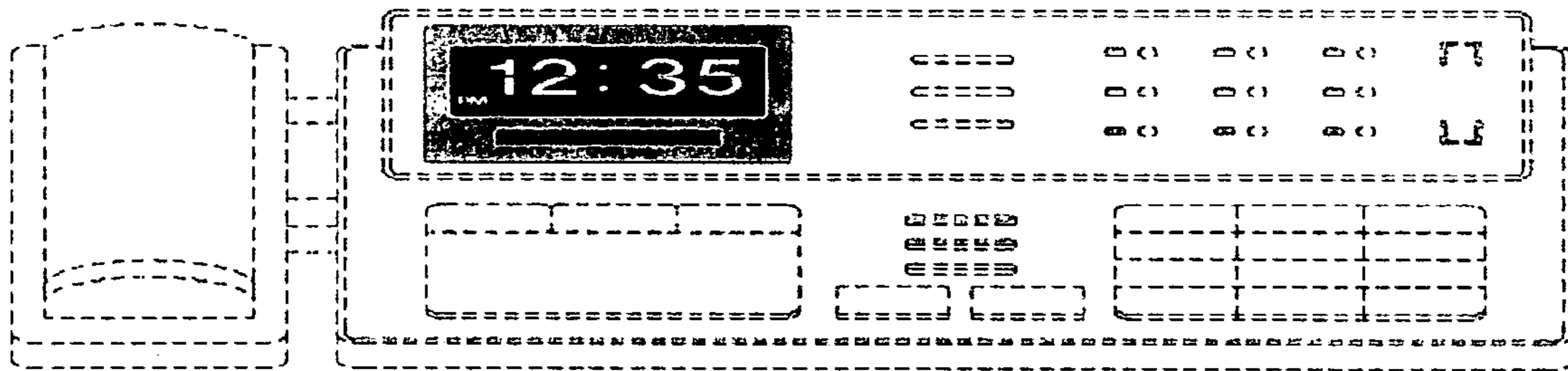

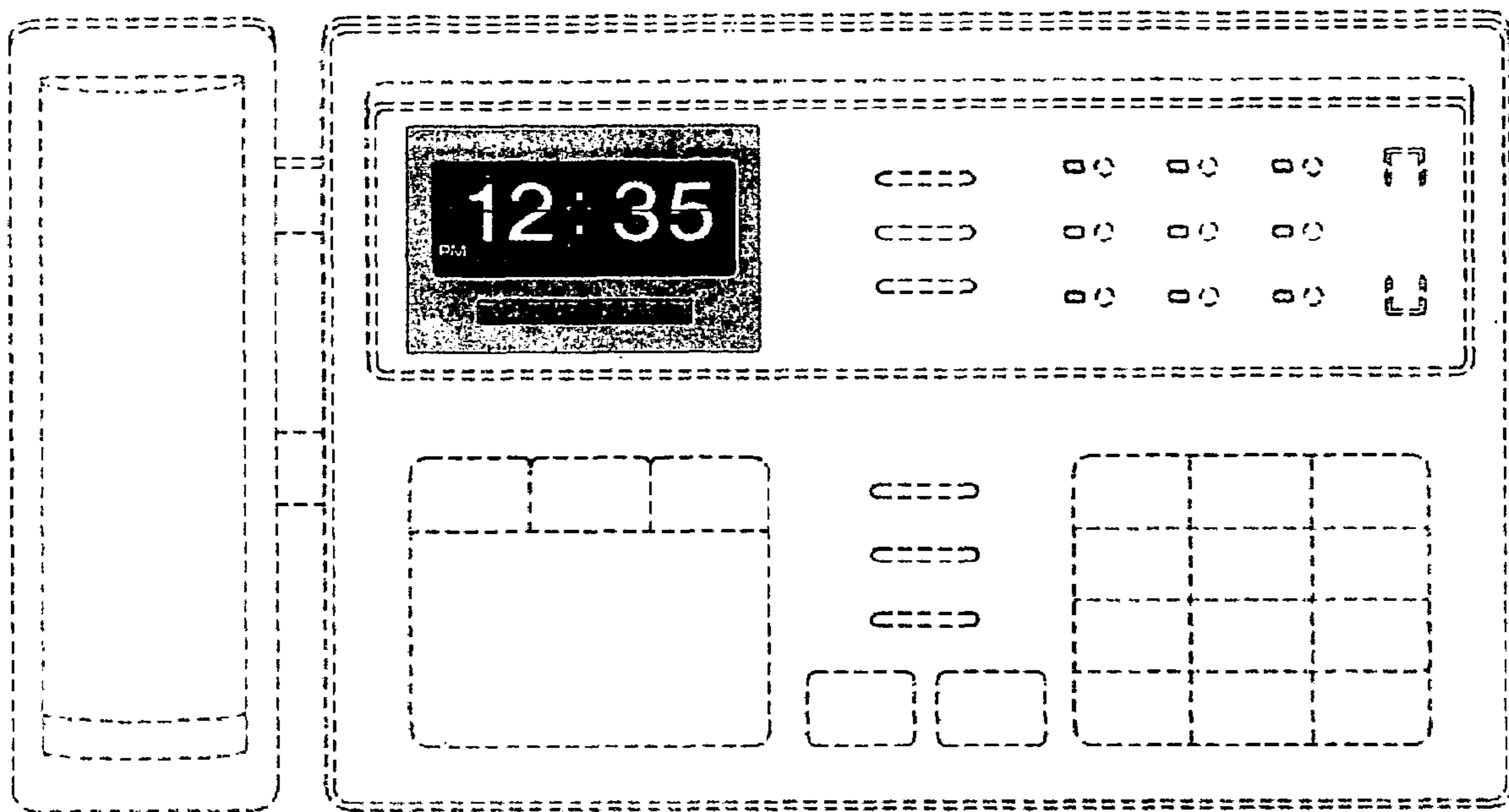
