(57) **CLAIM**

The ornamental design for a sliding tapered dovetail and fixed half-blind dovetail template, as shown and described.

FIG. 3 is a bottom view thereof.

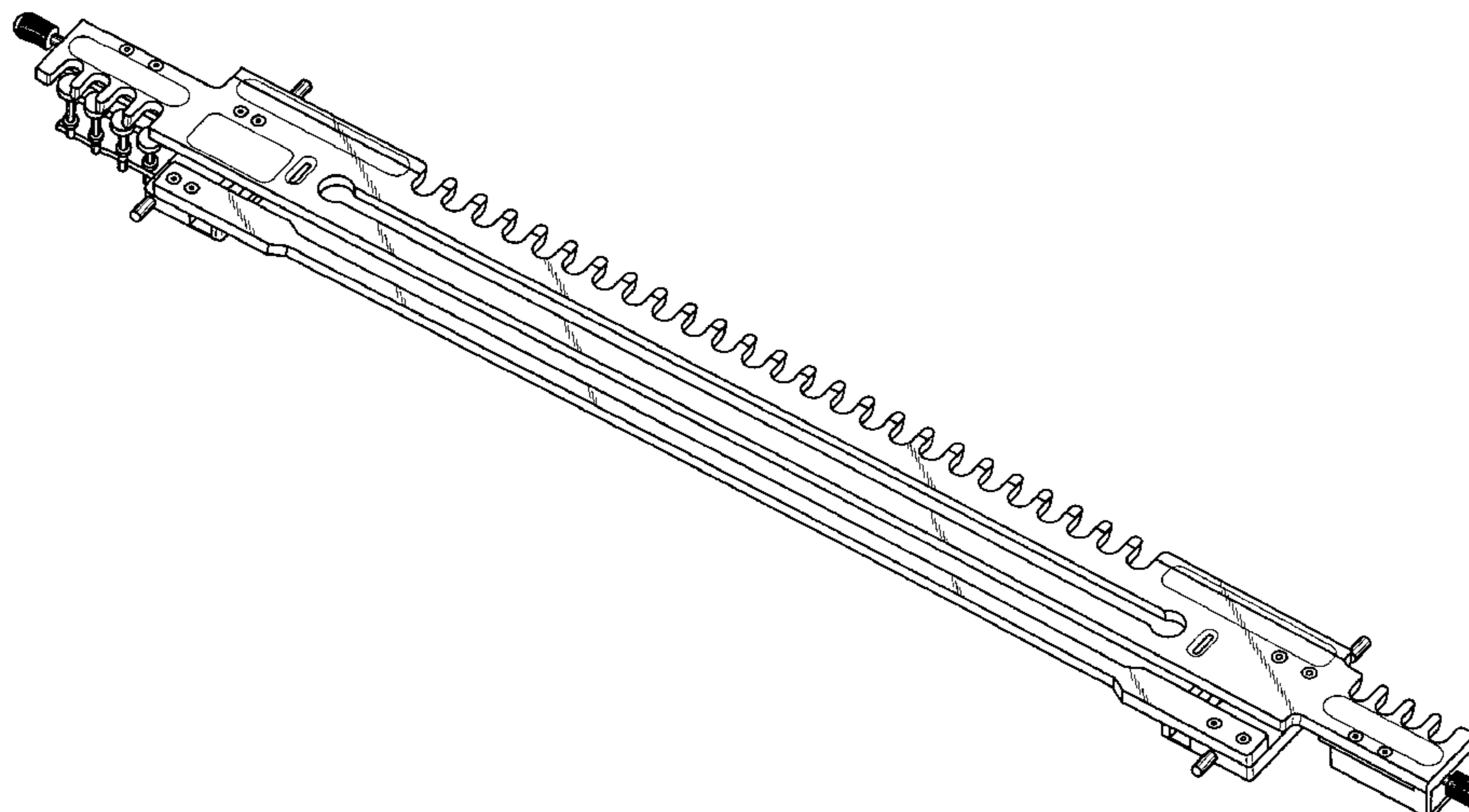
FIG. 4 is a rear elevational view thereof.

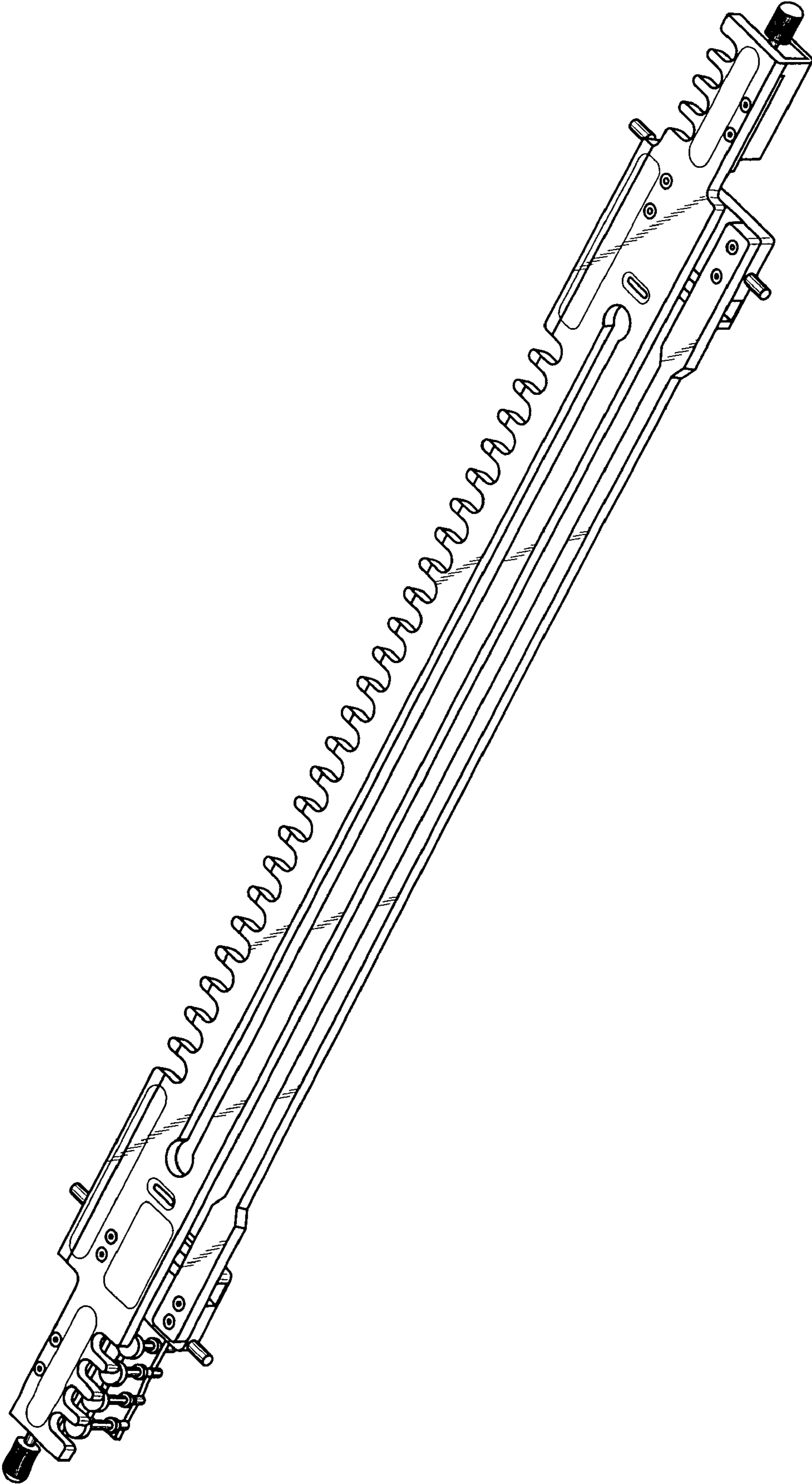

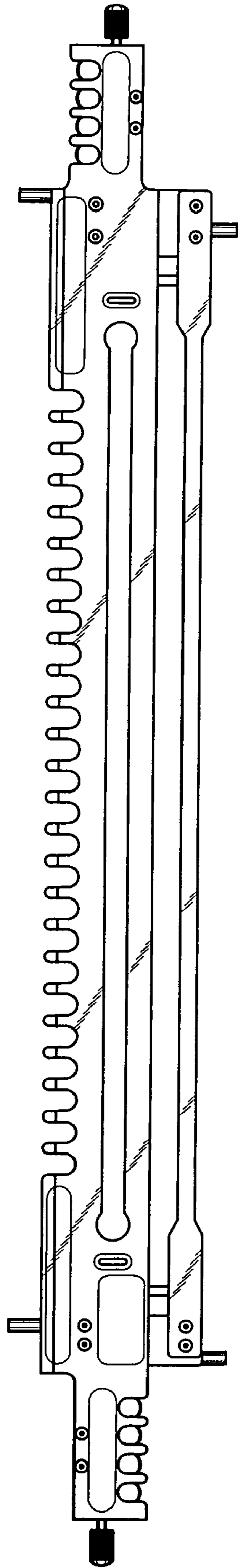

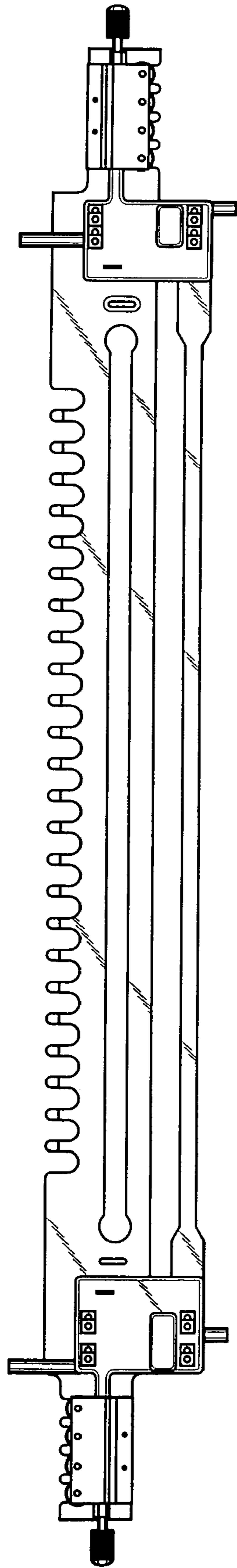

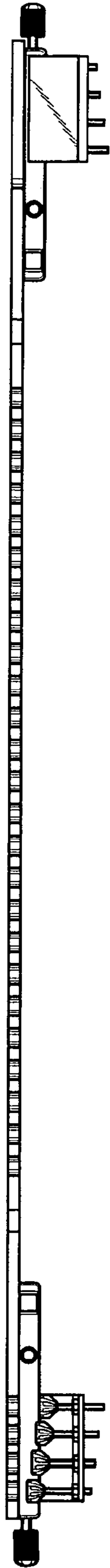

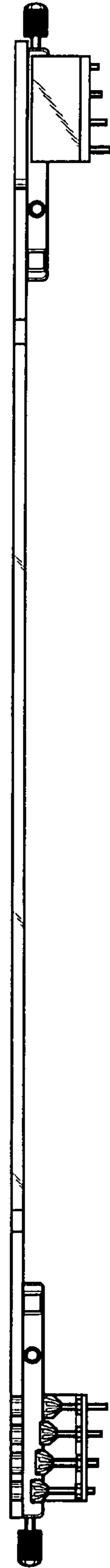

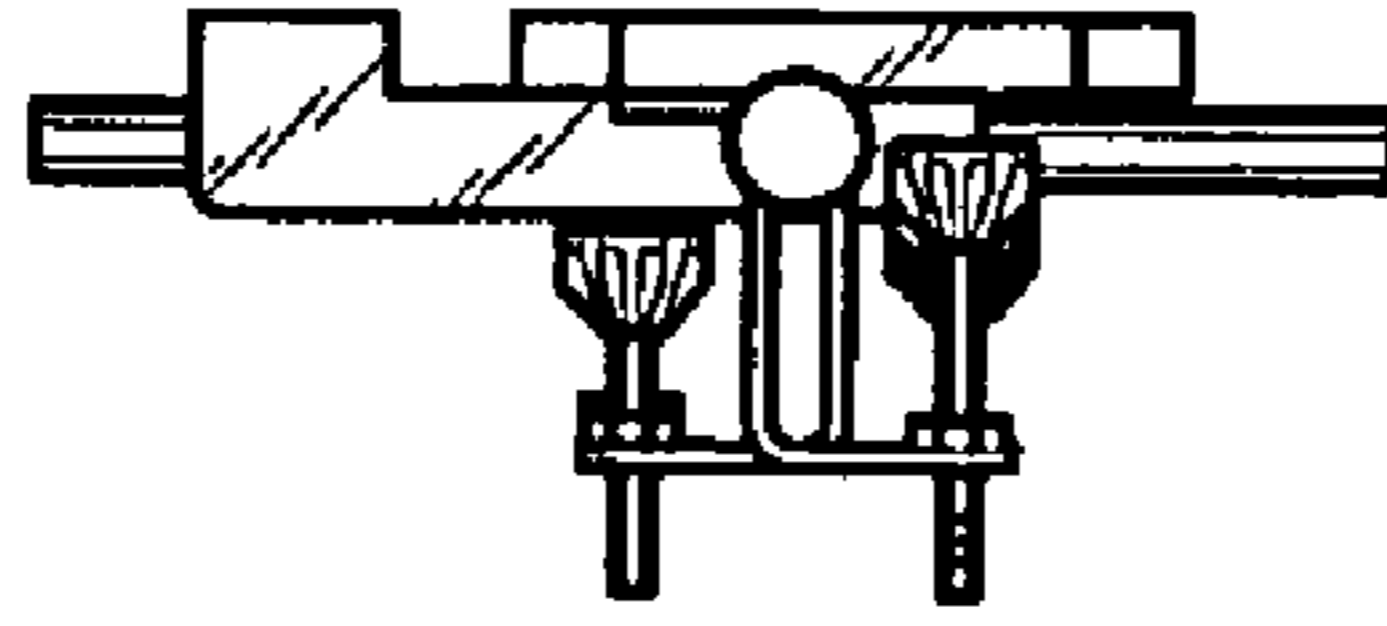

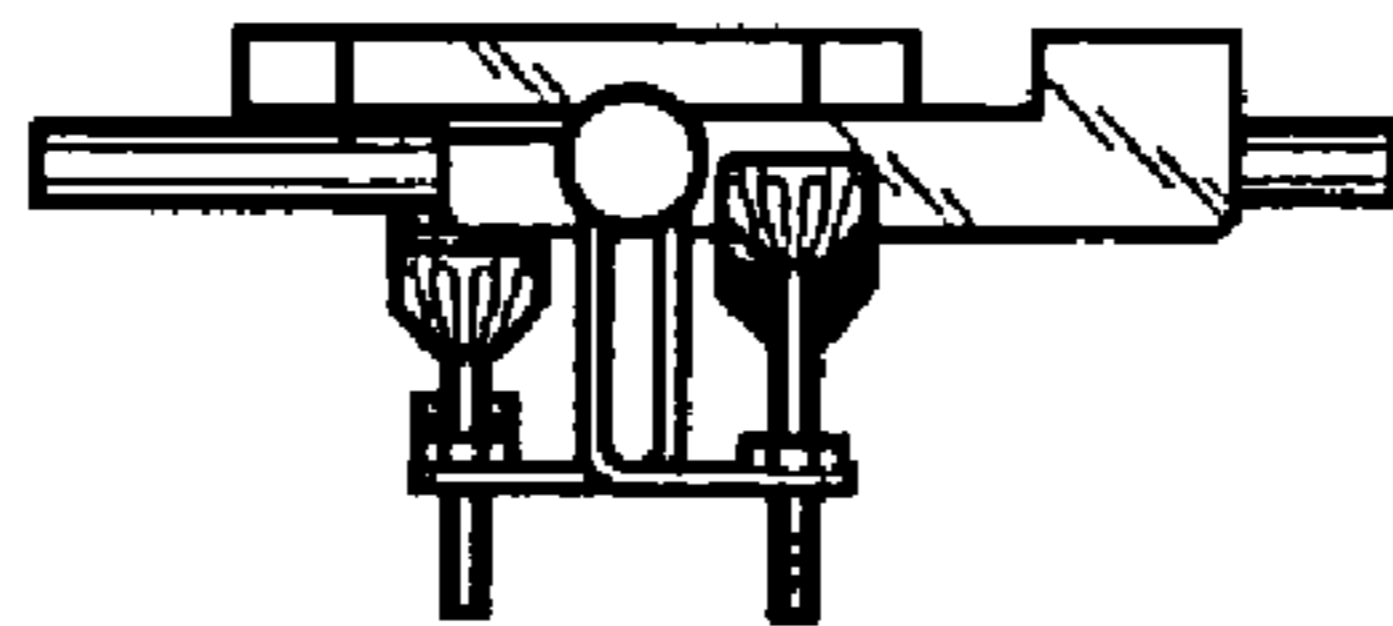
